Spinons and paraferm ions in ferm ion cosets

We introduce a set of gauge invariant ferm ion—elds in ferm ionic coset models and show that they play a very central role in the description of several Conform alField Theories (CFT's). In particular we discuss the explicit realization of primaries and their OPE in unitary minimal models, paraferm ion—elds in Z_k CFT's and that of spinon—elds in SU (N) $_k$; k=1 Wess-Zum ino-Witten models (WZW) theories. The higher level case (k>1) will be brie y discussed. Possible applications to QHE systems and spin-ladder systems are addressed.

Introduction

The purpose of this talk is to brie y review the ferm ionic coset description of some particular CFT's, whose relevance has shown up in particular in the construction of the primary operators in the minimal unitary models and the Z_k paraferm ion models, as well as in the identication of quasiparticle operators in SU (N) k WZW models [1,2]. We will particularly emphasize the realization of order-disorder (OD) algebras as well as the realization of quasi-particle operators with generalized statistics, where the gauge invariant ferm ion elds play a central role.

We want to point out that we will only brie y comment on some of the basics of CFT which are relevant for the discussion we want to pursue. For more details see for example ref. [3].

The so called coset construction was introduced by Goddard, Kent and Olive [4] as a way to obtain CFT's with Virasoro central extension less than unity, and can be used to build up many interesting conformal eld theories [3]. Lagrangian realizations of these coset theories have been presented, both in the bosonic formulation [5], in terms of gauged W ZW models and in the fermionic versions [6], in terms of constrained (gauged) fermions.

Here we will use the ferm ionic description of coset models, and will discuss essentially three cases: the models in the so called minimal unitary or FQS series [7], the Z_k paraferm ion models [8] and the SU (N)_k W ZW models [2,9] (from the point of view of ferm ion cosets). However, the present approach can be applied to the study of arbitrary coset models. (Details on the computations that lead to the results reviewed here are contained in refs. [10(13)).

In the case of m inim alm odels we have shown that all the prim aries can be constructed as certain ferm ion bilinears, and in the case of the Ising model, (the rst model in the minimal unitary series), we have shown that the role of the gauge invariant ferm ions is crucial in the identication of the OD elds. This is the rst case in which the relevance of gauge invariant ferm ions has shown up [10].

In ref. [11] we have shown how the construction of the $0\,D$ operators in [10] can be generalized to construct all the prim arises in Z_k paraferm ion models, and we used this construction to study the \thermal" perturbation of the system.

M ore recently [12], we have shown that the gauge invariant ferm ions realize in a natural way the so called \spinon" elds, which were shown to play a crucial role in the quasiparticle description of the Hilbert space of the SU (N) $_1$ W ZW theories, as motivated by the underlying Yangian symmetry [14]. (The extension to higher level cases is in progress [13]). As a byproduct, we have also shown how to factorize the W ZW primaries in holomorphic and anti-holomorphic parts, a problem that has received some attention recently [15].

All these results clearly suggest that the gauge invariant ferm ions (gif's) play an important role in the description of CFT's: in the case of SU (N)_k W ZW models, these gif's are precisely the quasiparticle operators, and both in the minimal unitary models and in the Z_k paraferm ion models, all the primaries are composites (bound states) of these gif's. Hence, there is a good chance that the construction of quasi-particle operators in terms of gif's pursued in refs. [12,13] could be extended to other CFT's. This construction could be of some interest in connection with the so called quasiparticle (or ferm ionic) representation of the characters for CFT's [16].

A nother interesting point is that the quasiparticle operators constructed in ref. [13] for the higher level cases satisfy non-abelian braiding relations, and hence could play a role in the description of some QHE systems, such as the so called Haldane-Rezayi and Pfa an states [17], where the elementary quasiparticles have non-abelian statistics.

Finally we want to mention the so called spin-ladder systems (see ref. [18], and references therein), which in the low energy regime can be studied as certain W ZW models with interactions. Our approach could be also useful in the study of these systems, where many interesting elects have a non-perturbative origin.

An example: $SU(N)_1 WZW$ theory as a ferm ion coset

Let us rst set up our conventions and describe the approach in a simple example, such as the ferm ionic coset representation of the SU $(N)_1$ W ZW theory [9].

The idea is to describe this model as a ferm ionic coset U(N)=U(1), which is constructed starting with N free massless D irac ferm ions and freezing the U(1) charge by imposing

where j is the U (1) ferm ionic current.

This is achieved in the path-integral by introducing a -functional as

The partition function of the U (N)=U (1) m odel is then given by

and is equivalent to the partition function of the SU $(N)_1$ W ZW model in the sense that correlators of corresponding elds in the two theories coincide [9].

In order to write the partition function in a more manageable form, we perform the following change of variables [19]

where $\theta = \frac{\theta}{\theta z}$, $\theta = \frac{\theta}{\theta z}$ and $\theta = \frac{1}{2}$. The elds u and u are parametrized in terms of real scalar elds as $\theta = \exp(\theta - i z)$.

Taking into account the gauge xing procedure and the Jacobians associated to (4) [19] one arrives at the desired decoupled form for the partition function:

w here

(The explicit form of the ghost partition function is inessential in what follows).

Notice that, although the partition function of the theory is completely decoupled, BRST quantization conditions connect the di erent sectors in order to ensure unitarity [5].

The central charge is now easily evaluated as the sum of three independent contributions coming from the dierent sectors, $c_{\text{ff}} = N$, $c_{\text{fb}} = 1$ and $c_{\text{gh}} = 2$, thus giving c = N - 1 which coincides with the central charge of the SU $(N)_1$ W ZW model. Sim ilarly, conformal dimensions of primaries can be evaluated using this decoupled picture.

M ore general models, as for example the SU $(2)_k$ W ZW models, can be also represented as ferm ionic cosets by making use of the general equivalence [9]

In this case, in addition to the constraint in plan ented by the abelian gauge eld a , we have to introduce another constraint associated with the SU (k) currents. This constraint will be implemented by a non-abelian gauge eld in the Lie algebra of SU (k). The SU (k) gauge eld is traded for a SU (k) W ZW eld through a decoupling transform ation sim ilar to that of eq.(4).

U sing the approach described above we have studied the following cases:

i) M in im al unitary models

These models can be represented as the cosets [4]

and the Virasoro central charges lie in the FQS series [7]

By making use of eq.(7), one is led to make the identication of the coset (8) with the ferm ion coset

whose Lagrangian is given by

where all the internal indices are supressed. (The ferm ions () transform in the fundamental representation of U(2k) (U(2))). The gauge elds a, b, B, A, in the Lagrangian (11), implement respectively the U(1), U(1), SU(k)2 and SU $(2)_{k+1}$. (The subindices refer to the central charge of the constrained a ne currents).

Within this approach one can show that the central charge of these ferm ionic coset models is given by eq.(9) [6], all the primaries can be constructed in terms of ferm ion bilinears [10], and the correlators can be evaluated in terms of known results on W ZW theories [20].

The point we want to make here is that the ferm ionic description is more suitable than the bosonic one regarding the construction of primary elds and their operator product algebra. In particular we can identify in a natural way the OD elds as we will show in the examples bellow. There is one interesting example that has been completely described within this scheme, which corresponds to the Ising model (c = 1=2, k = 1 in eq.(9)). In this case, not only the primary operators, (i.e. the elds with their dimensions in the Kactable), but also the OD algebra has been realized using the gauge invariant ferm ions [10].

Gauge invariant ferm ions

Let us introduce the gauge invariant ferm ion elds of the theory de ned by eq. (11), for k = 1,

(N ote that for k = 1, the B eld is not present)

In terms of these elds, the spin () and disorder () elds read

Using the decoupling formulation one can show that they have the correct dimensions (i.e. h = h = 1=16), and satisfy the OD algebra [21]

where (z) stands for the Heaviside function.

We will explain how the OD algebra arises in a simpler example later on, but let us point out that while the Schwinger line integrals associated with the non-abelian gauge eld A cancel out in the bilinears (14), those associated with the abelian gauge elds a and bwill not, and this fact will give rise to the OD algebra.

ii) Zk paraferm ion models

These models are realized as the cosets

and the V irasoro central charge is given by c = 2(k + 2).

In term s of ferm ionic cosets they correspond to

In order to construct the prim ary elds we have proceeded in two steps: rst we have used the identication of the prim ary elds of the SU $(2)_k$ W ZW in terms of fermion bilinears made in ref. [9], and then, rewritting these bilinears in terms of giffs we have shown that they correspond to OD elds. Other primaries of the Z $_k$ models, such as parafermion currents, were also constructed as suitable composites of gauge invariant fermions.

SU (2)_k prim aries

The Lagrangian of the ferm ionic description of the SU $(2)_k$ W ZW model is given by

where a $\$ and $\$ B $\$ are $\$ U (1) and $\$ SU (k) gauge $\$ elds, $\$ im $\$ plem enting the respective $\$ constraints $\$.

The fundamental eld g and its adjoint g^y of the bosonic SU $(2)_k$ W ZW theory are represented in terms of fermions by the bosonization formulae [9]

A llother integrable representations can be constructed as sym metrized normal ordered products of these fundamental elds. Note that these elds are invariant under gauge transformations, both in U (1) and SU (k), as they should be in order to correspond to physical operators.

The theory which we are interested in has one more U (1) constraint (see eq.(17)), which we implement by adding to the Lagrangian (18) the term

where t^3 is an SU (2) generator. This term (after functional integration over b^3) in plements the additional U (1) constraint as follows from eqs.(1),(2). It is easy to show, using the approach described above, that the central charge of the resulting model is the correct one.

The elds in (19) vary under gauge transform ations associated with the new gauge eld, b^3 , introduced in eq.(20). In order to ensure invariance also under these transform ations, we will de ne the gauge invariant ferm ions as

In [11] we have shown that all the Z_k primaries can be built up from these elds. Here we will only discuss an example in some detail, in order to show how OD algebras are realized in terms of gifs.

U sing (21) we can construct the gauge invariant version of the q-eld and its adjoint in eq.(19) [10]

Let us consider the composites

In the decoupled picture these elds can be rewritten as

Here $\mathbb U$ is the SU (k) $\mathbb W$ ZW eld that parametrizes the eld B, and a, b are the U (1) boson elds that parametrize a and b respectively, and b are the chiral (holomorphic and anti-holomorphic) components of the free boson b.

The dimensions of these elds are easily evaluated in the decoupled picture and are given by

and it can be shown that they satisfy the OD algebra [10]

Eqs. (25) and (26) lead one to identify the elds and de ned in (23) with the order and disorder operators in the Z_k paraferm ion theory.

Let us stress that the 0D algebra has its origin in the particular way in which the holom orphic components of the free boson $_{\rm b}$ are combined in eq.(24). This, in turn, is a consequence of the use of the gauge invariant ferm ions (21). Indeed, one can easily check, using the cannonical commutation rules for $_{\rm b}$ that

being the other factors com muting.

This construction can be generalized to all other Z_k prim aries and hence, having identi ed all the prim aries one can pursue the study of perturbations in the Lagrangian approach. We have studied the \thermal" perturbation of Z_k models within the present approach and reduced the problem to the study of interacting W ZW elds. In this scheme, two xed points of the perturbed system were identified [11].

iii) SU (N) k W ZW models: gif's, spinons and holom orphic factorization

All we have done so far is to study bilinears of the gauge invariant ferm ions. In this last section we will study the properties of the gauge invariant ferm ions them selves and show their relevance in the so called \spinon" description of W ZW models [14], as described in ref. [12,13].

Let us then de ne the gauge invariant ferm ion elds [12] corresponding to the SU (N)_k theory similarly as in (12), (with A replaced by B), that by construction will create the physical excitations, and let us study their properties. For simplicity we will discuss the level one case, although similar considerations apply to the higher level case [13].

In the decoupled picture, the gifs are given by

where '(z) and ' are the chiral (holom orphic and anti-holom orphic) components of the free boson . This fact together with the equation of motion of the free ferm ions ensures that $^{^1}_1$ and $^{^{^1}2}_2$ ($^{^2}_2$ and $^{^{^1}2}_1$) are holom orphic

(anti-holom orphic). The conform ald im ensions are given by ((N 1)=2N;0) and (0; (N 1)=2N) respectively, thus suggesting that they correspond to the halves" of the W ZW primary g(z;z).

In fact, it can be shown by the following sequence of identities

that the gifs are the holom orphic factors of the W ZW prim ary.

The second important property satisted by these operators is their OPE which allows us to identify them as the \spinon" operators of ref. [14]:

where A stands for antisym m etrization and $\frac{ij}{2}$ is the W ZW primary with dimension (N 2)=N.

As explained in the third reference of [14] the branch cut in the OPE singularity in plies that the excitations created by the spinon elds satisfy generalized statistics with \statistical angle" = $\pm N$. The chiral Fock space of the SU $(N)_1$ CFT can be constructed in terms of the modes of these elds and this space can be classified into multiplets corresponding to the irreducible representations of the Yangian algebra Y (sl_N) [14].

In the case of higher levels, the same construction can be done, and in this case, the excitations created by the gauge invariant ferm ions satisfy non-abelian braiding statistics. The holom orphic factorization of the W ZW elds in term s of gifs can also be proved. The results of this investigation will appear elsewhere [13].
