## ABSTRACT

The moduli space dynamics of vortices in the Jackiw-Pimodel where a non-relativistic Schrodinger eld couples minimally to Chem-Simons gauge eld, is considered. It is shown that the di culties in direct application of Manton's method to obtain a moduli-space metric in the rst order system can be circum vented by turning the Lagrangian into a second order system. We obtain exact metrics for some simple cases and describe how the vortices respond to an external U (1) eld. We then construct an elective Lagrangian describing dynamics of the vortices. In addition, we clarify strong-weak coupling duality between fundamental particles and vortices.

Vortices play an important role in describing som e 2+1 dimensional systems. Most of them arise as solitonic con gurations in eld-theoretic descriptions[1, 2, 3], as in the case of nonabelian magnetic monopoles in 3+1 dimensions. There are limited number of exact multi-vortex solutions and this partly explains why descriptions of their dynamics are mostly involved [4]. When a theory admits static multi-vortex solutions saturating Bogomol'nyibound [5], the low energy dynamics of slow ly moving vortices is well approximated by geodesic motions in the moduli manifold, which may be explained as follows. As the moduli space consists of a collection of points which give the same value of energy functional, the slow motions in moduli space can be electively described by the kinetic term s produced by the time dependence of moduli parameters. This is Manton's idea that was successfully applied to the case of BPS magnetic monopoles[6].

Exact multi-vortex solutions were found in Jackiw-Pim odel where a non-relativistic Schrodinger eld minimally couples to the Chern-Sim ons gauge potentials[3]. Previous attempts to analyze dynamics of the vortices within moduli space approximation are incomplete mainly because the model is rst order in time derivatives and hence the metric does not appear by direct application of the M anton's methods[7]. This problem, of course, persists in all rst-order system such as non-relativistic models and relativistic ferm ionic models. In Ref. [8], an extra phase to the static Schrodinger eld solution was introduced to overcom e the di culty and it was shown that the leading order kinetic term can be properly produced. But the role of the phase was unclear and, moreover, it was not xed by static con guration of vortices but rather trial functions were used in their fram ework.

In this note, we observe a simple fact that the Lagrangian can be turned into secondorder form in time by eliminating momentum variables. It will be shown that the phase in Ref. [8] is indeed determined by the continuity equation in terms of solely vortex con gurations. Once a second-order formulation is achieved, one may apply the standard M anton's method of evaluating the kinetic term in term of moduli parameters to derive the moduli space metric.

Equipped with the second-order Lagrangian, we shall obtain exact metrics in the cases of a vortex and coincident multi-vortices. We also study how the vortices respond to an external U(1) eld. We then describe the structures and asymptotic behaviors of the metric for spatially separated vortices. Based on these analyses, we will construct an elective Lagrangian describing the dynamics of well-separated vortices.

F inally, we observe that there is an intriguing dual structure between fundam entalparticles and the vortices described by the elective Lagrangian. Namely, at weak (strong) statistical interactions between the particles, the vortices feel strong (weak) statistical interactions.

The non-relativistic Schrodinger eld m in in ally coupled to the Chem-Sim ons gauge eld is described by the Lagrange density

where  $D_t = Q_t + iA^0$ ; D = r iA and is taken to be positive for simplicity. By solving the Gauss-law constraint

the system may be equivalently described by

Q uantization of this model leads to N-body Schrödinger equation describing particles interacting via A haronov-B ohm potential[9]. The coupling strength of the interaction is characterized by statistics parameter 1=(4), 2 multiple of which is the phase acquired when two particles are exchanged. O ther than obvious gauge and G alilean symmetries, this system possesses SO (2,1) group invariance comprizing usual time translation, time dilation T (t) = at, and special conform al transform ation T (t) = t=(1 at). This conform al symmetry is in general broken by quantum corrections, but there is a critical strength of g = 1=(2m) where the symmetry persists even at the quantum level[10]. At this critical strength, the system also adm its static multi-vortex solutions saturating the energy bound characterized by the self-dual equation,

In what follows we shall x the value of g to be critical. The general solutions of the self-dual equation were found in Ref. [3] and given by

where z = x + iy and  $z_n (= a_n^x + ia_n^y)$  are complex constants. It describes N separated solitons at positions  $a_n$  with scales and phases  $c_n$ . This accounts for the fact that the dimension of N -vortex m odular space is 4N 1 upon elimination of one overall phase parameter.

As stated earlier, the action m ay be turned into a second-order form by eliminating momentum variables. First, we rewrite the action (3) in terms of (r;t) and (r;t) with  $=\frac{1}{2}e^{i(+!)}$ , where ! is a xed background phase function. Later this will be identified

with the phase of the static soliton (7). In term s of new variables, the transform ed Lagrange density reads

In fact, this is nothing but the continuity equation for charge. M oreover, we clearly see that the phase introduced in Ref. [B] can now be determined from the vortex con gurations. We solve the constraint with respect to

Inserting (11) into (9) and dropping irrelevant total derivative term s, we obtain the desired second-order Lagrangian:

The redundant introduction of background phase ! in the derivation of (14) can be justified if one considers the vortex con gurations in (7). Namely,  $r^2!_{sol}$  with the phase ! sol in (8) contains delta-function contributions and their separation by the background phase gives some convenience in performing integration by parts with vortex wave functions.

Following M anton's idea, one substitutes the multi-vortex solution (7) with time dependent moduli parameters i into (14) to obtain N -soliton elective Lagrangian,

where we have used the fact that r A and the last integral in (14) are vanishing when evaluated upon the vortex solution. The generic expression of  $C_i$ () for N soliton solutions was given in Ref. [7, 8]. Hence we shall mainly focus on noting the metric.

Specialize in the N-coincident vortices described by

where a is the position of the vortex and the remaining positive quantity c is related to the dilatation of vortices. Of course these three degrees of freedom do not account for the full m oduli space but rather one is specialized in coherent m otions and dilatation of N vortices. W e then proceed by evaluating rst

Though the above equation resembles the two-dimensional Laplace equation with non at metric, the method of extracting solution is not known for generic  $\cdot$ . However, with the specific choice of in (16), one easily nds

Inserting the expression U into (14) and perform ing integration, one is led to the e ective Lagrangian

O ne sees that the vortex m ass is proportional to its number and no statistical interaction arises for the overall translation. For N  $\notin$  1, energy cost required for the nite velocity excitation in the conform alm ode is of the sam e order as the spatial velocity. In case N = 1, the charge diverges and the excitation in this m ode is forbidden due to its in nite energy cost. In generic con guration, one m ay show that the inertia for this overall conform alm ode is m easured by K (c)=c<sup>2</sup>. Noting that K in general diverges unless  $P_{m=1}^{P} C_m = 0$  [3], one conclude that the allowed conform alm ode in this coincident vortex is rather exceptional.

M otion of two vortices in the m oduli space is in general complicated especially when they approach closely. For simplicity, we consider here a conguration characterized by a special choice of f (z)

where the complex variable  $z_a$  denotes  $a_x + ia_y$ . The static solution with this choice is given as

Here the center of m ass frame is chosen to focus on the relative motion. The two solitons have the same size and the relative phase between  $c_1$  and  $c_2$  is xed to the above specic value. From the symmetry and scaling argument, one may easily show that the metric has the following form in the elective Lagrangian,

where b is the ratio c=a. One nd the last statistical interaction term agrees with that in (20) with N = 2. Explicit evaluation of the metric requires solving (18) with specified by (23). Due to the different evaluation of the evaluation, we consider here rather restricted cases. We explore the limit c ! 0, which describes two solitons at large separation compared to their size. In this limit, the metric ( $g_{aa}$ , g) must be constant in a since they only depend on the vanishing ratio b. In this case, takes a simple form,

which re ects that the prole is concentrated at each location. With this expression, the equation (18) is solved by  $U = \underline{a}$  r Sign (a r). Evaluation of integrals in (15) leads to the elective Lagrangian

The other case comes with the restriction of motion by the condition  $\frac{d}{dt}(a = c) = \frac{d}{dt}(a) = 0$ . A gain the equation in (18) can be solved with this restricted \_by U =  $cr^2 = (2c)$ . Then the following combination of the metric components can be determined:

where E (x) is the complete elliptic integral of the second kind. Taking the lim it b! 0, one regains  $g_{aa} = 4$  with help of E (1) = 1, which agrees with the metric in (26).

We now turn to the problem of how vortices respond to an external U (1) eld. We shall assume the external eld is su ciently weak so that the vortex con gurations are not deformed considerably. In this weak-eld probe, the response of the vortices is linear in the applied external eld. The system is described by the Lagrange density

where the external gauge potential A<sup>e</sup> couples m in in ally to the Schrödinger eld. A dopting sim ilar m ethods used for the case w ithout external eld, and keeping to the linear term s in the external eld, one obtains an elective Lagrangian for a generic soliton solution:

where U is de ned by the relation (17).

W hen the solution in (7) is used, the e ective Lagrangian can be easily computed in the lim it where each  $c_i$  goes to zero. The result is given by

where we have used the result (for well-separated vortices) given in Ref. [7] for the statistical interaction term . Each vortex couples to the external elds with a coulping strength 4 and carries a magnetic moment 2 .

Based on the above investigation, one may nally deduce N -soliton e ective Lagrangian with a help of C hem-S in ons kinetic term. We consider dynam ics of well separated vortices, and each vortex producing the A haronov-B ohm potential as indicated in the statistical interaction terms in above e ective Lagrangians. Each vortex is supposed to feel the gauge potential produced by other vortices. This reasoning is sum marized in the following local e ective Lagrangian:

with  $^{0} = 1 = (16^{2})$  and m $^{0} = 4$  m. Here the magnetic moment interaction is ignored since the magnetic eld produced by vortices are localized at the vortex locations.

In this elective theory approach, one indicate there is a duality between the soliton Lagrangian and the original N particle Lagrangian. Namely, the dimensionless coupling constants 1=(4) and 1=(4) are related by

where the equivalence classes of  $/ {}^{0}$  in particle/soliton sector come from the fact that these shift do not change statistics nor the physical amplitudes within each sector. For example, the cases = 1 and = 2 which are equivalent in particle sector correspond to inequivalent interactions ( ${}^{0}$ = 1 and  ${}^{0}$ = 1=2) in soliton sector.] This certainly is a strong and weak coupling duality since the weak (strong) coupling in the particle sector implies strong (weak) coupling in the soliton sector. In this note, we have investigated slow ly moving vortices in the Jackiw-Pimodel by M anton's method. One interesting problem we do not deal with in this note, is the problem of head-on collision of two vortices. To nd their motion, one needs a detailed form of the metric  $g_{aa}$  and g of the two solitons. (In the cases of A belian-H iggs model, it is shown that there are =2-angle scattering in head-on collision of two vortices[4].) A dm itting the disculty involved in analytic evaluation of the two vortex metric, it may be probable to resort to numerical works.

A nother point stressed is that the m ethods developed in this note m ight be applied to generic rst-order vortex system once there exist static multi-vortex solutions. This includes the vortices in Jackiw -P i m odel w ith nonvanishing chem ical potential[11] and the various m odels considered in R ef. [12]. If the m ethod turns out to be problem atic in analyzing these m odels, the reason or its possible m odi cation need to be clari ed.

We close this note with a remark that the origin of the duality m ight have to do with supersymmetry. Supersymmetric version of Jackiw-Pimodelwas studied in Ref. [13]. Detailed analyses of the soliton sector in this supersymmetric model will be of great interest.
