# F ixed point analysis of a scalar theory w ith an external eld

#### Abstract

A $m$ om entum dependent projection of the $W$ egner $H$ ougton equation is derived for a scalar theory coupled to an extemal eld. This form alism is useful to discuss the phase diagram of the theory. In particular we study som e properties of the $G$ aussian xed point.

In eld theory there are several physical situations where the scalar self-interacting theory plays a role of param ount im portance. In som e cases it is usefult to introduce the order param eters, lorentz-scalar from which one can extract inform ations on the ground state properties when $m$ acroscopic quantities like the tem perature or the density are changed. In QCD the representative exam ples are given by the two avour singlet quantities nam ely the P olyakov loop and the trace of the ferm ion condensate. The rst signals the appearance of the decon ning transition and the second one the chiral sym $m$ etry restoration.

On the other hand, the scalar theory has a central role in the StandarM odeland G U T's. Therefore it is ofgreat interest to have a carefulunderstanding of its xed point structure in order to determ ine the phase diagram and all possible relevant directions in the param eter space.

In the fram ew ork of the -expansion for the scalar theory, one nds only the $G$ aussian xed point in any dim ensions and the $W$ ilson $F$ isher xed point for $2<D<4$ [1] $]$. A $n$ interesting issue has been recently raised in $\overline{[ }]$ where it is found that around the G aussian sed point new relevant directions exist; this result how ever is not w idely accepted $[\underline{3} \mathbf{T}]$.

A conven ient w ay to discuss these problem s is provided by the $W$ egner $H$ oughton equation [ $[4]$ which is obtained by perform ing a functional integration over the in nitesim alm om entum shell $\mathrm{k} ; \mathrm{k} \mathrm{k}$ in the lim it $\mathrm{k}!~ 0$. The above functionalequation, which in principle is exact and contains the wholee ect due to the integration of the fast $m$ odes, has no known exact analytical solution and one has to resort to approxim ations in order to dealw ith a m ore tractable problem. In [-]. H ] a m om entum independent projection of the $W$ egner $H$ oughton equation has been used to obtain a renorm alization group equation for the local potential, and it has been used to classify the interactions around the Gaussian xed point. Later the $\mathrm{O}\left(\mathbb{C}^{2}\right)$ contributions have been included and the anom alous dim ension has been calculated [6] $\left.{ }_{6}\right]$.

In this Report we use the gradient expansion in order to project on a larger subset of the param eter space by including a generic eld dependence in the wavefunction renorm alization function $\left[\begin{array}{l}14 \\ 1\end{array}\right.$ two coupled scalar elds and, where the second one
is treated as classical, i.e. its quantum uctuations are neglected. This fram ew ork is useful when one is interested in studying the phase diagram for the eld in the presence of an extemal eld, whose functional form is kept xed, which in practioe is realized if the cut-o of the integrated eld is $m$ uch below the $m$ ass of the other (extemal) eld. In fact another application is a problem where a $m$ ass hyerarchy is present. For exam ple in som e cases one is interested in integrating out a heavy eld in order to construct the e ective theory in the low energy dom ain. In these cases it is im portant to $m$ onitor the decoupling of the heavy eld from the low energy e ective theory. C onversely one can discuss the e ects on a heavy eld of the integration of an extrem ely light one. H ere we concentrate on the rst issue and analyse how some properties of the xed point structure of scalar eld are m odi ed by tuming on a new scalar degree of freedom, which we treat as classical.

W e start w ith the euclidean action de ned at the cut-- $k$

The renorm alization group equation is obtained by $m$ eans of the blocking transform ation applied to the eld. By perform ing the functional integration in the path integral only on the com ponents of the eld with $m$ om entum $w$ ithin the shell ( $k ; k \quad k$ ), we obtain the blocked action

and the prime $m$ eans that the trace is taken over the in nitesim al shell ( $k ; k \quad k$ ). W e use the gradient expansion in order to calculate the trace in the above expression. W eset $(x)=0+^{\sim}(x)$ and $(x)=0{ }^{+}(x)$ and we write $K=K_{0}+K$ where $K_{0}=K(0 ; 0)=$ $Z_{k}(0 ; 0) p^{2}+@^{2} U_{k}(0 ; 0)$, the $m$ om entum $p$ lies in the shell, and $K$ is quadratic in both $\sim$ and $\sim$. Then, the follow ing expansion is used

and we com pute the trace in the last two term $s$ by retaining at the same time operators in the $m$ om entum and coordinate representation, as long as all the operators in one representation are on the right side of the operators in the other representation. In the last term of the expression this order is not ful lled and we use com $m$ utation rules to obtain the right ordering. A ll required com $m$ utators can be deduced from the sim ple rule [ $f(x)$; $p]=$ id $f(x)$. O nce the $p \quad x$ dependence has been disentangled, one can perform the trace operation and identify in the right hand side ofE $q \cdot(\overline{4})$ contributions to the local blocked potential $\mathrm{U}_{\mathrm{k}} \mathrm{k}$ and to the wavefunction renorm alization functions $Z_{k} \quad k ; W_{k} \quad k ; Y_{k} \quad k$. H ad we started w ith the action

the functions $z ; w ; y$ could have been expressed in term $s$ of $Z$; W ; Y , previously introduced, through $Z=@(z)$, $\mathrm{W}=@(\mathrm{w})$ and $Y=\mathrm{Y}+[@ \mathrm{z}+@ \mathrm{w}]=2$, so there is no am biguity in the $m$ ethod.

A fter a rather long but straightforw ard calculation one nds the follow ing ow equations for the dim ensionless renorm alized blocked potential $V=U k^{D}$ (the subscript $k$ will be om itted from now on and we de ne $\mathrm{t}=\ln (\mathrm{k}=)<0$ where is a $\mathrm{xed} U V$ scale)

T he above set of equations has been used to discuss the D ecoupling $T$ heorem (D T) $[\overline{9}]$ w ith in this approach in [10']. In particular, $m$ aking use of a polynom ialexpansion Of $V$ and $Z$ in the two elds, it has been shown that no deviation from theD $T$ appears in this context but around the heavy $m$ ass threshold som esm alle ect ofnon-locality is present in the w ave function renom alization $Z$.

H ere, since we do not expect largee ects due to $W$ and $Y$, we just consider, for the analysis of the xed point structure, the tw o coupled equations ( (G), (T, $\overline{1})$ in the case $2<\mathrm{D} \quad 4 . \mathrm{W}$ e begin our investigation by perturbing a xed point of the theory w ith $y=0$, $w$ th functions that in general depend on $y$.
Let us rst consider the $G$ aussian xed point, solution of EqS . ( $\overline{\mathrm{G}}),(\overline{\underline{T}} \overline{1})$,

W e thus write $\mathrm{V}=\mathrm{V}$ and $\mathrm{Z}=\mathrm{Z}_{0}+\mathrm{Z}$ where the perturbed quantities depend on the extemal eld and linearize the ow equations. From ( $\left.\overline{\sigma_{1}}\right),\left(\bar{T}_{1}\right)$ we obtain

Eq. (18) show $s$ that for the values chosen form and $n$, alleigen-directions around the xed point are irrelevant.

It $m$ ust be rem arked that, since we are in the presence of an extemal eld, we retain solutions $w$ ith odd $m$ and $n$, corresponding to unbounded potentials; obviously, when a speci c problem is considered, onem ust reject all solutions that are unphysical for that particular case.

N egative integer values ofm instead give bounded solutions that, how ever, are singular in $y=0$. W e shall com $m$ ent on these later.

A slightly di erent solution, involving an additive constant in the potential $V$, is obtained by selecting $m=0$ and, again, any non-negative integer $n$ in the eigenvalue (18)

O bviously the latter case corresponds to a decoupling of the eld $y$ which does not appear in the solutions, and again allperturbations are irrelevant except if $n=0$ $w$ here the interaction is instead $m$ arginal. $H$ ow ever, since $H_{0}(x)$ is a constant, it is easy to realize the $n=0$ solution is nothing else than the Gaussian xed point (10. $\left.\mathbf{O}_{1}^{\prime}\right)$, which explains the $m$ arginality of the solution.

T he set of solutions displayed so far is not com plete since the two equations (11 $\left.1_{1}^{\prime}\right)$, (12 $\underline{2}_{1}^{\prime}$ ) decouple for the particular choice $Z=0$. In this case the equation for $V$ only has to be solved and this yields new solutions which read ( $n$ is again any non-negative integer and $C_{2}$ an arbitrary non-vanishing integration constant)

which, for the latter case with $m=0$ gives the well know $n$ classi cation of the polynom ial interactions when $y$ is tumed o .

Sum $m$ arizing, any perturbation in the extemal eld which is present in the w avefiuntion renorm alization function $Z$, also appears in the potential and provides only
irrelevant directions in the param eter space w ith eigenfunctions that behave like $H_{n} Y^{m}$ where $H_{n}$ is a rescaled Herm tep polynom ial. The case corresponding to a constant non-vanishing $Z$ is $m$ arginal, but the solution is just the Gaussian xed point. Finally, for $Z=0$, the equation for $V$ decouples and we have new $m$ arginal and relevant perturbations due the presence of the extemal eld. In particular, we note that in $D=4$ the coupling corresponding to the $m$ ass of the extemal eld is a relevant interaction, although no integration on the extemal eld $m$ odes has been perform ed in the blocking procedure.

In this analysis we have not included the solutions w ith negative integer values ofm, that can correspond to positive mn in Eq. (181) and thus to relevant directions, but are singular in $\mathrm{y}=0$. They can be form ally taken into account, provided one does not tum o the eld y and replaces the norm alization introduced in Eq. (111) through the constant C, which would be illde ned, with another one that is suitable for this case. H ow ever the lim it where the in uence of the extemal eld becom es sm all and then disappears is now reached for $y!1$, $w$ hereas for $y \ll 1$ the physics of the eld $x$ is strongly $m$ odi ed by the other eld $y$. O ne can think of couplings like $x=y$ in the lagrangian that could play such a role, but we do not see any clear physicalm eaning that can be attached to these solutions.

The search for non-trivial xed points is a di cult task due to the non-linearity of the RG equations. For $2<\mathrm{D}<4$ one nds the ferrom agnetic xed point with only one relevant direction. The asym tpotic form of the potential for large eld in this xed point can be found in $\left[\frac{1}{6}\right]$ and, in principle, it is possible to study the m odications of the eigen-directions in the presence of an extemal eld, as we have done for the gaussian xed point, through a num erical investigation of equations ( $\overline{(\bar{G})},\left(\overline{7}_{1}\right)$.

From a di erent point of view our equations can be used to study the $t$ invariant solutions of ( $\overline{(\underline{i})}$ ), ( $\overline{1}$ ) $w$ th the extemal eld tumed on. In this case the extemal eld acts on the system as a new scale. In fact Eq. ( ${ }_{\mathbf{G}}^{\mathbf{G}}$ ) w ith the left hand side equal to zero, can be recast in the form

and we have supposed $y \quad x$ and we have worked out the expressions up to $O\left(y^{4}=x^{4}\right)$ term $s$. An interesting question is whether or not one recovers the $W$ ilson xed point in $y=0$ starting from a non-zero extemal eld strength as in Eqs. $\left(\mathbf{2}_{1}^{\prime}\right),(2 \overline{6})$. If this is not the case one should question the uniticity of the solution of the xed point equations in $y=0$. A num ericalinvestigation ofthe equations is $m$ andatory in order to answ er this issue. We hope to address this point in a follow ing com $m$ unication.
