P seudoclassical model for topologically massive gauge elds

A bstract

A pseudoclassical model for P,T-invariant system of topologically massive U (1) gauge elds is analyzed. The model demonstrates a nontrivial relationship between continuous and discrete symmetries and reveals a phenomenon of \classical quantization". It allows one to identify SU (1,1) symmetry and S (2,1) supersymmetry as hidden symmetries of the corresponding quantum system. We show this P,T-invariant quantum system realizes an irreducible representation of a non-standard super-extension of the (2+1)-dimensional Poincare group.

1 Introduction

Revealing new symmetries and investigating their structures is the most powerful and productive approach in modern physics [1]. Classical particle models are useful for noting hidden properties of corresponding quantum systems and understanding their nature: eciency of the approach, based on pseudoclassical mechanics [2] underlying the path-integral formulation of the quantum eld theory with fermions [3], was recently demonstrated in the context of constructing the covariant formulation of the superstring theory [4], for which the Brink-Schwarz superparticle model [5] played very important role. In a previous paper [6] we proposed a new pseudoclassical model, whose quantum analog is parity and time-reversal conserving system of topologically massive vector U (1) gauge elds [7]. The latter may be relevant to the quantum Halle ect [8] and high-temperature superconductivity [9], that basically motivates our studies.

Here we continue investigations started with Ref. [6]: The purpose of this paper is to uncover hidden sym metries of the Chem-Sim onseelds' system by means of the corresponding particle model. To be self-contained, we will recollect properties of our pseudoclassical construction. It contains a c-number parameter q, entering a mass term for spin variables, which displays a quantization property both at the classical and the quantum levels. The parameter does not a ect discrete P and T sym metries of the classical theory, but turns out to be crucial for continuous global sym metries: there are special discrete values of q at which the pseudoclassical model has a maximal set of integrals of motion. The same values of the parameter are separated by the requirement of maximality of global sym metry of the physical state space at the quantum level. Moreover, we shall see that only at these special values discrete sym metries of the pseudoclassical model are conserved upon quantization. It is interesting to note here that Deser, Jackiw and Templeton discovered the quantization of the dimensionless mass-coupling-constant ratio in the non-Abelian vector case having implicated sym metry arguments [7].

A nalyzing algebras of the integrals of motion we shall reveal hidden SU (1,1) sym metry and S (2,1) supersym metry of the P; T-invariant system of topologically massive vector U (1) gauge elds and show that the system realizes an irreducible representation of a non-standard super-extension of the (2+1)-dimensional Poincare group. Though here we deal with a free theory, these results can hopefully nd further development and applications in elementary particle and condensed matter physics. In this respect, it is worthwhile remembering that revealing of SU (N) symmetries in hadron and nuclear physics [10] and the discovery of supersymmetry [11] were realized rest in contexts of free theories but subsequently turned out to be forming the basis for the description of real world. Note also that the rest 4D group-theoretical supersymmetry constructions were motivated by certain aspects of parity in quantum eld theory [12].

2 The eld system and pseudoclassical model

The source-free equations for topologically massive vector U (1) gauge elds, given in terms of a self-dual free massive eld theory [13], are rst order dierential equations L F = 0, where L (i" P + m), P = i@, = diag(1;+1;+1), = + or, and we normalize the totally antisymmetric tensor "by " 012 = 1. Due to the basic equations, the eld F satis es also K lein-G ordon equation ($P^2 + m^2$)F = 0 and the transversality condition P F = 0. As a consequence, it carries massive irreducible representation of spin s = 1 of the 3D Poincare group. A lready in pioneering works [7] it was noted that topologicalm ass terms are parity and time-reversal odd, and the full set of discrete C, P and T symmetries may be restored if one doubles the number of elds and introduces opposite sign mass terms. In the case under consideration, when taking the action

we get P ,T -invariant system of topologically massive vector U (1) gauge elds [7]. This observation plays an essential role in constructing models of high-tem perature superconductors. A ctually, single spin state models predict observable parity and time-reversal violation in corresponding superconductors [14], for which one still has no experimental evidence [15]. Besides, the problem of cancellation between single bare and radiatively generated Chem-Sim ons terms arises in the conventional models [16]. Therefore, it is desirable to have parity and time-reversal conserving system modeling high- $T_{\rm c}$ superconductors without these serious obstructions [17]. And for our work it means a signal to pay particular attention to the requirement of P, T invariance.

The pseudoclassical model in question here is given by the Lagrangian

where x, = 0;1;2, denote space-time coordinates of the particle, a, a = 1;2, are real G rassm ann variables forming two Lorentz vectors, e and v are even Lagrange multipliers, and v is a real c-number parameter. The Lagrangian (2.1) is invariant v ith respect to the discrete parity and time-reversal transform ations

where X = x; $_1$; $_2$, $_1$ = +1 for x and $_1$ and $_1$ = 1 for $_2$ implying that $_2$ is a pseudovector. We have to stress that in the classical theory parity and time-reversal invariance take place for any value of the parameter q. Nevertheless, we shall see that the case of jqj=2 is particular both at the classical and the quantum levels of the theory, and that the quantization of the model (2.1) results in the P,T-invariant system of topologically massive vector U (1) gauge elds.

To nd the corresponding quantum system and reveal its hidden symmetries, let us construct the H am iltonian description of the model. The nontrivial canonical brackets following from the Lagrangian (2.1) are fx; pg= ,f $_a$; pg= i $_{ab}$, fe;peg= 1, fv;pvg= 1,

and we obtain two sets of primary, p_e 0, p_v 0, and secondary,

constraints form ing the trivial algebra of the rst class with respect to the above brackets. As a consequence of the reparam etrization invariance, the H am iltonian of our model is a linear combination of the constraints, $H=e+v+!_1p_e+!_2p_v$, with the coe cients at the primary constraints being arbitrary functions of the evolution parameter . From the equations of motion,

where $_{ab}$ = $_{ba}$, $_{12}$ = 1, we see that the energy-m om entum vector p and the total angular m om entum vector J = $^{"}$ x p + $\frac{1}{2}$ $^{"}$ a a are integrals of m otion.

To solve the equations for the spin variables $_a$, it is convenient to use complex mutually conjugate odd variables $b=\frac{1}{p-2}(1-i_2)$ with nontrivial brackets fb^+ ; bg=i. Taking into account the mass-shell constraint, we introduce the general notation $f^{()}$ $fe^{()}$ for the projection of any Lorentz vector f onto the complete oriented triad $e^{()}$ (p), =0;1;2, de ned by the relations

In term s of these, we not that the odd spin variables have the following evolution law:

The case of q=0 is dynam ically degenerated with the variables $b^{(0)}$ being trivial integrals of motion, $b^{(0)}$ () = $b^{(0)}$ (0). As we shall see, this special case is completely excluded on the quantum level. Further, we have the nilpotent second order quantities $B=b^{(2)+}b^{(2)}$ $b^{(1)+}b^{(1)}$ i $b^{(2)+}b^{(1)}+b^{(1)+}b^{(2)}$ satisfying a simple evolution law: B () = $e^{2i!}$ (0). We obtain that if and only if jqj=2, there are two additional third order nilpotent integrals of motion in the model, namely

which are local in the evolution parameter quantities.

Thus, here we have observed some phenomenon of classical quantization: there are two special values of the parameter q, q = 2, when, and only when, the system has additional (local in) nontrivial integrals of motion. These integrals are the generators of corresponding global symmetry transformations, and so, the system has maximal global symmetry at these two special values of the model parameter.

3 Quantization of the model

To quantize the model, we completely remove Lagrange multipliers and their conjugate momenta from the theory by gauge-xing conditions $e=e_0=0$, $v=v_0=0$ for the primary constraints, where e_0 and v_0 are some constants. Upon quantization, the odd variables become the fermionic creation-annihilation operators b=0 having the only nonzero anticommutators b=0, b=0, hold b=0. Then the arbitrary quantum state can be realized over the vacuum b=0, b=0, hold b=0.

The coe cients of this expansion are some square—integrable functions of the space-time coordinates. The quantum parity and time-reversal transformations are generated by the antiunitary operators

In correspondence with classical relations, we have

While acting on the general state (x) these operators induce mutual transformation of scalar, f(x) \$ f'(x), and vector, F(x) \$ F'(x), elds.

The physical states should be singled out by the quantum analogs of the remaining rst class constraints, $(P^2 + m^2) = 0$ and b = 0, where we assume that P = i0. Note that the nilpotent constraint admits no, even local, gauge condition, and so, the respective sector of the phase space can be quantized by the Dirac method only [18]. Let us x in the quantum operator b the same ordering as in the corresponding classical constraint. This gives

As a consequence of the quantum constraints, we not that f(x) = f'(x) = 0, whereas for the elds F'(x) and F''(x) we get the equations

and $(P^2 + m^2)F = (P^2 + m^2)F = 0$. Due to the linear equations (3.1) we have also P F = P F = 0 and $(P^2 + \frac{1}{4}q^2m^2)F = (P^2 + \frac{1}{4}q^2m^2)F = 0$. Therefore, the quantum constraints are consistent, and so, have nontrivial solutions if and only if jqj = 2. We have arrived at the same quantization condition which was obtained in the classical theory.

Putting q=2, =+ or , we nally see that the eld F can be identified with the topologically massive vector U (1) gauge eld F , whereas the eld F coincides with

F . This gives us the desirable P,T-invariant system [7]. Let us note here that the latter can be reformulated in terms of the gauge elds through the duality relation "F = F = @A @A. In this case the corresponding basic equations are of the second order, and can thus be compared with equations of motion for another P and T conserving system { gauge-non-invariant massive model. This one, the three-dimensional Procatheory, describes causally propagating massive eld excitations of spin polarizations + 1 and 1. So, the kinematical contents of the gauge-invariant and non-invariant cases are identical [7, 19]. However, our pseudoclassical model has led exactly to topologically massive gauge elds. The dierence between these systems may appear dynamically, when the vector elds interact with matter elds [20].

If we choose another ordering prescription for the quantum counterpart of the constraint function , we would have the same operator but with the constant term 3=2 changed for 3=2, where the constant species the ordering [21]. As a result, we would not that for 60;+3=2; 3=2 under appropriate choice of the parameter q (note in this case jqj 6 2) we have as a solution of the quantum constraints only one eld F or F_+ satisfying the corresponding linear dierential equation. This would lead to the violation of the P and T symmetries at the quantum level. For =+3=2 (or q=0) or =3=2 the physical states are respectively described by one scalar eld f(x) or f'(x), and for both these cases the discrete symmetries are broken.

We see that the same values of the parameter q, q = 2, which we have separated classically, turn out to be also special quantum mechanically: for these the number of physical states is maximal, so that the maximal global symmetry group can be realized on the physical state space, and only at q = 2 parity and time-reversal symmetries are conserved. This result indicates a profound relationship of discrete and continuous global symmetries.

4 Revealing dynam ical (super) sym metries

In what follows, we put q=2, the case q=2 can be achieved by obvious changes. To deal with the eld system obtained upon quantization of the pseudoclassical model (2.1), let us consider average value of the constraint operator b over an arbitrary state, hbi=y(x)b(x). We note that on the trivial equations of motion for unphysical scalar elds, f(x)=f'(x)=0, the space-time integral of this quantity, modiled on account of indenite metric of the state space, coincides with the action A for P,T-invariant system of topologically massive vector U(1) gauge elds. Switching to convenient matrix notations with Paulimatrices we can write this as follows:

where we have introduced a doublet of vector elds, $= (F_+; F_-)$ in transposed form, rede ned there the scalar product to hhii $= ^y$: and used generators (J_) = i" in the vector representation of the 3D Lorentz group, [J_;J_] = i" J_, J_J = 2. The procedure we have implemented in order to get the eld action A is reminiscent of the idea suggested in [22] for constructing a string eld theory action and subsequently developed in [23].

Continuous global sym m etries of this quantum system are generated by average values of the quantum counterpart of the third order nilpotent integrals of motion taking place at q=2. They are given by the expression $Q=\frac{1}{2}hh^{2}_{p}$, $ii=\frac{y}{x}(x)Q$ (x), where the quantum mechanical nilpotent operators

realize mutual transform ation of the physical states of spin +1 and $\,$ 1. Here we use the notation $\,=\,_1\,$ i $_2$ and $\,$ J $\,=\,$ J $\,$ (1) $\,$ iJ $\,$ (2), J $\,$ (1) $\,=\,$ J $\,$ e $\,$ (1). Commutation relation of these operators is

where $S = J^{(0)}$ 1 and $= J^{(0)}J^{(0)}$ 3. S is the spin operator corresponding to the average value of the quantum counterpart of the integral S, and is the operator associated with the projector onto the physical spin 1 states, $(1 + 2N_0)N_2$ (2 N_2). We have also

The operators Q reproduce the algebra of the quantum mechanical counterpart of the integrals B_+ . When considering the following linear combinations

we obtain that the quantum physical operators Q, = 0;1;2, form su(1;1) algebra,

The generators Q and the Casim ir operator C = Q $Q = \frac{3}{8}$ (S 2) of this algebra form also S(2;1) superalgebra [24],

The Casim ir operator takes the value C = 3=4 on the physical subspace given by two square-integrable transversal vector elds F_+ , F_- carrying spins 1 and +1.

We have thus revealed hidden SU (1,1) sym metry and S (2,1) supersym metry of the P,T-invariant quantum system of topologically massive vector U (1) gauge elds. This hidden dynamical symmetry leads to a non-standard super-extension of the (2+1)-dimensional Poincare group. To see this, one needs a covariant form of the above algebra relations [25]. A ctually, the quantities S and , as well as their combination Q $_0$, are expressed as covariant (scalar) operators, whereas Q $_i$ are given in terms of non-covariant quantities J $^{(i)}$, i=1;2. In the covariant form we found, the hidden (super)symmetry generators are presented by a rank-2 symmetric tensor, X = ie $^{(0)}$ e $^{(0)}$ Q $_0$ + X 2 , provided that its traceless and transversal part X 2 interchanges spins + 1 and 1 [25]. Together with the energy-momentum P and the total angular momentum M = " x P 1 1+ J 1 operators, they complete the set of generators of the superextended Poincare group ISO (2;12;1). The C asim ir operators

of this supergroup are P 2 and the superspin $=\frac{1}{2}$ (S +). The eigenvalues of the superspin are given by the set of numbers (1;0;0;0;0;1). Expressing the operator C through the superspin as C $=\frac{3}{4}$ (2 J $^{(0)}$ J $^{(0)}$ 1), we gain that the physical states are the eigenstates of the superspin operator with zero eigenvalue. Hence, the one particle states of the quantum P ,T -invariant system of topologically massive vector U (1) gauge elds realize an irreducible representation of the supergroup ISO (2;1½;1) labelled by the zero eigenvalue of the superspin. Similar properties have been elucidated for the double ferm ion system [26], which is also considered to be relevant to high-tem perature superconductivity [17].

5 Concluding remarks

In conclusion, with the help of the proposed pseudoclassical model (2.1) we have seen that the P,T-invariant system of topologically massive vector U (1) gauge elds has a rich set of hidden symmetries. It seems very likely that namely such 'internal properties' are responsible for critical phenomena in the corresponding models. Of course, it is not surprising too much, since the 3D topological mass terms [7] are originated from the -vacuum of 4D physics [27], and reject its rich and complicated structure. The pseudoclassical model itself turned out to be very interesting, having revealed the quantization of the parameter q and nontrivial superposition' of the discrete (P and T) and continuous (hidden SU (1,1) and S (2,1)) (super) symmetries. A principal question to be answered concerning these results is to understand the sense of quantumed analog of the hidden (super) symmetry generators. It is quite natural to expect that they should be generators of the correspondinged by monetry transformations [25]. One might further study the situation with P;T-invariant matter coupling and investigate what happens with the revealed hidden (super) symmetries.
