# Non-local conservation laws and ow equations for supersymmetric integrable hierarchies

#### A bstract

An in nite series of G rassm ann-odd and G rassm ann-even ow equations is de ned for a class of supersym m etric integrable hierarchies associated with loop superalgebras. All these ows commute with the mutually commuting bosonic ones originally considered to de ne these hierarchies and, hence, provide extra fermionic and bosonic sym m etries that include the built-in N=1 supersym m etry transform ation. The corresponding non-local conserved quantities are also constructed. As an example, the particular case of the principal supersym m etric hierarchies associated with the a ne superalgebras with a fermionic simple root system is discussed in detail.

## 1 Introduction

A rguably, one of the most important works in the subject of integrable systems was that of D rinfel'd and Sokolov [1], who showed how to associate integrable hierarchies of zero-curvature equations with the loop algebra of an ane Lie algebra. Their construction and its generalizations [2] provide a systematic approach to the study and classication of many integrable hierarchies previously described by means of pseudo-dierential Lax operators [3].

It is not dicult to extend the generalized D rinfel'd-Sokolov construction to the case of superalgebras. O ne sim ply has to replace the loop algebra by a loop superalgebra and include ferm ionic (G rassmann-odd) anticommuting elds among the dynamical degrees of freedom. However, the resulting hierarchy will not necessarily be supersymmetric. The rst authors who succeeded in nding a supersymmetric generalization of the DS construction were Inamiand K anno [4] who restricted to the class of a ne superalgebras with a fermionic simple root system. Since they made use of the principal gradation of the loop superalgebra in an essential way, their work has to be viewed as the direct generalization of the original DS construction. More recently, Delduc and Gallot [5] realized that it is possible to associate a supersymmetric integrable hierarchy of the DS type with each constant graded odd element of the loop superalgebra whose square = [;]=2 is semi-simple, a condition that is obviously satis ed in the cases considered by Inamiand Kanno.

A common feature of the hierarchies constructed in [4] and [5] is that they consist only of bosonic ow equations. This is in sharp contrast with the supersymmetric extensions of the KP hierarchy (SKP) which always include both Grassmann-odd and Grassmann-even ow equations [6]. This observation led Kersten to not and in nite set of fermionic non-local conservation laws [7] for the supersymmetric extension of the KdV equation obtained by Manin and Radulas a reduction of the SKP hierarchy [6]. A few years later, Dargis and Mathieu showed that they actually generate an in nite sequence of non-local Grassmann-odd ows [8] (see also [9]).

The aim of this paper is to show that the same is true for the whole class of supersym m etric hierarchies of [5] by constructing an in nite series of non-local (bosonic and ferm ionic) ow equations and conserved quantities which generalize those obtained in [7,8] for the supersym m etric K dV equation. The new ows close a non-abelian superalgebra that has to be regarded as an algebra of sym m etry transform ations for the hierarchy. It includes the built-in N=1 supersym m etry transform ation and, in some cases, extended supersym m etry transform ations.

Following ref. [5], a generalized supersymmetric hierarchy of equations can be associated with a fermionic Lax operator of the form L = D + q(x; ) +, where q(x; ) is an N = 1 G rassmann-odd super eld taking values in a particular subspace of the loop superalgebra, D is the superderivative, and is a constant graded odd element whose square = [; ]=2 is semi-simple. D elduc and G allot dened an innite set of mutually commuting bosonic ows and conserved quantities associated with the elements in the centre of E is a constant or E of E and E in our construction, there will be a non-local ow equation and conserved quantity for each (fermionic or bosonic) element in E with non-negative grade. These ows close a non-abelian superalgebra isom or phic to the subalgebra of E formed by the elements with non-negative grade.

The authors of [2] distinguished between (bosonic) generalized D S hierarchies of type-I and type-II. The generalized D S hierarchies are associated with bosonic Lax operators of the form  $L=\mathbb{Q}_x+\mathbb{Q}(x)$ , where  $\mathbb{Q}(x)$  is a bosonic eld taking values in a subspace of a loop algebra and is a constant sem i-simple graded element. Then, the hierarchy is of type-I or type-II depending on whether is regular or not, i.e., a type-II hierarchy is associated with a sem i-simple element such that K=K er(ad) is non-abelian. In [5], the analogue of L is the even Lax operator  $[L^2;L]=2=D^2+\mathbb{Q}(x;)$ . Therefore, from this point of view, all the supersymmetric hierarchies of [5] have to be considered as type-II: is in K but [;]=2 0, which proves that K is non-abelian. In fact, it is straightforward to extend our construction of non-local ow equations and conserved quantities to all the type-II bosonic hierarchies of [2].

The paper is organized as follows. In section 2 we brie y sum marize the supersym m etric hierarchies of Delduc and Gallot, making particular emphasis on the possibility of having ferm ionic local conserved quantities. In the next two sections we present the construction of non-local ows, sec. 3, and conserved quantities, sec. 4. We also characterise the owswhich are compatible with the supersymmetry transformation, and the conserved quantities which are supersymmetric. As an example, in section 5 we give a very detailed description of the non-local ows and conserved quantities for the principal hierarchies originally considered by Inami and Kanno, i.e., those associated with superalgebras with a ferm ionic simple root system. We show that the complete set of local and non-local ow equations are associated with a subalgebra of the superoscillator algebra constructed by Kac and van de Leur in [10], which is the principal Super Heisenberg algebra' of a<sub>1 il</sub> [11]. This relationship generalizes the well known role of the principal Heisenberg algebra in the original DS hierarchies, which could be used to derive a -function form alism for these hierarchies following the method of [12, 13, 14] and, especially, to construct solutions for the equations of the hierarchy using super vertex operator representations. It is also remarkable that, in the particular case of the ane superalgebras A (m; m) (1), there is a local G rassmann-odd ow D  $_1$  that, together with D , closes an N = 2 supersymmetry algebra, in agreement with the results of [15, 5]. In section 6 we apply our construction to the supersymmetric K dV equation in order to show how the results of [8] are recovered. As a bonus, we get additional non-local conserved quantities not obtained in previous works. Our conventions and some basic properties of Lie superalgebras are presented in appendix B. Since we are not aware of any reference where they are available, we have included in this appendix detailed expressions for the matrix-representations of the a ne Lie superalgebras with ferm ionic simple root systems which are needed for the understanding of section 5. Recall that this class of superalgebras play an important role in supersym m etric Toda theories and supersym m etric ham iltonian reduction and, hence, these expressions should be useful beyond the scope of this paper. Our conclusions are presented in section 7.

## 2 Review of the Delduc-Gallot construction

Following [5], a supersymmetric (partially modied) K dV system can be associated with four data (A;  $d_1$ ;  $d_0$ ; ). The rst, A, is a twisted loop superalgebra

attached to a nite dimensional classical Lie superalgebra G together with an automorphism of nite order. The second and third,  $d_1$  and  $d_0$ , are derivations of A that induce two compatible integer gradations:  $[d_0;d_1]=0$ . Then, the subsets  $A_m^n=A_m\setminus A^n$ , where  $A_m=fX$  2 A j  $[d_0;X]=m$  X g and  $A^n=fX$  2 A j  $[d_1;X]=n$ X g, de ne a bi-grading of A. We will assume that

which means, in the notation of [5], that we restrict ourselves to the K dV type system s'. Finally, is a constant odd element of A with positive  $d_1$ -grade, i.e.,  $[d_1; ] = k$  with k > 0, whose square  $= \frac{1}{2}[; ]$  is sem i-simple:

Therefore, K er(ad) is a, generally non-abelian, subalgebra of A and we will denote by Z its centre, which contains only even elements of A.

The dynam ical degrees of freedom will be super elds taking values in the tensor product  $\underline{A}$  of A with some G rassmann algebra  $Gr = Gr_{\overline{0}}$   $Gr_{\overline{1}}$ . An element in this space is called even if it belongs to  ${}_{+}A = A_{\overline{0}}$   $Gr_{\overline{0}}$   $A_{\overline{1}}$   $Gr_{\overline{1}}$ , and odd if it belongs to  $A = A_{\overline{0}}$   $Gr_{\overline{1}}$   $A_{\overline{1}}$   $Gr_{\overline{0}}$ . Let  $T^a$  be a set of basis vectors of A. Then, the (super) commutator of two elements  $A = {}_{a}A_{a}T^a$  and  $B = {}_{a}B_{a}T^a$  of  $\underline{A}$  will be defined as

Then, due to the non-degeneracy condition (2.4), for any q 2 Q there is a unique q-dependent gauge transform ation such that the image  $q_y = q_y$  (\*) is in

in other words,  $Q_V$  is isomorphic to Q=N. When regarded as functions of  $q \ge Q$ , the components of  $q_V$  are super-dierential polynomials that freely generate the set of gauge invariant polynomials on Q, and  $Q_V$  is said to specify a D rinfel'd-Sokolov gauge.

The construction of [5] relies on the following version of the dressing procedure:

This result is used to de ne an in nite number of commuting ows on Q = N associated with the elements of  $Z^{-0}$  as follows. For each constant b 2  $Z^{-0}$ , let us de ne the even

where P  $_0$  and P  $_{<0}$  are the projectors on the subalgebras A  $_0$  and A  $_{<0}$ , respectively, and R  $=\frac{1}{2}(P_{0} P_{<0})$  is a (super) classical r-m atrix.

In the following, it will be useful to introduce the notation  $K = K \operatorname{er}(\operatorname{ad})$ . Let us consider the evolution of H in (2.16), which reads

Then, an in nite set of local conservation laws can be associated with the components of H in  $\mathbb{R}$ . To be precise, let  $[K;K]^2 = \text{fb 2 } K \text{ jh}[K;K]$ ; bi = 0g. Since the restriction of the bilinear form to K is non-degenerate,  $[K;K]^2$  is conjugate to  $\mathbb{R}^2$  with respect to h; i. Then, for each  $[K;K]^2$  there is a local conservation law

A particular subset of  $[K;K]^2$  is Z, the centre of K, which obviously satis esh[K;K]; Z i = 0 due to the invariance of the bilinear form. Therefore, since Z contains only even elements of A, the components of H corresponding to Z provide an in nite set of even bocal conserved quantities, which are the H am iltonians corresponding to the owsde ned by (2.17). Namely, for b 2 Z 0,

However, in general, it is not true that  $Z = [K;K]^2$  or, in other words, that Z and  $R^2$  are conjugate with respect to h; i. Consequently, eq. (2.20) m ight provide more local conservation laws than those associated with Z and given by (2.21). In particular, and in contrast with Z, the vector subspace  $[K;K]^2$  can contain odd elements of A and, then, eq. (2.20) would provide G rassmann-odd local conserved quantities.

All this suggest that it should be possible to generalize the construction of [5] to de ne new ows associated somehow with the elements of  $[K;K]^2$  that are not in Z. In particular, it should be possible to de ne fermionic ows associated with the odd elements of  $[K;K]^2$ .

## 3 Non-local ows

In this Section, we will associate ow equations with all the elements of  $K = K \operatorname{er}(\operatorname{ad})$ . In general, these equations will be non local, i.e., the evolution of qwill not be given by a super-di erential polynomial of q. Moreover, instead of commuting among them selves, the resulting owswill close a non-abelian superalgebra isomorphic to  $K^{-0}$ .

## 3.1 Form aldressing transform ations

Our construction makes use of a di erent version of the formal dressing method inspired by the work of W ilson on the tau-function approach to hierarchies of KdV type [13, 12]. First of all, for any super eld!  $2 + K^{<0}$ , notice that the transformation

The super eld! is a non-local functional of q, and the constraints involve the components of H in K  $^{\rm k}$ .

Since the proof is quite involved, it will be presented in Appendix A.

It is not easy to give the precise form of the constraints on H <sup>k</sup> required by Proposition 1. However, their nature can be clarified by considering the transform ation (3.3) acting on the even Lax operator

that m anifests the constraints  $h^0 = 0$ , which are well known in the context of the taufunction approach to (bosonic) hierarchies of K dV type [12].

## 3.2 The ow equations

Eq. (3.11) provides a one-to-one m ap between the components of the (gauged xed) Lax operator and some components of and, in our construction, the owswillbede ned as ow equations for .

## 3.3 Supersym m etric ow equations

One of the main motivations of the work of Delduc and Gallot in [5] was to obtain supersymmetric hierarchies. In other words, hierarchies whose ow equations are compatible with a supersymmetry transformation relating commuting to anticommuting elds.

Since both the construction of [5] and ours are form ulated directly in N=1 superspace with coordinates  $\mathbf{x}=(\mathbf{x};)$ , there is a built—in supersymmetry transformation induced by the covariant derivative:  $^{SUSY}\mathbf{q}=D\mathbf{q}$ , where is any constant G rassmann-odd parameter. By construction, and according to eqs. (3.21), (3.11), (3.22), and (2.10)

Remarkably, although they are generally non-local, the supersymmetric ows can be written in terms of the same (super) classical r-matrix R used in eq. (2.17).

However, it is important to notice that, a priori, nothing prevents the existence of other local ows than those associated with Z. In particular, there could be G rassmann-odd local ows. An example is provided by the the following Lemma.

# 4 Local and non-local conserved quantities

In this section, we will construct an in nite number of local and non-local conserved quantities with respect to the bosonic ow equations (2.17) associated with Z, the centre of K = Ker(ad). We will also investigate which of them are supersymmetric.

Since most of the following expressions involve non-local terms, it is necessary to specify the boundary conditions. We will restrict ourselves to hierarchies where the super eld q = q(x) goes rapidly to zero at x = 1. Then, since F and H in Lemma 1 are super-dierential polynomials of q, they also vanish at x = 1:

This is the reason why their asymptotic values do not vanish in spite of the boundary conditions (4.1). However, some of the components of!  $j_{k=1}$  provide the local conservation laws given by (2.20).

At this stage, we would like to make a comment about partial integrations in expressions with non-local terms. It is clearly hot' true that  $^R$  dx  $^R$  dx  $^R$  (x) = 0 if P (x) is a generic non-local expression; for example, if P (x) =  $^R$  q the statement is obviously false. If, in agreement with (4.1), we choose boundary conditions such that all local expressions vanish su ciently fast at x = 1 and we take P (x) = L (x)N (x), where L (x) is a local expression while N (x) may be non-local, then the statement is true. This is clear since

Finally, it is worth noticing that, according to theorem 3, the non-local supersym metric conserved quantities are in one-to-one relation with the supersym metric ow equations. However, we have not been able to not a deeper relationship between them where, for example, J could be understood as the generator of the ow D.

# 5 Principal Hierarchies

In this section we will restrict ourselves to consider supersymmetric K dV systems in which is a principal ferm ionic element of A, i.e.,

where the sum is over all the simple roots of the algebra, and the  $a_i$  are non-zero numbers. A necessary condition for the existence of such an element is that A is equipped with a fermionic simple root system, and in table 2 we give a complete list of all such a ne Lie superalgebras; for future reference the table contains also the bosonic subalgebras.

However, we will start by giving two lem mas which apply to the general case, namely:

## 5.1 Principal Elements

Let now be a principal element of A, where A is one of the ane Lie superalgebras listed in table 2 except D (2;1; ); we have chosen not to consider this exceptional superalgebra in detail in order to keep the exposition as simple as possible, but it can be treated using the same methods as the other algebras. We write a grading d in the form  $(s_0; s_1; \ldots; s_r)$ , where  $s_i$  is the grade of the generator corresponding to the simple root i. Then, we call principal hierarchies those associated with a principal element , the principal grading  $d_1 = (1;1; \ldots; 1)$ , and another gradation  $d_0$ . It is convenient to distinguish the following cases:

- {  $d_0 = (1;0;0;:::;0)$  is the hom ogeneous grading. This corresponds to what we will call SK dV type hierarchies.
- $\{d_0 = d_1 \text{ are both the principal grading. } We will call the corresponding hierarchies Sm K dV hierarchies, supersymmetric modi ed K dV hierarchies.$
- {  $d_0$  is in between  $^4$  the homogeneous and the principal gradings. The resulting hierarchies are the Spm K dV hierarchies, supersymmetric partially modiled K dV hierarchies.

The choice of  $d_0$  is always restricted by the non-degeneracy condition (2.4). When is principal, this condition is satisted both for the SKdV and SmKdV type hierarchies, except for the algebra A  $(m;m)^{(1)}$ , where the choice  $d_0 = (1;0;0;:::;0)$  does not satisfy (2.4). Instead we can consider a m in in ally m odied' SpmKdV hierarchy; we can for example follow [5] and take  $d_0 = (1;0;0;$ ; (0;0;1).

Since all bosonic simple roots of  $A_0$  can be obtained as sum s of two simple roots of  $A_1$ ,  $A_2$  is a principal element in  $A_3$ . is therefore regular in  $A_3$ , and according to lemma 5 regular in  $A_3$ . The problem of nding the even subalgebra K  $_0$  of K, and of nding explicit realizations of its elements, has therefore been reduced to the problem of nding the kernel of ad ( ) in the case where is a principal element in a (bosonic) Lie algebra G. This question has been studied in e.g. [1]. The elements of ker(ad ( )) are in one-to-one correspondence with the set of exponents fe $_i$ g of G, and are essentially of the form  $_i$  for m ore details and for the exceptions see appendix C 1 and [1].

The task which is left is to not the odd subspace K  $_1$  of K. In order to do this, consider the covering hom om orphism , the mapping which sends the a nealgebra A=L(G;) G C[;] into the corresponding nite algebra G by setting equal to 1 (or any nonzero number). Take a root-basis for G such that  $(K_0)$  is the Cartan subalgebra. As shown in corollary 2, any two (ferm ionic) roots and such that E:E=2  $(K_1)$  must satisfy E:E=2 E:E=2

In appendix C 1 we show that together with the elements of  $[;K_0]$ ,  $[[;K_0];K_0]$ , etc., saturate this limit, except in the case of the algebra A  $(2m_1;2m_1)^{(2)}$ . In this last case, the bound allows two extra sets of elements of  $K_1$  which we not by explicit calculations, see eq. (C 1).

The elements of K  $_1$  turn out to fall naturally into two distinct classes of elements (four in the case of A (2m  $_1$ ;2m  $_1$ ) $^{(2)}$ ). We denote the elements in these two (four) classes by  $_i$  and  $_i$  (plus  $_i$  and  $_i$ ) respectively, where i is the principal grade. A convenient way to parametrize the grades is to write  $_{1+2i}$  and  $_{1+2i}$ , where for A (m;m) $^{(1)}$  i 2 Z, and for all other algebras i 2 2Z + 1. We identify  $= _1$ . Not all of these ows are supersymmetric, i.e., not all are compatible with the supersymmetry transformation. A coording to theorem 3, the supersymmetric ows are those corresponding to elements in  $< = \ker(ad)$ , i.e., the elements in the centre plus

We have used the fact that for the principal hierarchies, the only even elements which commute with are those in the centre, or  $(K_{0} n Z) \setminus < = ;$ , as is evident in appendix C 1.

We have given here the commutation relations of the subalgebra  $K_1$  [ Z of K. U sing the explicit expressions given in the appendices it is straightforward to not the commutation relations for all elements of K, and thereby also the algebra generated by all the possible ows. The result is that K is a subalgebra of the principal super H eisenberg algebra of  $a_{1,j}$  without central extension, which is isomorphic to the ane superalgebra  $gl_{1,j}$  [10, 11]. This generalizes the well known role of the principal H eisenberg algebra in the KP hierarchy and in the original DS (bosonic) hierarchies. We expect that this relationship helps to derive a tau-function formalism for these hierarchies in analogy with refs. [12, 13, 14] and, especially, to construct solutions for the equations of the hierarchy using super vertex operator representations; in particular, multi-soliton solutions.

## 5.2 Special Cases

### 5.2.1 A (m; m)<sup>(1)</sup>

The hierarchies related to the algebras A (m;m)  $^{(1)}$  have been studied previously in e.g. [5,15], and it is known that in these cases the supersymmetry can in fact be extended to an N = 2 supersymmetry. In our formalism, there is a very natural explanation for this fact: we see from the list above that there is a fermionic element  $_1$  2 K which satis es  $_1^2$  = . It follows from lemma 4 that D  $_1$ , the corresponding fermionic ow, is a local ow, and from theorem 1 that  $(D_1)^2$  =  $(0)_2$  =  $(0)_2$  and it is therefore clear that D  $_1$  = D and iD  $_1$  satis es the N = 2 supersymmetry algebra.

In this case, as mentioned above, K in eq. (2.19) contains ferm ionic elements. A coording to eq. (2.20), this implies that we have an in nite number of local conserved ferm ionic quantities. Moreover, explicit calculations show that  $[K_0; i] = [K_0; i] = 0$ . This, together with the commutations relations (5.2), shows that  $[2m \ 1; K^{<0}] = K^{<0}$ , and therefore according to lemma 4 the corresponding ow  $D_{2m-1}$  is local.

# 6 Example: SK dV

We will demonstrate the application of our construction in the example of SK dV, the supersymmetric version of the usual K dV hierarchy. This hierarchy has previously been studied by many authors, mainly in the formalism of super pseudo-dierential operators [6, 17, 8, 9, 18], but also using Lie superalgebras [4]. There are several advantages in taking SK dV as example: it is one of the simplest possible examples; we can compare the results of our construction with the results obtained using other methods; and we can demonstrate to which extent our method gives new results even for a hierarchy that has already been considerably studied.

The SK dV hierarchy is the supersymmetric hierarchy de ned by taking to be the

principal element in A  $(0;1)^{(2)}$  [4] <sup>7</sup>, and to take  $d_1$  to be the principal grading  $d_1$  = (1;1), and  $d_0$  to be the hom ogeneous grading,  $d_0$  = (1;0)

Elements  $\times$  2 A  $(0;1)^{(2)}$  can be realized as 3 3 m atrices of the form:

In this realization we can write the principal gradation  $d_1$  as ad  $(e_{2;2} e_{3;3} + 2 \frac{\theta}{\theta})$ , where  $e_{i;j}$  denotes the matrix with 1 in the i;j'th position, and zero elsewhere, while the homogeneous gradation  $d_0$  is ad  $(\frac{\theta}{\theta})$ .

A  $(0;1)^{(2)}$  is one of the two only examples where is not the direct sum of two terms which are each a principal element in a simple part of the even subalgebra (the other is D  $(2;1)^{(1)}$ ). Instead is here a direct sum of a part which is principal in A  $_1^{(1)}$ , and a part which lies in the U  $(1)^{(1)}$  subalgebra. This gives only trivial modi cations to the procedure, however.

(\*) is a super eld which we can expand on elds as (x) = (x) + u(x), where u(x) is the usual K dV function and (x) is its superpartner.

U sing the de nition (3.27) for the bosonic ows corresponding to the elements of Z , we not the ow corresponding to  $b_6$  to be:

This is exactly the non-local ow found in [8], where the ferm ionic owswere dened using pseudo-dierential operators as ows related to the fourth root of the Lax operator. We can verify by direct calculation that this ow satisfies D $_3^2 = 0_6$ .

In section 4 we have shown that if we impose suitable boundary conditions on the elds, in this case assuming that (x) goes su ciently fast to zero for x! 1, then the components of !  $j_{k=1}$  are conserved quantities under all bosonic ows. It is instructive to check explicitly that this is true with respect to  $\theta_6$ , since in order to show conservation we already need to use partial integration with non-local quantities, as described on page 13. We have done this calculation down to grade 5. In this case the conservation depends on a considerable number of cancellations of terms, giving a non-trivial check of the conservation of !  $j_{k=1}$ . Here we will restrict ourselves to show the conservation of the components of grade 1, 2 and 3 only.

A coording to (4.10), the conserved quantity associated with =  $_1$  is

! has two di erent term s of principal degree 2, which gives rise to two independent G rassm an-even conserved quantities. The rst one is I, and the second is given by

Our construction ensures that it is conserved by all the bosonic ow equations of the hierarchy. In particular,

## 7 Conclusions

For the entire class of supersym metric Drinfel'd-Sokolov integrable hierarchies constructed by Delduc and Gallot in [5], we have de ned an in nite sequence of additional Grassmann-odd and Grassmann-even ow equations, which are given by non-local equations, i.e., which are not de ned by super-di erential polynomials of the dynamical variables. In this

sense, they have to be seen as generalizations of the ferm ionic ows constructed by D argis and M athieu for the supersymmetric K dV equation in [8]. All these ows commute with the bosonic ones originally considered in [5] and, hence, provide new ferm ionic and bosonic symmetry transformations for the hierarchy. In particular, one of the ferm ionic ows corresponds precisely to the built-in supersymmetry transformation and, in some cases, others provide additional supersymmetries. The new ow equations do not commute among them selves; instead, they close an in nite non-abelian superalgebra.

The supersym m etric hierarchies of [5] are associated with a (twisted) loop superalgebra A, and two compatible gradations  $d_1$  and  $d_0$ . They are defined by means of fermionic Lax operators of the form  $L=D+q(x;\ )+$  where  $q(x;\ )$  is a N=1 super eld taking values in a subspace of A, D is the superderivative, and is a constant  $d_1$ -graded element of A whose square  $=[\ ;\ ]-2$  is semi-simple. Then, following our construction, there is a non-local ow associated with each element in K=K er (ad) with non-negative  $d_1$ -grade, i.e., in  $K^{-0}$ , and these lows close an infinite superalgebra isomorphic to  $K^{-0}$ . In contrast, the mutually commuting lows originally considered by the authors of [5] are associated with the elements in the centre of  $K^{-0}$ , which contains only even elements. Since the built-in supersymmetry transformation  $S^{SUSY}=D$  is identified with the low equation associated with the elements in  $K^{-0}$  that commute with  $M^{SUSY}=M$ 

We have also constructed an in nite series of non-local quantities which are conserved by all the commuting bosonic ows associated with the centre of  $K^{-0}$ . To be precise, there is a non-local conserved quantity for each element in  $K^{-0}$ , and only those conserved quantities associated with the elements that commute with are supersymmetric. Therefore, there is a one-to-one relationship between non-local ow equations and non-local conserved quantities, which suggest that the latter could be understood as the generators of the former. In the case of the supersymmetric K dV equation, this relationship was established in the work of D argis and M athieu B and C am os D by using the super pseudo-di erential Lax operator formalism. In our case, the precise nature of this relationship is one of the open questions that is left to be the subject of future work.

As an example of our construction, we have worked out in detail the structure of the non-local ow equations and conserved currents for the, so called, principal hierarchies, which are associated with the a ne superalgebras that have a ferm ionic simple root system; namely, those listed in table 2. Then,  $d_1$  is the principal gradation and is the cyclic element, i.e., the sum of the (a ne) simple root generators. Actually, these hierarchies can be seen as the direct generalization of the original Drinfel'd-Sokolov construction, and their commuting bosonic owswere de ned rst by Inamiand Kanno [4, 15]. In order to proceed, we have constructed explicit matrix-representations for the anne Lie superalgebraswith ferm ionic simple root system swhich, as far as we know, are not available in the literature. Using them, we have shown that  $K = K \operatorname{er}(\operatorname{ad})$  is a subalgebra of the in nite superoscillator algebra constructed by K ac and van de Leur in [10], i.e., of the principal Heisenberg superalgebra of a<sub>1 il</sub> without central extension [11]. The precise form of the subalgebra depends on the particular superalgebra we have started with. This generalises the well known role of the oscillator and Heisenberg algebras in the KP hierarchy [19] and the generalized hierarchies of K dV type [2, 12, 14]. It also suggests the possibility of understanding our hierarchies of local and non-local ows as reductions of the super KP hierarchy of super H irota bilinear equations constructed in the second article of [10].

Finally, let us comment about the construction of solutions for the equations of these hierarchies. A coording to (3.21), a particular solution is specified by which satisfies the system of rst order super differential equations given by (3.15). in the parlance of the second and third articles in [12],  $_0$  is the vacuum' solution of the associated linear problem . Eq. By analogy with the bosonic hierarchies, the elements obtained by exponentiating super vertex operators should be related to the multi-soliton solutions [12].

Eq. (7.2) can be easily solved for the principal hierarchies. To be specied, let us restrict ourselves to the lowest associated with the elements of the form  $_{1+2i}$ ,  $_{1+2i}$ , and  $b_i = ^{\frac{1}{2}}$ , which is a subset of  $K_1$  [  $Z = K^{-0}$ ; the resulting expressions can be easily modified to cover the complete set of lowes. # B Lie superalgebras

In this appendix we will recall a few basic facts about Lie superalgebras which are of special relevance to this paper. For a complete introduction to the subject we refer to e.g. [16, 20]

#### B.1 Bilinear Form

A Lie superalgebra is a  $\mathbb{Z}_2$ -graded algebra  $G = G_0$   $G_1$ , equipped with a graded commutator, which satisfies the graded Jacobi identity. We are here interested only in the contragredient or basic classical Lie superalgebras, which are those that are equipped with a non-degenerate bilinear form h; i which is invariant, i.e.:

## B.2 Root Systems of Ane Lie Superalgebras.

In this section, we will recall some useful facts about the root systems of Lie superalgebras. We will give the standard realizations of the root systems of some nite Lie superalgebras, which is useful for the calculation of the signature of the root-spaces, see page 17, and we

will give the ferm ionic sim ple root system s, as well as explicit m atrix realizations of the principal elements .

M ost of the construction in section 5 can be done without knowing the precise form of the principal element  $\,$ . In general, it is su cient to know that we can  $\,$ nd a matrix representation where  $\,$ takes the form

There are, however, a few cases where it turns out to be necessary to actually not an expression for in order to do explicit calculations. Explicit calculations are necessary to show that the 'spurious' element of  $K_0$  in the case of D (m + 1;m) (1) is an element of D, see page 34, and to not the extra elements of D and their commutation relations in the case of D (2m 1;2m 1) (2), see page 33.

At the same time, we are not aware of any reference in which one can not explicit expressions for the matrix-representations of ferm ionic simple root systems of a ne Lie superalgebras. Since Lie superalgebras with ferm ionic simple root systems are important in several applications of Lie superalgebras, for example in supersymmetric Toda theory or supersymmetric hamiltonian reduction, we have chosen to give these expressions in some detail.

Note that there are other matrix realizations of Lie superalgebras which may be useful when studying supersymmetric integrable hierarchies, see [21].

In all cases  $"_1; :::; "_n$  denotes an orthonorm albasis of a vector space  $V_+$ , while  $_1; :::; _m$  denotes a basis of a vector space  $V_-$  with negative denite inner product, normalized so  $_i _j = _{ij}$  (where  $_{ij}$  is the usual K ronecker delta-symbol). In addition,  $e_{i;j}$  will denote a matrix (the dimensions will be clear from the context) with one in the i;j'th position, and zero elsewhere.

For B (n;m) and D (n;m) the root space is  $V_+ = V$ . In the case of A (n 1;m 1), the root space is the subspace of  $V_+ = V$  of co-dimension 1, orthogonal to  $v_+ = v_+ = v_$ 

The upper lim it on the dimension of  $(K_1)$  is given by  $2 \text{ m in } (d_+^0; d^0)$ , where  $(d_+^0; d^0)$  is the signature of the root space of the superalgebra. If we denote by  $(d_+; d) = (\dim(V_+); \dim(V))$  the signature of  $V_+ = V$ , then clearly  $\min(d_+^0; d^0) = \min(d_+; d)$ , and we can therefore safely use the signature of  $V_+ = V$  as the upper  $\lim_{N \to \infty} \lim_{N \to \infty} \lim_{N \to \infty} (d_+, d)$ , case.

We will now give the ferm ionic simple root systems and the explicit matrices corresponding to the principal elements considered in this paper. Let us remind the reader that the simple root system for an untwisted a ne Lie superalgebra can be chosen to consist of the simple root system of the corresponding nite Lie superalgebra, with the addition of an a neroot', which can be realized as E , where is the loop-parameter, and E is the generator corresponding to minus the highest root. In the case of an a ne Lie superalgebra twisted with an automorphism of order k, the automorphism gives rise to a grading of the Lie superalgebra  $H = \frac{P}{i=0}^k G_i$  where  $G_0$  is invariant under , and each  $G_i$  forms a representation of  $G_0$ . As a simple root system of the twisted a ne Lie superalgebra we can take a simple root system of  $G_0$  in addition to the a ne root' which we can realize as E, where E is in this case the (unique) lowest weight in the  $G_0$ -representation provided by  $G_1$ .

 $\ker(\operatorname{ad}(_i))$  are  $\operatorname{well} \operatorname{know} n$ , and are generated by the elements  $_i^{e_j}$ , where  $\operatorname{fe}_j g$  is the set of exponents of  $G_i$ , with the following exceptions:

- 1)  $D_m^{(1)}$  has exponents n=1;3;5;:::;2m-3 and  $m-1 \mod 2m-2$ . There is an element  $e_{2m-2}$  of  $K_0$  corresponding to the spurious exponent m-1, which is not associated to m-1.
- 2)  $A_{2m-1}^{(2)}$  has exponents  $n=1;3;5;:::;4m-3 \mod 4m-2$ . The element of  $K_0$  corresponding to the exponent 2m-1 is  $2m-1-1 \mod 4m-1$ .

We have collected the exponents of the relevant bosonic a ne Lie algebras in table 3, and we refer to [1, 22] for further details.

Taking commutators [;K  $_0$ ], [[;K  $_0$ ], etc. we can now construct more elements of K  $_1$ . The elements found in this way were summarized on page 17. In table 4 we compare the number of these generators, modulo twice the Coxeter number, with the maximalpossible number 2 m in (d,;d) found in the previous subsection. We see that the number of fermionic generators saturate the limit in all cases except A (2m 1;2m 1) $^{(2)}$ . In this last case we not by explicit calculations two extra series of fermionic generators

### C.2 Commutation Relations

 $K_0$  is an Abelian algebra, so we need to nd only the commutation relations  $[K_1; K_1]$  and  $[K_0; K_1]$ .

Remarkably, we not that we can always choose the elements  $_{1+2i}$  and  $_{1+2i}$  to be

Note that  $(^{\sim})^i = \frac{i}{2} = \frac{i}{1}$  and  $^{\sim}(^{\sim})^i = ^{\sim}\frac{i}{1} = \frac{i}{2}^{\sim}$ . One can easily verify that the commutation relations of these generators are the ones given in equation (5.1). In the case of the algebra A (2m 1;2m 1)<sup>(2)</sup>, where we have extra ferm ionic generators  $_i$  and  $_i$ , explicit calculations give the commutation relations eq. (5.2).

In general K  $^{2i}$  is generated by  $c_{2i} = \frac{i}{1} + 0$   $^{9}$  and  $d_{2j} = 0 + \frac{j}{2}$  where i and j are exponents of respectively  $G_1$  and  $G_2$ , and Z  $^{2i}$  by  $b_{2i} = c_{2i} + d_{2i}$ . The exceptions, which follows directly from the exceptions in the bosonic case described in the previous section, are:

- 1) For the algebra D  $(m + 1; m)^{(1)}$  there is an 'extra' element  $e_{2m} + 0.2$  K  $_0$  which is not related to powers of  $_i$ . In the matrix realization given in section B 2.6,  $e_{2m}$  has the same form as  $_{2m-1}$  in equation (C 2).
- 2) For the algebra A (2m  $^{1}$ ; 2m )  $^{(2)}$ , K  $^{4m}$   $^{2}$  is generated by

M oreover, a direct calculation shows that in the algebras A (2m 1; 2m)  $^{(2)}$  and A (2m 1; 2m 1)  $^{(2)}$  it is possible to choose the normalizations  $c_{4m}$   $_2 = a_{4m}$   $_2$   $c_{4m}^0$   $_2$  and  $d_{4m}$   $_2 = b_{4m}$   $_2$   $d_{4m}^0$   $_2$  such that these elements also satisfy the commutation relations given above.
