## A bstract

A treatm ent of the spin-statistics relation in nonrelativistic quantum $m$ echanics due to Berry and Robbins $\mathbb{P}$ roc. R . Soc. Lond. A (1997) 453, 1771-1790] is generalised w thin a group-theoretical fram ew ork. T he construction of $B$ erry and $R$ obbins is re-form ulated in term s of certain locally at vector bundles over n-particle conguration space. It is shown how fam ilies of such bundles can be constructed from irreducible representations of the group $S U(2 n)$. T he construction of $B$ erry and $R$ obbins, which leads to a de nite connection betw een spin and statistics (the physically correct connection), is show $n$ to correspond to the com pletely sym $m$ etric representations. T he spin-statistics connection is typically broken for generalSU (2n) representations, which $m$ ay adm it, for a given value of spin, both bose and ferm istatistics, as well as parastatistics. The determ ination of the allowed values of the spin and statistics reduces to the decom position of certain zero-w eight representations of a (generalised) W eyl group of $S U(2 n)$. A form ula for this decom position is obtained using the $L$ ittlew ood $R$ ichardson theorem for the decom position of representations of $U(m+n)$ into representations of $U(m) \quad U(n)$.

## 1 Introduction

In nonrelativistic quantum $m$ echanics, the spin-statistics relation speci es the behaviour ofm any-body w avefunctions for indistinguishable particles under the exchange of a pair of particle labels, and asserts that the wavefiunctions either rem ain the sam e or change sign according to whether the spin of the particles, $s$, is integral or half-odd-integral. N onrelativistic quantum $m$ echanics can be form ulated in a logically consistent way without the spin-statistics relation, or else, w ith the w rong (ie, physically incorrect) spin-statistics relation. Therefore, if one is to derive the spin-statistics relation from within a nonrelativistic theory, the nonrelativistic theory $m$ ust be reform ulated, w ith postulates di erent from the standard ones. W hether such a reform ulation serves to explain the spin-statistics relation is, to som e extent, a $m$ atter of judgem ent, and depends on the naturalness and sim plicity of the assum ptions introduced.

Such a reform ulation was presented by Berry and R obbins [B] (referred to in what follow sas BR). In BR, the representation of spin was made to depend on position so that, in contrast to the standard form ulation, the $n$-particle wavefunction was single-valued on con guration space. The statistics of the wavefunction was determ ined by a topological property of this position-dependent spin representation. A calculation showed that the statistics were in accord w th the physically correct spin-statistics relation. The construction was based on Schw inger's representation of spin as num ber states of harm onic oscillators. Its im plem entation assum ed w thout proof the solution of a certain topological problem; a solution was subsequently found by Atiyah [2]. The extension to relativistic wave equations was discussed by A nandan [1].

To be com pelling, a derivation of the spin-statistics relation should be based on general physical and $m$ athem atical principles, rather than a particular construction. In BR, it was suggested that certain properties of the construction introduced therein $m$ ight be su cient to ensure the correct spin-statistics relation. Later, it was shown that this is not the case [4]), as altemative constructions exist which possess these properties but yield the wrong statistics. T hus, a nonrelativistic derivation of the spin-statistics relation from general principles rem ains to be established along these lines. For a discussion of other nonstandard approaches to the spin-statistics relation, see [5, 6]. O ur purpose here is to investigate a certain group-theoretical generalisation of the construction in BR.W e begin in Section 2 by fram ing the underlying requirem ent, nam ely that wavefunctions be single-valued, in a geom etrical context. The setting for the quantum description of n indistinguishable particles are œertain vector bundles over con guration space, which we call $n$-spin bundles. $n$-spin bundles carry a representation of the spin-statistics group
( $n$ ), which is (nearly) the group generated by perm utations and independent rotations of $n$ spinors (the precise de nition is given in Section 2.1). The particular representation of
$(n)$ characterises the spin and statistics of the particles. The statistics are then em bodied in a topologicalproperty of the $n$-spin bundle, nam ely them onodrom $y$ of its at connection. $T$ his form ulation is in the spirit ofearlier treatm ents by Leinaas \& M yrhein [13] and Sorkin [17].

In Section 3 it is show $n$ that $n$-spin bundles can be constructed from irreducible repre-
sentations ${ }^{f}$ of the group $S U(2 n)$. The construction in BR is seen to be a particular case, corresponding to the com pletely sym $m$ etric representations of $S U(2 n)$. For the com pletely sym $m$ etric representations, one obtains a de nite connection betw een spin and statistics, indeed the physically correct connection. In contrast, an arbitrary representation ofS $U(2 n)$ does not necessarily engender a de nite relation between spin and statistics; whether or not it does depends on the decom position of certain representations of the spin-statistics group constructed from ${ }^{\mathrm{f}}$.

This decom position is carried out in Section [4. The calculation involves the evaluation of integrals over characters of the spin-statistics group, and $m$ akes use of the Littlew ood$R$ ichardson form ula for the decom position ofrepresentations ofU ( $k+1$ ) into representations of $U(k) U(1)$. It tums out that for an arbitrary representation of $S U(2 n)$ and a given value of spin, various choioes of statistics $m$ ay be realised, including parastatistics (which correspond to representations of the sym $m$ etric group of dim ension greater than one).

Section 5 contains a sum $m$ ary and discussion of the results. A connection to a m ore general problem in representation theory is described in the A ppendix.
$T$ hroughout this paper we will use the follow ing notation: G iven $n$ elem ents $a_{1} ;::: ; a_{n}$ of a set A, we let A denote the ordered $n$-tuple $\left(a_{1} ;::: ; a_{n}\right)$. The action of a perm utation
$2 S_{n}$ on $A$ is denoted by $A$, and de ned by

$M$ any of the results presented here are discussed in greater detail in $H$ arrison [10].

## 2 Bundle description of n-particle quantum $m$ echanics

The con guration space $C_{n}$ for $n$ particles in three-dim ensional space is the set ofn-tuples $R=\left(r_{1} ;::: ; r_{n}\right)$. We will suppose the particles cannot coincide, so that $r_{j} \not r_{k}$. If the particles are indistinguishable, then permuted con gurations $R$ and $R$ are to be regarded as being the same. We describe here a fram ew ork for quantum $m$ echanics in which wavefiunctions of identical particles are single-valued on con guration space; that is, the wavefunction at perm uted con gurations is the sam e.

We rst introduce in Section 2.1] the particular irreducible representations of the spinstatistics group ( $n$ ), denoted by $Q^{s}$, which correspond to $n$ identical spins. $n$-spin-s bundles with statistics are de ned in Section 2.2. These are at, hem itian vector bundles over con guration space whose bres carry an irreducible representation of the spin-statistics group equivalent to $Q^{s}$. This representation is required to be com patible $w$ ith indistinguishability and the at connection. $W$ avefunctions are taken to be sections of the bundle, and operators representing quantum observables are de ned on them. The relation to the standard formulation of quantum m echanics, as well as that of BR, is discussed.

### 2.1 R ep resentations of the sp in-statistics group for identicalsp in ors

Let $S_{n}$ denote the sym $m$ etric group. The irreducible representations, ,of $S_{n}$ are characterised by Young tableaux, , ofn boxes (equivalently, partitions ofn). Let d denote the dim ension of the representation . Let jai, $a=1 ;::: ; \mathrm{d}$ denote an orthonorm albasis for $C^{d}$ (w th respect to the standard inner product). For $2 S_{n}$, we w rite

denote the direct product ofn copies ofSU (2). SU (2) ${ }^{\mathrm{n}}$ describes the independent rotations of $n$ spinors. D enote elem ents of $S U(2)^{n}$ by $U=\left(u_{1} ;::: ; u_{n}\right)$, with $u_{j} 2 S U(2)$. States of n spinors, all ofspin s , are unchanged if pairs of spinors are rotated through 2 , regardless of whether $s$ is integral or half-odd-integral. Let $N u l(n) \quad S U(2)^{n}$ denote the subgroup generated by pairs of 2 rotations. It consists of elem ents of the form

The spin-statistics group,

is the sem idirect product of the $n$-spin group and the sym m etric group. E lem ents are denoted by $\overline{(U} ;)$ ), where U $2 \mathrm{SU}(2)^{\mathrm{n}}$ and $2 \mathrm{~S}_{\mathrm{n}}$, and multiplication is given by

(It is easy to chedk that the right-hand side of (2.7) is unchanged ifU and $U^{0}$ arem ultiplied by an even number of 2 rotations.) For brevity, when $\operatorname{Spn}(n)$ and $S_{n}$ are to be regarded as subgroups of ( $n$ ), we will denote their elem ents sim ply by $\bar{U}$ and respectively, rather than by $\left.\overline{(U} ; I_{S_{n}}\right)$ and ( $\left.I_{\text {sp }(n)} ;\right)$.

The com plete set of irreducible representations of the spin-statistics group can be obtained from the general representation theory ofsem idirect products (see, eg, M ackey [16]).

H ere we shall only be interested in representations whose restriction to Spn (n) describes $n$ spinors all of spin $s, w h e r e s$ is integral or half-odd-integral. It is easily established that each such irreducible representation of $(n)$ is characterised by $s$ and, additionally, by an irreducible representation of $S_{n}$. W e denote this representation by $Q^{s}$, and describe it in the follow ing.

That is, the spin labels $M$ are perm uted while jai transform s according to the representation of $S_{n}$. For a general elem ent $\left.\overline{(U} ;\right) 2(n)$, the expression for $Q^{s} \overline{(U)}$; ) follows from (2.10) and (2.11) and the multiplication law (2.7).

## $2.2 n-s p i n-s$ bundles $w$ ith statistics

For our purposes, a $k$-dim ensionalherm titian vector bundle, $E$, over the con guration space $C_{n}$ w illbe regarded as a eld ofk-dim ensionalsubspaces, $E_{R}$, ofa nite-dim ensionalH ilbert space, $V$, depending sm oothly on $R 2 C_{n} . E_{R}$ is called the bre of $E$ at $R$. A herm tian inner product on $E_{R}$ is induced by the herm itian inner product on $V$. A section of $E$ is a function $j(R) i$ on con guration space taking values in $E_{R}$. The inner product of two sections is given by

T he space of square-integrable sections form s a H illert space.
To represent spin $s$ and statistics, each bre $E_{R} m$ ust carry a representation of the spin-statistics group unitarily equivalent to $Q^{s}$. Denote this representation by $L_{R}$. We require that $L_{R}$ depend sm oothly on $R$.

O perators representing spin, position and $m$ om entum $m$ ay be de ned on wavefiunctions as follow $s$. W e consider the spin operators, denoted $S^{\mathrm{op}}=\left(\mathrm{S}_{1}^{\mathrm{op}} ;::: ; \mathrm{S}_{\mathrm{n}}^{\mathrm{op}}\right)$, rst. C onsider the
rotation of the $r^{\text {th }}$ spinor about an axis $\hat{e}_{\mathrm{a}}$ by an angle $t$ holding the other spinors $x e d$. $T$ his is described by $U_{(r ; a)}(t)=\left(u_{1}(t) ;::: ; u_{n}(t)\right) 2 S U(2)^{\mathrm{n}}$, where

As the representation $L_{R}$ is unitary, $s_{j}^{\mathrm{op}}$, as de ned by (2.14), is self-adjoint. The representation property of $L_{R}$ implies that the standard com $m$ utation relations for spin are satis ed.

Position operators, $R^{\mathrm{op}}=\left(r_{1}^{\mathrm{op}} ;::: ; \mathrm{r}_{\mathrm{n}}^{\mathrm{op}}\right)$, are de ned com ponent-w ise by

$r_{j}^{\mathrm{op}}$ is hem itian w ith respect to the inner product (2.12), self-adjoint on a suitable dom ain, and the position operators com $m$ ute am ongst each other and $w$ ith the spin operators.
$T$ he de nition ofm om entum operators requires a herm itian connection on $E$. A herm itian connection associates to piecew ise sm ooth paths $R$ ( $t$ ) $2 C_{n}$ a fam ily of unitary $m$ aps between the bres $E_{R(t)}$. These unitary $m$ aps describe the parallel transport of spinors along $R(t)$. $M$ om entum operators $m$ ay be de ned in term $s$ of the covariant derivative $w$ ith respect to this connection.

A characteristic property of a connection is its curvature, which describes paralleltransport around in nitesim al closed paths. N onvanishing curvature corresponds physically to the presence of gauge (eg, $m$ agnetic) elds. In order that our theory be capable of describing physics in the absence of elds, we shall require that $E$ adm it a at connection. This condition is not autom atically satis ed; the existence of a at connection depends on the topology of the bundle (just as the fact that a two-tonus adm its a at R iem annian $m$ etric, while a two-sphere does not, is a consequence of their di erent Euler characteristics).

For a at connection, parallel transport around a closed path is trivial, provided the path is contractible. In $C_{n}$, every closed path is contractible ( $C_{n}$ is simply connected). $T$ herefore, parallel-transport w ith respect to a at connection on $E$ is path-independent, and depends only on the endpoints of the path. Therefore, a at herm itian connection on $E$ is characterised by unitary $m$ aps $T_{R}{ }^{0} \quad: E_{R}!E_{R} 0$ describing parallel transport from $R$ to $\mathrm{R}^{0}$. P ath independence then im plies that

That the m om entum operators com m ute am ongst them selves follow s from the fact that

$T$ he requirem ent that spin and $m$ om entum com $m$ ute is equivalent to the requirem ent that parallel transport be com patible $w$ th the representation $L_{R}$. That is, we should have that $L_{R^{0}}(\bar{U} ;) T_{R}{ }^{0}{ }_{R}=T_{R^{0}}{ }_{R} L_{R}(\bar{U} ;)$.

A s a basis for subsequent discussion, let us form ulate the standard description of $n$ particle quantum $m$ echanics $w$ ithin the fram ew ork described above. (In this case, the vector bundle description is unnecessary, ofcourse, and appears arti cial.) For this, take the bres $E_{R}$ to be everyw here equal to the xed vector space $V^{s} . T$ ake $L_{R}$, the representation of the spin-statistics group, to be everyw here equal to the standard representation $Q^{s}$. P arallel transport is everyw here taken to be trivial; ie $T_{R} 0 \quad R$ is just the identity $m$ ap on $V^{s}$. Then $E$ is just the cartesian product $C_{n} \quad V^{s}$, and wavefunctions $j(R) i$ are just $V{ }^{s}$-valued functions on $C_{n} . W$ avefunctions $m$ ay be expanded in the standard basis $M$; ai (cf (2.9) ),

W e now introduce the requirem ent, basic to the form ulation in $B R$, that for indistinguishable particles, the values of the wavefunction at perm uted con gurations should be the sam e. T hat is, we require that

(N ote that for this condition to be sensible, the bres at $R$ and $R$ must be the sam e.) In this case, the wavefunction is single-valued as a function of con gurations in which the particles are no longer labeled. W avefunctions in the standard description are not single-valued in this sense. Indeed, in the standard description, the coe cients of the wavefunction at perm uted con gurations are related by

A ) There exists a sm ooth fam ily, $L_{R}$, of unitary irreducible representations of the spinstatistics group $(n)$ acting on the bres $\mathrm{E}_{\mathrm{R}}$, unitarily equivalent to $Q^{s}$.
B) The bres at perm uted con gurations are the sam $e$, ie

The condition (2.32) im plies that the com ponents at perm uted con gurations are related as in (225), in accord w ith the standard form ulation.

A part from allow ing parastatistics, the fram ew ork described here is equivalent to the one given in Section 2 of BR. There are, how ever, som e di erences in the form ulation. In BR, properties A ) (D) are expressed directly in term s of the parallel-transported basis. For exam ple, instead of property C ), BR require that the parallel-transported basis satisfy

In this way, the form alism and term inology of vector bundles is avoided.
A $n$ advantage of the present form ulation is that properties required by physical considerations are distinguished from those which depend on convention. For exam ple, (2.37) im plies the existence of a at connection, but it im plies, additionally, that it is a particular connection which is at-nam ely, the connection induced by the inner product on $V$,
according to which vectors are parallel-transported by translating them to an in nitesi$m$ ally displaced bre and there pro jecting them perpendicularly. This choioe of connection, while convenient, is nevertheless a $m$ atter of convention, and is not required by physical considerations.

F inally, we note that we could, if we w ished, im pose the single-valuedness condition $m$ ore directly by taking $n$-particle con guration space to be the identi ed con guration space $\bar{C}_{n}=C_{n}=S_{n}$ consisting of (unordered) sets $X=f r ; s ;:: ;$ tg of $n$ distinct points in $R^{3}$. ( $T$ his is the point of view taken by Leinaas and $M$ yrheim (1977).) Then wavefiunctions would becom e functions of $X$, or, $m$ ore precisely, sections of an $n$-spin bundle over the identi ed con guration space $\overline{\mathrm{C}}_{\mathrm{n}}$. H ow ever, such a reform ulation involves som e additional $m$ athem atical com plication, and, for this reason, we will con ne our consideration of it to the follow ing inform al rem arks.

The com plication is due to the fact that there are no global Euclidean coordinates on $\overline{\mathrm{C}}_{\mathrm{n}}$; it is no longer sensible to refer to position, spin and m om entum operators for a particular particle. In place of individual $m$ om enta, for exam ple, one $m$ ust introduce generalised $m$ om entum operators, which are related to covariant derivatives along $s m$ ooth vector elds on $\overline{\mathrm{C}}_{\mathrm{n}}$. A form ulation in term s of $\overline{\mathrm{C}}_{\mathrm{n}}$ does have som e attractive aspects, though. P arallel transport betw een perm uted bres in $C_{n}$ becom es transport from a single bre to itself around a non-contractible closed path in $\overline{\mathrm{C}}_{\mathrm{n}}$. In this way, the statistics of the particles is re ected in the $m$ onodrom $y$ of the at connection, a topological property of the bundle.

## 3 Spin bundles $S U(2 n)$ representations

In this section we describe the construction of $n$-spin bundles from representations of SU ( 2 n ). The construction is based on a connection between $\mathrm{SU}(2 \mathrm{n})$ and the spin-statistics group ( $n$ ) (Section 3.1), which associates a representation ${ }^{\mathrm{f}}$ of ( n ) to an irreducible representation ${ }^{\mathrm{f}}$ of $\mathrm{SU}(2 \mathrm{n})$ (Section 32). In general, the representation ${ }^{\mathrm{f}}$ is reducible. $n$-spin bundles are constructed from the representations ${ }^{f}$ and ${ }^{f}$ and an $S_{n}$-equivariant $m$ ap from $C_{n}$ to $S U(n)=T(n)$ (Section (3.3).

W hether ${ }^{f}$ determ ines a spin-statistics relation is discussed in Section 3.4. The question is related to the decom position of ${ }^{f}$ into its irreducible com ponents. A de nite statistics for a given value of spin requires that ${ }^{\mathrm{f}}$ should contain only one irreducible representation of $(n)$ w th that spin. This is the case for the com pletely sym $m$ etric representations, which correspond to the construction in BR. The general case is discussed in Section (4.

### 3.1 The spin-statistics group and SU (2n)

C onsider $S U(2 n)$, the group of $2 n$-dim ensional unitary $m$ atrices of unit determ inant.

M ( $n$ ) also contains the $S U(2 n)$-centraliser of $T(n)$, denoted by $Z(n)$, ie the subgroup of $S U(2 n)$ whose elem ents com $m$ ute $w$ th all elem ents of $T(n)$. U nder the restriction of ${ }^{f}$ to $T(n), V m$ ay be decom posed into a direct sum of orthogonal subspaces, $\mathrm{V}^{\mathrm{K}}$, on which ${ }^{\mathrm{f}}(\mathrm{t}(\mathrm{I})$ ) is represented by the phase factor $\exp \mathrm{i}(\mathrm{K} \quad$ ). Here $K=\left(k_{1} ;::: ; k_{n}\right)$ is an $n$-tuple of integers, and $K \quad={ }_{j} k_{j}$. .The subspace $V^{0}$, corresponding to $K=(0 ;::: ; 0)$, consists of vectors which are invariant under ${ }^{\mathrm{f}}(\mathrm{T}(\mathrm{n}))$.

This multiplicity will play a central role in what follow s.

### 3.3 C onstruction of $n-s p$ in bundles

Let : $C_{n}$ ! $S U(n)=T(n)$ denote a smooth $m$ ap from $n$-particle con guration space $C_{n}$ to the coset space $S U(n)=T(n)$. Such a $m$ ap $m$ ay be represented by $g(R)$, an $S U(n)-$ valued function on $C_{n}$ which is sm ooth up to right $m$ ultiplication by an elem ent of $T(n)$. ( $T$ hat is, discontinuities in $g(R)$ can be rem oved locally by $m$ ultiplying on the right by a discontinuous $T(n)$-valued function.) The sym $m$ etric group $S_{n}$ acts on $C_{n}$ as perm utations (ie, R $7 \quad R$ ) and on $S U(n)=T(n)$ as the $W$ eylgroup (ie, fory (; ) $2 N(n), g T(n) T$ $\left.g y^{1}(;) T(n)\right)$. is said to be equivariant $w$ th respect to $S_{n}$ if, for all $2 S_{n}$, = . In term $s$ of $g(R), S_{n}$-equivariance is equivalent to

## 4 C alcu lation of the multip licities

G iven an arbitrary representation ${ }^{f}$ of $S U(2 n)$, we wish to determ ine for which spins an n -spin-s bundle can be constructed, and, for those spins, whether the constructions have a de nite type of statistics. To this end, we calculate the multiplicities ( $\mathrm{f} ; \mathrm{s}$ ) w ith which the irreducible representation $Q^{s}$ of $(n)$ appears in the representation ${ }^{f}$. The application of the Littlew ood$R$ ichardson theorem to the unitary groups is discussed by $H$ agen and $M$ acFarlane [8] and Itzykson and $N$ auenberg [11]. A m ore detailed discussion of the rules form ultiplying Y oung tableau can be found in H am erm esh (9].

### 4.3 Examples

In Section 3.4, we considered the case of com pletely sym $m$ etric representations, for which $f=(d)$. There we showed that ((d); ) vanishes unless $d=2 n s$ and unless is the trivial (resp . altemating) representation according to whether s is integral (resp. half-oddintegral). This particular case is readily obtained from the general form ulas (4.43) and (4.44). Instead of doing so, we sketch below the analogous calculation for the com pletely antisym $m$ etric representations of $S U(2 n)$. The result tums out to be rather di erent from the sym $m$ etric case, in that only $s=\frac{1}{2}$ constructions are supported; the com pletely antisym $m$ etric representations do not provide a system atic description for all spins. The $s=\frac{1}{2}$ statistics tum out to be bosonic in this case.

Com pletely antisym $m$ etric representations of $S U(2 n)$ correspond to single-colum ned tableaux of betw een 1 and $2 n \quad 1$ rows (the $2 n$-row ed tableau is equivalent to the trivial representation). D enote the $d$-rowed representation by $f=(1)^{d}$. From 4.39), ( (1) ${ }^{d}$; s ) vanishes unless $\mathrm{d}=\mathrm{n}$ and, from (4.45) and (4.49), unless $\mathrm{s}=\frac{1}{2}$. In this case, the expressions (4.43) and (4.44) sim plify considerably. The sum s over the $p^{\prime}$ 's collapse to the single term where all the $j_{p}$ J's are equal to one, and the sum sover the ${ }_{b}$ 's collapse to the single term where $\mathrm{b}_{\mathrm{b}}=(1)^{\hat{j}^{\hat{\prime}} \mathrm{j}}$. For these term S , the Littlew ood R ichardson coe cients and C lebschG ordan coe cients appearing in (4.44) are all equal to one. W e get that

$N$ ext, we consider general representations for the case of tw o particles, $n=2$. For sim plicity, we label the even and odd representations of $S_{2}$ by $=+$ and $=$, respectively, with characters $\mathrm{s}_{2}()=\operatorname{sgn}()$. A s in (4.45), let

The sim plest cases are the tableaux $f=(2 ; 0)$ and $f=(1 ; 1)$ with $\dot{f} j=2$. Then $s=\frac{1}{2}$ is the only perm 埔ed value of the spin, and ( $\mathrm{f} ; \mathrm{s}$ ) contains a single box. The tableau ( $2 ; 0$ ) corresponds to a com pletely sym $m$ etric representation. A s discussed in Section 3.4, this yields ferm i statistics for spin $-\frac{1}{2}$, so that $\left(f ; \frac{1}{2}+\right)=0$ and $\left(f ; \frac{1}{2}\right)=1$. (4.53) is readily evaluated for the tableau ( $1 ; 1$ ), and one nds the opposite result, nam ely bose statistics for spin $-\frac{1}{2}$ (this case is equivalent to the \anti-Schw inger construction" discussed in [4]).

For larger tableaux one typically nds that for each perm itted value of spin, both
 do not determ ine a spin-statistics relation. The sm allest tableau where this occurs is $f=(3 ; 2 ; 1)$ with $s=\frac{1}{2}$. Evaluation of (4.53) show $s$ there is one ferm $i$ and one bose representation. In fact, for larger tableaux one typically nds that ( $f ; \mathrm{s}+$ ) and ( $\mathrm{f} ; \mathrm{s}$ ) are nearly equal, and there are argum ents to suggest they are either exactly equal, or else di er by 1, according to whether their sum, given by $Y^{f}{ }_{(f ; s) ;((f ; s)}$, is even or odd. It tums out that $m$ ost of the term $s$ in the sum over tableaux in (4.53) cancel. First, since the sum $m$ and is sym $m$ etric in 1 and $\quad 2$, apart from the sign factor $(1)^{j 1 j}$, only term $s$ for which $j_{1}$ jand $j_{2}$ jhave the sam e parity contribute. Am ongst these rem aining term s , the sign factor is responsible for additional cancellations, due to the follow ing fact: If ${ }_{1}+$ is the tableau obtained by adding one box to the rst row of ${ }_{1}$, and 2 is the tableau obtained by rem oving one box from the rst row of ${ }_{2}$, then the rules formultiplying tableaux im ply that

To dem onstrate the possibility of parastatistics, we consider the sim plest case of three particles and the $s m$ allest $S U(6)$ tableau, $f=(2 ; 1)$. ## 5 D iscu ssion

W e have reform ulated the quantum kinem atics of $B R$ for indistinguishable spinning particles in term s of vector bundles over n-particle con guration space. $W$ ithin this geom etrical fram ew ork, our $m$ ain results concem a representation-theoretic generalisation of the construction in BR.W e have shown that $n$-spin bundles can be constructed from irreducible representations ${ }^{f}$ of the group $S U(2 n)$. The construction $m$ akes use of representations
${ }^{f}$ of the spin-statistics group ( $n$ ) associated to ${ }^{f}$, as well the existence of a continuous, $S_{n}$-equivariant $m$ ap from $S U(n)=T(n)$ to con guration space $C_{n}$ [2].

The construction in BR is based on particular representations of $S U(2 n)$, nam ely the com pletely sym $m$ etric representations. For a given num ber, $n$, of indistinguishable particles $w$ ith spin $s$, there is a unique com pletely sym $m$ etric representation of $S U(2 n)$, nam ely the 2ns-fold sym $m$ etric tensor product of $S U(2 n)$ w ith itself, which leads to a description of the quantum kinem atics (ie, which supports an $n$-spin bundle $w$ ith spin $s$ ). The statistics is necessarily in accord w ith the physically correct spin-statistics relation.

Representations of $S U(2 n)$ other than the com pletely sym $m$ etric representations, corresponding to Young tableaux $f$ of $m$ ore than one row, typically support multiple values of spin $s$, and for a given spin $m$ ay support distinct values of the statistics , including parastatistics. The values of spin and statistics supported by a given representation
${ }^{f}$ are determ ined by the multiplicities ( $f ; s$ ) of the irreducible representations of the spin-statistics group, ( $n$ ), in the decom position of ${ }^{f}$.

Our main calculation is an evaluation of the multiplicities ( $f$; $s$ ) using character $m$ ethods. Eqs. (4.43) \{ (4.44) give the multiplicities as a nite sum over characters of the sym m etric group $S_{n}$, the n-fold C lebsch-G ordan coe cients of SU (2), and the Littlew ood$R$ ichardson coe cients for the decom position of representations of $U(n+m)$ into representations of $U(n) \quad U(m)$.

O ur calculation is related to a $m$ ore general problem in representation theory, nam ely the decom position of zero-w eight representations of the $W$ eyl group $W$ of a com pact,
connected Lie group $G$ associated with an irreducible representation of $G$. It would be interesting to see if altemative $m$ ethods could be brought to bear on our calculation, as well as whether the $m$ ethods used here $m$ ight prove useful in other contexts. O ur construction of n-spin-bundles is sim ilarly related to the construction of at zero-weight bundles over the coset space $G=T$ (where $T$ is a $m$ axim altonus of $G$ ), whose decom position into a direct sum of sub-bundles irreducible under m onodrom y leads to the decom position problem described above.

C onceming the spin-statistics relation, in the rst instance our results are sim ilar to those of [3]. W thin the group-theoretical fram ew ork considered here, the requisite properties introduced in Section 2 do not determ ine a connection between spin and statistics. W hen general representations of $S U(2 n)$ are adm itted alongside the com pletely sym $m$ etric representations, the spin-statistics relation is lost.

A s argued in the Introduction, a derivation of the spin-statistics relation from a reformulation of quantum mechanics should be based on principles whose physicalm otivation is clear. The role played by the group $S U(2 n)$ in our considerations is not well m otivated in this respect. O ne could o er as m otivation the fact that $S U(2 n)$ inconporates both rotations ofn spins (ie, $S U(2)^{n}$ ) and the perm utations $S_{n}$, but of course it is not the only group which does so.

H ow ever, the role played by the com pletely sym $m$ etric representations deserves further consideration. They provide, at least as far as we have discemed, the only system atic m eans, w ithin the given fram ew ork, of associating a representation to a particular value of spin. It is suggestive, too, that the schem e which works treats the spins in a com pletely sym m etrical way; this would seem appropriate for indistinguishable particles. Indeed, characteristic aspects of the com pletely sym $m$ etric representations $m$ ay indicate a di erent approach to this nonrelativistic treatm ent of the spin-statistics relation, which we hope to report on in future.

## A General Setting

The construction ofn-spin bundles described in Section 3 is closely related to the follow ing general problem (see, eg, [12]). Let be an irreducible unitary representation on a vector space $V$ of com pact $L$ ie group $G$ w ith $m$ axim altonus $T$. $V$ m ay be decom posed into weight spaces, $V$, labeled by weights of $T$. The zerow eight space $\mathrm{V}^{0}$ carries a representation of the $W$ eyl group, $W$, of $G$, which is, in general, reducible. O ne can then ask for the decom position of this representation of the $W$ eyl group into its irreducible com ponents.

To each weight space $V$ of the representation is associated a herm itian vector bundle E over $\mathrm{G}=\mathrm{T}$ w ith Abelian G -invariant herm itian connection. The curvature of this connection depends linearly on , and therefore vanishes on the zero-w eight bundle $\mathrm{E}^{0}$. If G is sim ply connected, then $\mathrm{E}^{0}$ is trivial. H ow ever, the quotient bundle $\overline{\mathrm{E}}^{0}=\mathrm{E}^{0}=\mathrm{W}$ over the quotient space ( $\mathrm{G}=\mathrm{T}$ ) $=\mathrm{W}$, while locally $\quad$ at, m ay be nontrivial. For sim ply connected $G$, the fiundam entalgroup of the quotient space is just the $W$ eylgroup $W$, and the $m$ onodrom $y$ of the at connection yields a representation of $W$, which is precisely the representation described above.
$T$ his setting can be further generalised by regarding $G$ as a subgroup of a Lie group $F$, and regarding as the restriction to $G$ of a representation of $F$. In this case, the natural structure group for the zero-w eight bundle is the generalised W eyl group $\mathrm{V}=\mathrm{M}=\mathrm{T}$, where $M$ is the $F$ norm aliser of $T$.

The construction of Section [3 is an exam ple belonging to this m ore general setting, $w$ ith $F=S U(2 n), G=S U(n)$, and $T=T(n)$. The $W$ eylgroup of $S U(n)$ is just $S_{n}$, and the generalised $W$ eyl group $V$ is the spin-statistics group, $(n)=S U(2)^{n} \circ S_{n}=N u l(n)$. $T$ he $n$-spin bundles are pullbacks, via the $S_{n}$ equivariant $m$ ap $: C_{n}!\quad S U(n)=T(n)$, of zero-w eight bundles over $S U(n)=T(n)$.
$T$ his point of view is elaborated below.

Let $G$ be a com pact, connected sem ism ple Lie group $w$ ith $m$ axim altonus $T$. Let $N$ denote the norm aliser of $T$, and $W=N=T$ the $W$ eyl group of $G$. Suppose $G$ is a subgroup of a com pact, connected Lie group F. Let M denote the $F$-nom aliser of $T$, ie the subgroup of $F$ which leaves $T$ invariant under conjugation. $W$ e call

The spin-statistics group (n) is an example of a generalised $W$ eyl group, w ith $F=$ $S U(2 n), G=S U(n)$, and $T=T(n)$. The $W$ eyl group $W$ is isomorphic to $S_{n}, Z=T$ is isom orphic to $\operatorname{Spn}(n)$, and $V$, the generalised $W$ eyl group, is isom orphic to the sem idirect product $S p n(n) \circ S_{n}$, which is just ( $n$ ).

## A. 2 Zero-w eight representations of the generalised $W$ eyl group

G iven $T \quad G \quad F$ and $N \quad M$ as above. Let $f$ denote the (real) Lie algebra of $F$, $E x p: f!F$ the exponentialm ap, and ad the adjoint representation of $F$ on $f$. Let $g \quad f$ denote the Lie algebra of $G$, and $t \quad g$ the $L$ ie algebra of $T$, (ie, the $C$ artan subalgebra of $G$ ), with dualt. Denote the pairing between $2 t$ and 2 tby . The adjoint representation restricts to a representation of $M$ on $t$, denoted ad $(M)$. The co-adjint representation of $M$ on $t$, denoted ad $(M)$, is de ned by

Let $\operatorname{ker}_{t}(E x p)$ denote the lattioe in $t m$ apped to the identity in $T . A$ weight of $T$ is an elem ent of which is integer-valued on $\operatorname{ker}_{t}(\mathbb{E x p})$. Irreducible representations of $T$ are labeled by weights, and are given explicitly by $\operatorname{Exp} \quad 7 \exp (2$ i $)$.

Let denote an irreducible unitary representation of $F$ on a nite-dim ensional H ilbert space $V$. V m ay be decom posed into a direct sum of generalised w eight spaces $V$ on which
( $T$ ) acts w ith weight. (In case $F=G$, this is the usual weight-space decom position of $V$.) . Let $V^{0}$ denote the zero-weight space, ie the subspace of vectors invariant under $T$, for which $=0$.

Forx 2 M and Exp 2 T , we have that

It follows that the zero-w eight space, $V^{0}$, is invariant under $M$, so that restricts to a representation of $M$ on $V^{0}$. Since $T$ is contained in the kemel, $(M)$ reduces to a representation of the generalised $W$ eylgroup $V=M=T$ on $V^{0}$. D enote this representation by . In general, is reducible. Let denote an irreducible representation of $V$, and let ( ; ) denote the multiplicity of in the decom position of into its irreducible com ponents. The multiplicities (; ) are naturally associated with a pair of irreducible representations and of a com pact connected $L$ ie group $F$ and the generalised $W$ eyl group V. A natural question is how to compute them. In case $F=G=S U(n)$, this question has been discussed by K ostant [12].

## A. 3 W eight bundles over $\mathrm{G}=\mathrm{T}$

A ssociated to the weight space $V$ is a vector bundle E over $\mathrm{G}=\mathrm{T} . \mathrm{E}$ is a sub-bundle of the trivialbundle $G=T \quad V$, w ith bres $\mathrm{E}_{\mathrm{gT}}$ given by $(\mathrm{g}) \mathrm{V}$. By virtue of its em bedding in the trivialbundle, there is an induced $G$-invariant connection on $E$, according to which a vector $j(t) i 2 E_{g(t) T}$ is parallel transported along a curve $g(t) T 2 G=T$ if and only if
-(t) is orthogonal (w ith respect to the inner product on $V$ ) to the bre $E_{g(t) T}$.
It is straightforw ard to derive an explicit form ula for parallel transport along a oneparam eter subgroup,

where 2 g . W e note that gives a representation on $V$ of $f$, and, by restriction, of $g$, by anti-herm itian linear transform ations. W e denote these $L$ ie-algebra representations by
as well. Let $t^{?} \quad g$ denote the orthogonal com plem ent of $t$ in $g$ ith respect to the $K$ illing form (as G is com pact and sem isim ple, the $K$ illing form is negative de nite). It is a standard result (see eg [7]) that ( $t^{?}$ ) m aps $V$ into a direct sum of orthogonal subspaces $V^{0}$ (the di erence $0 \quad$ is, in fact, a root of $g$ ). G iven 2 g , let ${ }^{\mathrm{t}}+\mathrm{t}^{\text {? }}$ denote its (unique) decom position into components in $t$ and $t^{?}$ respectively. Then, for j i 2 V , we have that

It follow s from (A .8) that the parallel transport of $j$ i along $g(t)$ is given by

It follow s that the induced connection (A.9) is A belian; under parallel transport around a closed curve in $G=T$, a vector in E retums to itself up to a phase factor.

Since the left-invariant vector elds span the tangent bundle of $G=T$, A.10 determ ines . T he curvature form, like the connection, is invariant under the action of G .
A. 4 Zero-w eight bundle and representations of the generalised W eylgroup

Suppose the representation off has a nontrivial zerow eight space $V^{0}$. From (A.10), the curvature of the associated zero-w eight bundle $\mathrm{E}^{0}$ vanishes, so that induced connection on
$\mathrm{E}^{0}$ is at. In this case, parallel transport w ith respect to a at connection depends only on the hom otopy class of the path in $\mathrm{G}=\mathrm{T}$. If $\mathrm{G}=\mathrm{T}$ is sim ply connected, parallel transport is path independent, and $\mathrm{E}^{0}$ is globally at , and therefore trivial. T his is the case if G itself is sim ply connected, as we will assum e from now on. A sG is com pact and connected, $g(t) 2 \mathrm{G}$ can be expressed Exp (t (t)) for some (t) 2 g . It follows from 区.9) that parallel transport along in E along $\mathrm{g}(\mathrm{t}) \mathrm{T}$ is given by

The zerow eight bundle $\mathrm{E}^{0}$, in contrast to weight bundles w ith non-zero weights, desoends from a bundle over $\mathrm{G}=\mathrm{T}$ to a bundle over $\mathrm{G}=\mathrm{N} . \mathrm{W}$ e denote this reduced bundle by $\mathrm{E}^{0} . \mathrm{E}^{0}$ is a sub-bundle of the trivial bundle $\mathrm{G}=\mathrm{N} \quad \mathrm{V}$, with bres given by $\mathrm{E}_{\mathrm{gN}}=(\mathrm{g}) \mathrm{V}^{0}$. (N ote that since $N$ leaves $V^{0}$ invariant, this expression does not depend on the choice of representative $g$ for $g \mathrm{~N}$.) The at connection on E passes to E .

In general, the $\mathrm{G}=\mathrm{N}$ is not sim ply connected; its fiundam entalgroup is isom onphic to the W eyl group $\mathrm{W}=\mathrm{N}=\mathrm{T}$, as follows from the fact that $\mathrm{G}=\mathrm{N}=(\mathrm{G}=\mathrm{T})=(\mathbb{N}=\mathrm{T})=(\mathrm{G}=\mathrm{T})=\mathrm{W}$, and $\mathrm{G}=\mathrm{T}$ is sim ply connected by assum ption. An isom onphism between W and ${ }_{1}(\mathrm{G}=\mathrm{N}$; N ), the fundam ental group based at the identity coset IN, is given explicitly as follow s. Let $g(t) N$ denote a closed path in $G=N$ beginning and ending at $N$. For de niteness, take $0 \quad \mathrm{t} 1$ and $\mathrm{g}(0)=\mathrm{I}$. Then $\mathrm{g}(1) \mathrm{N}=\mathrm{IN}$ implies that $\mathrm{g}(1) 2 \mathrm{~N}$. The m ap

depends only on the hom otopy class of hom otopy class of $g(t) N$. It is easily veri ed that A.12) preserves group multiplication, and is $1 \quad 1$ (since $T$ is connected and $G$ is sim ply connected) and onto (since G is connected).

Because $\mathrm{G}=\mathrm{N}$ is not sim ply connected, parallel transport w ith respect to the at connection need not be trivial, and can depend on the hom otopy class of the path. For closed paths, parallel transport generates a unitary representation of the fiundam ental group, the $m$ onodrom $y$ of the connection. In view of the preceding, the $m$ onodrom $y$ at the identity coset N is naturally regarded as a representation of the W eyl group $\mathrm{W} . \mathrm{W}$ e denote this representation by , and com pute it as follow s. G iven y 2 N , let $g(t) 2 \mathrm{G}$ be a sm ooth path in $G$ w ith $g(0)=I$ and $g(1)=y$. From A.11), parallel transport in $E$ along $g(t) N$ is given by

is obtained from parallel transport at $t=1$, so that

$T$ his is just the restriction to N of the representation of the generalised W eylgroup V on $\mathrm{E}_{\mathrm{N}}$.

At an anbitrary bre $\mathrm{E}_{\mathrm{gN}}$ of the quotient bundle we can de ne a unitary representation of the generalised $W$ eyl group $V$, which we denote by $L_{g N}(y)$. For exam ple, we can take $L_{\mathrm{gN}}(\mathrm{y})=(\mathrm{g})(\mathrm{y}){ }^{\mathrm{y}}(\mathrm{g})$. A di erent choice of representative g for gN would yield a
di erent but equivalent representation. Therefore, there is a well-de ned decom position of $E$ into a direct sum of sub-bundles $E$ whose bres transform according to irreducible representations of $V$. This decom position is determ ined by the multiplicities (; ) discussed in Section A.1.
