M icroscopic and m acroscopic properties of A -superstatistics

A bstract

The m icroscopic and the m acroscopic properties of A-superstatistics, related to the class A (0;n-1) sl(1;n) of simple Lie superalgebras are investigated. The algebra sl(1;n) is described in terms of generators f_1 ;:::; f_n , which satisfy certain triple relations and are called Jacobson generators. The Fock spaces of A-superstatistics are investigated and the Pauli principle of the corresponding statistics is formulated. Some them all properties of A-superstatistics are constructed under the assumption that the particles interact only via statistical interaction imposed by the Pauli principle. The grand partition function and the average number of particles are written down explicitly in the general case and in two particular examples: 1) the particles have one and the same energy and chemical potential; 2) the energy spectrum of the orbitals is equidistant.

1 Introduction

In this paper we consider the m icroscopic and the m acroscopic properties of a class of generalized statistics, referred to as A -superstatistics. In our approach, the starting point is a certain symmetry principle, characterized by an algebra of creation and annihilation operators (CAO's) with Fock type representations.

The idea behind these investigations is based on a few observations. The rst one is that any n pairs of Bose CAO's B_1 ; B_2 ; ...; B_n generate a representation, the Bose representation B_n , of the orthosymplectic Lie superalgebra B_n of B_n of B_n , which in the Bose representation coincide with the Bose operators B_n ; B_n of B_n , which in the Bose representation coincide with the Bose operators B_n ; B_n , are para-Bose CAO's [1] and satisfy the relations

These triple relations give one possible de nition of the Lie superalgebra osp (1½n) [2], and are considered as the de ning relations of para-Bose statistics. So ordinary Bose statistics corresponds to one particular realization of para-Bose statistics.

The situation with Ferm i statistics and its generalization, para-Ferm i statistics [1], is similar. So the second observation is that any n pairs of Ferm i CAO's F_1 ; F_2 ; :::; F_n give a representation, the Ferm irepresentation F, of the orthogonal Lie algebra so F_n and any n pairs of para-Ferm iCAOs F_n , with

generate the algebra B_n [3].

Both algebras B_n (every Lie algebra is also a Lie superalgebra) and B (0jn) belong to the class B of basic classical Lie superalgebras in the classication of K ac [4]. Hence ordinary Bose and Ferm i statistics and their generalizations para-Bose and para-Ferm i statistics could be referred to as B-(super) statistics.

On the ground of these facts statistics related to the other classes of basic Lie superalgebras were introduced: A - B - C - and D - (super) statistics [5]. So far only A-statistics (corresponding to the Lie algebra sl(n + 1)) was studied in detail from the microscopic [5], [6] and macroscopic point of view [7]. In the present paper we investigate the properties of A-superstatistics [8], namely the statistics arising from the Lie superalgebra sl(1n) = A(0n) (0; n 1) or gl(1n).

The microscopic properties of this statistics related to gl(1jn) lead to the introduction of Ferm i-like operators f_i , and these are relevant for the description of certain physical models (see Section 3). In particular, lattice models of strongly correlated electron systems use these operators f_i (in a certain representation). A lso, the so-called ideal odd-particle creation and annihilation operators of K lein and M arshalek in nuclear shell model theory correspond to a particular realization of the operators f_i .

Section 2 is devoted to the m icroscopic properties of this new class of generalized statistics. First we recall the de nitions of the Lie superalgebras sl(1n) and gl(1n)

and their Fock representations. Like for para-Bose and para-Ferm i statistics, the generators f_i , i = 1; :::; n of sl(1; n) satisfy certain triple relations. These relations completely de ne the Lie superalgebra sl(1jn), just as the triple relations for the generators a_i , i = 1; :::; n of A-statistics do for the Lie algebra sl(n + 1) [6]. For sl(n + 1), this property of the operators a; was rst observed by Jacobson [9] and therefore the generators a_i are referred as Jacobson generators of sl(n + 1) [6]. By analogy we call the generators f_i of $sl(1j_i)$ also Jacobson generators of $sl(1j_i)$. The Fock representations of A-superstatistics are constructed in the same way as in parastatistics. They are generated by the operators f_i^+ and labelled by a positive integer p = 1;2;::::W ithin the corresponding module W (p;n) the generator f_i^+ (respectively f_i) can be interpreted as a creation (respectively annihilation) operator of a \particle" on the ith orbital (i = 1;2;:::;n). The Pauli principle of A-superstatistics is formulated and in Section 3 it is indicated that in the lim it p! 1 the representation dependent operators F (p)_i = $\frac{f_i}{P_{\overline{D}}}$ coincide with ordinary Ferm iCAO's. We complete this section by showing that the Jacobson generators of sl(1 in) are implicitly present in certain physical models.

The following sections are devoted to the macroscopic properties of A-superstatistics. In Section 4 we construct explicitly the $sl(1j_1)$ grand partition function Z (p;n) (GPF), the average number of particles in the system N (p;n) and the average number of particles on each orbital i under the assumption that the energy of each particle on orbital i is i. All these them all properties of the system are described by means of the elementary symmetric functions. The fact that symmetric functions appear naturally in the description of (grand) partition functions in statistical mechanics got attention recently [10]. For quantum systems with Bose or Ferm i statistics, see [10]. For quantum systems with A-statistics, the relevant symmetric functions are the so-called complete symmetric functions [7]. Here in the case of A-superstatistics, the relevant symmetric functions are the so-called elementary symmetric functions.

Then we consider two specializations of the general case of Section 4. In Section 5 the energy and the chem ical potential of each orbital are assumed to be the same. This is the so-called degenerate case. The thermodynamical functions simplify, and many of these can be expressed as hypergeometric series. Furthermore, these functions can be seen as deformations of the corresponding ones in the case of Fermi statistics. In Section 6 we investigate a model with equidistant energy levels. Also under this specialization, the thermodynamical functions assume a simple form, usually in terms of q-generalized or basic hypergeometric functions.

It should be emphasized that our notion \A -superstatistics" refers to a generalized quantum statistics based upon the Lie superalgebra of type A, and that it should not be confused with the recently introduce phenomenon of superstatistics" as in [11].

2 M icroscopic properties of A-superstatistics

A-superstatistics is de ned in the context of the Lie superalgebra sl(1n) or gl(1n). A convenient basis of gl(1n) is given with the W eyl generators e_{ij} , with i; j 2 f0;1;:::;ng. The grading of gl(1n) is as follows: the even elements are given by e_{00} and e_{ij} with i; j 2 f1;:::;ng; the odd elements are e_{0i} and e_{i0} (i = 1;:::;n). The Lie superalgebra bracket is determined by

where $\deg(e_{ij})$ is 0 (resp. 1) if e_{ij} is even (resp. odd). One can de ne sl(1jn) as the (super)comm utator algebra of gl(1jn); its basis consists of all elements e_{ij} (i \in j) and the C artan elements $e_{00} + e_{ii}$ (i = 1;:::;n).

The Jacobson creation and annihilation operators f_i of $sl(1j_i)$ are given by

A -superstatistics is determined by the relations that hold for the creation and annihilation operators. These are:

It is worth observing that these operators satisfy the compatibility conditions required in the context of W igner quantum systems [12].

The Fock representations of A-superstatistics have been classified by Palev [8]. These representations are labeled by a positive integer p, the order of statistics. Let us denote the Fock representation of order p for sl(1jn) by W (p;n). The space W (p;n) is characterized by a vacuum vector (p;n) such that

These Fock spaces are nite-dimensional unitary irreducible sl(1jn)-modules. A set of basis vectors for the space W (p;n) consists of all vectors

The linear span of all vectors (2.9), without the restriction (2.10), also forms a $sl(1j_n)$ module W (p;n). However, if p < n, W (p;n) is not irreducible: it contains a maximal invariant submodule, and W (p;n) is the quotient module of W (p;n) with respect to this submodule. If p = n, we have that W (p;n) = W (p;n); in this case it is clear that the restriction (2.10) is super uous.

One can de ne a Hermitian form h; i on W (p;n) with the usual Fock space technique, by requiring

W ith respect to this form, the dierent vectors in (2.9) are orthogonal, and the following vectors form an orthonormal basis of W (p;n):

Therefore, each f_i^+ (resp. f_i^-) can be interpreted as an operator creating (resp. annihilating) a particle (or quasiparticle, or excitation) on orbital i (with energy i). Since

p; i is interpreted as a state with i particles on orbital i.

The CAO's of sl(1n) together with the Hamiltonian (2.18) generate gl(1n). Then, in view of (2.19), f_1 ;:::; f_n , considered as operators in any W (p;n), generate gl(1n). For this reason we call the CAO's of sl(1n) also Jacobson generators [6] of gl(1n).

The Pauli principle for A-superstatistics follows basically from equation (2.10) and the form of the vectors (2.13). These relations imply that the system can accommodate up to m in (p;n), but no m ore than m in (p;n) particles, in such a way that every orbital contains at most one particle.

Note that in the atypical cases (p < n) the Pauli principle introduces an interaction, a statistical interaction, between the orbitals. For instance if the system is in the state with $_1 = :::=_p = 1$ and $_{p+1} = :::=_n = 0$, then it cannot accommodate more particles, not even on the empty orbitals with i > p. Therefore the orbitals are not led independently. The lling of a given orbital depends on llings of all other orbitals, which is the main feature of exclusion statistics [13]. Observe also that A-superstatistics is closely related to ordinary Ferm i statistics: the only extra condition comes from the order of statistics p.

3 Quasi-Ferm i creation and annihilation operators

In the present section we discuss some dierences and similarities between A-super-statistics and ordinary Ferm i statistics. First of all, observe that there is an important dierence between the Fock spaces W (p;n) with p < n and those with p = n. For p < n, the irreducible sl(1jn) representations are atypical, and their dimension is given by:

For this reason, the operators F (p), are said to be quasi-Ferm i creation and annihilation operators. For large p-values, they tend to ordinary Ferm i creation and annihilation operators.

It is interesting to consider the anti-com mutators of the quasi-Fermi creation and annihilation operators, acting in the Fermi Fock space W (n). From (3.10)-(3.11) one obtains

Com pare again with (3.6) to see that the above anti-com mutators tend to ordinary Ferm i anticom mutators when p tends to in nity. Also in this sense, the quasi-Ferm i creation and annihilation operators $(F(p)_i)$ can be considered as \deformations" of ordinary Ferm i creation and annihilation operators, with the integer p (the order of statistics) as a deformation parameter.

In such a way we have expressed all Weylgenerators fe_{ij} ji; j=0; 1; ...; ng ofgl(1jn) via n pairs of Ferm in parators. Let us mention that the \frac{1}{1} ferm initiation (3.21)-(3.22) of the Jacobson generators of sl(1jn) is not new. It is known as the Holstein-Primako realization of sl(1jn) [14]. The use of boson or ferm ion operators to construct representations of Lie algebras or Lie superalgebras has a long history. For Lie superalgebras, see [15, 16] for a realization of the algebra in terms of Bose and Ferm i operators and a construction of the corresponding representations.

Finally, we wish to mention that the Jacobson generators of gl(1jn) and the considered Fock representations W(p;n) (or equivalently, the quasi-Ferm in operators) are in plicitly present in certain physical models.

Examples from condensed matter physics include mainly models related in one or another way to high-tem perature superconductivity. We have in mind those lattice models of strongly correlated electron systems where (the electronic part of) the Hamiltonian is expressed in terms of Hubbard operators (X-operators) [17] as for instance in [18] or in [19]. In such models, each Hubbard operator is labeled by three indices, X_A^{ij} , where A refers to the lattice site and $i;j=0;1;\ldots;N$, if the (combined spin-avor) degrees of freedom (the number of the orbitals) of the electrons at each xed site are N . For any site the operators X_A^{i0} and X_A^{0i} , $i=1;\ldots;N$, are said to be ferm ion-like generators (or of odd degree), whereas X_A^{00} , X_A^{ij} , $i;j=1;\ldots;N$ are boson-like generators (or of even degree). The X-operators obey the relations

So the conclusion is that the operators $X_A^{\ k0}$ and $X_A^{\ 0k}$, creating and annihilating electrons at site A, are not Ferm i operators. They are creation and annihilation

operators of the Lie superalgebra gl(1 jn). The statistics of the electrons or of any other (quasi)particles described with these operators is not Ferm i statistics, it is A-superstatistics of order p.

In nuclear shell model theory the operators with the above properties are called ideal odd-particle (IDP) creation and annihilation operators [21]. O kubo [22] refers to the algebra of IDP operators as to the Marshalek algebra. The IDP operators play a relevant role for the description of properties of odd nuclei in the frame of the nuclear shell model (see the review article [23] and references therein).

4 M acroscopic properties of A-superstatistics

To describe the macroscopic properties of A-superstatistics for the Ham iltonian H with orbitals i (i = 1; :::; n), see (2.18), it is for us irrelevant whether the dierent orbitals correspond to dierent particles, to dierent energy levels of particles, or to dierent internal states of the particles. The only assumption is that they satisfy the Pauliprinciple for A-superstatistics, which follows from the Fock space construction.

As usually, we assume that the system is in a thermal and discontact and in a thermal and discontact equilibrium with a much bigger reservoir. We denote by its (fundamental) temperature, by $_{\rm i}$ the chemical potential and by $_{\rm i}$ the energy for the particles on orbital i.

The probability P (p;n;) for the system to be in a (quantum) state = $(1;:::;_n)$ with j = 1 + particles and energy E = 1 + particles and energy E = 1 + particles is given by the expression

The numerator in this expression is the G ibbs factor of the system in the state , and Z (p;n) is the grand partition function (GPF) of the system. In the case of Bose or Ferm i statistics or their generalizations (G reen parastatistics [1]), the GPF is simply a product of the GPFs of all orbitals. This is due to the fact that for those statistics the di erent orbitals can be considered as independent subsystems: the lling of each orbital is completely independent of the number of particles that have already been accommodated on the other orbitals. Here due to the new Pauli principle this is no longer the case if p < n. Therefore we have to compute directly the GPF for the whole system. The latter as usual is the sum of the G ibbs factors

over all possible states of the system. So we have:

Since all macroscopic properties are encapsulated in the grand partition function, this observation also implies that A-superstatistics with p = n has the same macroscopic properties as ordinary Ferm i statistics. So the case p = n = 1 can be considered as the smallest deviation from Ferm i statistics, as far as the macroscopic properties are concerned. In the following, we shall sometimes pay special attention to the p = n = 1 case, and compare it with the properties of Ferm i statistics.




Figure 1: Dependence of the average number of particles on the i-th orbital $_{i}$ upon the variable y = ()= , for xed n = 5, and p = 1;2;3;4;5. The distribution $_{i}$ is independent of i since we consider the degenerate case here. For p = n = 5, the distribution function coincides with the Ferm i-D irac distribution; for p < n it is dierent and $_{i}$ cannot exceed p=n.

In Figure 1, we plot $_i$ for p=1;2;:::;5. The case p=n=5 yields the known Ferm i-D irac distribution function. For p>n, the distribution function is the same. For p<n=5, the distribution function is dierent. The dierence is most noticable for p<n=5, as the average number of particles cannot exceed p=n.

Therefore if the system contains a particle, it is \sitting" perm anently on the rst (i.e. the lowest) energy orbital. This also explains why N (1;n) $_1$. To illustrate these ideas, we plot the values of the average number of particles $_1$ on orbital i, in the case p=1 and n=5 (ve equidistant energy levels), as a function of q, see Figure 3. For any value of q (0 < q < 1), $_1$ > $_2$ > $_3$ > $_4$ > $_5$. For small values of q, $_1$ is the large and the other averages close to zero. For increasing values of q, the averages on the other orbitals become larger.

7 Concluding remarks

In this paper we have studied the m icroscopic and therm al (m acroscopic) properties of \free" particles, interacting only via statistical interaction. This interaction follows from the Pauli principle of A—superstatistics: the system cannot accommodate more than p particles if the order of statistics is p, irrespective of the number of available orbitals (which may even be in nite).

A-superstatistics is de ned by the triple relations (2.4)-(2.6) which should hold for the creation and annihilation operators. The Fock spaces for A-superstatistics are naturally related to certain representations of the Lie superalgebra sl(1jn), and are labeled by a positive integer p referred to as the order of statistics. It is the mathematical structure of the Fock spaces that gives rise to the Pauli principle of A-superstatistics.

It is shown that the creation and annihilation operators of A -superstatistics are ferm ion-like. Just like ordinary Ferm ioperators, the creation (resp. annihilation) operators anti-com mute. However, they do not satisfy all traditional Ferm i relations: only in the limit p! 1 do the remaining relations tend to the ordinary Ferm i relations. It may be unusual and unconventional to consider such alternative creation and annihilation operators. However, we show that (representations of) such operators have already appeared in physical models, proving their applicability.

In the second part of the paper we focus on the macroscopic properties of A – superstatistics, for a free H am iltonian. The usual therm alfunctions (grand partition

function, average number of particles, orbital distribution, average energy, :::) are expressed in terms of elementary symmetric functions, and can be considered as deviations of the usual Fermi case when p < n.




Figure 2: Dependence of the average number of particles N (p;n) upon the variable y = ()= , for xed p = 1, and n = 1;2;3;4;5, in the degenerate case. The graph of N (1;1) is the closest to the y-axis, then N (1;2), etc. Observe that the graph of N (1;1) coincides with the Ferm i-D irac distribution.

In addition to the general case, we have considered two speci c examples. The case with identical energy levels per orbital (degenerate case) leads to further $\sin p$ lications of the thermal functions, and the deviation from Fermi statistics (for p < n) becomes more apparent. The corresponding distribution functions are reminiscent of the Fermi-Dirac case, but there are also some striking dierences (see Figures 1 and 2).




Figure 3: G raphs of the average number of particles $_{i}$ on the i-th orbital, for p=1, n=5, and i=1;2;3;4;5. The distribution $_{i}$ is plotted as a function of $q=\exp{(\ =\)}$, where $_{i}$ is the gap between the equidistant energy levels.

The case with equidistant energy levels is interesting from the mathematical point of view, since the thermal functions have simple expressions in terms of queries (or basic hypergeometric series). This can be considered as a q-deformation of the degenerate case, and in fact the degenerate case can be deduced from the current one under the limit q! 1. Also the situation with equidistant energy levels yields some interesting physical interpretations, e.g. concerning the orbital distribution (see Figure 3).

In this paper, A -superstatistics was introduced mainly on the ground of mathematical considerations. Therefore, a natural next step would be to use this statistics for studying real physical objects or phenomena like an ideal A -gas or the quantum Halle ect, or statistics of cosmic rays etc. Such a study also includes a comparison of the obtained results with existing experimental data or with the predictions of other noncanonical quantum statistics (parastatistics, fractional statistics, quon statistics, anyons statistics, T sallis statistics or quantum group noncommutative statistics). We hope to return to this issue elsewhere.
