# Leaky Q uantum G raphs: A pproxim ations by P oint Interaction H am iltonians

A bstract
W e prove an approxim ation result show ing how operators of the type ( $\mathrm{x} \quad$ ) in $\mathrm{L}^{2}\left(\mathrm{R}^{2}\right)$, where is a graph, can be m odeled in the strong resolvent sense by point-interaction $H$ am iltonians w ith an appropriate arrangem ent of the potentials. T he result is ilhustrated on nding the spectral properties in cases when is a ring or a star. Furtherm ore, we use this $m$ ethod to indicate that scattering on an in nite curve which is locally close to a loop shape or has m ultiple bends may exhibit resonances due to quantum tunneling or repeated re ections.

## 1 Introduction

The $m$ ain aim of this paper is to discuss a lim iting relation between two classes of generalized Schrodinger operators in $L^{2}\left(R^{2}\right)$. O ne of them are $m$ easure-type perturbations of the Laplacian, in particular, we will be interested in potentials which are a negative multiple of the $D$ irac m easure supported by a nite graph $R^{2}$, in other words, they are form ally given by the expression

w ith som e > 0.W e are going to show that such operators can be approxi$m$ ated in the strong resolvent sense by fam ilies of point-interaction $H$ am ilto-


Stated in this way the problem is an interesting $m$ athem atical question; the indicated result $w$ ill represent an extension the approxim ation theorem derived in ${ }^{[ }{ }^{-1}$ ward because properties of the potentials are dim ension-dependent. In addition, we have a strong physical m otivation com ing from the fact that H am iltonians of the type ( $\overline{1} \overline{\bar{\prime}} \overline{\mathrm{I}}$ ') are good $m$ odels of various graph-type nanostructures which in distinction to the usual description ${ }_{[K}^{\mathbb{K}}$. tunneling into account \{ see Exili for a bibliography to this problem .

To investigate such $m$ odels one has to nd spectral properties of the operator (1]. 1 I') for various shapes of . This is in general a com plicated task even if the original PDE problem $s$ is reform ulated by $m$ eans of the generalized Bim an-Schw inger principle $\bar{B} \mathrm{E}^{-} \overline{\mathrm{K}}$ ] into solution of an appropriate integralequation. On the other hand, spectral problem for point-interaction H am iltonians is reduced in a standard way to solution of an algebraic equation w ith coe cients containing values of the free $G$ reen function. H ence an approxim ation of the $m$ entioned type would be of practical im portance; our second aim is to illustrate this aspect of the problem on exam ples.

Let us describe brie y contents of the paper. In the next section we collect the needed prelim inaries stated in a w ay suitable for the further argum ent. In Section ' indicated above. In the follow ing two sections we discuss exam ples of two simple graph classes. The rst are graphs of the form of a ring, full or open. In this case the spectrum of the operator (1, $\overline{1} \mathbf{I} \mathbf{I})$ can be found by m ode $m$ atching $\left.\left[\mathbb{E}_{-1}\right]_{1}^{\prime}\right]$ which enables us to com pare the approxim ation $w$ th the \exact" result, in particular, to assess the rate of its convergence. In contrast, in Section ' num erical solution of the spectralproblem ism issing, how ever, we can derive several conclusions for (an in nite) star analytically and show how does the approxim ation results conform with them. Com putations of this type were
 to provide a reasonable approxim ation.

In the last section we address another question which is $m$ ore di cult and no analytical results are available presently. It concems the scattering problem on in nite leaky graphs w th asym ptotically straight \leads". On a heuristic level, it is natural to expect that the states from the negative part
of the continuous spectrum can propagate being transversally con ned to the graph edges, hence a nontrivial geom etry should yield an $N \mathrm{~N}$ on-shell scattering $m$ atrix, where $N$ is the number of the leads. This rem ains to be proved, how ever, and even more di cult it w ill be to com pute the $\mathrm{S}-\mathrm{m}$ atrix $m$ entioned above in term $s$ of the graph geom etry.

For sim plicity we will restrict ourselves to the sim plest case when is an in nite asym ptotically straight curve, i.e. $N=2$, w ithout self-intersections. O ne natural conjecture is that if the distance between the curve points is sm all som ew here so that is close to a loop shape locally, the system can exhibit resonances due to quantum tunneling. On the other hand, simple bends are unlikely to produce distinguished resonances; the reason is that the transverse coupling in,$(\overline{1}: 1)$ has a single bound state, hence there is no analog here to higher thresholds which give rise to resonances in bent hardwall tubes $\left.\overline{T N}^{-} \bar{E}^{-1}{ }^{\prime}\right]$. To support these con jectures, we have let us inspire by the so-called $\mathrm{L}^{2}$ approach to resonances, which was in the one-dim ensional case set on a rigorous ground in $\left.{ }_{[-1]}^{[1} \bar{M}_{i}^{\prime}\right]$. Speci cally, we study the spectrum of a nite segm ent of as a function of the cut-o position. In the rst case we nd in this dependence avoided eigenvalue crossings, the m ore narrow the sm aller the gap to tunnel is, while no such e ect is seen in the second case.

On the other hand, a tunneling between arcw ise distant points of the graphs is not the only source of resonances. To illustrate this claim, we analyze in our last exam ple a Z-shaped graph w th two shanp bends separated by a line segm ent. W e nd again avoided crossings the widths of which vary widely as functions of the bending angle. This provides an indirect but convincing indication that the above described on-shell $S$-m atrix for a bent curve in the shape of a broken line is nontrivial.

## 2 Prelim inaries

### 2.1 G eneralized Sch rodinger operators

$W$ e start $w$ th the de nition of Schrodinger operators of the form m in $L^{2}\left(\mathbb{R}^{2}\right)$, where $m$ is a nite positive $m$ easure on the Borel -algebra of , which is assum ed to be a non-em pty closed subset of $R^{2}$ and also the support of the $m$ easure $m$. is lower sem itbounded and closed in $L^{2}\left(R^{2}\right)$. Hence there exists a unique self-adjoint operator $H \mathrm{~m}$ associated w ith the form $\mathrm{q}_{\mathrm{m}}$.
$T$ he described de nition applies to $m$ ore general class of $m$ easures than we need here. If is a graph consisting of a locally nite num ber of sm ooth edgesm eeting at nonzero angles, i.e. having no cusps, there is another way to de ne $H$ m , nam ely via boundary conditions im posed on the wavefunctions. To this aim, consider rst the operator $\mathrm{H}_{\mathrm{m}}$ acting as

Then $\mathbb{H}$ is straightforw ard to check that $\mathrm{H}_{\mathrm{m}}$ is e.s.a. and by G reen's form ula it reproduces the form $q_{m}$ on its core, so its closure $m$ ay be identi ed with H m de ned above.

An im portant tool to analyze spectra of such operators is the generalized $B$ irm an-Schw inger $m$ ethod. ### 2.2 Schrodinger operators with point interactions

C onsider a discrete and nite subset $Y$ and the positive constant de ned above. A s it is well known we cannot regard the operator $H_{Y}$; $w$ ith the interaction supported by Y as before, i.e. as ' + m easure'. Instead, we de ne this operator via its dom ain: each function $2 \mathrm{D}\left(\mathrm{H}_{\mathrm{Y}} ;\right.$ ) behaves in the vicinity of a point a 2 Y as follow s

The form (2.111) which we have chosen is adapted for the indicated use of these operator in the approxim ation. In particular, the coupling param eter IY $j$ depends linearly on the cardinality of the set Y. How ever, it is im portant to stress that ourproblem di ers substantially form itsthree-dim ensional analogue considered in $\left[-\overline{\mathrm{B}}=\mathrm{T}_{1}^{-1}\right]$ w here no sign of played a preferred role. In
the tw o-dim ensional setting the coupling param eter tends to 1 in the lim it of weak and strong coupling, respectively. C onsequently, we will be able to nd an approxim ation for operators ( $1 \mathbf{1}_{1}^{(1)}$ ) w th attractive interactions only.

The K rein's form ula for the resolvent ( $\left.\mathrm{H}_{\mathrm{Y}} ; \quad \mathrm{z}\right)^{1}$ is the basic ingredient in the spectral analysis of the point-interaction H am iltonians.

O ne can see easily that the $m$ atrix $y ;\left(k^{2}\right)$ is invertible for su ciently large negative $z={ }^{2}$. Indeed, the diagonal part is dom inated by the term $\frac{1}{2} \log$, while the non-diagonal elem ents vanish as ! 1 , see the asym $p-$
 choioe of the coupling, an altemative way how to $m$ ake the $m$ atrix $y$; invertible is to take a su ciently large set $Y$.

## 3 A pproxim ation by Schrodinger O perators w ith P oint Interactions

W ith the above prelim inaries we can proceed to the m ain goal \{ we w illprove that for a chosen generalized Schrodinger operatorw ith an attractive interaction one can nd an approxim ating sequence of point-potential Schrodinger operators under requirem ents which w ill be speci ed below .

The assum ption about positions ofthe point potentials is obvious \{ loosely speaking, as the sites of potentials are getting denser in the set , they must copy the $m$ easure. Then we have to specify the coupling-constant behaviour in the approxim ating operators. $W$ e have already $m$ entioned that in the analogous situation in dim ension three the coupling constants scale by [BETM] linearly w th the num ber jy jof point potentials, and suggested the sam e behaviour here. T his requires an explanation, because it is well known that the coupling constants are $m$ anifested di erently in dim ension three and two; just consider a pair of point potentials and let their distance vary.

To get a hint that the scaling behavior for the approxim ation rem ains

Now let the number n increase. If we want to keep the solution preserved as $n!1$, then $m$ ust grow linearly $w$ th $n$; recall that for $>0$ this $m$ eans that the individual point interactions are becom ing weaker. ## 4 Soft ring graphs

Let us now pass to exam ples. The rst class of graphs to which we apply the approxim ation developed in the Section $i \overline{-1}$, are rings, both full or open. Since the spectral properties of $H$ am iltonians $w$ ith interaction supported by these ring graphs were already explored in the paper $\left.\mathbb{E}_{-1}^{-1}\right]$ \{ see also the threedim ensionalanalogue discussed earlier in $\left[\hat{A}-\bar{G} \bar{S}_{1}^{1}\right]\{$ this gives us an opportunity to com pare the approxim ation $w$ ith the \exact" results, in particular, to asses the convergence rate of the approxim ation.

Every eigenstate except the ground state is tw ice degenerate. In contrast, for a cut ring, $>0$, the spectrum is simple; the problem can be solved num erically by the m ode-


W e start the presentation of the num erical results $w$ ith the full ring. $F$ irst, we put $R=10$ and $=0: 5$. The discrete spectrum of $H ;$ iR consists of three eigenvalues, the ground state corresponds to the angular $m$ om entum $l=0$, the other two correspond to $l=1$; 2 , respectively, and they are twice degenerate; the number of eigenvalues is given be the inequality $R>2 j j$.

In case of a stronger interaction, $=1$, one gets a sim ilar picture, just the num ber of levels rises to ve, see Fig. eigenvalues is slow er than it is for the previous system. To estim ate the rate of convergence, we calculate the di erence betw een the exact eigenvalue and the eigenvalue com puted using the approxim ation. The result is shown in Fig. ${ }^{1}-1$, we observe that the aforem entioned di erence decays roughly as N a w ith a being less than 1 .

A closer inspection of the eigenfunctions ( (14) show S, of course, a logarithm ic peak at the site of each point potential, as pictures Fig. in and Fig. 'in dem onstrate. To our opinion the contributions to energy com ing from these spikes are responsible for the slow convergence of the approxim ation.

N ext, we consider an open ring, $==3$, i.e. one sixth of the perim eter is $m$ issing. For exam ple, the fth excited state for $R=10$ and $=1$ has the energy $\mathrm{E}_{5}=0: 151$, the corresponding eigenfunction is show n in F ig.'i- ${ }_{-1}$. The approxim ation by 1000 point potentials yields the energy $\mathrm{E}_{5}^{0}=0: 116$ and the corresponding eigenfunction shown in $F$ ig. ${ }^{\prime} \mathrm{I}_{1}$.

## 5 Star-shaped graphs

A nother class of leaky-graph system s to which we will apply the approxi$m$ ation by point-interaction H am ittonians are the star-graph H am iltonians where is a collection of segm ents coupled at a point. In distinction to the previous section no \direct" $m$ ethod to solve the problem is available in this case, and thus the approxim ation represents the only way how to obtain a num erical description of the eigenvalues and eigenfunctions.
$F$ irst we want to $m$ ake a rem ark about niteness of such graphs. O ur interest concems prim arily in nite stars in which the arm s are hal ines, in particular, since they support localized states despite the fact that the graph geom etry would allow escape to in nity. On the other hand, the above approxim ation result applies to nite graphs only because it requires $m$ to be nite. N evertheless, the result can be used, due to the fact that the in nite star H am iltonian is approxim ated, again in the strong resolvent sense, by a fam ily of operators w ith cut-o stars. To justify this claim, it is su cient to realize that the corresponding fam ily of quadratic form $s$ is by (2, m onotonous and bounded from below, so that Thm .V III. 3.11 of ${ }_{\mathrm{k}}{ }^{-}$à a applies.

### 5.5 N um erical results

H aving explained analytically how does the discrete spectrum of $H_{N}()$ depend on the num ber ofarm sand the angles, weem ploy now the approxim ation by point-potentialSchrodinger operators to obtain the num erical results for cut-o stars which would illustrate the above conclusions.

Consider a two-arms star graph 1 w ith both arms having the same length, $L_{1}=L_{2}=300$, and put $=0: 1$. Aswe already know, the threshold of the continuous spectrum of $\mathrm{H}_{2}\left(\mathrm{l}\right.$ is ${ }^{2}=4=0: 0025 . \mathrm{W}$ e approxim ate $\mathrm{H}_{2}\left(\mathrm{)}\right.$ by point-potential Schrodinger operator $\mathrm{H}_{\mathrm{Y}}$; that has 1 potential on the center of the star graph and 200 equidistant point potentials on each arm . O nly the low er part of the discrete spectrum of $H_{Y}$; approxim ates the discrete spectrum of the star-graph operator, while the upper part corresponds to the interval [ ${ }^{2}=4 ; 0$ ] ess $\left(\mathrm{H}_{2}()\right)$. Therefore only the states $w$ ith energy below the threshold $m$ ay be indeed understood as the approxim ation of the bound states of $\mathrm{H}_{2}()$.

The $m$ ain result of the analytic argum ent presented above was the dependence of the eigenvalues on the angle : if decreases, the eigenvalues decrease and their num ber grow s. T he discrete spectrum of $H_{Y}$; for varying is in a good agreem ent w ith this fact as Fig. ${ }_{1}^{\prime \prime}$ crossings we observe are actual, which is a consequence of the sym $m$ etry of
the graph ${ }_{1}$ ．For a non－sym $m$ etric graph the crossings becom e avoided．To dem onstrate it in Fig．＇⿳⺈⿴囗十一日寸，we slightly change the length of one arm， $\mathrm{L}_{2}=306$ ， while the other param eters are preserved．A lso the setting of the point po－ tentials approxim ating the new graph 2 stays the sam e，up to extra four potentials added on the longer arm ．

We lim it ourselves to a pair of exam ples: the ground state of $H_{6}()$ in $F i g$. $1 \overline{1} \overline{0}$ and the third excited state of $H_{10}()$ in Fig. in in. The length of the cut arm sis 30 , in the form er case the approxim ating operator $H_{Y}$; has 601 point potentials and in the latter case the num ber of point potentials is 1001. W e see, in particular, that for N large enough $\mathrm{H}_{\mathrm{N}}() \mathrm{m}$ ay have closed nodal lines; it is an interesting question what is the $m$ inim aln forwhich this happens.

## $6 \quad L^{2}$-approach to resonances

O ur last exam ple, as indicated in the introduction, conœms the situation when is a single in nite curve; we want to see whether resonances in the scattering of states propagating along $m$ ay be detected by inspecting the spectrum of the cut-o problem with the curve of a nite length which is a param eter to be varied.

C onsider a curve from F ig. 122 in it centralpart consists of three segm ents of a circle w ith the radius $\mathrm{R}=10$ and it has tw o in nite \legs". T he distance betw een tw o closest points of the curve, i.e. the bottleneck w idth, is denoted by . The coupling constant equals 1. W e cut the \legs" of the graph to a nite length $L$ and we plot the eigenvalues com puted using the approxim ation
for $L$ varying. The num ber of the point potentials involved in $H_{Y}$; is chosen so that the distance betw een every two ad jacent points equals $0: 3$. For sm all values $=1: 9$ and $=2: 9$ the tunneling e ect occurs and we can see the plateaux in $F$ igs. 1 of the avoided crossings increase with as expected. O $n$ the other hand, for m ore open curve, $=5: 2$, we get a di erent picture, where the plateaux are absent, see Fig.

The second graph type we are interested in are sim ple bends, in term $s$ of Section ${ }_{1}{ }_{-1}$ it is a two-arm star ( ). A swe have already mentioned, the avoided eigenvalue crossings are not expected here because the transport along the graph am involves a single transverse $m$ ode $\{$ this is con m ed in Fig. 'í $\overline{1}$, , which show s the results of the cut-o m ethod for $==4$.
$F$ inally to illustrate that resonances $m$ ay also result from $m$ ultiple re ections rather than from a tunneling, we apply the cut-o method to graphs which are of a stair-type, or Z-shaped. They consists of three line segm ents: the central one has a nite length $R$, i.e. the \heigth" of the stair, the other two are parallel (cut-o ) hal ines. If the angle betw een the segm ents is less than $=2$ the term Z-shaped is $m$ ore appropriate. $T$ he results for $R=10$ and
 to $=0: 32$, in the latter we have $=$; the distance between the point potentials of the approxim ating operator $H_{y}$; equals $0: 1 . \mathrm{We}$ nd avoided crossings, how ever, they are very narrow for $=0: 32$ and barely visible in the right-angle case; this observation can be naturally understood in term s of the re ection probability through a single bend \{ com pare w ith the angle dependence of the spectrum on $F$ ig.
