Leaky Quantum Graphs: Approximations by Point Interaction Hamiltonians

A bstract

We prove an approximation result showing how operators of the type (x) in L $^2(R^2)$, where is a graph, can be modeled in the strong resolvent sense by point-interaction H am iltonians with an appropriate arrangement of the potentials. The result is illustrated on noting the spectral properties in cases when is a ring or a star. Furthermore, we use this method to indicate that scattering on an in nite curve which is locally close to a loop shape or has multiple bends may exhibit resonances due to quantum tunneling or repeated rejections.

1 Introduction

The main aim of this paper is to discuss a limiting relation between two classes of generalized Schrödinger operators in $L^2(\mathbb{R}^2)$. One of them are measure-type perturbations of the Laplacian, in particular, we will be interested in potentials which are a negative multiple of the Dirac measure supported by a nite graph \mathbb{R}^2 , in other words, they are formally given by the expression

with some > 0. We are going to show that such operators can be approximated in the strong resolvent sense by families of point-interaction Hamiltonians [AGHH] with two-dimensional potentials suitably arranged.

Stated in this way the problem is an interesting mathematical question; the indicated result will represent an extension the approximation theorem derived in BFT] to the two-dimensional situation, which is not straightforward because properties of the potentials are dimension-dependent. In addition, we have a strong physical motivation coming from the fact that Hamiltonians of the type (1.1) are good models of various graph-type nanostructures which in distinction to the usual description [KS] take quantum tunneling into account $\{see [Ex1] \text{ for a bibliography to this problem.}$

To investigate such models one has to not spectral properties of the operator (1.1) for various shapes of . This is in general a complicated task even if the original PDE problems is reformulated by means of the generalized Birman-Schwinger principle [BEKS] into solution of an appropriate integral equation. On the other hand, spectral problem for point-interaction Hamiltonians is reduced in a standard way to solution of an algebraic equation with coe cients containing values of the free Green function. Hence an approximation of the mentioned type would be of practical importance; our second aim is to illustrate this aspect of the problem on examples.

Let us describe brie y contents of the paper. In the next section we collect the needed prelim inaries stated in a way suitable for the further argument. In Section 3 we form ulate and prove our main result, which is the approximation indicated above. In the following two sections we discuss examples of two simple graph classes. The rst are graphs of the form of a ring, full or open. In this case the spectrum of the operator (1.1) can be found by mode matching [ET] which enables us to compare the approximation with the \exact" result, in particular, to assess the rate of its convergence. In contrast, in Section 5 we discuss star-shaped graphs. Here an alternative method for numerical solution of the spectral problem is missing, however, we can derive several conclusions for (an in nite) star analytically and show how does the approximation results conform with them. Computations of this type were performed already in [EN] but the number of points used there was too small to provide a reasonable approximation.

In the last section we address another question which is more dicult and no analytical results are available presently. It concerns the scattering problem on in nite leaky graphs with asymptotically straight \leads". On a heuristic level, it is natural to expect that the states from the negative part

of the continuous spectrum can propagate being transversally con ned to the graph edges, hence a nontrivial geometry should yield an N N on-shell scattering matrix, where N is the number of the leads. This remains to be proved, however, and even more dicult it will be to compute the S-matrix mentioned above in terms of the graph geometry.

For simplicity we will restrict ourselves to the simplest case when is an in nite asymptotically straight curve, i.e. N=2, without self-intersections. One natural conjecture is that if the distance between the curve points is small somewhere so that is close to a loop shape locally, the system can exhibit resonances due to quantum tunneling. On the other hand, simple bends are unlikely to produce distinguished resonances; the reason is that the transverse coupling in (1.1) has a single bound state, hence there is no analog here to higher thresholds which give rise to resonances in bent hardwall tubes [DEM]. To support these conjectures, we have let us inspire by the so-called L^2 approach to resonances, which was in the one-dimensional case set on a rigorous ground in [HM]. Speci cally, we study the spectrum of a nite segment of as a function of the cut-o position. In the rst case we not in this dependence avoided eigenvalue crossings, the more narrow the smaller the gap to tunnel is, while no such elect is seen in the second case.

On the other hand, a tunneling between arcwise distant points of the graphs is not the only source of resonances. To illustrate this claim, we analyze in our last example a Z-shaped graph with two sharp bends separated by a line segment. We not again avoided crossings the widths of which vary widely as functions of the bending angle. This provides an indirect but convincing indication that the above described on-shell S-m atrix for a bent curve in the shape of a broken line is nontrivial.

2 P relim inaries

2.1 Generalized Schrodinger operators

We start with the de nition of Schrodinger operators of the form m in $L^2(R^2)$, where m is a nite positive measure on the Borel -algebra of , which is assumed to be a non-empty closed subset of R^2 and also the support of the measure m . Furthermore, is a bounded and continuous function, acting from to R_+ . We suppose that the measure m belongs to the generalized K ato class, in two-dimensional case it means that the

where B (x;") denotes the circle of radius "centered at x.

Due to the fact that the measure m belongs to K ato class, for each a>0 there exists b 2 R such that any from the Schwartz space S (\mathbb{R}^2) satisfies the inequality

as it was proven in the paper [SV]. Since S (\mathbb{R}^2) is dense in H 1 (\mathbb{R}^2) we can de ne a bounded linear transform ation

is lower sem i-bounded and closed in $L^2(\mathbb{R}^2)$. Hence there exists a unique self-adjoint operator H $_m$ associated with the form q_m .

The described de nition applies to more general class of measures than we need here. If is a graph consisting of a locally nite number of smooth edges meeting at nonzero angles, i.e. having no cusps, there is another way to de ne H $_{\rm m}$, namely via boundary conditions imposed on the wavefunctions. To this aim, consider st the operator H- $_{\rm m}$ acting as

Then it is straightforward to check that H_m is e.s.a. and by G reen's form ula it reproduces the form q_m on its core, so its closure may be identied with H_m de ned above.

An important tool to analyze spectra of such operators is the generalized B irm an–Schwinger method. If k^2 belongs to the resolvent set of H $_m$ we put R $_m^k$: (H $_m$ k^2) $_n^1$. The free resolvent R $_0^k$ is defined for Im k>0 as an integral operator with the kernel

Now we shall use R_0^k to de ne three other operators. For the sake of generality, suppose that ; are positive Radon measures on R^2 with (x) = (x) = 0 for any $x \ 2 \ R^2$. W ith this notation one can express the resolvent R $_{\rm m}^{\rm k}$ as follows [BEKS]:

The invertibility hypothesis is satis ed for all su ciently large negative k^2 because for such a k^2 the operator norm of $R_{m,m}$ (z) acting in L^2 (m) is less than 1, see again [BEKS], and similar result can be proven for the operator norm in L^1 (m) following [BFT]. Thus from now on we consider $k^2 < 0$ such that both these norms are less than one.

For later considerations it is useful we rewrite operator H $_{\rm m}$ = $\,$ m in the form $\,$ 1 , where we have introduced

Since R_0^k belongs to $H^2(R^2)$, using Sobolev's embedding theorem we conclude that it has a bounded and continuous version, and therefore also has a representative which is bounded and continuous on the set $S := fx \ 2 : (x) \in Og$.

2.2 Schrodinger operators with point interactions

Consider a discrete and nite subset Y and the positive constant de ned above. As it is well known we cannot regard the operator H_Y ; with the interaction supported by Y as before, i.e. as ' + measure'. Instead, we de ne this operator via its domain: each function 2 D (H_Y ;) behaves in the vicinity of a point a 2 Y as follows

The form (2.11) which we have chosen is adapted for the indicated use of these operator in the approximation. In particular, the coupling parameter jy j depends linearly on the cardinality of the set Y. However, it is important to stress that our problem diers substantially form its three-dimensional analogue considered in [BFT] where no sign of played a preferred role. In

the two-dimensional setting the coupling parameter tends to 1 in the limit of weak and strong coupling, respectively. Consequently, we will be able to nd an approximation for operators (1.1) with attractive interactions only.

The K rein's formula for the resolvent (H $_{\rm Y}$; z) 1 is the basic ingredient in the spectral analysis of the point-interaction H am iltonians.

One can see easily that the matrix $_{Y}$; (k^2) is invertible for succiently large negative $z=\frac{2}{2}$. Indeed, the diagonal part is dominated by the term $\frac{1}{2}$ log, while the non-diagonal elements vanish as ! 1, see the asymptotic formula [AS, 92.7] for the Hankel function $H_0^{(1)}$. In view of our special choice of the coupling, an alternative way how to make the matrix $_{Y}$; invertible is to take a succiently large set Y.

3 Approximation by Schrodinger Operators with Point Interactions

With the above preliminaries we can proceed to the main goal { we will prove that for a chosen generalized Schrodinger operator with an attractive interaction one can indian approximating sequence of point-potential Schrodinger operators under requirements which will be specified below.

The assumption about positions of the point potentials is obvious { loosely speaking, as the sites of potentials are getting denser in the set , they must copy the measure . Then we have to specify the coupling-constant behaviour in the approximating operators. We have already mentioned that in the analogous situation in dimension three the coupling constants scale by [BFT] linearly with the number jy j of point potentials, and suggested the same behaviour here. This requires an explanation, because it is well known that the coupling constants are manifested dierently in dimension three and two; just consider a pair of point potentials and let their distance vary.

To get a hint that the scaling behavior for the approximation remains nevertheless the same, consider an in nite straight polymer as in [AGHH, III.4], denote the coupling constant by and the period by l_0 n 1 . The threshold of the continuous spectrum is given as the unique solution E = 2 to the implicit equation

Now let the number n increase. If we want to keep the solution preserved as n! 1, then must grow linearly with n; recall that for > 0 this means that the individual point interactions are becoming weaker. This motivates the choice of the coupling constants in the form jy j which we made in the boundary condition (2.11).

Now we can prove the announced approximation result.

4 Soft ring graphs

Let us now pass to examples. The rst class of graphs to which we apply the approximation developed in the Section 3 are rings, both full or open. Since the spectral properties of H am iltonians with interaction supported by these ring graphs were already explored in the paper [ET] { see also the three-dimensional analogue discussed earlier in [AGS] { this gives us an opportunity to compare the approximation with the \exact" results, in particular, to asses the convergence rate of the approximation.

The Schrodinger operator with the interaction supported by given formally by (1.1) will be denoted by H $_{;R}$; it can be given meaning in either of the two ways described in Section 2. The spectrum and eigenfunctions are found easily in the full ring case, = 0, when H $_{;R}$ is reduced by the angular momentum subspaces. Every eigenstate except the ground state is twice degenerate. In contrast, for a cut ring, > 0, the spectrum is simple; the problem can be solved numerically by the modematching method [ET].

We start the presentation of the numerical results with the full ring. First, we put R=10 and =0.5. The discrete spectrum of H_{iR} consists of three eigenvalues, the ground state corresponds to the angular momentum l=0, the other two correspond to l=1; 2, respectively, and they are twice degenerate; the number of eigenvalues is given be the inequality R>2 j.j.




Figure 1: The dependence of eigenvalues of H_Y ; on the number of point potentials N for = 0.5 and the ring graph with R = 10. The dotted lines are the exact eigenvalues $E_0 = 0.0655$, $E_1 = 0.0524$, and $E_2 = 0.0207$.

We plot the eigenvalues of H_Y ; as $N = \gamma Y$ jincreases in Fig. 1.




Figure 2: The dependence of eigenvalues of H $_{\rm Y}$; on the number of point potentials N for = 1 and the ring graph with R = 10 . The dotted lines are the exact eigenvalues E $_0$ = 0.253, E $_1$ = 0.243, E $_2$ = 0.21, E $_3$ = 0.159, and E $_4$ = 0.0881.




Figure 3: The dependence of the error on the number of point potentials N in the logarithm ic scale. Dotted line corresponds to R=10 and =0.5 and the solid line corresponds to R=10 and =1.

In case of a stronger interaction, = 1, one gets a similar picture, just the number of levels rises to ve, see Fig. 2. Note that the convergence of eigenvalues is slower than it is for the previous system. To estimate the rate of convergence, we calculate the dierence between the exact eigenvalue and the eigenvalue computed using the approximation. The result is shown in Fig. 3, we observe that the aforementioned dierence decays roughly as N $^{\rm a}$ with a being less than 1.

The approximation by point-potential Schrodinger operators allows us to nd easily the eigenfunctions. By [AGHH, Thm . II.4.2], they can be written as a linear combination of the free Green functions:

where k_0^2 is the eigenvalue, i.e. det $_Y$; $(k_0^2) = 0$, and c is the solution to $_Y$; $(k_0^2)c = 0$. The eigenfunctions obtained in this way behave as one expects: they decrease exponentially ifm oving transversally away of the circle,




Figure 4: A detail of the wavefunction near the intersection of the circle and one of the nodal lines. It is the wavefunction of the third excited state (l=3) for R=10, =5 and 1/2 j=100.




Figure 5: A detail of the wavefunction of the third excited state (1 = 3) for R = 10, = 5 and Y = 100.

and for 1 > 0 they copy a sine function if moving along the circle. A closer inspection of the eigenfunctions (4.2) shows, of course, a logarithm ic peak at the site of each point potential, as pictures Fig. 4 and Fig. 5 demonstrate. To our opinion the contributions to energy coming from these spikes are responsible for the slow convergence of the approximation.




Figure 6: The wavefunction of the fith excited state of H $_{;R}$ for R = 10, = 1 and = =3. The solid line represents the ring .




Figure 7: The wavefunction of the fith excited state of H $_{\rm Y}$, for JY j= 1000, which approximates the fith excited state of H $_{\rm IR}$ from Fig. 6. The solid lines represent the nodal lines, the dotted line represents the graph .

Next, we consider an open ring, = 3, i.e. one sixth of the perim eter is m issing. For example, the fifth excited state for R=10 and =1 has the energy $E_5=0:151$, the corresponding eigenfunction is shown in Fig. 6. The approximation by 1000 point potentials yields the energy $E_5^0=0:116$ and the corresponding eigenfunction shown in Fig. 7.

5 Star-shaped graphs

A nother class of leaky-graph systems to which we will apply the approximation by point-interaction Hamiltonians are the star-graph Hamiltonians where is a collection of segments coupled at a point. In distinction to the previous section no \direct" method to solve the problem is available in this case, and thus the approximation represents the only way how to obtain a numerical description of the eigenvalues and eigenfunctions.

First we want to make a remark about niteness of such graphs. Our interest concerns primarily in nite stars in which the arms are hallines, in particular, since they support localized states despite the fact that the graph geometry would allow escape to in nity. On the other hand, the above approximation result applies to nite graphs only because it requires me to be nite. Nevertheless, the result can be used, due to the fact that the innite star Hamiltonian is approximated, again in the strong resolvent sense, by a family of operators with cut-ostars. To justify this claim, it is sucient to realize that the corresponding family of quadratic forms is by (2.3) me onotonous and bounded from below, so that Thm. VIII.3.11 of [Ka] applies.

Let us thus discuss in the beginning what can be derived analytically about in nite star graphs. Given an integer N 2, consider an (N 1)-tuple $= f_1; :::;_{N 1} g$ of positive numbers such that

The star-graph H am iltonians H $_{\rm N}$ () are de ned formally by (1.1) as Schrodinger operators with an attractive potential supported by the graph and with the coupling constant $\,$, and the proper meaning is given to this operator in the way described in Section 2.

R em ark 5.1 Properties of the operator H $_{\rm N}$ () certainly depend on the order of the angles in $\,$. However, the operators obtained from each other by a cyclic permutation are obviously unitarily equivalent by an appropriate rotation of the plane.

Let us m ention two trivial cases:

Example 5.2 (a) H_2 () corresponding to a straight line can be written as $h = I + I = (\theta_y^2)$, where $h = \theta_x^2 = (x)$ is the one-center point-interaction Hamiltonian [AGHH] on L^2 (R). Consequently, its spectrum is purely a.c. and equal to [2=4;1].

(b) H₄($_s$) with $_s = _{\frac{7}{2};\frac{7}{2}}$ again allows separation of variables being h I + I h . Hence the a.c. part of (H₄($_s$)) is the same as above, and in addition, there is a single isolated eigenvalue 2 =2 corresponding to the eigenfunction (2) 1 e $^{(j_s)+}$ j_s j_s =2.

5.1 The essential spectrum

First we notice that the essential spectrum of H $_{\rm N}$ () does not extend below that of H $_2$ () corresponding to a straight line.

P roposition 5.3 inf $_{ess}$ (H $_{N}$ ()) $\frac{^{2}}{4}$ holds for any N and .

Proof: By Neum ann bracketing. We decompose the plane into a nite union

where W $_{\rm j}$ is a wedge of angle $_{\rm j}$, S $_{\rm j}$ is a halfstrip centered at L $_{\rm j}$ which is obtained by a Euclidean transform ation of R $^+$ ['; '], and P is the remaining polygon containing the vertex of . Imposing Neumann boundary conditions at the common boundaries, we get a lower bound to H $_{\rm N}$ () by an operator which is a direct sum corresponding to the decomposition (5.1). The wedge parts have an a $_{\rm c}$. spectrum in R $^+$ while the polygon has a purely discrete spectrum . Finally, the halfstrip spectrum is a $_{\rm c}$. again and consists of the interval [(');1), where (') is the lowest eigenvalues of ($^{\circ}_{\rm C}$ (y) $^{\circ}_{\rm R}$ on L 2 ([';']). It is straightforward to see that to any $^{\circ}$ $^{\circ}$ =4 there is 'such that (') > , and since the decomposition (5.1) can be chosen with 'arbitrarily large, the proof is nished.

In fact, the essential spectrum is exactly that of a straight line.

Proposition 5.4 $_{ess}(H_N()) = [^2=4;1)$ holds for any N and .

Proof: In view of the previous proposition, it is su cient to check that $_{\rm ess}$ (H $_{\rm N}$ ()) [2 =4;1). Given a function 2 C $_{0}^{1}$ ([0;1)) with k k = 1 and (r) = 1 in the vicinity of r = 0, we construct

5.2 The discrete spectrum

The rst question concerns naturally the existence of isolated eigenvalues. It follows from two observations of which one is rather simple.

Proposition 5.5 H_N () H_{N+1} (~) holds for any N and angle sequence ~= f_1 ;...; f_1 ; f_2 ; f_3 ; f_4 ; f_4 ; f_5 ; f_4 ; f_5 ; f_6 ; f_7 ; f_8

Proof follows directly from the de nition by the quadratic form (2.3).

On the other hand, the second one is rather nontrivial. It has been proven in [EI] for a wide class of piecew ise continuous non-straight curves which includes, in particular, a broken line.

Proposition 5.6 $_{disc}$ (H₂()) is nonempty unless = .

C om bining these two results with the m in im ax principle (recall that H $_{\rm N}$ () is below bounded) we arrive at the following conclusion.

Theorem 5.7 $_{disc}(H_N())$ is nonempty except if N=2 and = .

Next one has to ask how many bound states does a star graph support. The answer depends on its geometry. There are situations, however, where their number can be large.

Theorem 5.8 Fix N and a positive integer n. If at least one of the angles $_{\rm j}$ is small enough, card ($_{\rm disc}$ (H $_{\rm N}$ ())) n.

Remark 5.10 The estimate used in the proof also shows that the number of the bound states for a sharply broken line is roughly proportional to the inverse angle,

as ! 0. This is the expected result, since the number is given by the length of the elective potential well which exists in the region where the two lines are so close that they roughly double the depth of the transverse well.

5.3 The Birm an-Schwinger approach

Now we are going to show how the spectral problem for the operators H $_{\rm N}$ () can be reform ulated in terms of suitable integral operators. We will employ the resolvent formula for measure perturbations of the Laplacian derived in [BEKS]. Notice that this technique was used in [EI] to derive a result which implies our Proposition 5.6.

Since the operators H $_{\rm N}$ () are de ned by the quadratic form (2.3) they satisfy the generalized B im an-Schwinger principle. If k^2 belongs to the resolvent set of H $_{\rm N}$ () we put R k , \rightleftharpoons (H $_{\rm N}$ () k^2) 1 . We already know the K rein-like form ula for the resolvent from Thm 2.1, here it has the form

The odd part of H_2 () then corresponds to the Dirichlet condition at x=0. The spectrum of this operator remains

the same if we change $\arg L_1$ to =2. Removing then the Dirichlet condition, we get the operator $H_2()$ with inf $(H_2()) = \inf_{ess} (H_2())$, so by minimax principle no eigenfunction of $H_2()$ can be odd.




Figure 8: The dependence of the discrete spectrum of H $_{\rm Y}$; on the angle for the sym m etric two-arm s star $_{1}$. The dotted line represents the threshold $_{2}$ =4

5.5 Numerical results

H aving explained analytically how does the discrete spectrum of H $_{\rm N}$ () depend on the number of arm s and the angles , we employ now the approximation by point-potential Schrodinger operators to obtain the numerical results for cut-o stars which would illustrate the above conclusions.

Consider a two-arms star graph $_1$ with both arms having the same length, $L_1=L_2=300$, and put $_2=0.1$. As we already know, the threshold of the continuous spectrum of H $_2$ () is $_2=4=0.0025$. We approximate H $_2$ () by point-potential Schrodinger operator H $_2$; that has 1 potential on the center of the star graph and 200 equidistant point potentials on each arm. Only the lower part of the discrete spectrum of H $_2$; approximates the discrete spectrum of the star-graph operator, while the upper part corresponds to the interval [$_2=4;0$] $_{ess}$ (H $_2$ ()). Therefore only the states with energy below the threshold m ay be indeed understood as the approximation of the bound states of H $_2$ ().




Figure 9: The dependence of the discrete spectrum of $H_{\rm Y}$; on the angle for the non-sym m etric two-arms star $_2$. The dotted line represents the threshold 2 =4.

The main result of the analytic argument presented above was the dependence of the eigenvalues on the angle : if decreases, the eigenvalues decrease and their number grows. The discrete spectrum of H_{Υ} ; for varying is in a good agreement with this fact as Fig. 8 illustrates. The eigenvalue crossings we observe are actual, which is a consequence of the symmetry of

the graph $_1$. For a non-symmetric graph the crossings become avoided. To demonstrate it in Fig. 9, we slightly change the length of one arm , $L_2=306$, while the other parameters are preserved. Also the setting of the point potentials approximating the new graph $_2$ stays the same, up to extra four potentials added on the longer arm .




Figure 10: The wavefunction of the ground state of H $_{\rm Y}$; , E $_{\rm 0}$ = 0:612, which approximates the ground state of H $_{\rm 6}$ () with being the 5-tuple of =3 and = 1. The contours correspond to logarithm ically scaled horizontal cuts, the dotted lines represents the graph .




Figure 11: The wavefunction of the third exited state of H $_{\rm Y}$; , E $_{\rm 3}$ = 0.265. It approximates the third excited state of H $_{\rm 10}$ () with being the 9-tuple of =5 and = 1. The convention is the same as above, the solid line is the nodal line.

The expression (4.2) again yields the eigenfunctions in the form of a sum of the free G reen functions. We lim it ourselves to a pair of examples: the ground state of H $_6$ () in Fig. 10 and the third excited state of H $_{10}$ () in Fig.11. The length of the cut arm s is 30, in the form er case the approxim ating operator H $_{\rm Y}$; has 601 point potentials and in the latter case the number of point potentials is 1001. We see, in particular, that for N large enough H $_{\rm N}$ () m ay have closed nodal lines; it is an interesting question what is the minimal N for which this happens.

6 L²-approach to resonances

Our last example, as indicated in the introduction, concerns the situation when is a single in nite curve; we want to see whether resonances in the scattering of states propagating along may be detected by inspecting the spectrum of the cut-o problem with the curve of a nite length which is a parameter to be varied.




Figure 12: An example of the curve : R = 10 and = 1.9.




Figure 13: The dependence of the discrete spectrum of the H $_{\rm Y}$, on the length L for R = 10, = 1 and = 19.




Figure 14: The dependance of the discrete spectrum of H $_{\rm Y}$; on the length L for R = 10, = 1 and = 2:9.




Figure 15: The dependence of the discrete spectrum of H $_{\rm Y}$, on the length L for R = 10, = 1 and = 52.

Consider a curve from Fig.12: its central part consists of three segments of a circle with the radius R = 10 and it has two in nite \legs". The distance between two closest points of the curve, i.e. the bottleneck width, is denoted by . The coupling constant equals 1. We cut the \legs" of the graph to a nite length L and we plot the eigenvalues computed using the approximation

for L varying. The number of the point potentials involved in H_{Υ} ; is chosen so that the distance between every two adjacent points equals 0.3. For small values = 1.9 and = 2.9 the tunneling e ect occurs and we can see the plateaux in Figs. 13, 14, which indicate the existence of resonances; the width of the avoided crossings increase with as expected. On the other hand, for more open curve, = 52, we get a dierent picture, where the plateaux are absent, see Fig. 15.




Figure 16: The dependence of the discrete spectrum of H $_{\rm Y}$, on the arm length L for the angle = =4 and = 1.

The second graph type we are interested in are $\sin p \ln b$ bends, in term s of Section 5 it is a two-arm s star (). As we have already mentioned, the avoided eigenvalue crossings are not expected here because the transport along the graph arm involves a single transverse mode { this is con rmed in Fig. 16, which shows the results of the cut-o method for = =4.




Figure 17: The dependence of the discrete spectrum of H $_{\rm Y}$; on the arm length L for R = 10, = 0:32 and = 5.




Figure 18: The dependence of the discrete spectrum of H_Y , on the arm length L for R=10, = and = 5.

Finally to illustrate that resonances m ay also result from multiple re ections rather than from a tunneling, we apply the cut-o method to graphs which are of a stair-type, or Z-shaped. They consists of three line segments: the central one has a nite length R , i.e. the \heigth" of the stair, the other two are parallel (cut-o) hal ines. If the angle between the segments is less than =2 the term Z-shaped is more appropriate. The results for R = 10 and = 5 are plotted in Figs. 17 and 18. In the former case the stair is \skewed" to = 0:32 , in the latter we have = ; the distance between the point potentials of the approximating operator $H_{\rm Y}$; equals 0:1. We not avoided crossings, however, they are very narrow for = 0:32 and barely visible in the right-angle case; this observation can be naturally understood in terms of the re-ection probability through a single bend { compare with the angle dependence of the spectrum on Fig. 8.
