# An isoperm etric problem for leaky loops and related $m$ ean-chord inequalities

#### Abstract

We consider a class of $H$ am iltonians in $L^{2}\left(\mathbb{R}^{2}\right)$ w ith attractive interaction supported by piecew ise $\mathrm{C}^{2}$ sm ooth loops of a xed length L , form ally given by ( $\mathrm{x} \quad$ ) with $>0$. It is shown that the ground state of this operator is locally $m$ axim ized by a circular . W e also conjecture that this property holds globally and show that the problem is related to an interesting fam ily of geom etric inequalities conceming $m$ ean values of chords of .


## 1 Introduction

T here is a sm all num ber of topics which can be regarded as tradem ark for $m$ athem atical physics. O ne of them without any doubt concems relations betw een geom etric properties of constraints and/or interaction and extrem al values of a spectral quantity; classical exam ples are Faber K rahn inequality [1] $\overline{2}$, ,'1] 1

A com $m$ on feature of these and analogous problem $s$ is that the extrem um is reached by shapes having a rotational sym $m$ etry. At the sam $e$ tim $e$, the nature of the extrem um $m$ ay be di erent. W hile a ballm inim izes the principal eigenvalue of the $D$ irichlet Laplacian am ong regions of a xed volum e,
for non-sim ply connected regions like annular strips or layers considered in [/ิ, ,1' $13=1]$, built over a curve (surface) ofa xed length (area), the circular shape is on the contrary a m axim izer. A natural topological way to understand this di erence becom es sm eared, how ever, when the particle is not localized by boundary conditions but by a potential, a regular or singular one.

In this paper we consider such a problem associated w th a class of operators in $L^{2}\left(R^{2}\right)$ which are given form ally by the expression

where $>0$ and is a C ${ }^{2}$ loop in the plane (see below for exact assum ptions) having a xed length $L>0$. A m otivation to study these operators com es
 a bibliography can be found in $\left[\left[_{-1}^{11}\right]\right.$ \{ aim ing at a $m$ ore realistic $m$ odel of quantum wire structures which would take quantum tunneling into account.

Our am is to show that the ground-state energy of H ; is (sharply) m axim ized when is a circle. W e will be able to prove that this property holds locally con jecturing its global validity. There are several reasons why one $m$ ay expect this result to be valid. On one hand, we know from $\left.{ }_{[1]}^{1} \overline{1}_{-1}\right]$ that in the lim it of strong coupling, ! 1 , the ground-state dependence on is given in the leading order by the low est eigenvalue of the operator $\frac{\mathrm{d}^{2}}{\mathrm{ds}^{2}} \quad \frac{1}{4}(\mathrm{~s})^{2}$ on $\mathrm{L}^{2}([0 ; L])$ w th periodic boundary conditions where is the curvature of , and the latter is easily seen to be globally sharply maxi-
 H ; can be approxim ated in the strong resolvent sense by point interaction H am iltonians w ith the point interactions equidistantly spaced along and properly chosen coupling constants, and from [in we know that the ground state of such an operator is locally $m$ axim ized by a regular polygon.

N eedless to say, neither of the above observations proves the desired result. The rst one is global, but it holds only asym ptotically and we do not know whether the error term w ill not spoil the inequality. The second argum ent holds for any $>0$ suggesting the local validity, but the polygons approxim ating the circle do not have exactly the sam e lengths.
$O$ urm ain tools in this paper are the generalized $B$ irm an-Schw inger principle in com bination w ith the convexity of reen's function. They allow us to reform ulate the problem in a purely geom etric way, in term sofm ean value of chords of arc segm ents of . Since such geom etric inequalities are of an independent interest, we discuss them in Sec. 'i'i separately in a broader context,
including the discrete version which arose in connection with the polygon problem treated in [i]. Before doing that, we will form ulate in the next sec-
 $m$ entioned reform ulation in Sec. $\overline{\mathrm{S}}$. A fter the discussion of the inequalities we will nish the proof of $T$ heorem $\underline{2} \mathcal{I}_{-1}$ and present som e concluding rem arks.

## 2 Form ulation and the $m$ ain result

W ewill assum e throughout that : $[0 ; L]!R^{2}$ is a closed curve, $(0)=$ (L ), param etrized by its arc length, which is $C^{1}-s m$ ooth, piecew ise $C^{2}$, and has no cuspss_1. Unless stated otherw ise, we will $m$ ean by the curve for sim plicity both the above $m$ entioned function and its im age in the plane. Furtherm ore, we introduce the equivalence relation: and ${ }^{0}$ belong to the sam e equivalence class if one can be obtained from the other by a Euclidean transform ation of the plane. Spectral properties of the corresponding $H$; and H ; o are obviously the sam e, and we will usually speak about a curve
having in $m$ ind the corresponding equivalence class. It is clear that the stated regularity assum ptions are satis ed, in particular, by the circle, say $C:=f((L=2) \operatorname{coss} ;(L=2) \sin s): s 2[0 ; L] g$, and its equivalence class.

Choosing now for $m$ the D iracm easure supported by the curve one can check easily that the condition (2.-4) is satis ed under our assum ptions about, hence we $m$ ay identify the above $m$ entioned self-adjoint operator $w$ th the form al one given by (İ:İI).

The described de nition applies naturally to a $m$ uch wider class of perturbations than we need here. Since is supposed to be sm ooth, w ith the norm al de ned everyw here, we can de ne H ; altematively through boundary conditions. we ask for which the principal eigenvalue is $m$ axim al. The $m$ ain result of this paper is a partial answer to this question, nam ely:

Theorem 2.1 W ithin the speci ed class of curves, 1 (; ) is for any xed $>0$ and $\mathrm{L}>0$ bcally shanply $m$ axim ized by a circle.

W hile we do not give a general answ er here, we suggest what it should be.
C on jecture 2.2 The circle is a sharp gbbalm axim izer, even under weaker regularity assum ptions.

## 3 B irm an-Schw inger reform ulation

$N$ ext we use the fact that the $m$ axim um eigenvalue of $R$; is simple. This conclusion results from the follow ing considerations: the kemel of the

## 4 M ean-chord inequalities

The inequality ( as an elem ent of a wider fam ily which we are now going to describe. Let
: $[0 ; \mathrm{L}]!\mathrm{R}^{2}$ be again a loop in the plane; for the $m$ om ent we do not specify its regularity properties. Let us consider all the arcs of having length u $2\left(0 ; \frac{1}{2} \mathrm{~L}\right]$. The $m$ entioned inequalities are the follow ing

They have also a discrete counterpart for an equilateral polygon $P_{N}$ of $N$ vertices and side length ' $>0$. Let $f y_{n} g$ be the fam ily of its vertices, where the index values are identi ed $m$ odulo $N$; then we introduce
for any $m=1 ;::: ;\left[\frac{1}{2} N\right]$, where [ ] denotes as usual the entire part.
In all the cases the right-hand side corresponds, of course, to the case $w$ ith $m$ axim al sym $m$ etry, i.e. to the circle and regular polygon $P_{N}$, respectively. W e con jecture that w ithout regularity restrictions $C_{L}{ }^{p}$ (u) holds for any p 2 and the sam $e$ is true for $D_{N}{ }_{i}^{p},(m)$, and furtherm ore, we expect the inequalities to be sharp unless $=C$ or $\mathrm{P}_{\mathrm{N}}=\mathrm{P}_{\mathrm{N}}$, respectively. In the polygon case it is clear that the claim $m$ ay not be true for $p>2$ as the exam ple of a rhom boid shows: $\mathrm{D}_{4}^{\mathrm{p}}$; (2) is equivalent to $\sin ^{\mathrm{p}}+\cos ^{\mathrm{p}} \quad 1$ for $0 \ll . W \mathrm{C}$
 generality; below we will present a few particular cases.

It is obvious that the inequalities have a scaling property, so w ithout loss of generality one can assum e, e.g., $\mathrm{L}=1$ and ' $=1$; in such a case we drop the corresponding symbol from the label. If necessary we can include also the case $\mathrm{p}=0 \mathrm{w}$ hen the inequalities tum into trivial identities.

These simple relations $m$ ean that to check the above stated conjecture one needs only to verify $C^{2}(u)$ and $D_{N}^{2}(m)$. W ewill address the continuous case in the next section, here we notioe that the results of $\left[\begin{array}{l}i-1\end{array}\right]$ in com bination w ith the last tw o propositions leads to the follow ing conclusions:

## 5 Proof of Theorem

A fter this interhude let us retum to ourm ain problem. N otice rst that our regularity hypothesis allows us to characterize by its (signed) curvature

As a certain analogy to Theorem in in (b) we can prove the sought global inequality in case when the curve arcs in question are su ciently short and/or the tangent vector direction does change too fast.

This result, how ever, does not help us with our m ain problem, because we need the inequality to be valid for all arc lengths. As indicated before, we can prove a local result which w ill im ply Theorem 'Iَئ.

Rem ark 5.3 O nem ay wonder what happened with the closedness require$m$ ent ( 5 using only the weaker property that $(0)=(\mathrm{L})$. This is possible, of course, for $s m$ all deform ations only! As an ilhustration, consider in the form of an \overgrown paperclip" which satis es the condition ( 0 ) = (L) but not (5늘) , i.e. a line segm ent w ith two $U$ tums at the ends. $M$ aking the latter short one can get $\mathrm{C}^{2}\left(\frac{1}{2} \mathrm{~L}\right)$ arbitrarily close to $\frac{1}{3} \mathrm{~L}^{3}$ which is larger than $\mathrm{L}^{3}={ }^{2}$.

## 6 Extensions and conclusions

To support our expectations that the result given in Theorem '2. 2 In holds globally and under weaker regularity assum ptions, consider a sim ple exam ple.

E xam ple 6.1 Let be a curve consisting of tw o circular segm ents of radius $R>\frac{L}{4}$, i.e. it is given by the equations

This function has for each u $2 \quad\left(0 ; \frac{1}{2} \mathrm{~L}\right]$ a $m$ aximum at $R=\frac{\mathrm{L}}{2}$ and one can check directly that its value is smaller for any other $R$. In particular, in the $\lim$ it $R$ ! 1 we have $c^{2}(u)!u^{2} \quad \frac{4}{3} u^{3}$ as one can nd also directly w ith the \lens" degenerate into a double line segm ent; this value is less than $\frac{L^{3}}{2} \sin ^{2} \frac{u}{L}$ because $\sin ^{2} x>x^{2} \quad \frac{4}{3} x^{3}$ holds in $(0 ;-)$.

To sum $m$ arize our discussion, to prove $C$ on jecture ${ }^{1} \overline{2} \overline{2}$ it is su cient to verify the inequality $C_{\mathrm{L}}^{\mathrm{p}}$ (u) for some $\mathrm{p} \quad 1$ under appropriate regularity hypothesis. Naturally, one can ask also about ground-state maxim izer in sm aller fam ilies of curves which do not contain the circle; exam ples could be polygonal loops with a xed or lim ited num ber of vertioes, or various prescribed com positions of arcs belonging to speci c classes, circular, elliptic, parabolic, etc. O bviously a reasonable strategy is to look rst for curves as close to the circle as possible w ithin the given class. Som etim es one expects that the answer $w$ illbe the curve $w$ ith $m$ axim um sym $m$ etry as in the polygon case, in other situations it $m$ ay not be true.

A nother, and $m$ aybe $m$ ore im portant extension of the present problem concems a $m$ axim izer for the generalized Schrodinger operator in $R^{3} w$ ith an attractive interaction supported by a closed surface of a xed area $A$, and its generalization to closed hypersurfaces of codim ension one in $R^{d} ; d>3$. In the case of $d=3$ we have a heuristic argum ent relying on [ $[\underline{[ }$, , 1 to that used in the introduction which suggests that the problem is solved by the sphere provided the discrete spectrum is not em pty, of course, which is a nontrivial assum ption in this case \{ for properties of the corresponding operators see []. $\overline{[1}]$. The B im an-Schw inger reduction of the problem sim ilar to that of Sec. 'ה. can be perform ed again and the task is thus reduced to veri cation of a geom etric inequality analogous to ( $\left.\bar{A} . \bar{I}_{1}\right)$ which we can label as $C_{A}^{d i p}(u) . W e w i l l$ discuss this problem in a follow ing paper.
