# A CLASS OF COMPLETELY INTEGRABLE QUANTUM SYSTEMS ASSOCIATED WITH CLASSICAL ROOT SYSTEMS

#### Abstract

We classify the completely integrable systems associated with classical root systems whose potential functions are meromorphic at an infinite point.


## 1. Introduction

A Shrödinger operator

$$

with the potential function $R(x)$ of $n$ variables $x=\left(x_{1}, \ldots, x_{n}\right)$ is called completely integrable if there exist $n$ differential operators $P_{1}, \ldots, P_{n}$ such that

P_{1}, \ldots, P_{n} \text { are algebraically independent. }
\end{array}\right.
$$

In this note $P$ is called to be completely integrable of type $B_{n}$ or of classical type if $P_{k}$ and $R(x)$ in the above are of the forms

R(x) & =\sum_{1 \leq i<j \leq n}\left(u_{i j}^{-}\left(x_{i}-x_{j}\right)+u_{i j}^{+}\left(x_{i}+x_{j}\right)\right)+\sum_{k=1}^{n} v_{k}\left(x_{k}\right) . \tag{1.4}
\end{align*}

Here $u_{i j}^{ \pm}$and $v_{k}$ are functions of one variable.
The systems of differential operators satisfied by the radial parts of zonal spherical functions or Whittaker functions on Riemannian symmetric spaces of the noncompact and classical type, Heckman-Opdam's hypergeometric equations (cf. [HO]), Calogero-Moser and Sutherland systems for one dimensional quantum $n$-body problems (cf. OP1, OP2]) and Toda finite chains associated with (extended) classical Dynkin diagrams are their examples.

We remark that Wa proves that if the potential function $R(x)$ is locally defined and analytic, then the condition (1.2) with (1.3) assures (1.4) and moreover $R(x)$ is extended to a global meromorphic function on $\mathbb{C}^{n}$ except for a trivial case corresponding to Type $A_{1}$ in Theorem 4.8 (cf. Oc for type $B_{2}$ and OS in the invariant case).

OOS, OS, O2 and OO determine this integrable system under the condition that $P$ is $B_{n}$-invariant, namely, $u_{i j}^{+}, u_{i j}^{-}$and $v_{k}$ are even functions and do not depend on $i, j$ and $k$ and $u_{i j}^{+}=u_{i j}^{-}$. On the other hand Oc , Ta and Wa determine it if $R(x)$ has certain singularities.

We assume in this note that $R(x)$ is meromorphic at $t=0$ under the coordinate system

and classify the Shrödinger operator (1.1) which allows a differential operator $P_{2}$ of the form (1.3) satisfying $P P_{2}=P_{2} P$. We note that the above examples with nonrational potential functions satisfy this assumption. In the first example this follows from the fact that the invariant differential operators on a Riemannian symmetric space have analytic extensions on a smooth compactification of the space (cf. [O1]).

Theorem 4.8 and Remark 4.7 in $\$ 4$ determine $R(x)$, which is the main result of this note and proved by using 42 and $\$ 3$ The result implies that the system is a suitable limit of the invariant quantum integrable system classified by OOS (cf. [I], [IM], Ru , VD ] and vD2]). Hence the integrals $P_{1}, \ldots, P_{n}$ will be calculated as suitable limits from the integrals given in [O2, which will be shown in another paper.

If $R(x)$ is analytic at $t=0$, we say that $R(x)$ has regular singularity at the infinite point $t=0$, which are also classified in Corollary 4.10

In 3 the potential function $R(x)$ is determined when $n=2$.
In $\$ 2$ we study the potential function $R(x)$ when $u_{i j}^{+}=v_{k}=0$, which we call to be of type $A_{n-1}$.

\text { 2. Type } A_{n-1}(n \geq 3)
$$

In this section we study the Shrödinger operator

\end{equation*}

which allows a differential operator

Q=\sum_{1 \leq i<i<k \leq n} \frac{\partial^{3}}{\partial x_{i} \partial x_{j} \partial x_{k}}+S \quad \text { with ord } S<3 \tag{2.2}
\end{equation*}
$$

satisfying $[P, Q]=\left[\sum_{j=1}^{n} \frac{\partial}{\partial x_{j}}, Q\right]=0$. Then the proof of OOS Proposition 4.2] implies that the existence of $Q$ is equivalent to

& +u_{i k}\left(t_{i} \cdots t_{k-1}\right)\left(-t_{i} \cdots t_{j-1} u_{i j}^{\prime}\left(t_{i} \cdots t_{j-1}\right)+t_{j} \cdots t_{k-1} u_{j k}^{\prime}\left(t_{j} \cdots t_{k-1}\right)\right) \\
& -u_{i j}\left(t_{i} \cdots t_{j-1}\right)\left(t_{i} \cdots t_{k-1} u_{i k}^{\prime}\left(t_{i} \cdots t_{k-1}\right)+t_{j} \cdots t_{k-1} u_{j k}^{\prime}\left(t_{j} \cdots t_{k-1}\right)\right)

by putting $u_{i j}\left(e^{-y}\right)=\tilde{u}_{i j}(y)$. We assume that $R(x)$ is holomorphic for $0<|t| \ll 1$ under the coordinate system (1.5) which corresponds to the expression

We assume $c_{0}^{i j}=0$ without loss of generality and expand (2.3) into the power series. Then the terms $\left(t_{i} \cdots t_{j-1}\right)^{p}\left(t_{j} \cdots t_{k-1}\right)^{q}$ with $p \neq 0, q \neq 0, p \neq q$ and $i<j<k$ appear only in $U_{i j k}$ and therefore if $p \neq 0, q \neq 0$ and $p \neq q$, we have

and hence

Denoting

we have

Then (2.3) is equivalent to

with suitable functions $V_{i j}^{i j k}, V_{j k}^{i j k}$ and $V_{i k}^{i j k}$ for $1 \leq i<j<k \leq n$.
Remark 2.1. If $\left(U_{i j}(t), U_{j k}(t), U_{i k}(t)\right)$ satisfies (2.9) with suitable $V_{i j}, V_{j k}$ and $V_{i j}$, then $\left(U_{j k}(t), U_{i j}(t), U_{i k}(t)\right)$ and $\left(c U_{i j}\left(a t^{r}\right), c U_{j k}\left(b t^{r}\right), c U_{i k}\left(a b t^{r}\right)\right)$ have the same property for any complex numbers $a, b$ and $c$ and a positive integer $r$ with $a b \neq 0$.

Proposition 2.2. The solution $\left(U_{i j}, U_{j k}, U_{i k}\right)$ of (2.9) with (2.6) is one of the followings and it satisfies $U_{i j k}=0$.
i) Two of $\left\{U_{i j}, U_{j k}, U_{i k}\right\}$ are zero and the other one is any function.
ii) $\left(U_{i j}, U_{j k}, U_{i k}\right)=\left(a t^{r}, b t^{r}, c t^{-r}\right)$ for any $a, b$ and $c \in \mathbb{C}$ and $r \in \mathbb{Z} \backslash\{0\}$.
iii) $\left(U_{i j}, U_{j k}, U_{i k}\right)=\left(\frac{a c t^{r}}{1-a t^{r}}, \frac{b c t^{r}}{1-b t^{r}}, \frac{a b c t^{r}}{1-a b t^{r}}\right)$ with any non-zero complex numbers $a, b$ and $c$ and a positive integer $r$.

Proof. All the solutions of the equation (2.9) are obtained by BP and BB (cf. OO Remark 2.3]), which implies this proposition. But we will give a simple proof under the assumption that the origin is at most a pole of $U_{i j}, U_{j k}$ and $U_{i k}$.

Suppose one of $U_{i j}, U_{j k}, U_{i k}$ is zero and the other two are not zero. If $U_{i j}=0$ and $C_{r}^{j k} \neq 0$, then we have $p(m+p) m C_{m}^{j k} C_{p}^{i k}=0$ and therefore $C_{p}^{i k}=0$ for $p \neq-r$, $C_{-r}^{i k} \neq 0$ and $C_{m}^{j k}=0$ for $m \neq r$. Thus we have ii). We similarly have ii) in the other two cases.

Hence we may assume that any one of $\left\{U_{i j}, U_{j k}, U_{i k}\right\}$ is not zero. Define $I_{\ell m} \in$ $\mathbb{Z} \backslash\{0\}$ such that $C_{I_{\ell m}}^{\ell m} \neq 0$ and $C_{\nu}^{\ell m}=0$ for $\nu<I_{\ell m}$. Then (2.8) shows

Suppose $I_{i j}>0$ and $I_{j k}>0$. Then (2.10) means $I_{i j}=I_{j k}$, which we put $r$, and therefore (2.8) with $q=r$ and that with $p=q+r$ mean

respectively.
If $C_{r}^{i k}=0$, it follows from (2.11) that $C_{p}^{i j}=0$ for $p \neq r$ by the induction on $p$ and we have similarly $C_{q}^{j k}=0$ for $q \neq r$ by the symmetry between $U^{i j}$ and $U^{j k}$ and finally $C_{q}^{i k}=0$ for $q \neq-r$ by (2.12). Hence this case is reduced to ii) with $r>0$.

Suppose $C_{r}^{i k} \neq 0$. Then by Remark 2.1 we may assume $C_{r}^{i j}=C_{r}^{j k}=C_{r}^{i k}$ by a suitable transformation $(s, t) \mapsto(a t, b t)$ and moreover by (2.11) that $U_{i j}=$ $c \sum_{\nu=1}^{\infty} t^{r \nu}$ and similarly $U_{j k}=c^{\prime} \sum_{\nu=1}^{\infty} t^{r \nu}$. Then (2.12) means $U_{i k}=U_{j k}+c^{\prime \prime} t^{-r}$. Finally we have $c^{\prime \prime}=0$ by (2.10) with $p=2 r$ and $q=-r$ and get $U_{i j}=U_{j k}=U_{i k}$.

Lastly we may assume $I_{i j}<0$ by Remark (2.1) Then (2.8) with $p=I_{i j}+I_{i k}$ and $q=I_{i k}$ implies $I_{i k}>0$ and that with $p=I_{i j}$ and $q>0$ means $C_{q}^{j k}=0$ for $q \geq 0$. Hence $I_{j k}<0$ and similarly we have $C_{p}^{i j}=0$ for $p \geq 0$. Moreover (2.8) with $p=q+I_{i j}$ shows $C_{q}^{i k}=0$ for sufficiently large integer $q$. Then $\left(U_{i j}\left(t^{-1}\right), U_{j k}\left(t^{-1}\right), U_{i k}\left(t^{-1}\right)\right)$ is also a solution of (2.9) and this case is reduced to the case when $I_{i j}>0$ and $I_{j k}>0$ and therefore we have ii) with $r<0$.

Note that it is easy to see that the given functions in the proposition satisfy $U_{i j k}=0$ (cf. Remark [2.1].

Remark 2.3. If $t=e^{-x}$, then

## 3. Type $B_{2}$

In this section we study the following commuting differential operators.

P=\frac{\partial^{2}}{\partial x^{2}}+\frac{\partial^{2}}{\partial y^{2}}+R(x, y)  \tag{3.1}\\
Q=\frac{\partial^{4}}{\partial x^{2} \partial y^{2}}+S \quad \text { with ord } S<4 \\
{[P, Q]=0}
\end{array}\right.
$$

Note that $P_{2}=P^{2}-2 Q$ in (1.3). First we review the arguments given in 00 and Oc. Since $P$ is self-adjoint, we may assume $Q$ is also self-adjoint by replacing $Q$ by its self-adjoint part if necessary. Here for $A=\sum a_{i j}(x, y) \frac{\partial^{i+j}}{\partial x^{i} \partial y^{j}}$ we define ${ }^{t} A=\sum(-1)^{i+j} \frac{\partial^{i+j}}{\partial x^{i} \partial y^{j}} a_{i j}(x, y)$ and $A$ is called self-adjoint if ${ }^{t} A=A$. Then

Q= & \left(\frac{\partial^{2}}{\partial x \partial y}+\frac{u^{+}(x+y)-u^{-}(x-y)}{2}\right)^{2}+w(y) \frac{\partial^{2}}{\partial x^{2}}+v(x) \frac{\partial^{2}}{\partial y^{2}}  \tag{3.2}\\
& +v(x) w(y)+T(x, y)
\end{align*}
$$

and the function $T(x, y)$ satisfies

& 2 \frac{\partial T(x, y)}{\partial x}=\left(u^{+}(x+y)-u^{-}(x-y)\right) \frac{\partial w(y)}{\partial y}+2 w(y) \frac{\partial}{\partial y}\left(u^{+}(x+y)-u^{-}(x-y)\right)  \tag{3.3}\\
& 2 \frac{\partial T(x, y)}{\partial y}=\left(u^{+}(x+y)-u^{-}(x-y)\right) \frac{\partial v(x)}{\partial x}+2 v(x) \frac{\partial}{\partial x}\left(u^{+}(x+y)-u^{-}(x-y)\right)
\end{align*}

On the other hand, if a function $T(x, y)$ satisfies (3.3) for suitable functions $u^{ \pm}(t)$, $v(t)$ and $w(t)$, then (3.1) is valid for $R(x, y)$ and $Q$ defined by (3.2).

We have the compatibility condition

& \quad=\frac{\partial}{\partial y}\left(\left(u^{+}(x+y)-u^{-}(x-y)\right) \frac{\partial w(y)}{\partial y}+2 w(y) \frac{\partial}{\partial y}\left(u^{+}(x+y)-u^{-}(x-y)\right)\right)
\end{align*}

for the existence of $T(x, y)$.

Definition 3.1 (Duality in $B_{2}$ ). Under the coordinate transformation

(x, y) \mapsto\left(\frac{x+y}{\sqrt{2}}, \frac{x-y}{\sqrt{2}}\right) \tag{3.5}
\end{equation*}

the pair $\left(P, \frac{1}{4} P^{2}-Q\right)$ also satisfies (3.1), which we call the duality of the commuting differential operators of type $B_{2}$.

Denoting $\partial_{x}=\frac{\partial}{\partial x}, \partial_{y}=\frac{\partial}{\partial y}$ and put
$L=P^{2}-4 Q-\left(\partial_{x}^{2}-\partial_{y}^{2}+v(x)-w(y)\right)^{2}-2 u^{-}(x-y)\left(\partial_{x}+\partial_{y}\right)^{2}-2 u^{+}(x+y)\left(\partial_{x}-\partial_{y}\right)^{2}$.
Then the order of $L$ is at most 2 and the second order term of $L$ equals

& -2(v-w)\left(\partial_{x}^{2}-\partial_{y}^{2}\right)-2 u^{-}\left(\partial_{x}+\partial_{y}\right)^{2}-2 u^{+}\left(\partial_{x}-\partial_{y}\right)^{2}=0

Since $L$ is self-adjoint, $L$ is of order at most 0 and the 0 -th order term of $L$ equals

-\left(\partial_{x}^{2}-\partial_{y}^{2}\right)(v-w)=\left(u^{+}+u^{-}+v+w\right)^{2}-4(v w+T)
\end{array}

and therefore we have the following proposition.
Proposition 3.2. i) By the duality in Definition 3.1 the pair $(R(x, y), T(x, y))$ changes into $(\tilde{R}(x, y), \tilde{T}(x, y))$ with

\tilde{T}(x, y)=\frac{1}{4} \tilde{R}(x, y)^{2}-v\left(\frac{x+y}{\sqrt{2}}\right) w\left(\frac{x-y}{\sqrt{2}}\right)-T\left(\frac{x+y}{\sqrt{2}}, \frac{x-y}{\sqrt{2}}\right)
\end{array}\right.
$$

ii) Combining the duality with the scaling map $R(x, y) \mapsto c^{-2} R(c x, c y)$, the following pair $\left(R^{d}(x, y), T^{d}(x, y)\right)$ defines commuting differential operators if so is $(R(x, y), T(x, y))$. This $R^{d}(x, y)$ is also called the dual of $R(x, y)$.

Now we give a list of the solutions of (3.4) and (3.3). They are suitable limits of the invariant solutions studied in OO and many of them are given in Oc.

Case I: $\left(\right.$ Any $\left.-A_{1}\right)+\left(\right.$ Any $\left.-A_{1}\right) \quad v=w=0$ and $u$ and $v$ are arbitrary functions.
Case II: $u^{+}=u^{-}, v=w$ and $\left(u^{+} ; v\right)$ is in the following list.

Case III: $u^{+}=u^{-},\left(u^{+} ; v, w\right)$ is in the following list.
(Toda- $D_{2}^{(1)}$-bry) $\quad\left(\langle\cosh 2 \lambda t\rangle ;\left\langle\sinh ^{-2} \lambda t, \sinh ^{-2} 2 \lambda t\right\rangle,\left\langle\sinh ^{-2} \lambda t, \sinh ^{-2} 2 \lambda t\right\rangle\right)$,
(Toda- $D_{2}^{(1)}$-S-bry) $\quad\left(\langle\cosh \lambda t, \cosh 2 \lambda t\rangle ;\left\langle\sinh ^{-2} \lambda t\right\rangle,\left\langle\sinh ^{-2} \lambda t\right\rangle\right)$,

Remark 3.4. i) Since the constant terms $U_{0}^{ \pm}, V_{0}$ and $W_{0}$ have no effect on the equation (3.12) and on the original functions $u^{ \pm}, v$ and $w$, we will identify two functions appeared in the solutions of (3.12) if they only differ in their constant terms.
ii) If $\left(U^{+}(t), U^{-}(t)\right)=0$ or $(W(t), V(t))=0$, then (3.12) is always true. We call such $\left(U^{+}, U^{-}, W, V\right) \in \mathcal{S}\left(B_{2}\right)$ a trivial solution of (3.13).

We summarize elementary transformations acting on $\mathcal{S}\left(B_{2}\right)$.
Lemma 3.5. Let $\left(U^{+}(t), U^{-}(t), V(t), W(t)\right) \in \mathcal{S}\left(B_{2}\right)$.
i) (dual) $\left(V(t), W(t), U^{+}\left(t^{2}\right), U^{-}\left(t^{2}\right)\right) \in \mathcal{S}\left(B_{2}\right)$.
ii) (bilinear) If $\left(U^{+}(t), U^{-}(t), S(t), T(t)\right) \in \mathcal{S}\left(B_{2}\right)$, then $\left(a U^{+}(t), a U^{-}(t), b V(t)+\right.$ $c S(t), b W(t)+c T(t)) \in \mathcal{S}\left(B_{2}\right)$ for $a, b, c \in \mathbb{C}$.
iii) (translations) $\left(U^{+}\left(a b^{2} t\right), U^{-}(b t), V(a b t), W(a t)\right) \in \mathcal{S}\left(B_{2}\right)$ for $a, b \in \mathbb{C} \backslash\{0\}$.
iv) (scaling) If $\left(U^{+}\left(t^{r}\right), U^{-}\left(t^{r}\right), W\left(t^{r}\right), V\left(t^{r}\right)\right)$ is well-defined for a suitable $r \in$ $\mathbb{Q} \backslash\{0\}$, it is in $\mathcal{S}\left(B_{2}\right)$.
v) (symmetry) If $W(t)$ is a rational function, the reflection $(x, y) \mapsto(x,-y)$ can be applied to the solution and then $\left(U^{-}(t), U^{+}(t), V(t),-W\left(t^{-1}\right)\right) \in \mathcal{S}\left(B_{2}\right)$.
vi) (symmetry) If $U^{-}(t)$ is a rational function, the reflection $(x, y) \mapsto(y, x)$ can be applied to the solution and then $\left(U^{+}(t),-U^{-}\left(t^{-1}\right), V(t), W(t)\right) \in \mathcal{S}\left(B_{2}\right)$.

The lemma is a direct consequence of the definition of $\mathcal{S}\left(B_{2}\right)$. For example, i) follows from

Definition 3.6. If a solution of (3.13) obtained by applying transformations in Lemma 3.5 to an original solution, it is called a standard transformation of the original solution.

We will study non-trivial solutions of (3.13). Considering standard transformations, we may assume

i) $U^{ \pm}(t), V(t)$ and $W(t)$ are rational functions.
ii) (Oc Theorem 2.3]) If $W(t)$ has a pole at $t=1$, then $U^{+}(t)=U^{-}(t)$ and $W\left(t^{-1}\right)+W(t)=0$. If $U^{-}(t)$ has a pole at $t=1$, then $V(t)=W(t)$ and $U^{-}\left(t^{-1}\right)+$ $U(t)=0$.

Here we note that this equality is interpreted in the sense of Remark 3.4
iii) ( Oc Corollary 3.8]) If at least two of $\left\{U^{+}(t), U^{-}(t), V(t), W(t)\right\}$ have poles in $\mathbb{C} \backslash\{0\},\left(U^{+}, U^{-}, V, W\right)$ is a standard transformation of a solution given in the list Trig- $B_{2}$ - (Toda- $D_{2}^{(1)}$-S-bry).
Proof. i) The equation (3.12) shows $W_{q-2 r} U_{r}^{+}=W_{q} U_{r}^{-}$if $q>2|r|+\left|r^{\prime}\right|$. Hence $W(t)$ is a rational function and therefore so are $U^{-}(t), U^{+}(t)$ and $V(t)$ because of Lemma 3.5 i) and v).

Lemma 3.8. i) If $V(t)$ has a pole at the origin, then $U^{+}(t)$ and $U^{-}(t)$ are holomorphic at the origin.
ii) If $U^{+}(t)$ has a pole at the origin, then $V(t)$ and $W(t)$ are holomorphic at the origin.
Proof. If $r<0$ and $r^{\prime}<0$ with $V_{r^{\prime}} \neq 0$, the coefficients of $s^{r+r^{\prime}} t^{r^{\prime}}$ and that of $s^{r+r^{\prime}} t^{2 r+r^{\prime}}$ in (3.13) show $V_{r^{\prime}} U_{r}^{-}=V_{r^{\prime}} U_{r}^{+}=0$, which contradicts to $\left(U_{r}^{+}, U_{r}^{-}\right) \neq 0$. Thus we have i) and then ii) by Lemma 3.5 i).

Theorem 3.9. Any non-trivial solution of (3.13) corresponds to a standard transformation of a solution in the list Trig- $B_{2}$ Toda- $C_{2}^{(1)}-\mathrm{S}$.

Proof. We will prove this theorem divided into several cases.
Case 1: One of $U^{+}, U^{-}, V, W$ is zero.
Proposition 3.7 assures that we may suppose $V=0$. Then (3.12) turns into

Since $W(t)=a t^{\bar{r}}\left(1+t^{\bar{r}}\right)^{-1}$ if $2 a+b=0$, we may assume $W(t)$ has a pole at $t=1$ by applying a transformation in Lemma 3.5ii) and hence $U^{+}(t)=U^{-}(t)$ by Proposition 3.7 ii).

On the other hand, (3.17) with $q=r^{\prime \prime}$ and that with $q=2 p+r^{\prime \prime}$ show

If $r>0, r r^{\prime \prime}\left(2 r-r^{\prime \prime}\right)\left(r-r^{\prime \prime}\right) W_{r^{\prime \prime}} U_{r}^{-}=0$ and therefore $r^{\prime \prime}=2 r$ or $r^{\prime \prime}=r$. Then by putting $\bar{r}=r$, the equation (3.17) with $p=r$ and $q>r^{\prime \prime}$ implies (3.18) and hence the same argument as above proves (3.19).

Hence the solution corresponds to a standard transformation of Case IV.
Case 1-2: $V=0$ and $\left(U_{r}^{+}, U_{r}^{-}\right)=(1,0)$ or $(0,1)$.
We have $q(2 r-q)(r-q) W_{q}=0$ or $p q(2 r-q)(r-q) W_{q-2 r}=0$. Hence $W(t)=$ $a t^{\bar{r}}+b t^{2 \bar{r}}$ with $b \neq 0$ and $\bar{r} \in \mathbb{Z} \backslash\{0\}$

If $a=0$, then (3.17) with $q=2 \bar{r}$ implies $U_{p}^{-}=0$ for $p \neq 0, \bar{r}, 2 \bar{r}$. If $a \neq 0$, then (3.17) with $(p, q)=\left(\frac{\bar{r}}{2}, 3 \bar{r}\right)$ implies $U_{\frac{r}{2}}^{+}=0$, that with $q=2 \bar{r}$ implies $U_{p}^{-}=0$ for $p \neq 0, \bar{r}, 2 \bar{r}$ and that with $q=\bar{r}$ implies $U_{p}^{-}=0$ for $p \neq 0, \pm \frac{\bar{r}}{2}, \bar{r}$. Hence $U^{-}(t)=c^{-} t^{\bar{r}}+d^{-} t^{2 \bar{r}}$ with $a d^{-}=0$.

Since $\left(U^{+}\left(t^{-1}\right), U^{-}\left(t^{-1}\right), 0, W\left(t^{-1}\right)\right) \in \mathcal{S}\left(B_{2}\right)$, we have $U^{+}(t)=c^{+} t^{-\bar{r}}+d^{+} t^{-2 \bar{r}}$ with $a d^{+}=0$ and the solution corresponds to the standard transform of Case V .

Now we may assume that none of $U^{ \pm}(t), V(t), W(t)$ is zero and

Lemma 3.8 and Lemma 3.5 i) assure that we may assume $r>0$ except for the following case.

Case 2: $W$ and $U^{-}$have poles and $V$ and $U^{+}$are holomorphic at the origin. Then $r^{\prime \prime}<0$ and $r<0$. Put $\bar{r}=-r$. The coefficients of $s^{-\bar{r}} t^{q}$ in (3.13) imply $W(t)=a t^{-2 \bar{r}}+b t^{-\bar{r}}$.

Case 2-1: $W(t)=t^{-2 \bar{r}}+b t^{-\bar{r}}$.
The coefficients of $s^{p} t^{-2 \bar{r}}$ imply $U^{-}(s)=s^{-\bar{r}}$. Note that $U^{-}\left(t^{-1}\right)$ and $W\left(t^{-1}\right)$ are holomorphic at the origin and $\left(U^{+}\left(t^{-1}\right), U^{-}\left(t^{-1}\right), V\left(t^{-1}\right), W\left(t^{-1}\right)\right) \in \mathcal{S}\left(B_{2}\right)$. If $U^{+}\left(t^{-1}\right)$ has a pole at the origin, Lemma 3.8 assures that $V\left(t^{-1}\right)$ is holomorphic there. Hence we may assume $r>0$ by using a transformation in Lemma 3.5 i) if necessary.

Case 2-2: $W(t)=t^{-\bar{r}}$.
The coefficients $s^{p} t^{-\bar{r}}$ in (3.13) imply $U^{-}(s)=s^{-\bar{r}}+c s^{-\frac{\bar{r}}{2}}$ and this case is reduced to the previous case by Lemma 3.5 i).

Now we may assume

Owing to Lemma 3.5 v), we may assume $U_{r}^{-}=0$. Then (3.22) with $q=r^{\prime \prime}+2 r$ means $r^{\prime \prime}=-2 r$ or $r^{\prime \prime}=-r$ and (3.12) with $q=r^{\prime \prime}$ means $U^{-}=0$. Hence this case is reduced to Case 1.

Case 3-2: $\left(U_{r}^{+}, U_{r}^{-}\right)=(1,1)$.
The equation (3.22) with $q=r^{\prime \prime}$ means $r^{\prime \prime}=r$ or $r^{\prime \prime}=2 r$.
Note that (3.22) means $W(t)=a t^{r}\left(1-t^{r}\right)^{-1}+b t^{2 r}\left(1-t^{2 r}\right)^{-1}$. Since $U^{ \pm}, V$ and $W$ are holomorphic at the origin, Lemma 3.5]i) assures that if $r^{\prime} \neq r^{\prime \prime}$, this case is reduced to Case 3-1. Hence we may assume $r^{\prime}=r^{\prime \prime}$ and therefore $\left(V_{r^{\prime}}, W_{r^{\prime}}\right)=(1,1)$ by a suitable translation $s \mapsto a s$. It also follows from Lemma 3.5i) that $U^{-}(s)=$ $c s^{\frac{r^{\prime}}{2}}\left(1-s^{\frac{r^{\prime}}{2}}\right)^{-1}+d s^{r^{\prime}}\left(1-s^{r^{\prime}}\right)^{-1}$ and then this case is reduced to Proposition 3.7iiii).

Thus we may assume $U^{+}(s)=\sum_{i=r}^{N} U_{i}^{+} s^{i}$ with $U_{N}^{+} \neq 0$. Suppose $W_{j}=0$ for $j>M$. If $M>0$, the coefficients of $s^{N} t^{M+2 N}$ in (3.13) implies $W_{M} U_{N}^{+}=0$. Hence $e_{5}=e_{6}=e_{7}=e_{8}=0$ and therefore $\left(U^{+}, 0, V, W\right) \in \mathcal{S}\left(B_{2}\right)$ and Case 1 implies $U^{+}(s)=s^{r}+c^{\prime} s^{2 r}$ with $b c^{\prime}=0$. The solution is a standard transform of case V .

Case 4-3: $e_{1}=e_{2}=\epsilon=0$.

Then if at least two in $\left\{U_{\alpha}, U_{\beta}, U_{\alpha+\beta}\right\}$ do not vanish, Proposition [2.2 shows that $\left(U_{\alpha}(t), U_{\beta}(t), U_{\alpha+\beta}(t)\right)$ is a standard transformation of $\left(t^{r}\left(1-t^{r}\right)^{-1}, t^{r}\left(1-t^{r}\right)^{-1}, t^{r}\left(1-t^{r}\right)^{-1}\right)$ or $\left(C_{1} t^{r}, C_{2} t^{r}, C_{3} t^{-r}\right)$.

The argument above shows the following lemma.
Lemma 4.1. Let $\alpha$ and $\beta \in \Sigma$ such that $\alpha \neq \pm \beta,\langle\alpha, \beta\rangle \neq 0,|\alpha| \geq|\beta|, U_{\alpha} \neq 0$ and $U_{\beta} \neq 0$. Suppose

Then we have the following two cases.
Case 1: $|\alpha|=|\beta|$.

Case 2: $|\alpha|^{2}=2|\beta|^{2}$.

$$ or

U_{\beta}(t)= \begin{cases}C_{1}^{\prime} t^{r}+C_{2}^{\prime} t^{2 r} & \text { if }\langle\alpha, \beta\rangle<0 \\ C_{1}^{\prime} t^{-r}+C_{2}^{\prime} t^{-2 r} & \text { if }\langle\alpha, \beta\rangle>0\end{cases}
$$

Definition 4.2. For the functions $u_{\alpha}$ in (4.4), put

Let $\bar{\Delta}$ be the root system generated by $\Delta$ and let

be the decomposition into irreducible root systems. Put

and we call it an irreducible component of $\Delta$.
We say that $P$ with the potential function $R(x)$ is irreducible if $\bar{\Delta}$ is an irreducible root system of rank $n$ or of type $A_{n-1}$.

Remark 4.3. i) $\Delta=\Delta_{1} \cup \cdots \cup \Delta_{N}$.
ii) Suppose $\alpha \in \Delta_{k}$. Then $\beta \in \Delta$ is an element of $\Delta_{k}$ if and only if there exists a sequence $\alpha_{1}=\alpha, \alpha_{2}, \ldots, \alpha_{\ell}=\beta \in \Delta$ such that $\left\langle\alpha_{i}, \alpha_{i+1}\right\rangle \neq 0$ for $i=1, \ldots, \ell-1$.
Lemma 4.4. Let $\Delta^{\prime}$ be an irreducible component of $\Delta$ and let $\bar{\Delta}^{\prime}$ and $\bar{\Delta}_{L}^{\prime}$ be the root systems generated by $\Delta^{\prime}$ and $\Delta_{L}^{\prime}:=\Delta^{\prime} \cap \Sigma_{L}$, respectively. Suppose $\bar{\Delta}^{\prime}$ is of type $B_{m}$ with $m>2$. Then $\bar{\Delta}_{L}^{\prime}$ is of type $A_{m-1}$ or type $D_{m}$.

Proof. Since $\Delta_{L}^{\prime}$ and $\left\{e_{1}, \ldots, e_{m}\right\}$ generate $\Delta^{\prime}$, there exist $\alpha_{i} \in \Delta_{L}^{\prime}$ such that $\left\langle\alpha_{i}, e_{i}\right\rangle \neq 0$ and $\left\langle\alpha_{i}, e_{i+1}\right\rangle \neq 0$ for $1 \leq i<m$. Since $\alpha_{1}, \ldots, \alpha_{m-1}$ generate a root system of type $A_{m-1}, \bar{\Delta}_{L}^{\prime}$ is of type $A_{m-1}$ or type $D_{m}$.

Lemma 4.5. Let $S$ be a subset of a classical root system $\tilde{\Sigma}$ of type $A$ or $B$. Suppose $S$ generates an irreducible root system $\bar{S}$ and

\langle\alpha, \beta\rangle \leq 0 \quad \text { for } \alpha \in S \text { and } \beta \in S \text { with } \alpha \neq \beta
$$

If the rank of $\bar{S}$ is larger than one, $S$ is the image of one of the following sets under the suitable transformation by an element of the Weyl group of $\tilde{\Sigma}$.

\left\{e_{1}-e_{2}, \ldots, e_{m-1}-e_{m}, e_{m}\right\} & (m \geq 2), \\
\left\{e_{1}-e_{2}, \ldots, e_{m-1}-e_{m}, e_{m-1}+e_{m}\right\} & (m \geq 4), \\
\left\{e_{1}-e_{2}, \ldots, e_{m-1}-e_{m}, e_{m}-e_{1}\right\} & (m \geq 3), \\
\left\{e_{1}-e_{2}, \ldots, e_{m-1}-e_{m}, e_{m},-e_{1}\right\} & (m \geq 2), \\
\left\{e_{1}-e_{2}, \ldots, e_{m-1}-e_{m}, e_{m-1}+e_{m},-e_{1}-e_{2}\right\} & (m \geq 4), \\
\left\{e_{1}-e_{2}, \ldots, e_{m-1}-e_{m}, e_{m-1}+e_{m},-e_{1}\right\} & (m \geq 3) . \tag{4.28}
\end{array}
$$

Proof. Let $S^{\prime}$ be a subset of $S$ such that $S^{\prime}$ is a transformation of one of the sets $\left\{e_{1}\right\},\left\{e_{1}-e_{2}\right\}$, 4.22), (4.23) and (4.24) by an element of the Weyl group of $\tilde{\Sigma}$.

If the number of the elements of $S^{\prime}$ is smaller than the rank of $\bar{S}$, there exists $\alpha \in S$ and $\beta \in S^{\prime}$ such that $\langle\alpha, \beta\rangle \neq 0$ and $\alpha \notin \sum_{\gamma \in S^{\prime}} \mathbb{R} \gamma$. Then it is easy to see that $S^{\prime} \cup\{\alpha\}$ is a transformation of (4.22), (4.23) or (4.24) by a suitable element of the Weyl group.

Thus we may assume that $S^{\prime}$ equals (4.22) or (4.23) or (4.24) and that the number of the elements of $S^{\prime}$ equals the rank of $\bar{S}$. Put $S_{o}=\left\{\beta \in \tilde{\Sigma} \cap \sum_{\gamma \in S^{\prime}} \mathbb{R} \gamma ;\langle\beta, \gamma\rangle \leq\right.$ 0 for any $\left.\gamma \in S^{\prime}\right\}$. Then if $S^{\prime}$ is (4.22) or 4.23), $S_{o}=\left\{e_{m}-e_{1}\right\}$ or $\left\{-e_{1},-e_{1}-e_{2}\right\}$, respectively. If $S^{\prime}$ is (4.24), then $S_{o}=\left\{-e_{1}-e_{2},-e_{1}\right\}$ or $\left\{-e_{1}-e_{2}\right\}$ according to $\tilde{\Sigma}$ is of type $B$ or $A$, respectively. Thus the lemma is clear because $S^{\prime} \subset S \subset S^{\prime} \cup S_{o}$.

Lemma 4.6. Let $\bar{\Delta}$ be a root system generated by a classical root system $\tilde{\Sigma}$ of type $A_{n-1}$ or $B_{n}$. Let $\bar{\Delta}=\bar{\Delta}_{1} \cup \cdots \cup \bar{\Delta}_{N^{\prime}} \cup \cdots \cup \bar{\Delta}_{N}$ be an irreducible decomposition so that the rank of $\bar{\Delta}_{i}$ is larger than one for $1 \leq i \leq N^{\prime}$ and the rank of $\bar{\Delta}_{i}$ equals one for $N^{\prime}<i \leq N$. Then under the transformation by an element of the Weyl group of $\Sigma$, there exists a sequence of integers $0=n_{0}<n_{1}<n_{2}<\cdots<n_{N^{\prime}}$ such that $\bar{\Delta}_{i}$ is generated by

\begin{cases}\left\{e_{n_{i-1}+1}-e_{n_{i-1}+2}, \ldots, e_{n_{i}-1}-e_{n_{i}}\right\} & \text { if } \bar{\Delta}_{i} \text { is of type } A, \\ \left\{e_{n_{i-1}+1}-e_{n_{i-1}+2}, \ldots, e_{n_{i}-1}-e_{n_{i}}, e_{n-i-1}+e_{n_{i}}\right\} & \text { if } \bar{\Delta}_{i} \text { is of type } D \\ \left\{e_{n_{i-1}+1}-e_{n_{i-1}+2}, \ldots, e_{n_{i}-1}-e_{n_{i}}, e_{n_{i}}\right\} & \text { if } \bar{\Delta}_{i} \text { is of type } B\end{cases}
$$

for $1 \leq i \leq N^{\prime}$. Moreover if $N^{\prime}<i \leq N$. $\bar{\Delta}_{i}$ equals $\left\{ \pm e_{\nu}\right\},\left\{ \pm\left(e_{\nu}-e_{\nu+1}\right)\right\}$ or $\left\{ \pm\left(e_{\nu}+e_{\nu+1}\right)\right\}$ for a suitable $\nu$ with $\nu>n_{N^{\prime}}$.
Proof. Note that $\left\{\alpha \in \tilde{\Sigma} ;\left\langle e_{1}-e_{2}, \alpha\right\rangle=0\right\}$ is generated by

\begin{cases}\left\{e_{3}-e_{4}, \ldots, e_{n-1}-e_{n}\right\} & \text { if } \tilde{\Sigma} \text { is of type } A_{n} \\ \left\{e_{3}-e_{4}, \ldots, e_{n-1}-e_{n}, e_{n}\right\} \text { and }\left\{e_{1}+e_{2}\right\} & \text { if } \tilde{\Sigma} \text { is of type } B_{n}\end{cases}
$$

Hence the lemma is clear by the induction on $N$ if $N^{\prime}=0$.
Suppose $N^{\prime}>0$. By the preceding lemma, we may assume that the fundamental system of $\Delta_{1}$ is (4.22), (4.23) or (4.24). Then $\left\{\alpha \in \tilde{\Sigma} ;\left\langle e_{1}-e_{2}, \alpha\right\rangle=0\right\}$ is generated by

\begin{cases}\left\{e_{m+1}-e_{m+2}, \ldots, e_{n-1}-e_{n}\right\} & \text { if } \tilde{\Sigma} \text { is of type } A_{n} \\ \left\{e_{m+1}-e_{m+2}, \ldots, e_{n-1}-e_{n}, e_{n}\right\} & \text { if } \tilde{\Sigma} \text { is of type } B_{n}\end{cases}
$$

and the lemma is clear by the induction on $N^{\prime}$.
Remark 4.7. i) Fix $\alpha \in \Delta^{\prime}$. Let $v \in \mathbb{R}^{n}$ with $\langle\alpha, v\rangle=0$. Then $\partial_{v} u_{\alpha}(\langle\alpha, x\rangle)=0$.
ii) If the rank of $\bar{\Delta}^{\prime}$ equals one, $u_{\alpha}(t)$ for $\alpha \in \Delta^{\prime}$ is any function.
iii) If the rank of $\bar{\Delta}^{\prime}$ is larger than one, $U_{\alpha}(t)$ with $\alpha \in \Delta^{\prime}$ are global meromorphic functions and therefore we may study $\left\{U_{\alpha}(t) ; \alpha \in \Delta^{\prime}\right\}$ under the image of a transformation by the Weyl group.
iv) By the irreducible decomposition in Definition 4.2 our classification reduces to the case when $P$ is irreducible.

Theorem 4.8. Let $\Delta^{\prime}$ be an irreducible component of $\Delta$. Then the potential function $R_{\Delta^{\prime}}(x):=\sum_{\alpha \in \Delta^{\prime}} u_{\alpha}(\langle\alpha, x\rangle)$ is a transformation of a function in the following list with $m \geq 2$ under a map generated by the Weyl group, translations and scalings of the coordinates (cf. Lemma 3.5).

Type $A_{1}$ : If the rank of $\bar{\Delta}^{\prime}$ equals $1, R_{\Delta^{\prime}}(x)$ is an arbitrary function of $\langle\alpha, x\rangle$ with $\alpha \in \Delta^{\prime}$. This solution is called trivial.

Type $B_{2}$ : A standard transform of the function in the list (Trig- $\left.B_{2}\right)-\left(\operatorname{Toda}-C_{2}^{(1)}\right)$ in 3 with replacing $(x, y)$ by $\left(x_{1}, x_{2}\right)$.
(Trig- $B_{m}$ ): Trigonometric potential of type $B_{m}$ :

(Toda- $B_{m}^{(1)}$ ): Toda potential of type $B_{m}^{(1)}$ is (Toda- $B_{m}^{(1)}$-bry) with $C_{3}=C_{4}=0$.
(Toda- $D_{m}^{(1)}$ ): Toda potential of type $D_{m}^{(1)}$ is (Toda- $D_{m}^{(1)}$-bry) with $C_{1}=C_{2}=$ $C_{3}=C_{4}=0$.
(Toda- $D_{m}$-bry): Toda potential of type $D_{m}$ with boundary is (Toda- $B_{m}^{(1)}$-bry) with $C_{1}=C_{2}=0$.
(Toda- $A_{m-1}$ ): Toda potential of type $A_{m-1}$ is (Toda- $C_{m}^{(1)}$ ) with $C_{1}=C_{2}=$ $C_{3}=C_{4}=0$.
(Toda- $B C_{m}$ ): Toda potential of type $B_{m}$ is (Toda- $C_{m}^{(1)}$ ) with $C_{1}=C_{2}=0$.
(Toda- $D_{m}$ ): Toda potential of type $D_{m}$ is (Toda- $B_{m}^{(1)}$-bry) with $C_{1}=C_{2}=$ $C_{3}=C_{4}=0$.

Proof of Proposition 4.8 We may assume that $\bar{\Delta}^{\prime}$ is not of type $B_{2}$. Then Lemma 4.4 says that for any elements $\alpha$ and $\beta$ of $\Delta_{L}^{\prime}$, there exists a sequence $\alpha=\alpha_{1}, \alpha_{2}, \ldots, \alpha_{k}=\beta$ such that $\left\langle\alpha_{i}, \alpha_{i+1}\right\rangle \neq 0$ and $\alpha_{i} \in \Delta_{L}^{\prime}$ for $i=1, \ldots, m-1$. Note that the number of elements of $\Delta_{L}^{\prime}$ is larger than one. Fix $\alpha \in \Delta^{\prime}$. Then lemma 4.1 assures that $U_{\alpha}(t)=C t^{r}\left(1-a t^{r}\right)^{-1}$ with $a \in \mathbb{C}$.

Case 1: $U_{\alpha}(t)=C t^{r}$.
Lemma 4.1 proves that $U_{\beta}(t)=C_{\beta} t^{2 \epsilon(\beta) r}$ for $\beta \in \Delta_{L}^{\prime}$. Here $\epsilon(\beta)=1$ or -1 . Then the set $S_{L}=\left\{\epsilon(\beta) \beta ; \beta \in \Delta_{L}^{\prime}\right\}$ satisfies the assumption of Lemma 4.5 and therefore we may assume that $S_{L}$ equals (4.22), 4.24), (4.25) or 4.27) under the transformation of an element of the Weyl group, which correspond to (Toda- $A_{m-1}$ ), (Toda- $D_{m}$ ), (Toda- $A_{m-1}^{(1)}$ ) and (Toda- $D_{m}^{(1)}$ ), respectively, if $U_{e_{i}}(t)=0$ for $i=$ $1, \ldots, m$. Suppose $U_{e_{i}}(t) \neq 0$ with a suitable $i$ satisfying $1 \leq i \leq m$. Then Lemma 4.1 shows that one of the the following two cases occurs, from which the statement of the proposition is clear.

Case 1-1: $U_{e_{i}}(t)=C^{\prime} t^{r}\left(1-a t^{r}\right)+C^{\prime \prime} t^{2 r}\left(1-a t^{2 r}\right)$ with $a \neq 0$.
We may assume $a=1$ by a translation. Lemma4.1]shows that then $U_{-e_{i}-e_{i+1}}(t)=$ $U_{e_{i}-e_{i+1}}(t)$ and if $i>1$ and $U_{e_{i-1}-e_{i}}(t)=U_{e_{i-1}+e_{i}}(t)$ if $i<m$. Therefore
$\begin{cases}i=1 \text { and } S_{L} \text { equals 4.27) } & \left(\Rightarrow\left(\text { Toda- } D_{m}^{(1)} \text {-bry }\right)\right) \\ \text { or } & \\ i=m \text { and } S_{L} \text { equals 4.24) or 4.27) } & \left(\Rightarrow\left(\text { Toda- } B_{m}^{(1)} \text {-bry) or (Toda- } D_{m}^{(1)} \text {-bry) }\right) .\right.\end{cases}$
Case 1-2: $U_{e_{i}}(t)=C^{\prime} t^{\epsilon_{i} r}+C^{\prime \prime} t^{2 \epsilon_{i} r}$ with $\epsilon_{i}= \pm 1$.
Lemma 4.1 says $\epsilon_{i}\left\langle e_{i}, \alpha\right\rangle \leq 0$ for $\alpha \in S_{L}$, only the following cases occur.

Case 2: $U_{\alpha}(t)=C_{\alpha} t^{r}\left(1-a_{\alpha} t^{r}\right)^{-1}$ with $a_{\alpha} \neq 0$.
The argument just before Lemma 4.1 says that the condition $U_{\beta}(t) \neq 0$ and $U_{\gamma}(t) \neq$ 0 with $|\alpha|=|\beta|=|\gamma|$ means $U_{w_{\beta}(\gamma)}(t) \neq 0$. Hence $\left\{ \pm \beta ; \beta \in \Delta_{L}^{\prime}\right\}$ is a root system of type $A_{m-1}$ or $D_{m}$. We may assume $a_{\alpha}=1$ for its simple root $\alpha$ and hence $C_{\alpha}$ and $a_{\alpha}$ does not depend on $\alpha \in \Delta_{L}^{\prime}$ because of (4.18) and Proposition 2.1

Case 2-1: $\bar{\Delta}_{L}^{\prime}$ is of type $A$.
Considering $\left\{U_{e_{i}+e_{i+1}}, U_{e_{i}-e_{i+1}}, U_{e_{i}}, U_{e_{i+1}}\right\}$, Theorem 3.9]shows $U_{e_{i}}(t)=U_{e_{i+1}}(t)=$ $C_{1} t^{r}+C_{2} t^{2 r}+C_{3} t^{-r}+C_{4} t^{-2 r}$ and this case is reduced to (Trig- $A_{m-1}$-bry).

Case 2-2: $\bar{\Delta}_{L}^{\prime}$ is of type $D$.
By the same consideration as in the previous case we may assume $U_{e_{\nu}}(t)=C_{1} t^{r}(1-$
$\left.t^{r}\right)^{-1}+C_{2} t^{2 r}\left(1-t^{2 r}\right)^{-1}+C_{3}\left(t^{r}-t^{-r}\right)+C_{4}\left(t^{2 r}-t^{-2 r}\right)$ for $\nu=1, \ldots, m$. Hence this case is reduced to $\left(\operatorname{Trig}-B_{m}\right)$.

Corollary 4.10. The non-trivial solutions in Proposition 4.8 which have regular singularity at the point $t=0$ are in Corollary 3.10 or in the following list.
(Trig- $B C_{m}$-reg)

Remark 4.11. We have a natural compactification $X$ of the space $\mathbb{C}^{n}$ of $t$ so that for every $w \in W_{\Sigma\left(B_{n}\right)}$

$$
s_{j}^{w}=e^{-\left(x_{j}^{\prime}-x_{j+1}^{\prime}\right)} \quad(j=1, \ldots, n-1), \quad s_{n}^{w}=e^{-x_{n}^{\prime}} \quad \text { with } x^{\prime}=w x
$$

gives a local coordinate system of $X$ and $t_{j}=s_{j}^{e}(j=1, \ldots, n)$. Then the non-trivial potential functions $R(x)$ we have obtained is meromorphic on $X$.

If $R(x)$ is holomorphic at $\left(s_{1}^{w}, \ldots, s_{n}^{w}\right)=0$ for any $w \in W_{\Sigma\left(B_{n}\right)}, R(x)$ is said to have regular singularity at every infinity. In this case, our classification says that $R(x)$ is decomposed to the functions (Trig- $B C_{m}$-reg) and (Trig- $A_{m}$ ) which exactly corresponds to Heckman-Opdam's potential function of classical type. This gives a characterization of Heckman-Opdam's hypergeometric equations.
