# Inhom ogeneous loop m odels w ith open boundaries

W e consider the crossing and non-crossing $O$ (1) dense loop m odels on a sem i-in nite strip, w ith inhom ogeneities (spectral param eters) that preserve the integrability. W e com pute the com ponents of the ground state vector and obtain a closed expression for their sum, in the form of $P$ fa an and determ inantal form ulas.

## 1. Introduction

The interplay between statisticalm echanics and combinatorics is an everlasting one, and takesm any di erent guises as tim e goes. Som e activity has developed recently around
 tw o-dim ensional statistical m odels of loops, which m ay altematively be view ed as onedim ensional quantum (spin) chains. A $s$ it tumed out, and am ong other integer num bers, the totalnum ber of altemating sign $m$ atrioes (A SM ) popped out of the study of the ground state vector of the integrable quantum spin chain corresponding to the dense O (1) loop m odel on a sem i-in nite cylinder of square lattice. T his num ber counts the total num ber of con gurations of the ige $m$ odel on a square $w$ ith dom ain $w a l l$ boundary conditions. It also counts the con gurations of the fully packed loop m odel on a square grid, yet another type of loop m odel, now with tw o kinds of loops crossing or touching at each vertex, and connecting by pairs the points at the periphery of the grid. This opened up the road to $m$ any $m$ ore observations tumed into con jectures, regarding correlation functions as well as other boundary conditions, and all involving integer sequences (see for instance Refs. $\underline{\Lambda}_{1}^{-1}$ ${ }_{-1}^{[1 / 1]}$ ). A $n$ activity also developed in trying to relate som e particular subsets of con gurations of the fully packed loop m odel to rhom bus tilings of planar dom ains w ith possible conic


The idea ofconsidering inhom ogeneous versions of the loop m odels cam ew ith trying to $m$ odify the boundary conditions of the loop $m$ odelon a cylinder by introducing dislocations in the underlying lattioe $[1]$ m ultiparam eter generalization of the loop $m$ odel that preserves its integrability actually leads to a ground state vector whose sum of suitably nom alized com ponents coincides w ith the so-called Izergin $K$ orepin determ inant, de ned as the partition function of the inhom ogeneous six vertex $m$ odel on a square grid $w$ ith dom ain $w a l l$ boundary conditions [1] suitably norm alized entries of the ground state vector of the $O$ (1) spin chain is the total num ber of altemating sign $m$ atrices. The general proof of [ī] $]$ takes full advantage of the integrability of the $m$ odel, and transform $s$ intertw in ing relations for the transfer $m$ atrix of the loop $m$ odel into local recursion relations for the ground state vector's entries.

A nother loop m odel, very sim ilar in nature to the O (1) loop m odel, also includes the possibility for loops to cross one-another. This is the so-called crossing or B rauer $O$ (1) loop $m$ odel, for which $m$ any com binatorial con jectures were $m$ ade in Ref. $[1 \overline{1}$-1 $]$, surprisingly
relating this quantum chain to degrees of com ponents of the com $m$ uting variety, com puted
 loop $m$ odel, were applied to this case in Ref. [2]0] $\overline{0}]$, allow ing to prove $m$ ost of the con jectures of Ref. $1 \mathrm{i} \bar{i}_{-1}^{1}$ ]. The algebro-geom etric intenpretation of these results was extended recently in Ref. $\left.{ }_{2} \overline{1} \overline{1}_{-1}\right]$.
 der, i.e. w ith periodic boundary conditions. The aim of the present note is to investigate the case of open boundary conditions, nam ely of (crossing or non-crossing) inhom ogeneous loop $m$ odels de ned on a sem i-in nite strip of square lattioe. By adapting the techniques of
 state vectors. Them ain outcom ew illbe som eparticularly sim ple Pfa an or determ inantal form ulas for the state sum as an explicit function of the $m$ odel's inhom ogeneities (spectral param eters). In the case of crossing loops, we will obtain a \re ected" generalization of the results of Ref.[2] sum $w$ ith the partition function of so-called $U$-tum sym $m$ etric altemating sign $m$ atrices of Ref. $\left[\frac{2}{2} \overline{2}\right]$. Let us stress at this point that as opposed to the crossing loop case where our proof is rigorous and com plete, the non-crossing case relies on an assum ption we $m$ ake on the total degree of the vector's com ponents, as functions of the spectral param eters. A though we have no doubt this is true, proving it would certainly require a lot ofe ort, and we prefer to concentrate on the consequences of this property on the ground state vector.

The paper is organized as follow s . Section 2 is devoted to the case of crossing loops w ith open boundaries. A fter giving de nitions in Sect 2.1, we show in Sect 2.2 the funda$m$ ental intertw ining relations satis ed by the transfer $m$ atrix of the $m$ odel. Solving for all the subsequent relations leads to the solution of Sect 2.3 in the form of an explicit recursion relation de ning the \fundam ental" entry of the ground state vector, out of which all others are iteratively constructed. T he above relations are tumed into recursion relations for all entries of the vector in Sect 2.4, as well as into sym m etry properties of the entries in Sect.2.5. U sing all these properties allow sfor proving two sum rules on the ground state vector com ponents in Sect2.6. Section 3 is concemed w th the case of non-crossing loops. W e follow the sam e route: de nitions (Sect.3.1), intertw ining properties (Sect.3.2), solution (Sect.3.3), recursion relations (Sect.3.4), sym m etries (Sect.3.5), and nally sum rule (Sect.3.6). A few concluding rem arks are gathered in Sect.4, while sam ples of entries of the ground state vector are given in appendioes A and B respectively for the crossing and non-crossing case.
2. The inhom ogeneous $O$ (1) crossing loop m odelw ith open boundaries

### 2.1. Transfer m atrix and basic relations

W e consider the open boundary version of the inhom ogeneous O (1) \B rauer" crossing loop $m$ odel considered in [20 sem i-in nite cylinder of even perim eter, thus giving rise to periodic boundary conditions. W e now consider the sam emodel on a square lattice that covers a sem i-in nite strip of width $N$ (even or odd), with centers of the lower edges labelled 1;2;::; N .0 n each face of th is dom ain of the square lattice, we draw at random, say with respective probabilities $a_{i} ; b_{i} ; c_{i}$ in the $i$-th colum $n$ (at the vertical of the point labelled i) one of the three follow ing con gurations


The strip is $m$ oreover supplem ented $w$ ith the follow ing pattem of $x e d$ con gurations of loops on the (left and right) boundaries:


In a given con guration, the points 1;2;::; N are connected by pairs (except for one of them if $N$ is odd, in which case it is connected to the in nity along the strip). Such a pattem of connection is called an open crossing link pattern. T he set of open crossing link pattems on $N$ points is denoted by $C L P_{N}$, and has cardinality ( $2 \mathrm{n} \quad 1$ )!! for $\mathrm{N}=2 \mathrm{n}$ or $\mathrm{N}=2 \mathrm{n}$ 1. The open crossing link pattems $2 \mathrm{CLP} \mathrm{N}_{\mathrm{N}}$ span a complex vector space of dim ension ( 2 n 1) !!, w ith canonicalbasis fjig $2 \mathrm{cLP} \mathrm{N}_{\mathrm{N}}$. An exam ple of loop con guration together w ith its link pattem are depicted in Fig.1.

O ne interesting question is to nd for given probability weights $a_{i} ; b_{i} ; c_{i}$, the relative probabilities of the occurrence of the crossing link pattems $2 \mathrm{CLP} \mathrm{N}_{\mathrm{N}}$. The crucial

property of this loop $m$ odel is that it is integrable for the follow ing choice of probability weights

$M$ ore precisely, the so-called $R-m$ atrix of the $m$ odel is an operator acting on a vector space of open crossing link pattems or any tensor product thereof, say at som e points labeled i and $j$ of the link pattems, as follow s:

Here $z$ and w are (arbitrary com plex) spectral param eters attached respectively to the points labelled i and j, and are carried, as well as the point labels, by the oriented straight lines in the pictorial representation on the left. E ach of the three possible con gurations ofboxes on the right acts on open crossing link pattems as follow $s$ : the con guration $m$ ust be connected by its low er end to the point $i$ and by its right end to the point $j$ of the link pattems, thus form ing new pattems whose new points i and $j$ are the upper and left ends of the box respectively. A ltematively, the $R-m$ atrix $m$ ay act locally at points $i, i+1$ on
open crossing link pattemswith $N$ points, via the perm uted $m$ atrix $R=P R$ :

for $i=1 ; 2 ;::: ; \mathrm{N} \quad 1$ and where P simply perm utes the point labels, so that each label is conserved along the vertical direction. $W$ e have displayed the $m$ atrix $R$ as a linear com bination of the three local operators $I \quad I, f_{i}, e_{i}, i=1 ; 2 ;:: ; \mathrm{N} \quad 1$, which form the generators of the $B$ rauer algebra $B_{N}(1)$, sub ject to the relations:

These relations are clear from the pictorial representation of the action on link pattems, nam ely: I I leaves the link pattems unchanged, $f_{i}$ crosses the links term inating at points $i$ and i+ 1 , and $e_{i}$ glues the tw $o$ ends of links at $i$ and i+ 1 and adds up a new link connecting i to i+ 1. If a loop is form ed in the process, it m ust sim ply be erased (loops are given a weight 1 here, leading to the relation $e_{i}^{2}=e_{i}$ ).

Follow ing Sklyanin [2-3̄1], we also introduce a boundary operator $K_{i}(z)$, whose action is diagonal at the points labelled $i=1$ or $N$, w ith $m$ atrix elem ent 1, but whose e ect is to $S w$ itch the spectral param eter $z!\quad z$ attached to that point, $w$ ith the pictorial representation

$T$ he solution to these equations forw hidh the $R \mathrm{~m}$ atrix is a linear com bination ofgenerators I $I ; e_{i} ; f_{i}$ is essentially unique (up to unim portant rede nitions) and takes the form ( The equation $(\underline{2} . \bar{d})$ is now supplem ented by the boundary $Y$ ang-B axter relations

The transfer $m$ atrix $T\left(t \dot{j}_{1} ; z_{2} ; \quad N\right.$ i)zof our m odel reads pictorially


It acts from the vector space of open crossing link pattems with $N$ points to itself. A s a consequence of the $Y$ ang-B axter and boundary $Y$ ang-B axter equations, the transfer $m$ atrices at tw o distinct values of $t$ com $m$ ute.

W e denote by ${ }^{(N)}\left(z_{1} ; z_{2} ; \quad N\right.$ ithe com $m$ on ground state vector of the $T$ 's for xed values of the $z_{i}$ 's, nam ely such that

As $T$ is a rational fraction of the $z_{i}$ 's, we norm alize ${ }_{N}$ so that all its entries are coprim e polynom ials of the $z_{i}$ 's. P icking say $t=0$, wem ay view the entries of (N) as the relative probabilities of open link pattem connections in random crossing loop con gurations w ith inhom ogeneous probabilities $\left(a_{i} ; b_{i} ; c_{i}\right)=\left(a\left(z_{i}\right) ; b\left(z_{i}\right) ; c\left(z_{i}\right)\right)$ in each colum $n$ i of the strip, and the equation $(\overline{2} \overline{1} \overline{2})$ expresses nothing but the invariance of probabilities under the addition of two rows to the sem i-in nite cylinder (left and right boundaries are indeed invariant only under translations of two lattice spacings). This interpretation is stricto
sensu only valid in the range of $z_{i}$ 's leading to $a_{i} ; b_{i} ; c_{i} 2[0 ; 1]$, in which case $(\mathbb{N})$ is the $P$ erron $\mp$ robenius eigenvector of $T$.

A last rem ark is in order. It tums out that the case of odd size $\mathrm{N}=2 \mathrm{n} \quad 1 \mathrm{~m}$ ay alw ays be recovered from that of even size $N=2 n$, upon taking $z_{2 n}$ ! 1 . Indeed,
 rightm ost $R$ m atrix elem ents (acting at the point labelled $N$ ) both tend to $f_{N}$, hence the action at point $N$ decouples from the transfer $m$ atrix, and we have the reduction $T\left(t \dot{z}_{1} ;::: ; \mathrm{z}_{\mathrm{N}}\right)!\mathrm{T}\left(\mathrm{t} \dot{z}_{1} ;::: ; \mathrm{Z}_{\mathrm{N}} \quad 1\right.$ ) I , reading pictorially

This implies that when $z_{N}$ ! 1 , the eigenvector $(\mathbb{N})\left(z_{1} ;::: ; \mathrm{z}_{\mathrm{N}}\right)$ becom es proportional (at leading order in $\mathrm{z}_{\mathrm{N}}$ ) to (N ${ }^{1)}\left(\mathrm{z}_{1} ;::: ; \mathrm{z}_{\mathrm{N}} \quad 1\right.$ ). This allow s for recovering the odd N case from the even N one. H enœforth, throughout the paper and unless otherw ise speci ed, we w ill alw ays assum e that N is even, and write $\mathrm{N}=2 \mathrm{n}$.

### 2.2. Intertw in ing

A s an im $m$ ediate consequence of the $Y$ ang-B axter equation, we have the intertw in ing property

A $n$ im portant direct consequence ofe $q$. ( $\left.2-1,1 \bar{T}_{1}\right)$ is that ${ }^{(N)}$ vanishes $w h e n z_{i+1}=1+z_{i}$ if the link pattem has no arch joining i and i+ 1. This is easily deduced for instance
 therefore only com ponents $w$ ith an arch joining ito i+ 1 m ay be non-zero. By taking appropriate products of $R$, this was straightforw ardly extended in thē $\overline{-1}]$, and (N) actually has the general property:
(P 1) For any pair $i<j$ of points such that, in the link pattem, no arch connects any pair of points am ong $i ; i+1 ;::: ; j$, the component $\mathbb{N}^{(N)}$ vanishes when $z_{j}=1+z_{i}$.
The rst set of relations ( $2,1,1)$ tums out to be su cient to generate all the entries of (N) from say that corresponding to the $m$ axim ally crossing link pattem, stilldenoted 0
by a slight abuse of notation, and that connects points i and $i+n, i=1 ; 2 ;:: ; n$ : indeed, like in Ref. $1 \overline{\underline{2}} \overline{0} \overline{1}]$, we just have to follow \paths" from 0 to $=f_{\mathrm{i}_{1}} \mathrm{f}_{\mathrm{i}_{2}} \quad \mathrm{i}_{\mathrm{k}} \mathrm{f} 0$ obtained by successive actions of the generators $f_{i}$, restricted in such a way that they do not act trivially (i.e. $f_{i}$ never acts on a link pattem that connects points i and i+ 1) and apply (2.17) accordingly.  other set of relations (2,ig) actually serves this purpose, as we shall see in next section. To conclude this section, let us mention tw o $m$ ore intertw ining properties, one in the $\backslash \mathrm{bulk}$ ", and the other on the boundary. The form er will lead to the $m$ ain recursion relation on entries of (N), while the latter will allow to derive som e boundary sym m etry property of ${ }^{(N)}$, both instrum ental in eventually computing the sum on the entries of ${ }^{(N)}$ ). An im portant conclusive rem ark is in order. An altemative transfer $m$ atrix $\mathrm{T}^{0}$ for the inhom ogeneous crossing loop $m$ odel w ith open boundary conditions $m$ ay be written uniquely in term sof \bulk" (R) and \boundary" (K ) operators, as shown for instance in $F$ ig 2. The com $m$ utation of $T^{0} w$ th $T$ is a consequence of the $Y$ ang $B$ axter and boundary Y ang Baxter equations (2. (2. inherited from the intertw ining properties involving $R$ and $K$ (nam ely Eqs. (2. $\left.\overline{1} \overline{1}_{1}\right)-\left(2,1 \overline{1}_{1}\right)$
 produce an obvious (Perron $\mp$ robenius) eigenvector for $T^{0}$. The purpose of next section is to exhibit a candidate for ${ }_{0}^{(\mathbb{N})}$ for which all these relations $w$ ill be satis ed: this in
tum w illprove, by a uniqueness argum ent, that the candidate for ${ }_{0}^{(\mathbb{N})}$ is indeed the right value, thus solving our problem for all com ponents of (N).

### 2.5. Sym m etries

3. The inhom ogeneous O (1) loop m odelw ith open boundaries

W e now tum to the open boundary version of the inhom ogeneous ( 1 ) (non-crossing) loop m odel considered in Refs.[i] 1 the sam e notations for transfer $m$ atrioes, ground state vectors, fundam ental link pattems, etc... as in the Brauer case, as there is no ambiguly that from now on we change the sub ject and dealw ith a di erent case. This allow sfor avoiding $m$ any repetitions, as $m$ any of the equations of the $B$ rauer case still hold in the non-crossing one.

### 3.1. Transfer $m$ atrix and basic relations

Like in the B rauer case, the m odel of non-crossing loops was originally de ned on a square lattioe w rapped on a sem i-in nite cylinder ofeven perim eter, giving rise to periodic boundary conditions. W e now consider the sam e m odel on a square lattice that covers a sem i-in nite strip of width N (even or odd), w ith centers of the low er edges labelled $1 ; 2 ;::: ; N$. W e attach probabilities ( $\mathrm{t}_{\mathrm{i}} ; 1 \quad \mathrm{t}_{\mathrm{i}}$ ) to the two face loop con gurations

in the colum $n$ above the edge labelled i. W e m oreover supplem ent the picture $w$ ith the sam e pattems of xed con gurations of loops on the (left and right) boundaries as for the B rauer case, as depicted in Eq. ( the N labelled points (one of which is connected to in nity if N is odd), via $\mathrm{n}=\mathbb{N}=2$ ] non-crossing arches. The set of such link pattems is denoted by $L P_{N}$, and has cardinality $\mathrm{C}_{\mathrm{n}}=\underset{\mathrm{n}}{2 \mathrm{n}}=(\mathrm{n}+1)$ the n -th C atalan num ber, for $\mathrm{N}=2 \mathrm{n}$ or $\mathrm{N}=2 \mathrm{n} \quad 1$. A s before, we also consider the $\mathrm{c}_{\mathrm{n}}$-dim ensional com plex vector space w ith canonical basis indexed by elem ents of $L P_{N}$.
$T$ he transfer $m$ atrix for this system is built out of the basic $R \rightarrow m$ atrix, that acts on open link pattems or tensor products thereof via:

A s before we denote by ${ }^{(N)}\left(z_{1} ; z_{2} ; \quad N ;\right) z t h e ~ c o m m$ on ground state vector of the $T$ 's for xed values of the $z_{i}{ }^{\prime}$ s, satisfying ( 2,12$)$. As $T$ is a rational fraction of the $z_{i}{ }^{\prime}$, ,
we norm alize $\mathrm{N}_{\mathrm{N}}$ so that all its entries are coprim e polynom ials of the $\mathrm{z}_{\mathrm{i}}$ 's. W em ay view the entries of (N) as relative probabilities of link pattem connections in random loop con gurationswith inhom ogeneous probabilities ( $t_{i} ; 1 \quad t_{i}$ ) in the $i$-th colum $n$ of the strip, and w ith $t_{i}=\left(\begin{array}{ll}q z_{i} & t\end{array}\right)=\left(\begin{array}{ll}q t & z_{i}\end{array}\right)$. $T$ his interpretation is again stricto sensu only valid in the range of $z_{i}$ 's leading to $t_{i} 2[0 ; 1]$, in which case $\mathbb{N}^{(N)}$ is the P erron $\mp$ robenius eigenvector of $T$.

The rem ainder of this note is based on an em pirical observation, which we con jecture to be true, that for even $N=2 n,(\mathbb{N})$ de ned above is a polynom ial of total degree $3 n\left(\begin{array}{ll}n & 1)\end{array}\right)$ and partial degree $2\left(\begin{array}{ll}n & 1)\end{array}\right.$ in each variable. A sim ilar property was proved in a rather indirect way in [1] [1] involving the details of the Bethe A nsatz solution of the corresponding integrable m odel. In the present case, we believe such a proof should be w thin reach, although technically tedious, but we will content ourselves with assum ing the result. This property was the $m$ ain di erence betw een the strategies of proof in the crossing and non-crossing periodic boundary loop $m$ odels of $R$ efs. $[\underline{120}]$ appearing as m ore straightforw ard, as it does not require any bound on the degree of the ground state vector.

An illustration is given in A ppendix B, where the entries of $(\mathbb{N})$ are listed for the case $N=4$.

Fig. 3: A non-crossing link pattem (left) and its associated D yck path (right). The box decom position of the path is indicated, as well as the corresponding actions of $e_{i}$ on the fundam ental link pattem $m$ ade of consecutive arches connecting points $2 i \quad 1$ and $2 i$.

If $j=i+1$, this is easily deduced from the relation $(\underline{1}-\overline{1})$, by noting that $R_{i ; i+1}\left(z_{i} ; q z_{i}\right) /$ $e_{i}$. It is easily generalized to $m$ ore distant points $i<j$ by considering suitable products of $R m$ atrices (see Ref. to the open boundary case is straightforw ard).

For even $N=2 n$, these equations allow to determ ine all the entries of $(\mathbb{N})$ in term $s$ of that corresponding to the link pattem 0 w ith maxim ally nested arches, that connects points $i$ and $2 n+1$ i. Indeed, we $m$ ay decom pose any link pattem canonically into successive actions of $e_{i}$ on the "lowest" one, $m$ ade of $n$ little arches connecting points 2i 1 to 2i. This is best seen in the D yck path form ulation of link pattems, which are represented as path s on a square lattice as show $n$ in $F$ ig. 3. The path of a given link pattem is de ned as follow s. W e visit the connected points say from left to right, and parallelly draw a path w th the rule that if we encounter a new arch the path goes up one step, and if we encounter an arch already opened earlier, the path goes down one step. The area below the path is then decom posed into square \boxes", each of which corresponds to an action $w$ ith an operator $e_{i}$, whose index is the horizontal coordinate of the box, while the vertical coordinate orders the successive actions. For instance, the decom position ofF ig. 3 corresponds to acting w ith $e_{3} e_{2} e_{4} e_{6}$ on the fundam ental link pattem $m$ ade of 5 successive little arches. W ith this form ulation, it is easy to w rite down explicitly the antecedents
${ }^{0}$ \& of a given link pattem under the action of $e_{i}$. For these to exist, the D yck path for $m$ ust necessarily have a maxim um at horizontal position i. O ne obvious antecedent ${ }^{\infty}$ is obtained by rem oving the box $w$ ith this $m$ axim um. O thers $m$ ore subtle $m$ ay arise from adding a whole row of boxes. The im portant property here is that we $m$ ay order antecedents by strict inclusion. Indeed, the antecedent with the sm allest num ber of boxes is ${ }^{\infty}$, and is strictly contained in allothers. W em ay therefore express each new com ponent in a triangular way with respect to strict inclusion. A s an exam ple let us treat the case
$\mathrm{N}=6$, w th 5 link pattems, explicitly. W e label 1;2;3;4;5 the link pattems and their corresponding D yck paths

In the hom ogeneous lim it where all $z_{i}$ 's tend to 1 , we nd that for $N=2 n$, $Z^{(2 n)}(1 ; 1::: 1)$ is $3^{n(n ~}{ }^{1)}$ tim es the totalnum ber of $U$-sym m etric A SM 's of size ( 2 n ) ( 2 n ) discussed in Ref.[2̄2̄ $]$, itself identical to that of vertically symmetric ASM 's of size $(2 n+1) \quad(2 n+1)$.

## 4. C onclusion

In this paper, we have derived sum rules for the ground state vector of the inhom ogeneous crossing and non-crossing $O$ (1) loop $m$ odels on a sem i-in nite strip. A s opposed to the crossing case where the result is rigorous and proved com pletely, we have $m$ ade in the non-crossing case a reasonable but crucial assum ption on the degree of the ground state vector as a polynom ialof the inhom ogeneities $z_{i}$. The com pletion of the latter proofw ould presum ably involve invoking the algebraic Bethe A nsatz solution of the XXZ spin chain w ith open boundaries, in $m$ uch the sam e spirit as in Ref.tin]. W e have rather chosen here to concentrate on the various properties of this ground state vector, for which we gave an explicit step-by-step construction by acting on a fundam ental com ponent with local divided di erence operators, in order to generate all other entries of the vector. In this respect, it m ight be possible to unify both crossing and non-crossing cases by deriving a proofuniquely based on the $m$ ain relations induced by Eq.( $(\underline{1}-\overline{1} \overline{-})$, and that only involve the interplay between the sym $m$ etric group action on spectral param eters and the $R-m$ atrix of the integrable system. In order to do this, and by analogy with the crossing case, one should be able to check that the solution of the non-crossing case $[(3-1 . \overline{1}-\overline{6})$ actually satis es
allconstraints inherited from the com patibility of allequations ( $\left(\overline{3} \cdot \overline{7} \bar{T}_{1}\right)$, as w ell as the bound-
 approach, which assum es the value of the degree of $(\mathbb{N})$. This is a problem for future work. N ote nally that such a construction, both in the crossing and non-crossing cases, should be instrum ental in trying to prove variants of the so-called $R$ azum ov-Stroganov con jectures ${ }_{-1,1}^{1}$ 1.

O ur approach allows in particular to com pute the entries of the ground state vector in the hom ogeneous lim 五, where it $m$ ay be identi ed $w$ ith the ground state vector of the $H$ am iltonian of a suitable quantum chain, expressed as a particular weighted sum of generators of the $B$ rauer (resp. Tem perley- ieb) algebra for the crossing (resp. noncrossing) case, acting on crossing (resp. non-crossing) link pattems (see Refs.[1]-1] and [-3్1] for explicit expressions). A s an outcom e of our calculation, we show that these entries $m$ ay be picked to be non-negative integers, sum $m$ ing to speci $c$ numbers as given by $\left(\underline{2} .9 \bar{q}^{2}\right)-\left(2.9 \overline{3} \overline{3}^{1}\right)$ for strips of even/odd size in the crossing case, and to the total num ber of vertically sym $m$ etric altemating sign $m$ atrices $A_{v}(2 n+1)$ of $\left.\underline{\underline{2} \overline{2}} \overline{2}\right]$ for strips of even size $\mathrm{N}=2 \mathrm{n}$. It is im portant to note that, as opposed to the standard case where the entries of the hom ogeneous ground state vector are norm alized so that the sm allest one is 1 after division by their GCD (c.f. 1 , but form them selves a quite intriguing sequence $\left(\underline{2}-\overline{6} \overline{7}_{1}\right)$, as derived from the hom ogeneous lim it of the relation ( $\left.2.4 \overline{4} \overline{0}_{1}^{\prime}\right)$.

W hile the num bers $A_{V}(2 n+1)$ have been given extensive com binatorial interpretations, that of the num bers $\left(2-\overline{9} \overline{2}_{2}\right)-(\underline{2}-9 \overline{3})$ is still elusive. Such an interpretation was suggested in Ref. $[1 \overline{1} \overline{-1}]$ for the cylinder case, by noticing and con jecturing that som e entries of the hom ogeneous ground state vector of the crossing loop m odelw ith periodic boundaries actually $m$ atched degrees of varieties related to the com $m$ uting variety [1]9.1]. This
 state vector were interpreted as the $m$ ultidegrees of the com ponents of a $m$ atrix variety.
 som em atrix varieties, still to be found. In this respect, the partial sum rule $W$ (N) in the perm utation sector $(\overline{2} \overline{8} \overline{-} \overline{3})$ leading to the num bers $(\overline{2} . \overline{8} \overline{6})$ seem $s$ to indicate, like in the periodic case, that the corresponding com ponents of the (yet unknown) m atrix variety form a com plete intersection, whose $m$ ultidegree has the factorized form ( $\overline{2} . \overline{8} \overline{3})$. W e could also hope that the totalm ultidegree, as given by Eq. $\left(\overline{2} . \bar{B}_{-1} \bar{T}_{1}\right)$, $m$ ay be altematively obtained like in $[\underline{\underline{2}} \overline{2} \overline{1}]$ as the result of a lvolum e" $m$ atrix integral over the putative $m$ atrix variety.
