# A sym ptotic corrections to the eigenvalue density of the G U E and LU E

#### Abstract

W e obtain correction term $s$ to the large $N$ asym ptotic expansions of the eigenvalue density for the Gaussian unitary and Laguerre unitary ensem bles of random $N \quad N$ matrices, both in the bulk of the spectrum and near the spectral edge. This is achieved by using the well known orthogonal polynom ial expression for the kemel to construct a double contour integral representation for the density, to which we apply the saddle point $m$ ethod. The $m$ ain correction to the bulk density is oscillatory in $N$ and depends on the distribution function of the lim iting density, while the corrections to the A iry kemel at the soft edge are again expressed in term $s$ of the $A$ iry function and its rst derivative. W e dem onstrate num erically that these expansions are very accurate. A m atching is exhibited between the asym ptotic expansion of the bulk density, expanded about the edge, and the asym ptotic expansion of the edge density, expanded into the bulk.

## I. IN TRODUCTION

W e consider in this paper tw o classicalensem bles of random $m$ atrioes, the $G$ aussian unitary ensem ble (G UE), and the Laguerre unitary ensemble (LUE). T hese ensembles can be characterized by their joint eigenvalue probability density functions

The GUE consists of $N \quad N$ Herm itian matrioes $w$ ith independent norm ally distributed entries on and above the diagonal. It is the comerstone of random $m$ atrix theory ${ }^{1,2,3}$. The LUE has fundam entalapplications in $m$ athem atical statistics and quantum eld theory since it includes $W$ ishart $m$ atrices and the $C$ hiralG UE as special cases (the latter after a straightforw ard change of variables); see e.g. R efil.

W e are interested in the large N behavior of the m arginaleigenvahe probability density ${ }_{\mathrm{N}}(\mathrm{x})$, which we hereafter refer to sim ply as \the density", and which is de ned by

The function $N_{N}(x)$ can be interpreted as the num ber density of eigenvahes near the point $x$. W e also rem ark that for the GUE,N $N_{N}(x)$ is equal to the num ber density of a harm onically trapped system of either non-interacting ferm ions or im penetrable bosons ${ }^{4}$. There is a sim ilar interpretation for the LUE in term s of a C alogero-Sutherland
type $m$ ode ${ }^{5}$. For recent advances in asym ptotic questions related to these interpretations, com plem entary to the present study, see $R$ efs $6,7,8$

A s background to the present study we note that aspects of the large $N$ form of ${ }_{N}(x)$ rst arose in studies of eld theories related to $H$ erm itian $m$ atrix $m$ odels ${ }^{9}$. There, for the G UE the large $N$ asym ptotic expansion of the $m$ om ents

w as sort. By a graphical expansion of the $m$ atrix integral, involving cataloging the corresponding $m$ aps according to their genus, it w as predicted that for certain coe cients a ${ }_{2 j}(\mathrm{p})$,

(the odd $m$ om ents of course vanish). A nalogous considerations in the case of the LU $\mathrm{E}^{10}$ show that

for certain coe cients $\mathrm{a}_{\mathrm{j}}(\mathrm{p} ;)$. O bserve in particular that (5) contains only even inverse powers in N , while (6) contains both even and odd inverse pow ers in N .

The graphicalm ethods allow $a_{0}(p)$ in (5) and $a_{0}(p ;)$ in (6) to be com puted in term $s$ of binom ial coe cients for all $p=0 ; 1 ;:::$. This know ledge in tum can used (see e.g. ${ }^{1}$ ) to prove that in the lim it $N!1$ and with $x$ xed

The rst functional form in (7) is referred to as the $W$ igner sem i-circle law, while the second is som etim es nam ed after $M$ aroenko-P astur. See e.g. Refs $1,2,3$.

The expansions (5) and (6) provide a $m$ otivation to undertake a study of the asym ptotic form of (4). In the case of the GUE such a result has been given by $K$ alish and Braak ${ }^{11}$. It states that for $\dot{x} j<1$ and $x e d$

$T$ hus one sees that unlike the situation $w$ ith the $m$ om ents [5), the leading correction term is $O(1=N)$. O f course this term is oscillatory so one $m$ ight anticipate that after integration it contributes at a higher order. H ow ever inspection of (8) reveals that the situation is m ore com plex: the oscillatory term is not integrable at the endpoints of the support $\dot{x} j=1$. Indeed, it is well known that $w$ ith the boundary of the eigenvalue support taken as the origin, a scaling regim e distinct from that of the bulk becom es relevant. Explicitly, with A $i(x)$ denoting the $A$ iry function, it has been proved that ${ }^{12}$

where is xed. In view of the breakdown of (8) in the vicinity of the spectrum edge, (referred to as the soft edge, since although it de nes the edge of the support of $(x)$, for any nite $N$ there is a nonzero probability of nding eigenvalues lying beyond it), we are thus led to also investigate the large $N$ asym ptotic expansion extending the lim it law (9).

At a technical level, the $m$ ain achievem ent of this paper is the derivation of the rst correction term $s$ to the lim it laws (7) and (9). We do this by utilizing the well known orthogonal polynom ial expression for ${ }_{\mathrm{N}}$ ( x ) to obtain a double integral representation which is am enable to the saddle point $m$ ethod. In the bulk, i.e. in the interior of the support of (x), we show that the asym ptotic series progresses in powers of $1=\mathrm{N}$, and we obtain the explicit form of the $1=\mathrm{N}$ correction. We nd for the LUE that the coe cient of the $1=\mathrm{N}$ term consists of a com ponent which is oscillatory in $N$ as well a com ponent which is non-oscillatory in $N$, whereas for the GUE it consists of only an oscillatory com ponent, as shown in (8). For the soft edge we w ill see that the asym ptotic series progresses in pow ers of $N^{1=3}$, and we obtain explicit expressions for the coe cients of the $N \quad{ }^{1=3}$ and $N^{2=3}$ term $S$, which again involve A iry functions.

D ue to the sim ilarity in the structure of ${ }_{N}(x)$ for the GUE and LUE, it is convenient to consider both cases sim ultaneously to avoid unnecessary repetition, and so at each step of our presentation we discuss the G UE and LUE in parallel. In Section $\square$ we discuss the double contour integral expression for $\mathrm{N}(\mathrm{x})$ to which we shall apply the saddle point $m$ ethod. Section III contains our discussion of the asym ptotics of $\mathrm{N}(\mathrm{x}$ ) in the bulk while Section IV) discusses the soft edge. In Section $\nabla$ we discuss the extent to which our expansions in the bulk $m$ atch up w ith those for the soft edge.

## II. CONTOUR INTEGRALEXPRESSION FOR $\quad$ N ( X )

For the unitary ensem bles there is a well known and very neat expression for ${ }_{\mathrm{N}}(\mathrm{x}$ ) in term s of orthogonal polynom ials, valid for any $N$ and $x 2$. If we let $f{ }_{j}(x) g_{j=0}^{1}$ denote the $m$ onic polynom ials orthogonalw ith respect to $!_{N}(x)$ on , then

Thenorm in the denom inator of (10) is just the $L^{2}$ norm associated $w i t h!_{N}(x)$ and. For a derivation of (10) the reader is referred to $R$ efs. $1,2,3$. W e rem ark at this point that there is no universally agreed scale by which the GUE and LUE are de ned. To $m$ atch our choice of scale and notation in (2) to that em ployed in Refi for instance, we observe that

where $P_{N}(x ; y)$ (not to be confused with our de nition (1) above) is the kemel de ned in Chapter 4 of $R$ efil (the kemel is often also denoted $\mathrm{K}_{\mathrm{N}}(\mathrm{x} ; \mathrm{y})$ in the literature).

To investigate the large N behavior of $\mathrm{N}(\mathrm{x})$ it is obviously advantageous to start w th the expression (10) rather than with the $\left(\mathbb{N}\right.$ 1)-fold integral (4). The $N+j_{1}(x)$ can be expressed in term $s$ of the standard $H$ erm ite and Laguerre polynom ials found in Szego's classic book ${ }^{13}$ as follow S

The required asym ptotic expansions of the scaled $H$ erm ite and Laguerre polynom ials appearing in (11) are known to any order both in the bulk and near the soft edge ${ }^{14,15}$, and such asym ptotic expansions of scaled orthogonal polynom ials are now generically said to be ofP lancherelR otach type ( $P$ lanchereland $R$ otach were the rst to com pute such asym ptotics for the $H$ em ite polynom ials). It is reasonable to assum $e$ that the $m$ ost straightforw ard procedure to obtain the desired asym ptotic corrections for N ( x ) in each region of interest is to sim ply insert the corresponding asym ptotic expansion for $\mathrm{N}+\mathrm{j}_{1}(\mathrm{x})$ into (10). W hile this is certainly legitim ate in principle, and does indeed recover the leading tem fairly easily, to derive the correction term s it tums out that such a procedure is rather tedious, and provides little if any insight into the resulting expressions. The source of the com plication is that the asym ptotic expansions for $N+j 1(x)$ contain a large am ount of super uous inform ation which is canceled when the expansions are substituted into [10. To avoid this, we shall pursue a related, but m ore direct route.
$T$ he $P$ lancherelR otach asym ptotics for the $H$ em ite and Laguerre polynom ials were originally derived by rst expressing the polynom ials in tem s of contour integrals, and then applying the saddle point $m$ ethod. By suitably
m assaging the standard results in Szego's book ${ }^{13}$ one nds that

In both cases the contour of integration is a closed positively oriented contour which encircles the origin; in the Laguerre case we further dem and that it not contain the point $z=2$.

Instead of applying the saddle point $m$ ethod to (12) and then substituting the expansions into (10), we shall rst insert the contour integrals (12) into (10) to obtain a double integral expression for ${ }_{N}(x)$, and then perform the saddle point $m$ ethod on this double integral. To highlight the sim ilarity between the GUE and LUE it is convenient in the GUE case to substitute the contour integral for $N+j 1(x)$ into (10) rather than that for $N+j 1(x)$; since $H_{j}(x)=(1)^{j} H_{j}(x)$ this ruse is perfectly harm less. $T$ his results in

The rem ainder of this paper $w$ ill involve a careful asym ptotic analysis of the double integral (15).
B efore proceeding we note that it is straightforw ard to show, using standard results in the orthogonal polynom ial literature ${ }^{13}$, that

Before applying the saddle point $m$ ethod to (15) we need to identify and classify the saddle points of (16). The functions $S(z ; x)$ in general have two saddle points at $z=z \quad$ where

the saddle points $z=z$ are both simple when $\dot{x} j<1$, i.e. $S^{\infty}(z ; x) 0$. However, when $x=1$ the two simple saddle points given in (22) coalesce to $z=1$ and $S^{\infty}(z ; 1)$ vanishes, so we obtain one double saddle point in this case. Thus we already see why the regions $\dot{x} j<1$ and $x \quad 1$ have qualitatively distinct asym ptotic behavior. Sim ple saddle points generically produce $G$ aussian integrals w hereas double saddle points generically produce A iry functions (see e.g. ${ }^{16}$ ).
III. BULK ASYMPTOTICSFOR THE GUEAND LUE

In the bulk of the spectrum, i.e. for $j \mathrm{j} j<1$, we hold x xed and investigate the asym ptotics of (15) as N becom es large. From (22) we see that there are two distinct simple saddle points of $S(z ; x)$, which form a com plex con jugate pair in this case. Let's de ne $S=S(z ; x)$. Then since

both saddle points contribute to the sam e order and we deform our contour through both of them. D enoting by a contour passing through $z$ along a path of steepest descent, the standard argum ents of the saddle point $m$ ethod (see for e.g. Ref. ${ }^{16}$ ) yield

W e now need to param eterize the contours. From (25) we see that if we set

$H$ ere $x_{0}$ is the left edge of the support of ( x ) given in (7), i.e. $\mathrm{x}_{0}=0 ; 1$, fror the LUE and GUE respectively. $W$ e note that $P(x)$ is the probability distribution function corresponding to $(x)$. The lim iting distribution function $P(x) w$ ill play a signi cant role in the bulk asym ptotic expansion of ${ }_{N}(x)$.

Henc, substituting (47) into (46) one can construct the asym ptotic series for ${ }_{\mathrm{N}}(\mathrm{x}$ ) out to any desired order. W e shall explicitly construct this series out to order $1=\mathrm{N}$ but the generalization to higher orders is obvious. H ow ever, as we shall see the resulting asym ptotic expansions obtained by keeping only the $1=\mathrm{N}$ correction are already extrem ely good, and it's quite likely that optim al truncation occurs at this order, providing little incentive to construct higher order corrections.

A s rem arked in the Introduction, the result (51) w as obtained previously in ${ }^{11}$ again by steepest descent, but starting from an integral representation derived by super-sym $m$ etric argum ents rather than orthogonalpolynom ials.

It is interesting to note that it is the distribution function $P(x)$ of the lim iting density ( $x$ ) which controls the large N oscillations in the $1=\mathrm{N}$ correction to $\mathrm{N}(\mathrm{x})$. N ote also that while the non-oscillatory correction vanishes at order $1=\mathrm{N}$ for the GUE leaving only an oscillatory correction at this order, the LUE has both an oscillatory and a non-oscillatory com ponent to its $1=\mathrm{N}$ correction.

To dem onstrate to the reader just how accurate the expansions given by Proposition 1 are we provide in $F$ igures 1 and 2 a num erical com parison of the asym ptotic expansions $w$ ith the exact results com puted using the expression (10) in term $s$ of orthogonalpolynom ials.

IV. SOFT EDGEASYMPTOTICSFOR THE GUE AND LUE

The reader $m$ ight be concemed by the slightly unorthodox term in the exponent proportional to $N^{1=3}$, how ever it is subdom inant to the $N S(z)$ term and its presence does not a ect any of the usual argum ents of the saddle point $m$ ethod; the asym ptotic behavior of (55) is determ ined by $S(z)$. From (22), (23) and (25) we see for both the GUE and LUE that $S(z)$ has one double saddle point, located at $z=1 . W$ e can deform the contour of integration to $a$ new contour which passes through $z=1$ along paths of steepest descent. $N$ ote that although in (12) the integrals $m$ ust be positively oriented, since we have two integrals in (55) we are free to orient the integrals in the negative direction since the consequent $m$ inus signs cancel. Let us denote by $C$ the contour consisting of the union of tw o rays of unit length, the rst starting at $z=e^{i=3} 1$ and ending at $z=1$ and the second starting at $z=1$ and ending at $z=e^{i=3}$ 1. If we then denote by $A$ any suitable arc such that $C$ [ $A$ is a sim ple closed curve enclosing the origin we can write

W ith such a choige for A one can obtain the required bounds by a straightforw ard generalization of the usual argum ent used in the saddle point $m$ ethod. For a carefuldiscussion of the saddle point $m$ ethod suitable for this purpose see for exam ple Section 2.5 of Refi ${ }^{16}$. W e note that $R$ ef ${ }^{16}$ refers to the saddle point $m$ ethod as $P$ erron's $m$ ethod.

In (66) w e have presented only term $\mathrm{sO}(1=\mathrm{N})$ in the rst factor since this is $w$ illibe su cient for our purposes in what follow s . H igher order term s are easily retained if desired.

O urwork is now essentially done. O ne expands $F(; t)$ around $t=0$ for xed as in 47) and then sets $i=b N t_{i}^{3}=3$, analogous to the bulk case. A gain, after integration, each value of $j$ in the $M$ aclaurin expansion (47) contributes to the sam e order in N . To see this explicitly we can use the follow ing lem m a.

W e have explicitly displayed term $\mathrm{s} \circ(1=\mathrm{N})$ here, but it straightforw ard to retain as $m$ any term $s$ as desired. The expansion constructed from term $s \circ(1=\mathrm{N})$ how ever is extrem ely accurate, as we dem onstrate in $F$ igures 3 and 4, and it appears to be the num erically optim al order at which to truncate the expansions.

The explicit form $s$ for the coe cients $\mathrm{c}_{\mathrm{m}}$ ( ) can be constructed from (70) and substituted into 71). W e can also further sim plify the A iry derivatives appearing in (68) using the A iry di erential equation $A i^{\infty}()=A$ i( ) so that only Ai( ) and its rst derivative appear. Figures 3 and 4 provide a num erical com parison of the asym ptotic expansions given in P roposition 2 w ith the exact results com puted using the expression (10) in tem s of orthogonalpolynom ials.
$N$ ote that it appears that the GUE converges m uch faster than the LUE, since while the two curves in (3) are alm ost indistinguishable at $N=10$ for the $G U E$, the asym ptotic expansion for the LUE begins to diverge from the exact result in (4) already by 2 , and both curves are rather di erent from the lim iting A iry kemelexpression (9) . $W$ e investigated the a ects of retaining $m$ ore term $s$ in the expansion for the LUE case; keeping term $S(1=N)$ did not notioeably change the plots, while keeping term shigher than $1=\mathrm{N}$ caused signi cant divergence of the asym ptotic expansion from the exact result. The explanation for this is $m$ ost likely that, as $m$ ade precise in the next section, the edge expansions $m$ atch onto the bulk expansions, and these in turn becom em ore divergent near the edge at each order in $1=\mathrm{N}$.

## V. MATCHINGOFTHEBULKANDEDGEEXPANSIONS

In F igures 14 plots of the bulk and edge asym ptotic expansions have separately been com pared against the exact density for $N=10$. A though the scale of the independent variable is di erent, we can see from $F$ igures 3 and 4 that the edge asym ptotic expansions are accurate approxim ations to the exact density up to the neighborhood of the rst localm axim um (relative to the edge $=0$ ) at least and thus should be used instead of the bulk asym ptotic expansion in this region.

At a quantitative level, it is possible to exhibit a m atching betw een the various asym ptotic expansions. Suppose in (51) we set $x=1+=2 N^{2=3}$, and in (52) we set $x=1+=(2 N)^{2=3}$, and take $<0$ and xed. Expanding the right hand sides as an asym ptotic series in N gives

where the symbol : denotes that the asym ptotic series have been expanded as speci ed. An im portant feature is that this procedure $m$ ixes the term $s$ which are at di erent orders in $N$ in 51) and (52).

Let us now compute the ! 1 asym ptotic expansions of the right hand sides of the rst two term $s$ in each of (72) and (73), multiplied by 2. U sing the fact that for x ! 1 (see e.g. ${ }^{17}$ )

we obtain expansions which reproduce the N -independent term s in 74) and 75), giving furtherm ore, term s of higher order in $1=j$. In (75) the term proportional to $1=(2 \mathrm{~N})^{1=3}$ is reproduced, and this too is accom panied by term s of higher order in $1=j j$. In (74) the term $j j^{3=2}=4 N^{2=3}$ is reproduced, while the other term sproportional to $1=N^{2=3}$ are out by rational factors. T he explanation for the $m$ issing higher order term $s$ in $1=j j$ and incorrect rational factors is $m$ ost likely due to the fact that term $s$ of all orders in $1=\mathrm{N}$ in (51) and (52) contribute to each distinct order in the expansions (74) and (75). Speci cally, from the results exhibited above, it would seem that expanding the com plete large $N$ asym ptotic series for $\underset{N}{G U E}(x)$ and ${\underset{N}{N E}}^{\mathrm{LUE}}(\mathrm{x})$ as in (74) and 75) would give precisely the large ! 1 expansion of (72) and (73), extended to all orders in $N$.
