# Solutions of the Gaudin Equation and Gaudin A lgebras

#### A bstract

Three well-known solutions of the G audin equation are obtained under a set of standard assumptions. By relaxing one of these assumptions we introduce a class of mutually commuting H am iltonians based on a dierent solution of the G audin equation. Application of the algebraic Bethe ansatz technique to diagonalize these H am iltonians reveals a new in nite dimensional complex Lie algebra.

## 1 Introduction

The Bardeen-Cooper-Schrie er (BCS) pairing model Ham iltonian was diagonalized by Richardson in 1963 in an algebraic way [1]. The step operators introduced in Richardson's solution belong to an in nite dimensional complex Lie algebra which is usually referred to as the rational Gaudin algebra. It is one of the three algebras which emerged from Gaudin's work during the 1970's [2] who introduced a new class of integrable models starting with the following operators:

where  $w_{ij}$  are complex numbers to be determined and  $t_i$  are the generators of N , mutually commuting SU (2) algebras. The latter obey the standard SU (2) commutation relations:

where  $t_i$   $t_i^1$   $it_i^2$ . Gaudin showed that the operators in (1) mutually commute

if and only if the coe cients satisfy the equations:

for all distinct triples (i; j;k) and for all permutations of the upper indices (0;1;2). There are three solutions to equation (4) under the following assum ptions: i) The coe cients w  $_{ij}$  are antisym metric under the exchange of the indices i and j

ii) each coe cient w  $_{ij}$  can be expressed as a function of the di erence between two real parameters  $u_i$  and  $u_j$ , and iii) each  $h_i$  commutes with the operator  $T = \int_{j} t_{j}^{0}$  so that the z component of the total SU (2) is conserved. G audin's solutions are given as follows:

which are commonly referred to as rational, trigonometric and hyperbolic solutions, respectively. Here, p is a real parameter  $^1$ .

The operator which is obtained by substituting the rational solution into (1) is called rational G audin magnet H am iltonian:

Sim ilarly, substituting the trigonom etric and hyperbolic solutions into (1) we obtain

which are called trigonom etric and hyperbolic G audin magnet Hamiltonians, respectively.

Application of the algebraic Bethe ansatz method to the Gaudin magnets yields the rational, trigonometric and hyperbolic Gaudin algebras [3, 4]. These are in nited in ensional complex Lie algebras which are related to particular solutions of the classical Yang-Baxter equation [5]. As a result, each

 $<sup>^1</sup>$ These solutions are not completely unrelated. G audin equation (4) is satis ed for all complex values of p. But only for the real and pure in aginary values of p H am iltonians in (1) are H erm itian. On the other hand, substituting ip in place of p, one can convert trigonom etric and hyperbolic solutions into each other. For this reason, we restrict ourselves with the real values of p. A lso note that in the lim it p! 0 trigonom etric and hyperbolic solutions go to the rational solution.

algebra adm its a one-param eter fam ily of mutually com muting H am iltonians H (). Here is a complex param eter which is usually referred to as the spectral param eter. These operators may be identied as the integrals of motion of a quantum system as well as the traces of transfer matrices of a vertex model. Main objective in both cases is to diagonalize them simultaneously and this is achieved by either functional or algebraic Bethe ansatz techniques [6]. Richardson-Gaudin methods have recently found many applications in quantum many-body physics [7].

## 2 Further Solutions of the Gaudin Equation

In this paper we investigate a di erent solution of the G audin equation (4). U nder the three assum ptions listed in the introduction, all possible solutions are enum erated above. To nd new solutions we need to relax one or more of these assum ptions. We keep the constraints (ii) and (iii) but generalize the constraint (i) to

where q is a real param eter<sup>2</sup>. This solution is given by

The operators which are obtained by substituting this new solution in (1) will be denoted by  $h_i^{(q)}$ :

Since (13) is a solution of G audin equation (4), these operators mutually commute:

In the  $\lim i q!$  0, the new solution given by (13) approaches Gaudin's rational solution (6). As a result,

The solution presented here is a di erent solution of G audin equation and the H am iltonians given by (14) for  $q \in 0$  cannot be obtained from the rational, trigonom etric or hyperbolic G audin m agnet H am iltonians. To see that, let us assum e for a m om ent that there exists an operator S such that

where  $h_i^{()}$  represents any one of the H am iltonians given in equations (9)-(11). Suppose we take the sum of both sides of (17):

for rational, trigonom etric and hyperbolic magnet Ham iltonians. Hence the sum on the left hand side is equal to zero. On the other hand, the sum on the right hand side of (18) is not equal to zero. Instead the new condition given in (12) implies

i.e. an operator S satisfying (17) does not exist for  $q \in 0$ .

# 3 Gaudin Algebras

If one applies the algebraic Bethe ansatz technique to diagonalize the G audin magnet H am iltonians which correspond to the solutions (6), (7), or (8), one uses the step operators belonging to the rational, trigonom etric or hyperbolic G audin algebras, respectively. Below we will show that if the algebraic Bethe ansatz method is employed to diagonalize the H am iltonian of (14), then a dierent algebra emerges in a completely analogous way. Before introducing this algebra, however, we would like to outline the basic features of rational G audin algebra and its relation to the rational G audin magnet

H am iltonian, as an illustration of the technique. Trigonom etric and hyperbolic G audin algebras and their relation to the trigonom etric and hyperbolic G audin m agnet H am iltonians follow very sim ilar lines.

Rational Gaudin algebra is generated by three families of operators  $J^+$  ( );  $J^-$  ( ) and  $J^0$  ( ) param eterized by a complex number . Commutators are given by

Commutators of  $J^+$  ();  $J^-$  () and  $J^0$  () at the same value of the complex parameter are given by taking the lim it  $\,!\,$ . From these commutation relations it is easy to show that

Starting from a lowest weight vector and using  $J^+$  ( ) as step operators, one can diagonalize these operators simultaneously. Lowest weight vector j0 > by de nition satis es

(For an analytic solution of these equations see e.g. References [8] and [9]). The corresponding eigenvalues will be

There exists a realization of the rational G audin algebra in terms of the SU (2) generators of (2), given by

Here  $u_1;u_2;\dots;u_N$  are arbitrary real numbers which are all dierent from each other and N is a nonnegative integer<sup>3</sup>. A ssum ing that the eigenvalues of the C asim ir operator of the  $j^{th}$  SU (2) are  $s_j(s_j+1)$ , the corresponding W ( ) is given by

We see that H () has simple poles on the real axis. Residues of H () at the points  $= u_i$  are proportional to the rational G audin m agnet H am iltonians given in (9):

As a result, rational G audin m agnet H am iltonians  $h_i^{(r)}$  are automatically diagonalized together with H (). It is easy to read o the eigenvalues of the rational G audin magnet H am iltonians from the eigenvalues of H () as follows:

Here  $\mathfrak{I}>$  is the lowest weight state and are the solutions of the Bethe ansatz equation (28).

We next search for an operator H  $^{(q)}$  ( ), the residue of which gives us the operators  $h_i^{\ (q)}$  (cf. Equation (33)). We wish to write such an operator using an algebra similar to that in (21). Below we show that such an algebra exists and its generators  $J_q^0$  ( ),  $J_q^+$  ( ) and  $J_q$  ( ) satisfy the commutation relations given as

We observe that, in the limit q! 0, commutators in (39) approach the commutators of G audin algebra given by (21). It should nevertheless be emphasized that the algebra of (39) is not a q-deformed algebra, but an ordinary Lie algebra. We can show that

This algebra adm its two realizations in terms of the SU (2) generators of (2). These are given by

In the  $\lim it q!$  0, the rst realization goes to the realization of the rational G audin algebra given by (30) whereas the second realization vanishes.

In the rst realization, Equation (47), the operator  $H^{(q)}$  () becomes

As a result, the operators  $h_i^{(q)}$  are autom atically diagonalized together with H  $^{(q)}$  ( ). As in the case of the rational G audin algebra, one can read o the eigenvalues of  $h_i^{(q)}$  from the eigenvalues of H  $^{(q)}$  ( ):

Details of the derivation of these eigenvalues are given in the Appendix.

## 4 Linear r-M atrix Structure

The rational, trigonom etric and hyperbolic G audin algebras have a linear r-m atrix structure. This means that one can write down the commutators of these algebras in the following matrix form:

where I is the 2 2 identity matrix, r( ) is the r-matrix described below and L() is given by

 $J^0$  ( ); $J^+$  ( ) and  $J^-$  ( ) are generators of the rational, trigonom etric or hyperbolic G audin algebras. In (56), the term [L ( ) I;I L ( )] is equal to a 4 4 m atrix whose elements are various commutators between the generators  $J^0$  ( ); $J^+$  ( ) and  $J^-$  ( ). On the other hand r ( ) is a M at 2 (C) M at 2 (C) m atrix valued function of which carries the information about the structure constants of the algebra. For instance, for the rational G audin algebra, the r-m atrix is given by

where P is the permutation matrix on  $C^2$   $C^2$ , which is equal to

where a; b are 2  $\,$  2 m atrices and I is the 2  $\,$  2 identity m atrix. Then  $r^{ij}$  are de ned as follows:

Since r-m atrix carries inform ation about the structure constants of the algebra, Jacobi identity leads to the equality

which is the well known classical Y ang-B axter equation (for solutions of this equation see [10], for a review see [11], [12]). Equation (64) guarantees the mutual commutativity of the operators H () which can now be written as

Trigonom etric and hyperbolic G audin algebras also have the r-m atrix structure described above and their r-m atrices are also solutions of the classical Yang-Baxter equation.

In order to see if one can repeat the same procedure for the algebra we introduced in (39), we study a matrix of the form

assum ing the existence of such an r-m atrix. One can compute the left-hand side of this equation and then set all the components equal to zero to nd the components  $r^{ij}$  of this r-m atrix. For instance, the (21) and (13) elements are equal to

and

respectively. Setting these elements equal to zero requires setting the coecients of all the algebra elements equal to zero. The coecient of J  $_{\rm q}$  ( ) in the rst equation and the coecient of J  $_{\rm q}^+$  ( ) in the second equation gives

respectively. But these equations are incompatible unless q=0. Repeating the same calculations for the other components, one can conclude that there is no r-m atrix which satisfies (67). Instead of the  $L_q$ () matrix in (66), one may try to indicate a more general form of  $L_q$ () matrix for which an r-matrix can be found to satisfy (67). But we were unable to indicate an  $L_q$ () matrix  $^4$ . On the other hand we were able to show that one can write the commutators of the algebra introduced in (39) in the following form:

Here  $L_q$  ( ) is given by (66) and the  $r_q$ -m atrix is given by

P is the permutation matrix introduced in (59). As in the case of the r-m atrices of rational, trigonometric and hyperbolic G audin algebras, the  $r_q$ -m atrix carries information about the structure constants of the algebra of (39).  $r_q^{ij}$  matrices, defined by similar maps as in Equations (60)-(63), satisfy the following equation:

We see that the r-m atrix structure of the algebra introduced in (39) is not the same as the r-m atrix structures of the rational, trigonom etric and hyperbolic G audin algebras. Nevertheless, it shares with the other three algebras, the crucial property of adm itting a one-parameter family of mutually commuting operators H  $^{\rm (q)}$ (). Similar to (65), one can write this operator as the trace of the square of Lq ():

Note that in the limit q! 0, the algebra of (39) approaches the rational Gaudin algebra. In this limit both  $r_q$  and  $r_q$  go to the r-matrix of the rational Gaudin algebra given in (58) and from (71) we recover the classical Yang-Baxter equation (64).

 $Tr[L_q()]L_q^{\gamma}()]$  is proportional to H  $^{(q)}()$  when  $^2=^2+^2$ . However, one can similarly show that there is no solution to (67) for this  $L_q()$  either.

## 5 Conclusion

In this article, by relaxing one of the conditions imposed by Gaudin, we presented a dierent solution to the Gaudin equation and wrote down the corresponding set of mutually commuting Hamiltonians. We also identified the related in nite dimensional Lie algebra. This algebra allows a one parameter family of mutually commuting Hamiltonians H (q) () parameterized by a complex spectral parameter. We diagonalized these Hamiltonians using the algebraic Bethe ansatzmethod and constructed the eigenvectors and eigenvalues. The procedure is parallel to the other known Gaudin algebras.

A di erent generalization of the G audin algebras was recently introduced in Ref.[13] that is based on the rational, trigonom etric, and hyperbolic solutions of the G audin equations. Our generalization is based on a di erent solution of the G audin equation obtained under di erent assum ptions.

## Appendix: Computation of the Eigenvalues

To see that the lowest weight state given by (42) is an eigenstate of H  $^{(q)}$  ( ) we rst use the commutators (39) to write H  $^{(q)}$  ( ) in the following form:

$$H^{(q)}() = J^{0}()J^{0}() + J^{+}()J^{-}() + \frac{1}{2}[J^{-}();J^{+}()]$$

$$= J^{0}()J^{0}() + J^{+}()J^{-}()$$

$$= \frac{1}{2}\lim_{t \to 0} 2q \frac{J^{0}() J^{0}()}{\tanh[q(-)]} + J^{0}() + J^{0}()$$

Then the action of H  $^{(q)}$  ( ) on the lowest weight state is

$$H^{(q)}()j0> = W()^2 W^0() 2qW()j0> : (74)$$

We see that the lowest weight state is an eigenstate of H  $^{(q)}$  ( ) with the eigenvalue E  $_0$  ( ) given by (43).

Now consider the state  $j >= J^+$  ( )  $\mathfrak{J} > .$  A ction of H  $^{(q)}$  ( ) on  $J^+$  ( )  $\mathfrak{J} >$  is

$$H^{(q)}()J^{+}()\dot{\mathcal{D}} > = 2q (coth [q()] 1)W()\dot{\mathcal{J}}()\dot{\mathcal{D}} > (75 + (E_{0}()) 2qW() coth [q()] + 2qW())J^{+}()\dot{\mathcal{D}} > :$$

We see that H  $^{(q)}$  ( )J  $^+$  ( ) $\mathfrak{D}$  > is a superposition of the states J  $^+$  ( ) $\mathfrak{D}$  > and J  $^+$  ( ) $\mathfrak{D}$  > . Therefore, for a generic , the vector J  $^+$  ( ) $\mathfrak{D}$  > is not an eigenstate of H  $^{(q)}$  ( ). But if is a root of the W ( ) then the coe cient of J  $^+$  ( ) $\mathfrak{D}$  > vanishes. In this case J  $^+$  ( ) $\mathfrak{D}$  > is an eigenstate of H  $^{(q)}$  ( ) with the eigenvalue E  $_1$  ( ) given by

$$E_1^{(q)}() = E_0() 2 (q \infty th [q()] q) W ():$$

This is the energy one nds by substituting n=1 and W ( ) = 0 in Eqn. (46).

For n > 1, action of  $H^{(q)}()$  on the state  $J^{+}(_{1})J^{+}(_{2}):::J^{+}(_{n})J^{0}>$  is given by

Coe cients of the states  $J^+(_1):::J^+(_n)_D^+>0$  vanish when the conditions (45) are satisfied. Consequently,  $J^+(_1)J^+(_2):::J^+(_n)_D^+>0$  become an eigenstate of  $H^{(q)}(_1)$  and its eigenvalue is given by (46).
