On the Hamiltonian formulation of Yang {Mills gauge theories

A bstract

1 Introduction

In some of our recent works [1, 2, 3] a new geom etrical fram ework for Yang {M ills eld theories and General Relativity in the tetrad {a ne formulation has been developed.

The construction of the new geom etrical setting started from the observation that even though the Lagrangian densities of the above theories are de ned over the

rst jet{bundle of the con guration space, they only depend of the antisym m etric com bination of eld derivatives in the space{tim e indexes. As for the Yang{M ills case, this is the reason for the singularity in the Lagrangian.

The idea consists is considering a suitable quotient of the stjet{bundle, making two sections equivalent when they possess a storder contact with respect to the exterior covariant di erentiation, instead of the whole set of derivatives. The ber coordinates of the resulting quotient bundle are the antisymmetric combinations of the eld derivatives that appear in the Lagrangian. The geometry of the new space has been widely studied, in order to build as many usual geometric structures of the jet{bundle theory as possible, such as contact form s, jet{prolongations of sections, morphism s and vector elds. These are the geometric tools that are needed to implement variational problems in the Poincare{Cartan form alism. Moreover, particular choices for the ber coordinates have been shown to be possible: they consist in the components of the strength tensor for Yang{M ills theories and in the torsion and curvature tensors for G eneral R elativity.

This resulted into the elimination of som e un {physical degrees of freedom from the theory (represented by un-necessary jet{coordinates) and to even obtain a regular Lagrangian theory in the case of Yang{M ills elds.

This last consideration was the thrust that moved us to write the present work: the presence of a regular Lagrangian allows us to write a Ham iltonian version of the theory proposed in [1, 2]. The advantages arising from the present approach, with respect to the already existing form ulations, based on singular Lagrangians (com pare, for example, with [4, 5]), are striking. In fact, the singularity of the Lagrangian is the source of known drawbacks: the equations are de ned on a constraint sub{manifold, there exist multiple Ham itonian forms associated with the same Lagrangian and the equivalence between Euler{Lagrange and Ham ilton equations is not a direct consequence of Legendre transform any more.

On the contrary, the situation in the new geometrical framework is simpler and more elegant: the \Lagrangian" space and the phase{space have the same dimension and the Legendre transform is a (local) dieomorphism. This ensures the direct equivalence of Lagrangian and Ham iltonian formulations, both in the Ham ilton{De Donder (section 3) and in the Multimomentum Ham iltonian approach (section 4).

F inally, we devoted the last section to study the peculiar (3+3) Yang [M ills theory. Starting from the work made in [7, 8], we showed that a coordinate transform ation in the phase space, together with the Poincare [C artan approach in our new form alism, allows to describe a (3+3) Yang [M ills theory by means of E instein { C artan like equations in 3 dimensions. In particular, in the case of a free (3+3)Yang [M ills eld the geometrical construction gives rise to a sort of rst order purely fram e form ulation of a G eneral R elativity like theory.

This result is interesting for its further developments: in fact we will show in a subsequent work that an analogous geom etrical machinery may be applied to build a rst{order purely fram e{form ulation of General Relativity in four dimensions [10].

2 The geom etrical fram ew ork

The present section is devoted to revising the geom etrical structure that has been introduced in [1, 2] to describe Y ang {M ills theories.

Let : P ! M be a principal ber bundle, with structural group G and let

The space of principal connections on P is identied with the quotient bundle $E := J_1(P) = G$ with respect to the (jet-prolongation of) the right action R_h of the structural group on P. If V (g;h) represents the dimensional of the right multiplication R_h in g 2 G, a set of local coordinates in the quotient space is provided by x; $a_i = g_i V$ (g;g¹), subject to the following transform ation laws:

where Ad and W denote respectively the adjoint representation of G and the dimensional of the left multiplication in G, while $:U \quad M \quad ! \quad G \quad (U \text{ open set})$ is an arbitrary smooth map.

As a consequence, the bundle $E \ ! M$ has the nature of an a ne bundle, whose sections represent principal connections over $P \ ! M$. In fact, every section $! :M \ ! J_1(P) = G$ yields a connection 1-form on P, locally described as:

where \underline{e} (= 1;:::;r) indicate a basis of the Lie algebra g of G.

Finally, let ^ : J₁ (E) ! E be the rst jet {bundle associated with the bundle E ! M, described by the set of local coordinates $x^i;a_i;a_{ij}' = \frac{\partial a_i}{\partial x^j}$.

In order to provide a better geom etrical fram ework to describe Yang-M ills gauge theories, the following equivalence relation is introduced in $J_1 (E)$: let $!_1 = (x; a_i; a_{ij}); !_2 = (x; a_i; a_{ij}) 2 J_1 (E)$ be such that $(!_1) = (!_2)$, then:

This means that two sections are declared equivalent if their skew {symmetric derivatives are equal. In more geometric terms, being every section of the bundle E ! M represented by a connection 1 {form, the rst jet{bundle has been constructed assuming that the equivalence between sections having a rst{order contact is evaluated through the exterior di erentiation (or, equivalently, the covariant exterior di erentiation), instead of the whole set of partial derivatives.

Let $J(E) \coloneqq J_1(E) =$ denote the quotient bundle with respect to the above de ned equivalence relation and $:J_1(E) ! J(E)$ the canonical (quotient) projection. This new ly de ned geom etrical fram ework is endowed with the most common features provided by a standard jet {bundle structure.

J -extension of sections. Given a section : M ! E its J -extension is de ned as J := J : M ! J (E), namely projecting the standard jet{prolongation to J (E) by means of the quotient map. Conversely, every section s : M ! J (E) will be said to be holonom ic if there exists a section : M ! E such that s = J.

Contact form s. Let us de ne the following 2-form s on J (E):

They undergo the transform ation laws = $Ad(^{1})$. The vector bundle which is locally spanned by the 2-form s (2.5) will be called the contact bundle C(J(E))and any section : J(E) ! C(J(E)) will be called a contact 2-form. Contact form s are such that s () = 0 whenever s : M ! J(E) is holonom ic.

J-prolongations of m orphism s and vector elds. A generic m orphism : E ! E, bered over M, can be raised to a m orphism J : J (E) ! J (E) considering its ordinary jet{prolongation and restricting it to J (E) through the quotient m ap, nam ely:

As a matter of fact, not every morphism : E ! E commutes with the quotient map and produces a well de ned prolongation (i.e. independent of the choice of the representative in the equivalence class), but it has to satisfy the condition:

The rst equation ensures the kinem atic admissibility of the critical section , while the second represents the eld equations of the problem . As a matter of fact, the kinem atical admissibility is directly obtained from the variational principle and is not im posed as an a-priori condition, as a consequence of the regularity of the Lagrangian L within the new fram ework provided by J (E).

3 The H am iltonian fram ework

Let m (E) denote the modulus of m-form s over E, and let r (E) = m (E)(r < m) be the sub-bundle consisting of those m-form s on E vanishing when r of its given arguments are vertical vectors over the bundle E! M. It is obvious that the above de ned bundles form a chain of vector bundles over E such that:

A deeper geom etrical insight in the problem can be given observing that eqs. (3.3) make $\frac{m}{1}$ into a vector sub-bundle of $\frac{m}{2}$, thus allowing us to introduce the quotient bundle $\frac{m}{2} = \frac{m}{1}$. As a consequence of the de nition, the latter has the nature of a vector bundle over E and is locally described by the system of coordinates $x^{i};a_{i};^{ij}$. The most striking feature of the Legendre transform ation between J (E) and H (E) is provided by its regularity, due to the acquired regularity of the Yang{M ills Lagrangian in the space J (E). In particular the condition

4 Multimomentum Hamiltonian formulation

In the previous section a Ham iltonian approach to $Yang\{M \text{ ills } eld \text{ theories has been developed, adapting the already known Ham ilton {D e D onder form alism developed within the framework of calculus of variations to the new geometrical setting.$

N evertheless, there exists another well{known H am iltonian approach to eld theory, represented by the so{called multim om entum H am iltonian form alism, where H am iltonian connections play the same role as H am iltonian vector elds in sym – plectic geom etry.

The argument has been widely studied in the literature (compare with [4, 5]), both on the rst jet{bundle and on the Legendre bundle (the phase space), in the Lagrangian and Ham iltonian framework. In this section we will show that a multimomentum formulation of the above theory can be built, starting from the Poincare{Cartan forms (2.13) and (3.16).

W e will start extending som e de nitions and som e results about the Legendre bundle of a generic eld theory to our space. All the argument will be presented without proofs; the reader is referred to [4, 5] for comments and further developments.

5 3+3Yang{M ills elds

In this section a particular G auge theory is considered: the base manifold M will be taken to be 3-dimensional and the gauge groups can be equivalently chosen between G = SO(3) and G = SO(2;1).

Under these hypotheses, both space{time and algebra indexes run from 1 to 3. Besides, given a basis \underline{fe} g for the Lie algebra g of G, we denote by K the coe cients of an Ad-invariant metric over g such that the structure coe cients

C are expressed in the form

The use of a dual form ulation [6] allows to express such a (3 + 3) gauge theory in terms of a gravity (like theory in purely metric form ulation, as proved in [7, 8]. Now, making an explicit use of the Poincare (Cartan approach of section 3, we will show that the H am iltonian version of a (3 + 3) gauge theory has the same shape as an Einstein (Cartan theory. Borrowing from [7, 8], the central idea consists in performing a local coordinate transform ation in the phase space (E), locally described by the following relations:

In particular, let us consider a free Yang{M ills eld, whose dynam ical properties are described by the usual Lagrangian density $L = \frac{1}{4}F_{ip}F_{jq}g^{ij}g^{pq}K \stackrel{p}{f}\overline{g}$, where g_{ij} is a given metric over M and $g := jdetg_{ij}j$. Eqs. (5.10a) are the transition functions of a bundle :T ! M, associated with P $_M L(M)$ (L(M) being the frame bundle over M) through the left action

The (local) sections e: M ! T may be identified with (local) triads $e_i(x) dx^i$ on M; the latter are truly gauge natural objects [9], sensitive to the changes of trivialization of the structure bundle P. Each triad e induces a metric on M expressed as G := K e e, which is invariant under transform ations (5.10a) by construction.

A new J-bundle ^ : J (T) ! M can also be constructed by quotienting the rst{jet bundle j_1 (T) of : T ! M with respect to an equivalence relation analogous to (2.3). The bundle J (T) is naturally referred to local coordinates $x^i; e_i; E_{ij} = \frac{1}{2} e_{ij} e_{ji}$ (i < j).

Now the idea is to choose the components of the spin {connections generated by the triads them selves as ber coordinates on the bundle J (T).

W ithin this fram ework, let $z = (x^i; e_i; E_{ij})$ be an element of J (T), x = (z) its projection over M, e a representative triad belonging to the equivalence class z and G = K e e the metric on M induced by the triad e; we also denote by k_{ih} the Levi{C ivita connection induced by the metric G and by $!_i$ the spin connection associated with k_{ih} through the triad e itself.

The relation between the coe cients $_{ih}^{k}$ and $!_{i}$, evaluated in the point x = ^ (z) 2 M, is expressed by the equation

Because of the metric compatibility condition $!_i := !_i K = !_i$, there exists a one-to-one correspondence between the values of the antisymmetric part of the derivatives $E_{ij}(x) = \frac{1}{2} \frac{@e_i(x)}{@x^j} \frac{@e_j(x)}{@x^i}$ and the coe cients of the spin { connection $!_i$ (x) in the point $x = ^(z)$.

The above considerations allow us to take the quantities $!_i$ as ber coordinates of the bundle J (I), boking at the relations (5.13) and (5.15) as coordinate changes in J (I).

Finally, it is a straightforward matter to verify that the transformation laws of the spin connection coe cients ! $_{i}$ coincide with eqs. (5.10b), as well as that the 3-form (5.3) is invariant under coordinate transformations (5.10a), (5.10b).
