# Distribution of particles which produces a desired radiation pattern

#### Abstract

A method is given for calculation of a distribution of small particles, embedded in a medium, so that the resulting medium would have a desired radiation pattern for the plane wave scattering by this medium.


## 1 Introduction

Let $D_{0} \subset \mathbb{R}^{3}$ be a bounded domain, $k_{0}$ be the wave number in $D_{0}$ and $k<k_{0}$ be the wave number in $D_{0}^{\prime}=\mathbb{R}^{3} \backslash D_{0}$. We assume that $D_{0}$ is a homogeneous medium, so that $k_{0}$ is a constant. This assumption can be weakened: we may assume that $k_{0}=k_{0}(x)$ is a known function. Let $D_{m}$ be a particle, $d_{m}$ be its diameter, $1 \leq m \leq M, M$ is the number of small particles, $a=\max _{1 \leq m \leq M} \frac{d_{m}}{2}$ is an estimate for the radius of a small particle. We assume that $k_{0} a \ll 1$, and then $k a \ll 1$, i.e., particles are small, that $d \gg a$, where $d=\min _{j \neq m} \operatorname{dist}\left(D_{m}, D_{j}\right)$ and that the particles are acoustically soft, i.e., $u=0$ on $S_{m}$, the boundary of $D_{m}$. Denote $U_{m=1}^{M} D_{m}:=U, R^{3} \backslash U=V, \partial U$ is the boundary of $U, C_{m}$ is the electrical capacitance of a perfect conductor with the shape of $D_{m}$.

The Inverse Problem is:
Can one distribute many small particles in $D_{0}$ so that a plane wave $u_{0}:=e^{i k \alpha \cdot x}$, (where $\alpha$ is a given unit vector, $\alpha \in S^{2}, S^{2}$ is a unit sphere), scattered by $D_{0}$, would produce a desired radiation pattern (scattering amplitude) $A\left(\alpha^{\prime}, \alpha\right)$ ?

The acoustic pressure $u$ solves the problem (1)-(3):

$$
\left(\nabla^{2}+k^{2}-q(x)\right) u=0 \text { in } V, \quad q(x)= \begin{cases}k^{2}-k_{0}^{2} & \text { in } D_{0}  \tag{1}\\ 0 & \text { in } D_{0}^{\prime}\end{cases}
$$

$$
\begin{gather*}
u=0 \text { on } \partial U  \tag{2}\\
u=e^{i k \alpha \cdot x}+A\left(\alpha^{\prime}, \alpha\right) \frac{e^{i k r}}{r}+o\left(\frac{1}{r}\right), \quad r:=|x| \rightarrow \infty, \quad \alpha^{\prime}=\frac{x}{r} \tag{3}
\end{gather*}
$$

and the coefficient $A\left(\alpha^{\prime}, \alpha\right)$ is called the scattering amplitude or radiation pattern.
Let $G=G(x, y)$ solve the problem

$$
\begin{equation*}
\left[\nabla^{2}+k^{2}-q(x)\right] G=-\delta(x-y) \text { in } \mathbb{R}^{3}, \quad r\left(\frac{\partial G}{o r}-i k G\right)=o(1) \quad r \rightarrow \infty \tag{4}
\end{equation*}
$$

This $G$ exists, is unique, and solves the integral equation

$$
\begin{equation*}
G(x, y)=g(x, y)-\left(k^{2}-k_{0}^{2}\right) \int_{D_{0}} g(x, z) G(z, y) d z, \quad g=g(x, y):=\frac{e^{i k|x-y|}}{4 \pi|x-y|} \tag{5}
\end{equation*}
$$

For brevity, we drop the $k$-dependence in $g, G$ and other functions below. One may consider $G(x, y)$ known since $D_{0}$ and $k_{0}$ are known.

Let us look for the solution to (11)-(3) of the form

$$
\begin{equation*}
u=U_{0}(x, \alpha)+\sum_{m=1}^{M} \int_{S_{m}} G(x, t) \sigma_{m}(t) d t \tag{6}
\end{equation*}
$$

where $\sigma_{m}(s)$ are unknown functions and $U_{0}(x, \alpha)$ is the scattering solution corresponding to the potential $q(x)$ in the absence of small bodies, i.e., in the whole space. For arbitrary $\sigma_{m}$ the right-hand side of (6) solves equation (11) (because $G$ solves (4)), satisfies the radiation condition (3), and

$$
\begin{equation*}
A\left(\alpha^{\prime}, \alpha\right)=A_{q}\left(\alpha^{\prime}, \alpha\right)+\frac{1}{4 \pi} \sum_{m=1}^{M} \int_{S_{m}} U_{0}\left(s,-\alpha^{\prime}\right) \sigma_{m}(s) d s \tag{7}
\end{equation*}
$$

where the scattering solution $U_{0}(s, \alpha)$ can be defined by the formula ([1, p.232]):

$$
\begin{equation*}
G(x, s)=\frac{e^{i k r}}{4 \pi r} U_{0}(s, \alpha)+o\left(\frac{1}{r}\right), \quad r:=|x| \rightarrow \infty, \quad \alpha=-\frac{x}{r} \tag{8}
\end{equation*}
$$

Formula (8) was proved in [3, p.46], where it was shown that $U_{0}(x, \alpha)$ solves the problem

$$
\begin{equation*}
\left[\nabla^{2}+k^{2}-q(x)\right] U_{0}(x, \alpha)=0 \text { in } \mathbb{R}^{3}, \quad U_{0}=e^{i k \alpha \cdot x}+A_{q}\left(\alpha^{\prime}, \alpha\right) \frac{e^{i k r}}{r}+o\left(\frac{1}{r}\right) \tag{9}
\end{equation*}
$$

where $r:=|x| \rightarrow \infty$ along the direction $\alpha^{\prime}$. The function $U_{0}$ can also be considered known, and $G$ can be considered as Green's function for the Schrödinger equation (9).

The right-hand side of (61) solves problem (11)-(3) if and only if $\sigma_{m}$ are such that boundary condition (22) is satisfied:

$$
\begin{equation*}
-U_{0}(s, \alpha)-\sum_{m \neq j} \int_{S_{m}} G(s, t) \sigma_{m}(t) d t=\int_{S_{j}} G(s, t) \sigma_{j}(t) d t, \quad s \in S_{j}, \quad 1 \leq j \leq M \tag{10}
\end{equation*}
$$

So far the smallness of the particles was not used. If $k a \ll 1$, then equation (10) can be simplified:

$$
\begin{equation*}
-U_{0}\left(s_{j}, \alpha\right)-\sum_{m \neq j} G\left(s_{j}, t_{m}\right) Q_{m}=\int_{S_{j}} g_{0}\left(s_{j}, t\right) \sigma_{j} d t, \quad 1 \leq j \leq M, \quad Q_{m}:=\int_{S_{m}} \sigma_{m} d t \tag{11}
\end{equation*}
$$

where $s_{j} \in S_{j}$ is any point in $S_{j}$, and $g_{0}=\frac{1}{4 \pi|x-y|}$. In equation (11) we have used two approximations. The first one is

$$
\begin{equation*}
G(s, t) \approx g(s, t), \quad s, t \in S_{j} \tag{12}
\end{equation*}
$$

This approximation is justified by (5) when $k|x-y| \ll 1$, because the term $g(x, y)$ is the main term on the right-hand side of (5) as $x \rightarrow y$, and $\left|s_{j}-t\right| \ll 1$. The second one is $g \approx g_{0}$ if $k|s-t| \ll 1$, and the error of this approximation is $O(k a)$, so this approximation is also justified because $k a \ll 1$.

Equation (11) is equation for the charge distribution $\sigma_{j}$ on the surface $S_{j}$ of a perfect conductor charged to the potential $-U_{0}\left(s_{j}, \alpha\right)-\sum_{m \neq j} G\left(s_{j}, t_{m}\right) Q_{m}$. Therefore the total charge $Q_{j}:=\int_{S_{j}} \sigma_{j} d t$ on the surface $S_{j}$ can be calculated by the formula

$$
\begin{equation*}
Q_{j}=C_{j}\left(-U_{0}\left(s_{j}, \alpha\right)-\sum_{m \neq j} G\left(s_{j}, t_{m}\right) Q_{m}\right), \quad 1 \leq j \leq M \tag{13}
\end{equation*}
$$

where $C_{j}$ is the electrical capacitance of the perfect conductor $D_{j}$. In [1, p.385] formulas for calculation of $C_{j}$ with arbitrary desired accuracy are given. Equation (13) is a linear algebraic system for finding unknown $Q_{j}, 1 \leq j \leq M$.

Consider the limiting case $M \rightarrow \infty$ of the distribution of particles in $D_{0}$. Define $C(y)$ as follows:

$$
\begin{equation*}
\int_{D} C(y) d y=\lim _{M \rightarrow \infty} \sum_{D_{m} \subset D} C_{m}, \tag{14}
\end{equation*}
$$

where $D \subset D_{0}$ is an arbitrary subdomain of $D_{0}$. The above definition means that $C(y)$ is the limiting density of the capacitances of the small particles in $D$. Formula (6) shows that the self-consistent field $u_{e}$ can be defined as

$$
u_{e}(x, \alpha)= \begin{cases}U_{0}(x, \alpha)+\sum_{m=1}^{M} G\left(x, t_{m}\right) Q_{m}, & \min _{1 \leq m \leq M}\left|x-t_{m}\right| \gg a  \tag{15}\\ U_{0}(x, \alpha)+\sum_{m \neq j} G\left(x, t_{m}\right) Q_{m}, & \left|x-t_{j}\right| \sim a\end{cases}
$$

Therefore, defining $u_{e}$ we neglect the influence of any fixed single small particle on the field. This is justified when $M \rightarrow \infty$. Using (13) and (15) one gets

$$
u_{e}(x, \alpha)=U_{0}(x, \alpha)-\sum_{m} G\left(x, t_{m}\right) C_{m} u_{e}\left(t_{m}, \alpha\right),
$$

and in the limit $M \rightarrow \infty$ one obtains the equation:

$$
\begin{equation*}
u_{e}(x, \alpha)=U_{0}(x, \alpha)-\int_{D_{0}} G(x, y) C(y) u_{e}(y, \alpha) d y \tag{16}
\end{equation*}
$$

where $C(y)$ is defined in (14). Equation (16) is equivalent to the Schrödinger scattering problem:

$$
\begin{equation*}
\left[\nabla^{2}+k^{2}-q(x)-C(x)\right] u_{e}=0 \text { in } \mathbb{R}^{3}, \tag{17}
\end{equation*}
$$

where $q(x)$ is known, the function $u_{e}$ has the following asymptotics

$$
\begin{equation*}
u_{e}=e^{i k \alpha \cdot x}+A\left(\alpha^{\prime}, \alpha\right) \frac{e^{i k r}}{r}+o\left(\frac{1}{r}\right), \quad r:=|x| \rightarrow \infty, \quad \alpha^{\prime}=\frac{x}{r} \tag{18}
\end{equation*}
$$

and $A\left(\alpha^{\prime}, \alpha\right)$ is the scattering amplitude at a fixed $k>0$.
Therefore the Inverse Problem, stated above, is reduced to inverse scattering problem of finding the potential $q(x)+C(x)$ from the knowledge of the corresponding fixed-energy scattering amplitude $A\left(\alpha^{\prime}, \alpha\right)$.

This problem was solved by the author (see [1, Chapter 5] and references therein). In Section 2 we outline the author's algorithm for solving this inverse scattering problem.

If the potential $q(x)+C(x)$ is found and $q(x)$ is known, then $C(x)$ is found and one knows the density of the particle distribution in $D$ which produces the desired radiation pattern $A\left(\alpha^{\prime}, \alpha\right)$. Assuming that the particles are identical, one has $C_{m}=\mathcal{C}$, where $\mathcal{C}$ is the electrical capacitance of one particle, and $C(x)=N(x) \mathcal{C}$, where $N(x)$ is the density of particles, that is, the number of particles per unit volume around point $x$. See [2] for the theory of wave scattering by small bodies.

## 2 Solution to inverse scattering problem

We follow [1, p.264] and take $k=1$ without loss of generality. Given $A\left(\alpha^{\prime}, \alpha\right)$ one finds $A_{\ell}(\alpha):=\int_{S^{2}} A\left(\alpha^{\prime}, \alpha\right) \overline{Y_{\ell}\left(\alpha^{\prime}\right)} d \alpha^{\prime}$, where $Y_{\ell}:=Y_{\ell m}$ are the normalized spherical harmonics, so that

$$
\begin{equation*}
A\left(\alpha^{\prime}, \alpha\right)=\sum_{\ell=0}^{\infty} A_{\ell}(\alpha) Y_{\ell}\left(\alpha^{\prime}\right), \quad \sum_{\ell=0}^{\infty}:=\sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} \tag{19}
\end{equation*}
$$

If the data $A\left(\alpha^{\prime}, \alpha\right)$ are exact, then (11, p.262])

$$
\begin{equation*}
\max _{\alpha \in S^{2}}\left|A_{\ell}(\alpha)\right| \leq O\left(\sqrt{\frac{b_{0}}{\ell}}\left(\frac{b_{0} e}{2 \ell}\right)^{\ell+1}\right), \quad\left|Y_{\ell}\left(\theta^{\prime}\right)\right| \leq \frac{1}{\sqrt{4 \pi}} \frac{e^{\kappa r}}{\left|j_{l}(r)\right|} \quad \forall r>0, \quad \theta \in \mathcal{M} \tag{20}
\end{equation*}
$$

where $b_{0}>0$ is the radius of the smallest ball containing the domain $D_{0}, \mathcal{M}:=\{\theta:$ $\left.\theta \in \mathbb{C}^{3}, \theta \cdot \theta=1\right\}, \theta \cdot \omega:=\sum_{j=1}^{3} \theta_{j} \omega_{j}, \kappa=|\operatorname{Im} \theta|, j_{\ell}(r)$ is the spherical Bessel function. Fix an arbitrary $\xi \in \mathbb{R}^{3}$. One can find (nonuniquely and explicitly) $\theta^{\prime}, \theta \in \mathcal{M}$, such that $\theta^{\prime}-\theta=\xi, \theta \rightarrow \infty$. For example, if $\xi=t e_{3}, t=|\xi|>0$, (which can be assumed without loss of generality), then $\theta^{\prime}=\frac{t}{2} e_{3}+z_{1} e_{1}+z_{2} e_{2}, \theta=-\frac{t}{2} e_{3}+z_{1} e_{1}+z_{2} e_{2}$, and the condition

$$
\begin{equation*}
\frac{t^{2}}{4}+z_{1}^{2}+z_{2}^{2}=1, \quad z_{1}, z_{2} \in \mathbb{C} \tag{*}
\end{equation*}
$$

implies $\theta, \theta^{\prime} \in \mathcal{M}$. One may find many $z_{1} z_{2} \in \mathbb{C}$, such that (図) holds and $\left|z_{1}\right| \rightarrow \infty$. For example, take $z_{1}=r e^{i \varphi}, z_{2}=r e^{-i \varphi}$, then $r^{2} \sin (2 \varphi)-r^{2} \sin (2 \varphi)=0, r^{2}[\cos (2 \varphi+$ $\cos (2 \varphi)]=1-\frac{t^{2}}{4}$, so $r^{2} \cos (2 \varphi)=\frac{1}{2}-\frac{t^{2}}{8}$. One can take $r \geq\left|\frac{1}{2}-\frac{t^{2}}{8}\right|^{1 / 2}$ and find $\varphi$ such that $\cos (2 \varphi)=\left(\frac{1}{2}-\frac{t^{2}}{8}\right) \frac{1}{r^{2}}$.

In what follows we always assume

$$
\begin{equation*}
\theta^{\prime}-\theta=\xi, \quad \theta^{\prime}, \theta \in \mathcal{M}, \quad|\theta| \rightarrow \infty \tag{21}
\end{equation*}
$$

Because of (20), the series

$$
\begin{equation*}
A\left(\theta^{\prime}, \alpha\right)=\sum_{\ell=0}^{\infty} A_{\ell}(\alpha) Y_{\ell}\left(\theta^{\prime}\right), \quad \theta \in \mathcal{M} \tag{22}
\end{equation*}
$$

converges absolutely and uniformly on compact subsets of $S^{2} \times \mathcal{M}$.
Fix positive numbers $b_{0}<b_{1}<b_{2}$ such that $D_{0} \subset B_{b_{0}}:=\left\{x:|x| \leq b_{0}\right\}$. Note that the scattering solution $u(x, \alpha)$ for the scattering potential $q(x)+C(x)$ can be written explicitly in the region $|x|>b_{0}$ :

$$
\begin{equation*}
u(x, \alpha)=e^{i \alpha \cdot x}+\sum_{\ell=0}^{\infty} A_{\ell}(\alpha) Y_{\ell}\left(\alpha^{\prime}\right) h_{\ell}(r), \quad r:=|x|>b_{0} \tag{23}
\end{equation*}
$$

where $k=1$ and $h_{\ell}(r)$ is the spherical Hankel function which is normalized by the asymptotics

$$
\begin{equation*}
h_{\ell}(r) \sim \frac{e^{i r}}{r} \quad r \rightarrow \infty \tag{24}
\end{equation*}
$$

Let $\nu(\alpha) \in L^{2}\left(S^{2}\right)$. Consider the problem:

$$
\begin{equation*}
\mathcal{F}(\nu)=\min \tag{25}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathcal{F}(\nu):=\int_{b_{1} \leq|x| \leq b_{2}}\left|e^{-i \theta \cdot x} \int_{S^{2}} u(x, \alpha) \nu(\alpha) d \alpha-1\right|^{2} d x \tag{26}
\end{equation*}
$$

The function $u(x, \alpha)$ in (261) is defined in (23), and the minimization in (25) is with respect to all $\nu \in L^{2}\left(S^{2}\right)$. One can prove ([1, p. 265 ]) that

$$
\begin{equation*}
\inf \mathcal{F}(\nu):=d(\theta) \leq \frac{\text { const }}{|\theta|}, \quad \theta \in \mathcal{M}, \quad|\theta| \gg 1 \tag{27}
\end{equation*}
$$

Let $\nu(\alpha, \theta)$ be an arbitrary approximate solution to (25) in the following sense:

$$
\begin{equation*}
\mathcal{F}(\nu(\alpha, \theta)) \leq 2 d(\theta) \tag{28}
\end{equation*}
$$

For this $\nu$ define

$$
\begin{equation*}
\hat{C}:=-4 \pi \int_{S^{2}} A\left(\theta^{\prime}, \alpha\right) \nu(\alpha, \theta) d \alpha \tag{29}
\end{equation*}
$$

where $A\left(\theta^{\prime}, \alpha\right)$ is defined in (22).
Let $\widetilde{C}(\xi)=\int_{D_{0}} C(x) e^{-i \xi \cdot x} d x$, where $C(x) \in L^{2}\left(D_{0}\right)$ vanishes in $D_{0}^{\prime}$. Let (21) hold.
The following theorem is proved by the author in [1, p.266].
Theorem. Under the above assumptions one has

$$
\begin{equation*}
|\hat{C}-\widetilde{C}(\xi)|=O\left(\frac{1}{|\theta|}\right) \tag{30}
\end{equation*}
$$

Conclusion: An algorithm is given for embedding many small particles in a domain $D_{0}$ in such a way that the plane wave, scattered by such domain, would have a desired radiation pattern $A\left(\alpha^{\prime}, \alpha\right)$.

The algorithm consists of solving the inverse scattering problem, namely, finding the potential $q(x)+C(x)$, vanishing outside $D_{0}$, from the fixed-energy ( $k^{2}=$ const $>0$ ) scattering amplitude $A\left(\alpha^{\prime}, \alpha\right)$. If this potential is found, then $C(x)$ is found, and the small acoustically soft identical particles should be distributed in $D_{0}$ with the density $N(x)=\mathcal{C}^{-1} C(x)$, where $\mathcal{C}>/$ is the electrical capacitance of a perfect conductor which has the shape of the particle.
