# QUATERNION LANDAU-GINSBURG MODELS AND NONCOMMUTATIVE FROBENIUS MANIFOLDS.

Abstract. We extend the classical topological Landau-G insburg model to a quaternion Landau-G insburg model, that satisfy the axioms of open-closed topological eld theory. Later we prove, that a moduli space of quaternion Landau-G insburg models are non-commutative Frobenius manifold in means of [15].



# 1. Introduction

In this paper we construct the dotted cells and dotted lines in the next scheme:

Explain this scheme in detail. The classical topological Landau-G insburg model was found by Vafa [17] (see also D ijkgraaf-W itten [5]). It generates an algebra over C on the tangent space to a polynomial  $p(z) = z^{n+1} + a_1 z^{n-1} + a_2 z^{n-2} + \dots + a_n$  in the space Pol(n) of all such polynomials. This algebra  $A_p$  is associative, with the unity and a linear functional  $l_p:A_p!$  C, such that the bilinear form  $(d_1;d_2) = l_p(d_1d_2)$  is non degenerates. We call by Frobenius pairs all pairs  $(A_p;l_p)$  with such algebraic properties. A lgebra  $A_p$  is commutative for classical topological Landau-G insburg model.

Commutative Frobenius pairs one-to-one correspond to topological eld theories that appear from closed topological strings [3, 4, 7, 16]. These topological eld theories naturally extend up to open-closed topological eld theories, describing strings with boundary [10, 12], and even up to Kleinian topological eld theories, describing strings with arbitrary world sheets [1]. In their turn, open-closed topological eld theories one-to-one correspond to combinations from one commutative and one unrestricted Frobenius pairs, connected by Cardy condition [1]. We call such algebraic structure by Cardi-Frobenius algebra. Some classications of Cardi-Frobenius algebras is contained in

In the present paper we construct som e extension of classical topological Landau-G insburg model to a Cardy-Frobenius algebra with a quaternion structure. Next we prove, that the set of such quaternion Landau-G insburg models over all polynomials  $p(z) = z^{n+1} + a_1 z^{n-1} + a_2 z^{n-2} + \dots + a_n$  from a non-commutative Frobenius manifold in means of [15].

Let us explain this result in more detail. The moduli space of the classical topological Landau-G insburg models coincides with the space Pol(n) of miniversale deformation for the singularity of type  $A_n$  [2]. The metrics  $(d_1;d_2) = l_p(d_1d_2)$  on the algebras  $A_p$  turn Pol(n) into a Riemannian manifold with some additional properties [6, 7]. The differential-geometric structure, arising here, is an important example of Frobenius manifolds [7, 11]. The theory of Frobenius manifolds has a lot of applications in different areas of mathematics (integrable systems, singularity theory, topology of symplectic manifolds, geometry of moduli spaces of algebraic curves etc.).

The Dubrovin's theory of Frobenius manifolds [7] is a theory of at deform ations of commutative Frobenius pairs. As we discussed, Frobenius pairs are extended up to Cardy-Frobenius algebras. This suggests on extension of Frobenius manifolds to Cardy-Frobenius manifolds. An approach to this problem, is contained in [15]. It is based on Kontsevich-Manin cohomological eld theory [9].

In this paper we de ne Cardy-Frobenius bundles as spaces of some at deform ations of Cardy-Frobenius algebras and prove, that they are

Cardy-Frobenius (noncom mutative) manifolds as regards to [15]. Moreover we prove that the family of all the quaternion Landau-Ginsburg models form a Cardy-Frobenius bundle with quaternion structure.

## 2. Cardy-Frobenius algebras.

Following [10,12] describe the algebraic structure (Cardy-Frobenius algebra), connected with open-closed topological eld theory. It is follow from [1], that Cardy-Frobenius algebras one-to-one correspond to open-closed topological eld theories.

## 2.1 Frobenius pairs.

De nition. By Frobenius pair over a eld K we call a set (D; 1) where

- 1. D is an associative algebra over K with the unity element  $1^D$ .
- 2.  $\mathbb{P}$  : D! K is a K-linear functional such that the bilinear form  $(d_1;d_2)^{\mathbb{D}} = \mathbb{P}$   $(d_1d_2)$  is non degenerated.

In this case D is a Frobenius algebra [8].

De nition. By orthogonal sum of Frobenius pairs  $(D_1; \mathbb{P}^1)$  and  $(D_2; \mathbb{P}^2)$  we call the Frobenius pair  $(D; \mathbb{P}^1) = (D_1; \mathbb{P}^1)$   $(D_2; \mathbb{P}^2)$ , where  $D = D_1$   $D_2$  is the direct sum of algebras  $(d_1d_2 = 0 \text{ for } d_1 \text{ 2 } D_1)$  and  $\mathbb{P}^1 = \mathbb{P}^1$   $\mathbb{P}^2$ .

## 2.2 Cardy-Frobenius algebras.

De nition. By Cardy-Frobenius algebra over K we call a set  $f(A; \mathbb{P}^A)$ ;  $(B; \mathbb{P}^B)$ ; g, where

1. (A;  $\mathbb{I}^{\mathbb{A}}$ ) and (B;  $\mathbb{I}^{\mathbb{B}}$ ) are Frobenius pairs over K and A is a commutative algebra;

- 2. : A! B is a hom om orphism of algebras, such that (A) belong to centre of B;
- 3. For any x; y 2 B is ful led  $((x); (y))^A = tr(W_{x,y})$ , where :B! A is the linear operator, such that (a; (b)) $^{A}$  = ((a);b) $^{B}$ , for a 2 A; b 2 B, and W  $_{x,y}$ : B! B is the linear operator, de ned by  $W_{x,y}(b) = xby$ .

The condition of this type rst appear in works of Cardy and usually has him name. Let us give a coordinate representation of Cardy condition, using bases (1; ::: n) A and (1; ::: n) B. Let fF i jg and  $fF^{ij}g$  be matrixes inverse to  $F_{ij} = (i; j)^A$  and  $F_{ij} = (i; j)^B$ . Then condition 3. is equivalent to

## 3. Quaternion Landau-Ginsburg models.

The classical topological Landau-G insburg model [17] of degree n is generated by a complex polynomial p in the form  $p(z) = z^{n+1} +$  $a_1 z^{n-1} + a_2 z^{n-2} + \dots + a_n$ , such that all roots  $a_1 : \dots : a_n$  of its derivative  $p^0(z)$  are sim ple.

The set of all such polynom ials form a complex manifold Pol(n) of complex dimension n. Its tangent space  $A_p$  in a point p consists of all polynom ials of degree n 1. The Landau-G insburg model generates on  $A_p$  a structure of algebra, where the multiplication  $q=q_1$  p  $q_2$  for polynom ials  $q_1=q_1$  (z) and  $q_2=q_2$  (z) 2  $A_p$  is defined by condition  $q(z)=q_1$  (z)  $q_2$  (z) (modp<sup>0</sup>(z)).

M oreover, the Landau-G insburg model generates on  $A_p$  a non-degenerated bilinear form  $(q_1;q_2)_p = l_p(q_1q_2) = l_p(q_1 p q_2)$ , where  $l_p(q) = \frac{1}{2i} \frac{q(z)dz}{p^0(z)}$ . (Here and late the formula  $\frac{1}{2i}$  means "minus residue in 1"). Thus  $A_p$  has a structure of Frobenius algebra.

residue in 1 "). Thus  $A_p$  has a structure of Frobenius algebra. The polynom ials  $e_p$ ;  $_i(z) = \frac{z_{-j}}{j \in i}$  form a basis of idem potents of  $A_p$ , that is  $e_p$ ;  $_ie_p$ ;  $_j = _{Q^{ij}}e_p$ ;  $_i$ . Thus  $A_p$  is a sem i-simple algebra. Put  $_{p;i} = \frac{1}{p}(e_p;i) = \frac{1}{n+1} \frac{1}{j \in i} \frac{1}{i-j}$ . #### 4. Frobenius manifolds.

#### 4.1. Frobenius manifolds and W DVV equations.

In middle of 90 years of the last century B D ubrovin found and investigated a class of "at" deformation of commutative Frobenius algebras that appear in dierent domain of mathematics. He calls this structure Frobenius manifolds [7]. Frobenius manifold is a manifold with a Dubrovin connection. Present some equivalent de nitions of the Dubrovin connection.

De nition.([7]) Let M be a smooth (real or complex) manifold. By Dubrovin connection on M is called is a family of commutative Frobenius pairs (M  $_{\rm p}$ ;  $_{\rm p}$ ) on the tangent spaces M  $_{\rm p}$  =  $T_{\rm p}$ M for any point p 2 M such that

- 4. There exists a vector eld E (it is called Euler eld), such that 0 (OE) = 0.

A Frobenius manifold M is called sem i-simple, if M  $_{\rm p}$  is a sem i-simple algebra for any point p 2 M .

If (e) = 0, then Frobenius manifold has a special at quasi-pom ogeneous coordinate system t = (t¹;:::;tⁿ), such that g =  $_{ij}^{i}$   $_{i+j;n+1}dt^{i}_{p}$   $_{i+j}^{i}$   $_{i$ 

Recall, that any sem i-simple commutative Frobenius algebra is a direct sum of one-dimensional one [8]. Thus it has a canonical basis  $e_1$ ; ...;  $e_n$ . This is a basis with the properties  $e_i e_j = e_{ij} e_i$ ,  $e_i e_j = e_{ij} e_i$ . The canonical basis is defined uniquely up to enumeration of its elements.

De nition.([13]) A sem i-simple anti-diagonale Dubrovin connection on a smooth (real or complex) manifold M is a family of commutative Frobenius pairs (M  $_{\rm p}$ ;  $_{\rm p}$ ) on the tangent spaces M  $_{\rm p}$  =  $T_{\rm p}$ M for any point p 2 M such that

By potential of Dubrovin connection  $(M_p;_p)$  on at quasihom ogeneous coordinates  $t=(t^1;...;t^n)$ , is called a function  $F(t^1;...;t^n)$  such that  $_p(\frac{\theta}{\theta t^1}\frac{\theta}{\theta t^1}\frac{\theta}{\theta t^1})=\frac{\theta F}{\theta t^1\theta t^1\theta t^k}$ .

De nition. Let F ( $t^1$ ; :::;  $t^n$ ) be a function on a set U  $C^n = (t^1; :::; t^n)$ . This equations was found in works of W itten [18] and D ijkgraaf, E .Verlinde, H .Verlinde [6] for a description of spaces of deform ations of topological elds theories.

A coording to [7], any solution of W DVV equations is a potential of some anti-diagonale D ubrovin connection and moreover the correspondance (potential)? (anti-diagonale D ubrovin connection) form one-to-one correspondance between solutions of W DVV equations and anti-diagonale D ubrovin connections.

If a solution F of W D V  $_{\rm F}$  equations has a representation in the form of Tailor series F (t) =  $c(i_1;i_2;...;i_k)t^{i_1}t^{i_2}...t^{i_k}$ , then associativity equations are equivalent to some relations between the coecients  $c(i_1;i_2;...;i_k)$ . M K ontsevich, Y u M anin [9, 11] presented a family of coecients with these relations by a special system of homomorphisms C  $^1$ ! H  $(M_0;i_1)$ , where M  $_{0;i_1}$  is the moduli space of spheres with 1 pictures. This gives some other method of description for Frobenius manifolds. It is called C ohomological Field Theory.

4.2. M oduli spaces of classical topological Landau-G insburg models.

The rst and very important example of a complex Frobenius manifold is the the moduli space Pol(n) of classical topological Landau-G insburg models. This space appear also in the theory of singularity, the theory of C oxeter groups, the theory of moduli spaces of R iem ann surfaces, in matrix models of mathematical physics and in integrable systems. Let us describe this example more detailed, following on the whole [7].

Theorem 4.1.[6,7] The structure of Frobenius pairs  $(A_p; l_p)$  for  $p \ge P$  ol(n) generates a complex Dubrovin connection on the space Pol(n) of polynomials  $p(z) = z^{n+1} + a_1 z^{n-1} + a_2 z^{n-2} + \dots + a_n$ .

Proof. A xiom 1 directly follow from the de nitions. Let  $(_1; :::;_n)$  be the set of roots of  $p^0$ . Consider the functions  $x^i(p) = p(_i)$  as coordinates on Pol(n).

Lem m a 4.1. The coordinates  $(x^1; ...; x^n)$  are canonical,  $= \frac{2}{n+1} - 1$  and  $E = \bigcap_{i=k}^n \frac{k+1}{n+1} a_k @=@a_k$ .

Proof. Prove, that  $\frac{\theta}{\theta x^j} = e_p$ ;  $_j$ . Really,  $_{ij} = \frac{\theta x^i}{\theta x^j} = \frac{\theta ((i)^{n+1} + a_1 (i)^{n-2} + \dots + a_n)}{\theta x^j} = ((n+1)(i)^n + (n-1)a_1 (i)^{n-2} + \dots + a_{n-1}) \frac{\theta}{\theta x^j} + \frac{\theta}{\theta x^j} (i)^{n-1} + \dots + \frac{\theta}{\theta x^j} = p^0 (i) \frac{\theta}{\theta x^j} + \frac{\theta p}{\theta x^j} (i) = \frac{\theta p}{\theta x^j} (i)$ . Thus  $\frac{\theta p}{\theta x^j} (i) = i_j = e_p$ ;  $_j (i)$  and therefore  $\frac{\theta p}{\theta x^j} (i) = e_p$ ;  $_j (i)$ . By denotion, this means that the polynom ial  $e_p$ ;  $_j (i)$  correspond to the tangent vector  $\frac{\theta}{\theta x^j}$ . Thus  $(\theta = \theta x^1; \dots; \theta = \theta x^n)$  form a canonical basis.

Prove now, that  $l_p = \frac{da_1}{n+1}$ . Really, considering the coe cients for  $z^{n-1}$  in  $\frac{\theta a_1}{\theta x^i} z^{n-1} + \dots + \frac{\theta a_n}{\theta x^i} = \frac{\theta p}{\theta x^i}$  (z)  $= e_p$ ; (z) we note that  $l_p (\theta = \theta x^i) = l_p (e_p)$ ; (b)  $l_p = \frac{1}{n+1} \frac{\theta a_1}{\theta x^i}$ . Thus  $l_p = \frac{a_1}{n+1} \frac{1}{\theta} (\theta = \theta x^i) dx^i = \frac{1}{n+1} \frac{\theta a_1}{\theta x^i} dx^i = \frac{da_1}{n+1}$ .

Construct now a at coordinate systems on Pol(n). Consider a function !=!(p;z) on Pol(n) C such that  $!^{n+1}=p(z)$ . Put  $z=!+\frac{t^1}{!}+\frac{t^2}{!^2}+\frac{t^3}{!^3}+\ldots$  The equality  $!^{n+1}=p(!+\frac{t^1}{!}+\frac{t^2}{!^2}+\frac{t^3}{!^3}+\ldots)$  gives a possibility to ndt as a quasihom ogenous polynom ial of fajg. In particularity  $t^1=\frac{a_1}{n+1}$   $t^2=\frac{a_2}{n+1}$ . Put  $t^1=(n+1)t^n$ ,  $t^n=t^1$  and  $t^i=\frac{p}{n+1}t^{n+1}$  if for i=2; ...; i=1.

Lem m a 4.2. The coordinates (t<sup>1</sup>; :::; t<sup>n</sup>) are at quasi-hom ogeneous and  $d_i = \frac{n+2-i}{n+1}$ .

Proof. Consider the set of polynom ials  $p(z;t) = z^{n+1} + a_1(t)z^{n-1} + a_2(t)z^{n-2} + \dots + a_n(t)$ , where  $t = (t^1;\dots;t^n)$ . Consider the function  $z(!;t) = ! + \frac{t^1}{!} + \frac{t^2}{!^2} + \frac{t^3}{!^3} + \dots$ , such that  $!^{n+1} = p(z(!;t);t)$ . We will consider ! and  $ft^1;\dots;t^ng$  as independent variables. Then  $0 = \frac{d!^{n+1}}{dt^i} = \frac{@p}{@t^i} + \frac{@p}{@z}\frac{@z}{@t^i} = \frac{@p}{@t^i} + p^0\frac{1}{!^1}$ . Using this fact and lemma 4.1, we not that  $i = \frac{a_1}{p} dt^i$  ( $\theta = \theta t$ ) =  $\frac{a_1}{n+1} da_1$  ( $\theta = \theta t$ ) =  $\frac{1}{p} (\theta = \theta t) = g(e_i \theta = \theta t) = g(e_$ 

It is follow from lem m a 4.1. that  $L_E\,a_i=\frac{i+1}{n+1}a_i.$  Thus, by the de nition oft, we not that  $I_E\,t^i=\frac{i+1}{n+1}t^i.$  Therefore  $L_E\,t^i=\frac{n+2-i}{n+1}t^i,$  and  $E=\frac{n}{i=1}\frac{n+2-i}{n+1}t^i$  (0=0ti).

Exam ple 4.2. The potential of the Frobenius manifold Pol(n) is a polynom ial  $F_n$  [7]. Its coe cients was found in [14]. In particulary  $F_2 = \frac{1}{2} (t^1)^2 t^2 + \frac{1}{24} (t^2)^4$ .

### 5. Non-commutative Frobenius manifolds.

# 5.1. Extended W D V V equations.

A theory of deform ations of closed strings is one of sours for the theory of Frobenius manifolds. Its mathematical equivalent is at deformations of commutative Frobenius pairs. But the theory of closed strings is only part of more general open-closed topological eld theory. It is follow from [1,10,12], that a mathematica equivalent of a open-closed topological eld theory is a Cardy-Frobenius algebra. A theory of at deformation for Cardy-Frobenius algebras was suggested in [15]. It continue the Kontsevich and Manin approach [9,11] and it gives some extension of WDVV equations to dierential equations on series of non-commutative variables.

Describe more detail these equations. Let  $t=(t^1; :::; t^n)$  (respectively  $s=(s^1; :::; s^m)$ ) be the standard coordinates on  $A=C^n$  (respectively on  $B=C^m$ ). Consider the algebras of formal tensor series  $F=(i_1;i_2; :::; i_k; j_1; j_2; :::; j_k)t^{i_1}$   $t^{i_2}:::t^{i_k}$   $s^{j_1}$   $s^{j_2}:::s^{j_k}$ ,  $c(i_1;i_2; :::; i_k; j_1; j_2; :::; j_k)$  2 C. Let  $F_A$  be the part of the series F that consists of all m onom ial m ithout  $s^i$ .

Partial derivatives of F are de ned by partial derivatives of m onomials.

We consider that  $\frac{e^{(t^{j_1} t^{j_2} \cdots t^{j_k} s^{j_1} s^{j_2} \cdots s^{j_k})}{e^{t^{j_1}}}$  is the sum of monom ials  $t^{i_1}$   $t^{i_2}$   $\cdots$   $t^{i_{p+1}}$   $\cdots$   $t^{i_{p+1}}$   $\cdots$   $t^{i_k}$   $t^{i_k}$ 

Reciprocally  $\frac{\varrho (t^{i_1} \ t^{i_2} \ \dots \ t^{i_k} \ s^{j_1} \ s^{j_2} \ \dots \ s^{j_k})}{\varrho s^j}$  is the sum of monomials  $t^{i_1} \ t^{i_2} \ \dots \ t^{i_k} \ s^{j_1} \ s^{j_2} \ \dots \ s^{j_{p-1}} \ s^{j_{p+1}} \dots \ s^{j_k}$ , such that  $j_p = j$ . We say that a tensor series  $F = c(i_1 \ _k jjji \ _k )$ tij  $^k$  t  $s^{j_1}$   $^j$  satisfy extended W D V V equations on a space H = A B, if the following conditions hold

- 1. The coe cients  $c(i_1 \ _k j j i \ _v)$  give invariant under all perm utation of  $fi_r g$ .
- 2. The coe cients c(i;j) c(j;j) generate nondegenerate matrices. By  $F_a^{i^it^j}$   $F_b^{s^is^j}$  denote the inverse matrices of c(i;j) and c(j;j) respectively.

In [15] are dem onstrated that solutions of extended W DVV equations one-to-one correspond to potentials of some extension of C ohom ological Field Theory and moreover they describe some class of deformations of Cardy-Frobenius algebras. Thus it is natural to consider solutions of extended W DVV equations as (non commutative) extension of Frobenius manifolds, that we call Cardy-Frobenius manifolds. Late we prove that quaternion Landau-G insburg models generate a Cardy-Frobenius manifold.

## 5.2. Cardy-Frobenius bundles.

De nition. Let M be a, were K is the real or the complex eld. By Cardy-Frobenius bundle on smooth (real or complex) manifold M we call a pair of bundles 'A: A! M and 'B: B! M with a at connection  $r_B$ , and a set of Cardy-Frobenius algebras  $f(A_p; \frac{1}{p}); (B_p; \frac{1}{p}); pg$ , where  $A_p = \frac{1}{A}(p), B_p = \frac{1}{B}(p)$ , such that:

- 1. The algebras  $f(A_p; \mathcal{A})$  g form a Dubrovin connection.
- 2. The connection  $r_B$  conserve the family of bilinear forms  $f(b_1;b_2)_p = 1_p^B(b_1b_2)\dot{p} \ 2 \ M \ g$ .

Call by a at system of coordinates on B a family of linear coordinates system s s = fs<sub>p</sub> =  $(s_p^1; :::; s_p^m)$  jp 2 M g on bands B<sub>p</sub>, that is invariant by r<sub>B</sub>. It generates a basis  $(\frac{e}{e \, s_p^n}; :::; \frac{e}{e \, s_p^m})$  on any vector space

 $B_p$ . A xiom 2. say that values  $(\frac{\theta}{\theta s_p^i}; \frac{\theta}{\theta s_p^j})_p = \frac{1}{p} (\frac{\theta}{\theta s_p^i}; \frac{\theta}{\theta s_p^j})$  are constants on M

- 3. Let  $s=(s^1; :::; s^m)$  be a at system of coordinates on B . Then the tensor elds  $\mathring{\mathbb{C}}(\frac{\theta}{\theta s^i}; \frac{\theta}{\theta s^j}; \frac{\theta}{\theta s^k}) = \mathbb{I}_p^B(\frac{\theta}{\theta s^i} \frac{\theta}{\theta s^j} \frac{\theta}{\theta s^k})$ , are smooth as functions on M . We call B-structures tensors.
- 4. The natural map =  $f_p p 2 M g : A ! B is smooth. It de ne smooth transition tensors eld <math>c^{AB}$  (a;b) =  $I_p^B$  (a)b).

Theorem 5.1. Let M be a sem i-simple Frobenius manifold with a Dubrovin connection  $f(A_p; l_p^A)$  is 2 M g. Then there exist Cardy-Frobenius bundles  $f(A_p; l_p^A)$ ;  $(B_p; l_p^B)$ ; g.

Proof. Let  $(x^1; :::; x^n)$  be canonical coordinates on M. Put  $p_{;i} = l_p^A$  (@=@ $x^i$  (p)). Let  $p_{;i}$  be a smooth function on M, such that  $p_{;i}^2 = p_{;i}$ . Consider the family of Frobenius pair  $(B_{p;i}; l_{p;i}^B) = M_p (m; C) (p_{p;i})$  from example 2.2. Put  $(B_p; l_p^B) = l_p (B_{p;i}; l_{p;i}^B)$  and  $B_p = l_p (B_p) = l_p (B_p)$ . Describe a connection  $p_{ij} = l_p (B_p)$ . We will be consider, that the connection  $p_{ij} = l_p (B_p)$  generate the basis the  $p_{ij} = l_p (B_p)$ . De nition. Let 'A : A ! M, 'B : B ! M, rB, f(Ap; Ip^A); (Bp; Ip^B); pp 2 M g be a Cardy-Frobenius bundle on M. Let t = (t^1; :::; t^n) be a system of at quasi-hom ogenies coordinates of the Dubrovin connection (Ap; Ip^A) and let s = (s^1; :::; s^m) be a system of at coordinates on B. By potential of this Cardy-Frobenius bundle is called the form altensor series F (tjs) =  $c(i_1; i_2; :::; i_k; j_1; j_2; :::; j_k)t^{i_1}$   $t^{i_2} :::t^{i_k}$   $s^{j_1} : s^{j_2} ::::; j_k)$  where  $c(i_1; i_2; :::; i_k; j_1; j_2; :::; j_k)$  2 C, such that

- 1. The matrixes  $c(i;j) = \frac{1}{p} (\frac{\theta}{\theta t^{i}} \frac{\theta}{\theta t^{j}}) c(ji;j) = \frac{1}{p} (\frac{\theta}{\theta s^{i}} \frac{\theta}{\theta s^{j}})$  are non-degenerated. Let  $F_{a}^{t^{i}t^{j}}$  and  $F_{b}^{s^{i}s^{j}}$  be the matrixes inverted to c(i;j) and c(ji;j) respectively.
- 2. If  $F_A$  is the part of F that don't depend from s, that it pass to the potential of D ubrovin connection  $(M_p; I_p^A)$  after changing the tensor multiplication to the ordinary multiplication.
- 3. The formal tensor series  $\frac{e^{3}F}{e^{s^i}e^{s^j}e^{s^r}}$  are not depend from s and, after changing the tensor multiplication to the ordinary multiplication, coincide with the B-structure tensors of the bundle.
- 4. The form altensor series  $\frac{\theta^2 F}{\theta t^{i} \theta s^{j}}$  are not depend from s and , after changing the tensor multiplication to the ordinary multiplication, coincide with the transition function of the bundle.

Theorem 5.2. Let a Dubrovin connection  $(A_p; l_p^A)$  on M has a potential in form of Taylor series. Then any Cardy-Frobenius bundle

'A:A! M,'B:B! M,rB,f(Ap; $^{A}_{p}$ ); (Bp; $^{B}_{p}$ ); pp2 M galso has a potential.

Proof. Let  $t=(t^1; :::; t^n)$  be a st quasi-hom ogeneous coordinates of the Dubrovin connection  $f(A_p; I_p^A)$  jp 2 M g. Let  $s=(s^1; :::; s^m)$  be be a st coordinates system on B. Consider the potential of the Dubrovin connection  $f(A_p; I_p^A)$  jp 2 M g. Changing the ordinary multiplication to the tensor multiplication we obtain a tensor series  $F_A$ . Let  $F_A^i$  be the tensor series, such that  $\frac{gF_A^i}{gt^i} = F_A$ . Then the tensor series  $F_P = F_A + \frac{1}{2}$   $I^A(\frac{g}{gt^i}, \frac{g}{gt^j})$   $t^i$   $t^j + I^B(\frac{g}{gs^i}, \frac{g}{gs^j})$   $s^i$   $s^j + F_A^i t^i$   $s^i + \frac{1}{3}$   $I^B(\frac{g}{gs^i}, \frac{g}{gs^j}, \frac{g}{gs^k})$   $s^i$   $s^j$  is the potential of the Cardy-Frobenius bundle.

Theorem 5.3. The potential of any Cardy-Frobenius bundle satisfy the extended W DVV equations.

Proof. All relation follow from properties of Cardy-Frobenius algebras f( $A_p I_p^A$ ); ( $B_p ; I_p^B$ ); pg. In particulary relation 1 follow from the commutativity of A. Relation 2 follow from the non-degeneracy the bilinear form s on A and B. Relations 3 and 4 follow from the associativity of algebras A and B. Relation 5. is true because  $p(A_p)$  belong to center of algebra  $B_p$ . Relation 6 is true because the map p is a hom om orphism. Relation 7 follow from Cardy axiom.

5.3. M oduli space of quaternion Landau-G insburg m odels.

Let us use the construction from theorem 5.1. for quaternion Landau-G insburg models. Then we have

Corollary 5.1. Family of quaternion Landau-Ginsburg models  $f(A_p; I_p^A); (B_p; I_p^B;); pp 2 Pol(n)g$  form a Cardy-Frobenius bundles over Pol(n). The space B has a natural quaternion structure that is invariant by the connection  $r_B$ .

A at system of coordinates  $t=(t;:::;t^n)$  for A is , described in section 4. A basis on  $B_p$  is  $f1^H e_p$ ,  $_i$ ;  $Ie_p$ ,  $_i$ ;  $Je_p$ ,  $_i$ ;  $Ke_p$ ,  $_i$ ; Ii=1; Ii:::ng from section 3. In a neighborhood of p it generate a at coordinate system  $s_{q;i}=(s_{q;i}^{1^H};s_{q;i}^{I};s_{q;i}^{I};s_{q;i}^{K})=\frac{p_{f,i}}{q_{f,i}}(1^H e_p,_i;Ie_p,_i;Je_p,_i)$ , where  $s_{q;i}=s_{p_{f,i}}=s_{p_{f,i}}$ .

Example 5.1. For any V;W 2 fl<sup>H</sup>;I;J;K g,  $\frac{e}{e s_{h,i}^{V}} \frac{e}{e s_{q,i}^{W}} = h_{iq} i_{ij}$   $\frac{e}{q_{i}} \frac{e}{e s_{q,i}^{V}}$ 

Thus we can to  $\ \ \, \text{nd} \ \, \text{the bilinear form} \ \, \frac{\left(\frac{\theta}{\theta}, s^{i}\right)}{\left(\frac{\theta}{\theta}, s^{i}\right)}^{B} = \ \, \mathbb{P} \left(\frac{\theta}{\theta s^{ij}} \frac{\theta}{\theta s^{kl}}\right)$  and the structure tensor  $c^{B}\left(\frac{\theta}{\theta s^{ij}}; \frac{\theta}{\theta s^{kl}}; \frac{\theta}{\theta s^{uv}}\right) = \ \, \mathbb{P} \left(\frac{\theta}{\theta s^{ij}} \frac{\theta}{\theta s^{kl}} \frac{\theta}{\theta s^{uv}}\right)$ , by values  $\ \, q_{i,i}$ . Example 4.1. contain an algorithm for these calculations for  $\ \, n=2$ . In this case  $\ \, \frac{2}{q_{i,i}} = \frac{p}{6} \frac{1}{t^{2}}$ .

Example 5.2. Coupling between canonical  $x = (x^1; ...; x^n)$  and at quasi-hom ogeneous coordinates  $t = (t^1; ...; t^n)$  generate the transition tensors. Demonstrate this for n = 2.

According to our denitions,  $\frac{\theta}{\theta t^2} = \frac{\theta}{\theta x^1} + \frac{\theta}{\theta x^2} = \frac{\theta}{\theta t^2} = R_1 \frac{\theta}{\theta x^1} + R_2 \frac{\theta}{\theta x^2}$ . Thus  $\frac{\theta}{\theta t^2} \frac{\theta}{\theta t^2} = R_1 \frac{\theta}{\theta x^1} + R_2 \frac{\theta}{\theta x^2}$ . On the other hand, according to example 42,  $\frac{\theta}{\theta t^2} \frac{\theta}{\theta t^2} = t^2 \frac{\theta}{\theta t^2} = t^2 \frac{\theta}{\theta t^2} = t^2 \frac{\theta}{\theta x^1} + \frac{\theta}{\theta x^2}$ ). Thus  $R_1 = t^2$ .

It is follow from example 42., that  $F_A = \frac{1}{2} (t^1)^2 t^2 + \frac{1}{24} (t^2)^4$ . Therefore  $F_A^1 = \frac{1}{6} (t^1)^3 t^2 + \frac{1}{24} t^1 (t^2)^4$  and  $F_A^2 = \frac{1}{4} (t^1)^2 (t^2)^2 + \frac{1}{120} (t^2)^5$ .

Thus, we can to  $\ \ \, n = 2$ . A coording to theorem 5.2 it is the tensor series  $\ \ \, P = F_A + \frac{1}{2} \quad 1^A \, (\frac{\theta}{\theta t^i} \frac{\theta}{\theta t^j}) t^i \quad t^j + \quad 1^B \, (\frac{\theta}{\theta s^i} \frac{\theta}{\theta s^j}) s^i \quad s^j + \quad F_A^i t^i \quad s^i + \quad \frac{1}{3} \quad 1^B \, (\frac{\theta}{\theta s^j} \frac{\theta}{\theta s^j} \frac{\theta}{\theta s^j}) s^i \quad s^j \quad s^k \, .$
