# LIOUVILLE AND LOGARITHM IC ACTIONS IN LAPLACIAN GROWTH

#### ALEXANDER VASIL'EV

A bstract. We discuss and construct an action functional (logarithm ic action) for the simply connected Laplacian growth and obtain its variation. This variation admits various interpretations. In particular, we consider a general smooth subordination evolution and give connections with the V irasoro algebra and N eretin polynomials.

#### 1. Introduction

An important quantity in mechanics and the eld theory is the action, a local functional over maps between the space-time and the target space which we assume to be the Euclidean straight line R. For example, one may consider the action given by the D irichlet integral  $\[ \]$ 

$$S[] = jr j^2 dv;$$

where the metric structure of and the volume element dv are to be taken into account as well as certain properties of smoothness of , that give sense to the right-hand side of the above equality. In the classical setup of mechanics this action represents the energy of the system as in nitesimally it is just the scalar product of the eld r and its momentum r dv for the potential . We note that in general, the action is the integral over the classical Lagrangian. If time does not enter explicitly into the Lagrangian, then the system is closed, and a typical example of such a Lagrangian is the kinetic energy minus the potential energy. One may assume dierent smooth functions on T as Lagrangians, however physical or geometrical background of the underlying space forces certain restrictions in the choice. Nevertheless, dierent points of view on the same object can lead to dierent functionals as Lagrangians.

The classical eld theory studies the extrem um of the action functional, and its critical value is called the classical action. The critical point satisfies H am ilton's principle (or the principle of the least action), i.e., S[] = 0, which is the Euler-Lagrange equation for the variational problem defined by the action functional. For the action given by the

D irichlet integral the classical action is achieved for the harm onic and the principle of the least action leads to the Laplacian equation = 0.

The Liouville action plays a key role in two-dimensional gravity. It is based on a Lagrangian given on the base of the Riemannian geometry of the underlying space. Liouville action describes a highly non-trivial dynamics in quantum eld theory and appears in connection with Feynman's path integral that represents the transition amplitude between two quantum states of a system expressed as a sum over contributions from possible classical histories of that system. Complex transition functions appear naturally in the theory of evolution equations. The original formulation of quantum Liouville theory through path integral has been obtained by Polyakov [29] in 1981 where the domain of integration consisted of all smooth conformal metrics ds² on an n-punctured Riemann sphere (n 4 to guarantee the hyperbolicity). A thorough mathematical treatment has been made later by Takhta and Zograf (see [36], [43], [44], [45]).

It is not very surprising that several \quantum features" appear in non-linear problems of hydrodynamics, in particular, in the Laplacian G rowth problem. In 1898 Hele-Shaw [15] proposed his famous cell that was a device for investigating a ow of viscous uid in a narrow gap between two parallel plates.

The dimensionless model of a moving viscous incompressible uid in the Hele-Shaw cell is described by a potential ow with the velocity eld  $V = (V_1; V_2)$ . The pressure p is the potential for the uid velocity

where h is the cell gap and is the viscosity of the uid (see, e.g. [27, 34]).

Given an incompressible advancing uid injected through a point source, the Laplacian growth is formulated as a moving boundary problem for the Laplacian equation for a function p(z;t), supported in a domain (t) C as a function of z,

where t is the time variable and  $_0$  is the D irac distribution supported in 0. The dynamic boundary condition is given by putting

and the kinem atic condition for the motion of the boundary @ (t) is given by the normal velocity as

where n is the outward unit vector to @ (t).

Through the sim ilarity in the governing equations, Hele-Shaw ows can be used to study models of saturated ows in porous media governed by Darcy's law. Over the years various particular cases of such a ow have been considered. Dierent driving mechanisms were employed, such as surface tension or external forces (suction, injection). We mention here a 600-paper bibliography of free and moving boundary problems for Hele-Shaw and Stokes ows since 1898 up to 1998 collected by Gillow and Howison [8].

As it has been shown in [1, 22, 25, 49], the Laplacian growth problem can be embedded into a larger hierarchy of domain variations (W hitham -Toda hierarchy) for which all Richardson's complex moments [33] are treated as independent variables (generalized time variables), and form an integrable system. Finally, the Laplacian growth has been modeled in the moduli space of Riem ann surfaces [21].

In the classical simply connected case of the Laplacian growth without gravity the kinetic energy is given by the Dirichlet integral for the pressure as a potential. However, given the evolution of the phase domain in time as a closed system with a Riemannian metric as the geometrical background, one may construct the action functional based on a dierent Lagrangian. The idea of the construction of the Liouville action gives us a way to derive an action functional for the Laplacian growth. The aim of this paper is to construct the logarithmic action for the Laplacian growth and to obtain its variation. Then we shall study a general smooth subordination and interpret the variation of the logarithmic action through the in nitesimal version of the action of the Virasoro-Bott group on the space of analytic univalent functions.

#### 2. Liouville and logarithmic actions

Following the classical approach by Poicare [28] we consider a compact Riem ann surface S of genus g 2 that adm its uniform ization by a Fuchsian group G acting in the unit disk U, S = U = G. If z is a local analytic coordinate de ned on an open set, then the Riem ann metric  $ds^2$  is represented as  $ds^2 = 2 dz^2$  for a density . A conformal metric corresponds to the invariancy under the change of the local coordinate. If  $z^0$  is another local coordinate de ned in an open set and  $ds^2 = (0)^2 dz^0$  in terms of the local coordinate  $z^0$ , then we have  $dz^0 dz^0$  in the intersection of these sets.

The Gaussian (sectional) curvature { of this metric is calculated by the form ula { =  $\frac{1}{2}$  log . It follows from the uniform ization theorem that there exists a unique conform al metric of Gaussian curvature { = 1 which is called the Poicare (hyperbolic) metric. In terms of the parameter z this is equivalent to the Liouville equation

where  $' = \log^{2}$ . In the sim plest case of the unit disk the Poicare metric is given as

Considering the universal covering of S by the unit disk and the automorphic (with respect to G) projection h:U! S we deduce that

where is taken from the fundam ental polygon U=G. This metric is complete and the area of S in this metric is 4 (g 1) (by the Gauss-Bonnet theorem).

It seems that equation (4) is the Euler-Lagrange equation for the variational problem de ned by the functional

where d  $_z=\frac{dz^{\wedge}dz}{2}$  which may be chosen as the Liouville action. However, the deal is much more dicult, because the integrant (the rst term) does not keep the local 2-form  $j_z f dz^{\wedge} dz$  invariant under the change of the local parameter from chart to chart on the Riemann surface. Thus, the functional (5) is well-de ned only for simply connected domains and the correct Liouville action requires an additional term which has been given by Takhtajan and Teo in [37].

When the underlying Riemann surface have singularities (e.g., punctures, branch points) the action functional is not well defend globally on the surface either. In this case, there are two options to treat the problem. One of them is to change the metric, the other is to make certain regularization. Actually, Poincare [28] worked in the presence of parabolic singularities. In this case some additional terms appear in (5), see [45]. But certainly one may look for equilibrium between these two options.

Let us turn now to the Laplacian growth. As it was said in Introduction, the problem (1{3}) de nes the Laplacian growth. More thoroughly we give a strong formulation of this problem. Let (t) C,02 (t), be a one-parameter family of bounded domains. We call the family f (t)g smooth if @ (t) are smooth (C  $^1$ ) interfaces for each t, and the normal velocity  $v_n$  continuously depends on tat any point of @ (t). Each (t) is supposed to be simply connected for any t2 [0;T) xed. A smooth family (t),0 t < T, as above, is said to be a strong solution for the Laplacian growth if there exists a potential p(z;t), z = (t), such that all conditions (1{3}) are satistic. The family of (t) forms a strong subordination chain of bounded domains:  $\overline{(s)}$  (t) for 0 s < t < T,02 (0).

It is known that if the initial dom ain (0) has an analytic smooth boundary, then the strong solution exists locally in time until the boundary @ (t) develops a cusp in a blow-up time or (t) changes its topology (see, e.g. [16, 32, 46, 48]).

By the Riem ann theorem we construct a conformal time-dependent map z=f(;t) from the unit disk U onto the phase domain (t), f(0;t)=0,  $f^0(0;t)>0$ . The function f(;0) =  $f_0($ ) parameterizes the initial boundary @ (0) =  $f_0(e^i)$ ; 2 [0;2 )g and the moving boundary is parameterized by @ (t) =  $f_0(e^i)$ ; 2 [0;2 )g. We use the notations  $f_0=0$  @  $f_0(e^i)$ .

Let us consider the complex potential W (z;t), ReW = p. For each xed tit is a multivalued analytic function de ned in (t) whose real part solves the D irichlet problem (1{2}). M aking use of the C auchy-R iem ann conditions we deduce that

The velocity eld ( r p) is the conjugation of ( W  $^{0}$ ). In other words the velocity eld is directed along the trajectories of the quadratic di erential in the left-hand side of (7) for each xed moment t. The equality (7) in plies that the boundary @ (t) is the orthogonal trajectory of the di erential (W  $^{0}(z;t) dz)^{2}$  with a double pole at the origin. The dependence on tyields that the trajectory structure of this di erential changes in time, and in general, the stream lines are not inherited in time. These lines are geodesic in the conformalmetric  $\psi$   $^{0}(z;t)$  jidz jeenerated by this di erential.

Observe that being thought of as a Riemann surface, the phase domain (t) n f0g is hyperbolic and it adm its the Poincare metric with constant negative curvature

The asymptotics about the origin and close to the hyperbolic boundary implies that the standard expression (5) for the Liouville action can not be used any more. Moreover,

the action integral for the hyperbolic metric in the punctured unit disk has the following asymptotics

where  $U_{n} = fz : "_{1} < jzj < 1 "_{2}g$ . Therefore, the corresponding integral for (t) n f0g will have a sim ilar asymptotics plus terms containing  $f^{0}(0;t)$  and the boundary distortion (in our case the boundary derivatives) at the unit circle that makes it discult to operate with.

Let us use the at logarithm ic metric instead generated by (7) which seems to be more natural for the Laplacian growth

The hyperbolic boundary is not singular for this metric whereas the origin is. But it is a parabolic singularity which can be easily regularized.

The density of this metric satis es the usual Laplacian equation ' $_{zz}=0$  in (t) n f0g, where '(z) =  $\log \frac{j^{z}}{j^{z}} \frac{1^{0}j^{z}}{j^{z}}$ . Obviously, the Laplacian equation is the Euler-Lagrange equation for the variational problem dened by the D irichlet integral

locally for any m easurable set D  $\,$  (t) n f0g. However, this functional cannot be de ned globally in  $\,$  (t) n f0g because of the parabolic singularity at the origin. To overcom e this obstacle we de ne the classical action in the following way. distribution supported at the origin, where is taken from the class of twice dierentiable functions in (t) n f0g with the asymptotics  $\log jzj^2$  as z! 0.

The functional (11) resembles the universal Liouville action de ned by Takhtajan and Teo in [38, 39] for quasicircles which is based on conformal maps from the unit disk and from its exterior.

O beerve that the classical kinetic energy E for the harm onic potential p is calculated by the D irichlet integral 7

The latter expression allows us to think of E as a capacity which exactly corresponds to the physical sense of E as m in imal energy.

### 3. Variation of the logarithmic action

The Laplacian growth problem (1{3) being rewritten for the parametric time dependent function f:U! (t) admits the form of the so-called Polubarinova-Galina equation, which is in principle, a reformulation of the kinematic condition (see, e.g., [16, 46]). Namely, the function f(;t) satisfies the non-linear rst-order partial differential equation

O beserve that a piece-wise smooth closed Jordan curve is a quasicircle if and only if it has no cusps. So any function f from A has a quasiconformal extension to U. By this realization the manifold M is naturally embedded into the universal Teichmuller space T. However, de ned as a complex Banach manifold the Teichmuller space T requires additional Hilbert manifold structure to assure the embedding M! T to inherit the Kahlerian structure of M. This has been done by Takhtajan and Teo in [38]{ [40]. The Kahlerian structure on M corresponds to the Kahlerian structure on T given by the analogue of the Weil-Petersson metric.

# 5. Semigroups of conformal maps

The basic ideas that we use in this section come from the development of Lowner's parametric method that emerges at a seminal Lowner's paper [24]. Lowner was rst who proposed to use Lie semigroups of conformal maps to obtain an evolution equation for conformal maps. His ideas have been furthered by many authors among whom we mention Pommerenke [30, 31] as a general reference, and Goryainov's works [10, 11] especially closed to our consideration, one also may see [35, 47].

We consider the sem igroup G of conform alunivalent maps from U into itself with composition as the sem igroup operation. This makes G a topological sem igroup with respect to the topology of local uniform convergence on U. where means the natural projection D i  $S^1$ ! M. This form appeared in [2, 3] in the context of the construction of a unitarizing probability measure for the Neretin representation of M. It is invariant under the left action of  $S^1$ . If f 2 A represents g and 2 Vect  $S^1$ , then the value of the form on the vector is

In this formula, we take into account the stoce cient, the conformal radius of the Laplacian evolution, that does not change the form .

#### 8. Some open questions

- (i) One may conjecture that the formula (22) remains true for general smooth subordination evolution.
- (ii) The logarithm ic action is clearly related to the universal Liouville action suggested by Takhtajan and Teo in [38, 39, 40]. There must be possible to obtain the variation given in Theorem 1 by means of the variation of the universal Liouville action obtained in [39]. This would be yet more interesting because the universal Liouville action is defined for contours without any smoothness hypothesis.
- (iii) A nother interesting question is whether it is possible to make regularization of the proper Liouville action integral based on the Poincare metric by the boundary distortion by a univalent function.
- (iv) A deeper task is concerned with the Laplacian growth and its embedding into the W hitham -Toda hierarchy. The extended Toda hierarchy (see [6]) adm its a non-abelian algebra of in nitesim alsymmetries isomorphic to half of the V irasoro algebra [7]. It would be interesting to reveal the connections between the Ham iltonian approach through the Toda hierarchies and the action approach suggested in the present paper.
- (v) The multiply connected Laplacian growth is a natural way of generalization of all these results.
