# R elations betw een P otts and R SO S m odels on a torus

#### Abstract

W e study the relationship betw een $Q$-state Potts m odels and staggered R SO S m odels of the $A_{p} 1$ type on a torus, $w$ ith $Q^{1=2}=2 \cos (=p)$. In general the partition functions of these $m$ odels di er due to clusters of non-trivial topology. H ow ever we nd exact identities, valid for any tem perature and any nite size of the torus, between various modi ed partition functions in the two pictures. $T$ he eld theoretic interpretation of these $m$ odi ed partition function is discussed.

## I. INTRODUCTION

The two-dim ensionalP otts $m$ ode. can be de ned in term $s$ of integer valued spins $S_{i}=1 ; 2 ;::: \%$ living on the vertices fig of a lattice. Its partition iunction reads

where is the $K$ ronecker delta and hiji are the lattioe edges. In this paper we take the lattice to be an $\mathrm{L} \quad \mathrm{N}$ square lattice (say, of verticalw idth L and horizontal length N ) w ith toroidalboundary conditions (i.e., periodic boundary conditions in both lattice directions). W e denote $V=L N$ the num ber of vertioes of the lattioe and $E=2 L N$ the num ber of edges.
$T$ his initial de nition can be extended to arbitrary real values of $Q$ by $m$ eans of a cluster expansion O ne nds

where $v=e^{K} \quad$ 1. Here, the sum is over the 2 possible colourings $C$ of the lattice edges (each edge being either coloured or uncoloured), e(C) is the num ber of coloured edges, and $c(C)$ is the num ber of connected com ponents (chusters) form ed by the coloured edges. For $Q$ a positive integer one has $Z_{\text {sp in }}=Z_{\text {cluster }}$.

Yet another form ulation is possible when $Q^{1=2}=q+q^{1}$ and $q$ is a root of unity

this tim $e$ in tem $s$ of a restricted height $m$ odel with face interactions henceforth referred to as the R SO S m odel. T his form ulation is m ost easily described in an algebraic way. I ne Potts $m$ odeltransfer $m$ atrix $T$ that $d s$ one colum $n$ of the square lattice can be written in tem $s$ of the generators $e_{j}$ of the $T e m$ perley-Lieb algebra as follow s

$H$ ere, $H_{i}$ and $V_{i}$ are operators adding respectively horizontal and vertical edges to the lattice, $I_{j}$ is the identity operator acting at site $j$, and the param eter $x=Q^{1=2} v=Q^{1=2}\left(e^{K} \quad 1\right)$. The generators satisfy the well-known algebraic relations

M ore precisely. V. can be thought of as adding a face to the lattice, surrounded by tw o direct and tw o dual vertices, as show $n$ in $F$ io $\quad H_{i}$ is sim ilarly de ned, by exchanging direct and dual sites on the gure.


F IG . 1: G raphical rendering of $V_{i}=I_{2 i}+x e_{2 i}$. D irect (resp. dual) vertices are shown as full (resp. em pty) circles. C oloured edges (direct and dual) in the cluster picture are depicted as thick blue lines. T heir surrounding cluster boundaries are given as thin red lines. R SO S heights $h_{j}$ are de ned on both direct and dualvertices as show $n$. The action of $I_{2 i}$ (resp. $e_{2 i}$ ) is illustrated on the left (resp. right) part of the gure. O ur convention is that the transfer $m$ atrix acts tow ards the right.
$M$ eanw hile, the operators $I_{j}$ and $e_{j}$ can be represented in various ways, thus giving rise to di erent transferm atrioes. $W$ hen $Q$ is a positive integer, a spin representation of dim ension $Q^{L}$ can be de ned in an obvious way, and one has

For any malo a. cluster representatior ofdim ension $C_{L}=\frac{(2 L)!}{(L+1)!L!}$ can be de ned by letting $I_{j}$ and $e_{j}$ act on the boundarie: that separate direct and dual clusters, represented as thin red lines in $F$ id But it is im possible to w rite $\mathrm{Z}_{\text {cluster }}$ as a trace of $\mathrm{T}_{\text {cluster }}$ de ned in this w ay. T his is due to the existence of loops or chuster boundaries are non contractible w ith respect to the periodic boundary conditions in the horizontal direction of the lattior For this reason, we shall not discuss $T_{\text {cluster }} m$ uch further in this paper, but wem aintain $E q$. as the de nition of $Z_{\text {cluster }}$ for realQ.

Finally, when $Q$ is given by Eq. the R © odel is introduced by letting $I_{j}$ and $e_{j}$ act on heights $h_{j}=$ $1 ; 2 ;::: ; \mathrm{p} 1$ de ned on direct and dualvertice: A pair of neighbouring direct and dual heights are constrained to di er by 1 . In this representation we have

where $S_{h}=\sin (h=p)$. $N$ ote that the clusters (direct and dual) are still $m$ eaningful as they are surfaces of constant height. The constants $S_{h}$ are actually the com ponents of the $P$ erron $F$ robenius eigenvector of the incidence $m$ atrix (of size p 1)
of the D ynkin diagram $m$ atrix $\mathrm{T}_{\text {Ros }}$ by Eq. con gurations.

In this paper we discuss the relations between $Z_{R s o s}$ and $Z_{\text {cluster, }}$ w ith $Q^{1=2}=2 \cos (=p) \mathrm{cf}$. Eq. . These partition functions are in general di erent, dun to clusters of non-trivialtopology w rapping around the torus.
$W$ e start by show ing num erically, in section that for $Q=3$ the transfer $m$ atrices $T_{\text {sp in }}$ and $T_{R ~ s o s}$ have nonetheless $m$ any identical eigenvalues. De ning vamous sectors ( $m$ otivated by duality and parity considerations) and also tw isting the periodic boundary conditions in di erent ways, we are able to con jecture several relations betw een the corresponding transferm atrix spectra.
$W$ ith this num ericalm otivation we then go on, in sectio to prove these relations on the level of the RSO S and cluster m odel partition functions on nite $L \quad N$ tori. Som e or the relations are specic to $Q=2(p=4)$ and $Q=3$ ( $p=6$ ), and som e hold for general values of $p$. All of them hold for arbitrary values of the tem perature variable $x$. W e stress that in all cases the proofe ambased on rigorous com binatorial considerations.

W e conclude the paper, in sectiol by interpreting our results, and the various partition functions introduced, on the level of conform al eld theory, at the selfdual tem perature $x=1$ where the P otts m odel is at a critical point.

TABLE I: Spectra of various transfer $m$ atrices $w i t h Q=3$, subject to periodic (I) or di erent tw isted periodic ( $Z_{2}$ and $Z_{3}$ ) boundary conditions, as de ned in the text. The rst colum n gives the free energies $f_{i}=L^{1} \log (i)$, here for $w$ idth $L=2$ and tem perature variable $x=5$. Subsequent colum ns give the $m$ ultiplicity of each $f_{i}$.

## II. TRANSFER MATRIX SPECTRA

$T$ he spectra of the transfer $m$ atrioes $T_{\text {sp in }}$ and $T_{R ~ s o ~}$ are easily studied num erically by exact diagonalisation techniques. D enoting the eigenvalues as $\quad$, $w$ th $i=1 ; 2 ;::: ;$ dim ( $T$ ), the results are $m$ ost conveniently stated in term s of the corresponding free energies por opin, $f_{i}=\quad L^{1} \log (i)$. Sam ple results for $Q=3$, $w$ idth $L=2$, and tem perature variable $\mathrm{x}=5$ are show n in Tab ]

D ue to the rules of the R SO S m odel, the heights living on the direct and dual lattices have opposite parities. The transfer $m$ atrix can therefore be decom posed in two sectors, $T_{R S O S}=T_{R S O}$ even $T_{R S O}^{\text {odd }}$, henceforth referred to as even and $00^{1-1}$ Th the even sector, direct heights take odd values and dual heights even values (and vice versa for the odd sector) R esults w ith stand 7 m (i.e., untw isted) periodic boundary conditions in the verticaldirection are given in the collum ns labeled I in Tabl

In the spin representation $I_{\text {spin }}(x)$ has been de ned above (recall that $x=Q^{1=2}\left(e^{K} \quad 1\right)$ ). W e also introduce a related transfer $m$ atrix

 $x_{\text {dual }}=x^{1}$ explains the term inology. M ore precisely, on a planar lattice one has the fundam ental duality relation

where $Z \mathrm{~m}$ ust be evaluated on the dual laHice. For a square lattice with toroidalboundary conditions, the dual and direct lattices are isom_nphic, but Eq. breaks down because ofe ects of non-planarity.

Referring to $T a b l$ we observe that the leading eigenvalues of the four transfer $m$ atrioes introduced this far (i.e., $T_{R S O}^{\text {even }}, T_{R S O S}^{\text {odd }}, T_{\text {spin }}$ and $T_{\text {spin }}^{\text {dual }}$ ) all coincide. On the other hand, for any two $T$ chosen am ong these four, som $e$ of the sub-leading eigenvalues coincide, whilst others are di erent. So the discrepancy betw een the four corresponding partition functions appears to be a boundary e ect which vanishes in lim it N! 1. H ow ever, when taking di erences of the $m$ ultiplicities we discover a surprising relation:

$N$ ote that the leading eigenvalues cancel on both sides of this relation.

At the selfdual point $x=1$, we nd that the spectra of $T_{R ~ R O S}^{\text {even }}$ and $T_{R S O}^{\text {odd } S \text { coincide com pletely, as do those of } T_{\text {sp }} \text { in }}$ and $T_{\text {spin }}^{\text {dual }}$. In particular, both sides of Eq , vanish. It is how ever still true that subleading eigenvalues of $\mathrm{T}_{\mathrm{R}}$ even S and $\mathrm{T}_{\mathrm{sp} \text { in }}$ di er.
$M$ ore relations can be discovered by introducing tw isted periodic boundary conditions in the transferm atrioes. For the R SO S m odel this can be done by tw isting the heights, $h!n, h$, hen traversing a horizontal seam. N ote that this transform ation $m$ akes sense at it leaves the weights of Eq , invariant, since $S_{h}=S_{p} h$. The shape of the seam can be deform ed locally w ithout changing the corresponding partition function; we can thus state m ore correctly that the seam $m$ ust be hom otopic to the horizontalprincipalcycle of the torus. $N$ ote also that the tw ist is only well de ned for even $p$ (and in particular for $Q=3, p=6$ ), since the heights on the direct and dual lattice m ust have xed and opposite parities in order to satisfy the RSOS constraint. In Tabl this tw ist is labeled $Z_{2}$, since it am ounts to exploiting the $Z_{2}$ sym $m$ etry of the underlying $D$ ynkin diagram $A_{p} 1 . C$ om paring again $m$ ultiplicities we discover a second relation

The relations and are snocial cases of relations that hold far $2 l l \mathrm{x}, \mathrm{L}$ and N , and for all even p . The
general relations (see Eqs, and are stated and proved in sectiol pelow.
In the particular case oI $Q=3$ one can de ne two di erent ways of twisting the spin representation, which $w$ ill lead to further relations. The rst type of tw ist shall be referred to as a $Z_{2}$ tw ist, and consist in interchanging spin states $S_{i}=1$ and $S_{i}=2$ across a horizontal seam, whereas the spin state $S_{i}=3$ transform $s$ trivially. The second type of tw ist, the $Z_{3}$ tw ist, consists in perm uting the three spin statمc fyclically when traversing a horizontal seam. $T$ he spectra of the corresponding transfer $m$ atrices are given in $T a b l$
$T$ his leads to another relation betw een the spectra in the spin representation (stated here in term $s$ of the corresponding partition functions)

III. RELATIONS BETW EEN PARTITION FUNCTIONS
A. W eights in the cluster and R SO S pictures

A possible con guration ofchusters on a 6 torus is shown in F if It can be thought of as a random tessellation using the tw o tiles of F io For sim plicity wo show here only the clusters (direct or dual) and not their separating boundaries (given by the ennin red lines in F is T wo clusters having a com m on boundary are said to be neighbouring. For convenience in visualising the periodic boundary conditions the thick lines depicting the chusters have been draw $n$ using di erent colours (apart from clusters consisting of just one isolated vertex, which are allblack).

To com pute the contribution of this con guration to $Z$ cluster $(x)$, each direct cluster is weighed by a factor of $Q$, and each coloured direct edge carries a factor of $v=Q^{1=2} x$. N ote in particular that the cluster representation does not distinguish clusters of non-trivial topology (i.e., chusters which are not hom otopic to a point). In the follow ing we shall call such clusters non-trivial; clusters which are hom otopic to a point are then referred to as trivial.

The contribution of this sam e con guration to $Z_{\text {Rsos }}$ consists of

1. a global factor of $Q^{V=2}$ com ing from the prefactor of Eq .
2. a factor of $x$ for each coloured direct edge and
3. an $x$-independent factor due to the topology of the (direct and dual) chusters
$T$ he interest is clearly concentrated on this latter, topological factor which we denote $w$ in the follow ing. For a given cluster con guration its value can be com puted from thadjacency inform ation of the clusterc $T$ his inform ation is conveninttly expressed in the form of a P asquier graph for the cluster con guration of $F$ ig his graph is show $n$ in F id


FIG. 2: A possible cluster con guration on a $6 \quad 6$ torus. D irect and dual vertices are shown as lled and em pty black circles. C lusters (direct or dual), other than isolated vertices, are depicted here using distinct colours, for conven ience in appreciating the periodic boundary conditions. T here are six direct clusters and four dual clusters. O ne direct cluster and one dual cluster are non-hom otopic to a point.

The rules for draw ing the $P$ asquier graph in the general case are as follow $s$. E ach cluster is represented by a vertex, and vertices representing neighbouring clusters (ie., clusters having a com mon boundary) are jined by a directed edge. A $n$ edge directed from vertex A to vertex B m eans that the com $m$ on boundary is surrounding chuster A and is surrounded by cluster B. In particular, the in-degree $b_{i n}$ of a cluster is the num ber of boundaries surrounded by that cluster, and the out-degree bout is the num ber of boundaries surrounding the chister. By de nition, a boundary separating a non-trivial chuster from a trivial one is said to be surrounded by the non-trivialcluster; note that there is necessarily at least one non-trivial cluster. W e do not assign any orientation to edges joining tw o non-trivial chusters, since in that case the notion of surrounding is nonsensical.

T he topological structure of the $P$ asquier graph is characterised by the follow ing three properties:

1. T he graph is bicolourable, w ith one colpur (represented by led circles in F ig corresponding to direct clusters and the other (em pty circles in F io to dual clusters.
2. T he vertiges corresponding to non-trivial chusters and the undirected edges form a cycle.
3. E ach vertex corresponding to a non-trivialcluster is the root ofa (possible em pty) tree, whose vertices correspond to trivial clusters. T he edges in the tree are directed tow ards the root.

P roperty 3 is easily proved by noticing that vertices corresponding to trivial clusters have all bout $=1$, i.e., such clusters have a unique extemalboundary. Regarding property 2 , we shall de ne the order $n$ of the $P$ asquier graph as the num ber of undirected edges. By property 1 , $n$ is even. W hen $n=0$ we shall call the graph degenerate; this corresponds to a situation in which a single chuster (direct or dual) is non-trivial.

In the RSO S picture, each con guration of the clusters (such as the one on F ig corresponds to $m$ any di erent height con gurations. T he topological ( $x$-independent) contribution to the weight or a cluster con guration in $Z \mathrm{R}$ so s is therefore obtained by sum $m$ ing weights in thos Som odel with $\mathrm{x}=1$ over all height con gurations which are com patible w ith the given cluster con guration This contribution can be com puted from the Pasquier graph by using the incidence $m$ atrix $G_{p} 1$ of the $D$ ynkin alagram $A_{p} 1$, as we now review.

Let w be the weight of a given $P$ asquier graph, and let $w^{0}$ be the w eight of the graph in which a leafof one of its trees (as well as its adjacent outgoing edge) has been rem oved. M ore precisely, w is the weight of a cluster con guration w ith given heights on each cluster, and $\mathrm{w}^{0}$ is the partial sum of such w eights over all possible heights of the leafchuster. Let $j$ be the height of the leaf, and let ibe the height of its parent. Then

where in the rst equality we used that the weight of a cluster at height $h$ is $S_{h}^{b_{o u t}} b_{\text {in }} \quad$ and in the second that $f S_{j} g$ is an eigenvector of $\mathrm{G}_{\mathrm{p}} 1 \mathrm{~W}$ ith eigenvahe $Q^{1=2}$. Iterating the argum ent until all the trees of the $P$ asquier graph have been rem oved, we conclude that each trivial cluster carries the weight $Q^{1=2}$.

W e have then

$w$ here $w_{c}$ is the weight of the cycle of the P asquier graph. It corresponds to the num ber of closed paths of length $n$ on the Dynkin diagram

N ote that, in contrast to the case of trivial chusters, all the eigenvalues contribute to the com bined weight $w_{c}$ of the non-trivialclusters, and that this weight cannot in generalbe interpreted as a mmduct of individual chister weights. (W e also rem ark that it is not a prioriobvious that the right-hand side of Eq. is an integer.)

## B. C oincidence of $h$ ighest eigenvalues

As an application we now argue that the dom inant eigenvalues of the transfer $m$ atrices $T_{R S O}, T_{\text {cluster }}, T_{\text {sp in }}$ coincide for any width L. We suppose $\mathrm{x}>0$ so that all weights are positive; this guarantees in particular that standard probabilistic argum ents apply.
$C$ onsider rst $T_{\text {cluster }}$ and $T_{\text {sp in }}$, supposing $Q$ a positive integer. Since the system is quasi one-dim ensional, w ith $L \quad N$, con gurations having clusters of linear extent $m$ uch larger than $L$ are exceedingly rare and can be neglected. In particular, alm ost surely no clusterw illw rap around the system in the horizontaldirection. W riting $Z_{\text {cluster }}(\mathrm{c})^{\mathrm{N}}$ and $Z_{\text {sp in }}(s)^{\mathrm{N}}$, the choige ofboundary conditions in the horizontaldirection w ill thus have no e ect on the va of $c$ and $s$. We therefore sw itch to free boundary conditions in the horizontal direction. Then it is possible to $w$ rite $Z_{\text {cluster }}=h f j\left(T_{\text {cluster }}\right)^{N}$ ̈i for suitable initial and nal vectors $\ddot{j} i$ and $\mathrm{hf} j$. It is not di cult to see, using the P erron $\mp$ robenius theorem, that these vectors both contain a non-vanishing com ponent of the dom inant eigenvector of $\mathrm{T}_{\text {cluster }}$. W e conclude that c m ust be the dom inant eigenvalue of $\mathrm{T}_{\text {cluster }}$. Likew ise, s is the dom inant eigenvalue of $\mathrm{T}_{\text {sp in }}$. T he conclusion follow sby noting that $Z_{\text {cluster }}=Z_{\text {sp in }}$ by construction,
$W$ e now tum to $T_{R \text { so }}$ and $T_{\text {cluster, }}$ supposing $Q^{1=2}=2 \cos (=p)$, cf. E $q$. A s before we im pose free horizontal boundary conditions on the chuster $m$ odel. $T$ hen, since the resulting lattice $r$, we recall that $Z_{\text {cluster }}$ can be w ritten as well in term s of the boundaries separating direct and dual chisters:

It follow $s$ that also in the RSO $S$ picture each -hinster boundary carries the weight $Q^{1=2}$, regardless of its hom otopy. I he conclusion follow $s$.

In section ve have introduced the decom position of the R SO S m odel into even and odd subsectors. In the even sector, heignts on direct (resp. dual) clusters are odd (resp. even) Th particular, we have $Z_{R S O S}=Z_{R S O S}^{\text {even }}+Z_{R S O S}^{\text {odd }}$. $N$ ote that since that the largest and sm allest eigenvalue in Eq. di er just by a sign change, we have the slightly $m$ ore precise statem ent for $N$ ! 1 :

This im plies Eq. upon noticing that the factors of $x$ correct the weighing of the colnimed direct edges (we have used that the amm of direct and dual coloured edges equals E ).

Subtracting Eq, from the relation obtained from Eq. under x ! $\mathrm{x}{ }^{1}$ gives a duallity relation for $\mathrm{Z}_{\mathrm{RSO}}^{\text {even }} \mathrm{S}$ $\mathrm{Z}_{\text {RSO }}^{\text {odd }}$ :

To prove Eq. we proceed by induction. Initially, when $C$ is the state $w$ ith no coloured direct edge, we have $l(C)=c(C)=V$ and $e(C)=0$, whence the second of the relations indeed holds true. A ny other con guration $C$ can be obtained from the initial one by successively colouring direct edges (and uncolouring the corresponding dualedges). W hen colouring a further direct edge, there are several possibilities:

1. The edge joins two clusters which were form erly distinct. The changes in the param eters of $E q$. are then
$l=1$ (the outer boundaries of the tw o clusters join to form the outer boundary ofthe am algam ated chuster),
$c=1$ and $e=1 . T h u s$, the changes to the left-and right-hand sides of Eq. cancelout.
2. The edge joins tw o vertices which w ere already in the sam e chister. Then $l=1$ (the operation creates a crucle in the cluster which $m$ ust then acquire an inner boundary), $c=0$ and $e=1$. This again $m$ aintains Eq. $T$ he sam e changes are valid when the added edge $m$ akes the cluster w rap around the rst of the two pemodic directions: no inner boundary is created in this case, but the chuster's outer boundary breaks into two disjoint pieces.
3. The edge $m$ akes, for the rst tim $e$, the cluster $w$ rap around both periodic directions. $T$ hen $l=1$ (the two nuter boundaries coalesce), $c=0$ and $e=1$. Thus one jum ps from the second to the rst of the relations

W e conclude that on a torus, Eq. m ust be replaced by

W e now prove Eq by show ing the each cluster con guration gives equalcontributions to the left-and the righthand sides. W hen evalluating the second term on the richt-hand side we consider instead the shifted con guration. $T$ his ensures that the contribution to allterm sin Eq yields the sam e pow er ofx; w e therefore only the topological weight w (cf. Eq. in the follow ing argum ent.

The contribution of non-degenerate $P$ asquier graphs to the left-hand side of Eq . is zero by Eq . and the discussion preceding it. The contribution of such graphs to the right-hand side also vanishes, since thoprginal and shifted con gurations have the sam e num ber of cluster boundaries $l$, and in both cases $=0$ in Eq
$C$ onsider next the contribution of a degenerate $P$ asquier graph w bom the non-trivial chister is direct. I he contribu-
 note that for the rst term, $Z_{\text {cluster }}(X)$, we have $=1$ in $\mathrm{Eq} \quad$ whereas for the second term, $\mathrm{x}^{\mathrm{E}} \mathrm{Z}_{\text {cluster }}\left(\mathrm{x}{ }^{1}\right.$ ) use the shifted con guration as announced, whence $=0$. T ne total contribution to the right-hand side of Eq. is then $Q^{l=2+1} \quad Q^{l=2}$ as required.

N ote that while Eq.

E. Topology of the non-trivial clusters

In the follow ing sections we consider tw isted $m$ odels, and it is necessary to be $m$ ore careful conceming the topology of the non-trivial clusters.

C onsider rst the non-degenerate case, $n \notin 0$. Each of the boundaries separating tw o non-trivial clusters takes the form of a non-trivial, non-self intersecting loop on the torus. A ssign to each of these loops an arbitrary orientation. $T$ he hom otopy class of an oriented loop is then characterised by a pair of integers ( $i_{1} ; i_{2}$ ), where $i_{1}$ (resp. $i_{2}$ ) indicates how $m$ any tim es the horizontal (resp. vertical) prin ${ }^{-1}$ cycle of the torus is crossed in the positive direction upon traversing the oriented loop once. W e recall a result stating that 1) $\ddot{\mu}_{1} j$ and $\ddot{\mu}_{2} j$ are coprim e (in particular they have opposite parities), and 2) the relative orientations of the non-trivial loops de ned by a given cluster con guration can be chosen so that all the loops have the sam e ( $i_{1} ; i_{2}$ ). Further, by a global choice of orientations, we can suppose that $i_{1} \quad 0$. The sign of $i$ is then changed by taking an appropriate $m$ irror $i m$ age of the con guration; since th is does not a ect the weights in the cluster and RSO S m odels we shall henœforth suppose that $i_{2} \quad 0$ as well.

By an abuse of language, we shall de ne the hom otopy class of the non-trivial clusters by the sam e indices ( $i_{1} ; i_{2}$ ) that characterise the non-trivial loops. For exam ple, clusters percolating only horizontally correspond to hom otopy class $(1 ; 0)$, and clusters percolating only vertically correspond to class $(0 ; 1)$. N ote that there are $m$ ore com plicated clusters which have both $i_{1}>0$ and $i_{2}>0$, and that if one of the indioes is 2 the other $m$ ust be 1 .
$F$ inally, in the degenerate case $n=0$, all the loops surrounded by the non-trivial cluster are actually trivial. The hom otopy class of the cluster is then de ned to be $\left(i_{1} ; i_{2}\right)=(0 ; 0)$.
F. Tw isted R SO S m odel

For even $p$, the RSOS m odel can be tw isted by im posing the identi cation $h!p \quad h$ upon crossing a horizontal seam, as already explained before E q $W$ e refer to this as $Z_{2}$ type tw isted boundary conditions.
Those new boundary conditions change the weights of the $P$ asquier graphs. The trivial chusters still have weight $Q^{1=2}$ (the seam can be locally deform ed so as to avoid traversing these clusters), whereas the weight of the cycle $\mathrm{w}_{\mathrm{c}}$ is m odied.

C onsider rst the non-degenerate case $n \in 0$. If a non-trivial cluster has $i_{2}$ odd (where $i_{2}$ corresponds to the direction penpendicular to the seam) its height $h$ is xed by $h=p \quad h$, whence $h=p=2$. But since $n \quad 2$, there $m$ ust be both a direct and a dual cluster w rapping in this way, and since their heights have opposite parities they cannot both equalp=2. So such a con guration is incom patible $w$ th the $Z_{2}$ boundary conditions.

Suppose instead that $n>0$ clusters (i.e., necessarily $n=2$ direct and $n=2$ dual) have $i_{2}$ even. The weight $w_{c}$ is no longer given by Eq. but rather by

These are of the form $\dot{j}_{k} i=f \sin (k h=p) g_{h=1 ; 2 ;:: ; p 1}$. The corresponding eigenvalues of $\mathrm{g}_{\mathrm{p}} 1$ read $k=2 \cos (k=p)$ for $k=1 ; 2 ;::: ; p$ 1. Since the eigenvectors $w$ ith $k$ odd (resp. even) are sym $m$ etric ( antisym $m$ etric) under the transform ation $h!p h$, the eigenvalues of $\Phi_{1}$ are ( 1$)^{k+1} . W$ e conclude that Eq m ust be replaced by

reasons as in Eq but $w$ th $w_{c}^{Z_{2}}$ now given by Eq $F$ inally, for $n=0$ one nds for a direct non-trivial cluster

G. H ighest eigenvalue of the tw isted R SO S m odel
$W$ e now argue that the dom inant eigenvalue of $T_{R S O S}^{Z_{2}}(x)$ coincides $w$ ith a subdom inant eigenvalue of $T_{R ~ s o ~}(x)$ for any width $L$. W e consider rst the case of $p=2$ odd.

T he con gurations contributing to $Z_{R S O S}^{Z_{2}}(x)$ are those in which non-trivialchusters have in even, which includes in particular the degenerate case (the non-trivial cluster being direct or dualdepending on the parity considered). In the lim it where L $N$, the typical con gurations correspond therefore to degenomte con gurations, w ith the non-trivial cluster being direct in the even sector and dual in the odd sector, see Eq. Because of these parity e ects, the dom inant eigenvalues are not the sam e for both parities (except of course 1or X $=1$ ).

For such degenerate con gurations, the weights corresponding to the tw isted and untw ictod m odels are di erent, but since the di erence $w_{c}^{e v e n} \quad w_{C}^{\text {odd }}$ is the sam e independently of the tw ist, we have Eq. . Since the dom inant eigenvalues do not cancel from the right-hand side of that relation, they also contribute to the efthand side.
$W$ e can therefore $w$ rite, in each parity sector, $Z_{R S O S}(x) \quad Z_{R S O S}^{Z_{2}}(x)+Z_{R S O S}^{0}(x)$, where $Z_{R S O S}^{0}(x)$ accounts for con gurations in which no cluster percolates horizontally (there will therefore be at least one, and in fact alm ost surely $m$ any, clustens percolating vertically). If this had been an exact identity, we could resolve on eigenvalues of the corresponding transferm atriges and conclude that the eigenvalues of $T_{R S O S}^{Z_{2}}$ ( $x$ ) form a proper subset of the eigenvalues of $T_{R S O S}(x)$. While it is indeed true that the leading eigenvalue of $T_{R S O S}^{Z_{2}}(x)$ belongs to the spectrum of $T_{R S O}(x)$ (see $T a b 1$ or a num erical check), this inclusion is not necessarily true for subdom inant eigenvalues of $T_{R}^{2} Z_{2}(x)$.

Finally note that the leading eigenvalue of $\mathrm{T}_{\mathrm{RSOS}}^{Z_{2}}\left(\mathrm{x}\right.$ ) coincides w ith a subdom inant eigenvalue of $\mathrm{T}_{\mathrm{R}}$ sos $(\mathrm{x}$ ), as $Z_{\text {RSO S }}^{0}(x)$ dom inates $Z_{\text {R SO S }}^{Z_{2}}(x)$.

In the case where $p=2$ is even, the di erence $w_{c}^{e v e n ~} \quad w_{c}^{\text {odd }}$ is the opposite betw een the tw isted and untw isted $m$ odels. $T$ herefore, the conclusion is unchanged, except that the leading eigenvalue of $\mathrm{T}_{\mathrm{R} ~ \mathrm{SO}}^{\mathrm{S}} \mathrm{S}$ ( Z ( ) coincides w ith a subdom inant eigenvalue of $T_{R S O}^{o d d}(x)$, and the leading eigenvalue of $T_{R S O}^{o d d} \mathrm{Z}_{2}(x)$ coincides $w$ ith a subdom inant eigenvalue of $T_{R S O}$ even $(x)$.

> H. T w isted cluster m odel
$W$ e want to extend the partition functions $Z_{s p i n}^{Z_{2}}(x)$ and $Z_{s p i n}^{Z_{3}}(x)$, considered in sectior by tw isting the spin representation for $Q=3$, to aroitrary values of $Q$. W ithin the cluster representation we introauce a horizontal seam . $W$ e de ne $Z \underset{\text { cluster }}{Q_{0}=1}(x)$ by giving a weight 1 to the non-trivialdirect clusters $w$ ith $i_{2}$ odd and to degenerate cycles $w$ ith
 giving a weight 0 to the non-trivialdirect clusters w ith $i_{2}$ coprim e w ith 3 and to degenerate cycles w ith a direct cluster percolating, while other direct clusters continue to have the weight $Q . Z_{c l u s t e r}^{Q}=1(x)$ and $Z_{c l u}^{Q}=0$ ( $x$ ) are extensions to arbitrary real values of $Q$ of, respectively, $Z_{\text {sp in }}^{Z_{2}}(x)$ and $Z_{\text {sp in }}^{Z_{3}}(x)$.
$W$ e have the follow ing duality relation for the $Q_{0}=1 \mathrm{~m}$ odel:

Indeed, for $Q_{0}=1$, the weight of a degenerate cycle is alw ays 1 , the cluster percolating being direct or dual. $T$ hat is the reason $w$ hy this equality is true, whemeas it $w$ as false for the untw isted $m$ odelbecause of the degenerate $P$ asquier graphs. For $Q=3$, one retrieves $E q$

For the $Q_{0}=0 \mathrm{~m}$ odel, there is a duality relation of the form :

Indeed, the tw o sides are non-zero only because of the degenerate $P$ asquier graphs, so the mbation follow sby com paring weight of cycles in the tw isted and untw isted models. C om bining this equation $w$ ith E q. enables us to relate the $Q_{0}=0 \mathrm{tw}$ isted cluster m odel to the R SO S m odel:

For $Q=3$, this reduces to Eq . as it should.
N ote that these equations are correct because of the weight $Q_{0}$ chosen for degenerate cycles with a direct chuster percolating, so the partition functions of other m odels, w th the sam $e$ value of $Q_{0}$ but di erents weights for other con gurations, would verify the sam e equations.

## I. The Ising case

Let us now discuss in $m$ ore detail the Ising case, $Q=2$ and $p=4$. In this case, the relationship betw een the R SO S and spin pictures is actually trivial, as the tw o transfer $m$ atrioes are isom orphic. C onsider for exam $p l e T_{R}$ even $\mathrm{S}(\mathrm{x})$. A $l l$ direct clusters have height $h_{i}=2$, and dual clusters have $h_{i}=1$ or 3 . $T$ he dual heights thus bijectively de ne Ising spin variables $S_{i}=1$ or 2 on the dual vertices.
$T o$ exam ine the weight of a lattice face, we decid to redistribute the factor $Q^{L=2}$ in $E q$ as a factor of $Q^{1=2}$ for each $V_{i}$ operator, i.e., on faces which are like in $F$ ic $\quad$ ff $h_{2 i}=h_{2 i}^{0}=1$ or 3 the weight is then $Q^{1=2}\left(x+S_{1}=S_{2}\right)=e^{K}$, and if $h_{2 i} \in h_{2 i}^{0}$ the weight is $Q^{1=2} S_{1}=S_{2}=1$. A sim lar reasoning holds on the faces associated with an $H_{i}$ operator, this tim e w ith no extra factor of $Q^{1=2}$. So these are exactly the weights needed to de ne an Ising $m$ odel on the dual vertices. A rguing in the sam e w ay in the odd R SO S sector, we conclude that

$\mathrm{U} \sin g$ again the explicit relation betw een heights and (dual) spins, the $Z_{2}$ tw ist in the R SO $\mathrm{S} m$ odel is seen to be the standard $Z_{2}$ tw ist of the Ising $m$ odel (antiperiodic boundary conditions for the spins). Since all local face weights are identical in the tw o m odels we have as well

For $Q=3$, we have con jectured an additional relation, given by Eq. $\quad$ which we recall here:

 contribution of non-degenerate $P$ asquier graphs $w$ ith clusters percolating vertically is $w=Q^{(1) n)=2}\left(Q^{n=2}+1\right)$ on both sides. T he contribution of non-degenerate $P$ asquier graphs $w$ ith clusters percolating horizontally is $\left.2 Q{ }^{(1)} n\right)=2 Q{ }^{l=2}$. $T$ he contribution of degenerate $P$ asquier graphs is $Q^{l=2}(Q+1)$ if the non-trivial chister is direct, and $2 Q{ }^{l=2}$ if the non-trivial chuster is dual. N ote that this relation cannot be extended to other values of p, as we used the explicit expressions for the eigenvalues of $G_{5}$ and that $p=2=Q$ and $(p, 2)=2=2$.

## IV . D ISCUSSIO N

In this paper we have studied the subtle relationship between Potts and RSOS model partition finctions on a square-lattice torus. The subtleties com e from clusters of non-trivialtopology, and in particular from those that w ind around both of the periodic directions. Treating these e ects by $m$ eans of rigorous com binatorial considerations on the associated P asquier graphs has produced a num ber of exact identities, valid on nite $L \quad N$ tori and for any
value of the tem perature variable $x=Q^{1=2}\left(e^{K} \quad 1\right)$. These identities link partition functions in the RSO S and cluster representations of the Tem perley-Lieb algebra, in various parity sectors and using various tw isted versions of the periodic boundary conditions.

O urm ain results are given in Eqs. $\square$ At the selfolual (critical) point $\mathrm{x}=1$, som e of these relations reduce to tautologies, but taking derivatives ofthe general relations $w$ ith respect to $x$ before setting $\mathrm{x}=1$ nevertheless produces non-trivial identities, such as Eq.
$N$ ote that we have proved the identities on the level of partition fiunctions, but the fact that they are valid for any $N \mathrm{~m}$ eans that there are strong im plications for the eigenvalues of the transfer $m$ atrioes. Let us wite for a given partition function $Z(x)={ }^{P}{ }_{i} \quad i \quad i(x){ }^{N}$, where (for a given width $L$ ) $i(x)$ am the eigenvalues of the corresponding transfer m atrix and $i$ their m ultiplicities. C onsider now, as an exam ple, Eq. for $Q>1$ integer. Since it is valid for any $N$, we have that the m ultiplicities satisfy

 at least in $\mathrm{T}_{\text {sp }}$ in $(x)$, and possibly also in $\mathrm{T}_{\text {sp in }}^{\text {dual }}(\mathrm{x}) \mathrm{w}$ ith a $s m$ aller $m$ ultiplicity. T he possibility that for som e eigenvalues ${\underset{R}{e n s}}_{\text {RSOS }}^{=}=\begin{aligned} & \text { odd } \\ & \text { RSOS }\end{aligned}$ explaincwhy only som e but not all the eigenvalues of the transfer $m$ atrices contributing to the individual term $s$ in Eq. coincide. Sim ilar considerations can of course be applied to our other identities. For exam ple, considering Eq. one deduces that the eigenvalues of the RSO S transfer $m$ atrix $w$ th a di erent $m$ ultiplicity betw een the even and odd sectors are eigenvalues of the tw isted R SO S transfer m atrix.

The $m$ ethods and results of this paper can straightforw ardly be adapted to other boundary conditions (e.g., w ith tw ists in both periodic directions) or to other lattices (in which case the relationsw illtypically link partition fiunctions on tw o di erent, m utually dual lattices).

It is of interest to point out the operator content of the tw isted boundary condit we have treated. W e here consider only the case $x=1$ for which the continuum lim it of the RSO Sm odel is
$M_{\text {pip }}$. . By standard conform altechniques, the ratio of tw isted and untw isted partition functions on a cylinder can be linked to two-point correlation function of prim ary operators.

In the case of the $Z_{2}$ tw ist of the RSOS m odel (which is possible only for even $p$ ) the relevant prim ary operator is $\mathrm{p}=2 ; \mathrm{p}=2$, them agnetic operatorof the $P$ ottsm odel, of conform alw eight $h_{p=2 ; p=2}=\frac{p^{2} 4}{16 p(p \quad 1)}$. To see this, rst note that the argum ent given in sectio mplies that the ratio of partition functions is proportional to the probability that both endpoints of the $Z_{2}$ seam are contained in the same (dual) chister. A s we are at the selfdual point ( $x=1$ ) we $m$ ay as well refer to a direct chuster. $N$ ow this probability is proportional to both the connected spin-spin correlation function (in the spin or cluster form ulations) and to the connected height-height correlation function (in the RSOS form ulation). The corresponding decay exponent is then the conform alw eight $h_{p=2 ; p=2}$ of the $m$ agnetisation operator.

For the special case of $p=6(Q=3)$ we have also discussed $Z_{2}$ and $Z_{3}$ type tw ists in the spin representation. T he form er is linked to the operator $2 ; 2$ of conform alw eight $\mathrm{h}_{2 ; 2}=\frac{1}{40}$, and the latter is linked to $4 ; 4 \mathrm{w}$ th $\mathrm{h}_{4 ; 4}=\frac{1}{8}$. The astute reader will notice that both operators are actually not present in the 3 -state P otts m odel but belong to the larger K ac tal of the m in m alm odelM 6;5. This is consistent with the fact that the R SO S m odel w ith param eter $p$ is precisely a $m$ icroscopic realisation of the $m$ inim almodel M p; 1 . In other words, the two types of tw ists generate operators which cannot be realised by fusing local operators in the spin $m$ odel, but are nevertheless local operators in the RSO S m odel.
The operators $2 ; 2$ and $4 ; 4$ are $m$ ost conveniently represented as the tw o types of fundam ental disorder operators in the $Z_{3}$ sym $m$ etric paraferm ionic theory (the $\mathrm{su}(2)_{3}=u(1)$ ) which is an extended CFT realisation ofM 6;5. $\mathbb{M}$ ore precisely, in the notation of Eq. (3.38) in Ref $\quad$ we have $h_{4 ; 4}=\quad(0)=\frac{1}{9}$ and $h_{2 ; 2}=\quad(1)=\frac{1}{40}$.
 operator content is di erent from that ofM p;p 1. In particular, correlation functionsm ust be de ned on a two-sheet $R$ iem ann sphere, and we expect half-integer gaps in the spectrum. This expectation is indeed brought out by our num erical investigations: for $p=6$ the second scaling level in the tw isted sector is a descendant of $2 ; 2$ at level $1=2$. These issues w ill be discussed further elsew here.
