Towards Spectral Theory of Ginibre's Ensemble of Real Random Matrices

The integrable structure of G in ibre's O rthogonal Ensemble of random matrices is looked at through the prism of the probability $p_{n,k}$ to nd exactly k real eigenvalues in the spectrum of an n real asymmetric G aussian random matrix. The exact solution for the probability function $p_{n,k}$ is presented, and its remarkable connection to the theory of symmetric functions is revealed. An extension of the D yson Integration Theorem is a key ingredient of the theory presented.

Introduction. In the mid-sixties of the last century, Jean G in ibre introduced¹ statistical ensembles of (i) real, (ii) complex, and (iii) real quaternion random matrices whose eigenvalues may belong to any point of the complex plane C. They were derived from the celebrated G aussian Orthogonal (GOE), G aussian Unitary (GUE), and G aussian Symplectic (GSE) random matrix ensembles² in a purely formal way by dropping the Hermiticity constraint and, therefore, can be thought of as their direct non-Hermitean descendants. Respectively coined as G inOE, G inUE, and G inSE, non-Hermitean random matrix models exhibited intriguingly rich mathematical structures whose complexity exceeded by far that of Hermitean R andom Matrix Theory (RMT).

From the physical point of view, non-Herm itean random matrices have proven to be as important3 as their Hermitean counterparts⁴. Ginibre's random matrices and their natural extensions appear in the description of dissipative quantum maps and dynamics of neural networks^{6,7}, in the characterisation of two-dimensional random space-lling cellular structures8. They also arise in the context of \directed quantum chaos and help elucidate universal aspects of the phenom enon of spontaneous chiral symmetry breaking in quantum chrom odynam ics11. M ore recent ndings12 associate statistical models of non-Hermitean random matrices with integrable structures of conform alm aps and interface dynam ics at both classical and quantum scales 4. For a com prehensive review of these and other physical applications, the reader is referred to Ref.3.

Out of the three non-Herm itean matrix models , G inibre's Orthogonal Ensemble de ned by the probability density $P_{G \text{ in O} E}$ [H] = $n^2 = 2$ exp tr H H T for an n real matrix H to occur is the least studied and the most challenging. Perhaps, the great diculties faced in statistical analysis of the G in OE can be attributed to the fact that its, generically complex, spectrum (w₁; n;) wm ay contain a nite fraction of real eigenvalues. This very peculiar feature of G in OE can conveniently be accommodated by dividing the entire space T (n) spanned by all real n n matrices H 2 T (n) into (n+1) mutually exclusive sectors T (n=k) associated with the matrices having exactly k real eigenvalues, such that T (n) = n = 0 T (n=k). The sectors T (n=k), char-

acterised by the partial jp d.f.'s $P_{H2T(n=k)}$ (w_1 ; n) w can be explored separately because they contribute additively to the jp d.f. of all n eigenvalues of H from T(n):

By the Theorem of Total Probability, this can equivalently be written

in terms of conditional jp.d.f.'s $P_{n,k}$ weighted by the probability $p_{n,k} = P \operatorname{rob} [H \ 2 \ T \ (n=k)]$ of exactly k real eigenvalues occurring. The otherwise complex spectrum additionally contains 'pairs of complex conjugated eigenvalues, so that n=k+2'. The probability function $p_{n,k}$ is the central object of our study which, if considered in a wider context, aims to highlight an exclusive rôle played by symmetric functions in the description of G in OE.

The most important and general result available for G in OE is due to the breakthrough work by Lehm ann and Sommers who proved, quarter of a century after G in ibre's work, that the k-th partial jpd.f. (0 k n) equals 16

In writing (3), we have used a representation due to Edelman¹⁷ who rediscovered the result¹⁵ a few years later. The above jp.d.f. is supported for ($_1$; $_k$) 2 R^k , (Rez₁; ; Rez₂ R , and (Im z₁; ; Im) z2

 (R^+) . A particular case k=n of (3), corresponding to the matrices H 2 T (n=n) with all eigenvalues real, was rst derived by G inibre¹.

Equations (1) and (3) solve the problem of nding the jp.d.f. of all n eigenvalues in G in OE. Despite this trem endous progress, a calculation of the p-point correlation function based on (3) turns out to be the problem, particularly, because a well-developed machinery of RMT, that was at use in studies of complex eigenvalue correlations in G in UE 1 and G in SE 18,19 , fails to work in this case. In particular, the famous Dyson Integration Theorem 20 (Theorem 5.1.4 in Ref.) is no longer applicable to the study of spectral statistics in G in OE, as will be reasoned below. This failure clearly signals of novel mathem atical structures lurking behind (3).

To unveiland explore these structures, we wish to concentrate on the probability $p_{n\,;k}$ to nd exactly k real eigenvalues in the complex spectrum of G in OE:

P revious attempts to attack this problem by Edelman and co-workers 17,21 brought no explicit formula for $p_{n\,;k}$ for generic k. The analytic results currently available include: (i) the probability of having all neigenvalues real equals 17 $p_{n\,;n}=2^{n\,(n-1)=4}$ (this is the smallest probability out of all $p_{n\,;k}$); (ii) for all 0 kn, the $p_{n\,;k}$ is of the form 17 $p_{n\,;k}=r_{n\,;k}+s_{n\,;k}$ $\overline{2}$, where $r_{n\,;k}$ and $s_{n\,;k}$ are rational; (iii) the expected number E $_n=\frac{n}{k=0}\,k\,p_{n\,;k}$ of real eigenvalues is given by 21

Main results. The following four statements sum - marise the new results reported in this Letter.

Statement 1. The probability $p_{n\,;k}$ of exactly k real eigenvalues occurring equals

The universalmultivariate polynomials

are exclusively determined by the partitions of the size j j = ', where ' is the number of pairs of complex-conjugated eigenvalues. The formula (7) uses a frequency representation²² of those partitions = $\binom{1}{1}$; $\binom{9}{1}$. Experts in the theory of symmetric functions may readily recognise that our F 's are, up to a factorial, so-called zonal polynomials²³

They are tabulated in the manuscript24 by H. Jack and

can also be e ciently calculated 23 by recursion. On the contrary, the arguments p_j 's of the multivariate polynomials in (6) are matrix model dependent:

(The notation [x] stands for the integer part of x). The non-universalm atrix % is sensitive to the parity of n. For n=2m even, its entries are

while for n = 2m + 1 odd,

Here, L; (x) are generalised Laguerre polynomials.

W e w ish to stress that zonal polynom ials Z $_{(1)}$ are the integral part of the nal solution (6), and not merely the means of its derivation. This highlights a strong connection between integrable structure of G in OE, integer partitions (7), and the theory of sym metric functions (8).

Statem ent 2. The entire generating function for the probabilities $p_{n\,;n-2}$ can be reconstructed from (6). The fairly compact result

w ith the % of needed parity provides us w ith yet another way of computing the entire set of $p_{n,k}$'s at once! For comparison of our analytic predictions w ith numeric simulations, see the Table I.

Statement 3. The previously unknown jp.d.f. of pairs of complex conjugated eigenvalues of a matrix H 2 T (n=k) is given by the formula (16).

Statement 4 is formulated in the form of the P fa an Integration Theorem (18) below.

Sketch of the derivation. Due to the space limitations, only key points of the derivation will be presented below; the technical details will be reported elsewhere²⁵.

To determ ine the probability function $p_{n,k}$, de ned by (4), we rst integrate out all ($_1$; $_k$) in (3) which can be viewed as a hybrid of GOE 2 and G in SE 18,19 . Them ost e cient way to do so is to spot that the second line in (3) is proportional to the average characteristic polynom ial h $_{j=1}$ det(z_j H) det(z_j H)i of a k k random matrix H drawn from the GOE with the weight function

The Vanderm onde determ inant $_2$ (fz;zg) is calculated on the set of complex eigenvalues (z₁; ,;zq; ,);zThe kernel function K $_n$ (z;z 0) in (13) is a so-called D -part 28 of the GOE m atrix kernel that can be expressed 29 in terms of arbitrary monic polynomials q_1 :

Substituting (13) into (4) completes the —integration therein bringing a new result for the jp.d.f. of 'pairs of complex conjugated eigenvalues of H 2 T (n=k):

The structure of (16) m irrors that of the jpd.f. of all complex eigenvalues in the G inSE [see, e.g., Chapter 15.2 in Ref.², and Ref.¹⁹], possibly triggering one to think that the remaining z-integrations in (4) could readily be accomplished by virtue of the Dyson Integration Theorem 2,20 . Sadly, this is not the case because the D-part K $_{\rm n}$ (z;z $^{\rm 0}$) of the GOE matrix kernel does not obey the projection property in the complex plane

with respect to the measure d (w) = $\operatorname{erfc}[(w \ w) = i^p \overline{2}]$ exp[$(w^2 + w^2) = 2]d^2w$ from (16) [compare to the Lemma 152.1 of Ref.²!]. Fortunately, the projection property is not actually necessary to carry out the integrations. We were able to prove the following pfa an integration theorem ²⁵.

Theorem . Let d (z) be any benign measure on $z \ge C$, and the kernel function $K_n(x;y)$ be an antisymmetric function specified by (14). Then, the integration formula

The pfa an integration formula contains particular zonalpolynom ials 23 Z $_{(1\)}$ whose arguments are traces of 3 with

O perationally, the proof 25 is based on a topological interpretation of the permutational expansion of pfa an in (18) combined with term-by-term integration.

Equipped with this theorem, we are ready to complete the z-integrations in (4). The calculation is most economic in the basis where monic polynomials $\mathbf{q_j}$'s coincide

with GOE skew-orthogonal polynomials. For n = 2m even, they are given by²

Substituting (20) and (21) into (19), and taking into account (18), we reproduce the announced solution (6) { (10) after a bit lengthy but straightforward calculations. The case n=2m+1 odd can be treated sim ilarly²⁵ leading to the same solution but with (10) replaced by (11).

It rem ains to establish the result (12) for the generating function G_n (z). It stems from the sum mation formula

wellknown in the theory of symmetric functions²³. Identifying $p_r = tr_{(0;[n=2]\ 1)}$ %, the exponent in (22) can be evaluated explicitly to con rm (12).

To conclude, we have presented the exact solution for the probability to nd k real eigenvalues in the spectrum of an n n random matrix drawn from G inOE. Expressed in terms of zonal polynomials, the solution reveals a strong connection between the integrable structure of G inOE and the theory of symmetric functions. An important ingredient of our analysis is an extension of the D yson Integration Theorem to the case when the kernel function under the sign of pfa an does not obey a projection property. It is highly likely that this extended theorem will have implications far beyond the scope of the present Letter. Last, but not least, extensive statistical analysis of spectra of 1,000,000 random matrices of the size 12 12 from G inOE gave further support to the theory presented.

Strictly speaking, the form ulae (14) and (15) as they stand are only valid for n=2m even. Since for n=2m+1 odd a sim ilar representation is available 2,26 for the kernel K_n (x;y), our derivation holds for n of any parity.
