Estimating the p-variation index of a sample function: An application to nancial data set

A bstract. In this paper we apply a real analysis approach to test continuous time stochastic models of nancial mathematics. Specifically, fractal dimension estimation methods are applied to statistical analysis of continuous time stochastic processes. To estimate a roughness of a sample function we modify a box-counting method typically used in estimating fractal dimension of a graph of a function. Here the roughness of a function f is defined as the inmum of numbers p > 0 such that f has bounded p-variation, which we call the p-variation index of f. The method is also tested on estimating the exponent 2 [1;2] of a simulated symmetric—stable process, and on estimating the Hurst exponent H 2 (0;1) of a simulated fractional Brownian motion.

1 Introduction: the p-variation index and nancial modeling

In nancial mathematics, a simplest continuous time model assumes that a stock price, or other nancial asset, is a stochastic process P = fP(t): 0 to Tg satisfying the relation

The mainstream econometric analysis of continuous time nancial models is to test dierent hypotheses about an integral equation describing a stock price process P, or to test various param eters of a distribution of a return process X (see e.g. Section 9.3 in Campbell, Lo and M acK in lay, 1997). In this paper we attempt to test the degree of roughness of a return process X. The legitim acy of such an endeavor is based on the fact that the support of a distribution of a stochastic processes is a particular class of functions. That is, a suitable class of functions contains alm ost all sample functions of a stochastic process. More specically, if X is a regular enough stochastic process de ned on a given probability space (;F;Pr), then for a suitable class of functions F, a sample function X(!) = fX(t;!):0 t Tg belongs to F for almost all! 2 . Often F can be taken as a proper subspace of the space of all continuous functions on [0;T], or a proper subspace of the (Skorohod) space of all regulated and right continuous functions on [0; T]. For exam ple, the support of the distribution of a standard B rownian motion is a subset of a class of functions having the order of Holder continuity strictly bigger than 1=2. However, the Holder continuity is not applicable to characterize sample functions of a Levy stochastic process without a Gaussian component, because almost every sample function of such a process is discontinuous. A simple example of a Levy process is a symmetric -stable stochastic process, or a S S stochastic process, X with the exponent 2 (0;2]. The case = 2 gives the only G aussian component, a standard B rownian motion, that is, $X_2 = B$. In general, if X is a S S stochastic process with 2 (0;2], then almost all sample functions of X have bounded p-variation for each p > p, and have in nite p-variation if 0 < pknown since the time P. Levy rst introduced this process around the beginning of thirties.

To recall the property of boundedness of p-variation, let f be a real-valued function on an interval [0;T]. For a number 0 , let

The function f has bounded p-variation on [0;T] if $v_p(f) < 1$. By Holder's inequality it follows that if $v_p(f) < 1$ and q > p, then $v_q(f) < 1$. The number

is called the p-variation index of f. For a regular enough stochastic process X , (X)(!) = (X(;!)), ! 2 , is a random variable which we call the p-variation index of X . In fact, for all stochastic processes discussed in this paper, their p-variation indices are known to be constants and we seek to estimate these constants.

Now for a S S stochastic process X, we can restate its sample regularity by saying that its p-variation index (X) = almost surely. This is a special case of the following more general fact.

Example 1. Let X be a homogeneous Levy stochastic process with the Levy measure , which is a - nite Borelmeasure on R n f0g such that

This follows from Theorem s 4.1 and 4.2 of B lum enthal and G etoor (1961), and from Theorem 2 of M onroe (1972).

A stock price model having as a return a Levy process without a Gaussian part is a common alternative to the Black-Scholes-M erton model. Another popular alternative is a fractional Brownian motion B_H with the Hurst exponent H 2 (0;1), where B_H with H=1=2 is a standard Brownian motion. The p-variation index of a fractional Brownian motion (B_H ; [0;T]) = 1=H almost surely. This is the special case of the following fact.

This follows from the fact that almost all sample functions of X obey a uniform Holder condition with exponent $<_{\rm X}$ (see Section 9.4 of C ram er and Leadbetter, 1967) and from the inequality of B erm an (1969) connecting the p-variation with the Fourier transform of local times of X . Relation (2) also follows from the characterization of the p-variation index for arbitrarily G aussian processes due to Jain and M onrad (1983).

From the point of view of a statistical time series analysis, estimation of the p-variation index in the above two examples of eranew perspective to analyzing nancial data sets. For instance, a symmetric—stable process and a fractional Brownian motion with the Hurst exponent H, both have the same p-variation index in the case = 1=H = 2 (1;2). However the latter has exponentially small tails, while the former has not even the second moment. These two examples are extensions of the Black-Scholes-Merton model (that is when = 1=H = 2) into two different directions. The Orey index, and so the p-variation index by relation (2), have already been estimated in the paper Norvaisa and Salopek (2000). They used two estimators based on the result of Gladyshev (1961). The estimators of the present paper can be applied under much less restrictive hypotheses about stock price returns, and helps to reconcile the two divergent directions of theoretical analyses of nancial markets.

2 The oscillation -sum ming index and related estimators

In this section we describe a method of estimating the p-variation index of a function based on existence of the metric entropy index (or the box-counting dimension) of its graph. Let f be a real-valued function dened on an interval [0;T]. Let = fN $_{\rm m}$: m = 1g be a sequence of strictly increasing positive integers. The sequence Q(f) := fQ(f; (m)): m 1g will be called the oscillation—sum m ing sequence. For a bounded non-constant function f on [0;T], and any sequence—as above, let

The lower bound follows from the bound Q (f; (m))=N $_{\rm m}$ Osc(f; [0;T]) < 1, which is valid for each m 1. The upper bound holds because Q (f; (m)) C=2>0 for all su ciently large m 1. Indeed, if f is continuous, then C = v_1 (f; [0;T]). Otherwise f has a jump at some t2 [0;T], so that C can be taken to be a saltus at tift 2 (m) for all su ciently large m, or C can be taken to be a one-sided non-zero saltus at tift 2 (m) for in nitely m any m. Instead of relation (4), a sharp one-sided bound is given by Lemma 13 in Appendix A.

If f has bounded variation, then for each ,

Indeed, since Q (f; (m)) v_1 (f; [0;T]) < 1 , we have $\log Q$ (f; (m))=N m $\log v_1$ (f; [0;T])=N m for all su ciently large m . Thus (f) 1, and equalities in (5) follow from relation (4).

Next we give a su cient condition for exitence of the oscillation —sum m ing index for any . Let E be a nonempty bounded subset in a plane R^2 , and let N (E;), > 0, be the m in im um number of closed balls of diameter —required to cover E . The lower and upper metric entropy indices of the set E are dened respectively by

If $(E) = {}^+(E)$, then the common value denoted by (E) is called the metric entropy index of the set E. In the actual calculations of the metric entropy index, it is often simpler to replace closed balls by squares (boxes) of a grid (cf. Lemma 9 below). Therefore in fractal analysis, (E) is also known as the box-counting dimension.

The proof of the following theorem is given in Appendix A.

Theorem 4. Let f be a regulated non-constant function on [0;T] with the p-variation index (f). If the metric entropy index of the graph gr(f) of f is de ned and

Essentially, relation (7) is the lower bound condition on the metric entropy index because the following always holds.

Proposition 5. For a regulated function f on [0;T], (qr(f)) 2 1=(1_ (f)).

The proof is similar to the proof of Theorem 4 and is also given in Appendix A.

The oscillation—sum m ing index is a slightly modi ed concept of a realbox-counting method introduced by Carter, Caw ley and Mauldin (1988). Independently, Dubuc, Quiniou, Roques-Carmes, Tricot and Zucker (1989) arrived at essentially the same notion, but called it the variation method. Both papers applied the new index to estimate the fractal dimension of several continuous functions whose dimension is known, and found the new algorithm superior over several other fractal dimension estimation methods (see also Section 62 in Cutler, 1993, for further discussion on this).

O scillation —sum m ing estim ators. Let f be a real-valued function de ned on [0;1], and let = fN_m :m = 1g be a sequence of strictly increasing positive integers. Let fu_1 ;:::; u_N g = [0;1] be a set of points such that for som e integer M ,

Relation (8) suggests that the set fr(m): m = 1; ...; M g m ay be used to estimate the p-variation index (f).

De nition 6. Let = fN_m :m | 1g be a sequence of strictly increasing positive integers, let $fu_1; \dots; u_N$ g [0;1] be such that (9) holds for some integer M , and let $ff(u_1); \dots; f(u_N)$ g be a set of known values of a real-valued function f on [0;1]. is the OLS oscillation —sum m ing estimator of 1_ (f) based on $_{\rm M}$:= fN $_{\rm m}$:1 m M g. The estimators e and b will be called the OS estimators, and the estimation either by e or by b will be called the OS estimation.

Relation (8) alone, if it holds for a function f and a sequence , does not imply that the two estimators will converge to (f) as N ! 1 , and so as M ! 1 by relation (9). If (f) < 1 , then f is a regulated function on [0;1], that is, there exist the limits f(t+) = $\lim_{u \to 1} f(u)$ for each t 2 [0;1) and f(s) := $\lim_{u \to 1} f(u)$ for each s 2 (0;1]. Assuming that f is regulated and either right-or left-continuous, then 0 sc(f;A) is the same as 0 sc(f;A\U) for a countable and dense subset U [0;1] and any subset A [0;1]. For such a function f, one can show that the naive estimator e (f) will approach (f) as the set fu1;:::;uN g will increase to [m (m). For sample functions of a stationary G aussian stochastic process X , Hall and W ood (1993) showed that the two estimators corresponding to the reciprocal of relation (11) converge to 1=(1_ (X)), and they also calculated asymptotic bias and variance.

O scillation —sum m ing index of stochastic processes. Here we show that the conditions of Theorem 4 hold for almost all sample functions of several important classes of stochastic processes. To this aim we use known results on Hausdor—Besicovitch dimension of graphs of sample functions. Let E R² be a bounded set, and let diam (A) denote the diameter of a set A R². An —covering of E is a countable collection $fE_k: k$ 1g of sets such that E [$_kE_k$ and $\sup_k diam$ (E $_k$) . For s>0, the Hausdor s-measure of E is defined by

Given E R^2 , the function s 7 H s (E) is nonincreasing. In fact, there is a critical value s_c such that H s (E) = 1 for $s < s_c$ and H s (E) = 0 for $s > s_c$. This critical value s_c is called the H ausdor -B esicovitch dimension and is denoted by dim $_{\rm H\,B}$ (E). That is,

A relation between the lower metric entropy index (E) of E and the Hausdor-Besicovitch dimension of E is given by the following result.

In fact, the left side is equal to the right side almost surely for several classes of stochastic processes. For example, let X be a sym metric—stable process for some 0 < 2. Then by Theorem B of Blum enthal and G etoor (1962), for almost all sample functions of X, we have

For these stochastic processes, relation (12) yields that assumption (7) of Theorem 4 is satisfed for almost every sample function, and so we have the following result.

C orollary 8. Let X = fX (t):0 t 1g be a stochastic process, and let $= fN_m : m$ 1g be a sequence of strictly increasing positive integers. The relation

holds for almost all sample functions of X provided either (a) or (b) holds, where

- (b) X is a mean zero Gaussian stochastic process with stationary increments continuous in quadratic mean and such that the 0 rey index $_{\rm X}$ exists.

Similar results for more general processes other than (a) and (b) of Corollary 8 can be respectively found in Pruitt and Taylor (1969, Section 8) and in Kôno (1986).

3 Simulated symmetric —stable process

In this section we carry out a simulation study of small-sample properties of the OS estimators from De nition 6. To this aim, we simulate a symmetric—stable process for several values of the exponent, which is equal to its p-variation index. Using repeated samples we calculate the bias, the standard deviation and the mean square error for the two estimators.

Simulating S S process. Let X = fX (t):t 0g be a symmetric -stable stochastic process with the exponent 2 (0;2]. As stated in the introduction, the p-variation index of X is given by (X) = almost surely. Since the 0 S estimators do not capture the values of the p-variation index below 1, we restrict our study to estimating the exponent 2 [1;2]. To simulate a sample function of a S S process X, we generate a set f i:i = 1;:::;ng of symmetric -stable pseudo-random variables and use the central limit theorem to get an approximation X^{c} of X, where

and [r] denotes the integer part of r. By the central lim it theorem, the distribution of X° on the Skorohod space D [0;1] converges weakly to the distribution of X as n! 1. We take $n=2^{14}$. To generate a sym metric—stable random variable, we use the results of Chambers et al. (1976) (see also Section 4.6 in Zolotarev 1986). That is, in the sense of equality in distribution, we have

The estimation results are presented in Tables 1 and 2. Next is a qualitative description of the perform ance of the two OS estim ators.

- B ias The estimation results show a dierent behavior of the bias for the two estimators. The naive estimator e (X) display monotonically decreasing positive bias when values increase from 1 to 2. While the bias of the OLS estimator b (X) monotonically decrease 1:4, and the m in im alabsolute from a positive bias for < 1:4 to a negative bias for bias is achieved when = 1:4.
- SD The estimated standard deviation is also dierent for the two estimators. SD values for the naive estimator e (X) monotonically decrease when values increase from 1 to 2, and are quite smallwhen is close to 2. While SD values for the OLS estimator b (X) remain sim ilar and som ew hat larger than for the naive estim ator; only a little im provem ent one can notice when is close to 2.
- M SE The estimated mean square error remain dierent for the two estimators. M SE values for the naive estimator e (X) decrease steady when values increase from 1 to 2, while M SE values for the OLS estimator e(X) is smallest when =1.5, and are increasing for all other values of .

In conclusion the results show a distinction between the two OS estimators: the OLS estimator e (X) display better perform ance for values 1:4 1:6, while the naive estimator e (X) behaves best for values close to 2. This M onte-Carlo study was extended to sample functions based on a larger number of points, i.e. fX^{e} $(k=2^{M}): k=0; ...; 2^{M}$ g with M 2 f15;16;17g. The results from the increased sample size show the same qualitative behavior as before, but with increased accuracy (see Norvaisa and Salopek, 2000b).

To the best of our know ledge, the two 0 S estim ators provide the rst attempt to estim ate the exponent of a S S process from a sample function. Recently C rovella and Tagqu (1999) introduced a new method to estimate the exponent of a S S random variable.

4 Simulated fractional Brownian motion

Here we perform a M onte Carlo study like in the preceding section, with a fractional Brownian motion. A fractional Brownian motion fB_H (t):t g og with the Hurst exponent H g (0;1) is a Gaussian stochastic process with stationary increments having the covariance function

and B_H (0) = 0 alm ost surely. Since its incremental variance B_H (u) = U^H , the O rey index B_H exists and is equal to the Hurst exponent H (cf. Example 2). Thus by relation (2), B_H has the p-variation index (B_H) = 1=H alm ost surely. To simulate a fractional Brownian motion we use the program of M aeder (1995) written in M athematica.

O S and G estimation. In this section we apply four estimators of the p-variation index. As before, the two O S estimators from De nition 6 will be used to estimate h := 1 = H. Moreover, we invoke the two estimators of the O rey index introduced in Norvaisa and Salopek (2000), and which will be called G estimation, which is short for the Gladyshev estimation. This gives us four di erent estim ates h of h = 1=H. We repeat this procedure K = 100 times to obtain the estimates $h_1; \dots h_K$ of h for each of the four cases. Then we calculate:

The estimation results are presented in Tables 3-6. First one can compare the 0 S estimation results of 2 [1;2] (Tables 1 and 2) for a S S process, and the 0 S estimation results of b=1H 2 (1;2] (Columns b=12;1:4;1:6;1:8;2:0 of Tables 3 and 4) for a fractional Brownian motion with the Hurst exponent H. The accuracy of the naive 0 S estimator for the two processes is similar. There is only somedierences in the character of monotonicity along dierent values of parameters. The same holds for the 0 LS 0 S estimator for the two processes.

Now if we look at columnsh 2 f2:0;2:2;:::;3:0g of Tables 3 and 4, it is clear that the 0 S estimates of hare very poor in this case. This is so since estimation errors appear in the denominator of the relation (11). For example, if H and H both are small, then the left side of the relation

can be relatively large as compared to ^{12}P H. The same remark applies to the G estimates in Tables 5 and 6. To show that this is so we applied the OS estimator to evaluate the Hurst exponent directly using the relations (2) and (8). This means that in our earlier estimation formulas we need just to interchange the numerator and the denominator in (11). The estimation results are presented in Tables 7 and 8, where ^{12}P , the bias, SD and MSE are defined as before with high replaced by H. In Tables 3-8, the estimation results for H = 1=2, and so for h = 2, are all based on the same set of 100 simulated sample functions, which can be used to verify the elect of the above relation 13. Also, the results of the OS estimation of H in Tables 7 and 8 can be compared with the results of the G estimation of H in Tables 1 and 3 of Norvaisa and Salopek (2000). The naive estimators corresponding to the OS and G estimations show very similar properties. As far as the OLS estimators concern, for small vaules of H, the bias and MSE of the OS estimation are larger than the bias and MSE of G estimation. However, for the same values of H, the standard deviation of the OS estimation is smaller than the standard deviation of the G estimation. In sum the two estimation methods OS and G show similar results when applied to estimate the Hurst exponent of a fractional Brownian motion.

5 Financial data analysis

In this section, we analyze the nancial data set provided by O lsen & Associates. It is the high-frequency data set HFDF96, which consists of 25 di erent foreign exchange spot rates, 4 spot metal rates, and 2 series of stock indices. This data set was recorded from 1 Jan 1996 GMT to 31 Dec 1996 GMT. Each set has 17568 entries recorded at half hour intervals. The same nancial data set was studied in Norvaisa and Salopek (2000) using the two estimators of the O rey index based on the result of G ladyshev (1961).


Returns. First notice that returns in continuous time and discrete time nancial models are treated slightly dierently. A return in a discrete time model is a function R^0 dened on a lattice to 2 f0;1;:::;Tg with values being a suitable transform of a pair fP (t 1);P (t)g, where P is a stock price process. A return in a continuous time model is a function R dened on [0;T] so that R (t) R (t 1) = R^0 (t) and R (0) = 0 for all to 2 f1;:::;Tg. This gives a 1 1 correspondence between continuous time returns used in this paper and the usual discrete time returns (see Section 2.1 in Norvaisa, 2000a, for further details).

Given a historical data set fd_0 ;:::; d_K g of values of a nancial asset, let P be a function de ned on [0;1] with values d_k at $u_k = k = K$ for k = 0;:::;K. U sually in econometric literature, returns are log transforms of the price. Thus in continuous time models, this corresponds to assuming that P (t) = P (0) expfX (t)g, 0 t 1, for some return process X which is to be analyzed. A lternatively, the price process P can be a solution of an integral equation, which is not a simple exponential. If a stochastic process X has the quadratic variation along the sequence of partitions = f (m):m 1g de ned by (9), and the price process P is a solution of a linear integral equation with respect to X (such as the B lack-Scholes-M erton model (1), with B replaced by X), then P also has the quadratic variation along the sequence and the process X can be recovered by the relation

for 0 t 1. Here the quadratic variation is understood in the sense of Folmer (1981), which is further developed in Norvaisa (2000b). The above process X will be called the net return of P, which is analogous to discrete time simple net returns. The log return X of the price process P is defined by X (t) = $R_{log}(P)$ (t) = log(P) (t)=P(0)], 0 t 1. The difference between the two returns is

Since P has the quadratic variation along the sequence , the di erence R $_{\rm net}$ (P) R $_{\rm log}$ (P) given by (14) has bounded variation. Thus the p-variation indices of the two returns are equal provided both are not less than 1. A discussion of the di erence R $_{\rm net}$ (P) R $_{\rm log}$ (P) when P is the geom etric B row nian m otion or P is a m odel for USD/JPY exchange rates can be found on pages 362 and 366 of N orvaisa and Salopek (2000).







Figure 1: Naive estimators: e = 1.27 and Figure 2: Naive estimators: e = 1.108 and $\mathcal{L} = 1.357$ based on $f2^m : m = 1; :::; 14g. <math>\mathcal{L} = 1.025$ based on fm : m = 1; :::; 240g.






Figure 3:0LS estimators: b = 1:814 and Figure 4:0LS estimators: b = 1:939 and f = 2.266 based on $f2^m : m = 1; :::; 14g. <math>f = 2.049$ based on fm : m = 1; :::; 240g.

OS and G estimation. To estimate the p-variation index of a return, the oscillation – summing estimators from Denition 6 will be used when the sequence = fN_m :m = 1g is given by $N_m = 2^m$ and $N_m = m$ for integers m = 1. A comparison will be made with the results of Norvaisa and Salopek (2000) by using their estimators based on the result of G ladyshev (1961). As before, the oscillation –summing estimation is called the OS estimation, and the estimation as in Norvaisa and Salopek (2000) is called the G estimation.

Estimation results. Estimation results for the data set HFDF96 are given by Tables 9, 10 and 11. M ore speci cally, the tables contain the estimated p-variation indices for the two returns of the bid price associated with the nearest prior datum. We picked the log-returns of USD/JPY exchange rates to illustrate by Figures 1 - 4 a dierence between the OS and G estimation results in more detail. Figures 2 and 4 show the estimation results based on a sequence = $fN_m = m : m$ 1g truncated at M = 240. The associated sequence of partitions 1g in this case is not nested, and technical calculations in this case are m ore complex. Figures 1 and 3 show the estimation results based on dyadic partitions, which are used for the rest of results. Because the conditions of Theorem 4 are more general as compared to the conditions of the main result of Gladyshev (1961), the results of the OS estimation are more reliable than the results of G estimation. This is also seen from the Figures 2 and 4. The columns e and b of Tables 9, 10 and 11 suggest that estimated p-variation indices of the returns of the nancial data are more likely to belong to the interval (1;2). These columns are essentially the sam e for net-returns as well as for log-returns, which would be in agreem ent if a stock price has the quadratic variation along a nested sequence of dyadic partitions and its p-variation index is



not less than 1. Due to the pattern exhibit by the results of Section 4 when estimating 1=H , it is unlikely that a fractional B rownian motion B $_{\rm H}$ would give a satisfactory to the nancial data for some values of H . However, as seen in Figures 1 – 4, a more general process from Example 2 m ight be used to model the HFDF96 data sets. Especially this concerns a modelling of stock indices (see Figure 11). Recall that the G estimation is reliable when applied to sample functions of stochastic processes having a suitable relationship between a sample function behavior and an asymptotic behavior of the incremental variance. The estimation results do not reject the hypothesis that returns may be modeled by a Levy process. To be more special about a degree of data thing, we need a theoretical asymptotic analysis of both, the OS and G estimations, which is not available at this writing.

Related results and techniques. The OS and G estimators are based on properties of a function similar to a kind of self-similarity property with respect to shrinking time intervals, sometimes referred to as a fractal or empirical scaling law. It is natural that a high-frequency data have already been used to detect such laws if exist. The work of Muller et. al. (1995) addresses this question and provide some preliminary indings in their analysis of a high-frequency FX data collected from raw data vendors such as Reuters, Knight-Rider and Telerate. Another related work of Mandelbrot (1997) have already been discussed in Section 4.3 of Norvaisa and Salopek (2000).

6 Discussion

Param eter estimation of a nancial model is a typical econometric analysis task. What is atypical in the preceding analysis is a generality of the underlying nancial model. This model applies far beyond of limits in posed by the sem in artingale theory, and its outline can be found in Bick and Willinger (1994), and Norvaisa (2000a). The p-variation index considered as a parameter of a model is dened for any function. Its estimate provides a grade for each concrete continuous time model of a price process P governed by an exponential, or by a linear integral equation






Figure 5: Four trajectories of $R_{\text{net}}(P)$ $R_{\text{log}}(P)$ (left) de ned by (14) corresponding to the Dolean exponential P = E(X) (right) given by (19), where X is a S S process with = 1:7. Vertical lines join jumps.

as its unique solution, where the lim it is understood either in the sense of renements of partitions $= ft_i : i = 0; :::;$ ng of [0;1], or in the more general sense along a xed sequence of nested partitions. The linear Itô stochastic integral equation with respect to a sem in artingale X is one such example of a continuous time model. A further generality of the underlying nancial model could be achieved once the net-returns are modified so as to reverse a solution of a non-linear integral equation.

We stress the importance of the notion of a return because it provides a two direction link between theory and practice. A nancial model without the notion of a return is just an exercise in theory building. As we noted earlier, the results of the preceding section show that the estimated p-variation indices for the calculated net-returns and log-returns are almost the same. Here we discuss the dierence between the net- and log-returns R $_{\rm net}(P)$ R $_{\rm log}(P)$ given by (14) for a simulated price process P . Suppose that P is the Dolean exponential E (X) of a symmetric -stable process X :

That is, P is defined by (18) with X replaced by X. Then the continuous part of the quadratic variation $P ^c$ 0, and so the simulation gives the remaining sums in (14) as shown in Figure 5.

To simulate the Dolean exponential E(X) we use its representation as the inde nite product integral (18), proved by Dudley and Norvaisa (1999, Corollary 5.23 in Part II). Theoretically, the Dolean exponential composed with the net-return gives $X = R_{net}(P)$. Thus the maximal discrepancy $d = \sup_{x \to \infty} \Re^x(x)$ (t) $\Re^x_{net}(P)$ (t) jbetween simulated versions of the two sides should be

sm all if simulation is accurate enough. Indeed, we get that the discrepency $d = 3.1 10^{-14}$ holds uniform by for all trajectories in the left Figure 5. Notice that one of the four trajectories breaks because its Dolean exponential jumps to the negative side, and so its logarithm is undened.

Appendix A

This section contains proofs of Theorem 4 and Proposition 5. The proofs consist of combining a few relations between the metric entropy index, the oscillation —sum ming index and the p-variation index, and will be discussed rst.

As noted earlier, in the actual calculations of the metric entropy it is offen simpler to replace closed balls by squares (boxes), which leads to the box-counting dimension (see Section 6.1 in Cutler, 1993). First we modify the box-counting method for sets which arise when connecting a graph of a discontinuous function. Throughout this section, f is a regulated function de ned on a closed interval [0;T]. This means that for each t 2 (0;T], there exists a lim it f (t) := $\lim_{u^*t} f(u)$, and for each t 2 [0;T), there exists a lim it f (t+) := $\lim_{u^*t} f(u)$.
