The Jacobian Conjecture as a Problem of Perturbative Quantum Field Theory

A bstract

The Jacobian conjecture is an old unsolved problem in mathematics, which has been unsuccessfully attacked from many dierent angles. We add here another point of view pertaining to the so called form al inverse approach, that of perturbative quantum eld theory.

Keywords: Jacobian conjecture, Reversion, Quantum eld theory.

I Introduction

The purpose of this modest note, for which we claim no originality except that of connecting apparently unrelated elds, is to draw the attention of theoretical physicists to one of the major unsolved problems of mathematics [35], viz. the Jacobian conjecture. The question is so simple that it was coined in [6] a problem in high school algebra". One can formulate it as follows.

Let $F : C^n ! C^n$ be a map written in coordinates as

One says that F is a polynom ial map if the functions $F_i: C^n ! C$ are polynom ial. Suppose that the Jacobian determ inant

is identically equal to a nonzero constant. Show then that F is globally invertible (for the composition of maps) and that its inverse $G \stackrel{\text{def}}{=} F^{-1}$ is also a polynom ialm ap.

Since it was rst proposed in [25] (for n = 2 and polynom ials with integral coe cients), this problem has resisted allattem pts for a solution. In fact, this seem ingly simple problem is quite an embarrassment. Indeed, some faulty proofs have even been published (see the indispensable [10] and [17] for a review). We will show here that the Jacobian conjecture can be form ulated in very nice way as a question in preturbative quantum eld theory (QFT). We also expect any future progress on this question to be bene cial not only for m athem atics, but also for theoretical physics as it would enhance our understanding of perturbation theory.

II The form al inverse as a one-point correlation function

The most tempting, yet unfortunately least developed, line of attack on the Jacobian conjecture is the so called form al inverse approach. One tries to solve explicitly for $x = (x_1; :::; x_n)$ in the equation y = F(x), one then nds a power series expression for x in terms of $y = (y_1; :::; y_n)$. By the uniqueness of the power series inverse, all one has to do then is to show that it is in fact a polynom ial, that is the term s of high degree in the y variables vanish. One of the many reasons this approach is in its infancy is that it took

m ore than two centuries (say from [27] to [10]) to have a workable form ula for the form al inverse in the multivariable case. Early contributions can be found in [28, 23, 15, 36, 29, 21]. An important contribution concerning form al inversion is due to Gurjar and Abhyankar [7]. M odern litterature on reversion and Lagrange-G ood type form ulas is huge and we invite the reader to consult [10, 20, 22, 40] form ore complete references. The rst form ula for the coe cients of the form al inverse power series G in terms of those of F is due to J. Towber and was rst published in [41]. In physicists' terms ours is the following.

C laim : (A . A ., V . R ivasseau) The form alsolution of y = F(x), without any assumption on F except that its linear part is invertible, is the pertubation expansion of the normalized one-point correlation function

We obtained this expression by solving iteratively the equation y = F(x) thereby generating a tree expansion in the same way one expresses the effective action () in terms of the logarithm W (J) of the partition function in QFT (see [42] for instance). We then determ ined the Feynman rules of this tree expansion and nally the \path integral" formulation (3), only to realize that in fact our formula is closely related to the one introduced by G.Gallavotti, following a suggestion of G.Parisi, to express the Lindstedt perturbation series in the context of KAM theory [18].

A mathematician will undoubtedly shrink at the sight of equation (3). In the following, we will state and prove a precise theorem, using some analysis, for the case where $F_i(x) = x_i$ $H_i(x)$, with the $H_i(x)$, 1 i n, being

hom ogenous of the same degree d. Indeed, it is enough to treat the cubic case d = 3, for all dimensions n, in order to prove the Jacobian conjecture in full generality [10]. However, form ula (3) is completely combinatorial in nature and its proper setting is in the ring of form all power series with variables corresponding to the coe cients of F together with the y_i's, over any eld of zero characteristic. One simply has to de ne form alG aussian integration, som ewhat in the spirit of [8, 9]. We refer to the expository article [1] for a form ulation and proof of our claim as a decent mathematical theorem. The latter article will also provide more details on how Feynm an diagram s can be useful in algebraic combinatorics and how well they t in the Joyal theory of combinatorial species [24]. We also refer to [2] for a very simple heuristic proof of the Lagrange-G ood multivariable inversion form ula, which becomes a fully rigorous and purely combinatorial proof when interpreted using the form alism of [1].

As is well known in QFT, the num erator and denom inator of (8) can be calculated by expanding

and integrating term by term with respect to the norm alized complex G aussian measure d d e . The result is a sum over all possible Feynm an diagram s that can be built from the vertices of (9) and (10) (and the source i for the numerator) by joining the half-lines of compatible directions. A quick look at the vertices shows that the only possible diagram s are trees connected to the source i, or vacuum graphs made by an oriented loop of say k 1 w-vertices to which k (d 1) trees, whose leaves are y-vertices, are attached. W hen one factors out the denom inator, the only diagram s that rem ain are made of a single tree with the source i as its root. Therefore, at least form ally, we have

where T is a Cayley tree (viewed as a set of unordered pairs) on a nite set E = E (V;N). The latter is chosen, non canonically, once for each pair (V;N), and must be the disjoint union of E root of cardinality 1, E internal of cardinality V and E leaf of cardinality N. T is constrained by the condition that elements of E root [E leaf have valence 1 while those of E internal have valence d + 1. This autom atically enforces the relation (d 1)V = N 1 which can be checked by counting the half-lines. Even though we write, in the sequel, seem ingly independent sum s over V and N, the previous relation is allways assumed.

W e now de ne the amplitude A $_{\rm i}$ (T). O ne directs the edges of T towards the root in E $_{\rm root}.$ For each such edge 12 T , one introduces an index $i_{\rm i}$ in the


set f1;:::;ng. One then considers the expression $A_i(T;(i_l)_{l^2T})$ which is the product of the following factors.

-For each a 2 E $_{\rm leaf}$, if l(a) is the unique line going from a, we take the factor $y_{i_{2(a)}}$.

-For each b2 E _{internal}, if fl₁ (b); :::; l_d (b)g is the set of lines coming into b and l₀ (b) is the unique line leaving b, we take the factor $w_{i_{l_0}(b)}$; $i_{l_1}(b)$...

The resulting m onom ial in the y's and w's is $A_i(T; (i_l)_{l2T})$ by de nition. Finally $A_i(T)$ is the sum of $A_i(T; (i_l)_{l2T})$ over all the indices $(i_l)_{l2T}$ except the index of the line arriving at the root which is xed at the value i, the source index.

For example, with d = 3, the amplitude of the following tree with V = 4 and N = 9

where the last sum is over trees with at least one w-vertex linked directly to the root. This sum can be performed in the following way. One chooses, among the V internal w-vertices, the vertex $w_0 2 E_{internal} which hooks to the root. This costs a factor V. Then one divides the remaining vertices into an unordered collection of sets <math>E_1$;:::; E_d such that E_i has V_i w-vertices and N_i y-vertices. This costs a factor

As a result the Taylor series of G at the origin is the right compositional inverse of F. Now algebraic combinatorialists m ight not be too impressed by this since one can readily rewrite formula (12) under the form given by

Towber [40] or Singer [34]. So the series expansion of the form al inverse itself is not new. To obtain a real in provem ent on previous approaches one has to return to the more fundam ental equation (3) and really consider the \integrals" appearing in it as, well, integrals on which one can try all the tools of ordinary calculus: integration by parts, change of variables:::For an example of the mathematical utility of this way of proceeding, see [8, 9, 32]. R em ark : Note that the generalized forest form ula of Towber [40] can be easily derived from the perturbation expansion of higher correlation functions $< \frac{1}{1} ::: \frac{n}{n} >$, where we used the standard statistical mechanics notation

III Comments on the Jacobian conjecture

III.1 W hat does the constant Jacobian condition m ean? Suppose that

is such that JF(x) = 1 for all x. Several conclusions can be drawn from this constraint. One that is due to V.R ivasæau is that our QFT model is self-norm alized. In other words


In the case where $F_i(x) = x_i$ $H_i(x)$ with the $H_i(x)$ hom ogenous of the same degree d, it is easy to show that the Jacobian condition is equivalent to M (x) being nilpotent for all x (see [10]). There are essentially two ways to express this



Equation (39) means that when one considers a chain (or caterpillar) diagram like



with n w-vertices, its contribution, for xed i and j, is zero after symmetrization of the indices of the n (d 1) incoming lower legs.

Equation (40) m eans that bop diagram s like

with k 1 w-vertices, vanish after sym m etrization of the indices of the k (d 1) incoming legs. The form al inverse approach to the Jacobian conjecture can now be rephrased as the following P roblem : Show explicitly that in the polynom ialalgebra C [w] with indeterm inates given by the tensor elements w $_{i;j_1}\ldots_{j_d}$, the y = 0 connected correlation functions

belong to the radical of the ideal generated by the sym m etrized chains and/or loops, provided the degree N $\,$ is large enough.

This statem ent is by the H ilbert nullstellensatz equivalent to the Jacobian conjecture. It is even a theorem due to S.W ang [38] in the (d = 2) quadratic case. The proof is non constructive however, and an explicit combinatorial argument is an urgent desideratum.

III.2 Chains and/or loops?

Let c be the ideal of C [w] generated by the sym m etrized chains of length n, and let 1 be the ideal generated by the symmetrized loops of length k 1. W hile it is very tempting to work with c, it seems more fundamental to use 1. This conclusion is implicit in [40]. Indeed the author uses the diagonal m inor sum s, i.e. the elementary symmetric functions of the eigenvalues, to express the nilpotence of M (x), instead of the matrix elements of M $(x)^n$. W e use the loops, that is the Newton power sum s of the eigenvalues, which makes no di erence since our ground ring is C. Note that c l: this is the Cayley-Hamilton theorem, i.e. the Jacobian problem for d = 1"! But c, trivially because a nilpotent matrix must have zero we also have 1 eigenvalues and therefore the Newton sum s of these eigenvalues are zero. It is very instructive to understand these two elementary statem ents in a purely combinatorial way. Regarding the rst inclusion, we were surprised to nd in the recent literature a combinatorial proof, with a avor of bop-erased random walk, of the eminently classical Cayley-Hamilton theorem [37]. As for the second inclusion, there is a very nice explicit Ferm ionic proof [12] that, for a generic n $n \mod n \mod N$, (tr N)^{k (n 1)+1} is in the ideal generated by the matrix elements of N $^{\rm k}$.

To see why the ideal c is tempting to work with, we need to recall a theorem, rst conjectured by W ang in the quadratic case [38], and proved in full generality by 0.G abber (see [10]).

Theorem 2 If F : C $^{\rm n}$! C $^{\rm n}$ is globally invertible with polynom ial inverse G then

where deg F $\stackrel{\text{def}}{=}$ m ax $_1$ $_i$ $_n$ (deg F $_i)$ and likewise for G .

In our context, this means that the vanishing of the connected correlation functions $\langle i_{j_1} ::: i_{j_N} \rangle_{y=0}^c$ should happen as soon as $N > d^{n-1}$. Note that this bound is saturated by the well known triangular example given by $F_i(x) = x_i x_{i+1}^d$, for 1 i n 1, and $F_n(x) = x_n$. But d^{n-1} is the maximal number of leaves of those of our trees which have a depth less than or equal to n = 1. If the chains in (41) needed not be symmetrized, the Jacobian conjecture would be trivial! Indeed, a tree with more than d^{n-1} leaves must have a chain of length at least n, going from the root i to one of the leaves i_j . This observation, which goes back to [10], was likely the main in petus behind the form al inverse approach.

Remark that if we condition the sum over Feynman diagrams for the correlations $< i_{j_1} ::: i_{j_1} >_{y=0}^{c}$, by requiring the path between the root i_{j_1} and a specified leaf j_{j_1} to be of a certain length n; the branches will be automatically symmetrized and the result would be zero. The problem is that we cannot know in advance which leaf will be linked to the root by a long chain.

In relation to previously used form al inversion form ulas, let us mention that it is against QFT wisdom to mix the index space f1;:::;ng and the abstract space E that labels the vertices, as far as the combinatorics are concerned. From a QFT point of view, which adm ittedly is only one am ong m any on the Jacobian conjecture, it is unnatural to use sum s over colored or planar objects, as this reduces symmetry in the resulting expansion instead of enhancing it. We nevertheless concede the point that planarity can serve to \locate" the long chain, and order the trees accordingly, which is the main ingredient of the combinatorial \tour de force" of [34].

O ne of the cases treated in the latter article is that of $F_i(x) = x_i \quad H_i(x)$, with the H_i hom ogenous of the same degree d and the matrix M (x) nilpotent of order 2. This has already been treated in [10] and [13] for instance, but let us sketch how to prove this result with our QFT model. The argument is adapted from an idea by V.R ivasseau.

First perform the translation change of variables ! + y, ! in (3) to get, using Z = 1,

Note that ${}^{2}_{i}(s;y) = 0$ since it contains ${}^{P}_{j=1} M_{jj}(x) = tr M(x)$ at x = + y, and M(x) is nilpotent. Likewise, ${}^{1}_{i}(s;y)$ and ${}^{3}_{i}(s;y)$ vanish since the integrand contains a factor of the form

where we used Euler's identity for the hom ogenous H_i 's, and the fact that M (x) is nilpotent of order 2. As a result $G_i(y) = y_i + H_i(y)$.

III.3 The Pauli exclusion principle

In order to be able to prove the Jacobian conjecture by purely combinatorial means, one needs to exhibit a volum e e ect similar to the Pauli exclusion principle, as otherwise one would not see the niteness of the index set f1;:::;ng within the strictly tensorial Feynm an diagram matic notation were indices are contracted i.e. sum med over. One would have to have Fermions, instead Bosons, entering the picture. Let us mention three, typically eld theoretic, ideas that have not been pursued in previous attempts with the form al inverse approach, and which deserve further investigation.

III.3.1 Supersym m etry

O ne way to introduce Ferm ions in a purely Bosonic model is to exhibit a supersymmetry. If this could be done; it would probably be the \voie royale" towards understanding the conjecture. Unfortunately we have not been able to make much headway in this direction so far. Let us simply mention a strange feature of our model that hints towards a hidden supersymmetry. As a result of our choice of vertices and the fact that the propagators are directed, the perturbation expansion of the one-point function is reduced to a tree graph expansion. This means that the sem i-classical expansion of our model around the \false vacuum " = 0, = 0 is exact. Besides, the \integrals" in (3) which are supposed to be over Cⁿ reduce to the contribution

of a single critical point: the \true vaccum " obtained by solving



that is = G(y) and = 0. This is rem in iscent of the D uisterm aat H eckm an theorem [16] which is known to involve supersymmetry (see [39]).

III.3.2 Renormalization

The G abber inverse degree bound, together with the previously given example that saturates it, suggest that the sought exclusion principle has to act along the chains from the root to the leaves of the trees but not across, i.e. within generations. This is quite odd in view of the eventual introduction of Ferm ionic variables in our model. This how ever hints to the possibility that the problem may come from \divergent" two-point subgraphs i.e. parts of the diagram s that look like


where the to indices i and j coincide. This leads to the following.

Q uestion : Is there a way to elim inate these \divergent" pieces by adding, to the \action" F() y, counter-term s that are made of symmetrized bops?

This is possible for d = 1, that is the Cayley-H am ilton theorem, but does not seem to be the consequence of a natural renorm alization condition on the two-point correlation function. It would be interesting to explore this idea using the new point of view on renorm alization pioneered by A.Connes and D.K reim er [14] since one of their motivations was the study of form al di eom orphism s which is clearly related to our subject material.

III.3.3 R everse M ayer expansion

We have repeatedly mentioned the Cayley-Ham ilton theorem as the d = 1 case of the Jacobian conjecture. Let us now make this more precise. If d = 1 then $F_i(x) = x_i$ $H_i(x)$ with $H_i(x) = \prod_{j=1}^{n} w_{ijj} x_j$ and $M(x) = M = (w_{ijj})_{1 \ ijj} N$. When y = 0, the only interesting connected correlation functions $\langle i_{j_1} ::: i_{j_N} \rangle_{y=0}^c$ are for N = 1, and their Feynman diagram expansion only generates chains of the form



If we use the loop ideal l in the form ulation of the problem in section III.1, then the ensuing statem ent that chains of length n belong to 1, or simply 1 here, is the Cayley-H am ilton theorem. Therefore any combinatorial solution of this problem, for general d, should at the very least reproduce this well known result. Now the Cayley-H am ilton theorem is the statem ent that the derivative of $\frac{1}{z} = \det(I \quad M)$, with respect to a matrix element of M, has a vanishing component in degree n in the M_{ij} variables. This in turn stems from the fact that $\frac{1}{z}$ is itself a polynom ial of degree n in M. We all know this from our \Fermionic/determ inantal" upbringing, but let us suppose for a moment that all we know is B osons and the only expression available to us is Z

It is am using to prove that $\frac{1}{z}$ is a polynom ial in M of degree at most n, using this form ula. Let us explain an answer that is inspired from the M ayer expansion in statistical mechanics (see [33]), and constructive QFT (see [30]).

Consider the partition function Z of a gas of propagators

and vertices

with two kinds of interactions.


- The propagators attach to the vertices in all possible ways, as when applying ${\tt W}$ ick's theorem .

-The propagators can interact by M ayer-links represented by a squiggly line

and carrying a factor _{ij} where i and j are the indices of the two propagators. One also assigns by hand a factor 1 per propagator-vertex loop, which we confess is cheating a bit. Z is therefore a sum of objects like



(66)

with the appropriate symmetry factors, that is $\frac{1}{k}$ for each oriented bop with k vertices, an overall $\frac{1}{m!}$ if there are m bops, and a global sign (1)^m. On the

one hand, if one sum s over the structure of M ayer-links, with xed contraction of the propagators to the vertices, one rebuilds a \hardcore constraint" factor $(1 \quad _{ij})$ for each pair of propagators, which is the opposite of the operation one would do in a standard M ayer expansion. Since the available index space f1;:::;ng has cardinality n, there cannot be m ore than n propagators in a nonvanishing graph, ergo Z is of degree at m ost n in M . On the other hand, $\log Z$, is a sum over connected objects like those of (66), where connectedness involves both types of lines. W hen one sum s over W ick contractions, with xed con guration of M ayer-links, the result is zero as soon as there is at least one M ayer-link, because of the follow ing exchange m ove along the M ayer-link.

Indeed such a move does not a ect the amplitudes, but modi es the loop count by one unit and thus the sign of the graph (compare with [37]). As a result, $\log Z$ is a sum over single loops without M ayer-links and with a single (-1) factor. That is $\log Z = \log Z$ which concludes the argument.

An interesting question raised by this approach is

Question : Is there a hyperdeterm inant, in the sense of [19], that would play, when d 2, the role played by $\frac{1}{z}$ when d = 1, and that would, upon derivation with respect to a tensor element $w_{i;j_1...j_d}$ around a solution of the Jacobian condition, give some niteness information on our correlation functions?

III.3.4 A re these three ideas di erent, really?

A lthough we have no precise uni ed fram ework to propose at the mom ent, we are tem pted to say no. The interplay between supersymmetry, renormalization and the M ayer expansion is quite mysterious and is probably related to the combinatorics of the symmetric group and the inclusion-exclusion principle.

W e will conclude by pointing out a few references where some clues on these relationships might be found. Mayer expansions involve coe cients which are M bius functions of certain partition lattices (see [31]). These coe cients can be calculated by an analog of the classical forest form ula of Z in m em ann in renorm alization theory (see the introduction to chap. 4 of β]). They can also be expressed using the so called B rydges-K ennedy forest form ula [11] that was rst proved there using the H am ilton-Jacobi equation. In [4] we gave a purely algebraic proof of the latter using som e partial fraction com binatorial identities (Lem m a II.2 in [4]). Such identities have been given a very elegant interpretation in term sofm inim al factorizations of permutations as a product of transpositions [26]. The global sign in the M ayer coe cients is (1)^k where k is the number of edges in the forest. This sign obviously becomes the signature of the permutation in the latter interpretation. This strongly suggests a relationship between M ayer expansions and Ferm ions which was also alluded to in [30]. Note nally that the Brydges-K ennedy identity was considerably generalized in [5] (section III.2.1), where critical use is made of shu es and a kind of Chen's lemma (see rem arks follow ing the proof of Lemma 9), although we did not know this at the time.

IV Conclusion

We hope to have provided enough evidence that the Jacobian conjecture is a very beautiful combinatorial challange, where mathematicians, either conceptually of computationally inclined, and theoretical physicists could fruitfully share their know ledge. While future progress on the conjecture itself is still uncertain, there are bound to be bene to from such an interdisciplinary collaboration on this problem.
