# ON A CONJECTURE OF AUSLANDER AND REITEN

#### CRAIG HUNEKE AND GRAHAM J.LEUSCHKE

Abstract. In studying Nakayam a's 1958 conjecture on rings of in nite dominant dimension, Auslander and Reiten proposed the following generalization: Let be an Artin algebra and Magenerator such that Ext<sup>i</sup> (M; M) = 0 for all i 1; then M is projective. This conjecture makes sense for any ring. We establish Auslander and Reiten's conjecture for excellent Cohen (Macaulay normal domains containing the rational numbers, and slightly more generally.

## 0. Introduction

The generalized Nakayama conjecture of M. Auslander and I. Reiten is as follows [4]: For an Artin algebra, every indecomposable injective—module appears as a direct summand in the minimal injective resolution of . Equivalently, if M is a nitely generated—generator such that  $\operatorname{Ext}^i(M;M)=0$  for all i 1, then M is projective. This latter formulation makes sense for any ring, and Auslander, S.D ing, and . Solberg [3] widened the context to algebras over commutative local rings.

Conjecture (AR). Let be a Noetherian ring nite over its center and M a nitely generated left -module such that  $Ext^i$  (M; ) =  $Ext^i$  (M; M) = 0 for all i > 0. Then M is projective.

In the same paper, Auslander and Reiten proved AR for modules M that are ultimately closed, that is, there is some syzygy N of M allof whose indecomposable direct summands already appear in some previous syzygy of M. This includes all modules over rings of nite representation type, all rings—such that for some integer n, has only a nite number of indecomposable summands of nth syzygies, and all rings of radical square zero.

A uslander, D ing, and Solberg [3, P roposition 1.9] established AR in case is a quotient of a ring of nite global dimension by a regular sequence. In fact, in this case they prove something much

stronger: If Ext<sup>2</sup> (M; M) = 0, then pd M < 1 [B, Proposition 1.8]. This in turn was generalized by L. Avram ov and R. O. Buchweitz [5, Theorem 4.2]: A nite module M over a (commutative) complete intersection ring R has nite projective dimension if and only if  $\operatorname{Ex}_R^{2i}$  (M; M) = 0 for some i > 0.

M. Hoshino [9] proved that if R is a symmetric Artin algebra with radical cube zero, then  $\operatorname{Ext}^1_R(M;M)=0$  implies that M is free. Huneke, L.M. Sega, and A.N. Vraciu have recently extended this to prove that if R is Gorenstein local with  $\operatorname{m}^3=0$ , and if  $\operatorname{Ext}^1_R(M;M)=0$  for some i. 1, then M is free, and have further veri ed the Auslander-Reiten conjecture for all nitely generated modules M over Artinian commutative local rings (R;m) such that  $\operatorname{m}^2M=0$  [11]. In particular, this veri es the Auslander-Reiten conjecture for commutative local rings with  $\operatorname{m}^3=0$ .

The assumption that be nite over its center is essential, given a counterexample due to R. Schultz [15].

Our main theorem establishes the AR conjecture for a class of commutative Cohen (Macaulay rings and well-behaved modules. Moreover, our result is elective; we can specify how many Ext are needed to vanish to give the conclusion of AR.

M ain Theorem. Let R be a Cohen {Macaulay ring which is a quotient of a locally excellent ring S of dimension d by a locally regular sequence. Assume that S is locally a complete intersection ring in codimension one, and further assume either that S is Gorenstein, or that S contains the eld of rational numbers. Let M be a nitely generated R-module of constant rank such that

Then M is projective.

The restriction imposed on R by assuming that S be locally complete intersection in codimension one is equivalent to assuming that R is a quotient by a regular sequence of some normal domain T, by [10, Theorem 3.1]. However, replacing S by T according to the construction in [10] would increase d, the number of Ext required to vanish. In any case, this observation gives the following corollary.

Theorem 0.1. Let R be a Cohen {Macaulay ring which is a quotient of a locally excellent ring S of dimension d by a locally regular sequence. Assume that S is locally a complete intersection ring

in codimension one, and further assume either that S is Gorenstein, or that S contains the eld of rational numbers. Then the AR conjecture holds for all nitely generated R-m odules, that is, if  $\operatorname{Ext}^i_R(M;R) = \operatorname{Ext}^i_R(M;M) = 0$  for all i > 0, then M is projective.

Not every zero-dim ensional ring R is a factor of a ring S as in the theorem, since not all Artinian local rings can be smoothed. For example, Anthony Iarrobino has pointed out that the easiest such example is a polynomial ring in four variables modulo an ideal generated by seven general quadrics (note, however, that the cube of the maximal ideal of such a ring is zero, so this case is covered by [11]). For other examples of non-smoothable rings, see Mum ford [14].

In the next section we prove some preliminary lemmas, and then prove the main result. This requires extra work regarding the trace of a module. Since we could not not a satisfactory reference for what we needed, we include basic facts concerning the trace in an appendix.

Throughout the following, all rings are Noetherian and all modules nitely generated. For an R-module M, we de ne the dual of M by M = Hom R (M;R). There is a natural hom om orphism M: M! M de ned by sending x 2 M to \evaluation at x". We say that M is torsion-free if M is injective, and re exive if M is an isomorphism. It is known (cf. [2, Theorem 2.17], for example) that M is torsion-free if and only if M is a rst syzygy, and re exive if and only if M is a second syzygy. We will say that a torsion-free R-module M has constant rank if M is locally free of constant rank at the minimal primes of R. This is equivalent to K R M being a free K-module, where K is the total quotient ring of R obtained by inverting all nonzerodivisors.

## 1. Proof of the Main Theorem

We begin by observing that the vanishing of Ext and the projectivity of M are both local questions, so that in proving our main theorem we may assume that both S and R are local. Furthermore, since S is assumed to be excellent we can (and do) complete S at its maximal ideal without loss of generality.

Next we point out the following consequence of the lifting criterion of Auslander, Ding, and Solberg [3, Proposition 1.6].

Lem m a 1.1. Let S be a complete local ring, x 2 S a nonunit nonzerodivisor, and R = S=(x). A ssum e that there exists t 2 such that for any S-m odule N ,  $\operatorname{Ext}_S^i$  (N ; N ) =  $\operatorname{Ext}_S^i$  (N ; S) = 0 for

i=1;:::;t implies that N is free. Then for any R-module M,  $Ext_R^i$  (M; M) =  $Ext_R^i$  (M; R) = 0 for i=1;:::;t implies that M is free. Furthermore, if AR holds for S-modules then it holds for R-modules.

Finally, repeating the argument with \alli 1" in place of i = 1; :::t" gives the last statement.

With Lemma 1.1 in mind, we now focus on the case R=S in our main theorem. Indeed, if dim (S) 1, then S is locally a complete intersection ring by hypothesis, and hence R is as well. By [3, P] roposition 1.9], then, AR holds for R-modules. So we may assume that R=S, and in particular we take d=d in R. Our next goal is to modify the module M.

Lem m a 1.2. [4, Lem m a 1.4] In proving the M ain Theorem , we may replace M by  $syz_R^n$  (M), where n=m axf2; d+1g, and assume that M is re-exive and that  $Ext_R^i$  (M; R) = 0 for i=1;:::;d. In proving AR, we may replace M by any syzygy module  $syz_R^t$  (M).

Proof. Put N =  $syz_R^n$  (M ). It is a straightforward computation with the long exact sequences of Ext to show that if Ext\_R^i (M ;M ) = 0 for i = 1;:::;d and Ext\_R^i (M ;R) = 0 for i = 1;:::;2d + 1, then Ext\_R^i (N ;N ) = 0 for i = 1;:::;d and Ext\_R^i (N ;R) = 0 for i = 1;:::;d. A ssum e, then, that we have shown that N is free. Then since Ext\_R^n (M ;R) = 0, the n-fold extension of M by N consisting of the free m odules in the resolution of M must split, so M is free as well. This proves the last statem ent.

To prove that N is re exive and  $\operatorname{Ext}_R^i$  (N ;R) = 0 for i = 1;::;d, one shows by induction on t that  $\operatorname{Ext}_R^i$  ((syz\_R^t (M )) ;R) = 0 for i = 1;::;t. For the base case t = 2, observe that since

 $\operatorname{Ext}^{i}_{R}(M;R) = 0$  for i = 1;2, the dual of the exact sequence

(\*) 
$$0 ! syz_R^2 (M) ! F_1 ! F_0 ! M ! 0;$$

where  $F_1$  and  $F_0$  are free modules, is still exact. Dualizing again gives (\*) back, so  $N = syz_R^2$  (M ) is re-exive and satis es  $Ex_R^{\frac{1}{2}}$  (N ;R) = 0 for i=1;2. For the inductive step, dimension-shifting shows that if  $Ext_R^{\frac{1}{2}}$  (M ;R) = 0 for  $i=1;\ldots;t-1$ , then  $Ext_R^{\frac{1}{2}}$  ((syz\_R^1 (M ));R) = 0 for  $i=2;\ldots;t$ , and the same argument as above shows that  $Ext_R^1$  ((syz\_R^1 (M ));R) = 0.

It is worth noting that if R is a Cohen {M acaulay (CM) ring, then  $syz_R^d$  (M) is a maximal Cohen { M acaulay (M CM) m odule for any M. A lso, the replacement in Lemma 12 has consequences for the assumptions (1) in the main theorem: If Ext\_R^i (M;R) = 0 for i = 1;:::;t, then Ext\_R^i (syz\_R^i (M);R) = 0 for i = 1;:::;t. 1. This observation combines with Lemmas 1.1 and 1.2 to reduce the proof of our main theorem to the following:

Theorem 1.3. Let (R;m) be a complete local CM ring of dimension d which is a complete intersection in codimension one. Assume either that R is Gorenstein, or that R contains Q. Let M be a MCM R-m codule of constant rank such that for i=1; :::;d,

Then M is free.

We postpone the proof of Theorem 1.3 to the end of this section, and establish some preparatory results.

By Cohen's structure theorem, the complete local ring R is a homomorphic image of a regular local ring, and so has a canonical module!. Since R is complete intersection in codimension one, it is in particular Gorenstein at the associated primes, and so! has constant rank. Hence! is isomorphic to an ideal of R. For a M CM R-module N, we write N - for the canonical dual  $Hom_R(N;!)$ .

We next apply a result found in [6, Corollary B4] (see also [8, Lem m a 2.1]):

Proposition 1.4. Let R be a CM boal ring with a canonical module ! and let N be a M CM R-module. If Ext $_R^i$  (N; R) = 0 for i= 1;:::;dim R then ! R N = (N )- is a M CM R-module.

Applied to our current context, this gives the following fact.

C orollary 1.5. Under our assumptions (2) in Theorem 1.3, both !  $_{\rm R}$  M and !  $_{\rm R}$  M are MCM R-m odules.

We will also show that the triple tensor product!  $_R$  M  $_R$  M is MCM, but for this we use the following lem ma. It requires that we add one further assumption to (2): that the module M in question has constant rank.

Lem m a 1.6. Let (R; m; k) be a CM local ring with canonical ideal!, and let N be a M CM R-m odule of constant rank. Assume that  $H \circ m_R$  (N; N) is also a M CM R-m odule, and that for some maximal regular sequence  $\underline{x}$ , we have

$$H ext{ om }_R (N;N) = R = (\underline{x}) = H ext{ om }_{R=(x)} (N = \underline{x}N;N = \underline{x}N)$$
:

Then  $\underline{x}$  is a regular sequence on N  $_R$  N - . In particular, N  $_R$  N - is M CM .

Proof. We indicate reduction modulo  $\underline{x}$  by an overline, and use () for the length of a module. We also continue to use - for Hom  $_{\overline{R}}$  (; $\overline{T}$ ) without fear of confusion. Since  $\overline{T} = E_{\overline{R}}$  (k), the injective hull of the residue eld of  $\overline{R}$ , we have (M-) = (M-) for all  $\overline{R}$ -modules M.

First, a short computation using Hom-Tensor adjointness:

$$(\overline{N} \quad \overline{R} \, \overline{N}^-)^- = H \text{ om } (\overline{N} \quad \overline{R} \, \overline{N}^-; \overline{T})$$

$$= H \text{ om } \overline{R} (\overline{N}; \overline{N}^{--})$$

In particular, this im plies that  $(\overline{N} \ \overline{R} \ \overline{N}^-) = ((\overline{N} \ \overline{R} \ \overline{N}^-) - = (H \text{ om } \overline{R} \ \overline{N} \ \overline{N}))$ . Since  $\overline{N} \ R \ N - = \overline{N} \ \overline{R} \ \overline{N}^-$ , our hypothesis yields  $(\overline{N} \ R \ N - ) = (H \text{ om } R \ \overline{N} \ \overline{N})$ . Finally, we compute, using the

fact that N , N  $_{\rm R}$  N -, and H om  $_{\rm R}$  (N ; N ) all have constant rank:

$$(N - R N - ) = (H \circ m_R (N; N))$$

$$= e(\underline{x}; H \circ m_R (N; N))$$

$$= rank (H \circ m_R (N; N)) e(\underline{x}; R)$$

$$= rank (N)^2 e(\underline{x}; R)$$

$$= rank (N - R N - ) e(\underline{x}; R)$$

$$= e(\underline{x}; N - R N - )$$

Here  $e(\underline{x};)$  denotes the multiplicity of the ideal  $(\underline{x})$  on the module. The second equality follows since we have assumed that  $H \circ m_R (N; N)$  is also a MCM R-module. The equality of the rst and last items in plies that  $N = R \cdot N - is M \cdot CM$  by [7, 4.6.11].

Proposition 1.7. Let (R;m) be a CM local ring with canonical ideal! and let M be a re exive R-m odule of constant rank such that  $Ext_R^i$   $(M;M) = Ext_R^i$  (M;R) = 0 for i = 1; :::;d = dim R. Then! RM RM is a MCM R-m odule.

Proof. We will take N = M in Lemma 1.6. By Proposition 1.4, M -= !  $_R$  M , so we need only show that Hom  $_R$  (M; M) cuts down correctly. Induction on the length of a regular sequence  $\underline{x}$ , using the vanishing of Ext $_R^i$  (M; M), then proves that  $\underline{x}$  is also regular on Hom  $_R$  (M; M) and that Hom  $_R$  (M; M)  $_R$  R=( $\underline{x}$ ) = Hom  $_{R=(\underline{x})}$  (M= $\underline{x}$ M; M= $\underline{x}$ M); nishing the proof.

Proposition 1.8. In addition to the assumptions (2) of Theorem 1.3, suppose also that M has constant rank. Then !  $_{\rm R}$  M  $_{\rm R}$  M is a M CM R -m odule. Furtherm ore, the natural hom om orphism

where is de ned by (f x)(y) = f(y) x, is in jective.

Proof. The rst statement follows im mediately from Proposition 1.7. For the second, pass to the total quotient ring K of R. Since R is generically G orenstein, ! R K = K, and since M has a rank, M R K is a free K-module. Since is an isomorphism when M is free, the kernel of 1 must be torsion. But ! R M R M is MCM, and so torsion-free. Hence the kernel of 1 is zero.

We return to the assumptions of Theorem 1.3: (R; m; k) is a complete local CM ring with a canonical ideal!, and M is a torsion-free R-m odule of constant rank, satisfying

$$\operatorname{Ext}_{R}^{i}\left(M;M\right)=0;$$

$$\operatorname{Ext}_{R}^{i}\left(M;R\right)=0; \text{ and }$$

$$\operatorname{Ext}_{R}^{i}(M;R) = 0;$$
 for  $i = 1; ::: ; d = \dim R$ .

We also assume that R is locally a complete intersection ring in codimension one. As we observed above, this implies by the work of Auslander, Ding, and Solberg that M is locally free in codimension one. We therefore assumed 2. The following lemma is standard. (See [13, Theorems 16.6, 16.7].)

Lem m a 1.9. Let (R; m; k) be a CM local ring of dimension at least 2. Let X be a M CM R-module and L a module of nite length over R. Then  $Ext_R^1$  (L; X) = 0.

Recall from Proposition 1.8 that under the assumptions (3), the homomorphism 1 :!  $_R$  M  $_R$  M !!  $_R$  Hom $_R$  (M; M) is injective.

Lem m a 1.10. If M is locally free on the punctured spectrum, then the hom om orphism 1 is a split monomorphism with cokernel of nite length.

Proof. We have the following exact sequence:



Since M is locally free on the punctured spectrum, 1 is an isomorphism when localized at any nonmaximal prime of R, which forces C to have nite length. Since!  $_R$  M  $_R$  M is MCM by Proposition 1.8, Ext $_R^1$  (C;!  $_R$  M  $_R$  M) = 0, and so (4) splits.

Proof of Theorem 1.3. We will proceed by induction on  $d = \dim R$ . As mentioned above, the case d = 1 follows from [3, Proposition 1.9], so we may assume d = 2, and that the statement is true for all modules over CM local rings matching our hypotheses (3) and having dimension less than that of R. In particular, we may assume that M is locally free on the punctured spectrum. Also, we may assume that M is indecomposable.

First assume that R is Gorenstein. Then  $: M \times_R M : Hom_R (M;M)$  must be a split monomorphism with cokernel of nite length, by Lemma 1.10. Since  $Hom_R (M;M)$  is torsion-free, this implies is an isomorphism, and hence that M is free.

Next assume that R is not necessarily Gorenstein, but contains the rationals. Consider the following diagram involving the trace homomorphism (see Appendix A).



By Lem m a A.6, the diagram com m utes. Furtherm ore, by Lem m a 1.10, 1 is a split m onom orphism with nite-length  $cokernel\ C$ , so ! R Hom R (M; M) has C as a direct sum m and and 1 is surjective onto the  $com\ plem$  ent. Since! is torsion-free, 1 tr m ust kill C.

As R contains Q, rank M is invertible and so tr is surjective by Corollary A.5. It follows that the composition 1 tr is surjective, so that 1 ev is as well. In other words, the evaluation map M  $_{\rm R}$  M  $_{\rm R}$  R induces a surjection when tensored with !. By Nakayama's Lemma, then, the evaluation map is surjective, and it follows that M has a free direct summand. Since M is indecomposable, M is free.

# Appendix A. The Trace of a Module

In this section we give a general description of the trace of a module. Our treatment is intrinsic to the module, and it satis es the usual properties of a trace de ned for torsion-free modules over a normal domain. We include full proofs for convenience.

Throughout this section, let R be a Noetherian ring with total quotient ring K; that is, K is obtained from R by inverting all nonzerodivisors. Let M be a torsion-free R-m odule. The trace of M will be a certain homomorphism  $tr: Hom_R (M; M) ! R: To de ne the trace, let$

be the natural hom om orphism de ned by  $(f \times)(y) = f(y)$ . Note that dualizing gives a hom omorphism from  $H \circ m_R (M ; M) = H \circ m_R (H \circ m_R (M ; M); R)$  to  $(M \cap_R M) = H \circ m_R (M ; M)$ . It is known (see [12], for example) that is an isomorphism if and only if M is free.

De nition A.1. Assume that : Hom  $_R$  (M; M) ! Hom  $_R$  (M; M) is an isomorphism. The trace of M is de ned by tr = ( )  $^1$  ( $l_M$  ). We say in this case that M has a trace.

Observe that the target of  $is (M_R M)$ , which we have used Hom-Tensor adjointness to identify with Hom  $_R (M)$ ; M). Under this identication, the identity map M! M corresponds to the evaluation map  $ev: M_R M!$  R defined by ev(f x) = f(x). To see this, recall that the Hom-Tensor morphism  $_{ABC}: Hom (A B;C)!$  Hom (A;Hom (B;C)) is defined by  $[_{ABC}(f)(a)](b) = f(a b)$  for a 2 A, b 2 B. Taking A = M, B = M, C = R, we see that for  $x \ge M$  and  $f \ge M$ ,  $[_{MMR}(ev)(f)](x) = ev(f x) = f(x)$ : So  $_{MMR}(ev)$  is the map M! M taking f to f. In particular, we could also define the trace by  $tr = ()^{1}(ev)$ .

Our st proposition generalizes the standard fact that a torsion-free module over a normal domain has a trace.

Proposition A.2. If M  $_p$  is a free  $R_p$ -module for all primes p of height one in R, and R satisfies Serre's condition  $(S_2)$ , then M has a trace.

Proof. We must show that  $: H \circ m_R (M; M) : H \circ m_R (M; M)$  is an isomorphism. Let  $L = \ker()$ ,  $I = \operatorname{im}()$ ,  $C = \operatorname{coker}()$ . Then dualizing gives two exact sequences:

0 ! C !  $(Hom_R (M ; M))$  ! I !  $Ext_R^1 (C; R)$ 

Since is an isomorphism at all minimal primes of R, the annihilator of L is not contained in any minimal prime. Hence L is a torsion module, and so L=0.

Since, further, is an isomorphism at all primes of height one in R, the annihilator of C is not contained in any height-one prime. By the assumption that R satis es condition  $(S_2)$ , then, grade (Ann C) 2, so C = Ext<sub>R</sub> (C; R) = 0. This shows that is an isomorphism.

Lem m a A .3. For f 2 Hom  $_R$  ( $R^n$ ;  $R^n$ ), tr(f) is the sum of the diagonal entries of a matrix representing f.

Proof. Since  $R^n$  is free, is an isomorphism already, and of course is as well. Write  $f = \begin{pmatrix} P & \\ & i=1 \end{pmatrix} a_{ij}g_j$   $e_i$ ; where  $e_i$  and  $g_i$  are the canonical bases for  $R^n$  and its dual, respectively. Then since  $g_j(e_i) = e_j$ , we see that

as desired.

Recall that the torsion-free R-m odule M is said to have constant rank n if K  $_R$  M is a free K-m odule of rank n. If this is the case, we x a basis feq;:::; $e_n$ g for K  $_R$  M , and let  $fg_1$ ;:::; $g_n$ g be the dual basis, so that  $g_i$  ( $e_1$ ) =  $_{i1}$ .

Lem m a A .4. Assume that M is a torsion-free R-m odule of constant rank and that M has a trace. Then for any f 2 M and x 2 M, we have  $x = \frac{P}{i=1} g_i(x) e_i$  and  $tr(f) = \frac{P}{i=1} g_i(f)(e_i)$ ; where f = K R f.

Proof. Since M is torsion-free, it embeds into a free R-m odule and so the hom om orphism M! KR M is injective. Considering x as an element of KRM, write  $x = \frac{P}{j=1}^n a_j e_j$ ; where the  $a_j$  are elements of K. Then a short computation using the denition of the q shows that  $\frac{P}{i=1}^n g_i(x)e_i = x$ . For the other assertion, pass to the total quotient ring K. Since KRM is free, Lemma A.3 implies that the trace of P is the sum of the diagonal elements of a matrix  $(a_{ij})$  representing P. Since  $g_i(P)(e_i) = a_{ii}$ , the statement follows.

C orollary A .5. Assume that M is a torsion-free module of constant rank and has a trace. If rank (M) is invertible in R, then tr is surjective from  $H \circ m_R (M)$  to R.

Lem m a A .6. Assume that M is a torsion-free of constant rank and that M has a trace. Then we have tr = ev as hom om orphisms from M  $_R$  M to R.

Proof. For any f 2 M and x 2 M, a straightforward computation using Lemma A.4 shows that f(x) = tr((f x)).
