A Particular Bit of Universality: Scaling Limits of Some Dependent Percolation Models

A bstract

We study families of dependent site percolation models on the triangular lattice T and hexagonal lattice H that arise by applying certain cellular automata to independent percolation congurations. We analyze the scaling limit of such models and show that the distance between macroscopic portions of cluster boundaries of any two percolation models within one of our families goes to zero almost surely in the scaling limit. It follows that each of these cellular automaton generated dependent percolation models has the same scaling limit (in the sense of Aizenman-Burchard [3]) as independent site percolation on T.

Keywords: continuum scaling limit, dependent percolation, universality, cellular autom aton, zero-tem perature dynamics.

1 Introduction

The phase diagram sofm any physical system shave a \critical region" where all traditional approximation methods, such as mean-eld theory and its generalizations, fail completely to provide an accurate description of the system's behavior. This is due to the existence of a \critical point," approaching which, some statistical mechanical quantities diverge, while others stay nite but have divergent derivatives. Experimentally, it is found that these quantities usually behave in the critical region as a power law. The exponents that appear in those power laws, called critical exponents, describe the nature of the singularities at the critical point. The theory of critical phenomena based on the renormalization group suggests that statistical mechanical systems fall into \universality classes" such that systems belonging to the same universality class have the same critical exponents.

It should be emphasized that the phenom enon of universality was discovered at least twice prior to the introduction of the renormalization group. In fact, in what A lan Sokal [45] calls the Dark Ages of the theory of critical phenomena, before the 1940's, physicists generally believed that all systems have the same critical exponents, namely those of the mean-eld theory of Weiss [47] (1907) or its analogue for uids, the van der Waals theory [46] (1873). The failure of this type of universality became apparent as early as 1900, following experiments on uid systems, but it began to be taken seriously only after 0 nsager's exact solution [37] (explicitly displaying non-mean-eld exponents) in 1944 and the rediscovery of the experimental evidence of non-mean-eld values for critical exponents by Guggenheim in 1945 [19]. Nonetheless, although mean-eld theory is clearly incorrect for short range models, some universality does seem to hold. Many, if not all, dierent uids, for instance, seem to have the same value for the critical exponent

(related to density uctuations), and it is believed that, for example, carbon dioxide, xenon and the three dimensional Ising model should all have the same critical exponents. Maybe even more surprisingly, it was soon realized that some (but not all) magnetic systems have the same critical exponents as do the uids. This remarkable phenomenon seems to suggest the existence of a mechanism that makes the details of the interaction irrelevant in the critical region. Nevertheless, the critical exponents should depend on the dimensionality of the system and on any symmetries in the Hamiltonian. Despite being a very plausible and appealing heuristic idea, backed up by renormalization-group arguments and empirical evidence, only very few cases are known in which universality has actually been proved.

Percolation, with its sim plicity and important physical applications, is a natural candidate for studying universality. This is especially so after the ground-breaking work of Lawler, Schramm, and Werner [23, 24, 25, 26, 27, 28, 29, 40], who identied the only possible conformally invariant scaling limit of critical percolation and derived many of its properties, and that of Smirnov [42, 43], who proved that, indeed, critical site percolation on the triangular lattice has a conformally invariant scaling limit. The combination of those results made it possible [44] to verify the values of the critical exponents predicted in the physical literature in the case of critical site percolation on the triangular lattice (and to derive also some results that had not appeared in the physics literature, such

as an analogue of C ardy's formula \in [41], or the description of the so-called backbone exponent [27]).

It is generally accepted that the lattice should play no role in the scaling lim it, and that there should be no di erence between bond and site percolation. In other words, two-dimensional critical (independent) percolation models, both site and bond, should belong to the same universality class, regardless of the lattice (at least for periodic lattices like the square, triangular or hexagonal lattice). Once again, though, despite being a very natural and plausible conjecture, such universality has not yet been proved. There is however another natural direction in which to study universality, which consists in analyzing critical percolation models on a given lattice that dier in their dependence structures. It is this direction that we pursue in this paper.

The cellular autom ata that we use to generate our families of dependent percolation models arise naturally in the study of the zero-tem perature limit of G lauber dynamics or as coarsening or agreement-inducing dynamics. The action of such cellular autom ata can be viewed as a sort of \sm all (local) perturbation" of the original, independent percolation model, and our main corollary can be viewed as proving a form of universality for two dimensional percolation. Therefore, we provide an explicit example of the principle of universality, in the strong form concerning scaling limits.

To be more precise, there are at least two, a priori di erent, notions of universality, one concerning the critical exponents discussed above, and a second one concerning the continuum scaling limit. The two concepts are closely related, but in this paper we are only concerned with the second type of universality (the rst type will be considered in a future paper).

We consider a family of dependent percolation models that arise through a (discrete time) determ in istic cellular autom aton T acting on site percolation con gurations on the set of sites of the triangular lattice T. Each conguration corresponds to an assignment of 1 or + 1 to the vertices of T. The variable $_{x}$, corresponding to the value of at x, is commonly called a spin variable. At discrete times n=1;2;:::, each spin $_{x}$ is updated according to the following rules (later, in Section 4, we will introduce other cellular autom ata, both on T and H, generated by dierent rules):

if x has three or m ore neighbors whose spin is the same as $_{\rm x}$, then the latter does not change value,

if x has only two neighbors y_1 and y_2 that agree with x, and y_1 and y_2 are not neighbors, then x_1 does not change value,

otherwise, x changes value: x! x.
```

The starting con guration $\,^{0}$, at time n=0, of our cellular autom aton is chosen from a Bernoulli product measure corresponding to independent critical percolation, and the distributions at times n=1 (including the nal state as n+1) of the discrete time determ inistic dynamical process $\,^{n}$ are the other members of our family of dependent percolation models. We show that all those dependent percolation models have the same

scaling lim it, thus providing an explicit example in which universality can be proven. This comes as a corollary of our main result, Theorem 1. To explain the main result, we rst need some term inology.

In the scaling limit, the microscopic scale of the system (i.e., the lattice spacing) is sent to zero, while focus is kept on features manifested on a macroscopic scale. In the case of percolation, it is far from obvious how to describe such a limit and we only do so brie y here; form one details, see [1,2,3]. We will make use of the approach introduced by A izenman and Burchard [3] (see also [4]) applied to portions of the boundaries between clusters of opposite sign, and present our results in terms of closed collections of curves in the one-point compactication \mathbb{R}^2 of \mathbb{R}^2 , which we identify (via the stereographic projection) with the two-dimensional unit sphere. For each xed > 0, the curves are, before compactication, polygonal paths of step size (i.e., polygonal paths between sites of dual lattice). The distance between curves is de ned so that two curves are close if they shadow each other in a metric which shrinks at in nity (for the details, see Sections 22 and 23).

The dynam ics allows one to construct the whole family of percolation models for all n 2 f0;1;:::;1 g on the same probability space, i.e., there is a natural coupling , realized through the dynam ics, between any two percolation models in the family. In terms of this coupling, Theorem 1 states, roughly speaking, that the -probability that the distance between the two collections of curves corresponding to two distinct percolation models in the family is bounded away from zero vanishes as ! 0. This means that, in the limit ! 0, given any two models in the family, for every curve in one of them, there exists a curve in the other one that shadows the rest curve and vice-versa.

The rest of the paper is organized as follows. In Section 2, we describe the behavior of the cellular autom aton T, de ne the family of dependent percolation models dynamically generated by T, and state the main results. The proofs of the main results are contained in Section 3. The dynamics described in Section 2 is chosen as a prototypical example, but is not the only one for which our results apply. In Section 4, we introduce other such dynamics (both on T and H), which can be obtained as suitable zero-tem perature limits of stochastic Ising models.

2 De nitions and results




Figure 1: The hexagonal (or honeycomb) lattice.

We start this section by giving a more detailed de nition of one of the families of dependent percolation models that are the object of investigation of this paper. The models in that family are dened on the triangular lattice T, embedded in R² by identifying the sites of T with the elementary cells (i.e., regular hexagons) of the hexagonal (or honeycomb) lattice H (see Figure 1). We will use those models as a paradigm and will give for them explicit and detailed proofs of the results. Later on, we will point out how to modify the proofs to adapt them to the other models discussed in the paper.

In the rest of the paper, points of R^2 will be denoted by u and v, while for the sites of T we will use the Latin letters x, y, z and the G reek letters and . An edge of T

incident on sites x and y will be denoted by $_{x,y}$, while by $_{x,y}$ we denote the dual edge (in H) perpendicular bisector of $_{x,y}$.

2.1 The dynam ics and the percolation models

We construct a family of dependent percolation models by means of a cellular autom aton T acting on site percolation con gurations on the triangular lattice T, i.e., T:!, where is the set of con gurations f 1;+1g $^{\rm T}$. This family is parametrized by n 2 f0;1;::g [f1 g representing (discrete) time. The initial con guration $^{\rm O}$ consists of an assignment of 1 or+1 to the sites of T. Attimes, we will identify the spin variable $_{\rm X}$ with the corresponding site (or hexagon) x. We choose $^{\rm O}$ according to a probability measure $^{\rm O}$ corresponding to independent identically distributed $_{\rm X}^{\rm O}$'s with $_{\rm O}^{\rm O}$ ($_{\rm X}^{\rm O}$ =+1)= 2 [0;1]. With the exception of Proposition 2.2, we will set = 1=2, so that $_{\rm O}^{\rm O}$ is the distribution corresponding to critical independent site percolation. We denote by $_{\rm O}^{\rm O}$ the distribution of $_{\rm O}^{\rm O}$ and write $_{\rm O}^{\rm O}$, where T is a map in the space of measures on . The action of the cellular autom aton T can be described as follows:




Figure 2: Example of local con guration with unstable spins. The numbered hexagons correspond to spins that will ip and the numbers indicate at what time step the spin ips occur.




Figure 3: Same local con guration after all the unstable spins have ipped.

Once the initial percolation con guration 0 is chosen, the dynamics is completely deterministic, that is, T is a deterministic cellular automaton with random initial state (see Figs. 2 and 3).

Certain con gurations are stable for the dynamics, in other words, they are absorbing states for the cellular automaton. To see this, let us consider a loop in T expressed

as a sequence of sites ($_0$;:::; $_k$) which are distinct except that $_0$ = $_k$ and suppose moreover that $_k$ 6 and that $_{i,1}$ and $_{i+1}$ are not neighbors; we will call such a sequence an m-loop. If $_0$ = $_1$ = ::: = $_{k-1}$ then every site $_i$ in such an m-loop has two neighbors, $_{i,1}$ and $_{i+1}$, such that $_{i,1}$ and $_{i+1}$ are not neighbors of each other and $_{i,1}$ = $_{i+1}$. A coording to the rules of the dynam ics, $_{i}$ is therefore stable, that is, retains the same e sign at all future times. O ther stable congurations are \barbells," where a barbell consists of two disjoint such m-loops connected by a stable m-path. The stability of certain loops under the action of T will be a key ingredient in the proof of the main theorem. A more precise de nition of m-paths and m-loops is given in Section 3.

An important feature of this dynam ics is that almost surely every spin ips only a nite number of times and every local conguration gets xated in nite time. To show this, we introduce a formal Hamiltonian

where N (x) is the set of six (nearest) neighbors of x. W e also introduce a \local energy"

where is a subset of T and @ is the outer boundary of , i.e., f $\not\geq$: x 2 N () for som e x 2 g. Notice that although the total energy H () is almost surely in nite and is therefore only de ned formally, we will only use local energies of nite subsets of T.

The notion of the energy change caused by a spin ip is somewhat ambiguous in a cellular autom aton because of the synchronous dynamics and hence multiple simultaneous spin ips. Nevertheless, it is easy to show (see the proof of Proposition 2.1) that each step of the dynamics either lowers or leaves unchanged the energy { both locally and globally. In this sense, our cellular autom aton can be considered a zero-tem perature dynamics (see, for example, [32] and references therein).

Proposition 2.1. For all values of , almost surely, every spin ips only a nite number of times.

Proof. By the translation invariance and ergodicity of the model, it is enough to prove the claim for the origin. At time zero, and for all values of , the origin is almost surely surrounded by an m-loop of spins of constant sign. (For =1=2, there are in nitely many loops of both signs surrounding the origin.) Such an m-loop is stable for the dynam ics and its spins retain the same sign at all times. Call the (a.s. nite) region surrounded by . The energy H of the nite region is bounded below . Consequently, if we can show that no step of the dynam ics ever raises H , it would follow that there can only be a nite number of steps that strictly lower the energy H .

Call an edge x_{7y} satis ed if x = y and unsatis ed otherwise; then the change in energy H ($^{n+1}$) H (n) is twice the dierence between the number of satis ed edges at time n that become unsatis ed at time n + 1 and the number of unsatis ed edges at time n that become satis ed at time n + 1. The edges that change from satis ed to unsatis ed

or vice-versa are those between spins that ip and their neighbors that do not, so

Notice that the only nonzero contributions in the set sum of (5) come from those sites y 2 that do not ip at timen. We want to show that $_nH_x$ 0 for all x 2 and nd some y with $_nH_y$ < 0 (assuming these was at least one spin ip inside at timen).

CallD $_x^n$ the number of disagreeing neighbors of x at time n and notice that a necessary condition for the spin at site x to ip at that time is D $_x^n$ 4. Let us is the consider the case D $_x^n$ 5 and assume, without loss of generality, that $_x^n = 1$ and $_x^{n+1} = +1$. Then, at time n, site x has at least veplus-neighbors, and at least three of them have plus-spins at time n + 1 (those having at timen two plus-neighbors that are not neighbors of each other). This implies that the number of edges incident on x that change from unsatised to satised is at least three, while the number of edges that change from satised to unsatised is one. Then,




Figure 4: Example of a step of the dynamics acting on a local conguration that leaves the energy of some sites (including x) unchanged and decreases that of other sites (the three spins at the top and the three at the bottom are stable, as determined also by spins that do not appear in the gure).

Next, we consider the case D $_{x}^{n}=4$. A gain, we can assume that $_{x}^{n}=1=\frac{n+1}{x}$. In this case, one can have two types of spin—ips, one with H $_{x}$ ($_{x}^{n+1}$)—H $_{x}$ ($_{x}^{n}$) < 0 and one with H $_{x}$ ($_{x}^{n+1}$)—H $_{x}$ ($_{x}^{n}$) = 0. The second type occurs when, of the four neighbors of $_{x}$ that are plus at time n, two remain plus at time n + 1 (we call them $_{x}$ 1 and $_{x}$ 2) and the other two—ip to minus (we call them $_{x}$ 1 and $_{x}$ 2), while the two neighbors that are minus at time n remain minus at time n + 1 (we call them $_{x}$ 1 and $_{x}$ 2). In this situation, site $_{x}$ 2 disagrees with four of its six neighbors both at time n and at time n + 1 (see Figure 4) and therefore H $_{x}$ ($_{x}$ 1)—H $_{x}$ ($_{x}$ 2) = 0.

The spins at z_1 and z_2 ip together with the spin at x. Each energy, H z_1 and H z_2 , is lowered or left unchanged. If either is lowered, then the energy H z_1 is lowered. If neither is lowered, then z_1 and z_2 must be in the same situation as x (but with minus and plus interchanged), which requires a conguration that looks locally like the one in the left part of Figure 4 (or one equivalent to it under some lattice symmetry). However, such a local conguration cannot extend forever; it must be nite and contained in . It follows that there can only be a nite number of times nat which spins in (in particular, the origin) ip. This completes the proof. \Box

Let us now give two results that are analogous to results proved in [9] for a related cellular autom aton that will be discussed below in Section 4.

Proposition 2.2. If > 1=2 (respectively, < 1=2), then for almost every 0 , there is percolation of +1 (respectively, 1) spins in n for any n 2 [0;1].

Proof. We only give the proof for > 1=2, since the case < 1=2 is the same by symmetry. If > 1=2, since the critical value for independent (Bernoulli) percolation on the triangular lattice is exactly 1=2, there is at time 2 zero percolation of +1 spins. This implies the existence, at time 0, of doubly-in nite plus-paths that are stable. Therefore, there is percolation of +1 spins for all n 0.0

We denote by C_x the cluster at x (for a con guration), i.e., the maximal connected set B 2 T such that x 2 B and $_y = _x$ for all y 2 B. We write C_x (n) to indicate the cluster at x for n . C_x (n) is random and its distribution is denoted n . E $_n$ denotes expectation with respect to n .

P roposition 2.3. For = 1=2, the following two properties are valid.

- 1. For almost every 0 , there is no percolation in n of either + 1 or 1 spins for any n 2 [0;1].
- 2. The mean cluster size in ⁿ is in nite for any n 2 [0;1]: for any x 2 T,

Proof. To prove the rst claim, notice that at time zero the origin is almost surely surrounded by both a plus and a minus m-loop. Those loops are stable and prevent the cluster at the origin, be it a plus or a minus cluster, from percolating at all subsequent times. Therefore the probability that the origin belongs to an in nite cluster is zero for all n 0.

To prove the second claim, we note that because of the absence of percolation for either sign, it follows from a theorem of Russo [39] applied to the triangular lattice, that the m ean cluster size of both plus and m inus clusters diverges. \Box

Before stating our main theorem, we need some more de nitions to formulate the continuum scaling \lim it. We adopt the approach of [3] (see also [4]).

2.2 C om pacti cation of R^2

The scaling lim it ! 0 can be taken by focusing on xed nite regions, R^2 , or by treating the whole R^2 . The second option is more convenient, because it avoids technical issues that arise near the boundary of .

A convenient way of dealing with the whole R^2 is to replace the Euclidean m etric with a distance function d(;) de ned on 2R R^2 by

where the in mum is over all smooth curves (s) joining u with v, parametrized by arclength s, and j jdenotes the Euclidean norm. This metric is equivalent to the Euclidean metric in bounded regions, but it has the advantage of making R² precompact. Adding a single point at in nity yields the compact space R² which is isometric, via stereographic projection, to the two-dimensional sphere.

2.3 The space of curves

Denote by S the complete, separable metric space of continuous curves in \mathbb{R}^2 with a distance D (;) based on the metric de ned by eq10) as follows. Curves are regarded as equivalence classes of continuous functions (t) from the unit interval to \mathbb{R}^2 , modulo monotonic reparametrizations. C will represent a particular curve and (t);t 2 [0;1], a particular parametrization of C, while F will represent a set of curves. The distance D between two curves, C_1 and C_2 , is defined by

where $_1$ and $_2$ are particular parametrizations of C_1 and C_2 , and the in mum is over the set of all monotone (increasing or decreasing) continuous functions from the unit interval onto itself. The distance between two closed sets of curves is defined by the induced Hausdor metric as follows:

For each xed > 0, the random curves that we consider are polygonal paths in the hexagonal lattice \mbox{H} , dual of \mbox{T} , consisting of connected portions of the boundaries between plus and m inus clusters in \mbox{T} . A subscript \mbox{m} ay then be added to indicate that the curves correspond to a model with a \short distance cuto ." The probability measure \mbox{n} denotes the distribution of the random set of curves \mbox{F} \mbox{n} consisting of the polygonal paths on \mbox{H} generated by \mbox{T}^{n} acting on $\mbox{0}$.

2.4 Main results

Since the cellular autom aton is determ inistic, all the percolation models $\,^n$ for n $\,^0$ are autom atically coupled, once they are all constructed on the single probability space (;; $\,^0$) on which $\,^0$ is de ned. The following theorem is valid for any , but $\,^0$ is the only interesting case, therefore we restrict attention to it.

Theorem 1. For = 1=2, the Hausdor distance between the system of random curves F^0 at time 0 and the corresponding system of curves F^n at time n goes to zero almost surely as ! 0, for each n 2 [1;1]; i.e., for 0 -almost every 0 ,

The main application of the theorem is that the scaling \lim its of our family F_1^n of percolation models, if they exist, must be the same for all n 2 [0;1]:

C orollary 2.1. Suppose that critical site percolation on the triangular lattice has a unique scaling lim it in the Aizenman-Burchard sense [3], i.e., F^0 converges in distribution as ! 0 (for = 1=2). Then, for every n 2 [1;1], F^n converges in distribution to the same lim it.

3 Proofs

In this section, we give the proofs of the main results. We start by rem inding the reader of the de nitions of m-path and m-loop and by giving some new de nitions and two lem mas which will be used later.

De nition 3.1. A path between x and y in T (embedded in R^2) is an ordered sequence of sites ($_0 = x; :::;_k = y$) with $_i \notin _j$ for $i \notin j$ and $_{i+1} 2 N (_i)$. A loop is a sequence ($_0; :::;_{k+1} = _0$) with k = 1 such that ($_0; :::;_k$) and ($_1; :::;_{k+1}$) are paths.

We call a path (0;:::;k) (resp., a loop (0;:::;k+1=0)) an m-path (resp., an m-loop) if i_1 and i_{i+1} are not neighbors for i=1;:::;k+1 (resp., for i=1;:::;k+1, where $i_{i+2}=i_1$).

Notice that for every path between x and y, there always exists at least one m-path between the same sites.

De nition 3.2. A boundary path (b-path) is an ordered sequence ($_0 = _{_0;_0}$;:::; $_k = _{_k;_k}$) of distinct dual edges such that either $_{i+1} = _{i}$ and $_{i+1} = _{i}$

We call a maxim alboundary path simply a boundary; it can either be a doubly—in nite path or a nite loop.

b-paths represent the (random) curves introduced in the previous section for a $\,$ xed value of the short distance cuto $\,$. A collection of such curves in the compact space R^2 is indicated by F $\,$.

b-paths are parametrized by functions (t), with t 2 [0;1]. When we write that, for t in some interval $[t_1;t_2]$ (the interval could as well be open or half-open), (t) 2 $_{x,y}$ we mean that the parametrization (t) for t between t_1 and t_2 is irrelevant and can be chosen, for example, so that $\frac{d}{dt}$ j is constant for t 2 $[t_1;t_2]$. The notation (u;v), where u and v can be dual sites or generic points of R 2 , stands for the portion of between u and v.

De nition 3.3. A stable loop 1 (for some) is an m-loop ($_0$ = x;:::; $_k$ = x) such that $_0$ = $_1$ = :::= $_k$.

De nition 3.4. We say that a dual edge $_{x,y}$ is stable if x and y belong to stable loops of opposite sign.

Lem m a 3.1. In general, a constant sign m -path ($_0$;:::; $_k$) is \ xated" (i.e., retains that same sign in n for all 0 n 1) if $_0$ and $_k$ are xated

Proof. The claim of the lem ma is straightforward.

Lem m a 3.2. For = 1=2, there is a one to one mapping from boundaries in Fⁿ⁺¹ to \parent" boundaries in Fⁿ.

Proof. Let $_n$ 2 F n be a boundary at time n and int($_n$) be the set of sites of T (i.e., hexagons) \surrounded" by $_n$. Let C the (unique) constant sign cluster contained in int($_n$) that has sites next to $_n$. Suppose that sites x and y in C do not change sign at time n + 1, then, at that time, they must belong to the same cluster C 0 . (This means that a cluster cannot split in two or more pieces under the elect of the dynamics.) The reason is that x and y are connected by an mepath at time n because they are in the same cluster, and since they have not ipped between time n and time n + 1, Lemma 3.1 (or more accurately, the single time step analogue of Lemma 3.1) in plies that the sites in have not ipped either, so that x and y are still connected at time n + 1 and therefore belong to the same cluster.

If at least one site x in C does not change sign at time n+1, we say that C has survived (and evolved into a new cluster C^0 that contains x at time n+1). From what we just said, the sites of C that retain the same sign form a unique cluster C^0 . We call C the parent cluster of C^0 and the external boundary $C = C^0$ of $C = C^0$ the parent of the external boundary $C = C^0$ (note that C^0 is a.s. nite { see Proposition 2.3).

To prove that there is a one to one mapping between boundaries in F^{n+1} and those in F^n , it remains to show that the parent boundary of each element of F^{n+1} is unique. (This means that clusters cannot merge under the elect of the dynamics.)

If this were not the case, then a cluster C 0 could have two or more distinct parent clusters, C_{1} ; C_{2} ; Notice that each of the parent clusters at time n is surrounded by a constant sign m-loop $_{i}$, i=1;2;..., which is stable. Suppose that x_{1} 2 C_{1} and x_{2} 2 C_{2} retain their sign at time n+1. W ithout loss of generality, we shall assume that this sign is plus. Assuming that C_{1} and C_{2} are both parents of C^{0} , x_{1} and x_{2} should both belong to C^{0} at time n+1 and therefore be connected by a plus-path. But this contradicts the fact that, at time n, x_{1} 2 int $(_{1})$ and x_{2} 2 int $(_{2})$, that is, they belong to the interiors of two disjoint stable minus-loops. \Box

Notice that boundaries cannot be \created," but can \disappear," as complete clusters are \eaten" by the dynam ics.

3.1 Proof of Theorem 1

Let us start, for simplicity, with the case of a single b-path. For any " > 0, given a b-path $_0$ at time 0, parametrized by some (t), we will not a path $_n$ at time n with parametrization 0 (t) such that, for small enough,

We start by showing that, thanks to the choice of the metric (10), one only has to worry about curves (or polygonal paths) that intersect $B^1(6=")$. Thus, given any curve in F 0 contained completely in R 2 nB 1 (6="), it can be approximated by any curve in F n also contained in R 2 nB 1 (6="), and viceversa. The existence of such curves in F 0 is clearly not a problem, since the region R 2 nB 1 (6=") contains an in nite subset of T and therefore there is zero probability that it doesn't contain any b-path at time zero. There is also zero probability that it contains no stable b-path at time zero, but any such b-path also belongs to F n .

Before we can proceed, we need the following lemma, which is a consequence of the the fact that at time zero we are dealing with a Bemoulli product measure. In this lemma

(and elsewhere), the diam eter diam () of a subset of R is dened by using the Euclidean metric.

Lem m a 3.3. Let $_0$ be any (determ inistic) dual edge; then for som e constant c > 0,




Figure 5: Elementary cell for the partition of H used in Lemma 3.3. Notice that the cell is made out of seven smaller cells, each of them formed by seven hexagons.

Proof. To prove the lemma, we partition the hexagonal lattice into regions Q_i as in Figure 5. We then do an algorithm is construction of , starting from $_0$, as a percolation exploration process, but with the additional rule that, when the exploration process hits the boundary of any Q_i for the rst time, all the hexagons in Q_i are checked next (according to some deterministic order). From every entrance point of Q_i , there is a choice of the values of the spins of the outermost layer of Q_i that forces to enter Q_i . Therefore, when hits Q_i , it always has a positive probability of entering the region.

We call F_i the event that a (dual) stable edge is found inside Q_i , belonging to . It is easy to see that such an event has positive probability, bounded away from zero by a constant that does not depend on how the exploration process enters the region Q_i . In fact, from any entrance point, there is clearly a choice of the values of the spins in Q_i that forces to cut Q_i in two symmetric parts, containing spins of opposite sign.

Now, if diam () M, then must clearly visit at least 0 (M) dierent regions Q $_{\rm i}$. The conclusion of the proof should now be clear (see, for example, [15]). $_{\rm II}$

W ith this lemma, we can now proceed to the proof of the theorem. As explained before, we restrict attention to paths that intersect B 1 (6="). G iven a b-path $_0$ = ($_0$ = $_{0;0}$;:::; $_k$ = $_{k;k}$) in F 0 w ith parametrization (t), call u_0 the point in R 2 where the rst (dual) edge $_0$ begins. The following algorithmic construction produces a sequence u_0 ;:::; u_N of points in $_0$.

- 1. Start with u_0 .
- 2. During the construction of the sequence u_0 ;:::; u_N , $_0$ is split in N+1 pieces, the rst N having diam eter at least "=3. The construction also produces a sequence of balls $B_{u_0}^{j_0}$ ("=3);:::; $B_{u_N}^{j_N}$ ("=3), with $j_i=1$ or 2. N otice that no two successive u_i 's can lie outside of B^1 (6="). In fact, if for some i, u_i lies outside of B^1 (6="), u_{i+1} belongs to $(B_{u_i}^2)$ ("=3), which is contained inside B^1 (6="), due to the choice of the metric. Each u_i contained in B^1 (6=") lies on an edge of B^1 , but no more than one B^1 (and B^1 is self-avoiding and cannot use the same edge or site more than once. Also, the number of B^1 is lying outside of B^1 (6=") cannot be larger than (one more than) the number of the B^1 is lying inside B^1 (6="). Therefore, D^1 const D^1 (") D^2 .

For any two successive balls, B $_{u_i}^{j_i}$ ("=3) and B $_{u_{i+1}}^{j_{i+1}}$ ("=3), let O $_i$ = B $_{u_i}^{j_i}$ ("=3 +) [B $_{u_{i+1}}^{j_{i+1}}$ ("=3 +). Now assume that there exists a sequence $_0$;::: $_{N-1}$ of stable (dual) edges of $_0$, with $_i$ contained in $_0$ (u_i ; u_{i+1}). $_0$ ($_i$; $_{i+1}$) is contained in O $_i$ (for xed " and small enough). A lso contained in O $_i$ are the two paths (i.e., paths in T which may be thought as sequences of hexagons) whose hexagons are next to $_0$ ($_i$; $_{i+1}$), one on each side. From those two paths one can extract two subsets that are m-paths which are stable since the rst and last hexagons of each one of them is stable (such hexagons must be stable since they are next to $_i$ and $_{i+1}$). The two m-paths so constructed constitute a \barrier" that \lim_i its the movements of the boundary, so that $_n$ ($_i$; $_{i+1}$) is in fact con ned to lie within those two m-paths and thus within O $_i$. To parametrize $_n$, we use any parametrization 0 (t) such that 0 (t) = (t) whenever (t) 2 $_i$. U sing this parametrization and the previous fact, it is clear that the distance between $_0$ ($_i$; $_{i+1}$) and $_n$ ($_i$; $_{i+1}$) does not exceed "+2, the diameter of O $_i$. Therefore, conditioning on the existence of the above sequence $_0$;:::; $_{N-1}$ of stable (dual) edges of $_0$, we can conclude that

for som e $c^0 > 0$. Equation (18) m eans that the probability of not noting at least one stable edge in each of the rst N pieces of $_0$ is very small and goes to 0, for xed ", as ! 0. This is enough to conclude that, with high probability (going to 1 as ! 0), equation (17) holds.

This proves one direction of the claim, in the case of a single curve. To obtain the other direction, notice that a large b-path at timen is part of a complete boundary which must come from a line of \ancestors" (see Lemma 3.2) that starts with some $_{0}$ at time 0. Therefore, one can apply the above arguments to $_{0}$, provided that the latter is large enough. A lthough the proof of this last fact is very simple, it is convenient to state it as a separate lemma.

Lem m a 3.4. Set = 1 for sim plicity; then for any boundary $_n$ at time n, there is an ancestor $_0$, with diam $(_0)$ diam $(_n)$ 1.

Proof. The existence of an ancestor $_0$ comes from Lemma 32, so we just have to show that diam ($_0$) diam ($_n$) 1. $_0$ is surrounded by a connected set of hexagons that touch $_0$ and whose spins are all the same (this is the \external boundary" of the set of hexagons that are in the interior of $_0$). From this set, one can extract an m-path of constant sign whose diam eter is bounded above by diam ($_0$) + 1. Since such a constant sign m-path is stable for the dynam ics, $_n$ m ust lie within its interior. This concludes the proof. \square

At this point, we need to show that the above argument can be repeated and the construction done simultaneously for all curves in F 0 and F n (for each n). First of all notice that, for a xed ", any b-path of diameter less than "=2 can be approximated by a closest stable edge, provided that one is found within the ball of radius "=2 that contains the , with the probability of this last event clearly going to 1 as ! 0, when we restrict attention to B 1 (6="). For a b-path outside B 1 (6="), we already noticed that it can be approximated by any other b-path also outside B 1 (6="). As for the remaining b-paths, notice that the total number of boundaries that intersect the ball B 1 (6=") cannot exceed const (") 2 (in fact, the total number of pieces in which the boundaries that intersect B 1 (6=") are divided cannot exceed const (") 2). So, we can carry out the above construction simultaneously for all the boundaries that touch B 1 (6="), having to deal with at most const (") 2 segments of b-paths of diameter of order at least ". Therefore, letting Y n = dist (F 0 ; F n), we can apply once again Lemma 3.3 and conclude that

3.2 Proof of Corollary 2.1

The Corollary is an immediate consequence of Theorem 1 and of the following general fact, of which we include the proof for completeness.

Lem m a 3.5. If fX g; fY g (for > 0), and X are random variables taking values in a complete, separable metric space S (whose -algebra is the Borel algebra) with fX g and fY g all de ned on the same probability space, then if X converges in distribution to X and the metric distance between X and Y tends to zero almost surely as ! 0, Y also converges in distribution to X.

Proof. Since X converges to X in distribution, the family fX g is relatively compact and therefore tight by an application of Prohorov's Theorem (using the fact that S is a complete, separable metric space { see, e.g., [7]). To conclude the proof of the Corollary, it is enough to apply Lemma 3.5 to f $^0{\rm g}$, f $^n{\rm g}$, $_{\rm sl}$ (or, to be more precise, to the random variables of which those are the distributions), for each n 2 [1;1], where $_{\rm sl}$ is the unique scaling limit of critical site percolation on the triangular lattice. $_\square$

4 Dependent site percolation models on the hexagonal and triangular lattice

The model that we have presented and discussed in Section 2 has been chosen as a sort of paradigm, but is not the only one for which such results can be proved. In fact, it is not the original model for which such results were obtained.

In this section we describe some percolation models on the hexagonal lattice and prove that they have the same scaling limit as critical (independent) site percolation on the triangular lattice. None are independent percolation models, but nonetheless, they represent explicit examples of critical percolation models on dierent lattices with the same scaling limit. Besides, the construction of the models on the hexagonal lattice can be seen as a simple and natural way of producing percolation models for which all the sites of the external (site) boundary of any constant sign cluster C belong to a unique cluster C^0 of opposite sign. In other words, this implies that the the boundaries between clusters of opposite sign form a nested collection of bops, a property that site percolation on the triangular lattice possesses automatically because of the self-matching property of T (which is crucial in Smimov's proof of the existence and uniqueness of the scaling limit of crossing probabilities and Cardy's formula).

4.1 The models

The percolation models that we briefy describe here can be constructed by means of a natural zero-tem perature G lauber dynam ics which is the zero-tem perature case of D om any's stochastic Ising ferrom agnet on the hexagonal lattice [13]. The cellular autom aton (i.e., Domany's stochastic Ising ferrom agnet at zero temperature) that gives rise to those percolation models can also be realized on the triangular lattice with ips when a site disagrees with six, ve and sometimes four of its six neighbors. The initial state 0 consists of an assignment of 1 or + 1 w ith equal probability to each site of the hexagonal or triangular lattice (depending on which version of the cellular autom aton we are referring to). In the rst version, H, as a bipartite graph, is partitioned into two subsets A and B which are alternately updated so that each x is forced to agree with a majority of its three neighbors (which are in the other subset). In the second version, all sites are updated simultaneously according to a rule based on a determ inistic pairing of the six neighbors of every site into three pairs. The rule is that x ips if and only if it disagrees with both sites in two or more of its three neighbor pairs; thus there is (resp., is not) a ip if the number D x of disagreeing neighbors is 5 (resp., 3) and there is also a ip for some cases of D $_x$ = 4. These percolation models on H and T are investigated in [10], where Cardy's formula for rectangular crossing probabilities is proved to hold in the scaling lim it.




Figure 6: Example of a (local) stable con guration for the zero-temperature Domany dynamics. Heavy lines on edges of Hoonnect, say, plus spins, while heavy broken lines connect minus spins. The dotted lines drawn on edges of the dual lattice are the perpendicular bisectors of unsatisted edges, indicating the boundaries between plus and minus clusters. Every spin has at least two neighbors of the same sign, since only loops and barbells are stable under the elect of the dynamics.

The discrete time cellular autom aton corresponding to the zero-tem perature case of D om any's stochastic Ising ferrom agnet on the hexagonal lattice can be considered as a simplified version of a continuous time M arkov process where an independent (rate 1) Poisson clock is assigned to each site x 2 H, and the spin at site x is updated (with the same

rule as in our discrete time dynamics) when the corresponding clock rings. (In particular, they have the same stable congurations { see Figure 6.) The percolation properties of the nal state 1 of that process were studied, both rigorously and numerically, in [22]; the results there (about critical exponents rather than the continuum scaling limit) strongly suggest that that dependent percolation model is also in the same universality class as independent percolation. Similar stochastic processes on dierent types of lattices have been studied in various papers. See, for example, [8, 14, 17, 32, 33, 34, 35] for models on \mathbb{Z}^d and [21] for a model on the homogeneous tree of degree three. Such models are also discussed extensively in the physics literature, usually on \mathbb{Z}^d (see, for example, [13] and [30]). Numerical simulations have been done by Nienhius [36] and rigorous results for both the continuous and discrete dynamics have been obtained in [9], including a detailed analysis of the discrete time (synchronous) case.

Let us now describe in more detail the two determ in istic cellular automata (on H and T). Later, we will prove the equivalence of the percolation models generated by those cellular automata.

Zero-tem perature D om any m odel

the change in the H am iltonian when the spin x at site x is ipped (i.e., changes sign).

The hexagonal lattice H is partitioned into two subsets A and B in such a way that all three neighbors of a site x in A (resp., B) are in B (resp., A). By joining two sites of A whenever they are next-nearest neighbors in the hexagonal lattice (two steps away from each other), we get a triangular lattice (the same with B) (see gure 7). The synchronous dynamics is such that all the sites in the sublattice A (resp., B) are updated simultaneously.

We now do not the discrete time M arkov process n ; n 2 N, with state space $S_H = f + 1g^H$, which is the zero temperature $\lim_{n \to \infty} f = 0$ to f = 0. It is the zero temperature $\lim_{n \to \infty} f = 0$.

The initial state 0 is chosen from a symmetric Bernoulli product measure.

At odd times n = 1;3;:::, the spins in the sublattice A are updated according to the following rule: $x; x \in A$, is ipped if and only if $x \in A$.

At even times n = 2;4;:::, the spins in the sublattice B are updated according to the same rule as for those of the sublattice A.

Cellular autom aton on T

We do not here a determ inistic cellular autom aton Q on the triangular lattice T, with random initial state chosen by assigning value +1 or 1 independently, with equal probability, to each site of T.

Given some site x 2 T, group its six T-neighbors y in three disjoint pairs $fy_1^x; y_2^xg$, $fy_3^x; y_4^xg$, $fy_5^x; y_6^xg$, so that y_1^x and y_2^x are T-neighbors, and so on for the other two pairs. Translate this construction to all sites x 2 T, thus producing three pairs of sites $fy_1^x; y_2^xg$, $fy_3^x; y_4^xg$, $fy_5^x; y_6^xg$ associated to each site x 2 T. (Note that this construction does not need to specify how T is embedded in R^2 .) Site x is updated at times $m = 1; 2; \ldots$ according to the following rule: the spin at site x is changed from x to x if and only if at least two of its pairs of neighbors have the same sign and this sign is

4.2 Equivalence between the models on H and T

We show here how the models on the hexagonal and on the triangular lattice are related through a star-triangle transform ation. More precisely, we will show that the dynamics on the triangular lattice T is equivalent to the alternating sublattice dynamics on the hexagonal lattice H when restricted to the sublattice B for even times n=2m.

To see this, start with T and construct an hexagonal lattice H^0 by m cans of a startriangle transform ation (see, for example, p. 335 of [18]) such that a site is added at

the center of each of the triangles $(x; y_1^x; y_2^x); (x; y_3^x; y_4^x)$, and $(x; y_5^x; y_6^x)$ (the sites y_1^x are de ned in the previous subsection). H⁰m ay be partitioned into two triangular sublattices A⁰ and B⁰ with B⁰ = T. One can now see that the dynamics on T for m = 1;2;::: and the alternating sublattice dynamics on H⁰ restricted to B⁰ for even times n = 2m are the same.




Figure 7: A star-triangle transform ation.

An imm ediate consequence of this equivalence between the two cellular autom ata is that the two families of percolation models that they produce are also equivalent in an obvious way through a star-triangle transform ation. To be more precise, the percolation models dened on T by Q for times m=1;2;::: are the same as those dened on B by the zero-tem perature D om any model for even times n=2m.

4.3 Results for the zero-tem perature D om any model

In this section we explain how the results obtained for the percolation models $^{\rm n}$ generated by the cellular autom aton T are also valid for the percolation models de ned by the zero-tem perature D om any model. Because of the results of the previous section, we can actually consider the percolation models $^{\rm n}$ on T generated by Q, for which we have results analogous to Theorem 1 and Corollary 2.1. Results equivalent to Propositions 2.1, 2.2 and 2.3 are contained in [9]. The proof of the main theorem (i.e., the analogue of Theorem 1) is basically the same as for the models generated by T, so we just point out the dierences. We follow here the setup and notation of [9], but give all the relevant de nitions in order to make this paper self-consistent.

Let us consider a loop in the triangular sublattice B, written as an ordered sequence of sites $(y_0; y_1; \dots; y_k)$ with k 3, which are distinct except that $y_k = y_0$. For $i = 1; \dots; k$, let i be the unique site in A that is an H-neighbor of both $y_{i,1}$ and y_{i} . We call an

s-loop if $_1; :::;_k$ are all distinct. Sim ilarly, a (site-self avoiding) path $(y_0; y_1; :::; y_k)$ in B, between y_0 and y_k , is called an s-path if $_1; :::;_k$ are all distinct. Notice that any path in B between y and y^0 (seen as a collection of sites) contains an s-path between y and y^0 . An s-loop of constant sign is stable for the dynam ics since at the next update of A the presence of the constant sign s-loop in B will produce a stable loop of that sign in the hexagonal lattice. Sim ilarly an s-path of constant sign between y and y^0 will be stable if y and y^0 are stable | e.g., if they each belong to an s-loop. A triangular loop $x_1; x_2; x_3 \in B$ with a common H-neighbor $y_0 \in B$ and $y_0 \in B$ that is not a star is an s-loop and will be called an antistar, while any loop in B that contains more than three sites contains an s-loop.

W ith these de nitions, the proof of the main theorem for the zero-tem perature D om any model is the same as that presented in Section 3 for our prototypical model, with the role of loops in the original proof played here by s-loops (in particular antistars), and that of m-paths by s-paths (see Section 3 below).

4.4 An am using further exam ple: totally synchronous dynam ics on H

The model that we consider here corresponds to the zero-tem perature G lauber dynam ics on the hexagonal lattice with all sites updated simultaneously at discrete times, without alternating between two subsets (contrary to the case of the zero-tem perature D om any model), with initial con guration of chosen according to a symmetric Bernoulli product measure.

Let us partition H in two subsets A and B as before and de ne the family of percolation models f_A^m ; m = 0;1; :: g, where A_A^m is the distribution of A_A^{2m} (at even times) restricted to the subset A (naturally endowed with a triangular lattice structure, so that A_A^0 is the distribution of critical site percolation).

The main dierence consists in the fact that ⁿ does not xate as n! 1 since there is a positive density of spins that ip in nitely many times. To see this, consider a loop in H containing an even number of sites and such that at time zero its spins are alternately plus and minus. At any time n, every spin in has two neighbors of opposite sign and will therefore ip at the next update. Thus, the spins in never stop ipping.

However, there is a simple observation that tremendously simplies the analysis of this totally synchronous dynamics. Namely, that if we restrict attention to sublattice A at odd times n=1;3;5;::: and sublattice B at even times n=0;2;4;:::, the dynamics is identical to the zero-temperature D om any dynamics discussed above (let us call this $\binom{n}{a}$). On the other hand, if we instead observe A at even times and B at odd times, this is identical to an alternative zero-temperature D om any type dynamics $\binom{n}{b}$ but with the rst (and third and :::) update on B rather than A. Furthermore, $\binom{n}{a}\binom{n}{n=0}$ and $\binom{n}{b}\binom{n}{n=0}$ are completely independent of each other. We conclude that there are two distinct limits $\binom{n}{a}$ and $\binom{n}{b}$ (independent of each other) and that the scaling limit of $\binom{n}{a}$ restricted to either A or B is the same as for independent critical percolation on T. But it appears that for any n, $\binom{n}{a}$ on all of H should be subcritical and thus have a trivial scaling limit.
