The Cross Curvature Flow of 3-m anifolds with Negative Sectional Curvature

1 The evolution equation

We introduce an evolution equation which deform smetrics on 3-manifolds with sectional curvature of one sign. G iven a closed 3-m anifold with an initial metric with negative sectional curvature, we conjecture that this ow will exist for all time and converge to a hyperbolic metric after a normalization. We shall establish a monotonicity formula in support of this conjecture. Note that in contrast to negative sectional curvature, every closed n -m anifold adm its a m etric with negative Ricci curvature by the work of G ao and Y au [5] for n = 3 and Lohkamp [10] for all n 3:W hen n 4; G rom ov and T hurston [6] have shown that there exist closed manifolds with arbitrarily pinched negative sectional curvature which do not adm it metrics with constant negative sectional curvature. It is unknown whether such manifolds admit Einstein metrics. In particular, the stability result of Ye [13] assumes more than curvature pinching. When n = 3; it is an old conjecture, which is also a consequence of the Geometrization C on jecture, that any closed 3-m anifold with negative sectional curvature admits a hyperbolic m etric.

Let (M ;g) be a 3-dim ensional R iem annian m anifold with negative sectional curvature. The E instein tensor is $P_{ij}=R_{ij}-\frac{1}{2}R\,g_{ij}$: We not it convenient to raise the indices: $P^{ij}=g^{ik}g^j$ ' R_k , $\frac{1}{2}R\,g^{ij}$: The cross curvature tensor is

Note that the rst identity is the contracted second Bianchi identity. The above identities in ply that the cross curvature tensor is dual to the Ricci tensor in the following sense.

Lem m a 2 Let (M ";q) be Riem annian manifold.

- 1. If the Ricci curvature is positive, then the identity map $: (M; g_j) !$ $(M; R_{ij})$ is harm onic.
- 2. If n=3 and the sectional curvature is negative (or positive), then $(M;h_{ij})! (M;g_{ij})$ is harm onic.

W ith this in m ind we de ne the cross curvature ow $(XCF)^1$ by

if the sectional curvature is negative and by $\frac{\theta}{\theta t} g_{ij} = 2h_{ij}$ if the sectional curvature is positive. Note that the XCF is fully nonlinear whereas the Ricci ow is quasi-linear.

2 Short tim e existence

Let $_{ijk}$ denote the volume form and raise indices by $^{ijk} = g^{ip}g^{jq}g^{kr}_{pqr}$: Our norm alization is such that $_{123} = ^{123} = 1$: We note it convenient to rewrite h_{ij} as

Lem m a 3 If (M;g) is a closed 3-m anifold with negative (or positive) sectional curvature, then for any smooth initial metric a solution to the XCF exists for a short time.

P roof. We consider the case of negative sectional curvature since the case of positive sectional curvature is similar. Let g_{ij} denote a variation of the metric g_{ij} and let tildes also denote the variations of various curvature tensors. We have

Since the sectional curvature is negative, P^m ' is positive and the eigenvalues of the symbol are nonnegative. One checks that the integrability condition is L $(h_{ij}) = 0$; where

By Theorem 5.1 of [7], a solution to the XCF exists for short time. ■

3 Evolution of the Einstein tensor

We nd it convenient to express the Einstein tensor as

4 M onotonicity of the volume of the Einstein tensor

P roposition 5 If (M ;g) is a 3-m anifold with negative sectional curvature, then $vol(P_{ij})$ is nondecreasing under the XCF.

This follows from the more general computation

Decomposing Tijk into its irreducible components

5 Approach to hyperbolic in an integral sense

 ${\tt W}$ e show that an integral measure of the dierence of the metric from hyperbolic is monotone decreasing. Let

where $P=g_{ij}P^{ij}$: By the arithmetic-geometric mean inequality, the integrand is nonnegative, and identically zero if and only if $P_{ij}=\frac{1}{3}P\,g_{ij}$; i.e., g_{ij} has constant curvature.

Theorem 7 Under the cross curvature ow $\frac{dJ}{dt}$ 0:

Suppose for som e T < 1 we have $\inf_{M=[0;T)} \det P = 0$: It is not dicult to show that there then exists a sequence of times t_i ! T such that $m_M \log \det P$ (t_i)! 1 and X (t_i)! 1: Hence there exists x_i 2 M such that $\det P$ (x_i ; t_i)! 0 and H (x_i ; t_i)! 1: Hence there exists a sequence of points and times where one of the sectional curvatures tends to zero and another tends to minus in nity.

7 Conclusion

In view of the well-developed theory of Ricci ow [9] and the ground breaking work of Perelm an [11] on the second author's program for Ricci ow as an approach to the Thurston Geom etrization and Poincare conjectures, it is hopeful that further progress can be made on the cross curvature ow. Recently Ben Andrews [1] has obtained new estimates for the cross curvature ow. In the case the universal cover of the initial 3-m anifold is isometrically embedded as a hypersurface in Euclidean or Minkowski 4-space, the Gauss curvature ow

(see [4], [12], [3], [8], [2] for earlier works on the GCF) induces the XCF for the metric. In this case Andrews has proved convergence results. In general, he expects long time existence and convergence of the XCF to reduce to proving local in time regularity (higher derivative estimates).
