# An Instability of the G odunov Schem e

A bstract
We construct a solution to a 2 strictly hyperbolic system of conservation law S, show ing that the G odunov schem e [12] can produce an arbitrarily large am ount of oscillations. This happens when the speed ofa shock is close to rational, inducing a resonance w ith the grid. $D$ i erently from the $G$ lim $m$ schem e or the vanishing viscosity $m$ ethod, for system s of conservation law s our counterexam ple indicates that no a priori BV bounds or $L^{1}$ stability estim ates can in general be valid for nite di erence schem es.

## 1 Introduction

C onsider a strictly hyperbolic m m system of conservation law $s$ in one space dim ension:

For in itial data $w$ ith $s m$ all total variation, the existence of a unique entropy weak solution is well known [11], [7], [5]. A closely related question is the stability and convergence of various types of approxim ate solutions. For vanishing viscosity approxim ations

[^0]uniform BV bounds, stability and convergence as " ! 0 were recently established in [4]. A ssum ing that all the eigenvalues of the Jacobian m atrix D f (u) are strictly positive, sim ilar results are also proved in [2] for solutions constructed by the sem idiscrete (upw ind) G odunov schem e

R ecently, B ianchini has succeeded in proving the sam e type of BV bounds for the Jin $-X$ in relaxation $m$ odel [3].

In the present paper we study the case of fully discrete schem es, where the derivatives $w$ th respect to both tim e and space are replaced by nite di erences. In sharp contrast w ith the previous situations, we show that the total variation of an approxim ate solution constructed by the $G$ odunov schem e can becom e arbitrarily large. This typically happens when the solution contains a shock along a curve $x=(t)$, whose speed rem ains for a long tim e very close (but not exactly equal) to a given rational, for exam ple

In this case, a resonance occurs and a substantial am ount of dow nstream oscillations is observed in the num erically com puted solution. For general $m \quad m$ system $s$, our counterexam ple indicates that a prioriBV bounds and uniform stability estim ates cannot hold for solutions generated by nite difference schem es. It leaves open the possibility that these di erence schem es still converge to the unique entropy weak solution. In any case, a rigorous proofofth is convergence cannot rely on the sam e argum ents as in [11], based on uniform BV bounds and H elly's com pactness theorem.
$W$ e recall that, for the $2 \quad 2$ system of isentropic gas dynam ics, the convergence of Lax Friedrichs approxim ations was proved in [9], w ithin the fram ew ork of com pensated com pactness. Further results w ere obtained for straight line system $s$, where all the Rankine $H$ ugoniot curves are straight lines. For these system s, uniform BV bounds, stability and convergence of G odunov and Lax Friedrichs approxim ations w ere established in [17], [6] and [21]. T he analysis relies on the fact that, due to the very particular geom etry, the interaction of waves of the same fam ily does not generate additional oscillations.

It is interesting to understand why the argum ents in [4] or [2] break down, when applied to fiully discrete schem es. A key ingredient in the analysis of vanishing viscosity approxim ations is the local decom position of a viscous solution in term s of traveling waves. To achieve a good control the
oscillations produced by interactions of w aves of a sam e fam ily, it is essential that the centerm anifold of traveling pro les has a certain degree ofsm oothness. This is precisely what fails in the case of fully discrete schem es. As rem arked by Serre [20], for general hyperbolic system $s$ the discrete shock pro les cannot depend continuously on the speed, in the BV norm. In the related paper [1] we constructed an explicit exam ple show ing how this happens.

O ur basic exam ple is provided by a 22 system in triangular form

This system is strictly hyperbolic provided that $\mathrm{f}^{0}(\mathrm{u})>$ for allu. Choosing $m$ esh sizes $t=x=1$, the $G$ odunov (upw ind) schem e takes the form

W e shall assum e that

so that the usual linearized stability conditions are satis ed. T hanks to the triangular form of the system (1.4)-(1.5), the exact solution of a $C$ auchy problem can be com puted explicitly. Indeed, one rst solves the scalar equation for $u$, say by the $m$ ethod of characteristics. T hen the function $g(u)_{x}$ is plugged as a source term into the second equation, which is linear in V .

M ore speci cally, we shall consider a solution of (1.4)-(1.5) where the rst com ponent u contains a single shock, located along the curve $x=\quad(t)$. O ne can arrange things so that the speed of the shock varies slow ly in tim e, rem aining close to som e rational num ber, say _( $t$ ) $\quad 1=2$. The second com ponent v w ill then satisfy a linear transport equation with a source located along a sm ooth curve, and a prioribounds on its total variation can be easily given.

For the corresponding approxim ate solution generated by the $G$ odunov schem e (1.6)-(1.7), how ever, things tum out to be quite di erent. B ecause of the discretization, in the equation for the second com ponent the source is not located along a sm ooth curve, but sam pled at grid points. Since the speed of the shock is close to rational, this source \resonates" w th the grid,
producing an arbitrarily large am ount of dow nstream oscillations as tim e progresses.

The plan of the paper is as follow s. Section 2 contains a prelim inary analysis of the heat equation $w$ th a m oving source. W e show that if the point sources are located at grid points and have an average speed close to rational, then the solution will contain dow nstream oscillations. By studying the strength and the location of these tail oscillations one gets a basic understanding of w hat happens for solutions generated by discrete schem es.

In Sections 3 -5 we carry out a detailed construction of a G odunov approxim ate solution for the system (1.4)-(1.5), show ing that the total variation can becom e arbitrarily large. C hoosing the ux

one can perform a nonlinear transform ation introduced by Lax [14], [15] and explicitly compute the discrete $G$ odunov solution $u_{j}^{n}$, in term $s$ of binom ial coe cients. In Section 6 we sum $m$ arize the $m$ ain features of our exam ple, and discuss its signi cance toward a rigorous theory of discrete schem es for hyperbolic conservation law s. For readers' convenience, som e results on the approxim ation of the binom ial distribution in term $s$ of heat kemels are recalled in an appendix.

## 2 The heat equation with a moving source

A s a m otivation for the follow ing analysis, consider a solution of the nite di erence schem e

For a scalar conservation law, the existence of discrete traveling pro leswas proved in [13]. W e assum e that the ux $f$ is strictly convex and that the shock pro le satis es

Inserting this solution as a source in the second equation (1.7), we obtain

W e can choose a function $g$ such that

for som e $>0 \mathrm{sm}$ all. W ith this choice, the source term s on the right hand side of (2.2) will vanish outside a thin strip centered around the shock. Indeed, if the shock is located along the line $x=t$, a fairly good approxi$m$ ation is

H ere 【s】denotes the largest integer s. To understand the oscillations in (2.2) determ ined by the presence of thesem oving sources, we rst study som e m odel problem s related to the standard heat equation. T he approxim ation of a nite di erence schem e by $m$ eans of a second order di usion equation is indeed a standard tool of analysis (see [16], p.117). In this section we review som e calculations that highlight the $m$ echanism responsible for generating variation in solutions to fiuly discrete schem es. For a detailed treatm ent we refer to the paper [1]. R igorous estim ates will then be worked out in Sections 3 -5.

First, consider the easier case of the heat equation $w$ ith point sources located on a discrete set of points $P_{n}=(n ; n)$, $w$ ith $n$ integer (the white circles in Figure 1)

T he details of the preceding argum ent are given (for the Lax Friedrichs schem e) in [1]. F inally we consider the case where the source travels $w$ th a carefiully chosen variable speed. In the previous com putation the source travelled w ith a constant speed $=1+$ ", and a signi cant am ount of oscillation was observed at a distance $\dot{\bar{y}} \mathrm{n}^{j}=$ " 2 downstream from the shock. To construct a solution whose oscillation becom es arbitrarily large, the idea is to choose a large tim e interval $[0 ; T]$ and generate a source $w$ ith non-constant speed, say located along a curve $x=(t) w$ ith

By construction, if $T=2<y<\mathrm{T}^{\mathrm{T}}=2$, this region contains a portion of the curve traveling $w$ ith speed

$T$ his is precisely the resonant speed that can produce dow nstream oscillations at a distance $y$ from the shock. As in (2.11), one has

Choosing T large, we expect to nd num erical solutions generated by the G odunov schem ew hose totalvariation grow sby an arbitrarily large am ount. In the follow ing sections we show that this is indeed the case. By providing rigorous estim ates on all the approxim ations perform ed in the above form al analysis, we will prove that the discrete G odunov solution satis es the sam e type of estim ate as in (2.15).

## 3 Special solutions

### 3.1 Inviscid solution

It w ill be conven ient to work w ith the particular scalar conservation law

O ur rst goal is to construct an exact solution of the inviscid equation 3.1) containing exactly one shock, located along a curve (t) which travels w ith a speed close to a rational number $0>$, where is as in (1.5). The role of this curve will be that its spatial translates are close to the level curves of a certain (everyw here de ned) solution of the upw ind schem e (1.6). This particular solution of the schem e will then be a good approxim ation of the exact solution of (3.1) which we construct here.

W e now $x$ the speed in (1.5) to be $1=2$. ( $T$ his choice is not essential but it sim pli es the calculations below which involve approxim ating binom ial distributions w ith the heat kemel.) T he shock solution of (1.4) will connect a variable state $u$ ( $t$ ) to a xed right state $u_{+}<u \quad$ ( $t$, , and we want this u-shock to travel faster than the advection speed $=1=2$ of the second equation. W e begin by xing the right state $u_{+}:=0$, and our solution w ill be constant equal to this value to the right of , i.e.

N ext, in analogy w ith the analysis in Section 2, we insist that the shock curve ( $t$ ) should have a speed as in (2.12). For notational conven ience we w illm ake the explicit construction for negative tim es. W e thus $x$ a large, positive (integer) tim e T, and de ne the curve (t) by setting

## 4 C onstruction of a specialdiscrete approxim ation

W e proceed to use the inform ation from Section 3.2 to construct an exact solution of the upw ind schem e (3.6) that is a good approxim ation of the particular solution of (3.1) w ith a single shock along the curve. for som e nite constant $C_{0}$ independent of $T$.
In order to com plete the argum ent show ing that $V$ has large total variation we need to introduce the follow ing condition.

A ssum ption (A) : T he sm ooth function $g$ has com pact support and is such that the 1-periodic function $(z)$ at (5.17) does not vanish identically.

It is not di cult to see that this condition is satis ed for a large class of functions $g$. For exam ple, if $g^{0}$ is form ally replaced by a D irac delta-fiunction u concentrated at a point $u$ close to $a_{0}$, then we can directly com pute

This com pletes the proof and show s that there is no a prioribound available on the totalvariation ofan approxim ate solution com puted using the upw ind schem e.

## 6 C oncluding rem arks

The analysis show s that it is possible to prescribe data for a strictly hyperbolic system of conservation law s in such a way that the total variation of the solution generated by the G odunov schem e increases by an arbitrarily large am ount, after a large num ber of tim e steps. W e observe that the total change in the speed of the curve decreases to zero as T ! 1 . Therefore, as in itial data for the $u$-com ponent, we can take an arbitrarily sm all perturbation of a single shock.
$W$ e sum $m$ arize here the $m$ ain features of our exam ple:

1. O ur 22 system is strictly hyperbolic. O ne characteristic eld is linearly degenerate, the other is genuinely nonlinear. T he characteristic speeds are both strictly contained inside the interval $[0 ; 1]$, so that the usual linearized stability conditions hold.
2. W e can choose a sequence of initial data of the form

In other words, the G odunov approxim ations are also unstable in the $L^{1}$ norm, w r.t. perturbations of the in itial data. This is in sharp contrast w ith the stability of g lim m or front tracking approxim ations [18], [7].

O ur counterexam ple has $m$ any special features: it can be solved in triangular form, the rst equation contains a very particular ux function, and the second equation is linear. All these additional features allow us to perform explicit calculations and derive rigorous estim ates, but none of them seem $s$ to be essential for the validity of the result. Indeed, we expect that the instabillty high lighted in this paper willbe a com $m$ on feature of all discrete schem es for system s of conservation law s , under generic conditions on the ux functions. In this direction, we observe that in our exam ple the oscillations in the $v$-com ponent are spread out on a very large spatial interval. Requiring that the rst eld be genuinely nonlinear (instead of linearly degenerate) would not achieve any appreciable decay in these oscillations.

W e observe also that our results do not show that the upw ind schem e fails to converge. In light of the convergence results in [9] (obtained through com pensated com pactness argum ents) we expect that one can in fact establish strong convergence also for the system s considered above. In this connection it is worth noticing that triangular 2 system $s$ of the form (1.4) -(1.5) are endow ed w ith strictly convex entropies.

A som ew hat subtle point in the preceding analysis is the issue of sm all data. A s presented above, our exam ples do not im mediately $t$ the setting
of G lim m 's theorem. W e started by giving a particular shock-w ave solution of the rst equation (1.4), and then chose a ux $g(u)$ for the second equation. H ow ever it is now possible to go back and see that if we rst x a sm ooth function $g(u)$, then we can give shock-w ave solutions of (1.4) of anbitrarily sm all am plitude and with the properties: (i) its level curves travels w ith speed [rational] $+1=-t$, and (ii) the assum ption (A) is satis ed. O ne can then redo the previous analysis for the resulting system/data pair. Since the data for the second equation are identically zero, this provides an exam ple w ithin the setting of $G$ lim $m$ 's theorem for sm all BV data.
