SECANT VARETES OF TORIC VARETES

DAVID COX AND JESSICA SIDMAN

A bstract. Let X_P be a smooth projective toric variety of dimension n embedded in P^r using all of the lattice points of the polytope P. We compute the dimension and degree of the secant variety $Sec X_P$. We also give explicit formulas in dimensions 2 and 3 and obtain partial results for the projective varieties X_A embedded using a set of lattice points A $P \setminus Z^n$ containing the vertices of P and their nearest neighbors.

1. Introduction

Let X P^r be a reduced and irreducible complex variety of dimension n: Its kth secant variety, $Sec_k X$; is the closure of the union of all (k-1)-planes in P^r meeting X in at least k points. In this paper, we discuss the dimension and degree of the secant variety $Sec X = Sec_2 X$ when X is a smooth toric variety equivariantly embedded in projective space.

Secant varieties arise naturally in classical examples (see Examples 1.1, 1.2 and 1.3 below) and also in the newly developing elds of algebraic statististics and phylogenetic combinatorics (see, for example, [10]). The basic theory of secant varieties is explained in the books [11, 27].

There is a rich collection of ideas relating secant varieties, tangent varieties, dual varieties, and the G aussmap, as discussed in [18] and [11, Section 4.4]. M any authors have studied the problem of classifying the varieties X such that $Sec_k X$ has the expected dimension, m in fr; k (n + 1) 1g; and what degeneracies may occur 2, 3, 4, 5, 23]. For the duals of toric varieties, this was done in [9]. Our paper can be regarded as the

beginnings of a similar study for the secant varieties of toric varieties.

Currently, there is much activity focused on rening our understanding of secant varieties. A lower bound for the degree of $Sec_k X$ is given in [6], and the degree of the secant variety of a monomial curve is worked out in [24]. Questions on the dening equations of secant varieties are discussed in [21, 26]. The recent paper [25] uses combinatorial Grobner methods to study the ideal of $Sec_k X$ and its degree and dimension.

M any classical varieties whose secant varieties have been studied in the literature are toric see for example [1, 2, 3, 5, 8, 15, 20]. The secant varieties below will play an important role in our paper.

Exam ple 1.1. If X is the image of the Veronese map $_2:P^n$! P^r by O_{P^n} (2), then its secant variety has the expected dimension only when n=1; otherwise the dimension is 2n < m infr; 2n + 1q.

The ideal of X is generated by the 2 2 m in or softhe (n+1) (n+1) generic sym m etric m atrix and the ideal of SecX is generated by the 3 3 m in or softhe same m atrix. (See Example 1.3.6 in [1].)

Example 1.2. If X = P ' P^n ', 1 ' n 1, is embedded in P via the Segre map, then Sec X has the expected dimension only when '= 1; n 1; otherwise dim Sec X = 2n 1 < m infr; 2n + 1g.

Here, the ideal of X is also determ in antal, generated by the 2 2 m inors of the generic ('+1) (n '+1) m atrix, and the ideal of Sec X is de ned by the 3 3 m inors of the same matrix when '+1; n '+1 3. (See Example 4.5.21 of [11].)

Exam ple 1.3. G iven positive integers $d_1; :::; d_n$, the rational norm al scroll $S_{d_1; :::; d_n}$ is the im age of

under the projective embedding given the ample line bundle $O_{P(E)}$ (1). The variety SecX always has the expected dimension, which is 2n+1 except when $\sum_{i=1}^{n} d_i = n+1$.

Furtherm ore, the ideal of X (resp. Sec X) is generated by the 2 (resp. 3) m inors of a matrix built out of H ankelm atrices. (See 2] and Section 4.7 of [11].)

A key observation is that Examples 1.1, 1.2 and 1.3 each involve a smooth toric variety coming from a particularly simple polytope. It is naturalask what happens form ore general toric varieties. To state our main theorem, we introduce some de nitions.

If P Rⁿ is an m-dimensional lattice polytope, we say that P is smooth if it is simplicial and the rst lattice vectors along the edges incident at any vertex form part of a Z-basis of Zⁿ. (Note that such polytopes are also called D elzant in the literature.) The lattice points $\mathrm{fu_0}; \ldots; \mathrm{u_r} \mathrm{g} = \mathrm{P} \setminus \mathrm{Z}^n$ give characters $\mathrm{u_i}$ of the torus (C)ⁿ that give an embedding X ,! $\mathrm{P^r}$ de ned by x 7 [$\mathrm{u_0}(\mathrm{x})$: $\mathrm{u_r}(\mathrm{x})$], where X is the abstract toric variety associated to the inner normal fan of P. We denote the image of X under this embedding by X P. Note that X is smooth if and only if P is smooth.

We also observe that X $_P$ is projectively equivalent to X $_Q$ if P is obtained from Q via an element of the group AGL $_n$ (Z) of a ne linear isomorphism s of Z n .

The standard simplex of dimension n in R n is

We let $(2_n)_k$ denote the convex hull of the lattice points in 2_n m inus a k-dim ensional face, and let B l_k (P^n) denote the blowup of P^n along a torus-invariant k-dim ensional linear subspace.

Here is the main result of the paper.

Theorem 1.4. Let P be a smooth polytope of dimension n. The dimension and degree of Sec X_P are given in the following table:

In the last row, L = O_{X_P} (1) and $c(T_{X_P})^{-1}$ is the inverse of the total Chem class of the tangent bundle of X_P in the Chow ring of X_P . Furtherm ore:

(1) For P in the rst four rows of the table, there are in nitely many secant lines of X $_{\rm P}$ through a general point of Sec X $_{\rm P}$.

(2) For P in the last row of the table, there is a unique secant line of X_P through a general point of $Sec X_P$.

For the rem ainder of the paper, the table appearing in Theorem 1.4 will be referred to as Table 1.4. In Section 4 we prove that the rst four rows of Table 1.4 give all smooth subpolytopes of 2 $_{\rm n}$ up to AGL $_{\rm n}$ (Z) equivalence. Hence dim SecX $_{\rm P}$ = 2n + 1 if and only if P does not tinside 2 $_{\rm n}$. This also determ ines the number of secant lines through a general point of SecX $_{\rm P}$.

Theorem 1.4 enables us to decide when the secant variety has the expected dimension.

C orollary 1.5. When X_P P^r comes from a smooth polytope P of dimension n, Sec X_P has the expected dimension m in fr; 2n+1g unless P is AGL_n (Z)-equivalent to one of

We can compute the degree of SecX $_{\rm P}\,$ explicitly in low dimensions as follows. Throughout, n-dimensional volume is normalized so that the volume of $_{\rm n}$ is 1.

Corollary 1.6. Let P be a smooth polygon in R^2 . If dim Sec $X_P = 5$, then

$$\deg \operatorname{Sec} X_P = \frac{1}{2} (d^2 \quad 10d + 5B + 2V \quad 12);$$

where d is the area of P , B is the number of lattice points on the boundary of P , and V is the number of vertices of P .

Corollary 1.7. Let P be a smooth 3-dimensional polytope in R^3 . If dim SecX $_P$ = 7, then

$$\deg \operatorname{Sec} X_{P} = \frac{1}{2} (d^{2} \quad 21d + c_{1}^{3} + 8V + 14E \quad 84I \quad 132);$$

where d is the volume of P; E is the number of lattice points on the edges of P, V is the number of vertices of P, and I is the number of interior lattice points. Also, $c_1=c_1\left(T_{X_P}\right)$.

R em ark 1.8. Com puting explicit degree form ulas for SecX $_{\rm P}$ in term s of the lattice points of P gets m ore di cult as the dimension increases. However, we would like to stress that given any smooth polytope P, the form ula in the last row of Table 1.4 is computable solely from the data of P. Indeed, $c(T_{\rm X_P})^{-1}$ depends only on the inner normal fan of P, and L is the line bundle given by P. The intersection products may be determined from the combinatorial geometry of P using standard results in [13] or any convenient presentation of the Chow ring of X $_{\rm P}$. We give an example of this in Theorem 4.8 when we compute the degree of the secant variety of a Segre-Veronese variety.

We prove Theorem 1.4 in three steps as follows.

First, for the polytopes in the $\,$ rst four rows of Table 1.4, the degrees and dim ensions of their secant varieties are computed in Section 2 using determinantal presentations for the ideals of X $_{\rm P}$ and SecX $_{\rm P}$, together with known results about dimensions and degrees of determinantal varieties. We also relate these polytopes to subpolytopes of 2 $_{\rm n}$.

Second, the bottom row of Table 1.4 uses a well-known formula for the degree of $SecX_P$ times the degree of the linear projection from the abstract join of X_P with itself to P^r . We discuss this formula in Section 3 and apply it to various examples.

Third, for the polytopes in the bottom row of Table 1.4, we prove in Section 4 that a general point of Sec X $_{\rm P}$ lies on a unique secant line by showing that P contains con gurations of lattice points that are easier to study. Known results about rational normal scrolls will be used in the proof.

From these results, Theorem 1.4 and Corollaries 1.5, 1.6 and 1.7 follow easily. The paper concludes with Section 5, where we study the toric varieties X_A embedded using a subset of lattice points A $P \setminus Z^n$ of a smooth polytope P of dimension n. When A contains the vertices of P and their nearest neighbors along the edges, we compute dim Sec X_A and obtain partial results about deg Sec X_A .

2. Smooth subpolytopes of 2 n

The purpose of this section is to study the polytopes $_{\rm n}$, $_{\rm 2}$, $_{\rm n}$, $_{\rm 2}$, $_{\rm n}$, and $_{\rm n}$, appearing in the rst four rows of Table 1.4. The dim ensions and degrees of the corresponding secant varieties will be computed using determinantal methods. We will also see that these polytopes give essentially all smooth subpolytopes of 2 $_{\rm n}$.

2.1. D im ension and degree calculations. We begin with the polytope $(2_n)_k$. As in the introduction, this is defined to be the convex hull of the lattice points of 2_n nF, where F is any k-dimensional face of 2_n . When k=1, F is the empty face, so that $(2_n)_{n=1}=2_n$, and when k=n1, F is a facet, so that $(2_n)_{n=1}=n$. In the discussion that follows, we will usually exclude these cases by requiring that 0 k n 2.

The toric variety corresponding to $(2_n)_k$ is easy to describe.

P roposition 2.1. Fix k between 0 and n 2, and let B $\frac{1}{4}$ (Pⁿ) denote the blow-up of Pⁿ along a torus-invariant k-dim ensional subspace. Then, B $\frac{1}{4}$ (Pⁿ) is the toric variety X $\frac{1}{4}$ $\frac{1}{4}$ $\frac{1}{4}$.

Proof. Let e_1 ;:::; e_n be the standard basis of Z^n . The standard fan for P^n has generators v_0 ; v_1 ;:::; v_n , where $v_1 = e_1$;:::; $v_n = e_n$ and $v_0 = \int_{i=1}^n e_i$. Given k between 0 and n 2, the star subdivison of the (n k)-dimensional cone = Cone(v_i ; v_{k+2} ;:::; v_n) is obtained by adding the new cone generator

and subdivding accordingly. A sexplained in [22, Prop.126], the toric variety of this new fan is the blow up of Pⁿ along the k-dimensional orbit closure corresponding to . Thus we have B $_{\mathbf{k}}$ (Pⁿ). The cone generators v_0 ;:::; v_{n+1} give torus-invariant divisors D $_0$;:::;D $_{n+1}$ on B $_{\mathbf{k}}$ (Pⁿ). One easily checks that D = 2D $_0$ + D $_{n+1}$ is ample.

U sing the description on p.66 of [13], the polytope P_D determined by D is given by the n + 2 facet inequalities

The inequalities on the $\,$ rst two lines de ne 2 $\,_{n}$ and the $\,$ nal inequality $\,$ rem oves the face corresponding to $\,$. It follows that P_{D} = (2 $\,_{n}$) $_{k}$.

We will see below that the ideal of $B \downarrow (P^n)$ is determinantal. We now turn our attention to some dimension and degree calculations.

Theorem 2.2. If P is one of the polytopes

then the dim ension and degree of SecX $_{\rm P}$ are given by the $\,$ rst four rows of Table 1.4.

Proof. The case of $_n$ is trivial. Turning our attention to 2 $_n$, we let $r=\frac{n+2}{2}$ 1. The lattice points in 2 $_n$ correspond to the r+ 1 m onom ials of degree 2 in x_0 ; ...; x_n . O rder these m onom ials lexicographically so that $_2:P^n$! P^r is the map

If z_0 ;:::; z_r are the hom ogeneous coordinates on P^r , then the 2 2 m inors of the (n + 1) (n + 1) sym m etric m atrix

vanish on $_2(\mathbb{P}^n)$. As noted in Example 1.1, these m inors generate the ideal of $_2(\mathbb{P}^n)$ and the 3 3 m inors generate the ideal of Sec $_2(\mathbb{P}^n)$. The degree of this determ inantal ideal is also classical see Example 14.4.14 of [12] for a reference. This completes the proof for 2 $_n$.

Since $(2_n)_k$ is constructed from 2_n by removing a face of dimension k, $(2_n)_k$ has exactly $\frac{k+2}{2}$ fewer lattice points. We will use the convention that these lattice points correspond to the last $\frac{k+2}{2}$ m onomials ordered lexicographically. The corresponding variables lie in the last k+1 rows and columns of M .

Let M $_{k+1}$ denote the m atrix M m inus its last k+1 rows. The m atrix M $_{k+1}$ is the partially symmetric (n $_{k}$) (n + 1) m atrix of R em ark 2.5 (c) in [7]. Since the 2 $_{k+1}$ m inors of M $_{k+1}$ vanish on X $_{(2_{n})_k}$, it follows that if they generate a prime ideal dening a projective variety of dimension n, then they generate the ideal of X $_{(2_{n})_k}$. Moreover, if the 2 $_{k+1}$ m inors of M $_{k+1}$ generate the ideal of X $_{(2_{n})_k}$, then the 3 $_{k+1}$ m inors of M $_{k+1}$ vanish on its secant variety. Thus, if the 3 $_{k+1}$ m inors generate a prime ideal dening a projective variety of dimension dim SecX $_{(2_{n})_k}$; then the ideal they generate must be the ideal of the secant variety.

From Example 3.8 of [7] we know that the dimension and degree of the projective variety cut out by the ideal generated by the total minors of M $_{k+1}$ is what we desire for $t=1;\ldots;n$ k, and from Remark 2.5 of [7] we know that the ideal is prime. Moreover, X $_{(2_n)_{n-2}}$ is the rational normal scroll S $_{1;\ldots;1;2}$; and by [3], we know that its secant variety lls P^{2n} : Therefore, we just need to show that the secant variety of X $_{(2_n)_k}$ also has dimension 2n for 0 k < n 2:Note that X $_{(2_n)_k}$ is the image of X $_{(2_n)_j}$ via a linear projection for all j < k: The variety X $_{(2_n)_1}$

is $_2(P^n)$: Therefore, applying Lemma 1.12 of [6] twice, tells us that dim SecX $_{(2_n)_k}$ = 2n for all k=0;:::;n 2:

Finally, 'n' gives the Segre embedding of P' P' '. In this case, the book [11] contains an explicit description of the ideal of the secant variety in Example 1.3.6 (2). The variety Sec P' P' 'is de ned by the 3 3 m inors of the generic ('+1) (n'+1) m atrix if '+1; n'+1 3. The degree of this determ inantal ideal was known to G iam belli and the formula appearing in Table 1.4 is given in Example 19.10 of [19]. If either '+1 or n+1 ' is strictly less than 3, then P' P' 'embeds into P^{2n-1} , and its secant variety lls the ambient space (see Example 4.5.21 in [11]), so that the degree is 1. This completes the proof of the theorem .

The determ inantal ideals arising from the polytopes 2 $_{\rm n}$, (2 $_{\rm n}$) $_{\rm k}$ and $_{\rm n}$ in the above proof have m any beautiful combinatorial and computational properties. Under the lexicographic term ordering (and other su ciently nice term orderings), the t tm inors contain a G robner basis for the ideal they generate, and this ideal has a square-free initial ideal. Thus, G robner basis techniques can be used to show that the m inors generate radical ideals, and Stanley-R eisner techniques can be used to compute degrees. This can be proved using [7] and the papers cited in [7].

We also note that for these polytopes P, the ideal of X_P is generated by quadrics (the 2 2 m inors) and the ideal of $Sec X_P$ is generated by cubics (the 3 3 m inors). A re there other interesting polytopes with these properties? Such questions have been raised in [10, Problem 5.15] in the context of Jukes-C antor binary models and in [26, C onjecture 3.8], which in the toric case asks whether the ideal of $Sec X_{mP}$ is generated by cubics for m 0.

22. Classication. The polytopes appearing in Theorem 22 that urally inside 2 $_{\rm n}$. We will now prove that these are essentially all smooth polytopes with this property.

The proofs given here and in Section 4 require three $\operatorname{lem} m$ as about sm ooth polytopes. We begin with $\operatorname{som} e$ de ntions.

De nition 2.3. If is an edge of a lattice polytope P, then its edge length is $j \setminus Z^n j$ 1, or alternatively, the normalized length of . We say that P is a polytope of edge length 1 if its edges all have length 1.

In term softhe corresponding toric variety X $_{\rm P}$, P determ ines an am – ple divisor D $_{\rm P}$ and determ ines a curve C . The intersection product D $_{\rm P}$ C is the edge length of .

De nition 2.4. A vertex v of a smooth polytope P is in standard position if v is the origin and its nearest lattice neighbors along the edges are the standard basis $e_1; ::: ; e_n$ of \mathbb{Z}^n .

It is easy to see that any vertex of a sm ooth polytope can be m oved into standard position via an element of AGL $_{\text{n}}$ (Z).

We om it the elementary proof of our rst lemma.

Lem m a 2.5. Let P be a sm ooth polygon with a vertex at the origin in standard position. If one of edges at the origin has edge length 2, then P contains the point $e_1 + e_2$.

Lem m a 2.6. If P is a sm ooth 3-dim ensional polytope of edge length 1, then, up to AGL_3 (Z)-equivalence, one of the following holds

R em ark 2.7. Even though $P_{1;2;2}$ has two edges of length 2, it can be contained in a smooth 3-dimensional polytope of edge length 1.

Proof. Put a vertex of P in standard position and note that any facet of P containing the origin is one of the following three types: (A) the facet is a triangle $_2$; (B) it is a square $_1^2$; or (C) it contains the lattice points

Now consider the three facets that m eet at the origin. One of four things can happen:

Two facets are of type (A). Then $P = _3$.

One facet is of type (A) and at least one is of type (B). Then $P = \begin{pmatrix} 1 & 2 \end{pmatrix}$.

Two facets are of type (C). Then P contains $\mathbb{P}_{;2;2}$.

Two facets are of type (B) and the other is not of type (A). Then P contains $\frac{3}{1}$.

The proofs of the rst three bullets are elementary and are om itted. For the fourth, we can assume that the two type (B) facets meet along the edge connecting 0 to e_1 . The third facet meeting at e_1 is of type (B) or (C), which easily implies that P contains $\frac{3}{1}$.

Proof. When we put P into standard position, the edge length 1 hypothesis in plies that $0;e_1;:::;e_n$ are vertices of P. The vertex e_1 lies in n facets of P, n = 1 of which lie in coordinate hyperplanes. For the remaining facet , its supporting hyperplane can be dened by


At e_1 , the nearest neighbors along the edges consist of 0 and n 1 vertices lying in .0 ur hypothesis on P implies that every 2-dimensional face of P is either $_2$ or $_1^2$. By considering the 2-dimensional face contained in Cone(e_1 ; e_i) for i=2;:::;n, we see that the n 1 nearest neighbors in are either e_i or e_i+e_1 . We can renumber so that the nearest neighbors in are

If '= n, then P = $_n$ follows easily. So now assume that '< n and pick i between 2 and n 1. Consider the 3-dimensional face F_i of P lying in Cone(e_1 ; e_i ; e_n). Depending on i, we get the following partial picture of F_i :



This picture shows that F_i cannot be $_3$. Hence by assumption it is AGL_3 (Z)-equivalent to $_1$ $_2$. In terms of the picture, this means that the nearest neighbors of the vertex e_n of F_i , are 0, $e_1 + e_n$, and

W e now prove a prelim inary version of our classi cation of sm ooth subpolytopes of 2 $\,_{\rm n}$.

Theorem 2.9. Let P be a smooth polytope of dimension n in standard position at the origin. If P $_{\rm n}$, then P is one of



Remark 2.10. In Section 4, we will show that the standard position hypothesis in Theorem 2.9 is unnecessary.

Note that $e_i + e_n$; $e_j + e_n$ 2 P by Lemma 2.5. Since P 2 $_n$, we have F 2 $_3$, so that the above picture shows all lattice points of F. The convex hull of these points is not smooth, giving the desired contradiction. It follows that

which easily implies that P $(2_n)_k$. For the opposite inclusion, note that since (3) consists of lattice points of P, Lemma 2.5 implies that P also contains the lattice point $e_i + e_j$ whenever 1 i k+1 and k+2 j n. Since $(2_n)_k$ is the convex hull of these points together with (3), we obtain $(2_n)_k$ P.

It remains to consider the case when P contains none of $2e_1$; ...; $2e_n$. This implies that P has edge length 1. Let F be a 3-dimensional face of P. Of the four possibilities for F listed in Lemma 2.6, note that F cannot contain a con guration $AGL_3(Z)$ -equivalent to $P_{1;2;2}$, since $P_{1;2;2}$ contains two parallel segments with 3 lattice points, which is impossible in 2_n . Similarly, 2_n cannot contain a con guration $AGL_3(Z)$ -equivalent to 1/2. This is because such a \cube" con guration would give an a ne relation

where v_0 and v_4 are opposite vertices of the cube and v_1 ; v_2 ; v_3 are vertices of the cube nearest to v_0 . This gives the relation

which cannot occur am ong distinct lattice points of 2 $_{n}$ (we om it the elem entary argument). It follows from Lemma 2.6 that F is AGL $_{3}$ (Z)-equivalent to $_{3}$ or $_{1}$ $_{2}$. Since F is an arbitary 3-dimensional face of P, Lemma 2.8 implies that P is AGL $_{n}$ (Z)-equivalent to $_{n}$ for some 0 $_{n}$ n. The proof of the theorem is now complete.

3. The degree formula for the secant variety

One of the key ingredients in the proof of Theorem 1.4 is a formula relating the degree of SecX to the Chem classes of the tangent bundle T_X and the line bundle O_X (1). We review this formula and then interpret it for toric surfaces and 3-folds.

3.1. The abstract join and the secant variety. Given X P^r of dimension n, consider P^{2r+1} with coordinates $x_0; \ldots; x_r; y_0; \ldots; y_r$. The abstract join J(X;X) of X with itself is the set of all points in P^{2r+1} of the form [x:y] with [x]; [y] 2 X and [:] 2 P^1 . Then J(X;X) has dimension 2n+1 and degree (deg X) [:] (see [11]).

The linear projection

given by ([x:y]) = [x y] is de ned away from the subspace of P^{2r+1} de ned by the vanishing of x_i y_i for i=0; :::; r. This induces a rationalm ap J(X; X) 99K Sec X with base locus the diagonal embedding of X in the abstract join. We have the following well-known result:

Theorem 3.1 (Theorem 82.8 in [11]). If X is smooth, then

where $L = O_X$ (1) and deg = 0 when dim SecX < 2n + 1.

This is sometimes called the double point formula since a general linear projection X ! P^{2n} has $\frac{1}{2} \deg Sec X \deg$ double points (see Corollary 82.6 of [11], for example). For surfaces, the double point formula was rst discovered by Severi. See [11, 12] for more general double point formulas and further references.

The following proposition explains the geometric meaning of deg.

Proposition 3.2. If $X P^r$ is a variety of dimension n > 1; then:

- (1) $\dim \operatorname{Sec} X = 2n + 1$ if and only if a general point of $\operatorname{Sec} X$ lies on at most nitely many secant lines of X.
- (2) $\dim \operatorname{Sec} X = 2n + 1$ im plies that \deg is 2 times the number of secant lines of X through a general point of $\operatorname{Sec} X$.

Proof. Both of the claims are probably well-known to experts, but we could not not explicit proofs in the literature. Two dierent ways of constructing an \abstract" secant variety which maps to SecX may be found in [27] and [6] and one may treat the results here from those points of view as well. We include a proof for completeness using the setup of [11].

If dim SecX = 2n+1, then the rationalm ap :J(X;X) 99K SecX is generically nite. This implies that a general point of SecX lies on at most nitely many secant lines of X. Conversely, suppose that this condition is satisted and dim SecX < 2n+1. Then $^{-1}(z)$ is in nite for z 2 SecX, so that we can not in nitely many distinct pairs $p_i \notin q_i$ in X such that z lies on $\overline{p_iq_i}$. Since there are only nitely many such lines through z, one of them must contain in nitely many points of X and hence lies in X. This line also contains z, so that z 2 X, and then X = SecX follows. One easily concludes that X is a linear subspace. Since X has dimension > 1, a general point of SecX = X lies on in nitely many secant lines, a contradiction.

For the second assertion, rst observe that the trisecant variety of X (the closure of the union of secant lines meeting X in 3 points) has dimension 2n by Corollary 4.6.17 of [1]. Since dim Sec X = 2n+1, it follows that at a general point z 2 Sec X, any secant line of X through z meets X in exactly two points, say $p \in q$. W riting z = p + q gives distinct points [$p: q \in q$: p in $p \in q$. Thus the cardinality of $p \in q$ is twice the number of secant lines through z, as claim ed.

Here is an immediate corollary of Proposition 32.

Corollary 3.3. If $X P^r$ has dimension n > 1, then deg = 2 if and only if there is a unique secant line of X through a general

point of SecX . Furtherm ore, dim SecX = 2n + 1 when either of these conditions are satis ed.

Theorem 3.1 gives a formula for deg SecX when deg = 2. This explains the $\frac{1}{2}$ appearing in Theorem 1.4 and Corollaries 1.6 and 1.7.

Here is an example of Theorem 3.1 and Corollary 3.3 that will be useful in the proof of Theorem 1.4.

Exam ple 3.4. Consider the rational normal scroll $X = S_{d_1,...,d_n}$, where d_i 1 and $d = \bigcap_{i=1}^n d_i$. Since X is a projective bundle over P^1 , its Chow ring is well-known, making it easy to compute the formula in Theorem 3.1. This computation appears in [23], with the result

$$\deg \operatorname{Sec} X \operatorname{deg} = \operatorname{d}^2 (2n + 1)\operatorname{d} + \operatorname{n} (n + 1)$$
:

Catalano-Johnson proved in [2] that a general point of Sec X lies on a unique secant line of X when d = 1. Thus deg = 2, so that

 (2n + 1)d + n(n + 1); d n + 2:

If d=n;n+1, this form ula gives zero, so that dim SecX < 2n+1 by Theorem 3.1. The cases d=n;n+1 correspond to the polytopes n-1, and $(2-n)_n-2$, respectively. Since the secant variety of a rational normal scrollalways has the expected dimension, this explains why these polytopes don't appear in the statement of Corollary 1.5.

32. D im ensions 2 and 3. In low dimensions, the degree formula of Theorem 3.1 can be expressed quite succinctly. The purpose of this section is to prove the following two theorems.

Theorem 3.5. If P is a smooth lattice polygon in \mathbb{R}^2 , then

where d is the area of P; B is the number of lattice points on the boundary of P, and V is the number of vertices of P.

Theorem 3.6. If P is a smooth 3-dimensional lattice polytope in R^3 , then

where d is the volume of P, E is the number of lattice points on the edges of P, V is the number of vertices of P, and I is the number of interior lattice points. Also, $c_1=c_1\left(T_{X_p}\right)$.

Both results follow from Theorem 3.1 via applications of Riem ann-Roch and the theory of Ehrhart polynomials. We begin with some useful facts about the total Chem class $c(T_{\rm X})$ and Todd class td (X)

from pp.109{112 in [13]. Let $c_i = c_i (T_X)$ and $H = c_1 (L)$, where L is the line bundle coming from P. Then:

4. Counting secant lines

To complete the proofs of our main results, we need to study the secant variety of a toric variety coming from the last row of Table 1.4.

4.1. A uniqueness theorem. Here is our result.

Theorem 4.1. If a smooth n-dimensional polytope P is not AGL $_{\rm n}$ (Z)-equivalent to any of the polytopes

Before beginning the proof of Theorem 4.1, we need some lem m as.

Lem m a 4.2. Let X P^F be a variety of dimension n>1 and x a linear projection P^F 99K P^S such that X is not contained in the center of the projection. Let Y P^S be the closure of the image of X, so that we have a projection :X 99K Y. If is birational and a general point of Sec Y lies on a unique secant line of Y, then dim Sec X = 2n+1 and a general point of Sec X lies on a unique secant line of X.

Proof. By Proposition 32, our hypothesis on Y implies that SecY has dimension 2n + 1, and then dim SecX = 2n + 1 since : X 99K Y induces a dominating map SecX 99K SecY.

Now suppose that a general point z 2 SecX lies on the secant lines \overline{pq} and $\overline{p^0q^0}$ of X. These map to secant lines of Y through (z), which coincide by hypothesis. Arguing as in the proof of Proposition 3.2, we can assume that this secant line meets Y at exactly two points. Switching p^0 and q^0 if necessary, we get p^0 and p^0

Since is generically 1-to-1 on X, we conclude that $\overline{pq} = \overline{p^lq^0}$. Thus a general point of SecX lies on a unique secant line of X.

We will prove Theorem 4.1 by applying Lemma 4.2 to projections constructed from carefully chosen subsets $A = fu_0; \ldots; u_s g \quad P \setminus Z^n$. The characters u_i give a rational map X 99K P^s de ned by x 7 [u_0 (x): u_s (x)], where X is the abstract toric variety of the normal fan of P. The closure of the image in P^s is denoted X_A . Note that $X_A = X_P$ when $A = P \setminus Z^n$.

We can view X_A as a projection of X_P as follows. By denition, X_P is the closure of the image of the rational map X_P 99K P^r , $r = P \setminus Z^n j = 1$. Labeling the coordinates of P^r using the lattice points of $P \setminus Z^n$, we obtain a projection

by projecting onto the linear subspace de ned by the coordinates corresponding to A $\,$ P \setminus Z^n . This induces the projection $\,$:X $_P$ 99K X $_A$. Some of the subsets A that we will use come from the toric interpretation of the rational normal scrolls from the introduction. Let

pretation of the rational normal scrolls from the introduction. Let $d_1; \ldots; d_n$ be positive integers and label the vertices of the unit simplex $_{n-1}$ R^{n-1} as $v_1=e_1; \ldots; v_{n-1}=e_{n-1}; v_n=0$. De ne $A_{d_1; \ldots; d_n}$ Z^{n-1} Z by

One can easily show that the toric variety $X_{P_{d_1},...,d_n}$ is the rational normal scroll $S_{d_1,...,d_n}$ dened in Example 13. The result of [2] mentioned in Example 3.4 implies the following lemma.

We are now ready to prove Theorem 4.1.

Proof of Theorem 4.1. The case of dimension 1 is trivial since $P = d_1$ gives a rational normal curve of degree dembedded in P^d . It is well-known (see [2] or Proposition 8.2.12 of [11]) that a unique secant line passes through a general point of SecX_P when d 3.

Now assume that $\dim P$ 2. We will consider vecases, depending on the maximum edge length and $\dim \operatorname{ension}$ of P.

Case 1. P has an edge E of length 3. Put a vertex of E in standard position so that E contains e_n . Now x i between 1 and n 1 and consider the 2-dim ensional face F_i of P lying in Cone (e_i ; e_n). Then F_i is a smooth polygon in standard position containing the points

This is the set $A = A_1,...,1,1,3$ de ned earlier. By Lem m a 4.3, a general point of SecX_A lies in a unique secant line of X_A .

The embeddings of X $_P$ and X $_A$ given by P \ Z n and A respectively share the points 0; e $_1$; :::; e $_n$. It follows easily that the linear projection X $_P$ 99K X $_A$ given by projecting onto the coordinates corresponding to points of A is the identity on the tori of X $_P$ and X $_A$ and hence is birational. By Lemma 42, we conclude that a general point of SecX $_P$ lies in a unique secant line of X $_P$.

Case 2. P has an edge E of length 2 but no edges of length 3. As in Case 1, put a vertex of E in standard position so that E contains e_n . Now x i between 1 and n 1 and consider the 2-dim ensional face F_i of P lying in Cone(e_i ; e_n). Using Lemma 2.5 as in Case 1 shows that F_i contains the points



It remains to show that $e_i + 2e_n \not\geq F_i$ for all i = 1; :::; n 1 cannot occur. If this were to happen, it is easy to see that F_i is either




Since P is smooth, n facets of P m eet at the vertex $2e_n$, n 1 of which lie in coordinate hyperplanes. The remaining facet has a normal vector perpendicular to the edge E_i of F_i indicated in the above picture. Thus $(i + e_n) = 0$ for i = 1; :::; n = 1, which easily implies that the supporting hyperplane of this facet is dened by $x_1 + \dots + x_n + x_n$. This hyperplane and the coordinate hyperplanes bound $2e_n$, and it follows that P = $2e_n$. Since P is in standard position, Theorem 2.9 implies that P is AGL_n(Z)-equivalent to one of the polytopes listed in the statement of the theorem, a contradiction.

C ase 3. P has only edges of length 1 and dimension 2. Put a vertex of P in standard position and note that e_1 and e_2 are also vertices of P. Since P is smooth, the vertex e_1 of P must lie on an edge containing $ae_1 + e_2$, a 0. If a = 0 or 1, then one easily sees that P is contained in 2 2. On the other hand, if a 3, then P contains

$$A = f0; e_1; e_2; e_1 + e_2; 2e_1 + e_2; 3e_1 + e_2q;$$

which equals $A_{1;3}$ up to $AGL_2(Z)$ -equivalence. Using Lemmas 4.2 and 4.3 as usual, we conclude that a general point of $SecX_P$ lies in a unique secant line of X_P . Finally, if a=2, then P is not contained in a=2. Applying a similar analysis to the edges emanating from the vertex a=2, one sees that P either contains a=20. A a=21 up to a=22 up to a=23 up to a=24.



The only way to complete this to a smooth polygon P is to add the vertex $2e_1 + 2e_2$ indicated in the gure. Applying Theorem 3.5 gives

Therefore, since deg must be even, it is either 2 or 6. If it were 6, then $SecX_P$ must be a linear space. Since dim $SecX_P$ 5; the variety $SecX_P$ cannot llP^6 : If $SecX_P$ were contained in a nontrivial linear space, then X_P would also be contained in this space which is a contradiction because X_P is easily seen to be nondegenerate. Therefore, we conclude that deg SecX = 2; and that a general point of $SecX_P$ lies on a unique secant line of X_P by Corollary 3.3.

C ase 4. P has only edges of length 1 and dimension 3. By Lemma 2.6, P is either $_3$ or $_1$ $_2$, or else P contains $P_{1;2;2}$ or $_1^3$. When P contains $P_{1;2;2}$, we are done by the usual combination of Lemmas 4.2 and 4.3. When P contains $_1^3$, note that Theorem 3.6, when applied to $Q = _1^3$, gives

This implies deg = 2 since deg is even. Thus a general point of SecX $_{\mathbb{Q}}$ lies on a unique secant line of X $_{\mathbb{Q}}$. Then X $_{\mathbb{P}}$ has the same property by Lemma 42.

Case 5. P has only edges of length 1 and dimension > 3. As usual we put a vertex of P into standard position. We will study the 3-dimensional faces of P.

First suppose that P has a 3-dimensional face F that contains $_1^3$ or $P_{1;2;2}$. We can arrange for this face to lie in Cone(e1;e2;e3) in such a way that e1 + e2 P . Now x i between 4 and n and consider the 3-dimensional face F1 of P lying in Cone(e1;e2;e1). What are the 2-dimensional faces of F1 containing e1? If both were triangles 2, then the argument of the rst bullet in the proof of Lemma 2.6 would imply that F1 = 3, which contradicts e1 + e2 P F1. It follows that one of these faces must contain another lattice point. This shows that there is u1 2 fe1;e2g such that e1 + u1 2 F1 P. If we let B denote the lattice points of $\frac{3}{1}$ or $P_{1;2;2}$ contained in our original face F7, then P contains the set

$$A = B [fe_i; e_i + u_i ji = 4; :::; ng:$$

Furtherm ore, the proof of C ase 4 shows that a general point of Sec X $_{\rm B}$ lies on a unique secant line of X $_{\rm B}$. By Lem m as 4.2 and 4.4, we conclude that a general point of Sec X $_{\rm P}$ lies on a unique secant line of X $_{\rm P}$.

By Lem m a 2.6, it rem aims to consider what happens when every 3-dim ensional face of P is $_3$ or $_1$ $_2$. Here, Lem m a 2.8 in plies that

 $P = \frac{1}{n}$, 0 'n, which cannot occur by hypothesis. This completes the proof of the theorem .

R em ark 4.5. In Case 1 above it is possible to see that $SecX_A$ has the expected dimension via results in [25]. A lexicographic triangulation of A in which the vertices precede the other lattice points of conv (A) will include the disjoint simplices at either end of an edge of length 3. This shows that A satsi es the condition of Theorem 5.4 of [25]. (We thank S. Sullivant for pointing out that a lexicographic triangulation works here.)

42. Proofs of the main results. We now prove the four theorems stated in the introduction.

Proof of Theorem 1.4. Theorem 2.2 proves the dimensions and degrees in the rst four rows of Table 1.4. Since all of these polytopes satisfy dim $SecX_P < 2n + 1$, part (1) of Theorem 1.4 follows from Proposition 3.2. Also, part (2) follows from Theorem 4.1. Finally, for the last row of Table 1.4, Theorem 4.1 and Corollary 3.3 in ply that dim $SecX_P = 2n + 1$ and deg = 2. Theorem 3.1 gives the desired formula for $deg SecX_P$.

Proof of Corollary 1.5. We always get the expected dimension in the last row of Table 1.4. Since the rst four row shave dim SecX $_{\rm P}$ < 2n+1, the only way to get the expected dimension is when dim SecX $_{\rm P}$ = r, where r+1 is the number of lattice points of P . The lattice points of these polytopes are easy to count, and the result follows.

Proof of Corollaries 1.6 and 1.7. These follow from Theorem 1.4 and Corollary 3.3, together with the formulas of Theorem s 3.5 and 3.6.

43. Subpolytopes of 2 $_{\rm n}$. We can now complete the classication of smooth subpolytopes of 2 $_{\rm n}$ begun in Theorem 2.9.

Theorem 4.6. Let P 2_n be a smooth polytope of dimension n. Then P is AGL_n (Z)-equivalent to one of

Proof. P 2 n gives a dominating map Sec $_2(P^n)$ 99K SecX $_P$, so that dim SecX $_P$ dim Sec $_2(P^n)$ = 2n < 2n + 1. This excludes the last row of Table 1.4, so that P must be AGL $_n$ (Z)-equivalent to a polytope in one of the rst four rows, as claim ed.

R em ark 4.7.6 iven a sm ooth lattice polytope P \mathbb{R}^n of dimension n, it is easy to determ ine if P is equivalent to a subpolytope of 2_n . Let d be the maximum number of length 2 edges incident at any vertex of

P and let v be any vertex that witnesses this maximum. Then let Q be the image of P under any element of AGL $_{\rm n}$ (Z) that places v at the origin in standard position.

The reader should consult [4] for further results on the secant varieties of Segre-Veronese varieties.

5. Subsets of lattice points

Let P be a sm ooth polytope of dimension n in Rⁿ. Using all lattice points of P gives the projective variety X_P P^r , $r = P \setminus Z^n$ j 1, in the usual way. As in the discussion leading up to (6) in Section 4.1, a subset A $P \setminus Z^n$ gives the projective toric variety X_A P^s , s = A j 1.

Here is our main result concerning the dimension and degree of the secant variety $\text{SecX}_{\,\text{A}}$.

Theorem 5.1. Let A P \ Z^n, where P is a smooth polytope of dim ension n. If A contains the vertices of P and their nearest neighbors along edges of P; then dim Sec X $_{\rm A}$ = dim Sec X $_{\rm P}$ and deg Sec X $_{\rm A}$ divides deg Sec X $_{\rm P}$.

When A satis es the hypothesis of Theorem 5.1, it follows that dim $SecX_A$ is given in Table 1.4. Furthermore, since $deg\,SecX_A$ divides $deg\,SecX_P$ and the latter is given in Table 1.4, we get an explicit bound for $deg\,SecX_A$.

Proof. By (6) of Section 4.1, A $P \setminus Z^n$ gives a projection $P^r = P^r + P^s$:

where $r=P \setminus Z^n j$ 1; s=A j 1. By our hypothesis on A, it is straightforward to show that induces an isomorphism $: X_P ! X_A$ (see, for example, the proof of the lemma on p. 69 of [13]). This in turn induces a projection

(10)

since projections take lines not meeting the center to lines. Let P^r be the center of the projection. If does not meet Sec X $_P$, then (10) is nite and surjective, and the theorem follows easily. Hence it remains to show that $\setminus Sec X_P = ;$.

Suppose by contradiction that there is z 2 \ SecX $_P$. Since A contains all vertices of P , it is easy to see that does not meet X $_P$. Hence z $\not\equiv$ X $_P$. There are now two cases to consider: either z lies on a secant line, i.e., z = p+ q, where p $\not\in$ q 2 X $_P$ and [:]2 P^1 , or z lies on a tangent line to p 2 X $_P$.

The toric variety X_P is covered by open a ne sets corresponding to the vertices of P. The point p lies in one of these. A ssume that we have m oved this vertex into standard position at the origin so that local coordinates near p are given by sending $(t_1; \ldots; t_n) \ge C^n$ to $[1:t_1:t_2:n::t_n]$ 2aRd let p = [1:1:2:n::].

In the rst case, we may write z=p+rq where r=- because we assume that $z\not\geq X$: Since $z\not\geq 2$, all of the coordinates corresponding to the elements of A must be zero. Therefore, p+rq must be zero in the rst n+1 coordinates since A contains each vertex and its nearest neighbors.

Since p is nonzero in the set coordinate and p+rq is zero in that coordinate, q must be in the seme open a ne chart as p. Therefore, $q = [1:_1:_2:_n::]$, and then r = 1 and $_i$ for all i. This implies p = q, a contradiction.

W e can also determ ine when $Sec X_A$ has the expected dim ension.

Theorem 5.2. Let X_A P^S come from $A = fu_0; :::; u_S g$ Z^n . If P = C onv (A) is smooth of dimension n and A contains the nearest neighbors along the edges of each vertex of P, then $Sec X_A$ has the expected dimension minfs; 2n + 1g unless A is AGL_n (Z)-equivalent to the set of all lattice points of one of

Proof. For P in the last row of Table 1.4, dim $SecX_A = dim SecX_P = 2n + 1$ by Theorem s 5.1 and 1.4. Now suppose that P is AGL_n (Z) equivalent to a polytope in the rst four rows. For these polytopes, all lattice points lie on edges and all edges have length 2. Hence A contains all lattice points of the polytope, so C orollary 1.5 applies.

W e conclude with two examples, one in which the degrees of SecX $_{\rm P}$ and SecX $_{\rm A}$ are equal and one in which they are not.

Exam ple 5.3. Let P=3 and let A be the set of all lattice points in P m inus the point (1;1). The variety X_P P^9 is the 3-uple Veronese embedding of P^2 and X_A P^8 is a projection of X_P from a point. Our results in ply that dim $Sec X_P = dim Sec X_A = 5$, $deg Sec X_P = 15$, and $deg Sec X_A$ divides 15. A Macaulay 2 computation shows that $deg Sec X_A = 15$ in this case. Note also that a general point of $Sec X_P$ or $Sec X_A$ lies on a unique secant line of $Sec X_P$ or $Sec X_A$, respectively.

Exam ple 5.4. Let A = f(0;0); (1;0); (0;1); (2;1); (1;2); (2;2)g and P be the convex hull of A. The set of lattice points in P is A [f(1;1)g. The variety X_P is a smooth toric surface of degree 6 in P^6 and X_A in P^5 is the projection of X_P from a point. Note that X_P is the Del Pezzo surface obtained by blowing up P^2 at three points, embedded by the complete anticanonical linear system. Our results imply that dim $SecX_P = dim SecX_A = 5$ and $deg SecX_P = 3$. However, dim $SecX_A = 5$ in plies that $SecX_A$ lls all of P^5 and hence $deg SecX_A = 1$. Thus $SecX_P = 8$. SecX_A has degree 3 and a general point of $SecX_A$ lies on three secant lines of X_A .

When X_A is a (possibly singular) monomial curve, the degree of $Sec X_A$ has been computed explicitly in the recent paper [24].
