HYPERBOLIC DISTRIBUTION PROBLEMS ON SIEGEL 3-FOLDS AND HILBERT MODULAR VARIETIES

Abstract. We generalize to Hilbert modular varieties of arbitrary dimension the work of W. Duke [14] on the equidistribution of Heegner points and of primitive positively oriented closed geodesics in the Poincare upper half plane, subject to certain subconvexity results. We also prove vanishing results for limits of cuspidal Weyl sums associated with analogous problems for the Siegel upper half space of degree 2. In particular, these Weyl sums are associated with families of Humbert surfaces in Siegel 3-folds and of modular curves in these Humbert surfaces.

1. Introduction

In this paper, we use the M aass correspondence for special orthogonal groups SO (p;q), with integers p;q 1, p+q=m, together with \accidental" isom orphisms between these groups and certain m odular groups in the case m=3;4;5, to derive explicit formulae expressing cuspidal W eyl sums, associated to hyperbolic distribution problems in Siegel 3-folds and

H ilbert m odular varieties, in terms of Fourier coe cients for M aass and H ilbert-M aass forms of half-integral weight. The case m=3, (p;q)=(2;1) with base eld Q was studied in [14]. Convexity and sub-convexity results for these Fourier coe cients, combined with an analogous treatment of the eigenfunctions for the continuous part of the spectrum of the Laplace-Beltram i operator, imply the equidistribution properties stated in this section.

Let Q be a non-degenerate integral quadratic form whose signature over R is (p;q), p+q=m, $pq \in 0$. Let 2R, $\in 0$, and

The group G=(Q) ofm m m atrices leaving Q invariant is isom orphic to SO (p;q) and G (R) acts transitively on W. The stabilizer of any $x \ 2 \ W$ is isomorphic to SO (p 1;q) if > 0 and to SO (p;q 1) if < 0. A choice of H aar m easure on G (R) determ ines an invariant volume form on the majorant space H_Q (see x2). Let Q be the Laplace-Beltramioperator on H_Q and an arithmetic subgroup of G, given by a congruence subgroup of a unit group of G. In [29], M aass constructed a -lift on the space of -invariant G integrable functions on G in G . This theta-lift converges on the G eigenfunctions for the discrete spectrum and has in age a corresponding M aass cusp form of half integral weight (see Proposition 2.1).

As mentioned brie y in [14], p84, the classical M aass correspondence in the cases m=4, m=5 leads to the study of other modular groups not treated in that paper. These modular groups arise from considering families of polarized abelian varieties of complex dimension 2. Recall that the complex points V (C) of the Siegel 3-fold can be realized as the quotient of the Siegel upper half space H $_2$ of degree 2 by the integer points Sp (4; Z) of the symplectic group in real dimension 4,

The underlying variety V has the structure of a quasi-projective variety de ned over Q . Here,

The group Sp (4;R) acts on H₂ by

The projective sym plectic group

$$PSp(4;R) = Sp(4;R) = Id_2g$$

is the full group of analytic autom orphism s of the complex domain H $_2$. The matrix J de nes a complex structure and a symplectic form E on R 4 .

To every point z 2 H 2 we can associate the complex torus

$$A = C^2 = 7^2 + 7^2$$

where $L=Z^2+zZ^2$, and the Riemann form E determines an R-linear non-degenerate alternating form on C^2-C^2 taking integer values on L-L which gives a principal polarization of A. The complex torus A has the structure of an abelian surface. In fact, the points of the complex variety V(C) correspond bijectively with the complex isomorphism classes of principally polarized abelian surfaces.

For an abelian variety A, we let End(A) be the endom orphism ring and we put End_o(A) = End(A) $_{\rm Z}$ Q. If A is simple, then End_o(A) is a division algebra over Q with a positive involution induced by the polarization of A.

A lbert [1], [2], [3] classi ed the division algebras over Q with positive involution. For the case of abelian surfaces dim (A) = 2, this gives the following (see for example [55] Proposition (12)).

Proposition 1.1. If A is a simple abelian surface then End(A) is one of the following:

- (1) the ring Z,
- (2) an order in a real quadratic eld F,
- (3) an order in an inde $\,$ nite quaternion division algebra Q $\,$ over Q $\,$
- (4) an order in a quartic CM eld K (totally imaginary quadratic extension of a real quadratic eld).

We restrict ourselves to families of simple abelian surfaces, the non-simple case being essentially covered by [14], as then the abelian surface is isogenous to a product of elliptic curves. In Proposition 1.1, case (1) is the generic case which will also not interest us here. Case (2) leads to considering families of Hilbert modular surfaces, case (3) to families of modular curves and case (4) to families of CM points. Case (4) will appear as a special case of Theorem 12.

The case m=5, (p;q)=(3;2), together with a natural isom orphism between Sp(4;R) and SO(3;2) enables us to apply the results of x2 to H $_2$ acted on by the lattice Sp(4;Z). Let R $_1$ be a fundam ental domain for the action of Sp(4;Z) on H $_2$ and normalize the invariant volume form $!_1$ on H $_2$ so that R $_1$ has volume $!_1(R_1)=1$. We describe in x4 sub-domains Sd, d > 0 and Ed, d < 0 arising from = d square-free with d = 1 m od 4. The complex surfaces Sd are related to case (2) in that they are the H umbert surfaces and parameterize abelian surfaces whose endomorphism ring contains an order in the real quadraticelle F = Q(=0). On the other hand Ed has the structure of a real variety of real dimension 3.

The case m = 4, (p;q) = (2;2), together with a natural isom orphism between SL(2;F) $_{\mathbb{Q}}$ R, where F = Q (d), and SO (2;2) leads to considering H 2 acted on by the lattice SL(-), where is the ring of integers of F. Let R $_2$ be a fundam ental domain for the actions of SL(-) on H 2 and normalize the invariant volume form $!_2$ on H 2 so that $!_2$ (R $_2$) = 1. We describe in x4 subdomains $X_{d,n}$, n > 0 arising from = n square-free with n N()N(-), some 2 F (the case n < 0 leads to nothing new as SO (2;1) 'SO (1;2)). The complex curves $X_{d,n}$ are related to case (3) in that they parameterize abelian surfaces whose endom orphism ring contains an order in the inde nite quaternion algebra Q $_{d,n}$ over Q with parameters (d; n=d), for a certain 2 F.

In x5 we derive in P roposition 5.1 vanishing results for limits of the cuspidal W eyl sum s on the side of the orthogonal groups in the above situations, which then apply to the modular side by the discussion of x4. Although we apply our results to families of principally polarized abelian varieties, the same arguments go through without this polarization assumption. In this paper, we do not explore in these same situations the analytically more involved question of how to modify the classical M aass correspondence for the eigenfunctions of the continuous spectrum of $_{\mathbb{Q}}$. Alternatively, one may derive directly in the case m=4;5 upper bounds for W eyl sums for eigenfunctions for the continuous spectrum, that is the analogues of the results for m=3 of our x7. We hope to return to this in a later paper. In general, the cuspidal case we treat here is arithmetically more interesting. Together, such results give the following.

E quidistribution in genus 2: (i) The fam ily $fS_dg_{d>0}$ of Humbert surfaces and the fam ily $fE_dg_{d<0}$ of real 3-folds, where d is square-free and d 1 m od 4, are equidistributed in Sp(4;Z)nH $_2$. Namely, if $_1$ is a convex region with sm ooth boundary in R $_1$ we have

(ii) Let d be a positive square-free integer and the ring of integers of Q (\overline{d}). The fam ily $fX_{d,n}g_{n>0}$ of modular curves, where n is congruent mod \overline{d} to the norm of an ideal in the same class as the inverse dierent of Q (\overline{d}), is equidistributed in SL ($\overline{}$) nH 2 . Namely, if $_2$ is a convex region with smooth boundary in R $_2$ we have

The case m = 3, (p;q) = (2;1), together with a natural isom orphism between SL(2;F) $_{\mathbb{Q}}$ R, where F is a totally real eld of degree g over Q, and SL(2;R) leads to considering H g acted on by the lattice SL(A) where A is a fractional ideal in F. The case g = 1 was treated in [14]. However, for the case g > 1, we need to adapt the classical M aass correspondence to the Hilbert modular situation (see x3) and we need new (as yet unproven) subconvexity results (see x8), hence our assumption of the generalized Riemann hypothesis (GRH) in Theorem 12. In order to treat the continuous spectrum, in x7 we study directly the corresponding Eisenstein Weyl sums.

Let's recall the associated fam ilies of abelian varieties. Let A be a g-dimensional complex torus where now g 1. Let F be a totally real eld with [F:Q]=g. Then A has real multiplication (RM) if End (A) contains an order in F. Such a complex torus always has the structure of an abelian variety (see [55], p207). We assume throughout that is the ring of integers of F and we denote the inverse dierent by -. Let A be a fractional ideal of F.

The group

acts by fractional linear transform ations on H g , via the g G alois em beddings of F into R, and induces an action of PSL (A) = SL (A)=f Id_2g . The quotient space

is called a H ilbert m odular variety and corresponds bijectively to the complex isom orphism classes of polarized g-dimensional abelian varieties A with RM by . In particular, as a complex torus we may write

for som e z 2 H g w ith A + z: embedded in C g using the G alois embedding of F into R g . The abelian variety A is principally polarized when A = -. When g = 2, we recover an example of case (2) in Proposition 1.1. There is a natural modular embedding

$$PSL(-)nH^2! Sp(4;Z)nH_2;$$

which is described in detail for arbitrary g in [55], Chapter IX, so that the Hilbert modular surfaces can be viewed as subsurfaces of the Siegel 3-fold. In this context, they are referred to as Humbert surfaces.

We consider in xx6,7,8 the situation arising from = 2, $\in 0$. When is totally negative this leads to the set of Heegner points (coming from SO $(2)^g$) and when is totally positive to families G of real g-dimensional varieties (coming from SO $(1;1)^g$), which for g=1 are primitive closed geodesics (see x4). The Heegner points correspond to abelian varieties of dimension g with complex multiplication by an order in F (),

and so the case g=2 is related to case (4) in Proposition 1.1. Let R_g be a fundam ental dom ain for the action of SL(2;) on H^g and normalize the invariant volume form g on H^g so that $g(R_g)=1$.

The main application in the case m = 3 is as follows.

Theorem 1.2. Let F be a totally real number eld of degree g 1 over Q with ring of integers . Assume that F has class number 1. Let 2 , \in 0 be a generator of the relative discriminant of F ()=F. Under GRH (or rather subconvexity), the families f g $_0$ of Heegner points and fG g $_0$ of real g-dimensional subvarieties are equidistributed in SL(2;)nH $_g$. Namely, if $_g$ is a region with smooth boundary in R $_g$ we have

We have made a number of simplifying assumptions which are not essential. In order to reduce the technicalities, we have assumed that A=, that F has class number 1 and that generates a fundamental relative discriminant. The technicalities arising from arbitrary class number and arbitrary A can be simplied by working in the adelic language. In [7], [8] it was indicated how the fundamental discriminant assumption, appearing also in [14], can be removed for the case g=1 and those same ideas may be applicable here. See also [18].

The present paper is organized as follows. In x2 we recall the classical M aass correspondence of [29] and derive formulae in Proposition 2.2 for Fourier coe cients of M aass form s of half-integral weight in term s of W eyl sums. In x3 we prove new results that generalize, in Proposition 3.2 and Proposition 3.3, the M aass correspondence and the Fourier coe cient formulae to the case m=3, (p;q)=(2;1) with base eld F a totally real eld of degree g=1 and arbitrary class number. This extends results of [14], [23], [29] that treat the case g=1.

In x4 we use the \accidental" isom orphism s to relate the results of x2 and x3 to Shim ura varieties. The case m=4;5 leads to studying families of H umbert surfaces in Siegel 3-folds and of modular curves in these H umbert surfaces. The case m=3 leads to studying families of H eegner points and of certain sub-domains of real dimension g, which for g=1 are primitive closed geodesics, in H ilbert modular varieties of complex dimension g.

In x5 we show how the subconvexity results of [14] (in fact convexity results would su ce here) can be used to give vanishing of limits of cuspidal Weyl sums.

In x6 we derive in Lem m a 6.3 upper bounds for cuspidal Weyl sum s in the Hilbert modular case. In x7, we prove in Proposition 7.1 and Proposition 7.2 new results that extend classical form ulae of Hecke [22] expressing Eisenstein

W eyl sum s, in the H ilbert m odular case, in term s of central values of certain L-series. These results are of independent interest.

The results of x6 and x7 combined with subconvexity results for Fourier coe cients of Hilbert-M aass modular forms are then used to prove Theorem 1.2. The corresponding subconvexity results for the holom orphic case have been shown in [12]. We would need (in the notation of x3, where is an integer of F assumed square-free or a fundamental relative discriminant in the case of class number 1) the Fourier coe cients (;f) for f a cusp form with L^2 -norm 1 or an Eisenstein series, with eigenvalue and half-integral weight k, to have an upper bound in the -aspect as good as (;f) k; c() $N_{F=Q}$ ()j L^{1-4} for a xed > 0 and a positive explicit constant c(). Partial progress towards subconvexity results in the M aass case have been made by G ergely H arcos [21], but the complete adaptation of the method of [12] to the M aass case remains elusive 1. Such results would follow however from GRH, so our Theorem 1.2 remains conditional. A lithough we do not pursue this here, from our methods we can estimate rates of convergence in the above equidistribution statements.

For compact maximal ats of SL_n (Z) nSL_n (R)=SO (n), an equidistribution result has been obtained in [34], and this represents a dierent type of equidistribution result to that of [14], even in the g=1, n=2 case. An equidistribution result for H eegner points in H ilbert m odular varieties using other methods has been announced by Zhang [61], assuming as yet unproven subconvexity results for H ilbert {M aass Fourier coecients. In [33], subconvexity results are obtained for Rankin-Selberg L-functions which prove an equidistribution property for incomplete orbits of H eegner points over denite Shimura curves.

Just after completing the write-up of this paper, we received a preprint of C lozel and U lm o [10] where similar, and more general, equidistribution results are independently obtained. The methods and language used in their paper are quite dierent, even though in certain aspects a comparison with the present paper is likely implicit. They use, in particular, methods in ergodic theory due to Ratner [35], formulae of Waldspurger [57], and generalizations of Hecke's formulae on Eisenstein series due to Wielonsky [58]. Their treatment of results analogous to our Theorem 12 also appeals to as yet unproven subconvexity results. In an earlier paper [9], these authors prove equidistribution results for certain families of Shimura subvarieties of

positive dim ension 2. They use ergodic argum ents, which do not give rates of convergence, in contrast to the methods used in the present paper.

2. The classical M aass correspondence

As in [14], x4, we exploit a construction of M aass forms as integrals of certain autom orphic eigenfunctions for the ring of invariant di erential operators, and in particular of the Laplace-Beltram i operator, against Siegel theta functions. We recall in outline this construction in order to x notations, referring the reader to [14], [23], [29] for details.

Let Q be a symmetric m m matrix with half-integer o -diagonal elem ents and integer diagonal elements. Let (p;q), with integers p;q satisfying p + q = m, be the signature of Q. The majorant space H_Q of Qis de ned as

From its de nition it follows that, for each xed z 2 H, the function (z;) on H $_{\mathbb{Q}}$ is left —invariant. Let the discrim inant D, the level N for \mathbb{Q} and the de nition of a M aass form of weight k, discrim inant D for level N be the same as in [14], x2, x4. 7. E isenstein W eyl sums: the case of the Hilbert modular group for class number 1

We continue with the notations of xx3{5. The methods of Maass, in particular Proposition 2.1 and Proposition 3.1, do not apply to the eigenfunctions of the continuous spectrum of the Laplacian, which is non-trivial in all cases considered in this paper as the group actions are not co-compact. These eigenfunctions are furnished by the E isenstein series. We are therefore led to consider averages or Weyl sums as in x5 with cusp forms replaced by E isenstein series.

We shall restrict ourselves to the case m=3, (p;q)=(2;1) and to the Hilbert modular group =A=PSL(2;1) where =E=0 is the ring of integers of a totally real eld F of degree $ext{g}=1$ with class number 1. We repeatedly use facts about Eisenstein series from [16], [45], [46], [47], and [48]. The generalization to arbitrary class number and to arbitrary A should be straightforward if somewhat technical, with some necessary material available in [54]. In order to extend to the case $ext{g}>1$ the arguments of [14] on Eisenstein Weyl sums, we will generalize in this section some

classical arguments due to Hecke [22] and Kronecker [26]. It would be of interest to consider also the cases m = 4, (p;q) = (2;2) and m = 5, (p;q) = (3;2), in order, for example, to deduce equidistribution results on the non-cuspidal part of the corresponding L²-spaces.

In [14], the E isenstein W eyl sum s for g=1 are shown to be proportional to the Fourier coe cients of E isenstein series of half-integral weight and level 4 using explicit form ulae for these coe cients derived in [20]. In [46], general form ulae for Fourier coe cients of E isenstein series of half-integral weight and level dividing 4 for the group Sp (m;F) are obtained, where F is a totally real algebraic number eld. The case m=1 gives generalizations of the form ulae of [20] to the Hilbert modular case. In the notations of [46], Theorem 6.1, the product L (s; $_m$)L (s; $_F$) $_{-}$ $_{-}$ $_F$ $_{-}$ $_m$) occurring (at $s=\frac{1}{2}+it$) in Proposition 7.1 and Proposition 7.2 is proportional to the product of the rst Fourier coe cient and the \ "-th Fourier coe cient c_f (;s) of the E isenstein series E $_{-}$ 0 = E $_{-}$ 0(z;s;1=2;0; $_m$;4) of level 4 and weight 1=2. The c_f (;s) of [46] correspond to $N_{F=Q}$ () $j^{1=2}$ (;E $_{-}$ 0) with the conventions that we adopt in x4 (3.8).

These results enable us to bound the E isenstein W eylsums from above in terms of the Fourier coecients of E isenstein series of weight 1=2 and level 4, or alternatively central values of L-functions.

8. Expected subconvexity results and proof of Theorem 1.2

We continue with the assumptions and notations of x6 and x7. The equidistribution results of Theorem 12 would follow, without GRH, from an unconditional proof of

provided by the B rauer-Siegel Theorem [6], [51] together with generalizations to the case g>1 of the subconvexity results for g=1 in [14], Theorem 5 would imply (8.1) and (8.2). The corresponding subconvexity results for the holomorphic case have been shown in [12]. We would need the Fourier coe cients (;f) for f a cusp form with L 2 -norm 1 or an E isenstein series, with eigenvalue and half-integral weight k, to have an upper bound in the -aspect as good as (;f) k; c() $N_{F=Q}$ () j $^{1=4}$ for a xed > 0 and a positive explicit constant c(). From Lemma 7.3, the desired result for E isenstein series would follow from a subconvexity result for L-functions of G L (1;F). Partial progress towards subconvexity results in the M aass case have been made by G ergely H arcos [21], but the complete adaptation of the G L (2;F) methods of [12] to the M aass case remains elusive. Such results would follow however from G R H, so our T heorem 1.2 remains conditional.

N ote added in Proof: As remarked to us by Emmanuel Ullmo, some comments must be added about the dependence on the parameter m $2\ Z^{g-1}$ in the upper bounds for Eisenstein series. We will add such a comment shortly.
