VOLATILITY ESTIMATORS FOR DISCRETELY SAMPLED LEVY PROCESSES

This paper provides rate-e cient estim ators of the volatility parameter in the presence of Levy jumps.

1. Introduction. In this paper, we continue the study started in [2], about the estimation of parameters when one observes a Levy process X at n regularly spaced times n;2 n;:::;n n, with n going to 0 as n! 1. In our earlier paper, we were concerned with the asymptotic behavior of the Fisher information, with the objective of establishing a benchmark for what e cient estimators are able to achieve in that context. Now, we wish to exhibit estimators which both achieve that rate and can be explicitly computed.

We want to estimate a positive parameter; which we call volatility, in the model

where W is a standard W iener process or, m ore generally, a sym m etric stable process of index , and the process Y is another Levy process w ithout W iener part and w ith jumps \dom inated" in a sense we make precise below by those of W . A llowing for jumps is of great interest in mathematical nance, in the diverse contexts of option

pricing, testing for the presence of jumps in asset prices, interest rate modelling, risk management, optimal portfolio choice, stochastic volatility modelling or for the purpose of better describing asset returns data (see the references cited in [2]).

asymptotically as $_{n}$! 0 and $_{n}$! 1. This is in line with the results of [2], in which we proved that property for the Fisher information. In other words, we want to be able to estimate the volatility parameter—at the same rate when Y; a jump perturbation of W; is present as when it is not. In some applications, Y may represent frictions that are due to the mechanics of the trading process, or in the case of compound Poisson jumps it may represent the infrequent arrival of relevant information related to the asset. Given that both W and Y contribute to the overall observed noise in X; it is not a priori obvious that it should be possible to estimate—equally well (at least in the rate sense) with and without Y: Beyond the robustness to misspeci cation risk that such a result a ords, it also for instance paves the way for risk management or option hedging that is able to target the \W risk" (continuous when = 2) separately from the \Y risk" (discontinuous).

We distinguish between a parametric case, where the law of Y is known, and a sem iparametric case, where it is not. We show that, in the parametric case, one can not estimators which are asymptotically experience in the Cramer (Rao sense, meaning that the asymptotic estimation variance is equivalent as $n \cdot 1$ to the inverse of the Fisher information for the model (2) without the perturbation Y. This is possible when the law of Y is completely known. In the semiparametric case, where that law is unknown, obtaining asymptotically experience eximators requires $n \cdot n$ to go fast enough to 0; but we can then exhibit estimators that are exient uniformly when the law of Y stays in a set su ciently separated from the law of W. And in general

we can exhibit a large class of estim ators which are consistent and achieve a speci ed rate (although not the e cient rate).

A distinctive feature of the present paper is that we construct estim ators which are as simple as possible to implement. For example, in the parametric situation where the law of Y is known, one can in principle compute the MLE, which is of course e cient. In practice, this is hardly feasible, as the likelihood function derived from the convolution of the densities of W and Y will in most situations not be available in closed form. So we provide a number of other { much simpler { estimators which are not as good (in the sense of not reaching the C ramer-R ao lower bound in general) but not too bad either (in the sense of achieving the e cient rate of convergence).

The paper is organized as follows. In Section 2, we specify our estimating setting. Section 3 is devoted to estimating equations: the estimators we propose all fall in that class and we state a general result which covers them all. Sections 4 and 5 are devoted to the parametric and sem iparametric cases respectively. Some examples are developed in Section 6, 7, 8 and 9, where we consider special types of estimating equations such as the empirical characteristic function, power variations and power variations with truncation.

2. The setting. W ith $X_0 = 0$, we observe n i.i.d. increments from the Levy process (1),

so that, when = 2; W is a standard W iener process. The parameter to be estimated is , and we will single out two situations concerning the parameter space : either = (0;1), or is a compact subset of (0;1).

The law of Y (as a process) is entirely specified by the law G of the variable Y for any given > 0. We write $G = G_1$, and we recall that the characteristic function of G is given by the Levy-K hintchine formula

Now we recall some results from [2]. The variable W $_1$ adm its a C 1 density h , which is dierentiable in the state variable (the derivative is denoted by h^0). Then we set

If we have a single observation X there is a (nite) F isher information for estimating , which we denote by I (;G). With n observed increments the corresponding F isher information becomes

Part (a) of the above theorem and (12) hint towards the existence of estimators b_n such that p_n (b_n) converges to a centered Gaussian variable with variance p_n (p_n) under p_n , when G 2 G is known: this is the parametric situation, and we will propose such estimators in Section 4 below. In the semiparametric situation where G is unknown, (c) suggests that we cannot achieve the same rate, unless, as given in (b), we know that G is in the class G(;) for some < and some function 2.

As a matter of fact, we can do slightly better. If (x) = > 0 for all x, we can still de ne G (;) by (6), although no longer belongs to .W e denote such a class by \overline{G} (;), that is we introduce the notation (we do not need to distinguish < 2 and = 2 here):

For example, G_0 is the class of all G 's for which Y is a pure drift ($Y_t = bt$), whereas \overline{G}_0 is the class of all G 's for which Y is a compound Poisson process plus a drift. Also, any stable process Y with index < 2 belongs to \overline{G} , but not to G.

3. A bout estim ating equations. The practical estim ators we will propose for are all obtained by setting an estimating equation (also known as a generalized m om ent condition) to zero. We prove here a general result about the asymptotic properties of such estim ators, which will be used several times below. Similar general results for estimating equations are of course known (see various forms in [5], [6] and [7]), but we adapt them here to our setting with assum ptions (by no means minimal) that are su cient in our context.

Recall that we want to estimate a parameter > 0. At stage n we observe p_n i.i.d. random variables $_{i}^{n}$ and introduce two auxiliary variables $S_{n}>0$ and Q $_{n}$ 2 R . Under the associated probability measure P_n ; we suppose that the families $(S_n;Q_n)$ and ($\binom{n}{i}:1$ i p_n) are independent, and of course p_n ! 1 . Let us introduce the following conditions:

A ssum ption 1 (A 1). If n : > 0 then $S_n : in P_n$, {probability.

A ssum ption 2 (A 2). If $_n$! > 0 then the sequence (Q_n jP $_{n;_n}$) is tight.

Note in particular that we are not assuming that the estimating equation is correctly centered: correct centering would requiring using $F_{n;s;q}$ instead of $H_{n;s}$: $H_{n;s}$ may be equal to $F_{n;s;q}$; but can also be just an approximation to it (in which case we will talk about \approximate centering") that may for instance be valid as $n \,! \, 1$. Incorrect centering leads to estimators that are asymptotically biased, although that e ect can be mitigated as $n \,! \, 1$ if $H_{n;s}$ approximates $F_{n;s;q}$ (see Assumption (B5) below).

Let us now list a series of assum ptions on the previous functions:

For this, it is enough to prove that from any subsequence one can extract a further subsequence along which (26) holds. So, in view of (A1) and (A2) it is no restriction to assume that in fact $(S_n; Q_n)$ converges in law to $(Q_n; Q_n)$ for some variable Q_n .

In fact, due to the independence of $(S_n;Q_n)$ and $(W^0(n;s;q):s>0;q2R)$, we can replace the pair $(S_n;Q_n)$ in the left side of (26) by any other pair $(S_n^0;Q_n^0)$ having the same law than $(S_n;Q_n)$ and still independent of $(W^0(n;s;q):s>0;q2R)$. W ith this general result in hand, we now turn to our specic situation: estimating in the presence of the Levy process Y; rst when the law of Y is known and second when it is not.

4. Estimation of in the parametric case. In this section, we study the estimation of when the law of Y; i.e., the measure G 2 G, is known. We will construct a class of estimating equations for , with $\frac{n}{i}$ given by (3).

Remark 1. In light of (41), it is of course possible / advisable to select the function k to minimize $^2(k)$: The choice $k=\overline{h}$ is indeed possible; by (11) the function $k=\overline{h}$ satistics (35) with =0 (resp. =2) if <2 (resp. =2). Such a choice gives asymptotically e cientestim ators, in the strong sense that they behave asymptotically like the e cient estimators for the model $X_t=W_t$ (with no perturbing term Y).

R em ark 2. To put these estim ators in use we would need to num erically compute the function $_{G}$; $_{ik}$ (u;v;0), for a single value of v (either 1 or 1=S $_{n}$ (G)), and all values of u (in principle). Except in special situations (see for instance Section 6), there is

no closed form for this function, and we have to resort to numerical integration or to M onte{C arb techniques. For this it is of course helpful to have a closed form for k (or rather for the truncated k_n). In general, this is not the case for the function $k=\overline{h}$ (the optimal choice), unless =2.

Remark 3. As an example of function k, we can take k(x) = jxf, for some r > 0 when = 2 and r = 2 (0; = 2) otherwise (when = 2 and r = 2 this is the optimal choice since $\overline{h}_2(x) = x^2$): the function $_{G; n; jk_n}$ is still not explicit, but it is easily approximated by M onte {Carlo techniques, at last when Y_t can be simulated, or it may be available in closed form for some common distributions of Y. We will do that in some detail in Section 7. In any event, the limiting variance is easy to compute from (41).

5. Estimation of in the semiparametric case. Perhaps more realistic than the situation of Theorem 3 is the case where we want to estimate; but the measure G is unknown, although we know that it belongs to the class G. This is a semiparametric situation: parametric as far as W_t is concerned, but nonparametric as far as Y_t is concerned. Because G is unknown, the estimating equations in this case must be based on the law of W alone. The challenge is then to achieve rate e ciency despite the lack of information about G:

5.1. Construction of the estimators. As said before, we cannot hope for estimators b_n that behave nicely for all G 2 G at once. Therefore we suppose that G is unknown, but is known to belong to \overline{G} (;) for som e < and som e > 0: we refer to this as C ase 1.W e also consider a more restrictive situation, called C ase 2, for which G is known to belong to the set $\overline{G}^{\circ}($;).

Remark 6. In connection with what precedes, one should mention that when (69) fails the actual rate of convergence (that is, a sequence $_n$ such that the law of $_n$ ($(b_n(k))$) converges to a non{degenerate limit, or at least admits among its weak limiting measures a non{degenerate one) is not only unknown, but actually depends on the true underlying (unknown) measure G and in particular on the minimal index 0 such that $G \ 2 \ \overline{G} \ 0$ (we know that 0), but the inequality could be strict). In other words, the rate could be for example $^p \ \overline{n}$ for a particular G, even without (69).

R em ark 7. However we will see in the examples below (see Section 9 in particular) that (70) is necessary for having convergence to a centered distribution with rate p \bar{n} and also that the rate in (b) of Theorem 5 is sharp, if we want to have a result which holds uniform ly in G 2 $\bar{G}^{0}($;). We do not know whether (69) or the rate in (b) are optimal for Theorem 4.

R em ark 8.0 fcourse itm ight exist other { thoroughly dierent { estim ators behaving better than the b_n (k)'s, and perhaps having a better rate than in (b) of these theorems (the rate cannot be improved in (a), of course). We think this doubtful, however.

Remark 9. The most interesting situation is when we have asymptotic e ciency (this happens when G is symmetrical), or at least \rate{e ciency" (that is of order $\frac{p}{n}$). We have this under (69) or (70), which mean that $\frac{p}{n}$ goes to 0 fast enough. Of course having $\frac{p}{n} = o(1-n)$ is of no practical use. When $\frac{p}{n} = 1-n$, then rate{e ciency is satistical as soon as $\frac{p}{n} = \frac{p}{n}$ is a compound Poisson process with drift, rate e ciency holds as soon as $\frac{p}{n}$ is bounded, whatever $\frac{p}{n} = \frac{p}{n}$ is bounded.

Remark 10. When we do not know that G is symmetrical we cannot achieve asymptotic e ciency even under (69). However the asymptotic variances in the two theorems above are the same, up to the factor 1 2: hence by choosing small one can approach asymptotic e ciency as much as one wants to.

with $b_1 > 0$. (If $b_1 = 0$ for some choice of (r; ;c) then the parameter—is not identied by an estimating function based on that combination.) A lso, $v_1 = 0$ corresponds to a rate of convergence of the estimator of n^{1-2} ; and any value $v_1 > 0$ corresponds to a slower than n^{1-2} rate of convergence.

We also note that when $b_1 > 0$ the rate of convergence and asymptotic variance of the sem iparam etric estimator of are identical at the leading order in $_n$ to the expressions one would obtain in the fully parametric, correctly specified, case where centering of the estimating equation is done with either (94) or (96) as appropriate, instead of the approximate centering using (95) or (97). Centering using the latter is of course the only feasible estimator in the sem iparametric case where the distribution of Y is unknown.

In what follows, we use the explicitness of this model to fully characterize the asymptotic distribution of the sem iparam etric estimator of , i.e., $(b_0;b_1;v_0;v_1)$ as functions of (r; ;c) and the param eters of the model (; ;):

8.1. Power variations without truncation. In that situation, we have for the asymptotic variance:

R em ark 11. The estimator based on power variations converges (not taking the bias into consideration) at rate n^{1-2} only when r-1: When r>1 the mixture of jumps and volatility slows down the rate of convergence ($v_1>0$). When r=2; the parameter is simply not identified, as is obvious from the fact that E (X^2) = (X^2 +): This is also apparent here from the fact that X^2 as X^2 the bias no longer vanishes asymptotically. And the bias even worsens the rate, of course.

R em ark 12. When r < 1; the asymptotic variance v_0 is identical to the expression obtained without jumps, as was the case when the log-likelihood score was used as an estimating equation. When r = 1; the rate of convergence remains n^{1-2} ; but v_0 is larger in the presence of jumps.

8.2. Power variations with $^{1=2}$ truncation. If we truncate the increments according to () = c $^{1=2}$; then v_1 = 0 for all values of r 2 (0;2] and

As for the bias, we have $b_1 = 1$ and

R em ark 13. Truncating at rate $^{1=2}$ restores the convergence rate $n^{1=2}$ for all values of r; (again, regardless of the bias) and perm its identication when r = 2:

When 0 < r < 1 (where the rate $n^{1=2}$ was already achieved without truncation), not truncating can lead to either a smaller or larger value of v_0 than truncating at rate $n^{1=2}$; depending upon the values of (2 ;c):

R em ark 14. The asymptotic variance v_0 is identical to its expression when no jumps are present, as it should be in view of our general results (as said before, this type of truncation leads to the estimators studied in our general results). In all cases, the bias is smaller than when no truncation is applied.

8.3. Power variations with slower than $^{1=2}$ truncation. If we now keep too m any increments by truncating according to () = c $^{1=2+}$; with 1=2 < < 0; then we have for r 2 (0;2]:

Remark 16. The expressions for < 0 do not converge to those with $O(\frac{1-2}{n})$ truncation as "0 because of the essential singularity of the incomplete function near in nity, given in (98): when $() = c^{1-2+}$ then ((1+r)=2;) is evaluated at $()^2=(2^2)=c^2^2=(2^2)$ and for xed < 0; terms proportional to $\exp(c^2)^2=(2^2)$ are negligible in the Taylor series in of v_0 and v_0 . This is not the case when v_0 however.

R em ark 17. As for the bias, keeping \too m any" but not all increments (1=2 < 1=(2+2r)) leads to a smaller bias than keeping all increments, since 3=2++r>1 r=2; but to a larger bias than keeping just the right amount since 3=2++r<1:

8.4. Power variations with faster than $^{1=2}$ truncation. Finally, if we keep too few increments by truncating according to c $^{1=2+}$; with > 0; then $v_1 =$ for all values of r 2 (0;2] and

$$v_0 = \frac{p_{\frac{1}{2}} (1 + r)^2}{2c (1 + 2r)}$$

As for the bias, we have $b_1 = 1$ and $b_0 = ...$

R em ark 18. Truncating at a rate faster than $^{1=2}$ deteriorates the convergence rate of the estim ator from $n^{1=2}$ to $n^{1=2}$ $_n$ $^{=2}$: while we successfully elim in ate the impact of

jum ps on the estim ator, we are at the same time reducing the e ective sample size utilized to compute the estimator, which increases its asymptotic variance.

R em ark 19. The expressions for v_0 and b_0 for > 0 also do not converge to those with O ($_n^{1=2}$) truncation as ~# 0 because once again we cannot interchange the order of the lim its $_n$! 0 and ! 0.

8.5. Com parison with the general case. Let us compare, in the sem iparam etric case, the speci c results just obtained with the general results obtained in Theorem s 4 and 5. In the present situation we have G 2 \overline{G}_0^0 . So these general results assert that if

(99)

then the estimators b_n converge at a rate p = 1, and the limit of the normalized error is Gaussian without bias; when (99) fails but p = 1 0 yet, then the sequence (p = 1) p = 1

The estimators (93) converge at rate $\frac{p}{n}$ when $v_1=0$ and n $_n^{2b_1}$ is bounded (then there is a bias) or n $_n^{2b_1}$! 0 (there is no bias). O therwise, the sequence $p - \frac{v_1}{n} \frac{v_1}{n} \frac{v_1}{n}$ (b_n) is tight. Then:

Power variation without truncation: we have a rate $\frac{p}{n}$ only when r 2 (0;1] and n $\frac{2}{n}$ r is bounded. O therw ise the rate is always worse than in our general results: this was expected, of course.

Power variation with $^{1=2}$ truncation: If $n \ ^2_n \ ! \ 0$ we have rate $^p \ \overline{n}$ with asymptotically unbiased error. If $n \ ^2_n \ ! \ a \ 2 \ (0;1)$ we have rate $^p \ \overline{n}$ with asymptotically biased error. If $n \ ^2_n \ ! \ 1$, then $\ ^1_n \ ^1_n$

also for r > 2 here, as a m atter of fact), but of course the asymptotic variance depends on r, and also on c.

Power variation with slower than $^{1=2}$ truncation: The rate is p $_n$ if 1=(2+2r) < 0 and n $_n^2$ is bounded, or if 3(2+4r) < 1=(2+2r) and n $_n^{3+2+2r}$ is bounded. This is worse than the previous case.

Power variation with faster than $^{1=2}$ truncation: The rate is at most p \overline{n}_{n} , and always worst than in the $^{1=2}$ truncation case.

- 9. Example: Sum of two stable processes. In this last section we consider the case where Y is also a symmetric stable process, with index 2 (0;). Then $G \ 2 \ \overline{G}^0$.
- 9.1. The empirical characteristic function. First, we can consider estimators based on the empirical characteristic function, that is we consider k(x) = cos(wx) for some w > 0. We have the parametric estimate $b_n = b_n(G; ; k)$ of Theorem 3 (here k is bounded, so is indeed irrelevant). The sequence $\frac{p}{n}$ (b_n) converges in law to N (0; $\frac{p}{n}$ (k), where $\frac{p}{n}$ (k), which by Theorem 5 behaves as such: under

 $^p \, \overline{n} \,$ (b_n (k)) converges in law to N (0; 2 2 (k)). And in general the sequence p $\overline{n} \, V$ \overline{n}) (b_n) is tight.

In fact, since we are in C ase 2 the preliminary estimator $S_n = S_n$ (G) is the same in both cases, and b_n and b_n (k) are the solution of U_n (u) = 0 and U_n^0 (u) = 0 respectively, which are closest to S_n , and the dierence between these two estimating functions is

(recall (79) and (85)). If we use the explicit form s (80) and (83), we get

We conclude that the results of Theorem 5 are sharp, for the particular estimation functions $k(x) = \cos(wx)$ at least.

9.2. Truncated power functions. We can do a similar analysis for the estimators (90), based on the truncated power variation V_n () of (89) with $B_n=0$ (because Y is symmetrical here). That is, we consider the truncated power variations at the level $\frac{1}{n}$. Namely when $n = \frac{2}{n}$! 1, one can show that, at least when is small enough (but it is probably true for all > 0), then the sequence $\frac{1}{n}$ (b_n) is tight and its limiting distributions include some Dirac masses at non vanishing constants. So here again the results of Theorem 5 are sharp. But of course, as already said before, this does not completely rule out the existence of estimators constructed in a different way and behaving better.

10. Conclusions. We exhibited a class of estim ators for the volatility parameter in a model where the driving process W_t is perturbed by another process Y_t : These estimators can be designed in such a way that they are immune to the presence of the perturbation Y_t : they are asymptotically e cient, in the strong sense that they behave asymptotically like the ecient estimators for the model $X_t = W_t$ with no perturbing term Y_t .
