

STABILITY OF ENERGY-CRITICAL NONLINEAR SCHRÖDINGER EQUATIONS IN HIGH DIMENSIONS

Abstract. We develop the existence, uniqueness, continuity, stability, and scattering theory for energy-critical nonlinear Schrödinger equations in dimensions $n \geq 3$, for solutions which have large, but finite, energy and large, but finite, Strichartz norms. For dimensions $n \leq 6$, this theory is a standard extension of the standard well-posedness theory based on iteration in Strichartz spaces. However, in dimensions $n > 6$ there is an obstruction to this approach because of the subquadratic nature of the nonlinearity (which makes the derivative of the nonlinearity non-Lipschitz). We resolve this by iterating in exotic Strichartz spaces instead. The theory developed here will be applied in a subsequent paper of the second author, [21], to establish global well-posedness and scattering for the defocusing energy-critical equation for large energy data.

1. Introduction

We study the initial value problem for the following nonlinear Schrödinger equation in spacetime $\mathbb{R}^n = \mathbb{R}_t \times \mathbb{R}_x^n$, $n \geq 3$,

$$\begin{cases} iu_t + \Delta u = f(u) \\ u(t_0; x) = u_0(x) \in H^{-1}(\mathbb{R}^n) \end{cases} \quad (1.1)$$

where $u(t; x)$ is a complex-valued function in spacetime $I \times \mathbb{R}^n$ for some time interval I containing t_0 , and the nonlinearity¹ $f: \mathbb{C} \rightarrow \mathbb{C}$ is continuously differentiable and obeys the power-type estimates

$$f(u) = O(|u|^{\frac{n+2}{2}}); \quad (1.2)$$

$$f_z(u); f_z(u) = O(|u|^{\frac{4}{2}}); \quad (1.3)$$

$$\begin{aligned} f_z(u) - f_z(v) &= O(|u - v|^{\frac{4}{2}}); \text{ if } n > 6; \\ f_z(u) - f_z(v) &= O(|u - v|(\frac{6-n}{2} + \frac{6-n}{2})); \text{ if } 3 \leq n \leq 6; \end{aligned} \quad (1.4)$$

where f_z, f_z are the usual complex derivatives

$$f_z = \frac{1}{2} \frac{\partial f}{\partial x} - \frac{i}{2} \frac{\partial f}{\partial y}; \quad f_z = \frac{1}{2} \frac{\partial f}{\partial x} + \frac{i}{2} \frac{\partial f}{\partial y}.$$

For future reference, we observe the chain rule

$$\operatorname{Re} f(u(x)) = f_z(u(x))u(x) + \overline{f_z(u(x))}u(x) \quad (1.5)$$

as well as the closely related integral identity

$$\int_0^1 (f(u) - f(v)) = \int_0^1 f_z v + \int_0^1 (u-v)(u-v) + \overline{f_z v} + \int_0^1 (u-v)\overline{(u-v)} \, ds \quad (1.6)$$

for any $u, v \in C$; in particular, from (1.3), (1.6), and the triangle inequality, we have the estimate

$$\|f(u) - f(v)\| \leq \|u - v\|^{4/2} + \|v\|^{4/2} : \quad (1.7)$$

Following [6], we shall only consider strong solutions² to (1.1), by which we mean solutions $u \in C_t^0 H_x^{-1}(\mathbb{R}^n)$ to the integral (or Duhamel) formulation

$$u(t) = e^{i(t-t_0)} u_0 - i \int_{t_0}^t e^{i(t-s)} f(u(s)) \, ds \quad (1.8)$$

of the equation (we will explain our notation more fully in the next section). Note that by combining Sobolev embedding, $H^{-1}(\mathbb{R}^n) \hookrightarrow L^{2n/(n-2)}(\mathbb{R}^n)$, and (1.2) we see that $f(u(s))$ will be a tempered distribution uniformly in s . Consequently, there is no difficulty interpreting (1.8) in the sense of tempered distributions at least.

The most important examples of nonlinearities of the above type are the defocusing power nonlinearity $f(u) := +|u|^{4/2}u$ and the focusing power nonlinearity $f(u) := -|u|^{4/2}u$. Note that in these cases, the problem (1.1) is invariant under the scaling

$$u(t; x) \mapsto \frac{1}{(n-2)/2} u\left(\frac{t}{2}; \frac{x}{2}\right); \quad u_0(x) \mapsto \frac{1}{(n-2)/2} u_0\left(\frac{x}{2}\right)$$

and that this scaling also preserves the $H^{-1}(\mathbb{R}^n)$ norm of u_0 . Thus we shall view (1.1) as an H_x^{-1} -critical or energy-critical equation³.

The Cauchy problem (1.1) has been studied extensively in the literature, especially in dimensions $n = 3, 4$; see the references below and particularly the books [2], [5], [6]. One can divide the theory into two parts: the "local" theory in which the solution is either restricted to have small energy, or to have a certain spacetime norm small (which can be achieved for instance by localizing the time interval) and the "global" theory in which there is no size restriction on the solution (other than finite energy). Our focus here will be on the local theory, in which the exact choice of the nonlinearity f does not play a major role; in particular, there will be no distinction between the focusing and defocusing cases. However, the results here will be applied towards the global theory. Specifically, they will be used (together with several other tools, notably an interaction Morawetz inequality and Bourgain's induction on energy argument) in a future paper of the second author,

²In dimensions $n > 4$, the nonlinearity is unlikely to be smooth and so we cannot use the usual trick of working entirely with classical (Schwartz class) solutions first and then taking limits, unless one also performs some regularization of the nonlinearity. If however the nonlinearity is smooth, then it is easy to see that Schwartz initial data leads to Schwartz solutions and, by using the well-posedness and stability theory which we will develop, one can then express the strong solutions given here as the unique strong limit of classical solutions.

³In this paper we shall use energy synonymously with (the square of) the H_x^{-1} norm; the potential energy (which is essentially the $L_x^{2n/(n-2)}$ norm) will not play a role in our discussions.

[21], establishing global well-posedness and scattering for the defocusing energy-critical equation for large $H^{-1}(\mathbb{R}^n)$ data for dimensions $n > 4$; the cases $n = 3, 4$ were treated in [7], [19] respectively (see also the works [1], [2], [13], [20] treating the radial case).

For the energy-critical local theory it is convenient to introduce a number of scale-invariant function spaces. We use $L_x^r(\mathbb{R}^n)$ to denote the Banach space of functions $f : \mathbb{R}^n \rightarrow \mathbb{C}$ whose norm

$$\|f\|_{L_x^r} := \left(\int_{\mathbb{R}^n} |f(x)|^r dx \right)^{1/r}$$

is finite (with the usual modification when $r = 1$). Similarly, for any space-time slab $I \times \mathbb{R}^n$, we use $L_t^q L_x^r(I \times \mathbb{R}^n)$ to denote the Banach space of functions $u : \mathbb{R}^n \rightarrow \mathbb{C}$ whose norm

$$\|u\|_{L_t^q L_x^r(I \times \mathbb{R}^n)} = \|u\|_{q;r} := \left(\int_I \left(\int_{\mathbb{R}^n} |u(t,x)|^r dx \right)^{q/r} dt \right)^{1/q}$$

is finite (with the usual modification when $q = 1$). We will omit mention of the slab $I \times \mathbb{R}^n$ when it is clear from context. In addition to the energy space $C_t^0 H_x^{-1}(I \times \mathbb{R}^n)$, we will also need the Strichartz space $W = W(I \times \mathbb{R}^n)$, defined on $I \times \mathbb{R}^n$ as the closure of the test functions under the norm

$$\|u\|_{W} := \|u\|_{k_{\frac{2(n+2)}{n-2}, \frac{2n(n+2)}{n^2+4}}} \quad (1.9)$$

which is a convenient norm that is particularly well adapted for controlling solutions to (1.1). Similarly, we introduce the nonlinearity space $N^{-1}(I \times \mathbb{R}^n)$ defined on $I \times \mathbb{R}^n$ as the closure of the test functions under the norm

$$\|F\|_{N^{-1}} := \|F\|_{k_{2, \frac{2n}{n+2}}} \quad (1.10)$$

This space is useful for controlling the forcing term $f(u)$.

A large part of the local theory for these energy-critical equations was worked out by Cazenave and Weissler, [3], [4], building upon earlier work of Ginibre-Velo, [11], and Kato, [14], for the energy-subcritical case. In this work, global solutions were constructed for small energy data and local solutions were constructed for large energy data, though, as is to be expected for a critical equation, the time of existence depends on the profile of the initial data and not simply on the energy. Furthermore, these solutions u were unique in a certain Strichartz space and in this space the solution depended continuously⁴ on the initial data in the energy space $H^{-1}(\mathbb{R}^n)$. A later argument of Cazenave, [6], also demonstrates that the uniqueness is in fact unconditional in the category of strong solutions (see also [15], [9], [10], [7] for some related arguments; we reproduce the argument in Proposition 2.3 below).

We now give an extremely oversimplified sketch of how these results are obtained. We rely heavily on the spaces $W(I \times \mathbb{R}^n)$ and $N^{-1}(I \times \mathbb{R}^n)$ introduced earlier. The

⁴Strictly speaking, the continuity in $C_t^0 H_x^{-1}$ was only demonstrated for the defocusing equation; for the general equation the continuity was established in $L_t^q H_x^{-1}$ for any finite q . See [6] for further discussion. In this paper we shall obtain the stronger result of Hölder continuity for the general equation in the scale-invariant space $C_t^0 H_x^{-1}$.

fundamental tools are the Strichartz estimate⁵

$$\|e^{i(t-t_0)} u_0 + \int_{t_0}^t e^{i(t-s)} F(s) ds\|_{W_-} \lesssim \|u_0\|_{H_{x'}^{-1}(\mathbb{R}^n)} + \|F\|_{N_{x'}^{-1}}; \quad (1.11)$$

whenever the right-hand side is finite (and on any spacetime slab $I \times \mathbb{R}^n$ containing $t = t_0$), as well as the Sobolev embedding

$$\|u\|_{L_{x'}^{\frac{2(n+2)}{n-2}}; L_t^{\frac{2(n+2)}{n-2}}} \lesssim \|u\|_{W_-} \quad (1.12)$$

for all $u \in W_-(I \times \mathbb{R}^n)$. We also take advantage of the Hölder inequality

$$\|v\|_{L_t^{4(n-2)} L_{x'}^{\frac{2(n+2)}{n-2}}} \|u\|_{L_t^{\frac{2(n+2)}{n-2}} L_{x'}^{\frac{2(n+2)}{n-2}}} \lesssim \|v\|_{W_-}^{4(n-2)} \|u\|_{W_-}; \quad (1.13)$$

which in conjunction with (1.5) and (1.12) implies that

$$\|f(u)\|_{N_{x'}^{-1}} \lesssim \|u\|_{L_t^{\frac{2(n+2)}{n-2}} L_{x'}^{\frac{2(n+2)}{n-2}}}^{4(n-2)} \|u\|_{W_-}^{(n+2)-(n-2)} \lesssim \|u\|_{W_-}^{(n+2)-(n-2)}; \quad (1.14)$$

Combining this with (1.11) we see that strong solutions to (1.8) which lie in $W_-(I \times \mathbb{R}^n)$ obey the a priori estimate

$$\|u\|_{W_-} \lesssim \|u_0\|_{H_{x'}^{-1}} + \|u\|_{W_-}^{(n+2)-(n-2)};$$

which then suggests that u stays small in $W_-(I \times \mathbb{R}^n)$ whenever u_0 is small in $H_{x'}^{-1}(\mathbb{R}^n)$. This can be made more rigorous by setting up an iteration scheme to construct u ; the case of large energy can be dealt with by an appropriate truncation of time (to reduce the $W_-(I \times \mathbb{R}^n)$ norm of $e^{i(t-t_0)} u_0$). The continuous dependence on the data is not difficult in rough spaces (e.g. in $C_t^0 L_x^2(I \times \mathbb{R}^n)$), but to obtain continuous dependence in an energy-critical space was previously only obtained in the defocusing case by a delicate argument, requiring the energy conservation law and a sharp form of Fatou's lemma; see [6] for details.

The above results (which were obtained by iteration in Strichartz spaces) already form a quite satisfactory local well-posedness theory in the energy space for the above equations. However, there are still some points that need to be resolved. Firstly, the known arguments that establish continuous dependence on the data do not necessarily establish uniformly continuous dependence on the data in energy-critical spaces (though they do apply in more supercritical spaces, such as spaces that scale like $L_x^2(\mathbb{R}^n)$). In fact, in the low dimensional cases, $n \leq 6$, it is possible to establish Lipschitz dependence on the data, because then we can differentiate equation (1.8) using (1.5) to obtain

$$\|u(t) - v(t)\|_{W_-} \leq \|u_0 - v_0\|_{H_{x'}^{-1}} + \int_{t_0}^t \| [f_z(u(s))u(s) + f_z(v(s))\overline{u(s)}] \|_{N_{x'}^{-1}} ds \quad (1.15)$$

and rely on the Lipschitz bounds (1.4) to control the difference between two solutions with slightly different data. The $n = 3, 4$ instances of this argument can be found in [7], [19], as well as Section 3 below. However, in the high-dimensional case the derivative maps $f_z, \overline{f_z}$ are merely Hölder continuous instead of Lipschitz. If

⁵Here and in the sequel, $X \lesssim Y$ will denote an estimate of the form $X \leq CY$ where $C > 0$ depends only on the dimension n .

one then tries to analyze differences of two solutions to (1.15) with slightly different initial data, one no longer obtains any useful bounds⁶.

Closely related to the continuous dependence of the data is the stability theory for the equation (1.1). By this we mean the following type of property: given an approximate solution

$$\begin{aligned} (i) \quad & i\alpha_t + \alpha = f(\alpha) + e \\ & \alpha(t_0; x) = \alpha_0(x) \in H^{-1}(\mathbb{R}^n) \end{aligned} \quad (1.16)$$

to (1.1), with e small in a suitable space and $\alpha_0 = u_0$ small in H_x^{-1} , is it possible to show that the genuine solution u to (1.1) stays very close to α (for instance, in the $W^{1,2}(\mathbb{R}^n)$ -norm)? Note that the question of continuous dependence of the data corresponds to the case $e = 0$. Again, if $n \leq 6$, an analysis based on subtracting (1.15) from the analogous equation for α and applying Strichartz estimates will yield a satisfactory theory, at least when α has small $W^{1,2}(\mathbb{R}^n)$ -norm; the case of large W -norm can be obtained by partitioning the time interval and iterating the small norm theory. See [7], [19] for instances of this argument (which also appears implicitly in [1], [2]). This type of approach does not work directly in dimensions $n > 6$ as the iteration is only Hölder continuous instead of Lipschitz and so, one is unable to close the argument effectively, even when one localizes time to make various norms small.

The purpose of this paper is to complete the previous analysis of Cazenave and Weissler for the Cauchy problem (1.1), by establishing a local well-posedness and stability theory which is Hölder continuous in energy-critical spaces and that applies even for large energy data, provided that the $W^{1,2}(\mathbb{R}^n)$ -norm is known to be bounded. This type of result is necessary for induction on energy type arguments, and will be applied in a subsequent paper of the second author, [21]. The main new tools will be an exotic Strichartz estimate, together with an estimate of fractional chain rule type; the point of working in an exotic Strichartz space is that it becomes possible to work with a small fractional derivative rather than a full derivative while still remaining energy-critical with respect to scaling. A very similar technique was employed by Nakanishi [18] for the energy-critical non-linear Klein-Gordon equation in high dimensions.

We now present our main results. We begin with a preliminary (and standard) local well-posedness theorem, which gives existence and uniqueness, as well as Lipschitz continuity, but in rough (supercritical) topologies. It does not require any exotic Strichartz spaces or nonlinear estimates, relying instead on iteration in the usual Strichartz spaces, the Leibnitz rule (1.5), and Hölder's inequality. It is convenient to place the initial data in the inhomogeneous Sobolev space $H^{-1}(\mathbb{R}^n)$ rather than the homogeneous one $\dot{H}^{-1}(\mathbb{R}^n)$; once we obtain the Hölder continuity estimates on the solution map, we will see that we can easily pass to the homogeneous space from the inhomogeneous one by a limiting argument.

⁶This is basically because any estimate of the form $A \leq C \epsilon^\alpha + A^\beta$, where $0 < \alpha < 1$, does not imply a bound on A which goes to zero as ϵ goes to zero, in contrast to the Lipschitz case, $\alpha = 1$, in which one can obtain a bound of the form $A \leq C \epsilon^\alpha$ (say) if a continuity argument is available and $\alpha > \frac{1}{2}$.

Theorem 1.1 (Standard local well-posedness, [3], [4]). Let I be a compact time interval that contains t_0 . Let $u_0 \in H^{\frac{1}{2}}(\mathbb{R}^n)$ be such that

$$\|e^{i(t-t_0)\Delta} u_0\|_{W_{-1}(\mathbb{R}^n)} \leq \delta_0 \quad (1.17)$$

for some $0 < \delta_0$ where $\delta_0 > 0$ is a small constant. Then there exists a unique solution u to (1.1) in $S^1(I, \mathbb{R}^n)$ (this space will be defined in the next section). Moreover, we have the bounds

$$\|u\|_{W_{-1}(\mathbb{R}^n)} \leq \delta_0. \quad (1.18)$$

$$\|u\|_{S^1(I, \mathbb{R}^n)} \leq \|u_0\|_{H^{\frac{1}{2}}(\mathbb{R}^n)} + \frac{n+2}{n-2} \delta_0 \quad (1.19)$$

$$\|u\|_{S^0(I, \mathbb{R}^n)} \leq \|u_0\|_{L^2(\mathbb{R}^n)} : \quad (1.20)$$

We can generalize (1.20) as follows: if $\alpha \in H^{\frac{1}{2}}(\mathbb{R}^n)$ is another initial data obeying the hypothesis (1.17), with associated solution $\alpha \in S^1(I, \mathbb{R}^n)$, then we have the Lipschitz bound

$$\|\alpha - u\|_{S^0(I, \mathbb{R}^n)} \leq \|\alpha_0 - u_0\|_{L^2(\mathbb{R}^n)} : \quad (1.21)$$

For the convenience of the reader we give a proof of this standard result in Section 2; it does not require the Hölder continuity hypothesis (1.4). Remarkably, there is no restriction on the $H^{\frac{1}{2}}(\mathbb{R}^n)$ -norm of the initial data, though we do require that this norm is finite. Instead, we have the smallness condition (1.17). Note from the Strichartz estimate (1.11) that

$$\|e^{i(t-t_0)\Delta} u_0\|_{W_{-1}(\mathbb{R}^n)} \leq \|u_0\|_{H^{\frac{1}{2}}(\mathbb{R}^n)} < 1 :$$

This already gives local existence for all large energy data since, from the above Strichartz estimate and monotone convergence, we can establish the hypothesis (1.17) for intervals I that are sufficiently small (but note that the size of I will depend on the profile of the initial data u_0 and not just on its $H^{\frac{1}{2}}(\mathbb{R}^n)$ -norm). Another immediate corollary of the above theorem and the Strichartz estimate is

Corollary 1.2 (Global well-posedness for small $H^{\frac{1}{2}}_x$ data, [3], [4]). Let $u_0 \in H^{\frac{1}{2}}_x$ be such that

$$\|u_0\|_{H^{\frac{1}{2}}(\mathbb{R}^n)} \leq \delta_0 \quad (1.22)$$

for some small absolute constant $\delta_0 > 0$ depending only on the dimension n . Then, there exists a unique global $S^1(\mathbb{R}, \mathbb{R}^n)$ solution u to (1.1). Moreover,

$$\begin{aligned} \|u\|_{W_{-1}(\mathbb{R}, \mathbb{R}^n)} &\leq \|u\|_{S^1(\mathbb{R}, \mathbb{R}^n)} \leq \|u_0\|_{H^{\frac{1}{2}}(\mathbb{R}^n)} \\ \|u\|_{S^0(\mathbb{R}, \mathbb{R}^n)} &\leq \|u_0\|_{L^2(\mathbb{R}^n)} : \end{aligned}$$

By combining the above standard theory with the exotic Strichartz estimate and fractional chain rule, we obtain our first main result.

Theorem 1.3 (Short-time perturbations). Let I be a compact time interval and let α be an approximate solution to (1.1) on $I \times \mathbb{R}^n$ in the sense that

$$(i\partial_t + \Delta)\alpha = f(\alpha) + e$$

for some function e . Suppose that we also have the energy bound

$$\|\alpha\|_{L^{\frac{1}{2}}_t H^{\frac{1}{2}}_x(I, \mathbb{R}^n)} \leq E \quad (1.23)$$

for some constant $E > 0$. Let $t_0 \in I$ and let $u(t_0) \in H^1(\mathbb{R}^n)$ be close to $\alpha(t_0)$ in the sense that

$$\|u(t_0) - \alpha(t_0)\|_{H^{-1}(\mathbb{R}^n)} \leq E^0 \quad (1.24)$$

for some $E^0 > 0$. Moreover, assume the smallness conditions

$$\|u\|_{W^{1,2}(I \times \mathbb{R}^n)} \leq \epsilon_0 \quad (1.25)$$

$$\|e^{i(t-t_0)}(u(t_0) - \alpha(t_0))\|_{W^{1,2}(I \times \mathbb{R}^n)} \leq \epsilon \quad (1.26)$$

$$\|e^{i(t-t_0)}(u(t_0) - \alpha(t_0))\|_{N^{1,2}(I \times \mathbb{R}^n)} \leq \epsilon \quad (1.27)$$

for some $0 < \epsilon \leq \epsilon_0$, where $\epsilon_0 = \epsilon_0(E; E^0) > 0$ is a small constant. Then there exists a solution $u \in S^1(I \times \mathbb{R}^n)$ to (1.1) on $I \times \mathbb{R}^n$ with the specified initial data $u(t_0)$ at time $t = t_0$ satisfying

$$\|u - \alpha\|_{W^{1,2}(I \times \mathbb{R}^n)} \leq \epsilon + \epsilon \frac{7}{(n-2)^2} \quad (1.28)$$

$$\|u - \alpha\|_{S^1(I \times \mathbb{R}^n)} \leq E^0 + \epsilon + \epsilon \frac{7}{(n-2)^2} \quad (1.29)$$

$$\|u - \alpha\|_{S^1(I \times \mathbb{R}^n)} \leq E + E^0 \quad (1.30)$$

$$\|(i\partial_t + \Delta)(u - \alpha) + e\|_{N^{1,2}(I \times \mathbb{R}^n)} \leq \epsilon + \epsilon \frac{7}{(n-2)^2} \quad (1.31)$$

We prove this theorem in Section 3. This theorem allows the energy of α and u to be large as long as the error e is small in a suitable norm, the free evolution of $u - \alpha$ is small in another norm, and α itself is small in a third norm. The $n = 3, 4$ cases of this theorem are in [7], [19] respectively, and the argument there extends easily to dimensions $n = 5, 6$. However, the cases $n > 6$ require a more delicate argument. It is probably possible to replace the Besov-norm type expression on the left-hand side of (1.26) by the Sobolev-norm expression $\|e^{i(t-t_0)}(u(t_0) - \alpha(t_0))\|_{W^{1,2}(I \times \mathbb{R}^n)}$, but this would presumably require the Coifman-Rochberg theory of paraproducts and we will not pursue it here to simplify the exposition. The Hölder exponent $\frac{7}{(n-2)^2}$ can be improved somewhat (perhaps to $\frac{4}{n-2}$) but we will not seek the optimal exponent here (for applications, all that is important is that this exponent is positive). However, it seems doubtful that one can obtain Lipschitz type bounds when the dimension n is sufficiently large. Indeed, if one had Lipschitz continuous dependence on the initial data then, by taking variations of (1.1) in u , one must (formally at least) have that the linearized equation

$$\begin{aligned} (i\partial_t + \Delta)v &= f_z(u(s))v(s) + \overline{f_z(u(s))v(s)} \\ v(t_0; x) &= v_0(x) \in H^1(\mathbb{R}^n); \end{aligned}$$

which is a system of linear Schrödinger equations in v and \bar{v} with time-dependent, non-selfadjoint potential, keeps the H_x^1 norm of $v(t)$ bounded in time. If n is large enough, it is unlikely that $f_z(u)$ (which behaves like $|u|^{4-(n-2)}$) remains in H_x^1 or even in $H_x^{1/2}$; thus, it seems that solutions to this equation may leave H_x^1 even when local smoothing effects (which typically gain half a derivative of regularity at most) are exploited⁷. It seems however to be somewhat difficult to convert these

⁷ However, it is still possible to iterate the above linearized equation in lower regularity spaces of the same scaling as H_x^{-1} and, in particular, using the X and Y spaces introduced in Section 3,

heuristic arguments into an explicit and rigorous demonstration of non-Lipschitz continuity and we will not pursue this issue here.

By an easy iteration argument (as in [7], [19]) based on partitioning the time interval, we can relax hypothesis (1.25) by allowing α to be large (but still bounded in some norm):

Theorem 1.4 (Long-time perturbations). Let I be a compact time interval and let α be an approximate solution to (1.1) on $I \times \mathbb{R}^n$ in the sense that

$$(i\partial_t + \Delta) \alpha = f(\alpha) + e$$

for some function e . Assume that

$$\|\alpha\|_{L_{t,x}^{\frac{2(n+2)}{n-2}}(I \times \mathbb{R}^n)} \leq M \quad (1.32)$$

$$\|\alpha\|_{L_t^1 H_x^{-1}(I \times \mathbb{R}^n)} \leq E \quad (1.33)$$

for some constants $M, E > 0$. Let $t_0 \in I$ and let $u(t_0)$ close to $\alpha(t_0)$ in the sense that

$$\|u(t_0) - \alpha(t_0)\|_{H_x^{-1}} \leq E^0 \quad (1.34)$$

for some $E^0 > 0$. Assume also the smallness conditions

$$\sum_N \|\mathcal{P}_N e^{i(t-t_0)\Delta} u(t_0) - \alpha(t_0)\|_{W^{-1}(I \times \mathbb{R}^n)}^2 \leq \epsilon^2 \quad (1.35)$$

$$\|e\|_{N^{-1}(I \times \mathbb{R}^n)} \leq \epsilon \quad (1.36)$$

for some $0 < \epsilon \leq \epsilon_1$, where $\epsilon_1 = \epsilon_1(E; E^0; M)$ is a small constant. Then there exists a solution u to (1.1) on $I \times \mathbb{R}^n$ with the specified initial data $u(t_0)$ at time $t = t_0$ satisfying

$$\|u - \alpha\|_{W^{-1}(I \times \mathbb{R}^n)} \leq C(E; E^0; M) \epsilon + \epsilon^{\frac{7}{(n-2)^2}} \quad (1.37)$$

$$\|u - \alpha\|_{S^{-1}(I \times \mathbb{R}^n)} \leq C(E; E^0; M) E^0 + \epsilon + \epsilon^{\frac{7}{(n-2)^2}} \quad (1.38)$$

$$\|u\|_{S^{-1}(I \times \mathbb{R}^n)} \leq C(E; E^0; M): \quad (1.39)$$

Here, $C(E; E^0; M) > 0$ is a non-decreasing function of $E; E^0; M$, and the dimension n .

We prove this theorem in Section 4. As a corollary of this theorem we also obtain a satisfactory scattering theory for these equations provided that one assumes a global $L_{t,x}^{2(n+2)/(n-2)}$ bound on solutions; see Corollary 4.1. This global bound is not difficult to obtain for small energy data (it follows directly from Theorem 1.1), but for large energy data the situation is substantially more delicate and requires further structural information on the nonlinearity. In [21] the second author will establish this bound for the defocusing equation; in the focusing case, Glassey's virial identity can be used to establish blowup for certain large data (even if the data is smooth, spherically symmetric, and compactly supported); see [12].

1.5. Notation. We will often use the notation $X \lesssim Y$ whenever there exists some constant C so that $X \leq CY$. Similarly, we will write $X \gtrsim Y$ if $X \geq Y \lesssim X$. We say $X \approx Y$ if $X \lesssim Y$ and $Y \lesssim X$ for some small constant c . The derivative operator ∂_x refers to the spatial variable only.

We define the Fourier transform on \mathbb{R}^n to be

$$\hat{f}(\xi) = \int_{\mathbb{R}^n} e^{-2\pi i x \cdot \xi} f(x) dx;$$

We shall use of the fractional differentiation operators ∂_x^s defined by

$$\partial_x^s f(\xi) = |\xi|^s \hat{f}(\xi);$$

These define the homogeneous Sobolev norms

$$\|f\|_{\dot{H}_x^s} = \|\partial_x^s f\|_{L_x^2};$$

Let $e^{it\Delta}$ be the free Schrodinger propagator. In physical space this is given by the formula

$$e^{it\Delta} f(x) = \frac{1}{(4\pi it)^{n/2}} \int_{\mathbb{R}^n} e^{i(x-y)^2/(4t)} f(y) dy;$$

while in frequency space one can write this as

$$e^{it\Delta} f(\xi) = e^{-2\pi i t |\xi|^2} \hat{f}(\xi); \quad (1.40)$$

In particular, the propagator preserves the above Sobolev norms and obeys the dispersive inequality

$$\|e^{it\Delta} f(t)\|_{L_x^1} \leq |t|^{-n/2} \|f\|_{L_x^1} \quad (1.41)$$

for all times $t \neq 0$. We also recall Duhamel's formula

$$u(t) = e^{i(t-t_0)\Delta} u(t_0) - i \int_{t_0}^t e^{i(t-s)\Delta} (u_t + u) ds; \quad (1.42)$$

We will also need some Littlewood-Paley theory. Specifically, let $\phi(\xi)$ be a smooth bump supported in the ball $|\xi| \leq 2$ and equaling one on the ball $|\xi| \leq 1$. For each dyadic number $N \geq 2$ we define the Littlewood-Paley operators

$$\begin{aligned} P_N f(\xi) &= \phi(\xi/N) \hat{f}(\xi); \\ P_{>N} f(\xi) &= (1 - \phi(\xi/N)) \hat{f}(\xi); \\ P_N^{\perp} f(\xi) &= [\phi(\xi/N) - \phi(2\xi/N)] \hat{f}(\xi); \end{aligned}$$

Similarly, we can define $P_{<N}$, $P_{\leq N}$, and $P_M \leq P_N \leq P_M$, whenever M and N are dyadic numbers. Sometimes we may write f_N for $P_N f$ and similarly for the other operators.

The Littlewood-Paley operators commute with derivative operators, the free propagator, and complex conjugation. They are selfadjoint and bounded on every L^p and H_x^s space for $1 \leq p \leq \infty$ and $s \geq 0$. They also obey the following Sobolev and Bernstein estimates that we will use:

$$\begin{aligned} \|P_N f\|_{L_x^p} &\leq N^{-s} \| \mathcal{R}^s P_N f \|_{L_x^p}; \\ \| \mathcal{R}^s P_N f \|_{L_x^p} &\leq N^s \|P_N f\|_{L_x^p}; \\ \| \mathcal{R}^s P_N f \|_{L_x^p} &\leq N^s \|P_N f\|_{L_x^p}; \\ \|P_N f\|_{L_x^q} &\leq N^{\frac{n}{p}-\frac{n}{q}} \|P_N f\|_{L_x^p}; \\ \|P_N f\|_{L_x^q} &\leq N^{\frac{n}{p}-\frac{n}{q}} \|P_N f\|_{L_x^p}; \end{aligned}$$

whenever $s \geq 0$ and $1 \leq p < q \leq \infty$.

Let us temporarily fix a spacetime slab $I \times \mathbb{R}^n$. We have already introduced two important norms on this slab, $W^{1,2}(I \times \mathbb{R}^n)$ and $N^1(I \times \mathbb{R}^n)$. Now we introduce a few more. We say that a pair of exponents (q, r) is Schrodinger-admissible if $\frac{2}{q} + \frac{n}{r} = \frac{n}{2}$ and $2 \leq q, r \leq \infty$. We define the $S^0(I \times \mathbb{R}^n)$ Strichartz norm by

$$\|u\|_{S^0(I \times \mathbb{R}^n)} = \|u\|_{S^0} := \sup_N \|P_N u\|_{L_x^q L_t^r}^{1/2} \quad (1.43)$$

where the supremum is taken over all admissible pairs (q, r) . This Besov-type formulation of the Strichartz norm will be convenient for us later when we need to prove nonlinear estimates. We also define the $S^1(I \times \mathbb{R}^n)$ Strichartz norm to be

$$\|u\|_{S^1(I \times \mathbb{R}^n)} := \| \mathcal{R} u \|_{S^0(I \times \mathbb{R}^n)};$$

We define the associated spaces $S^0(I \times \mathbb{R}^n)$, $S^1(I \times \mathbb{R}^n)$ as the closure of the test functions under these norms.

We observe the inequality

$$\|u\|_{S^0} \leq \|u\|_{S^1} \quad (1.44)$$

for all $2 \leq q, r \leq \infty$ and arbitrary functions u , which one proves by interpolating between the trivial cases $(q, r) = (2, 2); (2, 1); (1, 2); (1, 1)$. In particular, (1.44) holds for all admissible exponents (q, r) . Combining this with the Littlewood-Paley inequality, we find

$$\begin{aligned} \|u\|_{S^0} &\leq \|u\|_{S^1} \\ &\leq \| \mathcal{R} u \|_{S^0} \\ &\leq \| \mathcal{R} u \|_{L_x^q L_t^r}^{1/2} \\ &\leq \|u\|_{S^0(I \times \mathbb{R}^n)}; \end{aligned}$$

which in particular implies

$$\|u\|_{L_x^q L_t^r(I \times \mathbb{R}^n)} \leq \|u\|_{S^1(I \times \mathbb{R}^n)};$$

From this and Sobolev embedding, the S^1 -norm controls the following spacetime norms:

Lemma 1.6. For any S^1 function u on $I \times \mathbb{R}^n$, we have

$$\begin{aligned} & \|u\|_{L^2_t L^2_x} + \|u\|_{W^-} + \|u\|_{L^{\frac{2(n+2)}{n}}_t L^{\frac{2(n+2)}{n}}_x} + \|u\|_{L^{\frac{2n}{n-2}}_t L^{\frac{2(n+2)}{n-2}}_x} \\ & + \|u\|_{L^{\frac{2n}{n-2}}_t L^{\frac{2(n+2)}{n-2}}_x} + \|u\|_{L^{\frac{2(n+2)}{n-2}}_t L^{\frac{2(n+2)}{n-2}}_x} \leq \|u\|_{S^1} \end{aligned}$$

where all spacetime norms are on $I \times \mathbb{R}^n$.

By Lemma 1.6 and the definition of the Strichartz spaces S^0 and S^1 , we see that $S^0 \subset C^0_t L^2_x$ and similarly, $S^1 \subset C^0_t H^1_x$, by the usual limiting arguments. In particular $S^0 \setminus S^1 \subset C^0_t H^1_x$.

Next, let us recall the Strichartz estimates:

Lemma 1.7. Let I be a compact time interval, $k = 0, 1$, and let $u : I \times \mathbb{R}^n \rightarrow \mathbb{C}$ be an S^k solution to the forced Schrödinger equation

$$iu_t + \Delta u = \sum_{m=1}^M F_m$$

for some functions F_1, \dots, F_M . Then on $I \times \mathbb{R}^n$ we have

$$\|u\|_{S^k} \leq \|u(t_0)\|_{H^{-k}(\mathbb{R}^n)} + \sum_{m=1}^M \|F_m\|_{L^{q_m^0}_t L^{r_m^0}_x}$$

for any time $t_0 \in I$ and any admissible exponents $(q_1; r_1), \dots, (q_M; r_M)$. As usual, p^0 denotes the dual exponent to p , that is, $1 = p + 1/p^0 = 1$.

Note that from this lemma and Lemma 1.6, we have

$$\|u\|_{W^-} \leq \|u\|_{S^1} \leq \|u(t_0)\|_{H^{-1}_x} + \|iu_t + \Delta u\|_{N^{-1}} \quad (1.45)$$

and, in particular, replacing u with $e^{i(t-t_0)\Delta} u(t_0)$,

$$\|u\|_{W^-} \leq \|e^{i(t-t_0)\Delta} u(t_0)\|_{W^-} \leq \|iu_t + \Delta u\|_{N^{-1}} \quad (1.46)$$

In a similar spirit we have

$$\|u\|_{L^{\frac{2(n+2)}{n}}_t L^{\frac{2(n+2)}{n}}_x} \leq \|u\|_{S^0(I \times \mathbb{R}^n)} \leq \|u(t_0)\|_{L^2_x} + \|iu_t + \Delta u\|_{L^{\frac{2(n+2)}{n+4}}_t L^{\frac{2(n+2)}{n+4}}_x} \quad (1.47)$$

Proof. To prove Lemma 1.7, let us first make the following reductions. We note that it suffices to take $M = 1$, since the claim for general M follows from Duhamel's formula and the triangle inequality. We can also take k to be 0, since the estimate for $k = 1$ follows by applying r to both sides of the equation and noting that r commutes with $iu_t + \Delta$. As the Littlewood-Paley operators also commute with $iu_t + \Delta$, we have

$$(iu_t + \Delta)P_N u = P_N F_1$$

for all dyadic N . Applying the standard Strichartz estimates (see [16]), we get

$$\|P_N u\|_{q; r} \leq \|P_N u(t_0)\|_{L^2_x} + \|P_N F_1\|_{q^0_1; r^0_1} \quad (1.48)$$

for all admissible exponents $(q; r)$ and $(q_1; r_1)$. Squaring (1.48), summing in N , using the definition of the S^0 -norm and the Littlewood-Paley inequality together with the dual of (1.44), we get the claim.

$$ku^{(1)}k_{S^0} = ku_0k_{L^2(\mathbb{R}^n)}$$

thanks to Lemma 1.7. Choosing ϵ sufficiently small, we conclude that the sequence $\{u^{(m)}\}_{m=1}^\infty$ is Cauchy in $S^0(I; \mathbb{R}^n)$ and hence, there exists $u \in S^0(I; \mathbb{R}^n)$ such that $u^{(m)}$ converges to u in $S^0(I; \mathbb{R}^n)$ (and thus also in $L_{t,x}^{2(n+2)/n}(I; \mathbb{R}^n)$) as $m \rightarrow \infty$ and furthermore, we have (1.20). The above argument also shows that $f(u^{(m)})$ converges to $f(u)$ in $L_{t,x}^{2(n+2)/(n+4)}(I; \mathbb{R}^n)$. Applying (1.47) again we conclude that u solves (1.8). As the $u^{(m)}$ converge strongly to u in $S^0(I; \mathbb{R}^n)$ and remain bounded in $W(I; \mathbb{R}^n)$ and $S^1(I; \mathbb{R}^n)$ thanks to (2.2) and (2.3), we see that the $u^{(m)}$ converge weakly to u in $W(I; \mathbb{R}^n)$ and $S^1(I; \mathbb{R}^n)$ and we obtain the bounds (1.18), (1.19). As u lies in both $S^1(I; \mathbb{R}^n)$ and $S^0(I; \mathbb{R}^n)$, it is in $C_t^0 H_x^1(I; \mathbb{R}^n)$ and is thus a strong solution to (1.1).

2.2. Uniqueness. To prove uniqueness, we will in fact prove the following stronger (and standard) result:

Proposition 2.3 (Unconditional uniqueness in $H^1(\mathbb{R}^n)$, [6]). Let I be a time interval containing t_0 , and let $u_1, u_2 \in C_t^0 H_x^1(I; \mathbb{R}^n)$ be two strong solutions to (1.1) in the sense of (1.8). Then $u_1 = u_2$ almost everywhere.

Proof. By a standard continuity argument we may shrink I so that one can construct the solution given by the preceding iteration argument. Without loss of generality, we may take u_2 to be this solution; thus, $u_2 \in S^1(I; \mathbb{R}^n)$.

Write $v = u_1 - u_2 \in C_t^0 H_x^1(I; \mathbb{R}^n)$, and let J be the set of times t for which $v(t) = 0$ almost everywhere. Then J is closed and contains t_0 , so it suffices to show that J is open in I . Let $t_1 \in J$ and suppose also that $[t_1, t_1 + \epsilon) \subset J$ for some small $\epsilon > 0$. Henceforth, we will work entirely on the slab $[t_1, t_1 + \epsilon) \times \mathbb{R}^n$. By shrinking ϵ as much as necessary, we may use the continuity and vanishing of v at t_1 to assume

$$\|v\|_{L_t^1 H_x^1} \leq \epsilon$$

where ϵ is a small absolute constant to be chosen later; in particular, from Sobolev embedding we have

$$\|v\|_{L_t^1 H_x^1} \leq \epsilon \implies \|v\|_{L_t^1 L_x^\infty} \leq \epsilon$$

Similarly, from the hypothesis $u_2 \in S^1(I; \mathbb{R}^n)$ and Lemma 1.6 and (1.19) we may take

$$\|u_2\|_{L_t^{2(n+2)/n} H_x^1} \leq \epsilon$$

From (1.8) and the hypothesis $u_1, u_2 \in C_t^0 H_x^1$, we easily see that

$$u_j(t) = e^{i(t-t_1)} u_j(t_1) - i \int_{t_1}^t e^{i(t-s)} f(u_j(s)) ds$$

for $j = 1, 2$. Subtracting these and recalling that $v(t_1) = 0$, we conclude that

$$v(t) = -i \int_{t_1}^t e^{i(t-s)} (f(u_1(s)) - f(u_2(s))) ds$$

From (1.7) we have

$$f(u_1(s)) - f(u_2(s)) = O(|\nabla v(s)|^{n+2}) + O(|u_2(s)|^{4-n} |\nabla v(s)|^2)$$

Applying Lemma 1.6 and 1.7 followed by Hölder's inequality, we conclude that

$$\begin{aligned} \|v\|_{L_t^1 L_x^{\frac{2n}{n-2}}} &\leq \|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{(n-2)} \|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{4-(n-2)} \\ &\leq \|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{(n-2)} (\|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}} + \|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}})^{4-(n-2)} \\ &\leq \|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{4-(n-2)} \|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}} : \end{aligned}$$

As v was already finite in $L_t^1 L_x^{\frac{2n}{n-2}}$ (and hence in $L_t^2 L_x^{\frac{2n}{n-2}}$), we conclude (by taking δ small enough) that v vanishes almost everywhere on $[t_1; t_1 + \delta)$. This shows that I is open in the forward direction. A similar argument establishes the openness in the backwards direction, thus concluding the proof.

Remark 2.4. By combining this uniqueness statement with the existence theorem, one can show that for the Cauchy problem (1.1) there is a unique maximal interval I containing t_0 , such that the slab $I \times \mathbb{R}^n$ supports a strong solution. Furthermore, I is open and the solution has finite $W^{-1}(J \times \mathbb{R}^n)$ -norm for any compact $J \subset I$. It is also true that if I has a finite endpoint, then the W -norm will blow up near that endpoint (see Lemma 2.6 below).

2.5. Continuous dependence in rough norms. We turn now to the Lipschitz bound (1.21). Again we write $v = u - \alpha$. By (1.7), (1.47), and Hölder's inequality, we have

$$\begin{aligned} \|v\|_{S^0} &\leq \|u_0\|_{L_x^2} + \|f(\alpha)\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}} \\ &\leq \|u_0\|_{L_x^2} + \|u\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{\frac{4}{n-2}} + \|u\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{\frac{4}{n-2}} \|v\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{\frac{4}{n-2}} \\ &\leq \|u_0\|_{L_x^2} + \|u\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{\frac{4}{n-2}} + \|u\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{\frac{4}{n-2}} \|v\|_{S^0} : \end{aligned}$$

Applying (1.12) and (1.18), we conclude

$$\|v\|_{S^0} \leq \|u_0\|_{L_x^2} + \|u\|_{L_t^{\frac{4}{n-2}} L_x^{\frac{2n}{n-2}}}^{4-(n-2)} \|v\|_{S^0} :$$

By taking δ small enough, we obtain (1.21) as desired. This concludes the proof of Theorem 1.1.

We end this section with the following companion to Theorem 1.1.

Lemma 2.6 (Standard blow up criterion, [3], [4]). Let $u_0 \in H_x^1$ and let u be a strong S^1 solution to (1.1) on the slab $[t_0; T_0] \times \mathbb{R}^n$ such that

$$\|u\|_{L_{t,x}^{\frac{2(n+2)}{n-2}}([t_0; T_0] \times \mathbb{R}^n)} < 1 : \quad (2.4)$$

Then there exists $\delta = \delta(u_0) > 0$ such that the solution u extends to a strong S^1 solution to (1.1) on the slab $[t_0; T_0 + \delta] \times \mathbb{R}^n$.

In the contrapositive, this lemma asserts that if a solution cannot be continued strongly beyond a time T , then the $L_{t,x}^{\frac{2(n+2)}{n-2}}$ -norm must blow up at that time. One can also establish that other scale-invariant norms (except for those norms involving L_t^1) also blow up at this time, but we will not do so here.

Proof. Let us denote the norm in (2.4) by M . The first step is to establish an S^1 bound on u . In order to do so, we subdivide $[t_0; T_0]$ into $N = 1 + \frac{M}{\epsilon} \frac{2(n+2)}{n-2}$ subintervals J_k such that

$$k u k_{L_{t,x}^{\frac{2(n+2)}{n-2}}(J_k \times \mathbb{R}^n)} \leq \epsilon \quad (2.5)$$

where ϵ is a small positive constant. By (1.14) and (1.45), we have

$$\begin{aligned} k u k_{S^1(J_k \times \mathbb{R}^n)} &\leq k u(t_k) k_{H_x^{-1}(\mathbb{R}^n)} + k f(u) k_{N^1(J_k \times \mathbb{R}^n)} \\ &\leq k u(t_k) k_{H_x^{-1}(\mathbb{R}^n)} + k u k_{L_{t,x}^{\frac{2(n+2)}{n-2}}(J_k \times \mathbb{R}^n)}^{\frac{4}{n-2}} k u k_{S^1(J_k \times \mathbb{R}^n)} \\ &\leq k u(t_k) k_{H_x^{-1}(\mathbb{R}^n)} + \frac{4}{n-2} k u k_{S^1(J_k \times \mathbb{R}^n)} \end{aligned}$$

for each interval J_k and any $t_k \in J_k$. If ϵ is sufficiently small, we conclude

$$k u k_{S^1(J_k \times \mathbb{R}^n)} \leq k u(t_k) k_{H_x^{-1}};$$

Recall that the S^1 -norm controls the $L_t^1 H_x^{-1}$ -norm. Thus, we may glue these bounds together inductively to obtain a bound of the form

$$k u k_{S^1([t_0; T_0] \times \mathbb{R}^n)} \leq C(k u_0 k_{H_x^{-1}}; M, \epsilon);$$

which by Lemma 1.6 implies

$$k u k_{W_-([t_0; T_0] \times \mathbb{R}^n)} \leq C(k u_0 k_{H_x^{-1}}; M, \epsilon); \quad (2.6)$$

Now let $t_0 < T_0$. By (1.14) and (1.46), we have

$$\begin{aligned} k u e^{i(t-t_0)} u_0 k_{W_-([t_0; T_0] \times \mathbb{R}^n)} &\leq k f(u) k_{N^1([t_0; T_0] \times \mathbb{R}^n)} \\ &\leq k u k_{W_-([t_0; T_0] \times \mathbb{R}^n)}^{\frac{n+2}{n-2}} \end{aligned}$$

and thus, by the triangle inequality,

$$k e^{i(t-t_0)} u_0 k_{W_-([t_0; T_0] \times \mathbb{R}^n)} \leq k u k_{W_-([t_0; T_0] \times \mathbb{R}^n)}^{\frac{n+2}{n-2}} + k u k_{W_-([t_0; T_0] \times \mathbb{R}^n)};$$

Let ϵ_0 be as in Theorem 1.1. By (2.6), taking ϵ sufficiently close to T_0 , we obtain

$$k e^{i(t-t_0)} u_0 k_{W_-([t_0; T_0] \times \mathbb{R}^n)} \leq \epsilon_0$$

(say), while from Strichartz inequality we have

$$k e^{i(t-t_0)} u_0 k_{W_-([t_0; T_0] \times \mathbb{R}^n)} < 1;$$

By the monotone convergence theorem, we deduce that there exists $\epsilon = \epsilon(u_0) > 0$ such that

$$k e^{i(t-t_0)} u_0 k_{W_-([t_0; T_0] \times \mathbb{R}^n)} \leq \epsilon_0;$$

By Theorem 1.1, there exists a unique solution to (1.1) with initial data $v(t_0) = u_0$ which belongs to $S^1([t_0; T_0] \times \mathbb{R}^n)$. By Proposition 2.3, we see that $u = v$ on $[t_0; T_0] \times \mathbb{R}^n$ and thus v is an extension of u to $[t_0; T_0] \times \mathbb{R}^n$.

3. Short-time perturbations

The goal of this section is to prove Theorem 1.3. By the well-posedness theory that we have developed in the previous section, it suffices to prove (1.28)–(1.31) as a priori estimates, that is, we assume that the solution u already exists and belongs to $S^1(I; \mathbb{R}^n)$.

Remark 3.1. By (1.45) and Plancherel's theorem we have

$$\begin{aligned} \sum_N \|k P_N e^{i(t-t_0)} u(t_0) - \alpha(t_0)\|_{W_-}^2 & \stackrel{1=2}{=} \\ & \leq \sum_N \|k P_N r(u(t_0) - \alpha(t_0))\|_{L^2}^2 \stackrel{1=2}{=} \\ & \leq \|k r(u(t_0) - \alpha(t_0))\|_{L^2}^2 \\ & \leq E^0 \end{aligned}$$

on the slab $I \subset \mathbb{R}^n$, so the hypothesis (1.26) is redundant if $E^0 = 0$ (").

By time symmetry, we may assume that $t_0 = \inf I$. We will first give a simple proof of Theorem 1.3 in dimensions $3 \leq n \leq 6$ (following the arguments in [7], [9] covering the cases $n = 3; 4$ respectively). Let $v = u - \alpha$. Then v satisfies the following initial value problem:

$$\begin{aligned} (i v_t + \Delta v &= f(\alpha + v) - f(\alpha) = e \\ v(t_0; x) &= u(t_0; x) - \alpha(t_0; x): \end{aligned} \quad (3.1)$$

For $T \geq 1$ define

$$S(T) = \|k(i\partial_t + \Delta)v + e\|_{N^{-1}([t_0; T]; \mathbb{R}^n)}:$$

We will now work entirely on the slab $[t_0; T] \subset \mathbb{R}^n$. By (1.26), (1.27), and (1.45), we get

$$\begin{aligned} \|kv\|_{W_-} & \leq \|k e^{i(t-t_0)} v(t_0)\|_{W_-} + \|k(i\partial_t + \Delta)v + e\|_{N^{-1}} + \|k e\|_{N^{-1}} \\ & \leq S(T) + \epsilon; \end{aligned} \quad (3.2)$$

where we used (1.44) to estimate

$$\begin{aligned} \|k e^{i(t-t_0)} v(t_0)\|_{W_-} & \leq \sum_N \|k P_N e^{i(t-t_0)} u(t_0) - \alpha(t_0)\|_{W_-}^2 \stackrel{1=2}{=} \\ & \leq \epsilon: \end{aligned} \quad (3.3)$$

By (1.12) and (3.2) we have

$$\|kv\|_{\dot{W}^{\frac{2(n+2)}{n-2}, \frac{2(n+2)}{n-2}}} \leq S(T) + \epsilon: \quad (3.4)$$

On the other hand, from (1.5) we have

$$\begin{aligned} r(i\partial_t + \Delta)v + e &= r f(\alpha + v) - f(\alpha) \\ &= f_z(\alpha + v)r(\alpha + v) + f_z(\alpha + v)\overline{r(\alpha + v)} \\ &= f_z(\alpha)r\alpha + f_z(\alpha)r\bar{\alpha}; \end{aligned}$$

so, by our hypotheses on f , specifically (1.3) and (1.4), we get

$$\begin{aligned} \|\partial_t v + e\|_{L_t^2 L_x^{\frac{n}{n-2}}} &\leq \|f_z(\alpha + v)\|_{L_t^2 L_x^{\frac{n}{n-2}}} + \|f_z(\alpha + v)\|_{L_t^2 L_x^{\frac{n}{n-2}}} \\ &\quad + \|f_z(\alpha + v)\|_{L_t^2 L_x^{\frac{n}{n-2}}} + \|f_z(\alpha + v)\|_{L_t^2 L_x^{\frac{n}{n-2}}} \\ &\leq \|f_z(\alpha + v)\|_{L_t^2 L_x^{\frac{n}{n-2}}} + \|f_z(\alpha + v)\|_{L_t^2 L_x^{\frac{n}{n-2}}} : \end{aligned} \quad (3.5)$$

Hence by (1.13), (1.25), (3.2), and (3.4), we estimate

$$\begin{aligned} S(T) &\leq \|k\|_{W_-} \|k\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}} + \|k\|_{W_-} \|k\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}} + \|k\|_{W_-} \|k\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}} \\ &\leq \|S(T) + \epsilon\|_{L_t^2 L_x^{\frac{n}{n-2}}} + \|S(T) + \epsilon\|_{L_t^2 L_x^{\frac{n}{n-2}}} : \end{aligned}$$

If $\frac{4}{n-2} \geq 1$, i.e., $3 \leq n \leq 6$, a standard continuity argument shows that if we take $\epsilon_0 = \epsilon_0(E; E^0)$ sufficiently small we obtain

$$S(T) \leq \epsilon \quad \text{for all } T \geq T_0; \quad (3.6)$$

which implies (1.31). Using (3.2) and (3.6), one easily derives (1.28). To obtain (1.29), we use (1.24), (1.27), (1.45), and (3.6):

$$\begin{aligned} \|u\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}(\mathbb{R}^n)} &\leq \|u(t_0)\|_{H_x^{-1}} + \|\partial_t v + e\|_{L_t^2 L_x^{\frac{n}{n-2}}(\mathbb{R}^n)} + \|k\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}(\mathbb{R}^n)} \\ &\leq E^0 + S(T) + \epsilon \\ &\leq E^0 + \epsilon : \end{aligned}$$

By the triangle inequality, (1.12), (1.25), and (3.2), we have

$$\|k\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}(\mathbb{R}^n)} \leq \|k\|_{W_-}(\mathbb{R}^n) \leq \epsilon + \epsilon_0 :$$

Another application of (1.14) and (1.45), as well as (1.23), (1.24) yields

$$\begin{aligned} \|k\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}(\mathbb{R}^n)} &\leq \|u(t_0)\|_{H_x^{-1}} + \|f(u)\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}(\mathbb{R}^n)} \\ &\leq E + E^0 + \|k\|_{W_-}^{(n+2)/(n-2)}(\mathbb{R}^n) \\ &\leq E + E^0 + (\epsilon + \epsilon_0)^{\frac{n+2}{n-2}} ; \end{aligned}$$

which proves (1.30), provided ϵ_0 is sufficiently small depending on E and E^0 .

This concludes the proof of Theorem 1.3 in dimensions $3 \leq n \leq 6$. In order to prove the theorem in higher dimensions, we are forced to avoid taking a full derivative since this is what turns the nonlinearity from Lipschitz into just Hölder continuous of order $\frac{4}{n-2}$. Instead, we must take fewer than $\frac{4}{n-2}$ derivatives. As we still need to iterate in spaces that scale like S^{-1} , we either have to increase the space or the time integrability of the usual Strichartz norms. The option of increasing the spatial integrability is suggested by the exotic Strichartz estimates of Foschi, [8], but it turns out to be somewhat easier to increase the time integrability instead; this idea was used in the closely related context of the energy-critical non-linear Klein-Gordon equation by Nakanishi [18]. We will choose the norm $X = X(\mathbb{R}^n)$ defined by

$$\|k\|_X := \left(\int_{\mathbb{R}^n} |k|^{8/(n+2)} dx \right)^{\frac{1}{2}} \|k\|_{L_t^{\frac{n}{n-2}} L_x^{\frac{2(n+2)}{n-2}}(\mathbb{R}^n)}^{1/2} :$$

We observe that this norm is controlled by the S^1 -norm. Indeed, by Sobolev embedding, the boundedness of the Riesz transforms on every L^p_x , $1 < p < \infty$, the dual of (1.44), and the definition of the S^0 -norm, we get

$$\begin{aligned} \|u\|_{X^0} &= \left\| \sum_N N^{-(n+2)} P_N u \right\|_{L^2_{n+2, \frac{2(n+2)}{n}}}^{1=2} \\ &\leq \left\| \sum_N \langle \nabla \rangle^{-(n+2)} P_N u \right\|_{L^2_{n+2, \frac{2(n+2)}{n}}}^{1=2} \\ &\leq \left\| \sum_N \langle \nabla \rangle^{-(n+2)} P_N u \right\|_{L^2_{n+2, \frac{2n}{n^2+2n+4}}}^{1=2} \\ &\leq \|u\|_{S^1(I \times \mathbb{R}^n)} \end{aligned}$$

since $(n+2, \frac{2n}{n^2+2n+4})$ is a Schrodinger-admissible pair.

Now we need an inhomogeneous estimate. We use the norm

$$\|F\|_{Y^0} := \left\| \sum_N N^{-(n+2)} P_N F \right\|_{L^2_{\frac{n+2}{3}, \frac{2(n+2)}{n+4}}}^{1=2} :$$

Just as the X -norm is a variant of the S^1 -norm, one should think of the Y -norm as a variant of the N^1 -norm. The reason we use these norms instead of the usual S^1 and N^1 norms is that they require roughly $4-(n+2) < 4-(n-2)$ degrees of differentiability only, while still having the same scaling as the full-derivative spaces S^1 and N^1 . This will become relevant when we have to address the limited regularity available for f_z and $f_{\bar{z}}$.

Lemma 3.2 (Exotic Strichartz estimate). For any $F \in Y$, we have

$$\left\| \int_{t_0}^t e^{i(t-s)\Delta} F(s) ds \right\|_X \leq \|F\|_{Y^0} \quad (3.7)$$

Proof. Interpolating between (1.41) and the conservation of mass, we get the following dispersive inequality

$$\|e^{i(t-s)\Delta} F(s)\|_{L^2_{\frac{n}{n+2}}} \leq \int_s^t \|F(s)\|_{L^2_{\frac{2(n+2)}{n+4}}} ds$$

whenever $t \geq s$. By fractional integration, this implies that on the slab $I \times \mathbb{R}^n$ we have

$$\left\| \int_{t_0}^t e^{i(t-s)\Delta} F(s) ds \right\|_{L^2_{n+2, \frac{2(n+2)}{n}}} \leq \|F\|_{L^2_{\frac{n+2}{3}, \frac{2(n+2)}{n+4}}} :$$

As the Littlewood-Paley operators commute with the free evolution, we get

$$\left\| \sum_N P_N \int_{t_0}^t e^{i(t-s)\Delta} F(s) ds \right\|_{L^2_{n+2, \frac{2(n+2)}{n}}} \leq \left\| \sum_N P_N F \right\|_{L^2_{\frac{n+2}{3}, \frac{2(n+2)}{n+4}}} :$$

Squaring the above inequality, multiplying by $N^{8-(n+2)}$, and summing over all dyadic N 's, we obtain (3.7).

To complete the set of tools needed to prove Theorem 1.3 in high dimensions, we need the following fractional variant of (1.13).

Lemma 3.3 (Nonlinear estimate). On any slab $I \subset \mathbb{R}^n$, we have

$$\|f_z(v)u\|_{Y'} \leq \|v\|_{W^{n-2}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|u\|_{X'} : \quad (3.8)$$

whenever the right-hand side makes sense. A similar statement holds with f_z replaced by f_z .

Proof. We just prove the claim for f_z , as the corresponding claim for f_z is identical. The main estimate is

Lemma 3.4 (Frequency-localized nonlinear estimate). For any dyadic M , we have

$$\|P_M f_z(v)u\|_{k_{\frac{n+2}{3}, \frac{2(n+2)}{n+4}}} \leq \|v\|_{W^{n-2}}^{\frac{4}{n-2}} \sum_N \|u\|_{k_{n+2, \frac{2(n+2)}{n}}} \quad \text{in } 1; \frac{N}{M}^{\frac{4}{n-2}} \|P_N u\|_{k_{n+2, \frac{2(n+2)}{n}}} ; \quad (3.9)$$

where all spacetime norms are on $I \subset \mathbb{R}^n$.

Proof. We may rescale⁸ such that $M = 1$. Splitting u into Littlewood-Paley components, we estimate

$$\|P_1 f_z(v)u\|_{k_{\frac{n+2}{3}, \frac{2(n+2)}{n+4}}} \leq \sum_N \|P_1 f_z(v)P_N u\|_{k_{\frac{n+2}{3}, \frac{2(n+2)}{n+4}}} : \quad (3.10)$$

Let us first consider the components where $N \leq 1=4$; we use (1.3), Hölder's inequality, and (1.12) to bound the contribution of these components to the right-hand side of (3.10) by

$$\sum_{N \leq 1=4} \|f_z(v)u\|_{k_{\frac{n+2}{2}, \frac{n+2}{2}}} \|P_N u\|_{k_{n+2, \frac{2(n+2)}{n}}} \leq \sum_{N \leq 1=4} \|v\|_{k_{\frac{2(n+2)}{n-2}, \frac{2(n+2)}{n}}}^{4(n-2)} \|P_N u\|_{k_{n+2, \frac{2(n+2)}{n}}} \\ \leq \|v\|_{W^{n-2}}^{\frac{4}{n-2}} \sum_{N \leq 1=4} \|P_N u\|_{k_{n+2, \frac{2(n+2)}{n}}} :$$

Next, we consider the components where $N \geq 1=8$. We can freely replace $f_z(v)$ by $P_{1=2} f_z(v)$ and then drop the projection P_1 , leaving us with the task of estimating

$$\sum_{N \geq 1=8} \|P_{1=2} f_z(v)P_N u\|_{k_{\frac{n+2}{3}, \frac{2(n+2)}{n+4}}} :$$

We use Hölder to estimate this contribution by

$$\sum_{N \geq 1=8} \|P_{1=2} f_z(v)\|_{k_{\frac{n+2}{2}, p}} \|P_N u\|_{k_{n+2, r}} ;$$

where $\frac{1}{r} = \frac{n}{2(n+2)} - \frac{4}{n(n-2)}$ and $p = \frac{n(n-2)(n+2)}{2(n^2+4)}$. From Bernstein, we have

$$\|P_N u\|_{k_{n+2, r}} \leq N^{\frac{4}{n-2}} \|P_N u\|_{k_{n+2, \frac{2(n+2)}{n}}} ;$$

⁸Note that while the nonlinearity f is not necessarily invariant under the scaling $f(z) \mapsto (n+2)=(n-2)f(z)$, the hypotheses on the nonlinearity are invariant under this scaling and so, the scaling argument remains justified in such cases.

so the claim follows if we can establish that

$$\|P_{1=2} f_z(v) k_{\frac{n+2}{2}, p} \cdot \|v\|_{W_-}^{\frac{4}{n-2}} : \quad (3.11)$$

In order to prove (3.11), we split v into $v_{lo} := P_{<1} v$ and $v_{hi} := P_{\geq 1} v$, and use (1.4) to write

$$f_z(v) = f_z(v_{lo}) + O(\|v_{hi}\|^{4=(n-2)}):$$

To deal with the contribution of the error term $O(\|v_{hi}\|^{4=(n-2)})$, we discard $P_{1=2}$ and use Hölder and Bernstein to estimate

$$\begin{aligned} \|P_{1=2} O(\|v_{hi}\|^{4=(n-2)}) k_{\frac{n+2}{2}, p} \cdot \|v_{hi}\|_{W_-}^{\frac{4}{n-2}} & \cdot \|v_{hi}\|_{W_-}^{\frac{4}{n-2}}; \frac{2n(n+2)}{n^2+4} \\ & \cdot \|v_{hi}\|_{W_-}^{\frac{4}{n-2}}; \frac{2n(n+2)}{n^2+4} \\ & \cdot \|v_{hi}\|_{W_-}^{4=(n-2)} : \end{aligned}$$

We are thus left with the main term. We need to show

$$\|P_{1=2} f_z(v_{lo}) k_{\frac{n+2}{2}, p} \cdot \|v_{lo}\|_{W_-}^{\frac{4}{n-2}} : \quad (3.12)$$

In order to prove (3.12), we make a few remarks. First, observe that for any spatial function F we have the bound

$$\|P_{1=2} F\|_{k_p} \leq \sup_{|j| \geq 1} \|k_{|h|} F\|_{F k_p}$$

where $k_{|h|} F(x) := F(x - h)$ is the translation operator. Indeed, from the triangle inequality we have

$$\|k_y F\|_{F k_p} \leq \|y\| \sup_{|j| \geq 1} \|k_{|h|} F\|_{F k_p}$$

for any $y \in \mathbb{R}^n$; integrating this against the convolution kernel of $P_{1=2}$ (which is rapidly decreasing and has total mass one) we obtain the claim. Next, observe from (1.4) that we have the pointwise estimate

$$|f_z(v_{lo}) - f_z(v_{lo})| = |f_z(v_{lo}) - f_z(v_{lo})| = O(\|v_{lo}\|_{W_-}^{\frac{4}{n-2}})$$

and thus, for any $t \in \mathbb{I}$,

$$\|P_{1=2} f_z(v_{lo}(t))\|_p \leq \sup_{|j| \geq 1} \|k_{|h|} v_{lo}(t) - v_{lo}(t)\|_{k_{\frac{2n(n+2)}{n^2+4}}}^{\frac{4}{n-2}} :$$

But from the fundamental theorem of calculus and Minkowski's inequality, for $|j| \geq 1$ we have

$$\|k_{|h|} v_{lo}(t) - v_{lo}(t)\|_{k_{\frac{2n(n+2)}{n^2+4}}} \leq \|v_{lo}(t)\|_{k_{\frac{2n(n+2)}{n^2+4}}} :$$

Thus,

$$\|P_{1=2} f_z(v_{lo}(t))\|_p \leq \|v_{lo}(t)\|_{k_{\frac{2n(n+2)}{n^2+4}}}^{\frac{4}{n-2}}$$

and hence, by Hölder's inequality in the time variable, (3.12) follows:

$$\begin{aligned} \|P_{1=2} f_z(v_{lo})\|_{\frac{n+2}{2}, p} & \leq \|v_{lo}\|_{k_{\frac{2n(n+2)}{n^2+4}}}^{\frac{4}{n-2}}; \frac{2n(n+2)}{n^2+4} \\ & \cdot \|v_{lo}\|_{W_-}^{\frac{4}{n-2}} : \end{aligned}$$

We now return to the proof of (3.8), and rewrite (3.9) as

$$M^{4=(n+2)} k_{P_M} f_Z(v) u k_{\frac{n+2}{3}; \frac{2(n+2)}{n+4}} \\ \cdot k v k_{\frac{n}{2}}^{\frac{4}{n+2}} \sum_N \min \left(\frac{M}{N} \right)^{\frac{4}{n+2}} ; \left(\frac{N}{M} \right)^{\frac{16}{n^2-4}} N^{4=(n+2)} k_{P_N} u k_{n+2; \frac{2(n+2)}{n}} :$$

The claim (3.8) then follows from Schur's test.

We are now ready to resume the proof of Theorem 1.3 in dimensions $n > 6$. Recall that $v = u - \alpha$ satisfies the initial value problem (3.1) and hence,

$$v(t) = e^{i(t-t_0)} v(t_0) - i \int_{t_0}^t e^{i(t-s)} f(\alpha + v) - f(\alpha)(s) ds - i \int_{t_0}^t e^{i(t-s)} e(s) ds :$$

We estimate

$$k v k_X \leq k e^{i(t-t_0)} v(t_0) k_X + \int_{t_0}^t e^{i(t-s)} f(\alpha + v) - f(\alpha)(s) ds_X \\ + \int_{t_0}^t e^{i(t-s)} e(s) ds_X ;$$

which by (3.7) becomes

$$k v k_X \leq k e^{i(t-t_0)} v(t_0) k_X + k f(\alpha + v) - f(\alpha) k_Y + \int_{t_0}^t e^{i(t-s)} e(s) ds_X : (3.13)$$

We consider first the free evolution term in (3.13). Using Sobolev embedding and the boundedness of the Riesz transforms on L_x^p for $1 < p < \infty$, we estimate

$$k e^{i(t-t_0)} v(t_0) k_X = \sum_N N^{\frac{8}{n+2}} k_{P_N} e^{i(t-t_0)} v(t_0) k_{n+2; \frac{2(n+2)}{n}}^{1=2} \\ \sum_N k j^{\frac{4}{n+2}} P_N e^{i(t-t_0)} v(t_0) k_{n+2; \frac{2(n+2)}{n}}^{1=2} \\ \cdot \sum_N k_{P_N} r e^{i(t-t_0)} v(t_0) k_{n+2; \frac{2n(n+2)}{n^2+2n-4}}^{1=2} :$$

Now, we observe that $L_t^{n+2} L_x^{\frac{2n(n+2)}{n^2+2n-4}}$ interpolates between $L_t^{\frac{2(n+2)}{n-2}} L_x^{\frac{2n(n+2)}{n^2+4}}$ and $L_t^1 L_x^2$ and hence,

$$k_{P_N} r e^{i(t-t_0)} v(t_0) k_{n+2; \frac{2n(n+2)}{n^2+2n-4}} \\ \leq k_{P_N} r e^{i(t-t_0)} v(t_0) k_{\frac{n}{2(n+2)}; \frac{2n(n+2)}{n^2+4}}^{\frac{2}{n-2}} k_{P_N} r e^{i(t-t_0)} v(t_0) k_{1; 2}^{\frac{n-4}{n-2}} :$$

The first factor is just the $W^{-1, \infty}(\mathbb{R}^n)$ norm of $P_N e^{i(t-t_0)} v(t_0)$. Squaring the above inequality, summing over all dyadic N 's, and applying Holder's inequality

for sequences, we obtain

$$\begin{aligned} & \sum_N \|P_N r e^{i(t-t_0)} v(t_0)\|_{n+2; \frac{2n(n+2)}{n^2+2n-4}}^2 \\ & \leq \sum_N \|P_N e^{i(t-t_0)} v(t_0)\|_{W^{1,2}(\mathbb{R}^n)}^2 \\ & \leq \sum_N \|P_N r e^{i(t-t_0)} v(t_0)\|_{1;2}^2 \leq \frac{n-4}{2(n-2)} : \end{aligned}$$

By (1.26), we have

$$\sum_N \|P_N e^{i(t-t_0)} v(t_0)\|_{W^{1,2}(\mathbb{R}^n)}^2 \leq \frac{n-2}{n-2} ;$$

while by the usual Strichartz estimates and (1.24), we get

$$\begin{aligned} & \sum_N \|P_N r e^{i(t-t_0)} v(t_0)\|_{1;2}^2 \leq \sum_N \|P_N r v(t_0)\|_{2; \frac{n-4}{2(n-2)}}^2 \\ & \leq \|r v(t_0)\|_{2; \frac{n-4}{2}}^2 \leq (E^0)^{\frac{n-4}{n-2}} : \end{aligned}$$

Hence,

$$\sum_N \|P_N r e^{i(t-t_0)} v(t_0)\|_{n+2; \frac{2n(n+2)}{n^2+2n-4}}^2 \leq \frac{n-2}{n-2} (E^0)^{\frac{n-4}{n-2}} : \quad (3.14)$$

We consider next the error term in (3.13) which we estimate via Sobolev embedding and the usual Strichartz estimates, recalling that r commutes with the free propagator and that the Riesz transforms are bounded on L_x^p for every $1 < p < \infty$.

$$\begin{aligned} & \int_{t_0}^t \|e^{i(t-s)} e(s) ds\|_X^2 \leq \sum_N \int_{t_0}^t \|e^{i(t-s)} P_N e(s) ds\|_{n+2; \frac{2(n+2)}{n}}^2 \\ & \leq \sum_N \int_{t_0}^t \|r e^{i(t-s)} P_N e(s) ds\|_{n+2; \frac{2n(n+2)}{n^2+2n-4}}^2 \\ & \leq \sum_N \|P_N e\|_{N^{1,1}(\mathbb{R}^n)}^2 : \end{aligned}$$

By (1.27) and the dual of (1.44),

$$\sum_N \|P_N e\|_{N^{1,1}(\mathbb{R}^n)}^2 \leq \|e\|_{N^{1,1}(\mathbb{R}^n)}^2 ;$$

so

$$\int_{t_0}^t \|e^{i(t-s)} e(s) ds\|_X^2 \leq \|e\|_{N^{1,1}(\mathbb{R}^n)}^2 : \quad (3.15)$$

We turn now to the remaining term on the right-hand side of (3.13). From (1.6) we have

$$f(\alpha + v) - f(\alpha) = \int_0^1 f_z(\alpha + v)v + f_z(\alpha + v)v \, d$$

and so, by using Minkowski's inequality, (1.3), and (3.8), we get

$$kf(\alpha + v) - f(\alpha)k_{\mathbb{H}} \leq k\alpha k_{W^{1,2}(\mathbb{R}^n)}^{\frac{4}{n-2}} + k\alpha k_{W^{1,2}(\mathbb{R}^n)}^{\frac{4}{n-2}} kvk_X :$$

In order to bound $k\alpha k_{W^{1,2}(\mathbb{R}^n)}$, we will first estimate the free evolution of $u(t_0)$, i.e., $e^{i(t-t_0)} u(t_0)$. By the triangle inequality and (3.3), we have

$$\begin{aligned} k e^{i(t-t_0)} u(t_0) k_{W^{1,2}(\mathbb{R}^n)} &\leq k e^{i(t-t_0)} v(t_0) k_{W^{1,2}(\mathbb{R}^n)} + k e^{i(t-t_0)} \alpha(t_0) k_{W^{1,2}(\mathbb{R}^n)} \\ &\leq \epsilon + k e^{i(t-t_0)} \alpha(t_0) k_{W^{1,2}(\mathbb{R}^n)} : \end{aligned}$$

On the other hand, by (1.14), (1.25), (1.27), and (1.46), we get

$$\begin{aligned} k e^{i(t-t_0)} \alpha(t_0) k_{W^{1,2}(\mathbb{R}^n)} &\leq k\alpha k_{W^{1,2}(\mathbb{R}^n)} + kf(\alpha)k_{N^1(\mathbb{R}^n)} + k\epsilon k_{N^1(\mathbb{R}^n)} \\ &\leq \epsilon_0 + k\alpha k_{W^{1,2}(\mathbb{R}^n)}^{\frac{n+2}{n-2}} + \epsilon \\ &\leq \epsilon_0 ; \end{aligned}$$

for ϵ_0 sufficiently small. Hence

$$k e^{i(t-t_0)} u(t_0) k_{W^{1,2}(\mathbb{R}^n)} \leq \epsilon + \epsilon_0 \leq \epsilon_0 :$$

Assuming ϵ_0 is sufficiently small depending on E and E^0 , the hypotheses of Theorem 1.1 hold and hence its conclusions hold as well; in particular, (1.18) holds, i.e.,

$$k\alpha k_{W^{1,2}(\mathbb{R}^n)} \leq \epsilon_0 : \quad (3.16)$$

Returning to our previous computations, by (1.25) and (3.16), we get

$$kf(\alpha + v) - f(\alpha)k_{\mathbb{H}} \leq \epsilon_0^{\frac{4}{n-2}} kvk_X : \quad (3.17)$$

Considering (3.14), (3.15), and (3.17), (3.13) becomes

$$kvk_X \leq \epsilon_0^{\frac{2}{n-2}} (E^0)^{\frac{n-4}{n-2}} + \epsilon + \epsilon_0^{\frac{4}{n-2}} kvk_X :$$

Assuming that ϵ_0 is sufficiently small depending on E^0 , a standard continuity argument yields

$$kvk_X \leq \epsilon_0^{\frac{2}{n-2}} (E^0)^{\frac{n-4}{n-2}} : \quad (3.18)$$

By Sobolev embedding and (1.44), we conclude

$$\begin{aligned} kvk_{n+2, \frac{2n(n+2)}{n^2-8}} &\leq \int_{\mathbb{R}^n} \int_{\mathbb{R}^n}^{\frac{4}{n+2}} v_{n+2, \frac{2(n+2)}{n}} \\ &\leq \sum_N \int_{\mathbb{R}^n} \int_{\mathbb{R}^n}^{\frac{4}{n+2}} P_N v_{n+2, \frac{2(n+2)}{n}}^{1=2} \\ &\leq kvk_X \\ &\leq \epsilon_0^{\frac{2}{n-2}} (E^0)^{\frac{n-4}{n-2}} : \end{aligned} \quad (3.19)$$

We are now ready to upgrade our bounds on v ; first, we will show (1.28). Indeed, by Strichartz's inequality, (1.27), and (3.3), we have

$$\begin{aligned} \|v\|_{W^{-1}(\mathbb{R}^n)} &\leq \|e^{i(t-t_0)} v(t_0)\|_{W^{-1}(\mathbb{R}^n)} \\ &\quad + \|f(\alpha + v) - f(\alpha)\|_{N^{-1}(\mathbb{R}^n)} + \|e\|_{N^{-1}(\mathbb{R}^n)} \\ &\leq \|f(\alpha + v) - f(\alpha)\|_{N^{-1}(\mathbb{R}^n)} + \|e\|_{N^{-1}(\mathbb{R}^n)}. \end{aligned} \quad (3.20)$$

By (3.5), we have

$$\|f(\alpha + v) - f(\alpha)\|_{N^{-1}(\mathbb{R}^n)} \leq \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}}$$

and hence

$$\begin{aligned} \|f(\alpha + v) - f(\alpha)\|_{N^{-1}(\mathbb{R}^n)} &\leq \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \\ &\quad + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \\ &\quad + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \end{aligned}$$

where $\frac{1}{a} = \frac{1}{2} - \frac{4}{n^2-4}$ and $\frac{1}{b} = \frac{n+2}{2n} - \frac{2(n^2-8)}{n(n^2-4)}$. Note that the pair $(a;b)$ is a Schrodinger admissible pair and hence

$$\|v\|_{W^{-1}(\mathbb{R}^n)} \leq \|v\|_{S^{-1}(\mathbb{R}^n)}.$$

However, by (1.14), (1.45), and our hypotheses (1.23), (1.25), and (1.27), we have

$$\begin{aligned} \|v\|_{S^{-1}(\mathbb{R}^n)} &\leq \|v(t_0)\|_{H_x^{-1}} + \|f(\alpha)\|_{N^{-1}(\mathbb{R}^n)} + \|e\|_{N^{-1}(\mathbb{R}^n)} \\ &\leq E + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{n+2}{n-2}} + \|e\|_{N^{-1}(\mathbb{R}^n)} \\ &\leq E + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{n+2}{n-2}} + \|e\|_{N^{-1}(\mathbb{R}^n)} \end{aligned}$$

and hence, for $\|v\|_{W^{-1}(\mathbb{R}^n)}$ sufficiently small depending on E ,

$$\|v\|_{S^{-1}(\mathbb{R}^n)} \leq E. \quad (3.21)$$

Returning to our previous computations and using (3.16) (combined with (1.12)) and (3.21), we have

$$\begin{aligned} \|f(\alpha + v) - f(\alpha)\|_{N^{-1}(\mathbb{R}^n)} &\leq \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \\ &\quad + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \\ &\quad + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \\ &\leq E \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}}; \end{aligned}$$

which by (3.19) yields

$$\|f(\alpha + v) - f(\alpha)\|_{N^{-1}(\mathbb{R}^n)} \leq \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} (E^0)^{\frac{4(n-4)}{(n-2)^2}} E + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}}. \quad (3.22)$$

Returning to (3.20), we find

$$\|v\|_{W^{-1}(\mathbb{R}^n)} \leq \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} (E^0)^{\frac{4(n-4)}{(n-2)^2}} E + \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}} \|v\|_{W^{-1}(\mathbb{R}^n)}^{\frac{4}{n-2}}.$$

Assuming ϵ_0 is sufficiently small depending on E and E^0 , a standard continuity argument yields (1.28), i.e.,

$$\|v\|_{W_{\infty}^{-1}(I; \mathbb{R}^n)} \leq \epsilon_0 + \epsilon_0^{\frac{7}{(n-2)^2}};$$

By (1.28) and (3.22), we get (1.31). Indeed,

$$\begin{aligned} (i\partial_t + \Delta)(u - v) + e_{N^{-1}(I; \mathbb{R}^n)} &\leq \|f(v) - f(u)\|_{N^{-1}(I; \mathbb{R}^n)} \\ &\leq \epsilon_0^{\frac{8}{(n-2)^2}} (E^0)^{\frac{4(n-4)}{(n-2)^2}} E + \epsilon_0^{\frac{4}{n-2}} \epsilon_0 + \epsilon_0^{\frac{7}{(n-2)^2}} \\ &\leq \epsilon_0 + \epsilon_0^{\frac{7}{(n-2)^2}}; \end{aligned}$$

provided $\epsilon_0 = \epsilon_0(E; E^0)$ is sufficiently small.

To prove (1.29), we use Strichartz's inequality, (1.24), (1.27) and (1.28):

$$\begin{aligned} \|v\|_{S^1(I; \mathbb{R}^n)} &\leq \|v(t_0)\|_{H_x^{-1}} + \|(i\partial_t + \Delta)(u - v) + e_{N^{-1}(I; \mathbb{R}^n)}\|_{N^{-1}(I; \mathbb{R}^n)} \\ &\quad + \|e\|_{N^{-1}(I; \mathbb{R}^n)} \\ &\leq E^0 + \epsilon_0 + \epsilon_0^{\frac{7}{(n-2)^2}}; \end{aligned}$$

By triangle inequality, (1.29) and (3.21) imply (1.30), provided ϵ_0 is chosen sufficiently small depending on E and E^0 .

4. Long-time perturbations

The goal of this section is to prove Theorem 1.4 and to derive scattering results as corollaries. We will prove Theorem 1.4 under the additional assumption

$$\|u(t_0)\|_{L_x^2} < 1. \quad (4.1)$$

This additional assumption can be removed by the usual limiting argument: approximating $u(t_0)$ in H_x^{-1} by $f_{u_n}(t_0)g_n \in H_x^1$ and applying Theorem 1.4 (under finite mass assumptions) with $v = u_n$, $e = 0$, and $u = u_n$, we obtain that the sequence of solutions $f_{u_n}g_n$ to (1.1) with initial data $f_{u_n}(t_0)g_n$ is Cauchy in $S^1(I; \mathbb{R}^n)$ and thus convergent to an S^1 solution u to (1.1) with initial data $u(t_0)$ at time $t = t_0$.

We will derive Theorem 1.4 from Theorem 1.3 by an iterative procedure. First, we will assume without loss of generality that $t_0 = \inf I$. Let $\epsilon_0 = \epsilon_0(E; 2E^0)$ be as in Theorem 1.3. Note that we need to replace E^0 by the slightly larger $2E^0$ as the H_x^{-1} -norm of $u(t) - v(t)$ may possibly grow in time.

The first step is to establish an S^1 bound on v . In order to do so, we subdivide I into $N_0 = 1 + \frac{M}{\epsilon_0} \frac{2(n+2)}{n-2}$ subintervals J_k such that

$$\|v\|_{L_{t,x}^{\frac{2(n+2)}{n-2}}(J_k; \mathbb{R}^n)} \leq \epsilon_0. \quad (4.2)$$

By (1.14), (1.45), (1.33), (1.36), and (4.2), we estimate

$$\begin{aligned} & \|k\alpha\|_{S^1(J_k \times \mathbb{R}^n)} \leq \|k\alpha(t_0)\|_{H_x^{-1}} + \|kf(\alpha)\|_{N^{-1}(J_k \times \mathbb{R}^n)} + \|ke\|_{N^{-1}(J_k \times \mathbb{R}^n)} \\ & \leq E + \|k\alpha\|_{L_{t,x}^{\frac{2(n+2)}{n-2}}(J_k \times \mathbb{R}^n)}^{\frac{4}{n-2}} \|k\alpha\|_{W^{-1}(J_k \times \mathbb{R}^n)} + \epsilon \\ & \leq E + \epsilon^{\frac{4}{n-2}} \|k\alpha\|_{S^1(J_k \times \mathbb{R}^n)} + \epsilon. \end{aligned}$$

A standard continuity argument yields

$$\|k\alpha\|_{S^1(J_k \times \mathbb{R}^n)} \leq E;$$

provided ϵ_0 is sufficiently small depending on E . Summing these bounds over all the intervals J_k , we obtain

$$\|k\alpha\|_{S^1(I \times \mathbb{R}^n)} \leq C(E; M; \epsilon_0);$$

which by Lemma 1.6 implies

$$\|k\alpha\|_{W^{-1}(I \times \mathbb{R}^n)} \leq C(E; M; \epsilon_0).$$

We now subdivide I into $N_1 = C(E; M; \epsilon_0)$ subintervals $I_j = [t_j, t_{j+1}]$ such that

$$\|k\alpha\|_{W^{-1}(I_j \times \mathbb{R}^n)} \leq \epsilon_0. \quad (4.3)$$

Choosing ϵ_1 sufficiently small depending on N_1, E , and E^0 , we apply Theorem 1.3 to obtain for each j and all $0 < \epsilon < \epsilon_1$,

$$\begin{aligned} \|ku\|_{W^{-1}(I_j \times \mathbb{R}^n)} & \leq C(j) \epsilon + \epsilon^{\frac{7}{(n-2)^2}} \\ \|ku\|_{S^1(I_j \times \mathbb{R}^n)} & \leq C(j) E^0 + \epsilon + \epsilon^{\frac{7}{(n-2)^2}} \\ \|k\alpha\|_{S^1(I_j \times \mathbb{R}^n)} & \leq C(j) (E + E^0) \\ (i\partial_t + \Delta)(u - \alpha) + e_{N^{-1}(I_j \times \mathbb{R}^n)} & \leq C(j) \epsilon + \epsilon^{\frac{7}{(n-2)^2}}; \end{aligned}$$

provided we can show that (1.34) and (1.35) hold with t_0 replaced by t_j . We verify this using an inductive argument. By (1.34), (1.45), and the inductive hypothesis,

$$\begin{aligned} \|ku(t_{j+1}) - \alpha(t_{j+1})\|_{H_x^{-1}} & \leq \|ku(t_0) - \alpha(t_0)\|_{H_x^{-1}} + \|ke\|_{N^{-1}([t_0, t_{j+1}] \times \mathbb{R}^n)} \\ & \quad + \|(i\partial_t + \Delta)(u - \alpha) + e\|_{N^{-1}([t_0, t_{j+1}] \times \mathbb{R}^n)} \\ & \leq E^0 + \epsilon + \sum_{k=0}^j C(k) \epsilon + \epsilon^{\frac{7}{(n-2)^2}} : \end{aligned}$$

As the Littlewood-Paley operators commute with derivative operators and the free propagator, by Strichartz, we estimate

$$\begin{aligned} & \|kP_N e^{i(t-t_{j+1})\Delta} u(t_{j+1}) - \alpha(t_{j+1})\|_{W^{-1}(I \times \mathbb{R}^n)} \\ & \leq \|kP_N e^{i(t-t_0)\Delta} u(t_0) - \alpha(t_0)\|_{W^{-1}(I \times \mathbb{R}^n)} + \|kP_N e\|_{N^{-1}(I \times \mathbb{R}^n)} \\ & \quad + \|P_N (i\partial_t + \Delta)(u - \alpha) + e\|_{N^{-1}(I \times \mathbb{R}^n)} : \end{aligned}$$

$$\begin{aligned} & X \quad k P_N e^{i(t-t_{j+1})} u(t_{j+1}) \quad \alpha(t_{j+1}) k_{W-(I \quad R^n)}^2 \quad 1=2 \\ & N \\ & X \quad k P_N e^{i(t-t_0)} u(t_0) \quad \alpha(t_0) k_{W-(I \quad R^n)}^2 \quad 1=2 \\ & N \\ & + \quad X \quad k P_N e k_{N^{-1}(I \quad R^n)}^2 \quad 1=2 \\ & N \\ & + \quad X \quad P_N (i \partial_t + \quad) (u \quad \alpha) + e \quad 2 \quad 1=2 \\ & N \quad N^{-1}(I \quad R^n) \\ & N \\ & \cdot \quad " + k e k_{N^{-1}(I \quad R^n)} + k (i \partial_t + \quad) (u \quad \alpha) + e k_{N^{-1}(I \quad R^n)} \\ & X^j \\ & \cdot \quad " + \quad C(k) \quad " + \quad \frac{7}{(n-2)^2} \quad : \\ & k=0 \end{aligned}$$

This concludes the proof of Theorem 1.4. As a consequence of this theorem, we will derive scattering results. Let us start by proving that a finite bound of the $L_{t,x}^{\frac{2(n+2)}{n-2}}$ -norm of the solution to (1.1) implies scattering. Indeed, we have

$$\text{kuk } \frac{2(n+2)}{L_{\frac{n}{2}}(x)} \quad \text{M} \quad (4.4)$$
$$k u(t) - u(t) k_{H-1} \neq 0$$

Proof. We will only prove the statement for u_+ , since the proof for u_- follows similarly. Let us first construct the scattering state $u_+(0)$. For $t > 0$ define $v(t) = e^{-it\Delta} u(t)$. We will show that $v(t)$ converges in H_x^{-1} as $t \rightarrow \infty$, and define $u_+(0)$ to be the limit. Indeed, from Duhamel's formula (1.42) we have

$$v(t) = u(0) + \int_0^t e^{-is} f(u(s)) ds: \quad (4.5)$$

$$v(t) - v(\cdot) = \int_0^t e^{is} f(u(s)) ds:$$

By (1.14), (1.46), and Lemma 1.6, we have

$$\begin{aligned} kv(t) - v(\cdot)k_{H_x^{-1}} &\leq kf(u)k_{N^1([t]; \mathbb{R}^n)} \\ &\quad \cdot kuk_{L_{t,x}^{\frac{4}{n-2}}([t]; \mathbb{R}^n)}^{\frac{n-2}{2}} kuk_{W^{-1}([t]; \mathbb{R}^n)} \\ &\quad \cdot kuk_{L_{t,x}^{\frac{4}{n-2}}([t]; \mathbb{R}^n)}^{\frac{n-2}{2}} kuk_{S^1([t]; \mathbb{R}^n)} : \end{aligned}$$

However, (4.4) implies $kuk_{S^1(\mathbb{R}^n)} \leq C(E; M)$ by the same argument as in the proof of Theorem 1.4, where E denotes the kinetic energy of the initial data u_0 . Also by (4.4), for any $\epsilon > 0$ there exists $t \in \mathbb{R}_+$ such that

$$kuk_{L_{t,x}^{\frac{4}{n-2}}([t;1]; \mathbb{R}^n)}^{\frac{n-2}{2}}$$

whenever $t > t$. Hence,

$$kv(t) - v(\cdot)k_{H_x^{-1}} \rightarrow 0 \text{ as } t \rightarrow 1.$$

In particular, this implies that $u_+(0)$ is well defined. Also, inspecting (4.5) one easily sees that

$$u_+(0) = u_0 + i \int_0^1 e^{is} f(u(s)) ds \quad (4.6)$$

and thus

$$u_+(t) = e^{it} u_0 + i \int_0^1 e^{i(t-s)} f(u(s)) ds. \quad (4.7)$$

By the same arguments as above, (4.7) and Duhamel's formula (1.42) imply that $ku_+(t) - u(t)k_{H_x^{-1}} \rightarrow 0$ as $t \rightarrow 1$.

Similar estimates prove that the inverse wave operator $u_0 \mapsto u_+(0)$ is continuous from H_x^{-1} to itself subject to the assumption (4.4) (in fact, we obtain a Hölder continuity estimate with this assumption). We skip the details.

Remark 4.2. If we assume $u_0 \in H_x^{-1}$ in Corollary 4.1, then similar arguments yield scattering in H_x^{-1} , i.e., there exist finite energy solutions $u(t; x)$ to the free Schrödinger equation $(i\partial_t + \Delta_x)u = 0$ such that

$$ku(t) - u(t)k_{H_x^{-1}} \rightarrow 0 \text{ as } t \rightarrow 1.$$

Remark 4.3. If we knew that the problem (1.1) were globally well-posed for arbitrary H_x^{-1} (respectively H_x^{-1}) initial data, then standard arguments would also give asymptotic completeness, i.e., the maps $u_0 \mapsto u_+(0)$ would be homeomorphisms from H_x^{-1} (respectively H_x^{-1}) to itself. See for instance [6] for this argument in the energy-subcritical case.

As a consequence of Corollary 4.1 and the global well-posedness theory for small initial data (see Corollary 1.2), we obtain scattering for solutions of (1.1) with initial data small in the energy-norm H_x^{-1} :

Corollary 4.4. Let $u_0 \in H_x^{\frac{1}{2}}$ be such that

$$\|u_0\|_{H_x^{\frac{1}{2}}} < \infty$$

with ϕ_0 as in Theorem 1.1 and let u be the unique global solution to (1.1). Then there exist finite energy solutions $u(t; x)$ to the free Schrödinger equation $(i\partial_t + \Delta_x)u = 0$ such that

$$\|u(t) - u_0\|_{H_x^{\frac{1}{2}}} \rightarrow 0$$

as $t \rightarrow \pm\infty$. Moreover, the maps $u|_{\mathbb{T}} : u_0 \mapsto u(0)$ are continuous from $H_x^{\frac{1}{2}}$ to itself (in fact, we have a Hölder continuity estimate).
