# THE MODULI SPACE OF 5 POINTS ON $P^{1}$ AND K3 SURFACES

#### Abstract

We show that the moduli space of ordered 5 points on $P^{1}$ is isomorphic to an arithmetic quotient of a complex ball by using the theory of periods of K 3 surfaces. We also discuss a relation between our uniformization and the one given by Shimura [S], Terada [Te], Deligne-Mostow [DM].

## 1. Introduction

The purpose of this note is to show that the moduli space of 5 ordered points on $P^{1}$ is isomorphic to an arithmetic quotient of a 2-dimensional complex ball by using the theory of periods of K 3 surfaces (Theorem 6.10). This was announced in [K2], Remark 6. The main idea is to associate a K 3 surface with an automorphism of order 5 to a set of 5 ordered points on $P^{1}$ (see $\sqrt{3}$ ). The period domain of such K 3 surfaces is a 10 -dimensional bounded symmetric domain of type IV. We remark that a non-zero holomorphic 2 -form on the K 3 surface is an eigen-vector of the automorphism, which implies that the period domain of the pairs of these K 3 surfaces and the automorphism of order 5 is a 2-dimensional complex ball associated to a hermitian form of the signature $(1 ; 2)$ defined over $Z$ [ ] where is a primitive 5-th root of unity (see 6.3). Here we use several fundamental results of Nikulin [N1], [N2], [N3] on automorphisms of $K 3$ surfaces and the lattice theory.

Note that this moduli space is isomorphic to the moduli space of nodal del Pezzo surfaces of degree 4. For the moduli space of del Pezzo surfaces of degree 1, 2 or 3, the similar description holds. See [K2], Remark 5, [K1], [DGK], respectively.

On the other hand, Shimura [S], Terada [Te], Deligne-Mostow [DM] gave a complex ball uniformization by using the periods of the curve C which is the 5 -fold cyclic covering of $\mathrm{P}^{1}$ branched along 5 points. We shall discuss a relation between their uniformization and ours in $[7$ In fact, the above K 3 surface has an isotrivial pencil whose general member is the unique smooth curve $D$ of genus 2 admitting an automorphism of order 5 (see Lemma 3.4). We show that the above K 3 surface is birational to the quotient of $C \quad D$ by a diagonal action of $Z=5 Z$ in 87

In this paper, a lattice means a Z -valued non-degenerate symmetric bilinear form on a free Z module of finite rank. We denote by $U$ or $V$ the even lattice defined by the matrix $\begin{array}{lllll}0 & 1 \\ 1 & 0\end{array}, \begin{aligned} & 2 \\ & 1\end{aligned} \begin{gathered}1\end{gathered}$, respectively and by $A_{m}, D_{n}$ or $E_{1}$ the even negative definite lattice defined by the Dynkin matrix of type $A_{m}, D_{n}$ or $E_{1}$ respectively. If $L$ is a lattice and $m$ is an integer, we denote by $L(m)$ the lattice over the same Z -module with the symmetric bilinear form multiplied by m . We also denote by $\mathrm{L}{ }^{\mathrm{m}}$ the orthogonal direct sum of $m$ copies of $L$, by $L$ the dual of $L$ and by $A_{L}$ the finite abelian group $\mathrm{L}=\mathrm{L}$.

## 2. Quartic Del Pezzo surfaces

2.1. Five points on $P^{1}$. Consider the diagonal action of PGL (2) on $\left(P^{1}\right)^{5}$. In this case, the semistable points and stable points in the sense of [Mu] coincide and the geometric quotient $P_{1}^{5}$ is smooth and compact. The stable points are $f p_{1} ;:: ;{ }_{5} g$ no three of which coincide. It is known that $P_{1}^{5}$ is isomorphic to the quintic del Pezzo surface $\mathrm{D}_{5}$, that is, a smooth surface obtained by blowing up four points $f q_{H} ;::: ; q_{4} g$ in general position on $P^{2}$ (e.g. Dolgachev [D], Example 11.5). The quintic del Pezzo surface $D_{5}$ contains 10 lines corresponding to the 4 exceptional curves over $q_{i} ;::: ; q_{4}$ and the proper transforms of 6 lines through two points from $\mathrm{fq}_{\mathrm{q}} ;::: ; q_{4} g$. These ten lines correspond to the locus consisting of $f p_{1} ;::: ; p_{5} g$ with $p_{i}=p_{j}$ for some $i ; j$. The group of automorphisms of $D_{5}$ is isomorphic to the Weyl group $W\left(A_{4}\right)^{\prime} S_{5}$ which is induced from the natural action of $S_{5}$ on $\left(\mathbb{P}^{1}\right)^{5}$.
2.2. Quartic Del Pezzo surfaces. Let $S$ be a smooth quartic Del Pezzo surface. It is known that $S$ is a complete intersection of two quadrics in $P^{4}$. Consider the pencil of quadrics whose base locus is $S$. Its discriminant is a union of distinct five points of $P^{1}$. Conversely any distinct five points ( $1:$ i) on $P^{1}$, the intersection of quadrics

is a smooth quartic Del Pezzo surface. Thus the moduli space of smooth quartic Del Pezzo surfaces is isomprphic to $\left(\left(\mathbb{P}^{1}\right)^{5} \mathrm{n}\right)=$ PGL (2)) $=\mathrm{S}_{5}$ where is the locus consisting of points ( $\mathrm{x}_{1} ;:: ; ; \mathrm{x}_{5}$ ) with $x_{i}=x_{j}$ for some $i_{i j}(i \not j$ ). If five points are not distinct, but stable, the equation (2.1) defines a quartic Del Pezzo surface with a node. Thus $P_{1}^{5}$ is the coarse moduli space of nodal quartic Del Pezzo surfaces.

## 3. K3 SURFACES ASSOCIATED TO FIVE POINTS ON $P^{1}$

3.1. A plane quintic curve. Let $\mathrm{fp}_{1} ;::: ; \mathrm{P}_{5} g$ be an ordered stable point in $\left(\mathbb{P}^{1}\right)^{5}$. It defines a homogenious polynomial $f_{5}\left(\mathrm{x}_{1} ; \mathrm{x}_{2}\right)$ of degree 5 . Let C be the plane quintic curve defined by

The projective transformation

acts on $C$ as an automorphism of $C$ of order 5 where is a primitive 5 -th root of unity. Let $E_{0}, L_{i}$ $\left(\begin{array}{lll}1 & \text { i } & 5\end{array}\right)$ be lines defined by

Note that all $L_{i}$ are members of the pencil of lines through $(1: 0: 0)$ and $L_{i}$ meets $C$ at $\left(0: i_{i}: 1\right)$ with multiplicity 5 .
3.2. K3 surfaces. Let $X$ be the minimal resolution of the double cover of $P^{2}$ branched along the sextic curve $E_{0}+C$. Then $X$ is a $K 3$ surface. We denote by the covering transformation. The projective transformation $g$ in (3.2) induces an automorphism of $X$ of order 5. We denote by the same symbol $E_{0}$ the inverse image of $E_{0}$.

Case (i) Assume that the equation $f_{5}=0$ has no multiple roots. In this case there are 5 ( 2 )-curves, denoted by $E_{i}(1 \quad i \quad 5)$, obtained as exceptional curves of the minimal resolution of singularities of type $A_{1}$ corresponding to the intersection of $C$ and $E_{0}$. The inverse image of $L_{i}$ is the union of two smooth rational curves $F_{i} ; G_{i}$ such that $F_{i}$ is tangent to $G_{i}$ at one point. Let p;qbe the inverse image of ( $1: 0: 0$ ). We may assume that all $F_{i}\left(\right.$ resp. $\left.G_{i}\right)$ are through $p$ (resp. q). Obviously preserves each curve $E_{i} ; F_{j} ; G_{j}(0 \quad i \quad 5 ; 1 \quad j \quad 5)$ and preserves each $E_{i}$ and $\left(F_{i}\right)=G_{i}$.

Case (ii) If $f_{5}=0$ has a multiple root, then the double cover has a rational double point of type $D_{7}$. Hence $X$ contains 7 smooth rational curves $E_{j}^{0}$, (1 $\left.\begin{array}{lll}1 & j & 7\end{array}\right)$ whose dual graph is of type $D_{7}$. We assume that $\mathrm{E}_{1}^{0}$ meets $\mathrm{E}_{0}$ and $\mathrm{hE}{ }_{1}{ }^{0} \mathrm{E}_{2}^{0} \mathrm{i}=\mathrm{hE}{ }_{2}^{0} ; \mathrm{E}_{3}^{0} \mathrm{i}=\mathrm{hE}{ }_{3}^{0} ; \mathrm{E}_{4}^{0} \mathrm{i}=\mathrm{h}{ }_{4}^{0} ; \mathrm{E}_{5}^{0} \mathrm{i}=\mathrm{hE}{ }_{5}^{0} ; \mathrm{E}_{6}^{0} \mathrm{i}=h \mathrm{E}_{5}^{0} ; \mathrm{E}_{7}^{0} \mathrm{i}=$ 1. If ${ }_{i}$ is a multiple root, then $F_{i}$ and $G_{i}$ are disjoint and each of them meets one componet of $D_{7}$, for example, $\mathrm{F}_{\mathrm{i}}$ meets $\mathrm{E}_{6}^{0}$ and $\mathrm{G}_{\mathrm{i}}$ meets $\mathrm{E}_{7}^{0}$.
3.3. A pencil of curves of genus two. The pencil of lines on $P^{2}$ through ( $1: 0: 0$ ) gives a pencil of curves of genus two on $X$. Each member of this pencil is invariant under the action of the automorphism of order 5. Hence a general member is a smooth curve of genus two with an automorphism of order five. Such a curve is unique up to isomorphism and is given by

(see Bolza [Bol]). If ${ }_{i}$ is a simple root of the equation $f_{5}=0$, then the line $L_{i}$ defines a singular member of this pencil consisting of three smooth rational curves $E_{i}+F_{i}+G_{i}$. We call this singular member a singular member of type I. If ${ }_{i}$ is a multiple root of $f_{5}=0$, then the line $L_{i}$ defines a singular member consisting of nine smooth rational curves $\mathrm{E}_{1}^{0} ;::: ; \mathrm{E}_{7}^{0} ; \mathrm{F}_{\mathrm{i}} ; \mathrm{G}_{\mathrm{i}}$. We call this a singular member of type II. The two points p;qare the base points of the pencil. After blowing up at p;q, we have a base point free pencil of curves of genus two. The singular fibers of such pencils are completly classified by Namikawa and Ueno [NU]. The type I (resp. type II) corresponds to [IX-2] (resp. [IX-4] ) in [NU]. We now conclude:
3.4. Lemma. The pencil of lines on $P^{2}$ through ( $\left.1: 0: 0\right)$ gives a pencil of curves of genus two on X . A general member is a smooth curve of genus two with an automorphism of order five. In case that $f_{5}=0$ has no multiple roots, it has five singular members of type $I$. In case that $f_{5}=0$ has a multiple root (resp. two multiple roots), it has three singular members of type $I$ and one singular member of type II (resp. one of type I and two of type II).
3.5. A 5-fold cyclic cover of $P^{1} \quad P^{1}$. The following is due to $I$. Dolgachev. The above $K 3$ surface has an automorphism of order 5 by construction. This implies that X is obtained as a 5 -fold cyclic cover of a rational surface. Let $D$ be a divisor of $P^{1} \quad P^{1}$ defined by

where $l_{1} ;::: l_{5}$ are the fibers of the first projection from $P^{1} \quad P^{1}$ over the five points determined by the polynomial $f_{5}\left(\mathrm{x}_{1} ; \mathrm{x}_{2}\right)$ in (3.1), and $\mathrm{m}_{1} ; \mathrm{m}_{2} ; \mathrm{m}_{3}$ are three fibers of the second projection which are unique up to projective transformations. Take the 5-cyclic cover of $P^{1} \quad P^{1}$ branched along D. Then
taking the normalization and resolving the singularities, and blowing down the proper transforms of $l_{1} ;::: l_{5} ; \mathrm{m}_{1} ; \mathrm{m}_{2} ; \mathrm{m}_{3}$ which are exceptional curves of the first kind, we have a K 3 surface Y . Locally the singularities over the intersection points of $l_{i}$ and $m_{1} ; m_{2}$ are given by $z^{5}=x^{4} y$ and those over the intersection points of $l_{1}$ and $m_{3}$ are given by $z^{5}=x^{4} y^{3}$. Note that the ruling of the first projection from $P^{1} \quad P^{1}$ gives a pencil of curves of genus 2 on $Y$. On the other hand, consider the involution of $P^{1} \quad P^{1}$ which changes $m_{1}$ and $m_{2}$, and fixes $m_{3}$. Let $m_{4}$ be the another fixed fiber of this involution. Then this involution induces an involution of $Y$ which fixes the inverse image $C$ of $m_{4}$. The last curve $C$ corresponds to the plane quintic curve given in (3.1).

## 4. Picard and transcendental lattices

In this section we shall study the Picard lattice and the transcendental lattice of K 3 surfaces X given in 3.2. We denote by $S_{x}$ the Picard lattice of $X$ and by $T_{X}$ the transcendental lattice of $X$.

### 4.1. The Picard lattice.

4.2. Lemma. Assume that $\mathrm{f}_{5}=0$ has no multiple roots. Let S be the sublattice generated by $\mathrm{E}_{0}$ and components of the singular members of the pencil in Lemma 3.4 Then $\operatorname{rank}(\mathrm{S})=10$ and $\operatorname{det}(\mathrm{S})=5^{3}$. Moreover if X is generic in the sense of moduli, then the Picard lattice $\mathrm{S}_{\mathrm{X}}=\mathrm{S}$.

Proof. First note that the dimension of $\mathrm{P}_{1}^{5}$ is 2 . On the other hand, x has an automorphism of order 5 induced from $g$ given in (3.2) which acts non trivially on $H^{0}\left(X ;{ }^{2}\right)$. Nowhere vanishing holomorphic 2-forms are eigenvectors of . We can see that the dimension of the period domain is (22 $\left.\operatorname{rank}\left(\mathrm{S}_{\mathrm{x}}\right)\right)=\left(\begin{array}{ll}5 & 1\end{array}\right)([\mathrm{N} 2]$, Theorem 3.1. Also see the following section 6). Hence the local Torelli theorem implies that rank $\left(S_{X}\right)=10$ for generic $X$. Let $S_{0}$ be the sublattice of $S_{X}$ generated by $\mathrm{E}_{\mathrm{i}} ; \mathrm{F}_{\mathrm{i}} ;(1 \quad \mathrm{i} \quad 5)$. Then a direct calculation shows that $\operatorname{rank}\left(\mathrm{S}_{0}\right)=10$ and $\operatorname{det}\left(\mathrm{S}_{0}\right)=5^{5}$. The first assertion now follows from the relations:

Note that $S=S^{\prime} \quad(Z=5 Z)^{3}$. Now assume that rank $\left(S_{x}\right)=10$. If $S_{x} \notin S$, then $S \quad S_{x} \quad S$ and hence there exists an algebraic cycle $C$ not contained in $S$ and satisfying

4.3. Discriminant quadratic forms. Let $L$ be an even lattice. We denote by $L$ the dual of $L$ and put $A_{L}=L=L$. Let

4.4. The transcendental lattice. Let $T$ be the orthogonal complement of $S$ in $H^{2}(X ; Z)$. For generic $X, T$ is isomorphic to the transcendental lattice $T_{X}$ of $X$ which consists of transcendental cycles, that is, cycles not perpendicular to holomorphic 2-forms on X .
4.5. Lemma. Assume that $f_{5}$ has no multiple roots. Then

Proof. We can see that $q_{5}$ and the discriminant quadratic form of $V \quad A_{4} \quad A_{4}$ coincide. Also note that $q_{I}=q_{G}$ (Nikulin [N1], Corollary 1.6.2). Now the assertion follows from Nikulin [N1], Theorem 1.14.2.
4.6. Lemma. Let $\mathrm{S}_{\mathrm{i}}$ be the sublattice generated by $\mathrm{E}_{0}$ and components of the singular members of the pencil in Lemma 3.4 where $i=1$ or 2 is the number of multiple roots of $f_{5}=0$. Let $\mathrm{T}_{\mathrm{i}}$ be the orthogonal complement of $\mathrm{S}_{\mathrm{i}}$ in $\mathrm{H}^{2}(\mathrm{X} ; \mathrm{Z})$. Then

4.7. The Kähler cone. Let $S_{X}$ be the Picard lattice of $X$. Denote by $P(X)^{+}$the connected component of the set $\mathrm{fx}_{\mathrm{x}} 2 \mathrm{~S}_{\mathrm{X}} \quad \mathrm{R}$ : hx; xi> 0 g which contains an ample class. Let $(\mathrm{X})$ be the set of effective classes $r$ with $r^{2}=2$. Let

which is called the Kähler cone of $X$. It is known that $C(X) \backslash S_{X}$ consists of ample classes. Let $W(X)$ be the subgroup of $O\left(S_{X}\right)$ generated by reflections defined by

Note that the action of $W(X)$ on $S_{X}$ can be extended to $H^{2}(X ; Z)$ acting trivially on $T_{X}$ because $r 2 S_{X}=T_{X}$. The Kähler cone $C(X)$ is a fundamental domain of the action of $W(X)$ on $P(X)^{+}$.

## 5. Automorphisms

We use the same notation as in $\times 3$, 4. In this section we study the covering involution of $x$ over $P^{2}$ and the automorphism of $X$ of order 5.

### 5.1. The automorphism of order 2.

5.2. Lemma. Let $=$. Then the invariant sublattice $M=H^{2}(X ; Z)^{<}$is generated by $\mathrm{E}_{\mathrm{i}}$ (0 i 5):

Proof. Note that $M$ is a 2-elementary lattice, that is, its discriminant group $A_{M}=M=M$ is a finite 2-elementary abelian group. Let $r$ be the rank of $M$ and let lbe the number of minimal generator of $A_{M}=(Z=2 Z)^{1}$. The set of fixed points of is the union of $C$ and $E_{0}$. It follows from Nikulin [N3], Theorem 4.2.2 that $\left(\begin{array}{lll}22 & \mathrm{r} & \mathrm{l}\end{array}\right)=2=\mathrm{g}(\mathrm{C})=6$ and the number of components of fixed points set of other than $C$ is $(r \quad l)=2=1$. Hence $r=6 ; 1=4$. On the other hand we can easily see that $\mathrm{fE} \mathrm{i}_{\mathrm{i}}: 0 \quad \mathrm{i} \quad 5 \mathrm{~g}$ generates a sublattice of M with rank 6 and discriminant $2^{4}$. Now the assertion follows.
5.3. Lemma. Let N be the orthogonal complement of $\mathrm{M}=\mathrm{H}^{2}(\mathrm{X} ; \mathrm{Z})^{<>}$in S . Then N is generated by the classes of $\mathrm{F}_{\mathrm{i}} \quad \mathrm{G}_{\mathrm{i}}\left(\begin{array}{lll}1 & \mathrm{i} & 5\end{array}\right)$ and contains no (2)-vectors.

Proof. Since $\left(\mathrm{F}_{\mathrm{i}}\right)=\mathrm{G}_{\mathrm{i}}$, the classes of $\mathrm{F}_{\mathrm{i}} \quad \mathrm{G}_{\mathrm{i}}$ are contained in N. A direct calculation shows that

whose discriminant is $2^{4} \quad$ On the other hand, $N$ is the orthogonal complement of $M$ in $S$, and M (resp. S) has the discriminant $2^{4}$ (resp. $5^{3}$ ). 6.4. Remark. The hermitian form $h$ in (6.1) coincides with the one of Shimura [S], Yamazaki and Yoshida [YY]. This and the isomorphism (6.2) imply that our groups , ${ }^{0}$ coincide with , (1 ) in Yamazaki and Yoshida [YY].
6.5. Proposition. (1) is generated by reflections $\mathrm{R}_{\mathrm{a}}$ with $\mathrm{h}(\mathrm{a} ; \mathrm{a})=1$ and ${ }^{0}$ is generated by $\mathrm{R}_{\mathrm{a}}^{+}$ with $\mathrm{h}(\mathrm{a} ; \mathrm{a})=1$. The quotient $={ }^{0}$ is isomorphic to $O\left(3 ; \mathrm{F}_{5}\right)^{\prime} \quad \mathrm{Z}=2 \mathrm{Z} \quad \mathrm{S}_{5}$.
(2) $\mathrm{H}={ }^{0}$ consists of 10 smooth rational curves forming 10 lines on the quintic del Pezzo surface.

Proof. The assertions follow from the above Remark 6.4 and Propositions 4.2, 4.3, 4.4 in Yamazaki and Yoshida [YY].
6.6. Discriminant quadratic forms and discriminant locus. Let

Let $A_{4}$ be a component of $T$ with a basis $e_{1} ; e_{2} ; e_{3} ; e_{4}$ as in 5.8 Then $\left(e_{1}+2 e_{2}+3 e_{3}+4 e_{4}\right)=5=$ $\left(e_{1} 2\left(e_{1}\right)+3^{2}\left(e_{1}\right)+4^{3}\left(e_{1}\right)\right)=4 \bmod T$ is a vector in $A_{T}$ with norm $4=5$. It follows from Proposition 6.5 that $={ }^{0}$ acts transitively on the set of ( $4=5$ )-vectors in $A_{T}$. Hence for each $2 A_{T}$ with $q_{I}()=4=5$ there exists a vector $r 2 \mathrm{~T}$ with $\mathrm{r}^{2}=2$ satisfying $=\left(r+2(r)+3^{2}(r)+\right.$ $\left.4^{3}(r)\right)=5$. Moreover defines

### 6.7. Lemma. The restriction map $\sim$ ! is surjective.

Proof. We use the same notation as in 3.2 The symmetry group $\mathrm{S}_{5}$ of degree 5 naturally acts on the set $\mathrm{EE}_{1} ;::: ; \mathrm{E}_{5} \mathrm{~g}$ as permutations. This action can be extended to the one on S . Together with the action of , the natural map

Then it follows from Nikulin [N1], Proposition 1.6.1 that the isometry $\left(g^{0} ; g\right)$ of $S \quad T$ can be extended to an isometry in ${ }^{\sim}$ which is the desired one.

The group $S_{5}$ naturally acts on $P_{1}^{5}$ which induces an action on $S$ as permutations of $E_{1} ;::: ; \mathrm{E}_{5}$. On the other hand, $S_{5}=f \quad 1 \mathrm{~g} \quad{ }^{0}$ naturally acts on $B={ }^{0}$. Under the natural isomorphism $O\left(q_{s}\right)=$ $O\left(q_{T}\right)=f \quad 1 g \quad S$, $p$ is equivariant under these actions of $S_{5}$.

It is known that the quotient $B={ }^{0}$ is compact (see Shimura [S]). We remark that cusps of $B$ correspond to totally isotropic sublattices of T invariant under. Hence the compactness also follows from Lemma 5.10
6.10. Main theorem. The period map p can be extended to an $\mathrm{S}_{5}$-equivariant isomorphism

Proof. Let M be the space of all 5 stable points on $\mathrm{P}^{1}$ and $\mathrm{M}{ }_{o}$ the space of all distinct 5 points on $\mathrm{P}^{1}$. We can easily see that $M \mathrm{nM}$ ois locally contained in a divisor with normal crossing. By construction, p is locally liftable to B. It now follows from a theorem of Borel [Borel] that p can be extended to a holomorphic map from $M$ to $B={ }^{0}$ which induces a holomorphic map $p$ from $P_{1}^{5}$ to $B={ }^{0}$. Next we shall show the injectivity of the period map over $(B \cap H)={ }^{0}$. Let $C ; C^{0}$ be two plane quintic curves as in 3.1. Let ( X ; ) (resp. $\left(\mathrm{X}^{0} ;{ }^{9}\right)$ ) be the associated marked K 3 surfaces with automorphisms ; (resp. ${ }^{0} ; 9$. Assume that the periods of $(X ;)$ and $\left(X^{0} ;{ }^{0}\right)$ coincide in $B={ }^{0}$. Then there exists an isometry

preserving the periods and satisfying ${ }^{\prime} \quad\left({ }^{\circ}\right)=\quad$ and ${ }^{\prime} \quad\left({ }^{0}\right)=\quad$ (Lemma.7). It follows from Lemma 5.5 that ' preserves the Kähler cones. The Torelli theorem for K 3 surfaces implies that there exists an isomorphism $\mathrm{f}: \mathrm{X}!\mathrm{X}^{0}$ with $\mathrm{f}={ }^{\prime}$. Then f induces an isomorphism between the corresponding plane quintic curves $C$ and $C^{0}$. Thus we have proved the injectivity of the period map.

Since both $P_{1}^{5}$ and $B={ }^{0}$ are compact, P is surjective. Recall that both $P_{1}^{5} n\left(P_{1}^{5}\right)^{0}$ and $H={ }^{0}$ consist of 10 smooth rational curves. The surjectivity of $\beta$ implies that no components of $P_{1}^{5} n\left(P_{1}^{5}\right)^{0}$ contract to a point. Now the Zariski main theorem implies that p is isomorphic. By construction, p is $\mathrm{S}_{5^{-}}$ equivariant over the Zariski open set $\left(P_{1}^{5}\right)^{0}$. Hence $\beta$ is $S_{5}$-equivariant isomorphism between $P_{1}^{5}$ and $B=0$.

## 7. Shimura-Terada-Deligne-Mostow's reflection groups

The plane quintic curve C defined by (3.1) appeared in the papers of Shimura [S], Terada [Te], Deligne-Mostow [DM], and the moduli space of these curves has a complex ball uniformization. As we remarked, the hermitian form (6.1) coincides with those of Shimura [ $\bar{S}]$, Terada [Te], DeligneMostow [DM] (see Remark 6.4). This implies
7.1. Theorem. The arithmetic subgroup is the one appeared in Deligne-Mostow's list [ DM$]$ :

A geometric meaning of this theorem is as follows. Recall that X has an isotrivial pencil of curves of genus two whose general member is the smooth curve $D$ of genus two with an automorphism of order 5 given by the equation (3.3). The x is given by

Then over $C, v^{5}=f_{5}\left(x_{1} ; x_{2}\right)$ and hence the pencil is given by

s^{2}=x_{0}\left(x_{0}^{5}+v^{5}\right)
$$

which is nothing but the equation of the curve $D$. Thus the $K 3$ surface $X$ is birational to the quotient of C D by an diagonal action of $Z=5 Z$. This correspondence gives a relation between the Hodge structures of $C$ and $X$.

These functions generate a $(d+1)$-dimensional vector space which is invariant under monodromy. Let ${ }_{(i)}$ ) be the image of ${ }_{1}(M)$ in PGL $(d+1 ; C)$ under the monodromy action. In Deligne-Mostow [DM] and Mostow [M0], they gave a sufficient condition for which ${ }_{(i)}$ is a lattice in the projective unitary group $P U(d ; 1)$, that is, ${ }_{(i)}$ is discrete and of finite covolume, and gave a list of such ( $\left.i_{i}\right)$ (see [Th] for the correction of their list).

Denote $i={ }_{i}=D$ where $D$ is the common denominator. As remarked in Theorem7.1 in the case $D=5, \quad\left(_{i}\right)$ is related to $K 3$ surfaces. In case of $D=3 ; 4$ or $6, \quad\left(_{i}\right)$ is also related to $K 3$ surfaces (see [K2], [K3], [DGK]). In these cases, the corresponding K 3 surfaces have an isotrivial elliptic fibration whose general fiber is an elliptic curve with an automorphism of order 4 or 6.

For the remaining arithmetic subgroups ${ }_{\left({ }_{\mathrm{i}}\right)}$ with $\mathrm{D}>6$ in the Deligne-Mostow's list, are they related to K 3 surfaces ?
