GALOIS COHOMOLOGY OF A p-ADIC FIELD VIA (;)-MODULES IN THE IMPERFECT RESIDUE FIELD CASE

KAZUMA MORITA

Abstract. For a p-adic local eld K with perfect residue eld, L.Herr constructed a complex which computes the Galois cohomology of a p-torsion representation of the absolute Galois group of K by using the theory of (;) modules. We shall generalize his work to the imperfect residue eld (the residue eld has a nite p-basis) case.

1. Introduction

In this article, K denotes a complete discrete valuation eld of characteristic 0 with residue eld k of characteristic p>0 such that $[k:k^p]=p^n<1$. A ssume that K contains a primitive p-th root of unity if $p\in 2$ and a primitive 4-th root of unity if p=2. Choose an algebraic closure K of K and put $G_K=G$ along By a p-torsion G_K —representation, we mean a Z_p -module of nite length endowed with a continuous action of G_K . Let R ep $_p$ torsion G_K —representations. Let V be a p-torsion G_K —representation. In the case n=0 (i.e. k is a perfect eld), Herr [H1] obtained a presentation of the G alois cohomology H $(G_K;V)$ in terms of the (;K)-module D (V) associated to V in the sense of Fontaine [F].

Now, let n be arbitrary. The purpose of this paper is to give a presentation of H $(G_K;V)$ in terms of the (; K)-module (de ned in this paper) associated to V (Theorem 1:1). Our K is non-commutative if n 1.

Fix a lifting $(b_1)_1$ in of a p-basis of k in O_K (the ring of integers of K), and for each m 1 and 1 in, xap throot $b_1^{1=p^m}$ of b_1 in \overline{K} satisfying $(b_1^{1=p^m+1})^p = b_1^{1=p^m}$. the cyclotom ic character : $_{K} \circ !$ Z $_{p}$ and $_{K}$ is isom orphic to the sem i-direct product $_{K} \circ n$ Z $_{p}^{\ n}$ where $_{K} \circ$ acts on Z $_{p}^{\ n}$ via (see Section 3). The group $_{K}$ is non-commutative if n 1. Since $K^{\ 0}$ has perfect residue eld which we denote $k^{\ 0} = k^{\ p}^{\ 1}$, we can apply the theory of Fontaine [F] to obtain the (; $_{K} \circ$)-m odule D (V) for a p-torsion G_{K} -representation V. Then, D (V) is equipped with a Frobenius operator : D (V) ! D (V) and also with a continuous action of $_{K}$ (not only $_{K} \circ$) which commutes with . With these actions, D (V) becomes an object of the category M $_{A_{K}; K}^{\text{et,p-tor}}$ of torsion etale (; $_{K}$)-m odules which we will de ne (see Section 2) by in itating the denition of the category of torsion etale (; $_{K} \circ$)-m odules by Fontaine ([F], p273, 3.3.2). Then, we shall obtain an equivalence of categories between

 and $Met,p-tor_{A_K;K}$

which is a generalization of the equivalence of Fontaine (F], p274, 3.4.3) to the imperfect residue eld case (for details, see Theorem 2:7 in Section 2). By using this D (V), we will construct a complex C ; $_{\rm K}$ (D (V)) in Section 3. Our main result is the following.

Theorem 1.1. W ith notations as above, the group H $^{\rm i}$ (G $_{\rm K}$;V) is canonically isomorphic to the i-th cohomology group of the complex C $_{\rm i-K}$ (D (V)) for all i. This isomorphism is functorial in V .

Our proof of the main theorem is a little dierent from the method of Herr. In the case n=0, he considered an \e aceable" property of the complex C; (D (V)), whereas our method is to construct a free resolution of the $Z_p[[K]]$ -module Z_p .

This paper is organized as follows. In Section 2, we shall review the theory of (;)-modules, which is due to J.M . Fontaine [F] in the perfect residue eld case. We shall construct a theory of (;)-modules in the imperfect residue eld case (F.Andreatta [A] constructs a more general and ner theory of (;)-modules). In Section 3, for M 2 M $_{A_K\,;_K}^{\rm et,p-tor}$, we shall construct the complexes C $_{K}$ (M) and C $_{K}$ (M) which are to be used in the main theorem . In Section 4, we shall construct a free resolution of Z $_{\rm p}$ in the category of left Z $_{\rm p}$ [[$_{\rm K}$]]-modules. In Section 5, we shall prove that the cohom ology group of C $_{K}$ (D (V)) coincides with the Galois cohom ology H $_{K}$ (G $_{K}$; V).

2. The theory of (;)-modules

Let k^0 denote the perfect residue eld of K 0 as in Section 1. Put F (k^0) = W (k^0) [p 1] where W (k^0) denotes the ring of W itt vectors with coe cients in k^0 . Now, we apply the theory of (;)-m odules of Fontaine to K 0 . Since K $^{(0)}$ is a Henselian discrete valuation eld, we have an isom orphism $G_{K^0} = Gal(K^0 - K^0)$, $G_{K^0} = Gal(K^0 - K^0)$, W ith this isom orphism, we identify G_{K^0} with a subgroup of G_{K^0} . We have a bijective map from the set of nite extensions of K $^{(0)}$ contained in K^0 de ned by

L! LK $^{\rm 0}.$ Furtherm ore, LK $^{\rm 0}$ is the p-adic completion of L. Hence, we have an isomorphism of rings

where $O_{\overline{K}}$ and $O_{\overline{K}^{0}}$ denote the rings of integers of \overline{K} and \overline{K}^{0} . Thus, the p-adic completion of \overline{K} is isomorphic to the p-adic completion of \overline{K}^{0} , which we will write C_{p} . Put

For two elements $x=(x^{(i)})$ and $y=(y^{(i)})$ of \hat{E} , de ne their sum and product by $(x+y)^{(i)}=\lim_{j!\ 1}\ (x^{(i+j)}+y^{(i+j)})^{p^j}$ and $(xy)^{(i)}=x^{(i)}y^{(i)}$. Let $=(^{(i)})$ denote an element of \hat{E} such that $^{(0)}=1$ and $^{(1)}$ \in 1. Then, \hat{E} is a eld of characteristic p>0 (\hat{E}^+ is a subring of \hat{E}) and is the completion of an algebraic closure of $k^0((-1))$ for the valuation dened by $v_E(x)=v_p(x^{(0)})$ where v_p denotes the p-adic valuation of C_p normalized by $v_p(p)=1$.

Example 2.1. With this valuation, we have

The eld E is equipped with an action of a Frobenius and a continuous action of the G alois group G_K with respect to the topology denned by the valuation v_E . Put $E_{F(k^0)} = k^0((1))$ and de ne E to be the separable closure of $E_{F(k^0)}$ in $\hat{\mathbf{E}}$. Dene H $_{\mathrm{K}}$ = Gal $(\overline{\mathrm{K}}^{0}=\mathrm{K}_{1}^{0})$ which is isomorphic to the subgroup $\mathrm{G}_{\mathrm{K}_{1}^{(0)}}$ = $Gal(K = K_1^{(0)}) of G_K$. From now on, we identify H_K with $G_{K_1^{(0)}}$. If we put $E_K =$ $E^{\,H_{\,K}}\,$ and de ne G $_{E_{\,K}}\,$ to be the G alois group of E=E $_{K}$, the action of G $_{K}\,\circ\,$ on E induces the canonical isom orphism H $_{\rm K}$ ' G $_{\rm E_{\rm K}}$ by the theory of the $\,$ eld of norm s (FW], [W]). Let denote [] 1. Put A = W (E) (E is a perfect eld) and $\Re^+ = W (\Re^+)$. The ring \Re is endowed with the topology whose fundamental system of the neighborhoods of 0 has the form ${}^{k}\mathbf{\hat{R}}^{+} + p^{n+1}\mathbf{\hat{R}}$ for k; n 2 N. This topology coincides with the product topology de ned by the application \Re ! $\mathbb{R}^{\mathbb{N}}$:x 7 (x_k)_{k2N}. The continuous action of G_K on \mathbb{R} induces the continuous action of G_K on \Re which commutes with the Frobenius . Let $A_{F(k^0)}$ be the padic completion of $W(k^0)$ [[]][1] contained in R. This ring is a complete discrete valuation ring with the residue eld $E_{F(k^0)}$. Let A be the p-adic completion of the maximalunramied extension of $A_{F(k^0)}$ in R which has the residue eld E. The ring A is equipped with an action of the Galois group G_K and of the Frobenius induced from those of \hat{E} . Put $A_K = A^{H_K}$.

For all V 2 R ep $_{p}$ tor (G $_{K}$ 0), we can associate the (; $_{K}$ 0)-m odule over A $_{K}$

It is equipped with the residual action of $_{K} \circ '$ $G_{K} \circ = H_{K}$ and the Frobenius $_{D} (V)$ induced by that on A. The module D (V) is a torsion etale (; $_{K} \circ)$ -module over A_{K} (F], p274, 3.4.2).

Let $M_{A_K; K^0}^{\text{et,p-tor}}$ denote the category of torsion etale (; K^0)-modules in the sense of Fontaine (F], p273, 3.3.2). By the two constructions above, Fontaine proved the following (F], p274, 3.4.3).

Remark 2.4. Put $A_K^+ = A_K \setminus \Re^+$. If we xalifting T_K of the prime element of E_K in A_K^+ , we have $A_K^+ = W$ (K^0) [[T_K]]. Let M be a nitely generated $A_K = p^n - m$ odule. Fix a nitely generated sub- $A_K^+ = p^n - m$ odule M of M such that M is generated by M over $A_K = p^n$. The module M is endowed with the topology such that the family of submodules $\{T_K^m M^0\}_{m=1}$ is a fundamental system of neighborhoods of 0. This topology is independent of the choice of M of Furthermore, since $A_K = p^n$ is Noetherian and complete for the T_K -adic topology, $T_K^{-N} M^0$ is complete for the T_K -adic topology. We may use the family of submodules $\{T_K^m M^0\}_{m=1}$ instead of $\{T_K^m M^0\}_{m=1}$ to denote the same topology.

Consider a p-torsion G_K -representation V 2 R ep $_p$ tor (G_K) and D (V). Since the Galois group G_K acts on A $_{Z_p}$ V and we have D (V) = (A $_{Z_p}$ $V)^{H_K}$, the quotient $_K$ G_K = H_K and act on D (V) commuting with each other. This

means that D (V) becomes an object of M $_{A_K}^{et,p\text{-tor}}$. The continuous action of G_K on A $_{Z_p}$ V induces the continuous action of $_K$ on D (V) as follows. Let L be a nite Galois extension of K contained in K such that the action of $G_L = Gal(K = L)$ on V is trivial. Fix n 2 N such that $p^nV = 0$. Then, we have D (V) = $(A_L = p^n - Z_p, V)^{H_K}$. The following two topologies of D (V) coincide

R em ark 2.5. Let L be a nite G alois extension of K contained in \overline{K} . Let M be a nitely generated $A_L = p^n - m$ odule endowed with a continuous and sem i-linear action of G al($K_1^{(0)}L = K$). Fix M 0 as in Rem ark 2.4. Let M 1 be the sub- $A_L^+ = p^n - m$ odule of M generated by g (M 0) (g 2 G al($K_1^{(0)}L = K$)). Since G al($K_1^{(0)}L = K$) is compact, M 1 is also a nitely generated sub- $A_L^+ = p^n - m$ odule. By construction, M 1 is stable under the action of G al($K_1^{(0)}L = K$). Then, for N; m 2 N, NM $^1 = ^m M^1$ becomes a discrete Z_p [[G al($K_1^{(0)}L = K$)]]-m odule. Since NM 1 is complete for the -adic topology, NM 1 has the structure of Z_p [[G al($K_1^{(0)}L = K$)]]-m odule. Thus, M is equipped with the structure of Z_p [[G al($K_1^{(0)}L = K$)]]-m odule. For another sub- $A_L^+ = p^n$ -m odule M 2 of M stable under the action of G al($K_1^{(0)}L = K$) such that M is generated by M 2 over $A_L = p^n$, we cannot integers N $_1$ N $_2$ such that N $_1M$ M $_2M$ N $_2M$ N, therefore, the structure of Z_p [[G al($K_1^{(0)}L = K$)]]-m odule on M is independent of the choice of M $_1M$. With this, the action of $_K$ on D (V) naturally extends to the action of Z_p [[$_K$]].

Remark 2.6. Let L be a nite Galois extension of K contained in \overline{K} such that the action of G_L on V is trivial. Fix n 2 N such that $p^nV=0$. For a nite Galois extension of K such that L L 0 \overline{K} , A_{L^0} $_{Z_p}$ V is a nitely generated $A_{L^0}=p^n$ -m odule endowed with a continuous and sem i-linear action of Gal($K_1^{(0)}L^0=K$). Remark 2.5 says that the action of Gal($K_1^{(0)}L^0=K$) on A_{L^0} $_{Z_p}V$ naturally extends to the action of Z_p [[Gal($K_1^{(0)}L^0=K$)]]. Thus, the action of G_K on $A_{Z_p}V=\lim_{L^0}(A_{L^0}Z_pV)$ naturally extends to the action of Z_p [[G_K]]. Then, the canonical injection D (V)! $A_{Z_p}V$ is compatible with the action of Z_p [[G_K]]. (Proof: Let L, M 0 , M 0 be as in the proof of the coincidence of the two topologies of D (V) before Remark 2.5. We can assume that M 0 is endowed

with a continuous and sem i-linear action of $_{\rm K}$ (see Remark 2.5). Since the morphism $A_{\rm K}^+ = p^n ! 

Now, we shall give the proof of Proposition 5.4. Note that, since A $_{\rm Z_p}$ V becomes an object of E $_{\rm G_{\,K}\,;H_{\,K}}$ (see Remark 2.6), we have an exact sequence

On the other hand, we have isom orphisms of G_{E_K} (' H_K)-modules $A_{Z_p}V$ ' $A_{A_K}D(V)$ ' $A_{j=1}^dA=p^{m_j}A$. Thus, it success to show $H^i(G_{E_K};A=p^mA)=0$ for all i>0: This is clear for m=1 ($H^i(G_{E_K};E)=0$ for all i>0) and the general case can be deduced by induction on the integer m. Thus, by using P roposition 5.11, we obtain isom orphisms in D^+ (-M od) from the exact sequence above
