# DETECTING THE ORIENTATION OF LONG LINKS BY FINITE TYPE INVARIANTS

#### SN DUZHIN, M N KAREV

Abstract. We prove the existence of a degree 7 Vassiliev invariant of long (or string) two-component links which is not preserved under the simultaneous change of orientation of both components. The non-invertibility of this invariant can be detected by the standard weight system with values in the tensor square of the universal enveloping algebra for gl(n).

### 1. Introduction


It is well known that classical knot polynom ials and quantum invariants in general take equal values on a knot and its inverse. The class of Vassiliev invariants is strictly wider [Vog], and the problem whether they can be used to tell a knot from its inverse is open and seem ingly dicult. In this paper, we discuss the corresponding problem for links with more than 1 component.

Let  $S_p^1$  be the disjoint union of p numbered copies of an oriented circle,  $R_p^1$  the disjoint union of p numbered copies of an oriented real line, and  $I_p^1$  the disjoint union of p numbered copies of an oriented interval [0;1].


De nition. An p-component closed link is a smooth embedding of  $S_p^1$  into oriented 3-space  $R^3$ , considered up to a component-preserving isotopy.

An p-component long link is a smooth embedding of  $R_p^1$  into oriented 3-space  $R^3$  with xed behavior at in nity:  $x_i(t) = [i;0;t]$  for t > C, considered up to an isotopy, xed at in nity, and a Euclidean movement of space.


An p-com ponent string link is a sm ooth em bedding of  $I_p^1$  into the slice  $R^2$  [0;1]  $R^3$  with xed endpoints:  $x_i(t) = [i;0;t]$  for t = 0;1, considered up to an isotopy, xed at the boundary, and a Euclidean m ovem ent of the slice.



A closed link

It is immediately clear that the theories of long and string links are equivalent. In the case of knots (p = 1) they are also equivalent to the theory of closed links; this is not true when p > 1.

The problem of invertibility is stated as follows. Given a link L, let  $L^0$  be the same link with the orientation of all components reversed. May it happen that  $L^0$  is not equivalent to L? If yes, then what invariants can be used to detect that dierence?

For knots, the problem was standing for a long time, until Trotter [Tro] proved in 1964 that some knots (e.g. pretzel knot with parameters (3;5;7)) are non-invertible. The simplest non-invertible knot is  $8_{17}$  ([Ka]). However, it is not known if the two knots  $8_{17}$  and  $8_{17}^0$ , or any other pair of mutually inverse knots, can be distinguished by nite type invariants.

In the case of links, the only published result is a theorem of X.-S.Lin [L2] that asserts the non-invertibility of Vassiliev invariants for closed links with at least 6 components. Other papers containing the words links, Vassiliev invariants, invertibility ('separation', 'detection' etc) in their titles/abstracts have smaller relevance to the plain problem we are speaking about, e.g. D Bar-N atan [BN2] studies hom otopy string links invariants, X.-S.Lin [L1] uses a modil ed de nition of nite type invariants, etc.

The present text deals with the problem of detecting the orientation by nite type invariants for long links. The reform ulation of the problem in term softhord diagram s shows im mediately that the answer is positive for p > 2. In the case of 2-component links (p = 2) the problem is nontrivial; below, we give a proof of the following

Theorem . There exists a Vassiliev invariant f of order no greater than 7 and a 2-component long link L such that f (L)  $\bullet$  f (L).

We will give two proofs of this theorem, both based on direct calculations. The rst proof (Proposition 1, page 5) uses chord diagram s and requires computer calculations. The second one (Proposition 2, page 8) uses Jacobi diagram s and can be done by hand. Frankly speaking, both of these proofs refer to the invariants of framed links. In Section 6 we explain why they also imply the same result in the unframed case.

#### 2. Reduction to chord diagrams

Finite type invariants for various types of links are de ned in the same way as they are in the classical case of closed knots, see [BN1, Sta].


Let F be a eld of characteristic 0, e.g. Q or C. D enote by  $V_n$  (p) the vector space of F-valued V assiliev invariants for p-com ponent long links of degree no greater than n, by  $A_n$  (p) the space spanned by chord diagram s of degree n on p strings m odulo 4-term relations, and by  $W_n$  (p) =  $A_n$  (p) = H om  $_Q$  ( $A_n$  (p); F) the corresponding space of weight system s. Then there is a linear map  $_n^p:V_n$  (p)!  $W_n$  (p) (taking the symbol of a V assiliev invariant) whose kernel coincides with  $V_n$  (p) and whose in age consists of all weight systems that vanish on chord diagrams with isolated chords. For framed links, the in age equals the entire  $W_n$  (p), and, until Section 6, we will actually be speaking about invariants of framed links.

As before, we denote by  $L^0$  the inverse of a link L. Setting  $_V$  (f) (L) = f ( $L^0$ ) for f 2 V, we obtain an involution  $_V$  in the space of V assiliev invariants. On the level of chord diagram s, the corresponding operation  $_A$  acts as follows:

i.e. it changes the orientation of all the strings of a chord diagram, or, which is the same thing, rejects the plane picture of the diagram in a horizontal line, assuming that the support is drawn vertically (and preserves its orientation).


Instead of usual chord diagrams only, the same space A (p) may be spanned by all generalized chord diagrams (Chinese character diagrams in the term inology of [BN1]), i.e. 1-3-valent graphs, attached to the same support ( $R_p^1$ ) with a cyclic order of edges specied in every 3-valent vertex.

Generalized chord diagram s can be understood as linear combinations of ordinary chord diagram s by iterative applications of the STU rule, e.g.



(here and below, we use the blackboard convention: edges around trivalent vertices for every diagram drawn on paper are always ordered counterclockwise).

For generalized diagram s, one should be more cautious with the denition of the involution  $_{\rm A}$ . In fact, extending the previously dened map  $_{\rm A}$  from chord diagram s to generalized diagram s by STU relations, one arrives at the following rule:



i.e. one must either change the orientation of all strings and multiply the result by 1 depending on the parity of the number of trivalent vertices, or, again, simply reect the plane picture of the diagram in a horizontal line.

Lem m a 1. The involution  $_{\rm A}$  is the graded part of the involution  $_{\rm V}$  , i.e. the following square com m utes:



Proof. This follows im mediately from the de nition of (EN1, CD).

The problem of detecting the inversion of orientation on long links by nite type invariants is thus equivalent to the problem: nd a chord diagram on p lines which is dierent from its inverse modulo 4T relations. If p 3, then there is a straightforward example:




For n=2 the problem is non-trivial, because, as one can check, chord diagram s of small degrees (like the one depicted on page 2) are all  $_{\rm A}$ -invariant. In the next section, we indicate a diagram which is not.

## 3. First proof of the theorem

To prove that a certain element of the space A (p) is non-zero, one can use weight system s, i.e. linear functionals on these spaces. A powerful weight system is provided by K ontsevich's hom om orphism  $'='_g:A$  (p)! U (g)  $^p$  for a metrized Lie algebra g (see [K on, CD]). In fact, ' takes values in the g-invariant subalgebra U (p) = [U (g)  $^p$ ]. We give an explicit description for the case  $g=gl_N$ , using the basis  $e_{ij}$  (matrix with one 1 and many 0's) and the metric dened by the conjugacy rule  $e_{ij}=e_{ji}$ .

Lem m a 2. Let D 2 A (p) be a (generalized) chord diagram on p strings. The element '(D) 2 U (gl\_N) p can be obtained as follows. Consider the alternating sum of all resolutions [BN1] of the inner triple points of the diagram D . For each resolution label the connected components of the obtained diagram by dierent independent indices; then replace each pair of adjacent indices by  $e_{ij}$  and take the sum over all indices from 1 to N . (C beed components, if any, turn into factors N .)

The proof repeats the proof for the particular case p = 1 that can be found in BN1,CD. We give an example instead:



Therefore, the image of this diagram under ' is

Note that the order of the factors  $e_{ij}$  agrees with the orientation of each component of the support, but the order of the two subscripts (i;j) in each factor follows a go-round pattern, in our case bottom to-top for the left line and top-to-bottom for the right line.

Denote by  $_{\rm U}$  the operator in U (gl $_{\rm N}$ )  $^{\rm p}$  that rewrites each monom ial backwards and changes the order of the two subscripts in each generator  $e_{ij}$ , e.g.  $_{\rm U}$  ( $e_{12}e_{23}$   $e_{13}e_{24}$ ) =  $e_{32}e_{21}$   $e_{42}e_{31}$ . This is an involution that preserves the ad-invariant subspace U (p) =  $[U(gl_{\rm N}))^{\rm p}]^{\rm p}$ .


The construction of 'shows that the following assertion holds.

Lem m a 3. The square

is com m utative.

It follows that the non-invertibility of a chord diagram can be checked on the level of the universal enveloping algebra: if the '-im age of a diagram is not  $_{\rm U}$ -invariant, then the diagram itself is not invariant under  $_{\rm A}$ . Therefore, the next proposition gives the  $\,$  rst proof of our Theorem .

Proposition 1. Each of the following diagrams is dierent from its image under the involution  $_{\rm A}$ :



Proof. A direct computer calculation of the '-im ages of each diagram and its inverse shows that they are different for the Lie algebra gl (and hence for any gl, with n-4). The calculations are organized as follows: we -x a lexicographical ordering of the basic elements  $e_{ij}$  and transform the expression for '(D) obtained by the above algorithm using the commutator relations between the generators in order to rewrite each monomial lexicographically. The programs, input and output less are available at [Calc]. The result for the left-hand side diagram, for example, is a polynomial consisting of 58378 terms; its calculation requires several hours on a reasonably fast modern PC.

## 4. Reduction to Jacobidiagrams

A nother, yet simpler, reformulation of the invertibility problem, can be given in terms of colored Jacobi diagrams. A colored Jacobi diagram is the same thing as a Chinese character as de ned in  $\{1,1\}$ , only its univalent vertices are labeled by p colors. The space of colored Jacobi diagrams B (p) is de ned as a vector space formally generated by all p-colored Jacobi diagrams modulo two kinds of relations: antisymmetry and IH X.

Similarly to Theorem 8 of [BN1], one can prove that there is a symmetrization map: B(p)! A(p) which provides a linear isomorphism between the two spaces (see also [LM]).

The map is de ned as follows | we explain that in the case p = 2. Let D be a Jacobi diagram with k 'legs' of color 1 and 1 'legs' of color 2, then (D) is the average of all the k!!! ways to attach 1-colored legs to the support and 2-colored legs to the second line of the support, e.g.

Colored Jacobi diagram s can thus be viewed as symmetric elements of the space A (p), much in the same way as commutative polynomials over a Lie algebra g can be viewed as symmetric elements of the universal enveloping algebra U (g), by virtue of the PBW theorem.

The isom orphism is very important for our needs because the involution  $_{\rm A}$  takes an especially simple form when transferred to B (p) via this isom orphism. In fact, the following assertion holds:

Lem m a 4. Let  $_{\rm B}$  :B (p) ! B (p) be the linear operator de ned as identity on each Jacobi diagram with an even number of legs and as multiplication by 1 on each

Jacobi diagram with an odd number of legs. Then the square

Proof. The proofsm oothly follows from the de  $\,$ nitions of both  $_{A}$  and  $_{B}$  given above. A simple illustration m ight be helpful to understand how it goes. Let

The problem of nite type invertibility for 2-component long links can now be restated as follows: is there a non-zero 2-colored Jacobi diagram with an odd number of legs?. In the next section, we give an example of such a diagram.

## 5. Second proof of the theorem

Take a metrized Lie algebra g and denote by S (g) the symmetric algebra of the vector space g. The weight system B (1) ! S (g) described in [BN1, CD] has an immediate generalization to an arbitrary value of p giving a homomorphism : B (p) ! S (g) p whose image lies in the g-invariant subalgebra S (p) =  $[S (g)]^p$ .

Lem m a 5. The mapping ts into a commutative diagram

where is the isom orphism de ned in the previous section, ' is the K ontsevich weight system for the algebra A (p), and is the Poincare-Birkho -W itt isom orphism raised to the n-th tensor power.

Proof. The proof is straightforward, just like in the conventional case p = 1.

For the Lie algebra  $g=gl_N$  there is a pictorial algorithm for the calculation of , sim ilar to the procedure for 'described in section 3. The only dierence is that now the basic elements  $e_{ij}$  are commutative, so we do not have to bother about the order of factors in the monomials. Here is a simple example:

A big advantage that the mapping has over ' is that the g-invariant part of  $S(gl_N)^p$  has a rather transparent structure. A p-colored necklace of order n is a combinatorial object dened as a sequence of n numbers between 1 and p, considered up to cyclic shifts; it can be best viewed as a circular arrangement of n p-colored beads. To every necklace one can assign an element of  $S(gl_N)^p$ , which turns out to be ad-invariant, as follows. Sprinkle dierent indices over the arcs of the necklace; every bead transforms into  $e_{ij}$  where i is the index written on the incoming arc and j is the index of the outgoing arc; put this element  $e_{ij}$  into the tensor factor whose number is the color of the bead and take the sum over all indices from 1 to N . For example:


We denote such necklace elements by x where is the lexicographically smallest sequence corresponding to the given necklace.

Lem m a 6. For the Lie algebra  $g=gl_N$  the g-invariant part of S  $(g)^p$ , as an algebra, is generated by the necklace elements. A lgebraic relations between necklace elements of a given degree m ay exist for small values of N, but they disappear as N  $\,!\,$  1 .

Proof. Statements close to this lemma are proved in [M] and [MP]. We are sure that the fact itselfmust be written up somewhere, and we would be grateful to anybody who can give us an exact reference.

In the algebra generated by necklaces there is an involution  $_{\rm S}$  that inverts the orientation of each necklace. For p = 2, in small degrees, up to 5, it is identical; the m in in al necklace which is not xed by  $_{\rm S}$ , is  $x_{112122}$ . It turns out that the operation  $_{\rm S}$  agrees with all other inversions denoted by with various subscripts in this paper.

Lem m a 7. The involutions of the change of orientation in the spaces A (p), B (p), S (p), U (p) com m ute with the four arrows of the diagram in Lem m a (5). M ore precisely, we have a com m utative cube



(recall that  $g = g \downarrow_N$ , S  $(p) = [S (g)]^p f, U (p) = [U (g)]^p f$ ; the maps were all de ned in the text above, in particular, is the Poincare-Birkho-Witt isomorphism).

Proof. What we are really interested in is the commutativity of the top face of the cube. Since all 's, 's and 's are linear isomorphisms, this follows from the commutativity of the remaining 5 faces which was proved in various places of this paper above.

The commutativity of the upper face of the cube implies that, to prove the non-  $_{\rm B}$ -invariance of a Jacobi diagram (an element of B (p)) it is enough to prove the non-  $_{\rm S}$ -invariance of its image under in the necklace algebra. Since the minimal degree of a non-invertible necklace is 6 and we need to not a non-invertible diagram of an odd degree, the smallest example should be searched in degree 7. And, indeed, it exists | thus providing a second proof of the Theorem .

Proposition 2. The following diagram is non-zero as an element of the space B (2):

$$H = \begin{bmatrix} 1 & 2 & 2 \\ 2 & 2 & 2 \end{bmatrix}$$

Proof. A direct computation shows that the image of this diagram in the algebra S(2) (for N big enough), when expressed through necklaces, equals

which is dierent from zero. The entire expression for (H) involves 128 terms, out of which only 8 contain nonsymmetric necklaces, e.g.

The same result can also be obtained by a computer program available at [Calc].

## 6. Deframing

As we mentioned before, the proofs given in Sections 3 and 5, actually refer to the case of framed links, because the 1-term relations were not taken into consideration. In principle, detecting the orientation of a framed link is easier, because it contains an additional structure which may not be preserved by the inversion. Note that an unframed link can be considered as a framed one, so the Theorem in the unframed case is in any case stronger. Here we explain why does it hold.

Indeed, let A  $^0$ (2) be the space A (2) m odded out by 1-term relations, i.e. by the ideal generated by the diagram s  $a_1$  (with 1 chord on the rst component of the support) and  $a_2$  (with 1 chord on the second component of the support): A  $^0$ (2) = A (2)=ha<sub>1</sub>; a<sub>2</sub>i, where angular brackets denote the 2-sided ideal with given generators. The quotient algebra A  $^0$ (2) can also be considered as a subalgebra of A (2): by the structure theorem for cocommutative Hopfalgebras, A (2) is the universal enveloping algebra over its primitive subspace P, so if we take the subspace of P spanned by all connected diagrams except for a<sub>1</sub> and a<sub>2</sub>, we will obtain an inclusion A  $^0$ (2) A (2). Since the diagram s displayed in Proposition 1 belong to A  $^0$ (2), this means that non-invertibility holds for unifram ed long links, too.

Now let  $_2$ :A (2)! B (2) be the isomorphism discussed above.

Lem m a 8. The subspace  $^1$  (A  $^0$ (2)) = B  $^0$ (2) coincides with the subalgebra of B (2) generated by all connected Jacobi diagram s except  $b_1 = ^1_{---}^1$  and  $b_2 = ^2_{---}^2$ .

Proof. The assertion is non-trivial, because — does not preserve the multiplication, and the subalgebras  $A^0(2)$  and  $B^0(2)$  are described by their generators in the sense of di erent multiplications. However, a little thinking about the action of the operator shows that its value on a product of Jacobi diagrams di erent from  $a_1$  and  $a_2$ .

The  $\operatorname{lem} m$  a shows that the heptapus' element displayed in Proposition 2 belongs indeed to the subalgebra  $B^0(2)$  responsible for the Vassiliev invariants of unframed 2-component long links. Since it is non-zero, the existence of a 7 order invariant that can distinguish the orientation follows.

#### 7. Related open problems

Problem 1. Is there a -equivariant linear mapping B (1)! B (2) whose image is not a priori contained in the -invariant subspace of B (2)?


Remark. If such a mapping existed, then one could try to apply the techniques of this paper to the invertibility problem for knots. The standard doubling operator: B(1)! B(2) (as in [BN1, LM]) is no good, as one can easily see.

Problem 2. Do Vassiliev invariants detect invertibility of closed 2-component links?

Remark. The combinatorial object responsible for nite type invariants of closed links is the space of diagram s on 2 circles, call it A  $(S_2^1)$ . There is an evident epim orphism A  $(R_2^1)$ ! A  $(S_2^1)$ , but its kernel is non-trivial, so it cannot be used to de ne a K ontsevich type weight system with values in U  $^2$ .

Problem 3. Is 7 the minimal degree of Vassiliev invariants that can be used to distinguish the orientation of long links with 2 components?

Remark. The question is reduced to the existence of non-invertible diagrams of degree smaller than 7. For example, we do not know if the following diagram



is zero or not as an element of  $A_5$  (2).
