

IN VARIANT METRICS AND LAPLACIANS ON SIEGEL-JACOBI SPACE

JAE HYUN YANG

Abstract. In this paper, we compute Riemannian metrics on the Siegel-Jacobi space which are invariant under the natural action of the Jacobigroup explicitly and also provide the Laplacians of these invariant metrics. These are expressed in terms of the trace form.

1. Introduction

For a given fixed positive integer n , we let

$$H_n = \{Z \in C^{(n,n)} : jZ = {}^t Z, \operatorname{Im} Z > 0\}$$

be the Siegel upper half plane of degree n and let

$$\operatorname{Sp}(n; \mathbb{R}) = \{M \in \operatorname{GL}(2n, \mathbb{R}) : {}^t M J_n M = J_n\}$$

be the symplectic group of degree n , where

$$J_n = \begin{pmatrix} 0 & E_n \\ E_n & 0 \end{pmatrix} :$$

We see that $\operatorname{Sp}(n; \mathbb{R})$ acts on H_n transitively by

$$(1.1) \quad M \cdot Z = (AZ + B)(CZ + D)^{-1};$$

where $M = \begin{pmatrix} A & B \\ C & D \end{pmatrix} \in \operatorname{Sp}(n; \mathbb{R})$ and $Z \in H_n$:

For two positive integers n and m , we consider the Heisenberg group

$$H_R^{(n,m)} = \{(\cdot, \cdot, \cdot) \in \mathbb{R}^{(m+n)} : (\cdot, \cdot, \cdot) + {}^t (\cdot, \cdot, \cdot) \text{ symmetric}\}$$

endowed with the following multiplication law

$$(\cdot, \cdot, \cdot) \cdot (0, 0, 0) = (\cdot + 0, \cdot + 0, \cdot + 0 + t_0 - t_0) :$$

We define the semidirect product of $\operatorname{Sp}(n; \mathbb{R})$ and $H_R^{(n,m)}$

$$G^J = \operatorname{Sp}(n; \mathbb{R}) \ltimes H_R^{(n,m)}$$

endowed with the following multiplication law

$$M \cdot (\cdot, \cdot, \cdot) \cdot M^0 \cdot (0, 0, 0) = M M^0 \cdot (\cdot + 0, \cdot + 0, \cdot + 0 + t_0 - t_0) :$$

with $M \in M^0 \subset Sp(n; R)$; $(\cdot, \cdot, \cdot); (\cdot, \cdot, \cdot) \in H_R^{(n,m)}$ and $(\tilde{\cdot}, \tilde{\cdot}) = (\cdot, \cdot)M^0$. We call this group G^J the Jacobi group of degree n and index m . We have the natural action of G^J on $H_n \subset C^{(m,n)}$ defined by

$$(1.2) \quad M \cdot (\cdot, \cdot, \cdot) = (Z; W) = M \cdot (Z + W + \frac{1}{2}(CZ + D)) (CZ + D)^{-1};$$

where $M = \begin{pmatrix} A & B \\ C & D \end{pmatrix} \in Sp(n; R)$; $(\cdot, \cdot, \cdot) \in H_R^{(n,m)}$ and $(Z; W) \in H_n \subset C^{(m,n)}$: The homogeneous space $H_n \subset C^{(m,n)}$ is called the Siegel-Jacobi space of degree n and index m : We refer to [2-3], [6-7], [11], [14-21] for more details on materials related to the Siegel-Jacobi space.

For brevity, we write $H_{n,m} := H_n \subset C^{(m,n)}$: For a coordinate $(Z; W) \in H_{n,m}$ with $Z = (z) \in H_n$ and $W = (w_{kl}) \in C^{(m,n)}$; we put

$$\begin{aligned} Z &= X + iY; \quad X = (x); \quad Y = (y) \text{ real;} \\ W &= U + iV; \quad U = (u_{kl}); \quad V = (v_{kl}) \text{ real;} \\ dZ &= (dz); \quad d\bar{Z} = (d\bar{z}); \quad dY = (dy); \\ dW &= (dw_{kl}); \quad d\bar{W} = (d\bar{w}_{kl}); \quad dV = (dv_{kl}); \end{aligned}$$

$$\begin{aligned} \frac{\partial}{\partial Z} &= \frac{1+i}{2} \frac{\partial}{\partial z} ; \quad \frac{\partial}{\partial \bar{Z}} = \frac{1-i}{2} \frac{\partial}{\partial \bar{z}} ; \\ \frac{\partial}{\partial X} &= \frac{1+i}{2} \frac{\partial}{\partial x} ; \quad \frac{\partial}{\partial Y} = \frac{1-i}{2} \frac{\partial}{\partial y} ; \\ \frac{\partial}{\partial W} &= \begin{pmatrix} 0 & \frac{\partial}{\partial w_{11}} & \cdots & \frac{\partial}{\partial w_{m1}} & 1 \\ B & \vdots & \ddots & \vdots & C \\ 0 & \frac{\partial}{\partial w_{1n}} & \cdots & \frac{\partial}{\partial w_{mn}} & 1 \end{pmatrix}; \quad \frac{\partial}{\partial \bar{W}} = \begin{pmatrix} 0 & \frac{\partial}{\partial \bar{w}_{11}} & \cdots & \frac{\partial}{\partial \bar{w}_{m1}} & 1 \\ B & \vdots & \ddots & \vdots & C \\ 0 & \frac{\partial}{\partial \bar{w}_{1n}} & \cdots & \frac{\partial}{\partial \bar{w}_{mn}} & 1 \end{pmatrix}; \\ \frac{\partial}{\partial U} &= \begin{pmatrix} 0 & \frac{\partial}{\partial u_{11}} & \cdots & \frac{\partial}{\partial u_{m1}} & 1 \\ B & \vdots & \ddots & \vdots & C \\ 0 & \frac{\partial}{\partial u_{1n}} & \cdots & \frac{\partial}{\partial u_{mn}} & 1 \end{pmatrix}; \quad \frac{\partial}{\partial V} = \begin{pmatrix} 0 & \frac{\partial}{\partial v_{11}} & \cdots & \frac{\partial}{\partial v_{m1}} & 1 \\ B & \vdots & \ddots & \vdots & C \\ 0 & \frac{\partial}{\partial v_{1n}} & \cdots & \frac{\partial}{\partial v_{mn}} & 1 \end{pmatrix}; \end{aligned}$$

where δ_{ij} denotes the Kronecker delta symbol.

C. L. Siegel [12] introduced the symplectic metric ds_n^2 on H_n invariant under the action (1.1) of $Sp(n; R)$ given by

$$(1.3) \quad ds_n^2 = Y^{-1} dZ Y^{-1} d\bar{Z}$$

and H. Maaß [8] proved that the differential operator

$$(1.4) \quad n = 4 \quad Y^t Y \frac{\partial}{\partial Z} \frac{\partial}{\partial \bar{Z}}$$

is the Laplacian of H_n for the symplectic metric ds_n^2 : Here (A) denotes the trace of a square matrix A .

In this paper, for arbitrary positive integers n and m , we express the G^J -invariant metrics on $H_n \subset C^{(m,n)}$ and their Laplacians explicitly.

In fact, we prove the following theorem.

Theorem 1.1. For any two positive real numbers A and B , the following metric

$$\begin{aligned} ds_{n,m;A,B}^2 &= A Y^{-1} dZ Y^{-1} d\bar{Z} \\ &\quad + B V Y^{-1} t_V V Y^{-1} dZ Y^{-1} d\bar{Z} + Y^{-1} t_Y (dW) d\bar{W} \\ &\quad V Y^{-1} dZ Y^{-1} t_Y (d\bar{W}) \quad V Y^{-1} d\bar{Z} Y^{-1} t_Y (d\bar{W}) \end{aligned}$$

is a Riemannian metric on $H_{n,m}$ which is invariant under the action (1.2) of the Jacobi group G^J .

Theorem 1.2. For any two positive real numbers A and B , the Laplacian $\Delta_{n,m;A,B}$ of $(H_{n,m}; ds_{n,m;A,B}^2)$ is given by

$$\begin{aligned} \Delta_{n,m;A,B} &= \frac{4}{A} Y^t Y \frac{\partial}{\partial Z} \frac{\partial}{\partial \bar{Z}} + V Y^{-1} t_V t_Y \frac{\partial}{\partial W} \frac{\partial}{\partial \bar{W}} \\ &\quad + V^t Y \frac{\partial}{\partial Z} \frac{\partial}{\partial W} + t_V t_Y \frac{\partial}{\partial \bar{W}} \frac{\partial}{\partial \bar{Z}} \\ &\quad + \frac{4}{B} Y \frac{\partial}{\partial W} \frac{\partial}{\partial \bar{W}} : \end{aligned}$$

The following differential form

$$dv = (\det Y)^{(n+m+1)} [dx]^{\wedge} [dy]^{\wedge} [du]^{\wedge} [dv]$$

is a G^J -invariant volume element on $H_{n,m}$, where

$$[dx] = {}^k dx ; \quad [dy] = {}^k dy ; \quad [du] = {}_{k,l} du_{kl} \quad \text{and} \quad [dv] = {}_{k,l} dv_{kl} ;$$

The point is that the invariant metric $ds_{n,m;A,B}^2$ and its Laplacian $\Delta_{n,m;A,B}$ are expressed in terms of the trace form.

For the case $n = m = 1$ and $A = B = 1$, Berndt proved in [1] (cf. [19]) that the metric $ds_{1,1}^2$ on $H_1 C$ defined by

$$\begin{aligned} ds_{1,1}^2 &= ds_{1,1,1,1} = \frac{y+v^2}{y^3} (dx^2 + dy^2) + \frac{1}{y} (du^2 + dv^2) \\ &\quad + \frac{2v}{y^2} (dx du + dy dv) \end{aligned}$$

is a Riemannian metric on $H_1 C$ invariant under the action (1.2) of the Jacobi group and its Laplacian $\Delta_{1,1}$ is given by

$$\begin{aligned} \Delta_{1,1} &= \Delta_{1,1,1,1} = y^2 \frac{\partial^2}{\partial x^2} + \frac{\partial^2}{\partial y^2} + (y + v^2) \frac{\partial^2}{\partial u^2} + \frac{\partial^2}{\partial v^2} \\ &\quad + 2yv \frac{\partial^2}{\partial x \partial u} + \frac{\partial^2}{\partial y \partial v} : \end{aligned}$$

Notations: We denote by \mathbb{R} and \mathbb{C} the field of real numbers, and the field of complex numbers respectively. The symbol " \models " means that the expression on the right is the definition of that on the left. For two positive integers k and l , $F^{(k;l)}$ denotes the set of all $k \times l$ matrices with entries in a commutative ring F . For a square matrix $A \in F^{(k;k)}$ of degree k , (A) denotes the trace of A . For any $M \in F^{(k;l)}$, ${}^t M$ denotes the transpose matrix of M . E_n denotes the identity matrix of degree n . For $A \in F^{(k;l)}$ and $B \in F^{(k;k)}$, we set $B[A] = {}^t A B A$: For a complex matrix A , \overline{A} denotes the complex conjugate of A . For $A \in \mathbb{C}^{(k;l)}$ and $B \in \mathbb{C}^{(k;k)}$, we use the abbreviation $B f A g = {}^t \overline{A} B A$:

2. Proof of Theorem 1.1

Let $g = (M; (\cdot, \cdot, \cdot))$ be an element of G^J with $M = \begin{pmatrix} A & B \\ C & D \end{pmatrix} \in \mathrm{Sp}(n; \mathbb{R})$ and $(Z; W) \in H_{n,m}$ with $Z \in H_n$ and $W \in \mathbb{C}^{(m,n)}$: If we put $(Z; W) = g(Z; W)$; then we have

$$\begin{aligned} Z &= M \quad Z = (AZ + B)(CZ + D)^{-1}; \\ W &= (W + Z +) (CZ + D)^{-1}; \end{aligned}$$

Thus we obtain

$$(2.1) \quad dZ = dZ [(CZ + D)^{-1}] = {}^t(CZ + D)^{-1} dZ (CZ + D)^{-1}$$

and

$$(2.2) \quad dW = dW (CZ + D)^{-1} + f(W + Z +) (CZ + D)^{-1} C g dZ (CZ + D)^{-1};$$

Here we used the following facts that

$$d(CZ + D)^{-1} = (CZ + D)^{-1} C dZ (CZ + D)^{-1}$$

and that $(CZ + D)^{-1} C$ is symmetric.

We put

$$Z = X + iY; \quad W = U + iV; \quad X, Y, U, V \text{ real:}$$

From [9], p.33 or [13], p.128, we know that

$$(2.3) \quad Y = Y f(CZ + D)^{-1} g = {}^t(C\overline{Z} + D)^{-1} Y (CZ + D)^{-1};$$

First of all, we recall that the following matrices

$$\begin{aligned} t(b) &= \begin{pmatrix} E_n & b \\ 0 & E_n \end{pmatrix}; \quad b = {}^t b \text{ real;} \\ g_0(h) &= \begin{pmatrix} t_h & 0 \\ 0 & h^{-1} \end{pmatrix}; \quad h \in GL(n; \mathbb{R}); \\ J_n &= \begin{pmatrix} 0 & E_n \\ E_n & 0 \end{pmatrix} \end{aligned}$$

generate the symplectic group $\mathrm{Sp}(n; \mathbb{R})$ (cf. [4], [5]). Therefore the following elements

$t(b; ; ;)$; $g(h)$ and n of G^J defined by

$$\begin{aligned} t(b; ; ;) &= \begin{pmatrix} E_n & b \\ 0 & E_n \end{pmatrix}; \quad b = {}^t b \text{ real}; \quad (; ;) \in H_R^{(n,m)}; \\ g(h) &= \begin{pmatrix} t_h & 0 \\ 0 & h^{-1} \end{pmatrix}; \quad (0; 0; 0); \quad h \in GL(n; R); \\ n &= \begin{pmatrix} 0 & E_n \\ E_n & 0 \end{pmatrix}; \quad (0; 0; 0) \end{aligned}$$

generate the Jacobigroup G^J : So it suffices to prove the invariance of the metric $ds_{n,m; A, B}^2$ under the action of the generators $t(b; ; ;)$; $g(h)$ and n : For brevity, we write

$$\begin{aligned} (a) &= Y^{-1} dZ \ Y^{-1} d\bar{Z} ; \\ (b) &= Y^{-1} {}^t V V Y^{-1} dZ \ Y^{-1} d\bar{Z} ; \\ (c) &= Y^{-1} {}^t (dW) d\bar{W} ; \\ (d) &= V Y^{-1} dZ \ Y^{-1} {}^t (d\bar{W}) + V Y^{-1} d\bar{Z} \ Y^{-1} {}^t (dW) \end{aligned}$$

and

$$\begin{aligned} (a) &= Y^{-1} dZ \ Y^{-1} d\bar{Z} ; \\ (b) &= Y^{-1} {}^t V V Y^{-1} dZ \ Y^{-1} d\bar{Z} ; \\ (c) &= Y^{-1} {}^t (dW) d\bar{W} ; \\ (d) &= V Y^{-1} dZ \ Y^{-1} {}^t (d\bar{W}) + V Y^{-1} d\bar{Z} \ Y^{-1} {}^t (dW) \end{aligned}$$

Case I. $g = t(b; ; ;)$ with $b = {}^t b$ real and $(; ;) \in H_R^{(n,m)}$:

In this case, we have

$$Z = Z + b; \quad Y = Y; \quad W = W + Z + ; \quad V = V + Y$$

and

$$dZ = dZ; \quad dW = dW + dZ;$$

Therefore

$$\begin{aligned} (a) &= Y^{-1} dZ \ Y^{-1} d\bar{Z} = Y^{-1} dZ \ Y^{-1} d\bar{Z} = (a); \\ (b) &= Y^{-1} {}^t V V Y^{-1} dZ \ Y^{-1} d\bar{Z} + Y^{-1} {}^t V dZ \ Y^{-1} d\bar{Z} \\ &\quad + {}^t V Y^{-1} dZ \ Y^{-1} d\bar{Z} + {}^t dZ \ Y^{-1} d\bar{Z} ; \\ (c) &= Y^{-1} {}^t (dW) d\bar{W} + Y^{-1} {}^t (dW) d\bar{Z} \\ &\quad + Y^{-1} dZ {}^t d\bar{W} + Y^{-1} dZ {}^t d\bar{Z} \end{aligned}$$

and

$$\begin{aligned}
 (d) &= V Y^{-1} dZ Y^{-1 t} (\overline{dW}) & dZ Y^{-1 t} (\overline{dW}) \\
 & V Y^{-1} dZ Y^{-1} \overline{dZ}^t & dZ Y^{-1} \overline{dZ}^t \\
 & V Y^{-1} \overline{dZ} Y^{-1 t} (\overline{dW}) & \overline{dZ} Y^{-1 t} (\overline{dW}) \\
 & V Y^{-1} \overline{dZ} Y^{-1} dZ^t & \overline{dZ} Y^{-1} dZ^t :
 \end{aligned}$$

Thus we see that

$$(a) = (a) \quad \text{and} \quad (b) + (c) + (d) = (b) + (c) + (d) :$$

Hence

$$ds_{n,m;A,B}^2 = A (a) + B (b) + (c) + (d)$$

is invariant under the action of $t(B; ; ;)$:

Case II. $g = g(h)$ with $h \in GL(n; R)$:

In this case, we have

$$Z = {}^t h Z h; \quad Y = {}^t h Y h; \quad W = W h; \quad V = V h$$

and

$$dZ = {}^t h dZ h; \quad dW = dW h;$$

Therefore by an easy computation, we see that each of (a); (b); (c) and (d) is invariant under the action of all $g(h)$ with $h \in GL(n; R)$: Hence the metric $ds_{n,m;A,B}^2$ is invariant under the action of all $g(h)$ with $h \in GL(n; R)$:

Case III. $g = n = \begin{pmatrix} 0 & E_n \\ E_n & 0 \end{pmatrix}; (0; 0; 0)$:

In this case, we have

$$(2.4) \quad Z = Z^{-1} \quad \text{and} \quad W = W Z^{-1}:$$

We set

$${}_1 = \operatorname{Re} Z^{-1} \quad \text{and} \quad {}_2 = \operatorname{Im} Z^{-1}:$$

Then ${}_1$ and ${}_2$ are symmetric matrices and we have

$$(2.5) \quad Y = {}_2 \quad \text{and} \quad V = \operatorname{Im} W = V {}_1 + U {}_2:$$

It is easy to see that

$$(2.6) \quad Y = Z {}_2 \overline{Z} = \overline{Z} {}_2 Z;$$

$$(2.7) \quad {}_1 Y + {}_2 X = 0$$

and

$$(2.8) \quad {}_1 X - {}_2 Y = E_n:$$

According to (2.6) and (2.7), we obtain

$$(2.9) \quad X = (-{}_2)^{-1} {}_1 Y \quad \text{and} \quad Y^{-1} = {}_1 (-{}_2)^{-1} {}_1 - {}_2:$$

From (2.1) and (2.2), we have

$$(2.10) \quad dZ = Z^{-1} d\bar{Z} Z^{-1}$$

and

$$(2.11) \quad dW = d\bar{W} Z^{-1} W Z^{-1} dZ Z^{-1} = d\bar{W} W Z^{-1} dZ Z^{-1};$$

Therefore we have, according to (2.6) and (2.10),

$$\begin{aligned} (a) &= (-_2)^{-1} Z^{-1} dZ Z^{-1} (-_2)^{-1} \bar{Z}^{-1} d\bar{Z} \bar{Z}^{-1} \\ &= Y^{-1} dZ Y^{-1} d\bar{Z} = (a); \end{aligned}$$

According to (2.5)–(2.10), we have

$$\begin{aligned} (b) &= (-_2)^{-1} ({}_1^t V + {}_2^t U) (V^{-1} + U^{-1}) (-_2)^{-1} Z^{-1} dZ Y^{-1} d\bar{Z} \bar{Z}^{-1} \\ &= f^t U (-_2)^{-1} {}_1^t V g f U V^{-1} (-_2)^{-1} g Z^{-1} dZ Y^{-1} d\bar{Z} \bar{Z}^{-1} \\ &= f^t \bar{W} + (iE_n - (-_2)^{-1} {}_1^t V g f W V (iE_n + {}_1 (-_2)^{-1}) g \\ &\quad Z^{-1} dZ Y^{-1} d\bar{Z} \bar{Z}^{-1}; \end{aligned}$$

$$\begin{aligned} (c) &= (-_2)^{-1} Z^{-1} {}^t (dW) Z^{-1} dZ Z^{-1} {}^t W d\bar{W} \bar{Z}^{-1} \bar{W} \bar{Z}^{-1} d\bar{Z} \bar{Z}^{-1} \\ &= (-_2)^{-1} Z^{-1} {}^t (dW) d\bar{W} \bar{Z}^{-1} (-_2)^{-1} Z^{-1} {}^t (dW) \bar{W} \bar{Z}^{-1} d\bar{Z} \bar{Z}^{-1} \\ &\quad (-_2)^{-1} Z^{-1} dZ Z^{-1} {}^t W d\bar{W} \bar{Z}^{-1} \\ &\quad + (-_2)^{-1} Z^{-1} dZ Z^{-1} {}^t W \bar{W} \bar{Z}^{-1} d\bar{Z} \bar{Z}^{-1} \\ &= Y^{-1} {}^t (dW) d\bar{W} Y^{-1} {}^t (dW) \bar{W} \bar{Z}^{-1} d\bar{Z} \\ &\quad Y^{-1} dZ Z^{-1} {}^t W d\bar{W} + Y^{-1} dZ Z^{-1} {}^t W \bar{W} \bar{Z}^{-1} d\bar{Z} \end{aligned}$$

and

$$\begin{aligned}
 (d) &= (V_{-1} + U_{-2})(-2)^{-1} Z^{-1} dZ Z^{-1} (-2)^{-1} {}^n \bar{Z}^{-1} t(d\bar{W}) \bar{Z}^{-1} d\bar{Z} \bar{Z}^{-1} {}^1 t_W \circ \\
 &\quad (V_{-1} + U_{-2})(-2)^{-1} \bar{Z}^{-1} d\bar{Z} \bar{Z}^{-1} (-2)^{-1} Z^{-1} {}^1 t(d\bar{W}) Z^{-1} dZ Z^{-1} {}^1 t_W \\
 &= (V_{-1} + U_{-2})(-2)^{-1} Z^{-1} dZ Y^{-1} t(d\bar{W}) \\
 &\quad + (V_{-1} + U_{-2})(-2)^{-1} Z^{-1} dZ Y^{-1} d\bar{Z} \bar{Z}^{-1} {}^1 t_W \\
 &\quad (V_{-1} + U_{-2})(-2)^{-1} \bar{Z}^{-1} d\bar{Z} Y^{-1} t(d\bar{W}) \\
 &\quad + (V_{-1} + U_{-2})(-2)^{-1} \bar{Z}^{-1} d\bar{Z} Y^{-1} dZ Z^{-1} {}^1 t_W :
 \end{aligned}$$

Taking the $(dZ; d\bar{W})$ -part $(Z; \bar{W})$ in (b) + (c) + (d); we have

$$\begin{aligned}
 (Z; \bar{W}) &= V Y^{-1} dZ Y^{-1} t(d\bar{W}) + Y^{-1} dZ ({}^1 t_W - Z^{-1} {}^1 t_W) d\bar{W} \\
 &= V Y^{-1} dZ Y^{-1} t(d\bar{W}) \quad \text{because } W = W Z^{-1} (\text{cf. (2.4)}):
 \end{aligned}$$

Similarly, if we take the $(d\bar{Z}; dW)$ -part $(\bar{Z}; W)$ in (b) + (c) + (d); we have

$$\begin{aligned}
 (\bar{Z}; W) &= V Y^{-1} d\bar{Z} Y^{-1} t(dW) + d\bar{Z} Y^{-1} t(dW) (\bar{W} - \bar{W} Z^{-1}) \\
 &= V Y^{-1} d\bar{Z} Y^{-1} t(dW) \quad \text{because } W = W Z^{-1}:
 \end{aligned}$$

If we take the $(dW; d\bar{W})$ -part $(W; \bar{W})$ in (b) + (c) + (d); we have

$$(W; \bar{W}) = Y^{-1} t(dW) d\bar{W} :$$

Finally, if we take the $(dZ; d\bar{Z})$ -part $(Z; \bar{Z})$ in (b) + (c) + (d); we have

$$\begin{aligned}

Remark 2.1. The scalar curvature of the Siegel-Jacobi space $(H_{n,m}; ds_{n,m;A,B}^2)$ is constant because of the transitive group action of G^J on $H_{n,m}$: In the special case $n = m = 1$ and

$A = B = 1$, by a direct computation, we see that the scalar curvature of $(H_{1,1}; ds^2_{1,1,1,1})$ is 3:

3. Proof of Theorem 1.2

(c) Let $A; B$ and C be a $k \times l$, an $n \times m$ and an $m \times l$ matrix respectively. Assume that the entries of A commute with the entries of B . Then

Proof. The proof follows immediately from the direct computation.

Now we are ready to prove Theorem 1.2. First of all, we shall prove that $\eta_{\mathfrak{m}, A, B}$ is invariant under the action of the generators $t(b; ; ;)$; $g(h)$ and η_n :

It follows from the invariance of $ds_{n,m;A,B}^2$ under the action (1.2) and the transitivity of the action of G^J on $H_{n,m}$ that $ds_{n,m;A,B}^2$ is the Laplacian of $(H_{n,m}; ds_{n,m;A,B}^2)$. The invariance of the differential form dv follows from the fact that the following differential form

is invariant under the action (1.1) of $Sp(n; \mathbb{R})$ (cf. [13], p.130).

4. Remark on Spectral Theory of $ds_{n,m;A,B}^2$ on Siegel-Jacobi Space

Before we describe a fundamental domain for the Siegel-Jacobi space, we review the Siegel's fundamental domain for the Siegel upper half plane.

We let

$$P_n = \left\{ Y \in \mathbb{R}^{(n,n)} \mid Y = {}^t Y > 0 \right\}$$

be an open cone in $\mathbb{R}^{(n+1)=2}$. The general linear group $GL(n; \mathbb{R})$ acts on P_n transitively by

$$h \cdot Y = h Y {}^t h; \quad h \in GL(n; \mathbb{R}); \quad Y \in P_n;$$

Thus P_n is a symmetric space isomorphic to $GL(n; \mathbb{R})/O(n)$: We let

$$GL(n; \mathbb{Z}) = \{ h \in GL(n; \mathbb{R}) \mid h \text{ is integral} \}$$

be the discrete subgroup of $GL(n; \mathbb{R})$.

The fundamental domain R_n for $GL(n; \mathbb{Z})n\Gamma_n$ which was found by H. Minkowski [10] is defined as a subset of Γ_n consisting of $Y = (Y_{ij}) \in \Gamma_n$ satisfying the following conditions (M 1)–(M 2) (cf. [9], p.123):

(M 1) $aY^t a^{-1} Y_{kk}$ for every $a = (a_i) \in \mathbb{Z}^n$ in which $a_k; \dots, a_n$ are relatively prime for $k = 1, 2, \dots, n$.

(M 2) $Y_{k,k+1} = 0$ for $k = 1, \dots, n-1$:

We say that a point of R_n is Minkowski reduced or simply M-reduced.

Siegel [12] determined a fundamental domain F_n for $n\Gamma_n$, where $\Gamma_n = Sp(n; \mathbb{Z})$ is the Siegel modular group of degree n . We say that $Y = X + iY \in F_n$ with X, Y real is Siegel reduced or S-reduced if it has the following three properties:

(S 1) $\det(\text{Im}(Y)) = \det(\text{Im}(X))$ for all $2 \leq n$;

(S 2) $Y = \text{Im}(Y)$ is M-reduced, that is, $Y \in R_n$;

(S 3) $\Im_{ijj} \geq \frac{1}{2}$ for $1 \leq i, j \leq n$; where $X = (x_{ij})$:

F_n is defined as the set of all Siegel reduced points in H_n : Using the highest point method, Siegel [12] proved the following (F1)–(F3) (cf. [9], p.169):

(F1) $F_n \subset H_n$; i.e., $H_n = \bigcup_{Y \in F_n} \text{Im}(Y)$;

(F2) F_n is closed in H_n :

(F3) F_n is connected and the boundary of F_n consists of a finite number of hyperplanes.

The metric ds_n^2 given by (1.3) induces a metric $ds_{F_n}^2$ on F_n . Siegel [12] computed the volume of F_n

$$\text{vol}(F_n) = 2^{\sum_{k=1}^{n^2} \zeta(k) - (2k)},$$

where $\zeta(s)$ denotes the Gamma function and $\zeta(s)$ denotes the Riemann zeta function. For instance,

$$\text{vol}(F_1) = \frac{3}{3}; \quad \text{vol}(F_2) = \frac{6}{270}; \quad \text{vol}(F_3) = \frac{10}{127575}; \quad \text{vol}(F_4) = \frac{10}{200930625};$$

Let $f_{kl}(1 \leq k \leq m; 1 \leq l \leq n)$ be the $m \times n$ matrix with entry 1 where the k -th row and the l -th column meet, and all other entries 0. For an element $Y \in H_n$, we set for brevity

$$h_{kl}(Y) = f_{kl}; \quad 1 \leq k \leq m; 1 \leq l \leq n:$$

For each $Y \in F_n$; we define a subset P of $C^{(m, n)}$ by

For each $Y \in F_n$; we define the subset D of $H_n \cap C^{(m, n)}$ by

We define

$$F_{n,m} = \left[\begin{array}{c} < \\ & 2F_n \\ & D \end{array} \right]:$$

Theorem 4.1. Let

be the discrete subgroup of G^J , where

Then $F_{n,m}$ is a fundamental domain for $\mathbb{H}_n^{(n,m)}$:

Proof. The proof can be found in [20].

In the case $n = m = 1$, R. Berndt [2] introduced the notion of Maass-Jacobi forms. Now we generalize this notion to the general case.

Definition 4.1. For brevity, we set $\mathbb{H}_n^{(n,m)} = \mathbb{H}_{n,1,1}$ (cf. Theorem 1.2). Let

$$\mathbb{H}_n^{(n,m)} = \mathrm{Sp}(n; \mathbb{Z}) \cap H_n^{(n,m)}$$

be the discrete subgroup of G^J , where

A smooth function $f : H_{n,m} \rightarrow \mathbb{C}$ is called a Maass-Jacobi form on $H_{n,m}$ if f satisfies the following conditions (M J1)–(M J3):

(M J1) f is invariant under $\mathbb{H}_n^{(n,m)}$:

(M J2) f is an eigenfunction of the Laplacian $\Delta_{n,m}$.

(M J3) f has a polynomial growth, that is, there exist a constant $C > 0$ and a positive integer N such that

$$|f(X + iy; z)| \leq C |p(Y)|^N \quad \text{as } \det Y \rightarrow 1;$$

where $p(Y)$ is a polynomial in $Y = (y_{ij})$:

It is natural to propose the following problems.

Problem A : Construct Maass-Jacobi forms.

Problem B : Find all the eigenfunctions of $\Delta_{n,m}$:

We consider the simple case $n = m = 1$: A metric $ds_{1,1}^2$ on $H_{1,1} \subset \mathbb{C}$ given by

$$\begin{aligned} ds_{1,1}^2 &= \frac{y+v^2}{y^3} (dx^2 + dy^2) + \frac{1}{y} (du^2 + dv^2) \\ &\quad + \frac{2v}{y^2} (dx du + dy dv) \end{aligned}$$

is a G^J -invariant Kähler metric on $H_{1,1} \subset \mathbb{C}$. Its Laplacian $\Delta_{1,1}$ is given by

We provide some examples of eigenfunctions of $\Delta_{\mathbb{H}_n}$.

(1) $h(x; y) = y^{\frac{1}{2}} K_s \left(\frac{1}{2} (2 - \bar{y}y) e^{2 \operatorname{Im} x} \right)$ ($s \in \mathbb{C}; a \neq 0$) with eigenvalue $s(s-1)$: Here

$$K_s(z) = \frac{1}{2} \int_0^{\infty} \exp \left(-\frac{z}{2} (t + t^{-1}) \right) t^{s-1} dt;$$

where $\operatorname{Re} z > 0$:

(2) $y^s; y^s x; y^s u$ ($s \in \mathbb{C}$) with eigenvalue $s(s-1)$:

(3) $y^s v; y^s u v; y^s x v$ with eigenvalue $s(s+1)$:

(4) $x; y; u; v; x v; u v$ with eigenvalue 0.

(5) All Maaß wave forms.

We fix two positive integers m and n throughout this section.

For an element $L \in H_n$, we set

$$L = Z^{(m, n)} + \overline{Z}^{(m, n)}$$

It follows from the positivity of $\operatorname{Im} z$ that the elements $f_{kl}, h_{kl}(z)$ ($1 \leq k \leq m; 1 \leq l \leq n$) of L are linearly independent over \mathbb{R} . Therefore L is a lattice in $\mathbb{C}^{(m, n)}$ and the set $\{f_{kl}, h_{kl}(z)\}_{1 \leq k \leq m; 1 \leq l \leq n}$ forms an integral basis of L . We see easily that if L is an element of H_n , the period matrix $\Gamma_L = (I_n; L)$ satisfies the Riemann conditions (RC 1) and (RC 2):

$$(RC 1) \quad J_n^{-1} \Gamma_L = 0;$$

$$(RC 2) \quad \frac{1}{i} \operatorname{Im} J_n^{-1} \Gamma_L > 0.$$

Thus the complex torus $A = \mathbb{C}^{(m, n)} / L$ is an abelian variety.

It might be interesting to investigate the spectral theory of the Laplacian $\Delta_{A, \mathbb{R}}$ on a fundamental domain $F_{n, m}$. But this work is very complicated and difficult at this moment. It may be that the first step is to develop the spectral theory of the Laplacian $\Delta_{A, \mathbb{R}}$ on the abelian variety A : The second step will be to study the spectral theory of the Laplacian $\Delta_{A, \mathbb{R}}$ on the moduli space $M_{n, m}$ of principally polarized abelian varieties of dimension n . The final step would be to combine the above steps and more works to develop the spectral theory of the Laplacian $\Delta_{A, \mathbb{R}}$ on $F_{n, m}$: Maaß-Jacobi forms play an important role in the spectral theory of $\Delta_{A, \mathbb{R}}$ on $F_{n, m}$: Here we deal only with the spectral theory on $L^2(A)$:

We fix an element $z = X + iY$ of H_n with $X = \operatorname{Re} z$ and $Y = \operatorname{Im} z$: For a pair $(A; B)$ with $A, B \in Z^{(m, n)}$, we define the function $E_{(A, B)} : \mathbb{C}^{(m, n)} \rightarrow \mathbb{C}$ by

$$E_{(A, B)}(Z) = e^{2\pi i((\operatorname{tr} A U) + (\operatorname{tr} B A X Y^{-1} t V))},$$

where $Z = U + iV$ is a variable in $\mathbb{C}^{(m, n)}$ with real U, V .

Lemma 4.1. For any $A, B \in Z^{(m, n)}$, the function $E_{(A, B)}$ satisfies the following functional equation

$$E_{(A, B)}(Z + U + iV) = E_{(A, B)}(Z), \quad Z \in \mathbb{C}^{(m, n)}$$

for all $U, V \in \mathbb{C}^{(m, n)}$: Thus $E_{(A, B)}$ can be regarded as a function on A :

Proof. We write $= X + iY$ with real X, Y : For any $\in \mathbb{Z}^{(m,n)}$; we have

$$\begin{aligned} E_{A,B}(Z + \cdot) &= E_{A,B}(U + X + \cdot) + i(V + Y) \\ &= e^2 \text{ if } (t_A(U + X + \cdot)) + ((B \cdot A X)Y^{-1} t(V + Y))g \\ &= e^2 \text{ if } (t_A U + t_A X + t_A \cdot) + ((B \cdot A X)Y^{-1} t_V + B^t \cdot A X^t)g \\ &= e^2 \text{ if } (t_A U) + ((B \cdot A X)Y^{-1} t_V)g \\ &= E_{A,B}(Z): \end{aligned}$$

Here we used the fact that t_A and B^t are integral.

Lemma 4.2. The metric

$$ds^2 = (\operatorname{Im} \cdot)^{-1} t(dZ) d\bar{Z})$$

is a Kähler metric on A invariant under the action (5.15) of $J = \operatorname{Sp}(n; \mathbb{Z})$ on $H_{\mathbb{Z}}^{(m,n)}$ on $(\cdot; Z)$ with \cdot fixed. Its Laplacian of ds^2 is given by

$$= (\operatorname{Im} \cdot) \frac{\partial}{\partial Z}^t \frac{\partial}{\partial \bar{Z}} : \quad \cdot$$

Proof. The proof can be found [20].

We let $L^2(A)$ be the space of all functions $f : A \rightarrow \mathbb{C}$ such that

$$\|f\|^2 := \int_A |f(Z)|^2 dv ;$$

where dv is the volume element on A normalized so that $\int_A dv = 1$: The inner product (\cdot, \cdot) on the Hilbert space $L^2(A)$ is given by

$$(f; g) := \int_A f(Z) \overline{g(Z)} dv ; \quad f, g \in L^2(A) :$$

Theorem 4.2. The set $E_{A,B} j_A; B \in \mathbb{Z}^{(m,n)}$ is a complete orthonormal basis for $L^2(A)$. Moreover we have the following spectral decomposition of Δ :

$$L^2(A) = \bigoplus_{A, B \in \mathbb{Z}^{(m,n)}} C E_{A,B} :$$

Proof. The complete proof can be found in [20]
