# Them ixing time of the $T$ honp shu e

## A bstract


#### Abstract

The Thorp shu $e$ is de ned as follow s. Cut the deck into two equalpiles. D rop the rst card from the left pile or the right pile according to the outcom e of a fair coin ip; then drop from the other pile. C ontinue this way untilboth piles are em pty. W e show that the $m$ ixing tim efor the $T$ horp shu ew ith $2^{d}$ cards is polynom ial in $d$.


## 1 Introduction

### 1.1 The Thorp shu e

How $m$ any shu es are necessary to $m$ ix up a deck of cards? $W$ e refer to this as the $m$ ixing tim $e$ (see section 112 ' for a precise de nition). Them athem atics of card shu ing has been studied extensively over the past several decades and $m$ ost of the problem s have been solved. M ost fam ously, B ayer and $D$ iaconis []$\left._{1}^{1}\right]$ (in one of the few $m$ athem atical results to have $m$ ade the front page of the $N$ ew York $T$ im es) gave very precise bounds for the $G$ ilbert-Shannon-Reeds (ri e) shu em odel. Their bounds w ere correct even up to the constant factors. For alm ost allnatural shu esm atching upper and lower bounds are known (often even up to constants). H ow ever, one card shu ing problem has stood out for its resistance to attack.

In 1973, Thonp [10 in introduced the follow ing shu ing procedure. A ssum e that the num ber of cards, $n$, is even. Cut the deck into two equal piles. D rop the rst card from the left pile or the right pile according to the outcom e of a fair coin ip; then drop from the other pile. C ontinue th is $w a y, w$ ith independent coin ips deciding whether to drop left-right or right-left each tim $e$, untillboth piles are em pty.

The Thorp shu e, despite its sim ple description, has been hard to analyze. The problem of determ ining its $m$ ixing time is, according to PersiD iacon is $\left[\begin{array}{l}-1 / 1\end{array}\right]$, the $\backslash$ longest-standing open card shu ing problem." It has long been con jectured that them ixing tim e is $O\left(\log ^{c} n\right.$ ) for som e constant c. H ow ever, despite $m$ uch e ort the only known upper bounds are trivial ones of the form $O\left(n^{c}\right)$ that have circulated in the folklore. The $m$ ain contribution of this paper is to give the rst poly log upper bound for the $m$ ixing tim e.
$W$ e shall assum e that the num ber of cards is $2^{d}$ for a positive integer $d$. ( $T$ hus, our am is to prove that the $m$ ixing tim e is polynom ial in d.) In this case the $T$ horp shu e has a very appealing altemative description. By writing the position of each card, from the bottom card ( 0 ) to the top card (2 $2^{\mathrm{d}}$ ), in binary, we can view the cards as occupying the vertices of the $d$-dim ensional unit hypercube $f 0 ; 1 g^{d}$. The Thonp shu e proceeds in two stages. In the rst stage, an independent coin is ipped for each edge $e$ in direction 1 (i.e., each edge in the cube that connects tw $o$ vertices that dier in only the rst coordinate). If the coin lands heads, the cards at the endpoints of e are

[^0]interchanged; otherw ise the cards rem ain in place. In the second stage, a \cyclic left bit shift" is perform ed for each card, where the card in position ( $\mathrm{x}_{1} ;::: ; \mathrm{x}_{\mathrm{d}}$ ) is m oved to ( $\mathrm{x}_{2} ;::: ; \mathrm{x}_{\mathrm{d}} ; \mathrm{x}_{1}$ ).

W e w ill actually use a slightly modi ed de nition of the $T$ honp shu e. Say that an edge in the hypercube rings if its endpoints are sw itched with probability $\frac{1}{2}$. For $j=1 ;:: ; \mathrm{d}$; let $\mathrm{K}_{\mathrm{j}}$ be the transition kemel for the the process in which every edge e in direction $j$ rings.
$D e n$ ition: Thorp shu e. The Thonp shu $e$ is the $M$ arkov chain whose transition kemel at timen is $K_{j+1}$ if $j \quad n \bmod d$.

Since d iterations of this shu e is equivalent to diterations of the shu e described in [10] In it is enough to prove a poly (d) m ixing tim ebound for this new m odel.

It is natural to consider the change in the deck after $d$ shu es have been perform ed. ( $T$ his represents one com plete \cycle".) W e w ill call this a round. U sing the language of netw ork com puting, a round of the $T$ horp shu $e$ is like passing the cards through $d$ levels of a butter y netw ork (see, e.g., K nuth's book [日] []), where at each stage neighboring cards are interchanged w th probability $\frac{1}{2}$.
 has strictly positive entries. This can be viewed as a result about the \diam eter" of the $T$ horp shu e; after a sm all num ber of steps there is a positive probability of being in any given state. H ow ever, these probabilities are in general very $s m$ all so this does not im ply a good bound for the $m$ ixing time.

Them ain result of this paper is that indeed the $m$ ixing tim e is polynom ial in d. O urproofuses evolving sets, a technique for bounding $m$ ixing tim es that $w a s$ introduced by the author and $P$ eres in $[\underline{[ }]$. A nother paper that uses som e of the sam e ideas is $[\underline{\eta} \bar{\eta}]$, in which a variant of evolving sets is used to analyze the exclusion process. Evolving sets are related to the notion of strong stationary duality due to $D$ iacon is and $F$ ill [5-1

### 1.2 Statem ent of $m$ ain result

For a M arkov chain on state space $V$ w ith uniform stationary distribution, de ne the (uniform ) $m$ ixing tim e by

$w$ here $p^{n}(x ; y)$ is the $n$-step transition probability from $x$ to $y$. ( $T$ his is a stricter de nition of $m$ ixing tim e than the usual one involving total variation distance.)

O urm ain result is the follow ing theorem.
Theorem 1 Them ixing time for the $T$ horp shu $e$ is $O\left(d^{44}\right)$.
In sim ilar fashion to the analysis in [id], we prove our mixing tim e bound based on an isoperi$m$ etric function we call the root pro le. The paper is organized as follows. Follow ing a brief introduction to evolving sets in section $\overline{2}$, we devote much of the rest of the paper to proving a
 sets to give a bound on the root pro le. In section ${ }_{1}^{1} 1 \mathbf{1}, \mathrm{w}$ e describe the cham eleon process, a variant of the $T$ horp shu $e$ in which the cards have changing colors, which is usefulto bound $m$ ixing tim es. In section we use the cham eleon process to show that for a \reversibilized" version of the $T$ honp shu e, any collection of cards (if view ed as indistinguishable) m ixes in poly (d) tim e. In section $\boldsymbol{\sigma}_{\mathrm{n}}, \mathbf{\prime}$
 kemel for the $T$ honp shu e contracts fiunctions in a certain $l^{2}$ sense; then we use this to obtain our bound on the root pro le. Next, arm ed w th a good bound on the root pro le we prove Theorem

## 2 Evolving sets

W e will now give a brief overview of evolving sets (see $[\underline{i-1 /[ }]$ for a more detailed account). ## 4 C ham eleon process

It $w i l l$ be convenient to study the card shu e that behaves like the $T h o n p$ shu e for the rst $d$ steps $\left(K_{1} ;::: ; K_{d}\right)$ ，and then like a $\backslash$ reverse $T h o n p$ shu $e^{\prime \prime}$ for the next d steps（ $K_{d} ;::: ; K_{1}$ ）．We w ill call this the zigzag shu e．Every 2d steps of the zigzag shu e will be called a round．（So a round of the zigzag shu $e$ is a round of the $T$ honp shu efollowed by a round of a tim e－reversed Thorp shu e．）

$T$ he cham eleon process is an extension of the zigzag shu e．The cards $m$ ove in the sam $e$ way as in the zigzag shu e，but they also have colors，which can be red，white，black or pink．In itially， the cards are colored as follow $s$ ．There is a sequence of cards $\mathrm{x}_{1} ;::: ; \mathrm{x}_{\mathrm{b}}$ for som eb＞ $2^{\mathrm{d}}{ }^{1}$ such that
cards $\mathrm{x}_{1} ;::: ; \mathrm{x}_{\mathrm{b}} 1$ are colored white , card $\mathrm{x}_{\mathrm{b}}$ is colored red, and the rem aining cards are colored black. T he cards can change color in tw o ways. T he rst way is called pinkening, which takes place when an edge connecting a red card to a white card rings; in this case both cards are re-colored pink. The second way is called de-pinking, which takes place at the end of every 64 cod rounds of shu ing; in th is case all of the pink cards are collectively re-colored red or white, w ith probaility $\frac{1}{2}$ each. (A process of this type was rst used in $\bar{\eta}$ black cards can never change color.

(If both endpoints are pink then choose one of them arbitrarily.) Since at least a fraction 1=8 of the cards in $A_{n} w$ ill have a pink card associated to them in this round, and since any given pink card can be associated to at $m$ ost $d$ cards in $A_{n}$ in this round, the number of pink cards at the end of this round $m$ ust be at least $\frac{j A_{n} j}{8 d}$.
