A bstract

Lattices generated by lattice points in skeletons of re exive polytopes are essential in determ ining the fundam ental group and integral cohom ology of C alabi-Y au hypersurfaces. Here we prove that the lattice generated by all lattice points in a re exive polytope is already generated by lattice points in codim ension two faces. This answers a question of J.M organ.

1 Introduction and main result

Since its introduction by Batyrev in [Bat94] dual pairs of re exive polytopes have been used to successfully construct m irror pairs of sm ooth Calabi-Yau varieties as resolutions of non-degenerate anticanonical hypersurfaces in Gorenstein toric Fano varieties, see, e.g., [CK 99].

Recall that a re exive polytope is an n-dimensional lattice polytope P $M_R = M_Z R$ for a lattice $M = Z^n$ such that P contains the origin in its interior and the dual polytope P is also a lattice polytope with respect to the dual lattice $N = M = Hom_Z (M; Z)$. There is an associated pair P $_{P,M}$, P $_{P,N}$ of G orenstein toric Fano

varieties, where $_{P}$ is just the fan of cones over the faces of P, see, e.g., [Bat94, N i105].

For a given re exive polytope P M_R there exist nitely many choices of sublattices of M such that P is re exive with respect to this lattice. O by iously the minim alone of these is the lattice $_0$ generated by the vertices of P. M ore generally we de ne

 $_k \coloneqq$ lattice generated by all lattice points in the k-skeleton of P ,

where the k-skeleton is the union of k-dimensional faces.

Due to [N iD5, Lemma 1.17] and [Ful93, 3.2] we see that for k = 0;1;2 the quotient group $M = {}_k$ equals the fundamental group ${}_1$ of the union of all k + 1-codimensional torus orbits in P ${}_{_{\rm P},M}$.

Returning to the relevance of these lattices in m irror symmetry B atyrev and K reuzer [BK 05, C or 1.9] recently proved that for n = 3;4 the quotient group M = $_{n 2}$ is precisely the fundam ental group $_1$ (X) of a projective crepant resolution X of an (n 1)-dimensional non-degenerate anticanonical C alabi-Y au hypersurface in P $_{p M}$. M ore-over for n = 4 they showed that the torsion group of H² (X;Z) equals H om (M = $_{n 2}$;Q=Z) and the torsion group of H³ (X;Z) is isom orphic to H om (2 M = M $_{n 3}$;Q=Z), cf. [BK 05, C or 3.9]. M irror sym - m etry should exchange these torsion parts of integral cohom ology of X and a m irror X. Hence, this yields the surprising isom orphism M = $_{2} = ^{2}$ N = N $_{1}^{n}$, where $_{1}$ is the sublattice of N generated by lattice points in edges of P. U sing the classi cation of K reuzer and Skarke [K S00] they con m ed this conjecture.

These results and open questions motivate further investigation of the lattices $_k$ for an n-dimensional relexive polytope P. Here we rst note the following two observations:

Since there are no non-zero lattice points in the interior of P , we have $n_1 = n$.

If there exists a crepant toric resolution of P $_{P,M}$, then the boundary @P contains a lattice basis, hence $_{n,1} = M$. This holds for n = 2;3.

For n = 2 there are precisely three isom orphism classes of re exive polytopes with $n_2 = 0 \in M$, here 0 has index 2, 2, and 3:




Figure 1: Re exive polygons with $n_2 \in M$

As noted in [BK05, Remark 1.10] for n = 3 a non-degenerate Calabi-Yau hypersurface X arising from a crepant resolution of $P_{p,M}$ is a smooth K 3-surface, hence sim ply-connected. So the fundam ental group $_1(X) = M = _{n 2}$ is trivial, i.e., $_{n 2} = _{n 1}$. The authors did not know of a combinatorial proof of this result in the literature.

At PCM I 2004, John M organ (for a m irror-sym m etric conjecture concerning integral variations of H odge structure see C on jecture 2.9 in [DM 05]) asked the rst author for a combinatorial proof that $n_2 =$

 $_{n\ 1}$ would also hold for n = 4. This was con med by the classication of all four-dimensional releasive polytopes [K S00]. John M organ, and independently Batyrev and K reuzer [BK 05], have listed all 16 isomorphism classes of four-dimensional releasive polytopes with $_{n\ 2}$ 6 M. However in contrast to n = 3 not even an algebrogeometric proof seem ed to be known.

The goal of this article is to provide a purely convex-geom etric proofvalid in arbitrary dimension n > 2. (Figure 1 show sall \counter-examples" for n = 2).

Theorem 1.1. If n = 3, then $n_2 = n_1$.

The main idea of the proof is to show that any lattice point inside a facet can be obtained from lattice points on lower dimensional faces. For this we use a partial addition on the set of lattice points in P, observed by the second author in [N il05, Prop.4.1]. In [N il05] that m ethod has been applied to investigate the set of lattice points inside the facets, since this is precisely the set of D em azure roots for the autom orphism group of the corresponding G orenstein toric Fano variety P ____N.

2 Proof of theorem

Let P $\,$ M $_R$ be an n-dimensional relexive polytope. We denote by h ; i the non-degenerate symmetric pairing of the dual lattices M ;N .

For the proof we will use the following notions.

De nition 2.1.

W e denote by R the set of D em azure roots of P , i.e., the set of lattice points in the interior of facets.

For x 2 R we denote by F_x the unique facet of P containing x, and by x the unique inner norm $alofF_x$, i.e., $x = F_x 2 N$ st. $h_x;F_x i = 1$.

A pair of roots x;y 2 R is called orthogonal, if h_x ;yi = 0 = h_y ;xi. In particular $x \notin y \notin x \notin y$. In this case x + y 2 M $\setminus F_x \setminus F_y$ (see the next result).

The following lemma is the engine running our proof.

Lem m a 2.2 (N ilO4, Lem m a 3.5 & Corollary 3.6]). For x;y 2 @P $\ M$ exactly one of the following is true. Either x and y belong to a common facet, or x + y = 0, or x + y 2 @P. In the last case, there is a unique z(x;y) = ax + by 2 @P with a;b 2 $Z_{>0}$. We have a = 1 or b = 1, and x and z(x;y), respectively y and z(x;y), belong to a common facet. Furthermore, if $x \ge R$, then $a = h_x;yi + 1$.

The custom tailored version for our purposes reads as follow s.¹ W e abbreviate $\approx n_2$.

Corollary 2.3. Let x 2 R n , y 2 @P \setminus with y 2 F x. Then h_x ; yi 1, and p(x; y) = h_x ; yix + y 2 R n is a root orthogonal to x.




Figure 2: p(x;y)

Proof of Theorem 1.1. Let n=3, and let $x_1 \ 2 \ R$ arbitrary. We have to show $x_1 \ 2$. Assume not, that is, $x_1 \ 2$.

Let $y_0 \ 2 \ V(P) \ n \ F_{x_1}$ be a vertex of P outside F_{x_1} . Corollary 2.3 provides $x_2 \ = \ p(x_1; y_0) \ 2 \ R \ n$. The points x_1 and x_2 span a 2-dimensional linear space L. Either all vertices of P belong to $(F_{x_1} \ F_{x_2})$ [L or not.




Figure 3: V(P) ($F_{x_1} \setminus F_{x_2}$) [L

By Corollary 2.3 we have $k_1 := h_{x_2}; y_1 i$ 1 and $k_2 := h_{x_1}; y_2 i$

1. Furtherm ore $q \coloneqq p(r; y_2) = k_2 r + y_2 2 R n$, $h_{x_1}; qi = 0$. Since $h_{x_2}; ri = 0$ and $y_2 2 F_{x_2}$, we get $q 2 F_{x_2}$. Again by Corollary 2.3 $r^0 \coloneqq p(q; y_1) = k_1 q + y_1 2 R n$, $h_{x_2}; r^0 i = 0$. Since $h_{x_1}; qi = 0$ and $y_1 2 F_{x_1}$, we get $r^0 2 F_{x_1}$. Hence $r^0 2 A$. Since $r^0 = k_1 (k_2 r + y_2) + y_1$, we have $h_1; r^0 i = k_1 k_2 h_1; ri + k_1 > h_1; ri$, a contradiction.




Figure 4: Ping-pong




Figure 5: Finish
