BOOSTING W ITH EARLY STOPPING: CONVERGENCE AND CONSISTENCY

Boosting is one of the most signi cant advances in machine learning for classi cation and regression. In its original and computationally exible version, boosting seeks to minimize empirically a loss function in a greedy fashion. The resulting estimator takes an additive function form and is built iteratively by applying a base estimator (or learner) to updated samples depending on the previous iterations. An unusual regularization technique, early stopping, is employed based on CV or a test set.

This paper studies num erical convergence, consistency and statistical rates of convergence of boosting with early stopping, when it is carried out over the linear span of a family of basis functions. For general loss functions, we prove the convergence of boosting's greedy optimization to the in nimum of the loss function over the linear span. Using the num erical convergence result, we nd early-stopping strategies under which boosting is shown to be consistent based on i.i.d. sam ples, and we obtain bounds on the rates of convergence for boosting estimators. Simulation studies are also presented to illustrate the relevance of our theoretical results for providing insights to practical aspects of boosting.

As a side product, these results also reveal the importance of restricting the greedy search step-sizes, as known in practice through the work of Friedman and others. Moreover, our results lead to a rigorous proof that for a linearly separable problem, A daBoost with "! O step-size becomes an L^1 -margin maxim izer when left to run to convergence.

1. Introduction. In this paper we consider boosting algorithm s for classi cation and regression. These algorithm s represent one of the major ad-

vances in machine learning. In their original version, the computational aspect is explicitly specified as part of the estimator/algorithm. That is, the empirical minimization of an appropriate loss function is carried out in a greedy fashion, which means that at each step a basis function that leads to the largest reduction of empirical risk is added into the estimator. This specification distinguishes boosting from other statistical procedures which are defined by an empirical minimization of a loss function without the numerical optimization details.

Boosting algorithm s construct composite estimators using offen simple base estimators through the greedy tting procedure. An unusual regularization technique, early stopping, is employed based on CV or a test set. This family of algorithm shas been known as the stagew ise tting of additive models in the statistics literature [18, 17]. For the squared loss function, they were offen referred to in the signal processing community as matching pursuit [29]. More recently, it was noticed that the A daB oost method proposed in the machine learning community [13] can also be regarded as stagew ise tting of additivem odels under an exponential loss function [7, 8, 15, 31, 34]. In this paper we use the term boosting to indicate a greedy stagew ise procedure to minimize a certain loss function empirically. The abstract formulation will be presented in Section 2.

Boosting procedures have drawn much attention in the machine learning community as well as in the statistics community, due to their superior empirical performance for classication problems. In fact, boosted decision trees are generally regarded as the best o -the-shelf classication algorithms we have today. In spite of the signicant practical interest in boosting, a number of theoretical issues have not been fully addressed in the literature. In this paper we hope to 11 some gaps by addressing three basic issues regarding boosting: its numerical convergence when the greedy iteration increases, in Section 4.1; its consistency (after early stopping) when the training sample size gets large, in Sections 3.3 and 5.2; and bounds on the rate of convergence for boosting estim ators, in Sections 3.3 and 5.3.

It is now well known that boosting forever can over t the data (e.g., see [16, 19]). Therefore, in order to achieve consistency, it is necessary to stop the boosting procedure early (but not too early) to avoid over tting. In the early stopping fram ework, the consistency of boosting procedures has been considered by Jiang for exponential loss [19] boosting (but the consistency is in terms of the classi cation loss) and Buhlm ann under squared loss [10] for tree-type base classi ers. Jiang's approach also requires som e sm oothness conditions on the underlying distribution, and it is nonconstructive (hence does not lead to an implementable early-stopping strategy). In Sections 3.3 and 5.2 we present an early-stopping strategy for general loss functions that guarantees consistency. A di erent m ethod of achieving consistency (and obtaining rate of convergence results) is through restricting the weights of the composite estimator using the 1-norm of its coe cients (with respect to the basis functions). For example, this point of view is taken up in [5, 28, 30]. In this fram ework, early stopping is not necessary since the degree of over tting or regularization is controlled by the 1-norm of the weights of the composite estimator. A lthough this approach simpli es the theoretical analysis, it also introduces an additional control quantity which needs to be adjusted based on the data. Therefore, in order to select an optim al regularization parameter, one has to solve m any di erent optimization problems, each with a regularization parameter. M oreover, if there are an in nite (or extrem ely large) number of basis functions, then it is not possible to solve the associated 1-norm regularization problem. Note that in this case greedy boosting (with approximate optimization) can still be applied.

A question related to consistency and rate of convergence is the convergence of the boosting procedure as an optim ization m ethod. This is clearly one of the m ost fundam ental theoretical issues for boosting algorithm s. P revious studies have focused on special loss functions. Speci cally, M allat and Zhang proved the convergence of m atching pursuit in [29], which was then used in [10] to study consistency; in [9] B reim an obtained an in nite-sam ple convergence result of boosting with the exponential loss function for 1-trees (under some sm oothness assumptions on the underlying distribution), and the result was used by Jiang to study the consistency of A daB oost. In [12] a B regm an divergence-based analysis was given. A convergence result was also obtained in [31] for a gradient descent version of boosting.

N one of these studies provides any inform ation on the num erical speed of convergence for the optim ization. The question of num erical speed of convergence has been studied when one works with the 1-norm regularized version of boosting where we assume that the optimization is performed in the convex hull of the basis functions. Speci cally, for function estimation under least-squares loss, the convergence of the greedy algorithm in the convex hull was studied in [1, 20, 25]. For general loss functions, the convergence of greedy algorithms (again, the optimization is restricted to the convex hull) was recently studied in [37]. In this paper we apply the sam e underlying idea to the standard boosting procedure where we do not lim it the optim ization to the convex hull of the basis functions. The resulting bound provides inform ation on the speed of convergence for the optim ization. An interesting observation of our analysis is the important role of small step-size in the convergence of boosting procedures. This provides some theoretical justi cation for Friedman's empirical observation [14] that using small step-sizes alm ost always helps in boosting procedures.

M oreover, the combination of numerical convergence results with modem em pirical process bounds (based on R adem acher com plexity) provides T.ZHANG AND B.YU

a way to derive bounds on the convergence rates of early-stopping boosting procedures. These results can be found in Sections 3.3 and 5.3. Section 6 contains a simulation study to show the usefulness of the insights from our theoretical analyses in practical in plem entations of boosting. The proofs of the two main results in the num erical convergence section (Section 4.1) are deferred to Section A 2. Section A 3 discusses relaxations of the restricted step-size condition used for earlier results, and Section A 4 uses num erical convergence results to give a rigorous proof of the fact that for separable problem s, A daB oost with sm all step-size becom es an L_1 m argin m axim izer at its lim it (see [18]).

2. Abstract boosting procedure. We now describe the basics to de ne the boosting procedure that we will analyze in this paper. A similar setup can be found in [31]. Them aim di erence is that the authors in [31] use a gradient descent rule in their boosting procedure while here we use approximate m inim ization.

Let S be a set of real-valued functions and de ne

span(S) =

which form s a linear function space. For all f 2 span(S), we can de ne the 1-norm with respect to the basis S as

We want to nd a function f 2 span (S) that approximately solves the optimization problem

where A is a convex function of f de ned on span(S). Note that the optim al value m ay not be achieved by any f 2 span(S), and for certain form ulations (such as A daBoost) it is possible that the optim al value is not nite. B oth cases are still covered by our results, how ever.

The abstract form of the greedy boosting procedure (with restricted stepsize) considered in this paper is given by the following algorithm:

Algorithm 2.1 (Greedy boosting).

Remark 2.1. The approximate minimization of () in Algorithm 2.1 should be interpreted as nding $_k\,2_k$ and $g_k\,2\,S$ such that

where $\mathbf{w}_{k} = 0$ is a sequence of nonnegative numbers that converges to zero.

Remark 2.2. The requirement that 02 $_k$ is not crucial in our analysis. It is used as a convenient assumption in the proof of Lemma 4.1 to simplify the conditions. Our convergence analysis allows the choice of $_k$ to depend on the previous steps of the algorithm. However, the most interesting $_k$ for the purpose of this paper will be independent of previous steps of the algorithm :

(a)

As we will see later, the restriction of ${}_k$ to the subset ${}_k$ R is useful in the convergence analysis.

As we shall see later, the step-size $_{k}$ plays an important role in our analysis. A particular interesting case is to restrict the step-size explicitly. That is, we assume that the starting point f_{0} , as well as quantities " $_{k}$ and $_{k}$ in (3), are sample-independent, and $h_{k} = \sup_{k}$ satisfies the conditions

The reason for this condition will become clear in the numerical convergence analysis of Section 4.1.

3. A ssum ptions and m ain statistical results. The purpose of this section is to state assumptions needed for the analyses to follow, as well as the m ain statistical results. There are two m ain aspects of our analysis. The rst is the num erical convergence of the boosting algorithm as the num ber of iterations increases, and the second is the statistical convergence of the resulting boosting estimator, so as to avoid over thing. We list respective assumptions separately. The statistical consistency result can be obtained by combining these two aspects. 3.1. A ssumptions for the numerical convergence analysis. For all f 2 span(S) and g 2 S, we de ne a real-valued function A_{fg} () as

Definition 3.1. Let A (f) be a function off de ned on span (S). Denote by span (S)⁰ the dual space of span (S) [i.e., the space of real-valued linear functionals on span (S)]. We say that A is dimentiable with gradient r A 2 span (S)⁰ if it satisfies the following Frechet-like dimentiability condition for all f;g 2 span (S):

where $r A (f)^T g$ denotes the value of the linear functional r A (f) at g.N ote that we adopt the notation $f^T g$ from linear algebra, where it is just the scalar product of the two vectors.

For reference, we shall state the following assumption, which is required in our analysis.

A ssumption 3.1. Let A (f) be a convex function of f de ned on span (S), which satis es the following conditions:

- 1. The functional A is di erentiable with gradient r A.
- 2. For all f 2 span(S) and g 2 S, the real-valued function $A_{f,g}$ is second-order di erentiable (as a function of h) and the second derivative satis es

(5)

where M () is a nondecreasing real-valued function.

Remark 3.1. A more general form of (5) is $A_{f,g}^{(0)}(0)$ '(g)M (kfk₁), where '(g) is an appropriate scaling factor of g. For example, in the examples given below, '(g) can be measured by $\sup_x jg(x) j$ or $E_x g(X)^2$. In (5) we assume that functions in S are properly scaled so that '(g) 1. This is for notational convenience only. W ith more complicated notation techniques developed in this paper can also handle the general case directly without any norm alization assumption of the basis functions.

The function M () will appear in the convergence analysis in Section 4.1. A blough our analysis can handle unbounded M (), the most interesting boosting examples have bounded M () (as we will show shortly). In this case we will also use M to denote a real-valued upper bound of $\sup_a M$ (a). For statistical estimation problems such as classication and regression with a covariate or predictor variable X and a real response variable Y having a joint distribution, we are interested in the following form of A (f) in (2):

where (;) is a loss function that is convex in its rst argument and is a monotonic increasing auxiliary function which is introduced so that A (f) is convex and M () behaves nicely (e.g., bounded). We note that the introduction of is for proving numerical convergence results using our proof techniques, which are needed for proving statistical consistency of boosting with early stopping. However, is not necessary for the actual in plementation of the boosting procedure. Clearly the minimizer of (6) that solves (2) does not depend on the choice of . Moreover, the behavior of A lgorithm 2.1 is not a ected by the choice of as long as " $_{\rm k}$ in (3) is appropriately rede ned. We may thus always take (u) = u, but choosing other auxiliary functions can be convenient for certain problems in our analysis since the resulting formulation has a bounded M () function (see the examples given below). We have also used $E_{X,Y}$ to indicate the expectation with respect to the pint distribution of (X;Y).

W hen not explicitly specied, $E_{X,Y}$ can denote the expectation either with respect to the underlying population or with respect to the empirical samples. This makes no dierence as far as our convergence analysis in Section 4.1 is concerned. When it is necessary to distinguish an empirical quantity from its population counterpart, we shall denote the form erby a hat above the corresponding quantity. For example, \vec{E} denotes the expectation with respect to the empirical samples, and \vec{A} is the function in (6) with $E_{X,Y}$ replaced by $\vec{E}_{X,Y}$. This distinction will become necessary in the uniform convergence analysis of Section 4.2.

An important application of boosting is binary classi cation. In this case it is very natural for us to use a set of basis functions that satisfy the conditions

For certain loss functions (such as least squares) this condition can be relaxed. In the classi cation literature (f;y) usually has a form (fy).

C om m only used loss functions are listed in Section A 1. They show that for a typical boosting loss function % M , there exists a constant M such that $\sup_{a}M$ (a) M .

3.2. A ssum ptions for the statistical convergence analysis. In classi cation or regression problem s with a covariate or predictor variable X on R^d and a real response variable Y, we observe m i.i.d. sam ples $Z_1^m = f(X_1;Y_1); \ldots; (X_m;Y_m)$ g from an unknown underlying distribution D. Consider a loss function (f;y) and de ne Q (f) (true risk) and \hat{Q} (f) (em pirical risk) as

where E_D is the expectation over the unknown true joint distribution D of (X;Y) (denoted by $E_{X;Y}$ previously); \hat{E} is the empirical expectation based on the sample Z_1^m .

Boosting estimators are constructed by applying A gorithm 2.1 with respect to the empirical expectation \hat{E} with a set S of real-valued basis functions g(x). We use $\hat{A}(f)$ to denote the empirical objective function,

$$\hat{A}(f) = (\hat{Q}(f)) = (\hat{E}(f(X);Y)):$$

Similarly, quantities f_k , $_k$ and g_k in A loorithm 2.1 will be replaced by $\hat{f_k}$, k_k and $\hat{g_k}$, respectively.

Techniques from modern empirical process theory can be used to analyze the statistical convergence of a boosting estimator with a nite sample. In particular, we use the concept of R adem acher complexity, which is given by the following de nition.

Definition 3.2. Let G = fg(x;y)g be a set of functions of input (x;y). Let $f_{ig_{i=1}^{m}}$ be a sequence of binary random variables such that $_{i} = 1$ with probability 1=2. The (one-sided) sample-dependent Radem acher complexity of G is given by

and the expected R adem acher com plexity of G is denoted by

The R adem acher com plexity approach for analyzing boosting algorithm s rst appeared in [21], and it has been used by various people to analyze learning problem s, including boosting; for exam ple, see [3, 2, 4, 6, 30]. The analysis using R adem acher com plexity as de ned above can be applied both to regression and to classi cation. However, for notational sim plicity we focus only on boosting m ethods for classi cation, where we im pose the following assumption. This assumption is not essential to our analysis, but it sim pli es the calculations and some of the nalconditions.

A ssumption 3.2. We consider the following form of in (8): (f;y) = (fy) with a convex function (a): R ! R such that (a) > (a) for all a > 0.M oreover, we assume that

- (i) Condition (7) holds.
- (ii) S in Algorithm 2.1 is closed under negation (i.e., f 2 S ! f 2 S).
 (iii) There exists a nite Lipschitz constant () of in [;]:
 - - $8 j_1 j_2 j_2 j_1 (f_1) (f_2) j_1 f_2 j_1$

The Lipschitz condition of a loss function is usually easy to estimate. For reference, we list for loss functions considered in Section A 1:

(a) Logistic regression $(f) = \ln(1 + \exp(f))$: () 1. (b) Exponential $(f) = \exp(f)$: () $\exp(f)$. (c) Least squares $(f) = (f - 1)^2$: () 2(f + 1). (d) Modi ed least squares $(f) = \max(1 - f; 0)^2$: () 2(f + 1). (e) p-norm $(f) = f - 1^{p}(p - 2)$: () $p(f + 1)^{p-1}$.

3.3. Main statistical results. We may now state the main statistical results based on the assumptions and de nitions given earlier. The following theorem gives conditions for our boosting algorithm so that consistency can be achieved in the large sample limit. The proof is deferred to Section 5.2, with some auxiliary results.

Theorem 3.1. Under Assumption 3.2 let be one of the loss functions considered in Section A.1. Assume further that in Algorithm 2.1 we choose guantities f_0 , " $_k$ and $_k$ to be independent of the sample Z_1^m , such that $\int_{j=0}^{1} "_j < 1$, and $h_k = \sup_k$ satis es (4).

Consider two sequences of sample independent numbers k_m and m such that $\lim_{m \leq 1} k_m = 1$ and $\lim_{m \leq 1} (m) m R_m$ (S) = 0. Then as long as we stop A loorithm 2.1 at a step \hat{k} based on Z_1^m such that $\hat{k} = k_m$ and $k f_{\hat{k}} k_1 m$, we have the consistency result

Remark 3.2. The choice of $(k_m; m)$ in the above theorem should not be void, in the sense that for all samples Z_1^m it should be possible to stop A lgorithm 2.1 at a point such that the conditions $\hat{k} = k_m$ and $k f_{\hat{k}} k_1 = m$ are satis ed.

In particular, if $\lim_{m \mid 1} R_m(S) = 0$, then we can always nd $k_m k_m^0$ such that $k_m \mid 1$ and $\binom{m}{m} R_m(S) \mid 0$ with $m = kf_0k_1 + \frac{P_{k_m^0}}{j=0}h_j$. This choice of $(k_m; m)$ is valid as we can stop the algorithm at any $\hat{k} \geq [k_m; k_m^0]$.

Sim ilar to the consistency result, we may further obtain some rate of convergence results. This work does not focus on rate of convergence analysis, and results we obtain are not necessarily tight. Before stating a more general and more complicated result, we rst present a version for constant step-size logistic boosting, which is much easier to understand.

Theorem 3.2. Consider the logistic regression loss function, with basis S which satis es R_m (S) $\frac{c_s}{m}$ for some positive constant C_s . For each sample size m, consider A borithm 2.1 with $f_0 = 0$, $\sup_k k = h_0 (m)$ $1 = \frac{p_m}{m}$ and $"_k h_0 (m)^2 = 2$. A ssume that we run boosting for $k (m) = m = h_0 (m)$ steps. Then

$$\mathbb{E}_{Z_{1}^{m}} Q(\hat{f}_{\hat{k}}) \quad \inf_{f2 \text{ span}(S)} Q(f) + \frac{(2C_{S} + 1)_{m}}{p_{\overline{m}}} + \frac{kfk_{1} + 1}{p_{\overline{m}}} + \frac{kfk_{1}}{kfk_{1} + m} :$$

Note that the condition R_m (S) $C_s = \frac{p_m}{m}$ is satisfied for many basis function classes, such as two-level neural networks and tree basis functions (see Section 4.3). The bound in Theorem 3.2 is independent of h_0 (m) [as long as h_0 (m) m¹⁼²]. Although this bound is likely to be suboptimal for practice problems, it does give a worst case guarantee for boosting with the greedy optimization aspect taken into consideration. A ssume that there exists f 2 span (S) such that Q (f) = $\inf_{f_2 \text{ span}} Q$ (f). Then we may choose m as m = 0 (kf k₁¹⁼² m¹⁼⁴), which gives a convergence rate of $E_{Z_1^m} Q$ (\hat{f}_k) Q (f) + 0 (kf k_1^{1=2} m¹⁼⁴). As the target com plexity kf k₁ increases, the convergence becom es slow er. An exam ple is provided in Section 6 to illustrate this phenom enon.

We now state the more general result, on which Theorem 3.2 is based (see Section 5.3).

Theorem 3.3. Under Assumption 3.2, let (f) 0 be a loss function such that A (f) satis es A ssumption 3.1 with the choice (a) = a.G iven a sample size m, we pick a positive nonincreasing sequence fh_kg which may depend on m.Consider A porithm 2.1 with $f_0 = 0$, $\sup_k k = h_k$ and $"_k h_k^2 M$ (s_{k+1})=2, where s_k = $\begin{bmatrix} k & 1 \\ i & 0 \end{bmatrix} h_i$.

Given training data, suppose we run boosting for $\hat{k} = k \text{ (m)}$ steps, and let $m = s_{k \text{ (m)}}$. Then 8f 2 span (S) such that Q (f) Q (0)

If the target function is f which belongs to span(S), then Theorem 3.3 can be directly interpreted as a rate of convergence result. However, the expression of $_{\rm m}$ may still be quite complicated. For speci c loss function and step-size choices, the bound can be simplied. For example, the result for logistic boosting in Theorem 3.2 follows easily from the theorem (see Section 5.3).

4. Preparatory results. As discussed earlier, it is well known by now that boosting can over t if left to run until convergence. In Section 3.3 we stated our main results that with appropriately chosen stopping rules and under regularity conditions, results of consistency and rates of convergence can be obtained. In this section we begin the proof process of these main results by proving the necessary preparatory results, which are interesting in their own right, especially those on num erical convergence of boosting in Section 4.1.

Suppose that we run A lgorithm 2.1 on the sample Z_1^m and stop at step \hat{k} . By the triangle inequality and for any f 2 span (S), we have

(9)

The middle term is on a xed f, and thus it has a rate of convergence 0 (1 = m) by the CLT. To study the consistency and rates of convergence of boosting with early stopping, the work lies in dealing with the rst and third terms in (9). The third term is on the empirical performance of the boosting algorithm, and thus a numerical convergence analysis is required and hence proved in Section 4.1. Using modern empirical process theory, in Section 4.2 we upper bound the rst term in terms of R adem acher complexity.

We will focus on the loss functions (such as those in Section A 1) which satisfy A ssumption 3.1. In particular, we assume that is a monotonic increasing function, so that m inim izing A (f) or \hat{A} (f) is equivalent to m inim izing Q (f) or \hat{Q} (f). The derivation in Section 4.2 works with Q (f) and \hat{Q} (f) directly, instead of A (f) and \hat{A} (f). The reason is that, unlike our convergence analysis in Section 4.1, the relatively simple sample complexity analysis presented in Section 4.2 does not take advantage of .

where

4.1. Numerical convergence analysis. Here we consider the numerical convergence behavior of f_k obtained from the greedy boosting procedure as k increases. For notational simplicity, we state the convergence results in term s of the population boosting algorithm, even though they also hold for the empirical boosting algorithm. The proofs of the two main lemmas are deferred to Section A 2.

In our convergence analysis, we will specify convergence bounds in terms of kfk₁ (where f is a reference function) and a sequence of nondecreasing numbers s_k satisfying the following condition: there exist positive numbers h_k such that

where f $_k$ g are the step-sizes in (3). Note that h_k in (10) can be taken as any number that satis es the above condition, and it can depend on f $_k$ g computed by the boosting algorithm . However, it is often desirable to state a convergence result that does not depend on the actual boosting outputs (i.e., the actual $_k$ computed). For such results we may simply $x h_k$ by letting $h_k = \sup_k$. This gives convergence bounds for the restricted stepsize m ethod which we mentioned earlier.

It can be shown (see Section A 2) that even in the worse case, the value A (f_{k+1}) A (f) decreases from A (f_k) A (f) by a reasonable quantity. C ascading this analysis leads to a num erical rate or speed of convergence for the boosting procedure.

The following lemma contains the one-step convergence bound, which is the key result in our convergence analysis.

Applying Lemma 4.1 repeatedly, we arrive at a convergence bound for the boosting A lgorithm 2.1 as in the following lemma.

The above lemma gives a quantitative bound on the convergence of A (f_k) to the value A (f) of an arbitrary reference function f 2 span(S). We can see that the num erical convergence speed of A (f_k) to A (f) depends on kfk₁ and the accumulated or total step-size s_k . Specifically, if we choose f such that A (f) A (f_0) , then it follows from the above bound that

Note that the inequality is autom atically satis ed when A (f_{k+1}) A (f).

Clearly, in order to select f to optimize the bound on the right-hand side, we need to balance a trade-o: we may select f such that A (f) (and thus the rst term) becomes smaller as we increase kfk_1 ; however, the other two terms will become large when kfk_1 increases. This bound also reveals the dependence of the convergence on the initial value of the algorithm f_0 : the closer A (f_0) gets to the in nimum of A, the smaller the bound. To our know ledge, this is the rst convergence bound for greedy boosting procedures with quantitative num erical convergence speed information.

P revious analyses, including m atching pursuit for least squares [29], B reim an's analysis [9] of the exponential loss, as well as the B regm an divergence bound in [12] and the analysis of gradient boosting in [31], were all limiting results without any information on the numerical speed of convergence. The key conceptual di erence here is that we do not compare to the optim al value directly, but instead, to the value of an arbitrary f 2 span (S), so that kfk₁ can be used to measure the convergence speed. This approach is also crucial for problem s where A () can take 1 as its in nimum, for which a direct comparison will clearly fail (e.g., B reim an's exponential loss analysis requires sm oothness assumptions to prevent this 1 in nimum value).

A general limiting convergence result follows directly from the above lemma.

Theorem 4.1. Assume that $P_{j=0} "_j < 1$ and $P_{j=0} h_j = 1$; then we have the following optimization convergence result for the greedy boosting algorithm (2.1):

The above results regarding population m inim ization automatically apply to the empirical minimization if we assume that the starting point f_0 , as well as quantities "_k and _k in (3), are sample-independent, and the restricted step-size case where $h_k = \sup_k$ satisfies the condition (4).

The idea of restricting the step-size when we compute $_{j}$ was advocated by Friedman, who discovered empirically that taking small step-size helps [14]. In our analysis, we can restrict the search region so that Corollary 4.1 is automatically satis ed. Since we believe this is an important case which applies for general loss functions, we shall explicitly state the corresponding convergence result below.

Corollary 4.2. Consider a loss function (e.g., those in Section A 1) such that $\sup_a M$ (a) < +1 .P ick any sequence of positive numbers h_j (j 0) such that $\prod_{j=0}^{1}h_j=1$, $\prod_{j=0}^{1}h_j^2<1$. Note that the above result requires that the step-size h_j be small ($\stackrel{P}{_{j=0}}h_j^2<1$), but also not too small ($\stackrel{1}{_{j=0}}h_j=1$). As discussed above, the rst condition prevents large oscillation. The second condition is needed to ensure that f_k can cover the whole space span(S).

The above convergence results are limiting results that do not carry any convergence speed information. Although with specic choices of h_k and s_k one may obtain such information from (14), the second term on the right-hand side is typically quite complicated. It is thus useful to state a simple result for a specic choice of h_k and s_k , which yields more explicit convergence information.

Corollary 4.3. Assume that A (f) satis as Assumption 3.1. Pick a sequence of nonincreasing positive numbers h_j (j 0). Note that similar to the proof of Theorem 4.1, the term $(k)h_{v}^{2}$ in C orollary 4.3 can also be replaced by $\int_{j=v+1}^{p} h_{j}^{2}$. A special case of C orollary 4.3 is constant step-size $(h_{k} = h_{0})$ boosting, which is the original version of restricted step-size boosting considered by Friedman [14]. This method is simple to apply since there is only one step-size parameter to choose. C orollary 4.3 shows that boosting with constant step-size (also referred to as "-boosting in the literature) converges to the optim al value in the limit of h_{0} ! 0, as long as we choose the number of iterations k and step-size h_{0} such that kh_{0} ! 1 and kh_{0}^{2} ! 0. To the best of our know ledge, this is the only rigorously stated convergence result for the "-boosting method, which justi es why one needs to use a step-size that is as small as possible.

It is also possible to handle sample-dependent choices of $_k$ in Algorithm 2.1, or allow unrestricted step-size ($_k = R$) for certain formulations. However, the corresponding analysis becomes much more complicated. A coording to Friedman [14], the restricted step-size boosting procedure is preferable in practice. Therefore we shall not provide a consistency analysis for unrestricted step-size formulations in this paper; but see Section A.3 for relaxations of the restricted step-size condition.

In addition to the above convergence results for general boosting algorithm s, Lem m a 4.2 has another very useful consequence regarding the lim iting behavior of A daB oost in the separable classi cation case. It asserts that the in nitely sm all step-size version of A daB oost, in the convergence lim it, is an L_1 m argin m axim izer. This result has been observed through a connection between boosting with early stopping and L_1 constrained boosting (see [18]). O ur analysis gives a direct and rigorous proof. This result is interesting because it shows that A daB oost shares some sim ilarity (in the lim it) with support vector m achines (SVM s) whose goal in the separable case is to nd m axim um m argin classi ers; the concept of m argin has been popularized by Vapnik [36] who used it to analyze the generalization perform ance of SVM s. The detailed analysis is provided in Section A 4.

42. Uniform convergence. There are a number of possible ways to study the uniform convergence of empirical processes. In this section we use a relatively simple approach based on R adem acher complexity. E xam ples with neural networks and tree-basis (left orthants) functions will be given to illustrate our analysis.

The R adem acher complexity approach for analyzing boosting algorithms appeared rst in [21]. Due to its simplicity and elegance, it has been used and generalized by many researchers [2, 3, 4, 6, 30]. The approach used here essentially follows Theorem 1 of [21], but without concentration results.

From Lemma 4.2 we can see that the convergence of the boosting procedure is closely related to kfk_1 and kf_kk_1 . Therefore it is natural for us to m easure the learning complexity of A lgorithm 2.1 based on the 1-norm of the function family it can approximate at any given step. We shall mention that this analysis is not necessarily the best approach for obtaining tight learning bounds since the boosting procedure may electively search a much smaller space than the function family measured by the 1-norm kf_kk_1 . How – ever, it is relatively simple, and su cient for our purpose of providing an early-stopping strategy to give consistency and some rate of convergence results.

Given any > 0, we now would like to estimate the rate of uniform convergence,

A function class F that satis es A sum ption 4.1 is also a D onsker class, for which the central lim it theorem holds. In statistics and machine learning, one often encounters function classes F with nite VC-dimension, where the following condition holds (see Theorem 2.6.7 of [35]) for some constants C and V independent of \mathbb{N}_2 (";F;m) C (1=")^V. C learly a function class with nite VC-dimension satis es A ssum ption 4.1.

For simplicity, in this paper we assume that S satis es A ssumption 4.1. It follows that

Træ-basis functions. Træ-basis (left orthant) functions in R $^{\rm d}$ are given by the indicator function of rectangular regions,

Similar to two-level neural networks, it is well known that S has a nite VC-dimension, and for any compact set U 2 R^d, span(S) is dense in C (U).

In addition to rectangular region basis functions, we may also consider a basis S consisting of restricted size classi cation and regression trees (disjoint unions of constant functions on rectangular regions), where we assume that the number of term inal nodes is no more than a constant V. Such a basis set S also has a nite VC-dimension.

5. Consistency and rates of convergence with early stopping. In this section we put together the results in the preparatory Section 4 to prove consistency and some rate of convergence results for A kyorithm 2.1 as stated in the main result Section 3.3. For sim plicity we consider only restricted step-size boosting with relatively simple strategies for choosing step-sizes. A coording to Friedman [14], the restricted step-size boosting procedure is preferable in practice. Therefore we shall not provide a consistency analysis for unrestricted step-size formulations in this paper. D iscussions on the relaxation of the step-size condition can be found in Section A.3.

5.1. General decomposition. Suppose that we run the boosting algorithm and stop at an early stopping point \hat{k} . The quantity \hat{k} , which is to be specified in Section 5.2, may depend on the empirical sample Z_1^m . Suppose also that the stopping point \hat{k} is chosen so that the resulting boosting estimator $\hat{f}_{\hat{k}}$ satisfies

C learly, in order to prove consistency, we only need to stop at a point such that 8 f 2 span (S), all three terms in (19) become nonpositive in the lim it m ! 1 .By estimating the third term using Lemma 42, we obtain the following proof of our main consistency result (Theorem 3.1).

O beerve that the right-hand side is independent of the sample Z_1^m . The following universal consistency result is a straightforward consequence of Theorem 3.1.

The goal of classi cation is to nd a predictor f to minimize (21). Using the notation (x) = P(Y = 1 - x), it is wellknown that L, the minimum of L(f), can be achieved by setting f(x) = 2 (x) 1. Let D be a Borel measure de ned on U f 1;1g; it is known (e.g., see [38]) that if Q(f)! inf_{f2B(U)}Q(f), then L(f)! L. Note that in the above theorem the stopping criterion k_m is sample-independent. However, similar to Theorem 3.1, we may allow other sample-dependent \hat{k} such that $k f_{\hat{k}} k_1$ stays within the $_m$ bound. One may be tempted to interpret the rates of $_m$. However, since di erent loss functions approximate the underlying distribution in di erent ways, it is not clear that one can rigorously compare them .Moreover, our analysis is likely to be loose.

5.3. Some bounds on the rate of convergence. In addition to consistency, it is also useful to study statistical rates of convergence of the greedy boosting m ethod with certain target function classes. Since our analysis is based on the 1-norm of the target function, the natural function classes we may consider are those that can be approximated wellusing a function in span(S) with small 1-norm.

We would like to emphasize that rate results, that have been stated in Theorem s 3.2 and 3.3 and are to be proved here, are not necessarily optim al. There are several reasons for this. First, we relate the num erical behavior of boosting to 1-norm regularization. In reality, this may not always be the best way to analyze boosting since boosting can be studied using other com – plexity m easures such as sparsity (e.g., see [22] for some other com plexity m easures). Second, even with the 1-norm regularization com plexity m easure, the num erical convergence analysis in Section 4.1 m ay not be tight. This again will adversely a ect our nalbounds. Third, our uniform convergence analysis, based on the relatively sim ple R adem acher com plexity, is not necessarily tight. For some problem s there are m ore sophisticated m ethods which im prove upon our approach here (e.g., see [2, 3, 4, 5, 6], [2, 30]]).

A related point is that bounds we are interested in here are a priori convergence bounds that are data-independent. In recent years, there has been much interest in developing data-dependent bounds which are tighter (see references mentioned above). For example, in our case we may allow

in (16) to depend on the observed data (rather than simply setting it to be a value based only on the sample size). This approach, which can tighten the nalbounds based on observation, is a quite signi cant recent theoretical advance. However, as mentioned above, there are other aspects of our analysis that can be bose. Moreover, we are mainly interested in worst case scenario upper bounds on the convergence behavior of boosting without boking at the data. Therefore we shall not develop data-dependent bounds here.

The statistical convergence behavior of the boosting algorithm relies on its num erical convergence behavior, which can be estimated using (14). Com – bined with statistical convergence analysis, we can easily obtain our main rate of convergence result in Theorem 3.3.

6. Experiments. The purpose of this section is not to reproduce the large number of already existing empirical studies on boosting. A lthough this paper is theoretical in nature, it is still useful to empirically exam ine various implications of our analysis, so that we can verify they have observable consequences. For this reason our experiments focus mainly on aspects of boosting with early stopping which have not been addressed in previous studies.

Speci cally, we are interested in testing consistency and various issues of boosting with early stopping based on our theoretical analysis. A s pointed out in [28], experimentally testing consistency is a very challenging task. Therefore, in this section we have to rely on relatively simple synthetic data, for which we can precisely control the problem and the associated Bayes risk. Such an experimental setup serves the purpose of illustrating main insights revealed by our theoretical analyses.

6.1. Experimental setup. In order to fully control the data generation mechanism, we shall use simple one-dimensional examples. A similar experimental setup was also used in [23] to study various theoretical aspects of voting classication methods.




Fig.1. Target conditional probability for d = 2.


Our goal is to predict Y 2 f 1g based on X 2 [0;1]. Throughout the experiments, X is uniformly distributed in [0;1]. We consider the target conditional probability of the form P (Y = 1)X) = 2fdX gI (fdX g 0.5) + 2(1 fdX g) I (fdX g > 0.5), where d 1 is an integer which controls the complexity of the target function, and I denotes the set indicator function. We have also used the notation fzg = z bzc to denote the decimal part of a real number z, with the standard notation of bzc for the integer part of z. The Bayes error rate of our model is always 0.25.

G raphically, the target conditional probability contains d triangles. Figure 1 plots such a target for d = 2.

We use one-dimensional stumps of the form I([0;a]) as our basis functions, where a is a parameter in [0;1]. They form a complete basis since each interval indicator function I((a;b]) can be expressed as I([0;b]) = I([0;a]).

There have been a number of experimental studies on the impact of using dierent convex loss functions (e.g., see [14, 27, 28, 39]). A lthough our theoretical analysis applies to general loss functions, it is not rened enough to suggest that any one particular loss is better than another. For this reason, our experimental study will not include a comprehensive comparison of different loss functions. This task is better left to dedicated empirical studies (such as some of those mentioned above).

We will only focus on consequences of our analysis which have not been well studied empirically. These include various issues related to early stopping and their impact on the performance of boosting. For this purpose, throughout the experiments we shall only use the least-squares loss function. In fact, it is known that this loss function works quite well for many classication problems (see, e.g., [11, 27]) and has been widely applied to many patterm-recognition applications. Its simplicity also makes it attractive.

For the least-squares loss, the target function which the boosting procedure tries to estimate is f (x) = 2P (Y = 1K = x) 1. In our experiments, unless otherwise noted, we use boosting with restricted step-size, where at each iteration we limit the step-size to be no larger than $h_i = (i + 1)^{2=3}$. This choice satis are our numerical convergence requirement, where we need the conditions $_ih_i = 1$ and $_ih_i^2 < 1$. Therefore it also satis as the consistency requirement in Theorem 3.1.

62. Early stopping and over thing. A lthough it is known that boosting forever can over t (e.g., see [16, 19]), it is natural to begin our experiments by graphically showing the elect of early-stopping on the predictive performance of boosting.

W e shall use the target conditional probability described earlier with com – p lexity d = 2, and training sam p le-size of 100. Figure 2 plots the graphs of estimators obtained after k = 32 and 1024 boosting iterations. The dotted lines




Fig. 3. Predictive perform ance of boosting as a function of boosting iterations.




Fig. 4. Training error.

on the background show the true target function f (x) = 2P (Y = 1)X = x). We can see that after 32 iterations, the boosting estimator, although not perfect, roughly has the same shape as that of the true target function. However, after 1024 iterations, the graph appears quite random, im plying that the boosting estimator starts to over t the data.

F igure 3 shows the predictive perform ance of boosting versus the number of iterations. The need for early stopping is quite apparent in this example. The excessive classication error quantity is dened as the true classication error of the estimator minus the Bayes error (which is 0.25 in our case). Similarly, the excessive convex loss quantity is dened as the true leastsquares loss of the estimator minus the optimal least-squares loss of the target function f (x). Both excessive classication error and convex loss are evaluated through numerical integration for a given decision rule. Moreover, as we can see from F igure 4, the training error continues to decrease as the number of boosting iterations increases, which eventually leads to over thing of the training data.

6.3. Early stopping and total step-size. Since our theoretical analysis favors restricted step-size, a relevant question is what step-size we should choose. We are not the rst authors to look into this issue. For example, Friedm an and his co-authors suggested using sm all steps [14, 15]. In fact, they argued that the sm aller the step-size, the better. They perform ed a number of empirical studies to support this claim. Therefore we shall not reinvestigate this issue here. Instead, we focus on a closely related in plication of our analysis, which will be useful for the purpose of reporting experim ental results in later sections.

Let $_{i}$ be the step-size taken by the boosting algorithm at the ith iteration. Our analysis characterizes the convergence behavior of boosting after




Fig. 5. Predictive perform ance of boosting as a function of total step-size.

the kth step, not by the number of iterations k itself, but rather by the quantity $s_k = \sum_{i k} h_i$ in (10), as long as $\sum_{i k} h_i 2_{pi}$. Although our theorem s are stated with the quantity $\sum_{i k} h_i$, instead of $\sum_{i k} i$, it does suggest that in order to compare the behavior of boosting under di erent con gurations, it is more natural to use the quantity $\sum_{i k} i$ (which we shall call total step-size throughout later experiments) as a measure of stopping point rather than the actual number of boosting iterations. This concept of total step-size also appeared in [18, 17].

Figure 5 shows the predictive perform ance of boosting versus the total step-size. We use 100 training examples, with the target conditional probability of complexity d = 3. The unrestricted step-size method uses exact optimization. Note that for least-squares loss, as explained in Section A 3, the resulting step-sizes will still satisfy our consistency condition $\frac{2}{1} < 1$. The restricted step-size scheme with step-size hemploys a constant step-size restriction of 1 h. This experiment shows that the behavior of these di erent boosting methods is quite similar when we measure the performance not by the number of boosting iterations, but instead by the total step-size. This observation justi es our theoretical analysis, which uses quantities closely related to the total step-size to characterize the convergence behavior of boosting methods. Based on this result, in the next few experiments we shall use the total step-size (instead of the number of boosting iterations) to compare boosting methods under di erent con gurations.

6.4. The e ect of sam ple-size on early stopping. An interesting issue for boosting with early stopping is how its predictive behavior changes when the number of sam ples increases. A lthough our analysis does not o er a quantitative characterization, it im plies that we should stop later (and the allow able stopping range becomes wider) when sam ple size increases. This




Fig. 6. Predictive perform ance of boosting at di erent sam ple sizes.

essentially suggests that the optim al stopping point in the boosting predictive perform ance curve will increase as the sample size increases, and the curve itselfbecom es atter. It follows that when the sample size is relatively large, we should run boosting algorithms for a longer time, and it is less necessary to do aggressive early stopping.

The above qualitative characterization of the boosting predictive curve also has important practical consequences. We believe thism ay be one reason why in many practical problem sit is very dicult for boosting to over t, and practitioners often observe that the perform ance of boosting keeps improving as the number of boosting iterations increases.

Figure 6 shows the e ect of sample size on the behavior of the boosting method. Since our theoretical analysis applies directly to the convergence of the convergence of classi cation error follows in plicitly as a consequence of convex loss convergence), the phenom enon described above is more apparent for excessive convex loss curves. The e ect on classication error is less obvious, which suggests there is a discrepancy between classi cation error perform ance and convex loss minimization perform ance.

6.5. Early stopping and consistency. In this experiment we demonstrate that as sample size increases, boosting with early stopping leads to a consistent estimator with its error rate approaching the optimal Bayes error. Clearly, it is not possible to prove consistency experimentally, which requires running a sample size of 1. We can only use a nite number of samples to demonstrate a clear trend that the predictive performance of boosting with early stopping converges to the Bayes error when the sample size increases. Another main focus of this experiment is to compare the performance of di erent early stopping strategies.




Fig. 7. Consistency and early stopping.

Theoretical results in this paper suggest that for least squares loss, we can achieve consistency as long as we stop at total step-size approxim ately m with < 1=4, where m is the sample size. We call such an early stopping strategy the -strategy. Since our theoretical estimate is conservative, we exam ine the -strategy both for = 1=6 and for = 1=4. Instead of the theoretically motivated (and suboptim al) -strategy, in practice one can use cross validation to determ ine the stopping point. We use a sam ple size of one-third the training data to estim ate the optim al stopping total stepsize which m in im izes the classi cation error on the validation set, and then use the training data to compute a boosting estimator which stops at this cross-validation-determ ined total step-size. This strategy is referred to as the cross validation strategy. Figure 7 compares the three early stopping strategies mentioned above. It may not be very surprising to see that the cross-validation-based method is more reliable. The -strategies, although they perform less well, also demonstrate a trend of convergence to consistency. We have also noticed that the cross validation scheme stops later than the -strategies, in plying that our theoretical results in posem ore restrictive conditions than necessary.




Fig. 8. Consistency and early stopping.

It is also interesting to see how well cross validation nds the optim al stopping point. In Figure 8 we compare the cross validation strategy with two oracle strategies which are not implementable: one selects the optim al stopping point which m inim izes the true classication error (which we refer to as optim al error), and the other selects the optim al stopping point which m inim izes (which we refer to as optim al convex risk). These two m ethods can be regarded as ideal theoretical stopping points for boosting m ethods. The experiment shows that cross validation performs quite well at large sample sizes.

In the log coordinate space, the convergence curve of boosting with the cross validation stopping criterion is approximately a straight line, which

implies that the excess errors decrease as a power of the sample size. By extrapolating this inding, it is reasonable for us to believe that boosting with early stopping converges to the Bayes error in the limit, which veries the consistency. The two stopping rules, even though showing much slower linear convergence trend, also lead to consistency.

6.6. The e ect of target function com plexity on early stopping. A lthough we know that boosting with an appropriate early stopping strategy leads to a consistent estimator in the large sample limit, the rate of convergence depends on the complexity of the target function (see Section 5.3). In our analysis the complexity can be measured by the 1-norm of the target function. For target functions considered here, it is not very di cult to show that in order to approximate to an accuracy within ", it is only necessary to use a combination of our decision stumps with the 1-norm C d=". In this form ula C is a constant and d is the complexity of the target function.




Fig. 9. The e ect of target function complexity.

O ur analysis suggests that the convergence behavior of boosting with early stopping depends on how easy it is to approxim ate the target function using a combination of basis functions with small 1-norm. A target with d = u is u-times as discult to approximate as a target with d = 1. Therefore the optim all stopping point, measured by the total step-size, should accordingly increase as d increases. Moreover, the predictive performance becomes worse. Figure 9 illustrates this phenomenon with d = 1;3;5 at the sample size of 300. Notice again that since our analysis applies to the convex risk, this phenomenon is much more apparent for the excessive convex loss performance than the excessive classi cation error performance. C learly this again shows that although by minimizing a convex loss we indirectly minimize the classi cation error, these two quantities do not behave identically.

7. Conclusion. In this paper we have studied a general version of the boosting procedure given in A lgorithm 2.1. The num erical convergence behavior of this algorithm has been studied using the so-called averaging technique, which was previously used to analyze greedy algorithm s for optim ization problem s de ned in the convex hull of a set of basis functions. We have derived an estimate of the num erical convergence speed and established conditions that ensure the convergence of A lgorithm 2.1. O ur results generalize those in previous studies, such as the matching pursuit analysis in [29] and the convergence analysis of A daB oost by B reim an [9].

Furtherm ore, we have studied the learning com plexity of boosting algorithm sbased on the R adem acher com plexity of the basis functions. Together with the num erical convergence analysis, we have established a general early stopping criterion for greedy boosting procedures for various loss functions that guarantees the consistency of the obtained estim ator in the large sam – ple lim it. For speci c choices of step-sizes and sam ple-independent stopping criteria, we have also been able to establish bounds on the statistical rate of convergence. W e would like to m ention that the learning com plexity analysis given in this paper is rather crude. C onsequently, the required conditions in our consistency strategy m ay be m ore restrictive than one actually needs.

A number of experiments were presented to study various aspects of boosting with early stopping. We speci cally focused on issues that have not been covered by previous studies. These experiments show that various quantities and concepts revealed by our theoretical analysis lead to observable consequences. This suggests that our theory can lead to useful insights into practical applications of boosting algorithm s.

R emark A.1. Similar to the least squares case, we can de ne the modi ed p-norm loss for classi cation problem s. A lthough the case p2 (1;2) can be handled by the proof techniques used in this paper, it requires a modi ed analysis since in this case the corresponding loss function is not second-order di erentiable at zero. See related discussions in [37]. Note that the hinge loss used in support vector machines cannot be handled directly with our current technique since its rst-order derivative is discontinuous. However, one may approxim ate the hinge loss with a continuously di erentiable function, which can then be analyzed.

A 2. Num erical convergence proofs. This section contains two proofs for the num erical convergence analysis section (Section 4.1).

Proof of the one-step analysis or Lemma 4.1. Given an arbitrary xed reference function f 2 span(S) with the representation

A 3. D iscussion of step-size. We have been deriving our results in the case of restricted step-size in which the crucial small step-size condition is explicit. In this section we investigate the case of unrestricted step-size under exact m inim ization, for which we show that the small step-size condition is actually in plicit if the boosting algorithm converges. The implication is that the consistency (and rate of convergence) results can be extended to such a case, although the analysis becomes more complicated.

Let $_k = R$ for all k, so that the size of $_k$ in the boosting algorithm is unrestricted. For simplicity, we will only consider the case that $\sup_a M$ (a) is upper bounded by a constant M.

Interestingly enough, although the size of $_k$ is not restricted in the boosting algorithm itself, for certain formulations the inequality $_j^2 < 1$ still holds. Theorem 4.1 can then be applied to show the convergence of such boosting procedures. For convenience, we will impose the following additional assumption for the step-size $_k$ in Algorithm 2.1:

Using exact computation, Breim an obtained an equality similar to the matching pursuit energy conservation equation. A lthough unrestricted step-size boosting procedures can be successful in certain cases, for general problem s we are unable to prove convergence. In such cases the crucial condition of $\frac{1}{j=0}$ $\frac{2}{j} < 1$, as required in the proof of C orollary A 1, can be violated. A lthough we do not have concrete exam ples at this point, we believe boosting m ay fail to converge when this condition is violated.

For example, for logistic regression we are unable to prove a result similar to Lemma A 2. The di culty is caused by the near-linear behavior of the loss function toward negative in nity. This means that the second derivative is so sm all that we may take an extrem ely large step-size when _j is exactly minim ized.

Intuitively, the di culty associated with large $_{j}$ is due to the potential problem of large oscillation in that a greedy step m ay search for a suboptim al direction, which needs to be corrected later on. If a large step is taken toward the suboptim al direction, then m any m ore additional steps have to be taken to correct the m istake. If the additional steps are also large, then w e m ay overcorrect and go to some other suboptim al directions. In general it becomes di cult to keep track of the overall e ect.

A 4. The relationship of A daB oost and L $_1$ -m argin m axim ization. G iven a real-valued classi cation function p(x), we consider the following discrete prediction rule:

This implies that as h! = 0, $f_k(x) = kf_kk_1$ achieves a margin that is within h of the maximum possible. Therefore, when h! and k! = 1, $f_k(x) = kf_kk_1$ approaches a maximum margin separator.

Note that in this particular case we allow a small step-size (h <), which violates the condition $_kh_k^2 < 1$ imposed for the boosting algorithm to converge. However, this condition that prevents large oscillation from occurring is only a su cient condition to guarantee convergence. For speci c problem s, especially when $\inf_{f2\,span\,(S)}A(f)=1$, it is still possible to achieve convergence even if the condition is violated.
