A comparative study of two stochastic mode reduction methods

Abstract

W e present a com parative study of two m ethods for the reduction of the dimensionality of a system of ordinary di erential equations that exhibits time-scale separation. Both m ethods lead to a reduced system of stochastic di erential equations. The novel feature of these m ethods is that they allow the use, in the reduced system, of higher order terms in the resolved variables. The rst m ethod, proposed by M ajda, T in ofeyev and Vanden-E inden, is based on an asym ptotic strategy developed by K urtz. The second m ethod is a short-m em ory approximation of the M ori-Zw anzig projection form alism of irreversible statistical m echanics, as proposed by C horin, H ald and K upferm an. W e present conditions under which the reduced m odels arising from the two m ethods should have sim ilar predictive ability. W e apply the two m ethods to test cases that satisfy these conditions. The form of the reduced m odels and the num erical simulations show that the two m ethods have sim ilar predictive ability as expected.

Keywords: Mori-Zwanzig formalism, Stochastic mode reduction, scale separation, stochastic equations.

1 Introduction

In recent years have appeared di erent m ethods for reducing the dimensionality of a system of ordinary or stochastic di erential equations. The realization that despite the rapid increase of com putational power there are m any problem s that are too expensive to tackle directly, or that in several problem s the objects of interest are m acroscopic, coarse-grained quantities, has led m any

researchers to construct m ethods for extracting m odels of reduced dimensionality.Since them otivation to develop such m ethods comes usually from specic physical problem s, m ost m ethods exploit the m athem atical structure of the problem at hand, and thus are not suited for all problem s where dimensional reduction is needed.

Since there exists a whole range of dimension reduction methods, it is interesting to compare the behaviour of the reduced models predicted by diment methods in examples that are inspired by problems of physical interest. The purpose of the present work is to report some results of the application of the asymptotic mode reduction strategy (AMRS) and of the short-memory Mori-Zwanzig approximation (short-memory MZ) to a collection of models that share common features with more complicated systems that appear in the study of climate dynamics. These non-trivial test cases appeared in [1] where an analysis of their behaviour and of the performance of AMRS can be found. The analysis here suggests that the asymptotic mode reduction strategy and short-memory MZ approximation have, under conditions that we discuss in Section 4, similar predictive ability. The test cases satisfy these conditions and thus, we expect the reduced models arising from the two methods to have similar predictive ability. The form of the reduced models and the numerical simulations support our expectations.

The majority of the methods for dimensional reduction rely on a separation of time-scales between the variables of interest and the rest of the variables in the system under investigation. This separation of scales can be used in di erent ways depending on the form of the solutions for the fast dynam ics. Thus, in the case of inertial manifold methods [2], the fast variables are, after a short transient, slaved to the slow ones. In the case of methods that are known as "averaging methods" β , the fast variables are allowed to have m ore complex behaviour and a ect the slow variables through the empirical measure on the fast dynamics. The resulting equations for the slow variables are determ inistic. In the case of the asymptotic mode reduction strategy [4], the fast variables reach a statistical equilibrium much faster than the slow variables and this is used to obtain (in a certain limit) the reduction of the system 's dimension. The resulting system of equations for the slow variables is stochastic. In the case of [5] the resolved variables are coupled to a heat bath that is then approximated using the trigonom etric representation for Gaussian processes. Chorin, Hald and Kupferm an [6,7], have proposed the use of the Mori-Zwanzig projection formalism of irreversible statistical mechanics, for the reduction of the dimensionality of a system of ordinary di erential equations. In contrast to the previous methods, the Mori-Zwanzig projection form alism results in a reform ulation of the equations for the resolved variables. This does not make the problem of dimensional reduction easier. However, the reform ulation serves as a starting point for approxim ations of various degrees of sophistication depending on the properties of the problem at hand. Finally,

we should note the work of Papanicolaou [8{11] which uses a projection formalism (similar to Mori-Zwanzig, albeit with a dierent projection operator) on the level of the Fokker-Planck and backward Fokker-Planck (Chapman-Kolm ogorov) equations.

Every mode reduction method has two parts: a) identify the variables that will constitute the reduced description and b) nd the equations for these variables. The techniques mentioned above avoid the rst part by assuming that the variables to be picked are known in advance. However, know ledge of what are the "right" variables to pick in an arbitrary system is a very important and di cult problem, since di erent combinations of variables can lead to very di erent reduced equations. This is an important issue for the e cient numerical implementation of any mode reduction method. Techniques based on proper orthogonal decomposition [12], coarse-grained integration [13] and the transfer operator [14] attempt not only to perform dimension reduction, but also to identify the appropriate variables that will constitute the reduced system. A concise exposition of all the methods mentioned above along with applications to models can be found in [15].

The paper is organized as follows. In Section 2 we present a summary of the asymptotic mode reduction strategy as it is applied to a system of ordinary di erential equations. In Section 3 we present the Mori-Zwanzig projection form alism and the short-memory approximation arising from it which is appropriate for the examples that we will be studying. This approximation serves to illustrate some analogies and di erences between the two methods and we present them in Section 4. We also present conditions under which the two methods are expected to have similar behaviour. In Section 5 we present the equations for the test cases that we will be examining. Section 6 collects the results of the application of the two methods to the test cases. A short discussion follows in Section 7.

2 A sym ptotic m ode reduction strategy

Suppose we are given a system of ordinary di erential equations

with initial condition (0) = x: The asymptotic mode reduction strategy [4,16] is a two step procedure based on the assumption that the set of variables of the system have been split into two subsets, the resolved and unresolved. The objective is to construct equations for the evolution of the resolved variables by eliminating the unresolved variables. The splitting of the variables in resolved and unresolved and unresolved is not arbitrary but relies on the assumption that there exist

two sets of variables in the system that evolve on di erent time-scales. The slow variables are identified as resolved ones while the fast variables as unresolved. In the fast step, the equations for the unresolved variables are modified by replacing the nonlinear self-interaction terms between the unresolved variables by stochastic terms. The motivation for this is that the self-interaction terms govern the perturbations on short time-scales, and if we are interested in coarse-grained modelling on longer time-scales, these terms can be replaced accurately by stochastic terms. It is important to note that this replacement is an assumption that has to be checked case by case. The second step uses projection techniques for stochastic di erential equations [17{19,8] to elim inate the fast variables. The elimination procedure can be made rigorous in the limit of in nite separation of time-scales between resolved and unresolved variables (see e.g. [17]).

W e present a sum m ary of the two steps of the m ethod for a system of ordinary di erential equations. W e w ill focus on equations whose form can describe all the examples that we w ill study. M ore general form s can be found in [4,15] and references there.

For the state we assume that we have obtained in some way the splitting of the variables in resolved and unresolved such that these two sets evolve on di erent time-scales. Suppose that the vector of system variables can be written as $= (\hat{;});$ where $\hat{}$ are the resolved variables and $\hat{}$ the unresolved ones. Similarly, the initial conditions can be written as $x = (\hat{x}; x)$: The st step is to represent the nonlinear self-interactions between unresolved variables in the equations for the unresolved variables with suitable stochastic term s. In general, it is not easy to justify such a replacement (see e.g. [20]). For the examples that we study, the justi cation has been numerical [1]. We will return to this point when we present the test cases. We rewrite the system (1) as

where the term S(~) contains the nonlinear self-interaction term s between the unresolved variables and H () contains the rest of the term s on the RHS of the equations for the unresolved variables. The step of AMRS replaces the term S by the following stochastic expression

where ; are positive de nite (diagonal in our case) matrices and W (t) is a vector-valued W iener process. As mentioned in [4], the choice of this par-

ticular expression in not essential to the theory but it is convenient for the calculations because of the availability of explicit expressions for the inverse of the associated backward Fokker-P lanck operator. The parameter roughly measures the ratio of the correlation times of the unresolved variables to the resolved ones and its precise de nition will be given later when we study the test cases. The stochastic approximation introduces the matrices ; that have to be determined before we proceed with the second step of AMRS. The entries of and are chosen so as to minimize the difference between the statistical moments of the original system and those of the approximate stochastic approximation which introduces two parameters, the procedure will involve the one-time and two-time statistical properties of (1). We can use the uctuation-dissipation theorem (one-time statistics) to reduce the number of parameters to be determined to only the entries of the matrix : The matrix

is determ ined through the two-time statistics of (1). More details on how to determ ine ; will be given when we present the test cases.

W ith the stochastic approximation (3) the system (2) is replaced by

To facilitate the presentation, we can think of the following splitting of the RHS for the resolved variables,

where $\hat{R}^0()$ is the fast part of the RHS that includes the contributions from the unresolved variables, while $\hat{R}^1(\hat{})$ is the slow part that comes only from interactions between the resolved variables. The asymptotic mode reduction strategy can be made rigorous in the limit of ! 0:To prepare the equations for the nalelimination of the unresolved variables, we coarse-grain the time t ! t and we have

As can be seen from (5), the dynamics for \sim are an order of magnitude faster than the ones for $\hat{}$:

Before we proceed with the second step of AMRS that eliminates the unresolved variables, we note again that the approximation (3) is a working assumption that has to be checked case by case. However, if we assume that the approximation (3) is valid, then, due to a theorem by Kurtz [17], the process of elimination of the unresolved variables becomes rigorous in the limit of ininite scale separation. The theorem operates on the level of the Chapman-Kolm ogorov (or backward Fokker-Planck) equation associated with (5).

W hen presented with a system of stochastic di erential equations of the form (5) we can construct two linear partial di erential equations, one for the evolution of the probability density function (Fokker-P lanck equation) and one for the evolution of expectation values of functions of the solution (C hapm an-K olm ogorov equation). The C hapm an-K olm ogorov equation is the adjoint of the Fokker-P lanck equation with respect to the scalar product de ned on $X = R^n$; where n is the dimensionality of the system (1) (see below). We shall focus our attention on the C hapm an-K olm ogorov equation, since we are only interested in giving a brief account of AM RS (see [15] form ore details). For any scalar-valued function g(x), we de ne the quantity

where I_{x} ; I_{x} are index sets for the resolved and unresolved variables respectively. A lso, $_{j}$; $_{j}$ are the (diagonal) entries of the matrices ; :

The second step of AMRS eliminates the unresolved variables. From (6) we see that the limit ! 0 is singular. Also, that (6) is a partial di erential equation involving both resolved and unresolved variables. Thus, our aim is to derive (if possible), in the limit ! 0, a Chapman-Kolmogorov equation for the resolved variables only and from this equation read o the form of the corresponding stochastic system for the resolved variables. We will use only form almanipulations that can be made rigorous in the limit of ! 0 through Kurtz's theorem .We proceed by expanding the solution u (x;t) in powers of

for any two scalar-valued functions a; b: The solvability of the equations (9)– (11) requires that the RHS of the equations belong to the range of L_1 , or equivalently that they are orthogonal (under the scalar product just de ned) to the kernel of L_1 ; the adjoint of L_1 : By construction, we have chosen the dynam ics of L_1 in such a way that the kernel of L_1 contains only one element. This is the invariant density $f_s(\mathbf{x})$ under the dynam ics governed by the linear stochastic operator in (3). Thus, the solvability condition for all the equations in plies that the RHSs average to zero with respect to $f_s(\mathbf{x})$: C onsequently, if we denote by P the projection on the subspace \hat{X} of resolved variables, where

we have P (R H S) = 0:A lso, the solvability of the equation (9) in plies P $u_0 = u_0$; i.e. u_0 is independent of * (see [15]). From equation (7) and the de nition of the projection P we have that P $L_1 = L_1P = 0$ (form one details see [4,15]). We collect these remarks and nd that the function u_0 satisfies the equation

where L_1^{1} is the inverse of the operator L_1 (see Appendix A in [4]). In the lim it of ! 0; K urtz's theorem makes these manipulations rigorous by stating that under the condition $P L_2 P = 0$; is the solvability condition for (10), the solution u (x;t) tends to u_0 (x;t), where u_0 satis es (13). Moreover, equation (13) is a Chapman-K olm ogorov equation involving only the resolved variables and since L_1^{1} is computable for the stochastic approximation (3), we can use (13) to compute the corresponding stochastic di erential equations for the resolved variables. This concludes the second step of AMRS.Note, that in general, the elective computational use of the Chapman-Kolm ogorov equation for the resolved variables relies on the operator L_1 having a closed form expression for its inverse.

3 Mori-Zwanzig projection formalism and the short-memory approximation

W e present the M ori-Zwanzig form alism and derive from it the approximation that we will be using later, namely the short-m em ory approximation.

3.1 Conditional expectations and the Mori-Zwanzig form alism

Suppose that we are given the system of equations (1) with initial condition

(0) = x: Furtherm ore, assume that we know only a fraction of the initial data, say \hat{x} , where $x = (\hat{x}; x)$ and correspondingly $= (\hat{z}; x)$ and that the unresolved data are drawn from a measure with density f(x): Unlike the case of AMRS, here we do not assume anything about the form of the density f(x):

The conditional expectation E $[u_j \hat{x}]$ is the best approximation of u by a function of \hat{x} :

for all functions h.

We pick a basis in \hat{L}^2 , for example $h_1(\hat{x}); h_2(\hat{x}); \dots$ For simplicity assume that the basis functions $h_i(\hat{x})$ are orthonormal, i.e., $E[h_ih_j] = i_j$. The conditional expectation can be written as $E[u\hat{x}] = a_jh_j(\hat{x})$, where $a_j = E[uh_j] = E[u(\hat{x}; x)h_j(\hat{x})]$. If we have a nite number of terms only, we are projecting on a smaller subspace and the projection is called a nite-rank projection. In the special case where we pick a the nite set of functions $h_1(\hat{x}) = x_1; h_2(\hat{x}) = x_2; \dots; h_m(\hat{x}) = x_m$, then the corresponding nite-rank projection is called in physics the "linear" projection (note that all projections are linear, so "linear" is used to denote that the projection is on linear functions of the resolved variables). We should note here that it is not always true that $E[x_ix_j] = 0$ for $i \in j$.

The system of ordinary di erential equations we are asked to solve can be transformed into the linear partial di erential equation [21]

Equation (15) is the M ori-Zwanzig identity [22{24]. Note that this relation is exact and is an alternative way of writing the original PDE. It is the starting point of our approximations. Of course, we have one such equation for each of the resolved variables $_{j}; j = 1; ...; m$. The rst term in (15) is usually called M arkovian since it depends only on the values of the variables at the current instant, the second is called "noise" and the third "m em ory". The m eaning of the di erent term s appearing in (15) and a connection (and generalization) to the uctuation-dissipation theorem s of irreversible statistical mechanics can be found in [6,25].

3.2 The short-time and short-memory approximations

The approximation we will examine is a short-time approximation and consists of dropping the integral term in Dyson's formula (16)

In other words we replace the ow in the orthogonal complement of \hat{L}^2 with the ow induced by the full system operator L. Some algebra shows that

A sexpected the approximation (19) is good only for short times. However, under certain conditions this approximation can become valid for longer times. To see that consider the case where P is the nite-rank projection so P LQ $e^{sQ L}Q Lx_j = P_{k=1}^{1} (LQ e^{sQ L}Q Lx_j;h_k)h_k(x)$ and $P LQ e^{sL}Q Lx_j = P_{k=1}^{1} (LQ e^{sL}Q Lx_j;h_k)h_k(x)$: The quantities $(LQ e^{sL}Q Lx_j;h_k)$ can be calculated from the full system without recourse to the orthogonal dynamics. Recall (20) which states that the error in approximating $e^{sQ L}$ by e^{sL} is small for small s. This means that for short times we can infer the behaviour of the quantity $(LQ e^{sQ L}Q Lx_j;h_k)$ by examining the behaviour of the quantity $(LQ e^{sQ L}Q Lx_j;h_k)$.

If the quantities $(LQ e^{sL}Q Lx_j;h_k)$ decay fast we can infer that the quantities $(LQ e^{sQ L}Q Lx_j;h_k)$ decay fast for short times. We cannot infer anything about the behaviour of $(LQ e^{sQ L}Q Lx_j;h_k)$ for larger times. However, if $(LQ e^{sQ L}Q Lx_j;h_k)$ not only decay fast initially, but, also, stay small for larger times, then we expect our approximation to be valid for larger times. To see this consider again the integral term in the Mori-Zwanzig equation. The integrand becomes negligible for t to, where to is the time of decay of the quantities $(LQ e^{sQ L}Q Lx_j;h_k)$. This means that our approximation becomes

From this we conclude that the short-time approximation is valid for large times if t_0 is small and is called the short-memory approximation. On the other hand, if t_0 is large, then the error, which is $O(t_0^3)$, becomes large and the approximation is only valid for short times. Note that the validity of the short-memory approximation can only be checked after constructing it, since it is based on an assumption about the large time behaviour of the unknown quantities (LQ $e^{SQ L}Q Lx_j;h_k$). Note, that determination of the quantities (LQ $e^{SQ L}Q Lx_j;h_k$) requires the (usually very expensive) solution of the orthogonal dynam ics equation. The short-memory approximation, when valid, allow s us to avoid the solution of the orthogonal dynam ics equation.

If the quantities $(LQ e^{sL}Q Lx_j;h_k)$ do not decay fast, then we can infer, again only for short times, that the quantities $(LQ e^{sQ L}Q Lx_j;h_k)$ of the exact M ori-Zwanzig equation do not decay fast. Yet, it is possible that the quantities $(LQ e^{sQ L}Q Lx_j;h_k)$ start decaying very fast after short times and remain small for longer times, so that the short-mem ory approximation could still hold. Of course, this can only be checked a posteriori, after the simulation of the short-mem ory approximation equations.

In the statistical physics literature, the assumption that the correlations vanish for $s \in 0$ is often m ade which is a special case of the short-m em ory approxim ation with the correlations replaced by a delta-function multiplied by the integrals. An application of the short-m em ory approximation can be found in [26].

4 A form alcom parison of the two m ethods

W e use the conditions under which the asymptotic mode reduction strategy holds to derive conditions under which we can construct a short-memory reduced model in the context of the MZ formalism. This allows us to obtain a form of the reduced system in the MZ formalism that is more amenable to comparison to the reduced model obtained by AMRS.We should note here that it is possible to start from the Chapman-Kolm ogorov equation (6) and apply a projection formalism similar to Mori-Zwanzig using the operator P not P (see e.g. [9] and references therein). Under suitable assumptions (the sam e conditions as the ones we will postulate for the derivation of the short-mem ory M Z model in this section) one can arrive at the reduced Chapman-Kolm ogorov equation (13). Our intention in this section is dierent. We want to compare the reduced short-memory model that arises when M Z is applied to the determ inistic system (1) to the reduced short-memory model that arises from AMRS, where the system (1) is rst replaced by the stochastic system (2).

The asymptotic mode reduction strategy has two steps. In the rst step, under suitable assumptions, the dynam ics described by S are replaced by a linear stochastic operator. In the second step, under suitable assumptions which guarantee the applicability of K urtz's theorem, the unresolved variables are eliminated and a reduced model for the resolved variables is obtained. O ur goal here is to translate all these assumptions (conditions) in the language of the MZ form alism, and, thus, obtain the conditions under which, for a system with L given by (23), it is possible to construct a short-mem ory model for the slow variables.

G iven the specific structure of the operator L and the conditions (26), the kernels $(L_2 e^{sQ(\frac{1}{2}L_1 + \frac{1}{2}L_2 + L_3)}L_2 x_j;h_k)$ can be approximated, in the limit ! 0, by $(L_2 e^{s\frac{1}{2}L_1}L_2 x_j;h_k)$: So, in the limit of ! 0; the orthogonal dynam ics are dominated by the S dynam ics of the unresolved variables. This is also them earling of the operator $L_2 L_1^{-1}L_2$ in (13). Moreover, if the correlations $(L_2 e^{s\frac{1}{2}L_1}L_2 x_j;h_k)$ decay on a time-scale O (²), then the integral term contributes to the RHS of (27) at the same order with the rst term. In sum mary, for L given by (23), we have that: i) the conditions given by (26), ii) the approximation $(L_2e^{sQ(\frac{1}{2}L_1+\frac{1}{2}L_2+L_3)}L_2x_j;h_k)$ $(L_2e^{s\frac{1}{2}L_1}L_2x_j;h_k)$ and iii) the assumption that the quantities $(L_2e^{s\frac{1}{2}L_1}L_2x_j;h_k)$ decay fast, guarantee the existence of a short-memory MZ model in the limit ! 0: The reduced model (28) bears great form al similarity to the reduced model (13) obtained by AMRS (see also Appendix A in [4] for the integral representation of L⁻¹). However, there are two main points of di erence that we now discuss.

The rst point is the di erence between the operators L_1 and L_1 : This di erence arises from the stochastic approximation (3) in the rst step of AMRS. A swe have already mentioned, it is not easy to justify this approximation in the general case [20]. For the test cases the justi cation was numerical [1].

The second point is the di erence between the projection operators P and P: The operator P is de ned by

where $f_c(\hat{x}; \mathbf{x}) = \frac{R_c f}{r_x f d\mathbf{x}}$ is the conditional density conditioned on the resolved variables $\hat{x}: On$ the other hand, the operator P is defined by

where $f_s(x)$ is the invariant density of the dynam ics governed by the linear stochastic operator appearing in (3). Thus, the question if and how P relates to P is reduced to the question of if and how f_c is related to f_s : It is not obvious, if and how f_c and f_s are related in general. However, for the case when the original system (1) admits an invariant density f; the question is ultimately connected to the rst point mentioned above, i.e. whether the replacement of the S dynam ics by a stochastic operator is justimed. To see that we will need a result for the conditional density f_c in the limit 1 o; which we now derive. The result states that, if the density f is invariant under the S dynam ics.

If we assume that the equations (32–33) adm it each a unique solution (for the same boundary conditions), then the relation between the densities f_c and f_s is governed by the relation between the operators L_1 and L_1 : But the relation between L_1 and L_1 is determined by the relation between the operators L_1 and L_1 ; i.e. by whether or not we are allowed to replace the fast dynam ics S by a stochastic operator. So, the relation between the two projection operators P and P, which are de ned by f_c and f_s respectively, is determined, in the case that f is invariant for (1), by whether or not we are allowed to replace the fast dynam ics S by a stochastic operator. For the test cases we have $f_s = f_c$ and thus, we expect the reduced m odels constructed from the two m ethods to have sim ilar predictive ability. The num erical sim ulations support our expectations.

5 Themodels

The models that we use to compare the two stochastic mode reduction methods mentioned above rst appeared in [1], where the performance of the asymptotic mode reduction strategy was evaluated. We chose these exam ples since, there exist already published results about them for the asymptotic m ode reduction strategy and all the param eters involved are well-docum ented. A ll the m odels that we shall exam ine have a common structure. They consist of a system of determ inistic di erential equations where a few (two at m ost) slow ly evolving variables are coupled to a fast evolving heat bath. The heat bath com es from a Fourier-G alerkin truncation of the Burgers-H opf system

A s dem onstrated num erically by M a jda and T in ofeyev in [27], this truncation (for a large enough num ber of modes) is a determ inistic but chaotic and m ixing system, that is ergodic on suitably de ned equi-energy surfaces, and the tim ecorrelations of the modes obey a simple scaling law. These properties qualify this system as a good candidate for a stochastic heat bath. The modes of the G alerkin truncation will be the unresolved variables that we wish to elim inate, thus obtaining a stochastic system for the slow ly evolving resolved variables. The coupling of the variables on the RHS of the equations will be of triad type, i.e. no variable appears on the RHS of its own equation.

The rst model is called the additive case and is given by

This equivalence was shown for the Burgers bath only in [27] for = 50, but the form of the invariant density suggests it should hold also for the coupled systems (see also discussion in [4]). This is supported by the fact that, in the num erical simulations, the quantities of interest were computed by averaging over initial conditions and are identical to the results in [1], where they were obtained by tim e-averaging over a single trajectory.

6 Construction and application of the reduced models

W e proceed to construct the reduced models for the test cases mentioned above.

6.1 A sym ptotic m ode reduction strategy m odels

For AMRS the reduced models were constructed in [1], so we only have to construct here the reduced models for the short-memory MZ approximation. However, as promised in Section 2, we mention brie y the methods involved in the rst step of AMRS (the stochastic approximation step) for the determination of the parameters introduced by the stochastic approximation (3).

The parameters introduced are the entries of the matrices ;: For our test cases, = diag($_1;:::;$) and = diag($_1;:::;$). In the numerical sim – ulations, the resolved variables will be coupled only to the rst vem odes of the Burgers bath. How ever, this does not change anything about the method used to determ ine the parameters of the stochastic approximation. Since we have two parameters, the statistical agreement between

will have to involve the one-time and two-time statistics of the system (see [1] for details). First, we use the one-time statistics to reduce the number of parameters. The unresolved variables evolve on a faster time-scale than the resolved ones and, thus, are considered to relax quickly to a stationary state. For the stochastic approximation (3), the unresolved variables $y_k; z_k$ reach a stationary state described by a G aussian density with zero mean and variance $\frac{2}{k}; k = 1; \ldots; :0$ n the other hand, we know from (40) or (41) that every unresolved variable is G aussianly distributed with zero mean and variance $\frac{1}{2}:$ Thus, the identication $\frac{2}{2k} = \frac{1}{2}$ yields a relation between k and k and reduces the parameters to be determined to only k. To do this, we exploit the two-time statistics of the system. For the stochastic approximation (3), the correlations exhibit exponential decay and the characteristic decay time is $k^{-1}: 0$ focurse, the coupling with the resolved variables will alter the decay rates so that the correlations do not decay exactly as exponentials. So, the rst step is to approxim ate the actual correlation functions by exponentials

The superscript denotes that the correlations are computed from simulations of the full system and E denotes expectation with respect to the density for the full system. The second step is to pick the values of $_{k}$ in (42) so as to optimize consistency with exp $\begin{pmatrix} dns \\ k \end{pmatrix} = 2$: In [1], there are three dimensional event procedures suggested to achieve this. The rst procedure (P1) uses the scaling law for the

correlation times for the Burgers bath [27] to identify the coe cients k

The third procedure (P3) adjusts the $_k$ in such a way that the correlations for (42) reproduce the functions $exp(\frac{dns}{k})=2$ as close as possible (m ore details about the procedures can be found in [1]). For the additive case the procedures P3 is superior, while for the multiplicative and combined cases the procedures P2 and P3 are superior and give similar results. The num erical values that we used for the $_k$ can be found in [1].

A fler we determ ine the parameters of the stochastic approximation we can apply the elimination procedure outlined in Section 2 to obtain the reduced system for the resolved variables. The elimination procedure requires the introduction of a small parameter that controls the magnitude of the di erent term s that appear in the equations. For the additive and multiplicative cases,

6.2 Short-m em ory M Z approxim ation m odels

W e construct the short-m em ory M Z equations for the three test cases. The invariant probability density used to compute all the necessary projections is given by (40) or (41) depending on the test case. The equations for the short-m em ory approximation are

In general, we allow the di erent resolved variables to have di erent scaling factors $_{j}$, but in all the num erical simulations the scaling factors were set to zero.

We also employ the proposition in [25] that, if the probability density is invariant then the operator L is skew-symmetric. For the case of the nite-rank projection we nd

Thus, the projection coe cients of them em ory are correlations of di erent order of the noise term. The projection coe cients in them em ory term in (58) are computed by sampling the invariant density, evolving the full system and averaging. The noise term is computed using the moving average m ethod for sampling stationary stochastic processes with given m ean and autocorrelation [29].

An important issue is how does one decide how many terms and of what form are needed in the expansion of the memory term. For cases, where a scale separation between resolved and unresolved variables exists and the resolved variables include all the slow variables, one way to choose the term s in the expansion is to retain only terms whose coe cients decay fast. The larger is the ratio of scale separation in the system under investigation, the more accurate should this approximation be. One would think that maybe what is needed for a better model is the inclusion of slow ly decaying memory terms. However, this is not necessarily so unless one is willing to solve the orthogonal dynam ics equation. The reason is that slow by decaying m em ory term s need to be computed through the solution of the orthogonal dynam ics equation (see also Section 32).0 therwise, their inclusion can hamper the accuracy of the m odel (evidence of that for the K uram oto-Sivashinsky equation was presented in [25]). In other words, when faced with a system that exhibits time scale separation and all the slow variables are resolved, then the appropriate choice for the m em ory term s (as far as expense/accuracy is concerned) is to pick the fast decaying ones. In the limit of in nite scale separation the choice of fast decaying term s becomes exact and this is the idea behind the construction of AMRS and short-memory MZ.

The problem with the suggestion of picking only the fast decaying term s is that it quickly becomes in practical. To determ ine how fast the dierent coe cients

decay we need to compute them and determ ine which ones decay fast by visual inspection. For a system with even a few resolved variables the number of possible combinations of basis functions grows very fast with the order of the polynom ials used. Additionally, we do not expect all of the fast decaying coe cients to be equally important for the accuracy of the reduced m odel. Thus, if we include them all, we may reduce the e ciency of the the m odel unnecessarily.

We propose here a partial x of the problem of picking the coe cients that are m ost relevant for system s which exhibit tim e-scale separation. If the resolved variables include all the slow variables we expect, as already m entioned, the dom inant coe cients in the expansion of the memory term to be fast decaying. However, among these fast decaying coe cients the most important ones are those with the largest values at s = 0 (see (58)). In other words, if we can pute the projection coe cients (Lx ;; Lh); we suggest to keep in the expansion only the term s whose coe cient magnitude is substantially larger (e.g. at least a couple of orders of magnitude) than the magnitude of the coe cients of the rest of the term s. The advantage of this approach is that we can decide which term s' coe cients we want to compute by a relatively cheap calculation since we do not need to evolve the full system. We applied this criterion to the test cases and concluded that the most important terms in the expansion are similar to the ones predicted by AMRS. The calculation of the evolution of the coe cients for these terms (by integrating repeatedly the full system and averaging) showed that they are indeed fast decaying. How ever, note that there is the possibility that a projection coe cient (Lx ;; Lh) may have a large value at s = 0, but the magnitude of the corresponding term h in the expansion can be small, thus making the above procedure not completely failproof.

W e should add here, that the test cases we exam ine do not exhibit extrem ely large scale separation ratios and this results in errors in the predictions. This is to be expected and drives hom e the point that for an improved prediction we should, also, include in the expansion slow ly-decaying coe cients of higher order, computed through the orthogonal dynam ics equation. In M Z, in addition to picking up only the fast decaying terms in the expansion, we have at our disposal the orthogonal dynam ics equation whose solution, although expensive, can provide us with slow ly decaying projection coe cients even for the case where there is no scale separation between the resolved and unresolved variables. Of course, this ability stems from the fact that M Z is a reform ulation of the problem, hence it allows, in principle, the construction of m odels of arbitrary accuracy. In AM R S, it is not possible, except for special cases (see Section 4.5 in [4]), to account for slow ly decaying terms.

It is true that the M Z form alism allows re nem ents by computing the evolution of slow ly decaying m em ory term s. This can be done through the orthogonal dynam ics equation. How ever, there are two sources of additional computational expense in this case. One is to solve the orthogonal dynam ics equation and the other is to solve the random integrodi erential equation for the reduced m odel, which will now have m ore integral terms. The solution of the orthogonal dynam ics equation is not particularly expensive because the quantities needed to set it up can be computed in the same process of computing the quantities needed for the short-mem ory model. Of course, there is an additional expense to actually solve the orthogonal dynam ics equation but this is not as severe. The reason is that the solution of the orthogonal dynam ics equations which can be done e ciently (see also [6]). The main expense appears after one has constructed the reduced model. First, there are more integral terms now than before, and moreover, these terms have slow ly decaying integrands. As a result, the repeated solution of such a reduced model can become prohibitively expensive because the evaluation of the integral terms can be very costly.

6.3 Num erical simulations

We present the results of the num erical simulation of the reduced models produced by AMRS and MZ for the test cases of Section 5.We should note here that the amount of work needed to construct and integrate the reduced m odels is comparable for the two methods. For AMRS, one needs to solve the full system repeatedly to compute the entries of the dissipation matrix . For short-memory MZ, one needs to solve the full system repeatedly to compute the memory kernels ($e^{sL}Lx_{i}$; Lh): A fler the reduced models are computed, one needs to integrate them. In the case of AMRS, we need to integrate a system of stochastic di erential equations. In the case of MZ, a system of random integrodi erential equations. The fact that the M Z reduced equations are random (colored noise) allows the faster convergence of the averaging procedure (e.g. to compute correlations). However, the gain in e ciency is o set by the fact that we dealwith integrodi erential equations. As a result, the overall computationale ort needed is the same for the two methods. More details about the implementation of the reduced models are o ered below when the examples are analyzed.

For the additive case the AMRS reduced equation for the resolved variable x_1 is given by (43) and the MZ reduced equation is given by




Fig. 1. Additive case. Evolution of $(e^{tL} Lx_1; LH_1(x_1))$:

The coupling constant = 4; the truncation size is = 50 and = 50: Note that due to the short-m em ory approximation, the interval of the integral in (59) is restricted to $[0;t_0]$: This is done for two reasons. First, because the kernel of the integral $(e^{SL}Lx_1; LH_1(x_1))$ decays fast and second, because the estim ate of the kernel can not be accurate for large s by the error estim ates for the short-mem ory approximation. The tem poral evolution of the kernel is shown in Fig.(1). It was computed by sampling the density (40), evolving the full system (34) with the fourth-order Runge-Kutta algorithm and averaging. The results shown in Fig.(1) correspond to averaging over 10000 samples. For the numerical simulations of (59) we set $t_0 = 1$: The fact that the kernel decays fast motivates its replacement by a delta-function multiplied by the integral of the kernel. This approximation will be referred to as the delta MZ approximation. To check the relevance of the short-memory approximation, we also solved the orthogonal dynam ics equation for x_1 keeping up to second order terms in the expansion of the memory and the temporal evolution of $(e^{t_{L}L} Lx_{1}; LH_{1}(x_{1}))$ is identical to $(e^{t_{L}L} Lx_{1}; LH_{1}(x_{1}))$: The parameter = 0.63 for this case, which is not small, but as seen from the results below it is small. enough to quarantee the validity of the short-m em ory approximation and of AMRS.




Fig. 2. Additive case. a) Autocorrelation of the resolved mode x_1 : b) Relative error of the predictions of the autocorrelation of x_1 :

In [1], the autocorrelation of x_1 was used to evaluate the perform ance of the reduction strategy. Fig.(2) shows the predictions for the autocorrelation of x_1 from AMRS, short-memory MZ and the delta MZ approximation. The

truth refers to the autocorrelation computed from the full system (in this case (34)). As mentioned before, only the st ve interactions coe cients were nonzero. The truth was computed by sampling the density (40), evolving (34) with the fourth-order Runge-Kutta algorithm and averaging. The estimate was computed using 10000 samples. The AMRS reduced equation (43) was evolved with the Euler scheme for initial values of x_1 drawn from the projected on x_1 form of the density (40) and di erent realizations of the white noise term . The AMRS estimate of the autocorrelation was computed by averaging over 20000 sam ples and noise realizations. Finally, the M Z estimates were produced by sampling again the projected on x_1 density and the noise term F_1 (t), evolving with the fourth-order Runge-Kutta algorithm and averaging. Note that, the MZ equations have a colored noise term and thus do not require the use of a stochastic solver. The short-memory MZ estimates were computed by averaging over 1000 sam ples and noise realizations. The use of a colored noise allows for the faster convergence of the averaging procedure. However, the gain in computational time by the need to evolve fewer samples is balanced by the fact that we have to solve integrodi erential equations for the shortmemory approximation. The delta MZ approximation, where we no longer have integral m em ory term s, perform s surprisingly well, since it has alm ost the same accuracy as the short-memory MZ approximation while being much more e cient num erically (about 10 tim es). The delta M Z approxim ation was computed by averaging over 1000 samples and noise realizations. All three estim ates have com parable accuracy for short times, while for later times the relative error of the AMRS estimate appears to increase reaching a plateau of about 20%: The MZ estimates' relative error remains around 3% for the interval of integration.

For the multiplicative case (see (36)), the AMRS reduced equations for $x_1; x_2$

are given by (44) while the MZ equations are




Fig. 3. Multiplicative case. a) Evolution of $(e^{tL} Lx_1; LH_1(x_1)): b)$ Evolution of $(e^{tL} Lx_1; L(H_2(x_2)H_1(x_1))):$

The coupling constant = 3: Theinterval of integration is again restricted to $[0;t_0]$ and for the num erical sim – ulations $t_0 = 2$: Fig.(3) shows the temporal evolution of the memory kernels $(e^{tL}Lx_1;LH_1(x_1))$ and $(e^{tL}Lx_1;L(H_2(x_2)H_1(x_1)))$: The kernels for the equation for x_2 have similar behaviour. The kernels decay fast and, as in the previous case, we also tried to replace the kernels by a delta function multiplied by the integral of the kernel and this approximation is again called delta M Z . H ow ever, the fact that we have to integrate the kernels up to $t_0 = 2$ show s that they decay more slow ly than in the additive case. This is to be expected if we bok at the form of, say, $Lx_1: D$ ue to the multiplicative coupling, this quantity now depends not only on the unresolved variables, but, also, on the slow resolved variable x_2 and thus the autocorrelation of Lx_1 depends on the autocorrelation of x_2 . This results in a slower decay of $(e^{L}Lx_1; LH_1(x_1))$, and we expect the error of the short-m em ory approxim ation to be larger than in the additive case. On the other hand, AMRS results in equations for the resolved variables that have a multiplicative noise (see (44)), i.e. the dependence on the slow variables is taken out of the noise process. This is in accordance with the way the AMRS equations are derived, which is in the limit of in nite-scale separation.

The parameter = 0.41: All algorithm ic considerations and numbers of sam – ples are the same as in the additive case, except for the algorithm used to

integrate the AMRS reduced equations (44). We followed [1] and used time-splitting, using a second-order R unge-K utta algorithm for the nonlinear term s and the strong M ilstein scheme of order 1 for the stochastic term s.




Fig. 4. Multiplicative case. a) Autocorrelation of the resolved mode x_1 : b) Relative error of the predictions of the autocorrelation of x_1 :

To check again the validity of the short-mem ory approximation we solved the orthogonal dynam ics equations for $x_1; x_2$ keeping up to second order polynom ials in each variable and the results for the kernels were very close to the ones predicted by the short-memory approximation. This suggests that we expect the short-m em ory and AMRS estimates to be, at least for short times, accurate. Fig. (4) shows the estimates for the autocorrelation of x_1 as predicted by AMRS, short-memory MZ and delta MZ compared to the truth (similar results hold for x_2). The MZ estimates are superior to the ones produced by AMRS for up to time t 5; after which the AMRS estimate becomes more accurate. Note that, up to time t 5 the error for all methods is around 10%; thus justifying our expectation of the validity of the short-mem ory approxim ation for short times. At the instant t = 10 when we stopped the integration the relative error of the AMRS estimate is about 25% while the one produced by the two MZ variants is about 45%. The larger error com pared to the additive case con m s our expectations stated above. The fact that delta M Z and short-memory MZ give very similar results and that to within second order polynom ials the orthogonal dynam ics kernels are close to the short-m em ory ones, indicates that the short-mem ory kernels are rather accurate. So, what seem s to be needed for an improvement of the results is to compute, through the orthogonal dynamics, projection coe cients of higher order and, possibly, for these coe cients extend the interval of time integration in the memory term. We did not attempt this here, because our purpose was to compare AMRS and MZ in situations where their numerical e ciency is of the same order.

The last test case we examined is the combined one (see (38)), where the coupling of the resolved variables to the unresolved is of both additive and multiplicative type. For this case, the AMRS reduced equations are given by (49), while the reduced MZ equations are

The coupling constants are $_a = 4$; $_m = 3$: The interval of integration is again restricted to [0;t_0] and for the num erical simulations $t_0 = 1$: Note, that while the reduced AMRS equa-




Fig. 5. Combined case. a) Evolution of $(e^{tL}Lx_1;LH_1(x_1))$: b) Evolution of $(e^{tL}Lx_1;L(H_2(x_2)H_1(x_1)))$:




Fig. 6.C om bined case.a) A utocorrelation of the resolved m ode x_1 :b) R elative error of the predictions of the autocorrelation of x_1 :

tions (49) involve term s that com e either from the multiplicative coupling part or the additive coupling part, the M Z equations (61) involve also cross-term s, i.e. products of term s where one factor com es from the multiplicative part and the other from the additive part. Fig.(5) shows the tem poral evolution of the kernels ($e^{tL}Lx_1;LH_1(x_1)$); ($e^{tL}Lx_1;L(H_2(x_2)H_1(x_1))$): The kernels for the equation for x_2 have sim ilar behaviour. The kernels decay fast and, as in the previous case, we also tried to replace the kernels by a delta function multiplied by the integral of the kernel and this approximation is again called delta M Z. The parameter = 0:49: All algorithm ic considerations and numbers of sam ples are the same as in the multiplicative case.

Fig.(6) shows the estimates for the autocorrelation of x_1 as predicted by

AMRS, short-memory MZ and delta MZ compared to the truth (similar results hold for x₂). The MZ estimates are superior to the ones produced by AMRS for up to timet 5: A fler that and until timet 9; the AMRS estimate's accuracy is higher. For the time interval shown here, the relative error for all three methods has a maximum value around 25%: If we compare the accuracy of the results for MZ and AMRS taking into account their behaviour in the pure additive and multiplicative cases, we see that the perform ance in the combined case is to be expected, since it is a mixture of the advantages and drawbacks of each individual method as manifested in the additive and multiplicative cases. The fact, that MZ exhibits higher accuracy for a larger interval of time, should be attributed to the fact that the additive coupling constant is larger, thus bringing the combined case somewhat closer to the additive case (see also discussion of results for the combined case in [1]).

7 Conclusions

We have presented numerical results comparing two stochastic mode reduction strategies. The rstmethod (AMRS), proposed by Majda, Timofeyev and Vanden-Eijnden, is based on an asymptotic strategy developed by Kurtz. The second method is a short-memory approximation of the Mori-Zwanzig projection formalism of irreversible statistical mechanics, as proposed by Chorin, Hald and Kupferman. The novel feature of these methods is that they allow the use, in the reduced system, of higher order terms in the resolved variables. The two methods were applied to a collection of test cases that exhibit separation of time-scales between the resolved and unresolved variables and, also, share some features with more complicated models used in the study of climate dynamics.

D epending on the test case, one of the two m ethods can have superior accuracy, but the overall behaviour suggests that for cases with separation of time-scales, the two m ethods result in reduced systems of equations that have similar predictive ability. For the test cases we exam ined, the replacement of the kernels in the mem ory terms by delta-functions (the delta M Z approxim ation) does not appear to be very harm full to the accuracy of the approximation, while at the same time it makes the integration of the reduced equations around 10 times faster. The test cases highlight the limitations of AM RS and of short-mem ory M Z when the separation of time-scales becomes less sharp. In this case, M Z allows for a systematic, although expensive, calculation of reduced equations that incorporate long-time memory elects. On the other hand, AM RS, by construction, cannot be readily extended to these cases. For special cases, like the multiplicative case above (see also Section 4.5 in [4]), the reduction performed by AM RS can be elected by working directly on the stochastic dilerential equations (4), without recourse to the associated C hapm an K olm ogorov equation. This allows for a system atic developm ent of reduced equations that account for long-time memory elects.

It would be interesting to compare the two methods when applied to more realistic models e.g. equations for climate dynamics, where a separation of time-scales is known to exist between the quantities of interest and the huge number of faster variables that constitute the climate system [30].
