# Asymptotic Expansion of the Risk Difference of the Bayesian Spectral Density in the ARMA model

#### Abstract

The autoregressive moving average (ARMA) model is one of the most important models in time series analysis. We consider the Bayesian estimation of an unknown spectral density in the ARMA model. In the i.i.d. cases, Komaki showed that Bayesian predictive densities based on a superharmonic prior asymptotically dominate those based on the Jeffreys prior [7]. It is shown by using the asymptotic expansion of the risk difference. We obtain the corresponding result in the ARMA model.

## I. INTRODUCTION

Let us consider a prediction problem in the Bayesian framework. Suppose that a parametric model

$$
\mathcal{M}:=\left\{p(x \mid \theta): \theta \in \Theta \subseteq \mathbf{R}^{k}\right\}
$$

is given and our problem is to estimate $p(y \mid \theta)$ itself from an observation $x$. If a proper prior density $\pi(\theta)$ is known, the best predictive density minimizing the average risk is obtained by 1]

$$
p_{\pi}(y \mid x):=\int p(y \mid \theta) \pi(\theta \mid x) \mathrm{d} \theta
$$

If one has no knowledge on the unknown parameter $\theta$, he or she tends to adopt a noninformative prior. It is often recommended to use the Jeffreys prior as a noninformative prior due to several reasons. However the Jeffreys prior is often improper, i.e., $\int \pi(\theta) \mathrm{d} \theta=\infty$. In such a situation, the above result does not hold any more and other noninformative priors could be recommended. One of those is a superharmonic prior. Komaki showed that Bayesian predictive distributions based on a superharmonic prior asymptotically dominate those based on the Jeffreys prior [7]. He compared two prior distributions by using the asymptotic expansion of the risk difference.

In the present paper, we extend this result to the ARMA process. We formulate the prediction problem of spectral densities in the ARMA model as described below and obtain the asymptotic expansion of the risk difference. Our conclusion is the same as in the i.i.d. cases. Since we used the properties of the ARMA model only when evaluating the expectation of the log likelihood, it can be expected that almost all our arguments hold true in general stationary Gaussian processes.

## A. General setting

Let us consider a parametric model of stationary Gaussian process with mean zero. It is known that a stationary Gaussian process corresponds to its spectral density one-to-one (for proof, see, e.g., [4]). Thus, we focus on the estimation of the true spectral density $S\left(\omega \mid \theta_{0}\right)$ in a parametric family of spectral densities

\mathcal{M}:=\left\{S(\omega \mid \theta): \theta \in \Theta \subseteq \mathbf{R}^{k}\right\}
$$

The performance of a spectral density estimator $\hat{S}(\omega)$ is evaluated by the Kullback-Leibler divergence.

$$
D\left(S\left(\omega \mid \theta_{0}\right)|\mid \hat{S}(\omega)):=\int_{-\pi}^{\pi} \frac{\mathrm{d} \omega}{4 \pi}\left\{\frac{S\left(\omega \mid \theta_{0}\right)}{\hat{S}(\omega)}-1-\log \left(\frac{S\left(\omega \mid \theta_{0}\right)}{\hat{S}(\omega)}\right)\right\}\right.
$$

The above setting is proposed by Komaki (6].

## B. Bayesian framework

First, let us consider minimizing the average risk assuming that a proper prior density $\pi(\theta)$ is known in advance. Aitchison's result [1] applies to this setting. The spectral density estimator minimizing the average risk,

& :=\int \mathrm{d} \theta \pi(\theta) \int \mathrm{d} x_{1} \ldots \mathrm{~d} x_{n} p_{n}\left(x_{1}, \ldots, x_{n} \mid \theta\right) D(S(\omega \mid \theta) \| \hat{S}(\omega)),
\end{aligned}

is given by the Bayesian spectral density (with respect to $\pi(\theta)$ ), which is defined by

$$
\begin{equation*}
S_{\pi}(\omega):=\int S(\omega \mid \theta) \pi(\theta \mid x) \mathrm{d} \theta \tag{1}
\end{equation*}
$$

We call $S_{\pi}(\omega)$ in (11) a Bayesian spectral density even when an improper prior distribution is considered.

## C. Choice of a noninformative prior

If one has no information on the unknown parameter $\theta$, it is natural to adopt a noninformative prior in the Bayesian framework. There is much room to argue the choice of a noninformative prior. While the Jeffreys prior is a well-known candidate from several reasons, it can be expected that it is better to adopt a superharmonic prior in some cases. The reason is that stationary Gaussian processes are getting close to the i.i.d. cases as the sample size becomes large and a superharmonic prior can be better than the Jeffreys prior in the i.i.d. cases.

## D. Construction

In the following section, we briefly review basic results necessary to the asymptotic expansion. The asymptotic expansion of the posterior distribution is presented. In section 3, we obtain the asymptotic expansion of the Bayesian spectral density. For the ARMA model, it can be also written in the differential-geometrical quantities as in the i.i.d. cases. In section 4, we evaluate the expectation of the KL-divergence from the true spectral density $S\left(\omega \mid \theta_{0}\right)$ to the Bayesian spectral density $S_{f}$ up to the second order for an arbitrary prior (possibly improper) $f(\theta)$. Finally, we obtain the principal term of the risk difference between $S_{f}$ and $S_{\pi_{J}}$, where $\pi_{J}$ denotes the Jeffreys prior. As a direct consequence of this result, a superharmonic prior is recommended as a noninformative one if there exists a positive superharmonic function on the corresponding model manifold.

## II. PRELIMINARY

## A. Notation and assumption

In the present section, we consider general stationary Gaussian processes with mean zero. We recall that the likelihood function is given by

p_{n}\left(x_{1}, \cdots, x_{n} \mid \theta\right)=\frac{1}{\sqrt{\operatorname{det} \Sigma_{n}(\theta)(2 \pi)^{n}}} \exp \left(-\frac{1}{2} X_{n}^{\prime} \Sigma_{n}(\theta)^{-1} X_{n}\right), \tag{2}
\end{equation*}
$$

where $X_{n}=\left(x_{1}, \cdots, x_{n}\right)$ and $\Sigma_{n}$ denotes a covariance matrix and $\theta \in \Theta \subset \mathbf{R}^{k}$ denotes an unknown parameter. We often use the log likelihood of the form omitting the constant term

$$
l_{n}(\theta)=-\frac{1}{2} X_{n}^{\prime} \Sigma_{n}^{-1}(\theta) X_{n}-\frac{1}{2} \log \operatorname{det} \Sigma_{n}(\theta)
$$

We also assume that an arbitrary prior density $\pi(\theta)$ on $\Theta$ is given.

In the present paper, we assume several regularity conditions (See, e.g., Taniguchi and Kakizawa (11]).

Differential operators are denoted as $\partial_{j}:=\frac{\partial}{\partial \theta^{j}}$ as often seen in the differential geometry (for other basic notation, see, e.g., Kobayashi and Nomizu [5]). We also use Einstein's
summation convention: if an index occurs twice in any one term, once as an upper and once as a lower index, summation over that index is implied.

## B. Asymptotic expansion of the posterior density

For stationary Gaussian time series models, we have the asymptotic expansion of the posterior density

$$
\pi\left(\theta \mid X_{n}\right)=\frac{p_{n}\left(X_{n} \mid \theta\right) \pi(\theta)}{\int \mathrm{d} \theta p_{n}\left(X_{n} \mid \theta\right) \pi(\theta)}
$$

Here, we give the moment form of the expansion.

## Lemma 1.

The asymptotic expansion of the posterior density in the moment form is given by

& =\int \Delta \theta^{i_{1}} \cdots \Delta \theta^{i_{p}} \frac{1}{\sqrt{\operatorname{det}\left(n^{-1} J_{n}(\hat{\theta})^{-1}\right)}} \frac{1}{(2 \pi)^{k / 2}} \exp \left(-\frac{n}{2} J_{n}(\hat{\theta})(\theta-\hat{\theta})^{2}\right) \\
& \times\left\{1+\frac{A_{n}(x)}{\sqrt{n}}+O_{p}\left(n^{-1}\right)\right\} \mathrm{d} \theta, \tag{3}
\end{align*}

where $\hat{\theta}$ is the maximum likelihood estimate and

$$
\begin{gathered}
\Delta \theta^{i}:=\theta^{i}-\hat{\theta}^{i}(x),\left[J_{n}(\hat{\theta})\right]_{i j}:=-\frac{1}{n} \frac{\partial^{2} l_{n}(\hat{\theta})}{\partial \theta^{i} \partial \theta^{j}} \\
A_{n}(x):=\frac{1}{3!} \frac{\partial_{i_{1}} \partial_{i_{2}} \partial_{i_{3}} l_{n}(\hat{\theta})}{n}\left(\sqrt{n} \Delta \theta^{i_{1}}\right)\left(\sqrt{n} \Delta \theta^{i_{2}}\right)\left(\sqrt{n} \Delta \theta^{i_{3}}\right)+\partial_{j} \log \pi(\hat{\theta})\left(\sqrt{n} \Delta \theta^{j}\right)
\end{gathered}

For derivation, see, for example, Philippe and Rousseau [8]. From this formula, we can calculate $E^{\pi}\left[\Delta \theta^{i_{1}} \cdots \Delta \theta^{i_{p}}\right]$ in an arbitrary order. The $p$-th moment is defined by

We need only the second moment $I^{i j}(\hat{\theta})$ and the fourth moment $I^{i j k l}(\hat{\theta})$ in the present paper.

$$
\begin{gathered}

Stochastic order of them is evaluated as (for even $p$ )

Using these moment formula, we obtain

& +\frac{1}{\sqrt{n}} \partial_{i_{1}} \log \pi(\hat{\theta}) \sqrt{n} I^{i_{1} i}(\hat{\theta})+O_{p}\left(n^{-2}\right)\left(=O_{p}\left(n^{-1}\right)\right) \\
E^{\pi}\left[\Delta \theta^{i} \Delta \theta^{j}\right]= & I^{i j}(\hat{\theta})+O_{p}\left(n^{-2}\right) \\
E^{\pi}\left[\Delta \theta^{i} \Delta \theta^{j} \Delta \theta^{k}\right]= & O_{p}\left(n^{-2}\right)
\end{aligned}
$$

## III. ASYMPTOTIC EXPANSION OF THE SPECTRAL DENSITY

We consider a parametric family of spectral density

$$
\mathcal{M}:=\left\{S(\omega \mid \theta): \theta \in \Theta \subseteq \mathbf{R}^{k}, S \text { corresponding to an ARMA process }\right\} .
$$

Let $f(\theta)$ be an arbitrary prior distribution on $\Theta$ and $\pi_{J}(\theta)$ be the Jeffreys prior. From now on, $\theta_{0}$ denotes the true parameter. We consider estimating the true spectral density $S\left(\omega \mid \theta_{0}\right)$ itself instead of $\theta_{0}$. From the $n$ data, $X_{n}:=\left(x_{1}, \ldots, x_{n}\right)$ subject to an ARMA process, we construct the posterior distribution $f\left(\theta \mid X_{n}\right)$ and the Bayesian spectral density $\hat{S}_{f}(\omega)$ with respect to $f(\theta)$ is given by

$$
\hat{S}_{f}(\omega):=\int S(\omega \mid \theta) f\left(\theta \mid X_{n}\right) \mathrm{d} \theta
$$

From the result of the previous section, we obtain

## Lemma 2.

Let the maximum likelihood estimator $\hat{\theta}=\theta_{0}+O_{p}\left(n^{-\frac{1}{2}}\right)$ given, then the Bayesian spectral density is evaluated as

\begin{equation*}
\hat{S}_{f}(\omega)=S(\omega \mid \hat{\theta})+\partial_{i} S(\omega \mid \hat{\theta}) B_{f}^{i}(\hat{\theta})+\frac{1}{2} \partial_{i} \partial_{j} S(\omega \mid \hat{\theta}) I^{i j}(\hat{\theta})+O_{p}\left(n^{-\frac{3}{2}}\right) \tag{4}
\end{equation*}
$$

Proof.
Using the Taylor expansion of $S(\omega \mid \theta)$ around $\hat{\theta}$, Eq.(4) immeadiately follows from Lemma1. Q.E.D.

## A. Geometrical expansion of the derivatives of the log likelihood

We rewrite the Eq.(4) using geometrical quantities, which are defined by

& M_{i, j k l}=\int \frac{\mathrm{d} \omega}{4 \pi} \partial_{i} \log S\left(\omega \mid \theta_{0}\right) \frac{\partial_{j} \partial_{k} \partial_{l} S\left(\omega \mid \theta_{0}\right)}{S\left(\omega \mid \theta_{0}\right)} \\
& N_{i j, k l}=\int \frac{\mathrm{d} \omega}{4 \pi} \partial_{i} \partial_{j} S\left(\omega \mid \theta_{0}\right) \\
& S\left(\omega \mid \theta_{0}\right) \frac{\partial_{k} \partial_{l} S\left(\omega \mid \theta_{0}\right)}{S\left(\omega \mid \theta_{0}\right)} \\
& T_{i j k}=\int \frac{\mathrm{d} \omega}{2 \pi} \partial_{i} \log S\left(\omega \mid \theta_{0}\right) \partial_{j} \log S\left(\omega \mid \theta_{0}\right) \partial_{k} \log S\left(\omega \mid \theta_{0}\right) \\
& L_{i j, k l}=\int \frac{\mathrm{d} \omega}{4 \pi} \partial_{i} \log S\left(\omega \mid \theta_{0}\right) \partial_{j} \log S\left(\omega \mid \theta_{0}\right) \frac{\partial_{k} \partial_{b} S\left(\omega \mid \theta_{0}\right)}{S\left(\omega \mid \theta_{0}\right)}
\end{aligned}
$$

For these geometrical notations, e.g., see Amari [2, 3]. It is convenient to introduce some notation for the $\log$ likelihood $l_{n}\left(\theta_{0}\right)$ and its derivatives.

$$
L_{i_{1} \cdots i_{p}}\left(\theta_{0}\right):=\frac{1}{n} \frac{\partial^{p} l_{n}\left(\theta_{0}\right)}{\partial \theta^{i_{1}} \cdots \partial \theta^{i_{p}}}=O_{p}(1)
$$

and

$$
m_{i_{1} \cdots i_{p}}(\theta):=E_{\theta_{0}}\left[L_{i_{1} \cdots i_{p}}(\theta)\right]
$$

Note that $\theta \neq \theta_{0}$, for example, $m_{i}(\theta)=E_{\theta_{0}}\left[L_{i}(\theta)\right] \neq 0$ but $m_{i}\left(\theta_{0}\right)=0$. Likewise, the expectation of the product of the $\log$ derivatives are defined by

$$
m_{i_{1} \cdots i_{p}, j_{1} \cdots j_{q}}(\theta):=E_{\theta_{0}}\left[L_{i_{1} \cdots i_{p}}(\theta) L_{j_{1} \cdots j_{q}}(\theta)\right] .
$$

We omit the argument $\theta_{0}$ if otherwise necessary. Other important notations are $L^{i j}(\theta)$ and $m^{i j}(\theta)$. Each of them denotes the inverse matrix of $L_{i j}(\theta)$ and that of $m_{i j}(\theta)$. Note that $L^{i j}:=\left(L^{-1}\right)_{i j}=m^{i j}-m^{i l}(\delta L)_{l k} m^{k j}+\cdots$, where $(\delta L)_{l k}=L_{l k}-m_{l k}\left(=O_{p}\left(n^{-\frac{1}{2}}\right)\right)$.

## Lemma 3.

For the ARMA model, we obtain the explicit forms of $m_{i j}, m^{i j}, m_{i j k}$ and $m_{i j, k}$. They are represented by geometrical quantities.

& =-\left(\stackrel{(e)}{\Gamma}_{i, j k}+\stackrel{(e)}{\Gamma}_{j, i k}+\stackrel{(e)}{\Gamma}_{k, i j}+T_{i j k}\right)+O\left(n^{-1}\right) & =O(1) \\

where $\stackrel{(e)}{\Gamma}_{i, j k}:=\stackrel{(m)}{\Gamma}_{i, j k}-T_{i j k}$.

## Proof.

First, we show $m_{i j}=-g_{i j}+O\left(n^{-1}\right)$. From straightforward calculation, we obtain

m_{i j}=-\frac{1}{2 n} \operatorname{Tr}\left(\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{i}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{j}}\right) \tag{5}

Here, the following fact holds for a parametric family of the spectral density of the ARMA model (See, Lemma 4.1.2 [11]),

Fact. 11]
Let $p_{n}\left(x_{1}, \ldots, x_{n} \mid \theta\right)$ is given by Eq.(2) and the corresponding spectral density is $S(\omega \mid \theta)$.
Then, for arbitrary $k \geq 1$ and $p_{1}, \ldots, p_{k}$,

\begin{aligned}
& \frac{1}{n} \operatorname{Tr}\left\{\Sigma^{-1}\left(D_{p_{1}} \Sigma\right) \Sigma^{-1} \cdots\left(D_{p_{k}} \Sigma\right)\right\} \\
= & \frac{1}{2 \pi} \int_{-\pi}^{\pi} \frac{D_{p_{1}} S(\omega \mid \theta)}{S(\omega \mid \theta)} \cdots \frac{D_{p_{k}} S(\omega \mid \theta)}{S(\omega \mid \theta)} \mathrm{d} \omega+O\left(n^{-1}\right),
\end{aligned}
$$

where $D_{p}$ denotes an arbitrary $p$-th order differential operator $\frac{\partial}{\partial \theta^{l_{1}}} \cdots \frac{\partial}{\partial \theta^{l_{p}}}$.

Using the fact, the trace in the r.h.s. of (5) is rewritten in the form of the integral

$$
\frac{1}{n} \operatorname{Tr}\left(\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{i}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{j}}\right)=\frac{1}{2 \pi} \int_{-\pi}^{\pi} \frac{\partial_{i} S(\omega \mid \theta)}{S(\omega \mid \theta)} \frac{\partial_{j} S(\omega \mid \theta)}{S(\omega \mid \theta)} \mathrm{d} \omega+O\left(n^{-1}\right)
$$

Thus, we obtain

$$
m_{i j}=-g_{i j}+O\left(n^{-1}\right)
$$

Since $m^{i j}$ is the inverse of $m_{i j}$, the second equation clearly holds. The other equations are shown in the same way.
Q.E.D.

## B. Geometrical expansion of the Bayesian spectral density

Now we rewrite the asymptotic expansion (4) in the geometrical quantities.

## Lemma 4.

Let $\hat{\theta}$ be the maximum likelihood estimate, then the following expansion holds.

\begin{align*}
\hat{S}_{f}(\omega)= & S(\omega \mid \hat{\theta})+\frac{1}{2 n} g^{i j}(\hat{\theta})\left(\partial_{i} \partial_{j} S(\omega \mid \hat{\theta})-\stackrel{(m)}{\Gamma}_{i j}^{k}(\hat{\theta}) \partial_{k} S(\omega \mid \hat{\theta})\right) \\
& +\frac{1}{n} g^{i j}(\hat{\theta})\left\{\partial_{i} \log \frac{f}{\pi_{J}}(\hat{\theta})+\frac{1}{2} T_{i}(\hat{\theta})\right\} \partial_{j} S(\omega \mid \hat{\theta})+O_{p}\left(n^{-\frac{3}{2}}\right), \tag{6}
\end{align*}
$$

where $T_{i}:=T_{i j k} g^{j k}$. Note that Eq.(6) is formally in the same form as those in the i.i.d. cases if one reads $p(y \mid \theta)$ as $S(\omega \mid \theta)$.(See, Komaki[7]).

Proof.
In order to prove Eq.(6), one can neglect $O_{p}\left(n^{-\frac{3}{2}}\right)$ terms. For example, up to this order, the following identity holds

& =\frac{1}{n} g^{i j}\left(\theta_{0}\right)+O_{p}\left(n^{-\frac{3}{2}}\right) \\
& =\frac{1}{n} g^{i j}(\hat{\theta})+O_{p}\left(n^{-\frac{3}{2}}\right)
\end{aligned}
$$

Now let us rewrite the principal term of $\partial_{i} S(\omega \mid \hat{\theta}) B_{f}^{i}(\hat{\theta})$ in Eq.(4). From Lemma 3,

## IV. ASYMPTOTIC EXPANSION OF THE EXPECTATION OF THE KLDIVERGENCE

In this section, we evaluate the expectation of the KL-divergence up to the second order, focusing on the terms including the prior distribution $f(\theta)$. For simplicity, we introduce the
following notation.

Note that $\Delta S_{m}:=\frac{\hat{S}-S_{0}}{S_{0}}=O_{p}\left(n^{-\frac{1}{2}}\right)$ and $\Delta S_{f}:=\frac{S_{f}-\hat{S}}{S_{0}}=O_{p}\left(n^{-1}\right)$. The KL-divergence from the true spectral density $S\left(\omega \mid \theta_{0}\right)$ to a Bayesian spectral density $\hat{S}_{f}(\omega)$ is given by

First of all, we calculate $V$ and $W$. We need the principal terms of each. In the principal order, one can replace $\hat{\theta}$ with $\theta_{0}$. Each quantity is evaluated at the point $\theta_{0}$, but for simplicity, we omit $\theta_{0}$.

However the evaluation of the expectation requires no such higher order terms because $E\left[T_{i} \delta^{i}\right]=O\left(n^{-\frac{5}{2}}\right)$ in spite of $T_{i} \delta^{i}=O_{p}\left(n^{-2}\right)$. Indeed,

## V. COMPARISON BETWEEN $S_{\pi_{J}}$ AND $S_{f}$

From the result in the previous section, we obtain the same result as that in the i.i.d. cases, which was shown by Komaki [7]. Let us calculate the risk difference between two Bayesian spectral densities, one of which is based on the Jeffreys prior $\pi_{J}(\theta)$ and the other is based on an arbitrary prior $f$,

= & \frac{1}{8} g^{i j} T_{i} T_{j}+\stackrel{e}{\nabla}_{k}\left(g^{k j} \frac{1}{2} T_{j}\right)-\frac{1}{2} g^{i j}\left(\partial_{i} \log \frac{f}{\pi_{J}}+\frac{1}{2} T_{i}\right)\left(\partial_{j} \log \frac{f}{\pi_{J}}+\frac{1}{2} T_{j}\right) \\
& -\stackrel{\rightharpoonup}{\nabla}_{k}\left\{g^{k j}\left(\partial_{j} \log \frac{f}{\pi_{J}}+\frac{1}{2} T_{j}\right)\right\}+O\left(n^{-\frac{1}{2}}\right) \\
= & -\frac{1}{2} g^{i j}\left(\partial_{i} \log \frac{f}{\pi_{J}}\right)\left(\partial_{j} \log \frac{f}{\pi_{J}}\right)-\frac{1}{2} g^{i j} T_{i} \partial_{j} \log \frac{f}{\pi_{J}} \\
& -\frac{e}{\nabla_{k}}\left\{g^{k j}\left(\partial_{j} \log \frac{f}{\pi_{J}}\right)\right\}+O\left(n^{-\frac{1}{2}}\right) \\
= & -\frac{1}{2} g^{i j}\left(\partial_{i} \log \frac{f}{\pi_{J}}\right)\left(\partial_{j} \log \frac{f}{\pi_{J}}\right)-\nabla_{k}\left\{g^{k j}\left(\partial_{j} \log \frac{f}{\pi_{J}}\right)\right\}+O\left(n^{-\frac{1}{2}}\right) \\
= & -\frac{1}{2} g^{i j}\left(\partial_{i} \log \frac{f}{\pi_{J}}\right)\left(\partial_{j} \log \frac{f}{\pi_{J}}\right) \\
& -\frac{\pi_{J}}{f} \Delta \frac{f}{\pi_{J}}+g^{i j}\left(\partial_{i} \log \frac{f}{\pi_{J}}\right)\left(\partial_{j} \log \frac{f}{\pi_{J}}\right)+O\left(n^{-\frac{1}{2}}\right) \\
= & \frac{1}{2} g^{i j}\left(\partial_{i} \log \frac{f}{\pi_{J}}\right)\left(\partial_{j} \log \frac{f}{\pi_{J}}\right)-\frac{\pi_{J}}{f} \Delta \frac{f}{\pi_{J}}+O\left(n^{-\frac{1}{2}}\right) .
\end{aligned}

In the above calculation, we used some formulas with respect to the Laplace-Beltrami operator (see Appendix D.).
Thus, we obtain the following theorem,

## Theorem 1.

For the ARMA models, if there exists a superharmonic function $h(\theta)$ such that $\Delta h \leq 0$ and $h>0$, then up to the second order, one can improve $\hat{S}_{\pi_{J}}$ based on the Jeffreys prior by adopting the superharmonic prior $\pi_{H}(\theta):=\pi_{J}(\theta) h(\theta)$.

## VI. SUMMARY

In the present paper we obtain the asymptotic expansion of the risk difference of the KL-divergence in the ARMA model. If there exists a superharmonic function $h(\theta)$ on the corresponding ARMA model manifold, it is better in the Bayesian framework to adopt a superharmonic prior $\pi_{H}(\theta):=\pi_{J}(\theta) h(\theta)$ as a noninformative prior. It is because that Bayesian spectral densities based on a superharmonic prior asymptotically dominates those based on the Jeffreys prior in evaluating the averaged Kullback-Leibler loss.

It is shown that there exists a superharmonic prior for the $\operatorname{AR}(2)$ process and the $\mathrm{MA}(2)$ process [9]. The explicit form of the superharmonic prior is also obtained and the numerical simulation ensures our theorem [10]. The existence of superharmonic priors for the higher order $\operatorname{ARMA}(p, q)$ processes $(p+q \geq 3)$ remains to be discussed.

## APPENDIX A: ASYMPTOTIC EXPANSION OF $\delta$

In the present section, we evaluate $E_{\theta_{0}}\left[\delta^{k}\right]$ up to $O_{p}\left(n^{-1}\right)$. The key equation is as follows.

We set $L_{m}:=\frac{1}{n} \frac{\partial l\left(\theta_{0}\right)}{\partial \theta^{m}}$ etc. We omit $\theta_{0}$ in the remainder of this section. Since $\delta^{i}=O_{p}\left(n^{-\frac{1}{2}}\right)$, higher order terms are recursively obtained and

\delta^{i}=-L^{i m} L_{m}-\frac{1}{2} L^{l k} L_{k i j}\left(L^{i m} L_{m}\right)\left(L^{j n} L_{n}\right)+O_{p}\left(n^{-\frac{3}{2}}\right),
$$

where $-L^{i m} L_{m}=O_{p}\left(n^{-\frac{1}{2}}\right)$ and $L^{l k} L_{k i j}\left(L^{i m} L_{m}\right)\left(L^{j n} L_{n}\right)=O_{p}\left(n^{-1}\right)$. Now we evaluate $E\left[\delta^{i}\right]$ up to $O_{p}\left(n^{-1}\right)$. Since $L^{l k} L_{k i j}\left(L^{i m} L_{m}\right)\left(L^{j n} L_{n}\right)=O_{p}\left(n^{-1}\right)$,

& E\left[L^{l k} L_{k i j}\left(L^{i m} L_{m}\right)\left(L^{j n} L_{n}\right)\right] \\
= & E\left[L^{l k}\right] E\left[L_{k i j}\right] E\left[L^{i m}\right] E\left[L^{j n}\right] E\left[L_{m} L_{n}\right]+O\left(n^{-\frac{3}{2}}\right)
\end{aligned}
$$

Note that some identities $E\left[L_{m}\right]=0, \quad E\left[L_{m} L_{n}\right]=-\frac{1}{n} E\left[L_{m n}\right]$. Let us denote $m_{i j}:=$ $E\left[L_{i j}\right], L^{i j}=E\left[L^{i j}\right]+O_{p}\left(n^{-\frac{1}{2}}\right)$ etc. and $m^{i j}$ be the inverse matrix of $m_{i j}$. Note that $E\left[L^{i j}\right]=m^{i j}+O\left(n^{-\frac{1}{2}}\right)$. Thus,

= & -\frac{1}{2 n} m^{l k} m_{k i j} m^{i m} m^{j n}\left(-m_{m n}\right)+O\left(n^{-\frac{3}{2}}\right) \\
= & +\frac{1}{2 n} m^{l k} m_{k i j} m^{i j}+O\left(n^{-\frac{3}{2}}\right) .
\end{aligned}

Collecting the all terms, we can rewrite $E\left[\delta^{i}\right]$,

Here, the first term is $O\left(n^{-\frac{1}{2}}\right)$ and we need to evaluate the second principal term.

& =-\frac{1}{n} m^{i l} m_{l k, m} m^{k m}+O\left(n^{-\frac{3}{2}}\right),
\end{aligned}

where $m_{l k, m}:=n E\left[\delta L_{l k} L_{m}\right]$. Thus, we obtain

## APPENDIX B: EXPLICIT FORM OF THE EXPECTATION OF THE LOG LIKELIHOOD FOR THE ARMA MODEL

In this section, we calculate $m_{i j}, m_{i j k}$ and $m_{i j, k}$ for the ARMA model. Up to $O\left(n^{-1}\right)$, it can be written in geometrical quantities $g_{i j}, T_{i j k}$ and $\stackrel{(m)}{\Gamma}_{i, j k}$, which are defined by spectral density $S(\omega \mid \theta)$.

## 1. Trace formula

Before going into details, we mention the trace formulas. Suppose that $\left\{x_{i}\right\}_{i=1}$ subject to a stationary Gaussian process with zero mean, i.e., $\left(x_{1}, \ldots, x_{n}\right) \sim \mathcal{N}(0, \Sigma)$. (The $(s, t)$ th component $\Sigma_{s t}$ depends only on $s-t$ and such a matrix is called a Toeplitz matrix.) Then for any symmetric matrices $A$ and $B$, the following equations hold.

Taking expectation of $L_{i j}\left(:=\frac{1}{n} \frac{\partial^{2} l_{n}}{\partial \theta^{2} \partial \theta^{j}}\right)=X_{n}^{\prime} S_{i j} X_{n}+J_{i j}^{\prime}-h_{i j}$, we obtain

L_{k} & =\frac{1}{2 n}\left\{X_{n}^{\prime}\left(\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{k}} \Sigma^{-1}\right) X_{n}-\operatorname{Tr}\left(\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{k}}\right)\right\} \\
& =X_{n}^{\prime} B_{k} X_{n}-E\left[X_{n}^{\prime} B_{k} X_{n}\right],
\end{aligned}
$$

where

$$
B_{k}:=\frac{1}{2 n}\left\{\Sigma^{-1}\left(\frac{\partial \Sigma}{\partial \theta^{k}}\right) \Sigma^{-1}\right\}
$$

Thus,

$$
\begin{aligned}
& m_{i j, k} \\
= & E\left[\left(X_{n}^{\prime} S_{i j} X_{n}+J_{i j}^{\prime}-h_{i j}\right)\left(X_{n}^{\prime} B_{k} X_{n}-\operatorname{Tr}\left[B_{k} \Sigma\right]\right)\right] \\
= & \operatorname{Tr}\left[S_{i j} \Sigma\right] \operatorname{Tr}\left[B_{k} \Sigma\right]+2 \operatorname{Tr}\left[S_{i j} \Sigma B_{k} \Sigma\right]-\operatorname{Tr}\left[S_{i j} \Sigma\right] \operatorname{Tr}\left[B_{k} \Sigma\right] \\
= & 2 \operatorname{Tr}\left[S_{i j} \Sigma B_{k} \Sigma\right] \\
= & 2 \operatorname{Tr}\left[\frac{1}{2 n}\left\{\Sigma^{-1} \frac{\partial^{2} \Sigma}{\partial \theta^{i} \partial \theta^{j}}-\left(\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{i}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{j}} \Sigma^{-1}+\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{j}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{i}}\right)\right\}\right. \\
& \left.\times \frac{1}{2 n}\left\{\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{k}}\right\}\right] \\
= & \frac{1}{n}\left\{\frac{1}{2 n} \operatorname{Tr}\left(\Sigma^{-1} \frac{\partial^{2} \Sigma}{\partial \theta^{i} \partial \theta^{j}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{k}}\right)-\frac{1}{2 n} \operatorname{Tr}\left(\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{i}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{j}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{k}}\right)\right. \\
& \left.-\frac{1}{2 n} \operatorname{Tr}\left(\Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{j}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{i}} \Sigma^{-1} \frac{\partial \Sigma}{\partial \theta^{k}}\right)\right\} \\
= & \frac{1}{n}\left(\Gamma_{k i j}^{\prime}-T_{i j k}^{\prime}-T_{j i k}^{\prime}\right)\left(=O\left(n^{-1}\right)\right)
\end{aligned}
$$

Now we summarize the whole results,

\begin{aligned}
m_{i j} & =-J_{i j}^{\prime} \\
m_{i j k} & =2\left(T_{i j k}^{\prime}+T_{j i k}^{\prime}\right)-\left(\Gamma_{i j k}^{\prime}+\Gamma_{j i k}^{\prime}+\Gamma_{k i j}^{\prime}\right) \\
m_{i j, k} & =\frac{1}{n}\left(\Gamma_{k i j}^{\prime}-T_{i j k}^{\prime}-T_{j i k}^{\prime}\right)
\end{aligned}
$$

## APPENDIX C: MOMENT FORMULA

Let us calculate the $p$-th moment of the multivariate Gaussian distribution by using the characteristic function (chf). We set a mean parameter equal to zero and denote a covariance matrix as $\Sigma$. Then, chf is given by

$$
\varphi(t):=E\left[e^{i t^{\prime} X}\right]=\exp \left(-\frac{1}{2} t^{\prime} \Sigma t\right)
$$

where $t=\left(t^{1} \cdots t^{k}\right)^{\prime}$.For even $p$,

$$
I^{i_{1} i_{2} \cdots i_{p}}=\left.(i)^{p} \frac{\partial}{\partial t^{i_{1}}} \frac{\partial}{\partial t^{i_{2}}} \cdots \frac{\partial}{\partial t^{i_{p}}} \exp \left(-\frac{1}{2} t^{\prime} \Sigma t\right)\right|_{t \rightarrow 0}
$$

Note that for odd $p$, the moments vanish.

## APPENDIX D: LAPLACE-BELTRAMI OPERATOR

We briefly summarize the Laplace-Beltrami operator in the Riemannian manifold. (See, e.g., Kobayashi and Nomizu [5]). The covariant derivative in the $j$-th direction of a vector $V^{l}$ is defined by

$$
\nabla_{j} V^{l}:=\partial_{j} V^{l}+\Gamma_{k j}^{l} V^{k}
$$

where $\partial_{j}$ denotes $\frac{\partial}{\partial \theta^{j}}$. When we set $V^{j}=\nabla^{j} \phi=\partial^{j} \phi=g^{j l} \partial_{l} \phi$ for a scalar function $\phi$, the Laplace-Beltrami operator is defined by

$$
\begin{aligned}
\Delta \phi:=\nabla_{j} \nabla^{j} \phi & =\partial_{j}\left(\nabla^{j} \phi\right)+\Gamma_{j k}^{k}\left(\nabla^{j} \phi\right) \\
& =\partial_{j}\left(\nabla^{j} \phi\right)+\frac{1}{\sqrt{g}}\left(\partial_{j} \sqrt{g}\right)\left(\nabla^{j} \phi\right) \\
& =\frac{1}{\sqrt{g}} \partial_{i}\left(\sqrt{g} \nabla^{j} \phi\right) \\
& =\frac{1}{\sqrt{g}} \partial_{i}\left(\sqrt{g} g^{j k} \partial_{k} \phi\right) .
\end{aligned}
$$

Denoting $g:=\operatorname{det} g_{i j}$, and since $\frac{\partial_{j} g}{g}=g^{k l} \partial_{j} g_{k l}$,

$$
\Gamma_{j i}^{i}=\frac{1}{2} g^{i k}\left(\partial_{i} g_{k j}+\partial_{j} g_{k i}-\partial_{k} g_{j i}\right)=\frac{1}{2} g^{i k} \partial_{j} g_{k i}=\frac{1}{2} \frac{\partial_{j} g}{g} .
$$

Thus we can rewrite $\Gamma_{j i}^{i}=\frac{1}{\sqrt{g}} \partial_{j}(\sqrt{g})=\partial_{j} \log (\sqrt{g})=\partial_{j} \log \pi_{J}$.
