# On phylogenetic trees \{ a geom eter's view

A bstract: In the present note we investigate pro jective varieties which are geo$m$ etric $m$ odels ofbinary sym $m$ etric phylogenetic 3-valent trees. $W$ e prove that these varieties have $G$ orenstein term inal singularities (w ith sm all resolution) and they are Fano varieties of index 4. M oreover any two such varieties associated to trees $w$ ith the sam e num ber of leaves are deform ation equivalent, that is, they are in the sam e connected com ponent of the $H$ ilbert schem e of the pro jective space. A s an application we provide a sim ple form ula for com puting their $H$ ibert E hrhard polynom ial.

## 0 Introduction

A lgebraic geom etry, a classical, alm ost ancient, branch of pure m athem atics, is constantly stim ulated by questions arising in applicablem athem atics and other sciences. String theory and $m$ irror con jecture from $m$ athem atical physics, coding theory and im age recognition from com puter sciences | to $m$ ention just a few of the big areas of sciences which had enorm ous im pact on the developm ent of algebraic geom etry in the past decade. N ow the m odem biology w ith its com putational aspects and relations to statistics seem $s$ to be $m$ aking its $w$ ay into this branch of $m$ athem atics.

A though the roots of questions which we tackle are beyond the area of our professional interest and we do not claim any thorough understanding of them still, the questions form ulated in the language of our trade seem to be extrem ely interesting for its ow $n, m$ athem atical $m$ eaning. In fact, we believe that $m$ ost of the im portant things in $m$ athem atics are related to realphenom ena of $N$ ature. T he interpretation of this profound feature ofM athem atics is left for the reader and it willde nitely depend on the reader's attitude tow ards fundam entalC reation vs. Evolution problem, cf. and
K now ing our lim itations as laym en in com putationalbiology and statistics we try to stay w ithin borders of the branch ofm athem atics which w e believe we understand. That isw hy we take a relatively sim plem odel, rede ne it in purely algebraic language and exam ine it using $m$ ethods of algebraic geom etry. The result exceeds our original expectations, we nd the ob ject appearing in this process very interesting for its own, pure geom etric aspects, with properties which we have not expected originally.

O ur originaltask was com puting H ilbert $\pm$ hrhard polynom ials for varieties arising as geom etrical m odels of binary sym m etric 3 -valent phylogenetic trees. The question is consistent w ith the attitude of com putational algebraic geom etry and
algebraic statistics where the point is to com pute and understand the ideal of the variety in question in the am bient pro jective space. T hen the $H$ ilbert $\pm$ hrhard polynom ial provides a fundam ental invariant of such an ideal, the dim ensions of hom ogeneous parts of it. To our surprise the polynom ialdoes not depend on the shape of the tree but m erely on its size, the num ber of leaves or, equivalently the dim ension of its geom etric $m$ odel. The strive to understandina this phenom enon lead us to proving one of the $m$ ain results of the present paper which asserts that m odels of trees w th the sam e num ber of leaves are deform ation equivalent, that is they are in the sam e connected com ponent of the $H$ ilbert schem e of the pro jective space in question (hence they have the sam e $H$ ilbert polynom ial).

The fact that the geom etric $m$ odels of trees $m$ odelling som e processes $\mid$ the discreet ob jects | live in a connected continuous fam ily of geom etric ob jects probably deserves its explanation in term sof algebraic statistic or even biology. For the algebraic geom etry part we have a natural question arising about irreducibility of the com ponent of the H ilbert schem e containing thesem odels and (ifthe irreducibility is con m ed) about varieties which arise as general deform ations (that is, over a generalpoint of the com ponent of the $H$ ibert schem e in question). The question about a generaldeform ation of the m odel is related to the other $m$ ain result of the present paper which is that these m odels are index 4 Fano varieties $w$ ith $G$ orenstein tem inal singularities. Thus one would exnect that their general deform ation is a sm ooth Fano variety of index 4, c.f.

The present paper is organized as follow s. W e deal w ith varieties de ned over com plex numbers. In the rst section we de ne phylogenetic trees and their geom etric models. We do it in pure algebraic way and with m any sim pli cations: we deal w th unrooted sym $m$ etric trees which are then assum ed to be binary and eventually 3 -valent. From the algebraic geom eter point of view studying geom etric m odels in this case can be reduced to understanding special linear subsystem s of the Segre linear system on a product of $P^{1 / s}$ Eventually, the question boils dow $n$ to studying xed points of the Segre system with respect to an action of a group of involutions Since the action can be diagonalized this brings us dow $n$ to toric geom etry.

In the second section we de ne a geom etric m odel of a tree in term $s$ of toric geom etry, via a polytope in the space of characters of a com plex tonus, which we calla polytopem odelof the tree and to which we subsequently associate a pro jective variety. Them ain results of this part ar and $\quad$ hich assert that the $m$ odels de ned in the rst part are the same as these de ned the toric way. In this part we also prove results which are of the fundamental technical im portance: this is a ber product form ula for polytopes of trees and its counterpart for varieties,
a quotient form ule The latter asserts that the geom etric m odel of a tree obtained by gluing two sm aller trees is a M um ford's G IT (G eom etric Invariant Theory) quotient of the product of their respective m odels.
$T$ he third section of the present paper contains itsm ain results. A fter a briefdiscussion of equations de ning a geom etric m odel of a tree, with special consideration to a tree w ith two inner nodes and four leaves, we exam ine fans of geom etric m odels and resolution of their singularities. W e prove that geom etric $m$ odels of 3 -valent binary sym $m$ etric trees are index 4 Fano varieties with $G$ orenstein term inal singularities which adm it sm all resolution N ext we consider deform ations ofm odels of trees. The approach is, roughly, as follow s: we know how to deform equations of a sm all tree w ith four leaves and one inner edge, the result of the deform ation is another tree w ith the inner edge \opped":


A pplying the G IT quotient form ula
we are able to use this elem entary defor$m$ ation associated to four leaves trees to get a sim ilar deform ation for every inner edge of any tree This im plies the result about deform ing one geom etric m odel to another

In the last part of section 3, we discuss H ilbert E hrhard polynom ial of m odels (both polytopes and varieties) oftrees. W e de ne a relative version ofthe polynom ial and then a product of such polynom ials which is related to gluing respective trees. The elem entary deform ation procedure im plies associativity of the product which not only im plies the invariance of the $H$ ilbert $\Psi$ hrhard polynom ial for trees $w$ w th the sam e num ber of leaves but also provides a sim ple form ula for com puting it

The appendix contains som e com putations. Firstly we prove that the polytopes of the 3 -valent trees are norm alwhich is needed to ensure the proper de nition of their geom etrical $m$ odels. $N$ ext, using the software we verify a sim ple (yet 9-dim ensional) exam ple to check that tne porytope $m$ odels of di erent trees in this case are di erent. The question if the polytone (or aeom etric) m odels of non-
 $m$ ake num erical experim ents (using and to look at the behaviour of the relative volum e distribution which $m$ easures une (norm alized) volum e of the $m$ odelw th respect to a xed leaf of a tree.

The paper uses consistently the language of algebraic geom etry, inchuding toric geom etry. W e ignore, or barely m ention. relations to algebraic statistic and biology, suggesting the reader to look into -................. (or into for a concise version of exposition), to get an idea about the oackground of the problem s that we
deal with. It was our prim ary intention to $m$ ake the present paper self-contained so that it can be read as it is by an algebraic geom eter w ith no know ledge of its possible applications outside algebraic geom etry. On the other hand, a reader who is not fam iliar w ith algebraic geom etry but is interested in acquiring ideas which are im portant in our approadh (regarding quotients and deform ations) is advised to look into and for a short exposition to these $m$ atters.

## 1 P relim inaries: phylogenetic trees.

Sum m ary: (for algebraic geom eters) phylogenetic trees are a clever way of describing linear subsystem s of Segre system on the product of projective spaces. In case of binary sym $m$ etric trees the question is to nd subsystem $s$ of sections of Segre system on a product of $\mathrm{P}^{1}$ 's invariant $w$ ith respect to som e $Z_{2}^{\text {NN }}$ action.

### 1.1 Trees and linear algebra

A n edge which contains a leaf is called a petiole, an edge which is not a petiole is called an inner edge (or branch), and the set of inner edges w ill be denoted by $\mathrm{E}^{\circ}$.

An caterpillar of length $n$ is a 3 -valent tree $w$ ith $n$ inner edges and $n+1$ inner nodes whose defoliation (ie. after rem oving all leaves and petioles) is just a string of edges. That is, there are exactly tw o inner nodes to which of them there are attached two petioles (w e call them heads or tails), any other inner node has exactly one petiole (called a leg) attached.

### 1.2 B inary sym m etric trees.

D epending on the choice of W W we get di erent phylogenetic trees and their m odels. A natural assum ption is that in the m atrix representation the elem ents of W the sum of the num bers in each row and each colum $n$ is the sam e (in applications, these num bers would stand for the probability distribution so their sum should be equal to 1 ). If $W$ is of dim ension 2 this is equivalent to saying that the respective $m$ atrix is of the form

From now on we will consider binary sym m etric phylogenetic trees, that is, we assum e that dim ension of $W$ is 2 and $W$ consists ofm atrices (tensors) satisfying the above sym $m$ etric condition. The elem ents of the distinguished basis of $W \mathrm{w}$ ill be denoted and. N ote that W has dim ension 2 as well. We w ill call them binary sym $m$ etric trees or just trees when the context is obvious. O ur task is to understand geom etric m odels of these trees.

W ew illprove that, in fact, b L is an isom orphism so that the geom etric $m$ odel of the tree is de ned by $\mathrm{G}^{\mathrm{N}}$ invariant sections of the Segre linear system. Because o $\quad G^{N}$ can be treated as a subgroup of a com plex torus and thus we can use toric geom etry.

## 2 Toric geom etry.

Sum $m$ ary: $W$ e study invariants of an action of $Z_{2}^{N}$ on $\left(P^{1}\right){ }^{£ j}$ and a related polytope in the cube $[0 ; 1]^{\text {Ej }}$ which we call a polytope $m$ odel of the tree. The polytope m odels are used to de ne geom etric m odels in term s of toric geom etry. These polytopes tum out to be ber products of elem entary ones. This leads to interpreting the geom etricalm odel of a tree as a quotient of products.

### 2.1 Lattice of a tree and the action of the torus

G iven a tree $T$ we encode it in term s of dual lattioes.
De nition 2.1. Let $T_{L}$ be a tree with the set of vertices $V$ and the set of edges E . $W$ e set $M=M(T)={ }_{e 2 \mathrm{E}} Z \quad$ e to be a lattice, or free abelian group, spanned on the set $E$. Let $N=N(T)=H$ om $M$; $Z$ ) be the dual lattice. $W$ e represent elem ents of V as elem ents of N . Nam ely, for v 2 V we set $\mathrm{v}(\mathrm{e})=1$ ife contains the vertex V and $v(e)=0$ otherw ise. The pair ( $\mathrm{M} ; \mathrm{N}$ ) together $w$ ith the choice of the basis E of M and $\operatorname{set} \mathrm{V} \quad \mathrm{N}$ is called the lattice pair of the tree T .

From this point on we identify the edges and the vertioes of $T$ w ith the respective elem ents in $M$ ( $T$ ) and $N(T)$. The elem ents of the basis of $N$ duapl to fe 2 Eg will be denoted by $e$. Then for any $v 2 \mathrm{~V}$ we have, by de nition, $\mathrm{v}=\mathrm{e}_{\mathrm{e} \mathrm{v}} \mathrm{e}: \mathrm{N}!\mathrm{Z}$. In particular, v is a leaf if and only if $\mathrm{v}=\mathrm{e}$ for som $\mathrm{e} e$, which is a petiole for v .

Let us recall that $\ddagger j=\mp j+1$ so the set ofvertioes has to be linearly dependent in $\mathrm{N} . \mathrm{The}$ set of vertioes of T can be divided into two disjoint classes, say $\mathrm{V}=\mathrm{V} \quad\left[\mathrm{V}^{+}\right.$, each class consisting of vertioes which can be reached one from another by passing through an even num ber of edges.

Sum $m$ ary : From this point on we concentrate on understanding varieties associated to 3 -valent binary trees and we prove $m$ ain results of the present note which are as
follow s: (1) such varieties have only G orenstein term inal singularities and are Fano of index 4, (2) any two such varieties associated to trees w ith the sam e num ber of leaves are in the sam e connected com ponent of the $H$ ilbert schem e of the pro jective space, (3) their H ibert Ehrhard polynom ial can be com puted e ectively..

### 3.1 P aths, netw orks and sockets.

Let $T$ be a 3-valent binary sym $m$ etric tree. In section ve identi ed the variety $X(T)$ in $P^{2^{j \mathrm{H} ~ 1 ~} 1}{ }^{1} \mathrm{w}$ ith the closure of the im age of a torusm ap de ned by a polytope
( T ). W e recall that the linear coordinates on the am bient pro jective space can be identi ed with the vertioes of ( T ) which are am ong the vertioes of the cube $\quad \mathrm{m}$ satisfying parity relation with respect to the form s v 2 N For 3-valent trees we have a convenient interpretation of these points.

A netw ork of paths (or just a network) on $T$ is a set of paths (possibly an em pty set), each two of them have no comm on vertex (neither edge). For any netw ork of paths on $T$ we de ne the socket ( ) L to be the set of leaves which are ending points of paths in .

A tree $T$ is labeled if its leaves are num bered by $1 ;::: ;$; $j$. A subset $L$ is represented by a characteristic sequence (1);:::; ( $\ddagger$ depending on whether the leaf num bered by $i$ is in or not.

Sockets of netw orks will identi ed by their characteristic binary sequences. W e note that, clearly, every socket consists of even num ber of elem ents in L.

E xample 3.2. Let us consider a labeled 3 -valent tree with four leaves. In the follow ing diagram, in the upper row we draw all possible networks on this tree, where paths are denoted by solid line segm ents. In the low er row we w rite dow $n$ the respective sockets in term s of characteristic sequenœes of length four

This $m$ ap is surjective, that is, every subset of $L$ w ith even um ber ofelem ents is a socket of a netw ork. Indeed, this follow s by a straightforw ard induction $w$ ith respect to the num ber of leaves of the tree: in the induction step we $w$ rite a tree $T_{n+1}$ w ith $n+1$ leaves as a graft of a tree $T_{n} w$ ith $n$ leaves and a star tree w ith 3 leaves and consider three cases depending on how $m$ any of the two new leaves replacing one old are in the set L.

Finally, because the num ber of all subsets of $L$ w ith even num ber of elem ents equals to $2^{j j}{ }^{j 1}$ we get the follow ing.

### 3.3 M utation of a tree, deform ation of a m odel.

In exam ply we noted that a four-leaf 3-valent tree can be labeled in three nonequivalent ways. W e can revert it to say that given four num bered leaves we have three 3 -valent labeled trees connecting these leaves. By grouping in pairs the leaves whose petioles are attached to com $m$ on inner nodes we can list these as follow s : $(1 ; 2)(3 ; 4),(1 ; 3)(2 ; 4)$, and $(1 ; 4)(2 ; 3)$.

N ow, given four pointed trees $\mathrm{T}_{\mathrm{i}}$, where $\mathrm{i}=1 ;::: ; 4$ we can produce a tree T by grafting the tree $T_{i}$ along the $i$-th leaf of a labeled 3 -valent 4-leaf tree $T_{0}$. H ere are possible con gurations, $e_{0}$ denotes the inner edge of the tree $T_{0}$


De nition 3.19. In the above situation we say that there exists an elem entary mutation along $e_{0}$ from one of the above trees to the other two. (W e note that a $m$ utation $m$ ay actually yield an equivalent tree.) W e say that two trees are m utation equivalent if there exists a sequence of elem entary $m$ utations from one to the other.

Lem m a 3.20. A ny two 3-valent trees with the sam e num ber of leaves are m utation equivalent.

Proof. W e prove, by induction, that any 3-valent tree is m utation equivalent to a caterpillar. can be deform ed to $X_{b}$ over the base $B$. This gives rise to a notion of deform ation equivalent subvarieties of $\mathrm{P}^{\mathrm{m}}$.

Denition 3.21. G iven two subvarieties $X_{1} ; X_{2}$ in $P^{m}$ we say that they are defor$m$ ation equivalent if their classes are in the sam e connected com ponent of the $H$ ibert schem e of $\mathrm{P}^{\mathrm{m}}$.

Com plete intersections of the sam e type are deform ation equivalent. Let us consider an fundam ental exam ple, understanding of which is essential for the proof of the $m$ ain result of this section.

The above theorem m plies that the operation ? on relative Ehrhard functions of polytopes of 3-valent trees is not only com mutative (which is obvious from its de nition) but also associative. This im plies that the function does not depend on either the shape nor the location of the leaf. M ore precisely we have the follow ing form ula which allow s to com pute the $H$ ilbert $\pm$ hrhard polynom ial very e ciently.

## A. 2 Two 3-valent trees w ith 6 leaves

O ne of the fiundam ental questions regarding the phylogenetic trees is the follow ing. $G$ iven two (3-valent binary sym $m$ etric) trees $T_{1}$ and $T_{2}$ suppose that ( $T_{1}$ ) $=\left(T_{2}\right)$ as lattice polytopes, or the projective models $\mathrm{X}\left(\mathrm{T}_{1}\right)$ and $\mathrm{X}\left(\mathrm{T}_{2}\right)$ are projectively equivalent. D oes it im ply that the trees are equivalent (as CW com plexes) as well?

W e tackled the problem by understanding the di erence of $m$ odels of the two sim plest non-equivalent trees. These are 6-leaf trees pictured below . resnectively, a 3-caterpillar tree and a tree which we call a snow ake,



The snow ake tree is obtained from the 3-catenpillar tree by elem entary $m$ utation along its $m$ iddle inner edge. Therefore their $H$ ibert $\pm$ hrhard polynom ials are equal and com puted w ith [maxima] to be as follow s.

## A . 3 V olum e distribution

The leading coe cient in the Ehrhard polynom ial of a lattioe polytope can be identi ed as the volum e of (w ith respect to the lattice in question, whose unit cube is assum ed to have volume 1). Sim ilarly, we can de ne a relative volume function which $w i l l m$ easure the distribution of the volum e of ( $T$ ) w ith respect to a leaf ' of $T$. Because o this function does not depend either on the shape of the tree nor on the choige of the leaf '. M oreover we will norm alize it so that its integral over the unit segm ent is 1 .

If ${ }^{r}:[0 ; 1]!R$ is the nom alized volume distribution with respect to a leaf of a 3-valent tree w ith $r$ leaves then because o ve have ${ }^{n}(t)={ }^{n}\left(\begin{array}{ll}1 & t\end{array}\right)$ and for t $2(0 ; 1=2)$ we get the follow ing recursive form ula

H ow ever, the num erical experim ents which we have $m$ ade seem to indicate that for $r>3$ the actual values of ${ }^{r}$ do not depend too $m$ uch on $r, s e \mathrm{~F}$ ig. 1. It sem s that this function does not see the shape of the tree (which is because it com es from the relative H illeert E hrhard polynom ial) but also alm ost disregards its size (or dim ension of the $m$ odel)
