Design Issues for Generalized Linear Models: A Review

Abstract. Generalized linear models (GLMs) have been used quite effectively in the modeling of a mean response under nonstandard conditions, where discrete as well as continuous data distributions can be accomm odated. The choice of design for a GLM is a very important task in the developm ent and building of an adequate m odel. How ever, one major problem that handicaps the construction of a GLM design is its dependence on the unknown parameters of the tted model. Several approaches have been proposed in the past 25 years to solve this problem . These approaches, however, have provided only partial solutions that apply in only some special cases, and the problem, in general, remains largely unresolved. The purpose of this article is to focus attention on the aforem entioned dependence problem . We provide a survey of various existing techniques dealing with the dependence problem . This survey includes discussions concerning locally optim aldesigns, sequential designs, Bayesian designs and the quantile dispersion graph approach for comparing designs for GLM s.

1. IN TRODUCT ION

In m any experim ental situations, the m odeling of a response of interest is carried out using regression

techniques. The precision of estimating the unknown parameters of a given model depends to a large extent on the design used in the experiment. By design is meant the speci cation of the levels of the factors (control variables) that in uence the response.

The tools needed for the adequate selection of a design and the subsequent thing and evaluation of the model, using the data generated by the design, have been developed in an area of experim ental design known as response surface m ethodology (R SM). This area was initially developed for the purpose of determ ining optim um operating conditions in the chem ical industry. It is now used in a variety of elds and applications, not only in the physical and engineering sciences, but also in the biological, clinical, and social sciences. The article by M yers, K huri and Carter (1989) provides a broad review of RSM (see also M yers, 1999). In addition, the three books by Box and D raper (1987), M yers and M ontgom ery (1995) and K huriand C omell (1996) give a com prehensive coverage of the various techniques used in RSM .

Most design methods for RSM models in the present statistical literature were developed around agricultural, industrial and laboratory experiments. These designs are based on the standard general linear model where the responses are assumed to be continuous (quite often, norm ally distributed) with uncorrelated errors and hom ogeneous variances. How ever, clinical or epidem iological data, for exam ple, quite frequently do not satisfy these assumptions. For example, data which consist primarily of hum an responses tend to be m ore variable than is expected under the assumption of hom ogeneous variances. There is much less control over data collected in a clinical setting than over data observed in a laboratory or an industrial setting. Furtherm ore, most biological data are correlated due to particular genetic relationships. There are also many situations in which clinical experim ents tend to yield discrete data. Dose-response experim ents are one good example where the responses are binary in most cases. Furtherm ore, several responses m ay be observed for the same patient. For example, in addition to the standard binary response of success or failure, som e m easure of side e ects of the treatm ent m ay be of importance. Since responses are measured from the sam e subject, they will be correlated, and hence considering each response to be independent of others m ay lead to erroneous inferences.

Due to the nature of the data as described above, doing statistical analysis of the data using standard linear models will be inadequate. For such data, generalized linear models (GLM s) would be more appropriate. The latter models have proved to be very e ective in several areas of application. For example, in biological assays, reliability and survival analysis and a variety of applied biom edical elds, GLM shave been used for drawing statistical conclusions from acquired data sets. In multicenter clinicaltrials, estim ates of individual hospital treatm ent e ects are obtained by using GLMs (see Lee and Nelder, 2002). In entom ology, GLM s are utilized to relate changes in insect behavior to changes in the chem ical composition of a plant extract (Hern and Dom, 2001). Diaz et al. (2002) adopted som e G LM s in order to study the spatial pattern of an important tree species. In clim atology, G LM s are used to study the basic clim atological pattern and trends in daily maximum wind speed in certain regions (see Yan et al., 2002). A lso, Jewell and Shiboski (1990) used GLM s to exam ine the relationship between the risk

of H IV (hum an immunode ciency virus) infection and the number of contacts with other partners.

In all of the above examples and others, the cornerstone of modeling is the proper choice of designs needed to tGLMs. The purpose of a design is the determ ination of the settings of the control variables that result in adequate predictions of the response of interest throughout the experim ental region. Hence, GLMs cannot be used e ectively unless they are based on e cient designs with desirable properties. Unfortunately, little work has been done in developing such designs. This is mainly due to a serious problem caused by the dependence of a design on the unknown parameters of the tted GLM.

In this article, we address the aforem entioned design dependence problem by providing a survey of various approaches for tackling this problem. The article is organized as follows: Section 2 presents an introduction to GLM s. Section 3 describes criteria for the choice of a GLM design, and introduces the design dependence problem. The various approaches for solving this problem are discussed in Sections 4 (locally optim al designs), 5 (sequential designs), 6 (Bayesian designs) and 7 (quantile dispersion graphs). The article ends with som e concluding rem arks in Section 8.

2. GENERALIZED LINEAR MODELS

As a paradigm for a large class of problems in applied statistics, generalized linear models have proved very e ective since their introduction by Nelder and Wedderburn (1972).GLM s are a unied class of regression models for discrete and continuous response variables, and have been used routinely in dealing with observational studies. M any statisticaldevelopm ents in term s of m odeling and m ethodology in the past twenty years may be viewed as special cases of GLM s. Exam ples include logistic regression for binary responses, linear regression for continuous responses and log-linear models for counts. A classic book on the topic is M cC ullagh and N elder (1989). In addition, the more recent books by Lindsey (1997), M cCulloch and Searle (2001), D obson (2002) and M yers, M ontgom ery and V ining (2002) provide added insights into the application and usefulness of GLM s.

There are three components that de ne GLM s. These components are: tributed independently according to a certain probability distribution considered to belong to the exponential fam ily, whose probability mass function (or probability density function) is given by

where a (), b() and c() are known functions; canonical parameter and is a dispersion parameter (see M cC ullagh and N elder, 1989, page 28).

(ii) A linear regression function, or linear predictor, in k control variables $x_1; x_2; \ldots; x_k$ of the form

where f(x) is a known p-component vector-valued function of $x = (x_1; x_2; \dots; x_k)^T$, is an unknown parameter vector of order p = 1 and $f^{T}(x)$ is the transpose of f(x).

(iii) A link function g() which relates in (22)to the mean response (x) so that $(x) = g[(x)]_{r}$ where g() is a monotone di erentiable function. where (x) is the linear predictor in (2.2), and h W hen g is the identity function and the response has the norm aldistribution, we obtain the special class of linear m odels.

GLM s have several areas of application ranging from medicine to economics, quality controland sam ple surveys. Applications of the logistic regression m odel, expanded with the popularity of case-control designs in epidem iology, now provide a basic tool for epidem iologic investigation of chronic diseases. Sim ilar methods have been extensively used in econom etrics. P robit and logistic m odels play a key role in all form s of assay experim ents. The log-linear m odel is the cornerstone of m odern approaches to the analysis of contingency table data, and has been found particularly useful for medical and social sciences. Poisson regression models are widely employed to study rates of events such as disease outcom es. The com plem entary log { log m odel arises in the study of infectious diseases (e.g., in HIV disease transmission and AIDS as illustrated in Jewell and Shiboski, 1990), and more generally, in the analysis of survival data associated with clinical and longitudinal follow-up studies.

Traditionally, the exponential family model adopted for the study of GLM s deals with a linear function of the response variable involving the unknown parameters of interest. This covers most of the experim ental situations arising in practice.

(i) The elements of a response vector y are dis- How ever, som e special members, such as the curved exponential fam ily of distributions, are not covered. Thus, GLMs should be further generalized to include such m em bers.

> As was pointed out earlier, all known response surface techniques were developed within the fram ework of linear models under the strong assumptions of norm ality and equal variances concerning the eris for distribution. One in portant area that needs fur-

ther investigation under the less rigid structure of generalized linear models is the choice of design.

3. CHOICE OF DESIGN

By a choice of design we mean the determ ination of the settings of the control variables that yield an estimated (predicted) response with desirable properties. The mean response, (x), at a point x in a region of interest, R, is given by

is the inverse function of the link function q. An estimate of (x) is obtained by replacing in (3.1)with ^, the maximum likelihood estimate of , that is,

The variance of $^{(x)}$ is approximately given by (see Khuri, 1993, page 198)

where is the dispersion parameter (determ ined by the exponential fam ily considered), X is a matrix whose rows consist of $f^{T}(x)$ at the various settings of x used in a particular design and W is a diagonal matrix of the form

where $\frac{2}{u}$ is the variance of y_u , the response value at the uth experimental run, and $\frac{d}{d}u$ denotes the derivative of (x) with respect to (x) evaluated at the setting of x at the uth experimental run (u =1;2;:::;n).

The estimation bias incurred in (x) is approximately given by (see Robinson and Khuri, 2003)

and 1_n is an n 1 vector of 1's. Here $\frac{d^2}{d_u^2}$ denotes the second-order derivative of (x) with respect to

(x) evaluated at the uth experimental run (u = 1;2;...;n).

A good design is one that m in in izes the mean-squared error of $^(x)$, namely,

This is known as the mean-squared error of prediction (M SEP).Onemajorproblem in doing thism inimization is that the M SEP depends on , the parameter vector in the linear predictor in (2.2), which is unknown. This leads us to the so-called design dependence problem. Other design optimality criteria such as A -, D -, E - and G-optimality, which are variance-based criteria, su eralso from the same problem.

3.1 The Design Dependence Problem

In the foregoing section it has been emphasized that in the context of a GLM, the minimization of the mean-squared error of prediction, or of the variances of the parameter estimators, leading to the so-called optimal designs, depends on the values of unknown parameters. Common approaches to solving this problem include:

(a) The speci cation of initial values, or best \guesses," of the parameters involved, and the subsequent determ ination of the so-called locally optim aldesigns. (b) The sequential approach which allows the user to obtain updated estimates of the parameters in successive stages, starting with the initial values used in the rst stage.

(c) The Bayesian approach, where a prior distribution is assumed on the parameters, which is then incorporated into an appropriate design criterion by integrating it over the prior distribution.

(d) The use of the so-called quantile dispersion graphs approach, which allows the user to compare di erent designs based on quantile dispersion proles.

We now provide a review of the basic results that have been developed under the aforem entioned approaches.

4. LOCALLY OPT IM AL DESIGNS

B inary data under a logistic regression m odel and Poisson count data are the best known examples to illustrate the implementation of the rst approach leading up to a locally optim aldesign.

4.1 Logistic Regression M odel

Let us rst discuss the study of optim aldesigns for binary data under a logistic regression m odel. The key reference is M athew and Sinha (2001). O ther related references include Abdelbasit and P lackett (1983), M inkin (1987), K han and Yazdi (1988), W u (1988) and Sitter and W u (1993). It is postulated that a binary response variable y assumes the values 0 and 1 and the chance m echanism depends on a nonstochastic quantitative covariate X taking values in a speci ed dom ain. Speci cally, for X = x;ytakes the value 1 w ith probability given by

where and are unknown parameters with > 0. It may be noted that there are other versions of this model studied in the literature. One version refers to the dose-response model which will be discussed in the next sections. The parameters them selves and also some parametric functions such as – and percentiles of (x) are of interest to the experimenter. The purpose is to suggest continuous (or approximate) optim al designs, that is, optimum dose levels and their relative weights, following the term inology of continuous design theory. See Pukelsheim

(1993). It turns out that the solutions to the optim al design problem s m entioned above provide optim um values of + x . Hence, in order to im plem ent such designs in practice, good initialestim ates, or quess values, of and are needed. W hereas the earlier researchers established optim ality results case by case, M athew and Sinha (2001) developed a unied approach to tackle the optimality problems by exploiting the property of Loew ner-order dom ination in the comparison of information matrices. However, in some of these studies the technical details depend crucially on the symmetry of the transform ed factor space. For asym metric dom ains, Liski et al. (2002) have initiated som e studies in the conventional regression setup. Much yet remains to be done there and also in the context of logistic regression.

W ith reference to the model (4.1), consider now s distinct dose levels $x_1; x_2; :::; x_s$, and suppose we wish to obtain f_i observations on y at dose level x_i (i = 1; 2; :::; s). Let $\sum_{i=1}^{s} f_i = n$. For most e cient estimation of and , or some functions thereof, the exact optimal design problem in this context consists of optim ally selecting the number s of distinct dose levels, the x_i 's (in a given experimental region) and the f_i 's, with respect to a given optimality criterion, for a xed n. This is equivalent to the approximate determination of optimum dose levels with respective optimum (relative) weights, denoted by p_i (i = 1;2;:::;s), which sum to 1.

For various application areas, it turns out that the estim ation problem s that are usually of interest refer to (a) the estimation of , or = , or som epercentiles of (x) given in (4.1), or (b) the joint estim ation of a pair of param eters such as (i) and , and = , (iii) and a percentile of (x) and (ii) (iv) two percentiles of (x). The approach is to start with the asymptotic variance (covariance matrix of the maximum likelihood estimators of and , and then choose the x_i 's and the p_i 's optim ally by m inim izing a suitable function, depending on the nature of the problem at hand and the specic optimality criterion applied. For this reason, we consider the information matrix of the two parameters as a weighted combination of component information m atrices based on the x_i 's, using the p_i 's as weights. Then we argue that the asymptotic variance (covariance matrix of the maximum likelihood estimators of the param eters is just the inverse of the weighted inform ation m atrix com puted above. The optim ality functions to bem in im ized are di erent scalar-valued

functions of the information matrix. The D - and A -optim ality criteria are well-known examples. H istorically, the D -optim ality criterion has received considerable attention in this context and A -optim ality has also been considered by som e authors; see Sitter and W u (1993). As was mentioned earlier, the optim um dose levels depend on the unknown param eters and , as is typical in nonlinear settings. In fact, solutions to the optim aldesign problem sm entioned above provide optimum values of $+ x_{i}$ i= 1;:::;s. Therefore, while im plan enting the optim aldesign in practice, good initial estimates of and are called for. In spite of this unpleasant feature, it is in portant to construct the optim aldesigns in this context; see the argum ents in Ford, Torsney and W u (1992, page 569).

Follow ing the approxim ate design theory, a design is denoted by $D = f(x_i;p_i); i = 1;2; ...; sg.$ Therefore, the inform ation m atrix for the joint estim ation of and underlying the design D is given by

where $a_i = + x_i$, i = 1;...;s.

Note that except for the factors $\frac{\exp(a_i)}{(1+\exp(a_i))^2}$, the inform ation m atrix is identical to the one under the usual linear regression of y on a nonstochastic regressor x under the assumption of hom oscedastic error structure. This rem inds one of the celebrated de la Garza Phenom enon (de la Garza, 1954) which can be explained as follows. Suppose we consider a pth-degree polynom ial regression of y on x under hom ogeneous error structure and we start with an n-point design where n > p + 1. Then, according to this phenom enon, it is possible to come up with an alternative design with exactly p+1 support points such that the two designs have identical inform ation m atrices for the entire set of p + 1 param eters. This shows that in the hom oscedastic scenario, essentially one can con ne attention to the collection of designs supported on exactly p+ 1 points, if the underlying polynom ial regression is of degree p.On top of this, it is also possible that a particular (p+1)-point design dom in a tes another (p + 1)-point design in the

sense that the inform ation m atrix (for the entire set of param eters) based on the form er design Loew nerdom inates that based on the latter. Here, Loew ner dom ination m eans that the di erence of the two inform ation m atrices is nonnegative de nite. It must be noted that Loew ner dom ination is the best one can hope for, but it is rarely achieved. Pukelsheim (1993) has made som e system atic studies of Loew ner dom ination of inform ation m atrices. See Liski et al. (2002) for som e applications.

In the present setup, how ever, the form of the inform ation m atrix indicates that we are in a linear regression setup, but with a heteroscedastic error structure. Does the de la Garza Phenom enon still hold in this case? More importantly, do we have Loewner domination here? The Mathew and Sinha (2001) article m ay be regarded as one seeking answers to the above questions. From their study, it turns out that though Loewner dom ination is not possible, for D -optim ality the class of two-point designs is complete in the entire class of competing designs while for A-optimality, it is so in a subclass of competing designs which are symmetric in som e sense. Here, com pleteness is in the sense that any competing design outside the class is dom inated (with respect to the speci c optim ality-criterion) by another design within the class.

W e shallbrie y explain below the salient features of the arguments in M athew and Sinha (2001). Note rst that for the joint estimation of and , or for that m atter, for any two nonsingular transforms of them, the D -optimality criterion seeks to maximize the determinant of the joint information matrix of

and . R outine com putations yield an interesting representation for this determ inant,

Note that for any real number a, $\frac{\exp(a)}{(1+\exp(a))^2} = \frac{\exp(a)}{(1+\exp(a))^2}$. Moreover, it also turns out that for a given D = f(x_i;p_i);i= 1;2;:::;sg, there exists a real number c> 0 such that

Therefore, for this choice of c, the design D (c) = [(c;0.5); (c;0.5)] provides a larger value of the determ inant of the underlying inform ation m atrix than that based on D. Hence, the class of two-point sym - m etric designs provides a complete class of D -optim al designs. It is now a routine task to determ ine speci c D -optim al designs for various parametric functions. Of course, the initial solution is in terms of c-optim um (which is independent of and) and then we have to transfer it to optim um dose levels, say x_0 and x_{00} , by using the relations $c = + x_0$ and $c = + x_{00}$. Thus an initial good guess of and is called for to evaluate x_0 and x_{00} .

Again, for A-optim ality with respect to the parameters and , some algebraic simplication yields the following function (to be minimized) when we restrict to the subclass of symmetric designs (i.e., designs involving a_i and a_i with equal weights for every i):

In view of the existence of the real number c with the properties laid down above, it turns out that the design D (c) = [(c;0:5); (c;0:5)] once again does better than D with respect to A -optim ality, at least in the subclass of symmetric designs so de ned. It is a routine task to spellout the nature of a speci c A -optim aldesign, which in this case depends on the unknown parameters and in a twofold m anner. First, we have to determ ine the optim um value for c from given values of the parameters by minimizing the lower bound to (4.6) as a function of ; and c. Then we have to evaluate the values of the two recommended dose levels using the relations involvc, as above. Note that in the context ing c and of D-optim aldesigns, this twofold phenom enon did not arise.

R emark 4.1.1. It so happens that without the sym m etry restriction on the class of competing designs, construction of A -optim aldesigns, in general, is di cult. Numerical computations have revealed that A -optim aldesigns are stillpoint sym m etric but not weight sym m etric. An analytical proof of this observation is still lacking. In M athew and Sinha (2001), E -optim aldesigns have also been studied.

4.2 Poisson Count M odel

Let us now consider Poisson count data and explain the optim ality results following M inkin (1993) and Liski et al. (2002). Here we assume that y follows a Poisson distribution with mean (x), (x) = $c(x) \exp[(x)]$, (x) = +x; < 0. The emphasis in M inkin (1993) was on most e cient estimation of 1= by choosing a design in the nonstochastic factor space of x over [0;1). Naturally, only a locally optim al design could be characterized, which turned out to be a two-point design with 21:3% m ass at 0 and the rest at 2:557. Thus a good guess for

is called for. Liski et al. (2002) developed a unied theory in Minkin's setup for the derivation of a stronger result on completeness of two-point designs, including the point 0. Consequently, it was much easier to re-establish M inkin's result as well as to spell out explicitly the nature of A-, D-, Eand M V -optim al designs for simultaneous estim ation of the two param eters in the model. It may be noted that Fedorov (1972) gave a complete characterization of D -optim al designs in a polynom ial regression setup involving several fam ilies of heterogeneous variance functions. In an unpublished technical report, Das, M andal and Sinha (2003) extended the Loewner dom ination results of Liski et al. (2002) in a linear regression setup involving two speci c variance functions. W e shall brie y present these results below.

We recall that the setup of M inkin (1993), in a form suitable for our discussion, and as suggested in Liskiet al. (2002), is of the form

It is a routine task to write down the form of the information m atrix for the parameters ; underlying the design $D_s.W$ e call it $I_{D_s}.L$ iskiet al. (2002) established that given D_s , one can construct a two-point design D_2 whose information matrix, say ID_2 , dominates $I_{D_s}.D$ as, M and al and Sinha (2003) generalized this result when the above form of v(x) is changed to

Follow ing D as, M andaland Sinha (2003), we start with a general variance function v(x) subject to v(0) = 1 and v(x) increasing in x over 0 to 1 . N ext, we start with a two-point design of the form [(a;p);(b;q)] where 0 < a < b < 1 and 0 < p;q = 1 p <1. Then, we ask for the sort of variance functions for which this two-point design can be Loewnerdom inated by another two-point design, including the point 0. D e ne in this context two other related functions, (x) = 1 = v(x) and (x) = (v(x) - 1) = xfor every x > 0, (0) being the limit of (x) as x tends to 0. It follows that whenever these two functions satisfy the following conditions, it is possible to achieve this t:

D as, M andal and Sinha (2003) demonstrate that for both form s of v(x) as in (4.8), the above conditions are satis ed. They then continue to argue that this result on Loewner dom ination (by a twopoint design, including the point 0) holds even when one starts with an s-point design for s > 2. This greatly sim pli es the search for speci c optim aldesigns under di erent variance structures covered by the above two form s. M inkin's result follows as a special case of (i) in the above m odel. The details are reported in D as, M andal and Sinha (2003).

5. SEQUENTIAL DESIGN

In the previous section, initial values of the param eters are used as best \guesses" to determ ine a locally optim aldesign. Response values can then be obtained on the basis of the generated design. In the sequential approach, experim entation does not stop at this initial stage. Instead, using the inform ation thus obtained, updated estim ates of the param eters are developed and then used to determ ine additional design points in subsequent stages. This process continues until convergence is achieved with respect to a certain optim ality criterion, for example, D – optim ality. The implem entation of such a strategy is feasible provided that the response values in a given stage can be obtained in a short time, as in sensitivity testing. Sequential designs for GLM s were proposed by Wu (1985), Sitter and Forbes (1997) and Sitter and Wu (1999), am ong others.

The theory of optim al designs, as noted earlier, involves selection of design points with the goal of m in im izing som e objective function which can often be interpreted as an expected loss. In a sequential fram ework, with the arrival of each data point, one needs to make a decision of whether or not to pay for the cost of additional data or else to stop sam pling and make a decision. A lso, if additional observations become necessary, when there is an option of selecting samples from more than one population, the choice of a suitable sampling rule is equally im portant. The latter, on m any occasions, am ounts to the selection of suitable design points. Thus the issue of optim aldesigns goes hand in hand with sequential analysis, and together they constitute an area of what has become known as sequential design of experim ents.

Research on sequential designs can be classied into multiple categories depending on the objective of the researcher. We review here primarily a broad area commonly referred to as \Stochastic Approximation," which was initiated by Robbins and Monro (1951), and was subsequently extended by numerous authors. Here, the problem is one of sequential selection of design points according to some optimality criterion. We also discuss brie y some work on multistage designs.

In Section 5.1, we begin with the stochastic approximation procedure as described in R obbins and M onro (1951). We then consider several extensions and m odi cations of this pioneering work, and discuss asymptotic properties of the proposed m ethods. The R obbins{M onro article and m uch of the subsequent work do not prescribe any stopping rule in this sequential experimentation. There are a few exceptions, and we point out one such result.

Section 5.2 discusses application of the R obbins{ M onro m ethod and its extensions for estimating the percentiles of the quantal response curve, in particular, estimation of the median e ective dose, popularly known as ED 50. We highlight in this context the work of W u (1985). We also discuss brie y the Bayesian stopping rule as proposed by Freem an (1970). Finally, in Section 5.3, we provide a very short account of multistage designs.

In general, the core of sequential analysis involves sample size determ ination. This itself is an \optim al" design problem as stopping rules, in general, are motivated by some optim ality criteria. A very succinct account of sequential design of experim ents, motivated by several in portant statistical criteria, appeared in Chemo 's (1972) classic monograph.

5.1 Stochastic Approximation

We begin with a description of the stochastic approximation procedure of R obbins and M onro (RM) (1951). Let y be a random variable such that conditional on x, y has a distribution function (df) H (yjx) with mean E (yjx) = M (x) and variance V (yjx) = 2 (x). The function M (x) is unknown to the experimenter, but is assumed to be strictly increasing so that the equation M (x) = has a unique root, say . It is desired to estimate by making successive observations on y, say, $y_1; y_2; :::$ at levels $x_1; x_2; ::::$ The basic problem is the selection of the design points $x_1; x_2; ::::$

RM address this problem as follows: consider a nonstationary M arkov chain with an arbitrary initial value x_1 , and then de ne recursively

A nite sample justication of the RM procedure is given by W u (1985) when y and x are related by a simple linear regression model. In particular, let $y_i = 0 + 1x_i + e_i$, where e_i are independent and identically distributed with mean 0. Then the param eter of interest is $= 0^{-1}$, the solution of $_0 + _1 x = 0$. If $_1$ is know $n_i = y_n$ 1 x_n is the least-squares estimator of $_0$ based on $f(x_i; y_i); i =$ 1;:::; ng. Thus a natural choice of x_{n+1} is given by $\hat{y}_{n} = 1 = x_n$ $\frac{1}{1} y_n$. It is shown in Lai $x_{n+1} =$ and Robbins (1979) that $x_{n+1} = x_n$ $\begin{pmatrix} 1 \\ 1 \end{pmatrix} y_n$ for all n is equivalent to $x_{n+1} = x_n$ $\begin{pmatrix} 1 \\ 1 \end{pmatrix} = x_n$ for all n. This is an RM procedure with $a_n = \frac{1}{1} = n$ and = 0.

RM investigated asymptotic properties of their procedure. Let $b_n = E (x_n)^2$. RM showed that for bounded y and strictly increasing M (x), if $a_n = 0$ (n¹), then $b_n ! 0$ as n ! 1.

A more general result is proved later in Robbins and Siegm und (1971). Rather than the boundedness of y and the monotonicity of M (x), one assumes boundedness of (x) + M(x) jby a linear function of jxj. These conditions neither im ply nor are im plied by the original RM conditions. In addition, Robbins and Siegm und (1971) have another assumption which essentially im plies that M (x) and x are of the same sign. Finally, they assume that

Remark 5.1.1. The best rate of convergence is achieved when = 1, and then them inim um asymptotic variance is given by ${}^{2}() = M {}^{0}() f$. This is attained when a = $M {}^{0}()]^{1}$.

In view of Remark 5.1.1, an optimal asymptotic choice of $fa_n g$ is given by $a_n = (n + n_0)^{-1} d_n$, where d_n is any consistent estimator of M⁰() and n_0 is positive. One can interpret n_0 as a \tuning parameter" which does not a ect the asymptotics at all, but can play a major role when the sample size is small. A lso, Fabian (1983) has shown that when the conditional probability density function of y given x is N (M (x); ²(x)), then the RM procedure is locally asymptotically minimax. Moreover, Abdelham id (1973) and A nbar (1973) pointed out independently that even for nonnorm alconditional probability density functions, the RM process can be made asym ptotically optim alby a suitable transform ation of observations.

The next thing is to outline procedures which guarantee consistent estimation of M $^0($).Venter (1967) addressed this by taking observations in pairs at x_i c_i for a suitable positive sequence of constants fcig, i 1.W e denote by y_{i1} and y_{i2} the corresponding responses so that

where $\hat{d_n}$ is a truncated version of d_n ensuring that $x_n \stackrel{P}{!}$. Fabian (1968) and later Lai and Robbins (1979) contain relevant asymptotic results.

In spite of all the asymptotic niceties, the RM procedure can be seriously de cient for nite samples. This was demonstrated in the simulation studies of W u (1985) and Frees and Ruppert (1990). First, the initial choice of x_1 heavily in uences the recursive algorithm. If x_1 is far away from , then the convergence of x_n to may dem and prohibitively large n. A gain, if all the x_i 's are closely clustered around , no estimator of M⁰() can be very accurate, and imprecise estimation of M⁰() leads to imprecise estimation of due to the proposed recursive algorithm, at least for small samples.

The original RM paper, and much of the subsequent literature, address sequential design problem swithout specifying any stopping rule. However, a simple stopping rule can be proposed based on asym ptotic considerations. In particular, in the setup of Venter (1967), $\hat{d_n}_{\rm p} {\rm consistently}$ estimates M $^0($). voking the asymptotic normality of x_n , a large sam -)% con dence interval for is given by ple 100 (1 ¹ (1 =2) $\hat{}_{n} = f \hat{d}_{n} (2n)^{1=2} g$, where is the Xn cum ulative distribution function of the N (0;1) variable. If one decides to construct a con dence interval of length not exceeding 1, then one can stop at the rst n for which the width of the above interval is less than or equal to 1. Sielken (1973) proposed this stopping rule and proved that as 1! 0 (so

that n ! 1), the coverage probability converges to 1 .A Itemative stopping rules have been proposed by Stroup and Braun (1982) and W ei (1985) when the responses are norm al. R uppert et al. (1984) proposed a stopping rule for M onte C arb optim ization which is so designed that M (x_n) is within a speci ed percentage of M ().

K iefer and W olfow itz (1952) considered a related problem of locating the point where the regression function is maxim ized or m in in ized instead of nding the root of a regression equation as in RM. This amounts to solving M⁰() = 0. The resulting procedure is similar to that of RM, but y_n in (5.1) is replaced by an estimate of M⁰(). We omit the details.

O ne of the major applications of the RM stochastic approximation procedure is the estimation of the percentiles of the quantal response curve. We shall speci cally discuss this problem in the next section.

5.2 QuantalResponse Curves

Consider now the special case when y is a binary variable with

The independent variable x is the dose level, while the binary response y is a quantal variable. Such a model is called a \dose-response" model. The param eter is the 50% response dose, or ED 50. It is easy to recognize this as a logistic model with location parameter and scale parameter and as a simple reparameterization of the model given in (4.1). Also, here (x) is the same as M (x). Equating (x) to leads to the solution = $+ \frac{1}{\log(\frac{1}{1})}$.

Hence, e cient estimation of depends on e cient estimation of and .

The direct RM procedure will continue to generate the x-sequence with an arbitrary initial value x_1 , and then de ne $x_{n+1} = x_n$ a_n (y_n), where one m ay take a_n as proportional to n¹. How ever, as recognized by m any, including RM, for speci c distributions there m ay be a m ore c cient way of generating the x values. Indeed, simulations by W u (1985), and subsequently by Frees and Ruppert (1990), demonstrate the poor perform ance of the RM procedure for sm all n in this example.

W u's procedure begins with generating som e initial values $x_1; :::; x_m$. Then one obtains the M LE's $_m$ and $_m$ of and , respectively, based on f(x_i; y_i); i = 1; :::; mg by solving the likelihood equations (i) $_{i=1}^m y_i = _{i=1}^m (x_i)$ and (ii) $_{i=1}^m x_i y_i =$

^P $_{i=1}^{m} x_i$ (x_i). Let $x_{m+1} = \hat{}_m + \hat{}_m^{-1} \log(\frac{}{1})$. Update the M LE's of and by $\hat{}_{m+1}$ and $\hat{}_{m+1}$, respectively, based on f($x_i; y_i$); i = 1; :::; m + 1g. N ow let $x_{m+2} = \hat{}_{m+1} + \hat{}_{m+1}^{-1} \log(\frac{}{1})$, and continue in this manner. The f x_n g generated in this way meet the consistency and asymptotic optimality properties mentioned in the previous section. W u (1985) also suggested modi cation of the likelihood equations (i) and (ii) by multiplying both sides of the ith component by a factor w ($\dot{y}_i \quad x_m$), where w is a certain weight function. This can partially overcom e vulnerability of the logits at extrem e tails.

A sm entioned earlier, the case = 1=2 is of special interest since then = = ED 50. In this case, an alternative procedure known as the \up-and-down" procedure for generating the design points was proposed by D ixon and M ood (1948). Speci cally, let

where is som ew hat arbitrary. Once again, perform ance of this procedure depends very much on the choice of a good guess for x_1 and . Unless is made adaptive, the large sample perform ance of x_n cannot be studied. W etherill (1963) discusses som e modi cations of this method.

One in portant issue that has not been discussed so far is the choice of the stopping rule. This requires explicit consideration of payo between the cost of further observation and that of less accurate estimation. The study was initiated by Marks (1962) who considered the problem as one of Bayesian sequential design with known and a two-point prior for . Later, Freem an (1970) considered the problem, once again for known , but with a conjugate prior for . In addition, he considered special cases of one, two or three dose levels. For one dose level, he introduced the prior

This amounts to a Beta $(r_0;n_0 r_0)$ prior for the response probability at dose level , with prior parameters $0 < r_0 < n_0$.

W ith squared error loss plus cost and a uniform prior, that is, $r_0 = 1$ and $n_0 = 2$, Freem an (1970) considered the usual backward induction argument to set up the necessary equations for noting the Bayes stopping rule. The stopping rule cannot be found analytically, but Freem an provided the numerical algorithm for noting the solution. He also but did not provide a general algorithm. Thus, what is needed here is an approxim ation of the \optim al" stopping rule. A Bayesian approach using dynamic program ming is hard to implement in its full generality. It appears that a suitable approximation of the Bayes stopping rule which retains at least the asymptotic optimality of the regular Bayes stopping rule is the right approach toward solving this problem .

5.3 Multistage Designs

In most practical situations, it is more realistic to adopt a multistage design rather than a sequential design, since continuous updating of the inferential procedure with each new observation m ay not be very feasible. We discuss one such application as considered in Storer (1989) in the context of Phase I clinical trials. These trials are intended to estim ate the maximum tolerable dose (MTD) of a new drug. Although a strict quantitative de nition of MTD does not exist in clinical trials, very often the 33rd percentile of the tolerance distribution is taken to de neMTD.

From a clinician's perspective, an optim al design is one in which the MTD is de ned by the dose at which the trial stops. Storer (1989, 1990) argues that the design problem should be viewed instead as an e cient way of generating sam ples, wherein the design and analysis are robust to the vagaries of patient treatment in a clinical setting. He rst introduces four single-stage designs, and then proposes two two-stage designs by combining some of these single-stage designs. The details are available in the two cited papers. Storer in plem ented his proposal for M T D estimation in a dose-response setting with three logistic curves.

6. BAYESIAN DESIGNS

Application of Bayesian design theory to generalized linear models is a promising route to avoid the design dependence problem . O ne approach, as discussed in Section 3, is to design an experim ent for a xed best guess of the param eters leading to a \locally optim al" (Chemo, 1953) design. Locally optimaldesigns for nonlinearm odels were rst suggested in the sem inal paper by Box and Lucas (1959). As suggested in Box and Lucas (1959), another natural approach to solve this problem is to express the uncertainty in the parameters through a prior distribution on the parameters. The Bayesian design

considered situations with two or three possible doses, problem for norm all linearm odels has been discussed in Owen (1970), Brooks (1972, 1974, 1976, 1977), Chaloner (1984), Pilz (1991) and DasG upta (1996). Chaloner and Verdinelli (1995) present an excellent overview of Bayesian design ideas and their applications. Atkinson and Haines (1996) discuss local and Bayesian designs speci cally for nonlinear and generalized linear models.

6.1 Bayesian Design Criteria

The Bayesian design criteria are often integrated versions of classical design optim ality criteria where the integration is carried out with respect to the prior distribution on [is as in (22)]. Most of the Bayesian criterion functions are based on norm alapproxim ations to the posterior distribution of the vector of parameters , as computations involving the exact posterior distribution are often intractable. Several such approximations to the posterior are available (Berger, 1985) and involve either the observed or the expected Fisher inform ation matrix. The most common form of such norm al approxim ation states that under standard reqularity conditions, the posterior distribution of is N (^b; [nI(^b;)]¹), where ^b is the maximum likelihood estimate (MLE) of , and for any given design measure , the expected F isher information matrix is denoted by I(;).We shall assume, as usual, that the design m easure puts relative w eights $(p_1; p_2; \ldots; p_n)$ p_k) at k distinct points $(x_1; \dots; x_k)$, respectively, $\sum_{i=1}^{k} p_i = 1$. The prior distribution for with is used as the predictive distribution of ^b and consequently the Bayesian optimality criteria can be viewed as approximations to the expected posterior utility functions under the prior distribution p(). The rst criterion which is an analogue to the Doptim ality criterion in classical optim ality theory is given by

Maxim izing this function is equivalent to approximately maximizing the expected increase in the Shannon information or maxim izing the expected Kullback {Leibler distance between the posterior and prior distributions (Lindley, 1956; DeG root, 1986; Bemardo, 1979).

The next criterion is of interest when the only quantity to be estimated is a function of , say h(). In such situations, the approxim ate asymptotic variance of the M LE of h () is

Since the interpretation of the Bayesian alphabetic optim ality criteria, as approxim ations to expected utility, is based on norm alapproxim ations to the posterior, C lyde and C haloner (1996, 2002) suggest several approaches to verify norm ality through in posing constraints and discuss how to attain such multiple design objectives in this context. O ther design criteria which can be related to a Bayesian perspective appear in T sutakawa (1972, 1980), Zacks (1977) and Pronzato and Walter (1987). How well the Bayesian criteria actually approximate the expected utility in small samples is not very well known.Som e illustrations are presented in Atkinson et al. (1993), C lyde (1993a) and Sun, T sutakawa and Lu (1996). Dawid and Sebastiani (1999) attempt to connect this type of criterion-based Bayesian design to a purely decision-theoretic utility-based approach to Bayesian experim ental design.

M uller and Parm igiani (1995) and M uller (1999) suggest estimating the exact posterior utility through M arkov chain M onte Carlo (M CM C) methods instead of using analytical approximations to the posterior distribution. They embed the integration and maximization of the posterior utility function by curve thing of M onte Carlo samples. This is done by simulating draws from the joint parameter/sample space and evaluating the observed utilities and then

tting a sm ooth surface through the sim ulated points. The tted surface acts as an estimate to the expected utility surface and the optimal design can then be found determ inistically by studying the extrem a of this surface. Parm igiani and M uller (1995), C lyde, M uller and Parm igiani (1995) and Palm er and M uller (1998) contain applications of these sim ulation-based stochastic optim ization techniques.

6.2 Bayesian Optim ality and Equivalence Theorem s

All of the Bayesian criteria m entioned above are concave over the space of all probability m easures on the design space X. The equivalence theorem for establishing optimality of a design for linear m odels (W hittle, 1973) has been extended to the nonlinear case by W hite (1973, 1975), Silvey (1980), Ford, Torsney and W u (1992), C haloner and Lamtz (1989) and C haloner (1993).

It also states that if is di erentiable, then at the support points of the optim aldesign, the directional derivative function d(;x) should vanish. The usual approach to evaluate Bayesian optim al designs for G LM s is through nding a candidate design by numerical optim ization of the criterion function. Verication of global optim ality is then done by studying the directional derivative function d(;x) for the candidate design under consideration.

Example. Chaloner and Lamtz (1989) and Zhu and W ong (2001) consider the problem of estimating quantiles in a dose-response experiment, relating the dose level of a drug x to the probability of a response at level x, namely, (x). A popular model is the simple logistic model as described in (5.6), namely,

For the Bayesian D - and A - optim ality criteria, as mentioned in (6.1) and (6.3), the directional derivative function, respectively, turns out to be

Chaloner (1987) and Chaloner and Lamtz (1988, 1989) developed the use of such Bayesian design criteria. The general equivalence theorem for these criteria can be derived under suitable regularity conditions (Chaloner and Lamtz, 1989; Chaloner, 1993; see also Lauter, 1974, 1976; Dubov, 1977). The directional derivative d(;x) is evaluated over the range of possible values of x to check the global optim ality of a candidate design.

6.3 Binary Response M odels

The Bayesian design literature outside the norm al linear m odel is vastly restricted to binary response m odels. T sutakawa (1972, 1980), O wen (1975) and Zacks (1977) allhave considered optim aldesign problems for binary response m odels from a Bayesian perspective. M any of these designs are restricted to equally spaced points with equal weights at each point. Chaloner and Lamtz (1989) investigate the Bayesian D -optim ality and A -optim ality criteria w ith several choices of B () in the context of a binary response logistic regression m odel w ith a single design variable x. A s illustrated in the above exam ple, Chaloner and Lamtz (1989) consider the problem of nding ED 50 and ED 95, and of estim ating the value of x at which the success probability equals

with having a uniform distribution on [0;1]. The last problem is de ned as average percentile response point estimation. The optimal designs are obtained through implementing the simplex algorithm of Nelder and Mead (1965). They assume independent uniform priors on the parameters and evaluate the expectation over the prior distribution through numerical integration routines. They notice that the number of support points of the optimal design grows as the support of the prior becomes wider and the designs in general are not equispaced and not supported with equal weights. Sm ith and R idout (1998) extend the computational algorithm

of Chaloner and Lamtz (1988) to nd locally and Bayesian optim al designs for binary response models with a wide range of link functions and uniform, beta or bivariate norm al prior distributions on the param eters.

in the context of dose-response bioassays. Markus et al. (1995) consider a Bayesian approach to nd a design which m in im izes the expected m ean-squared pint prior distribution on the parameters of the re- the simulation-based curve tting ideas of Muller sponse distribution. Sun, T sutakawa and Lu (1996)

reiterate that approximation of the expected utility function, using the usual Bayesian design criteria, can be poor, and they introduce a penalized risk criterion for Bayes optim al design. They illustrate that the chance of having an extrem e poste-There is wide interest in the binary response model rior variance could be avoided by sacri cing a small am ount of posterior risk by adding the penalty term . Kuo, Soyer and Wang (1999) use a nonparametric Bayesian approach assum ing a Dirichlet process error of an estimate of ED 50 with respect to the prior on the quantal response curve. They adopt and Parm igiani (1995) to reduce com putational tim e

appreciably. C lyde, M uller and Parm igiani (1995) and F lournoy (1993) also use the logistic regression m odel and present B ayesian design and analysis strategies for two very interesting applications.

Zhu, Ahn and W ong (1998) and Zhu and W ong (2001) consider the optim aldesign problem for estim ating several percentiles for the logistic m odelw ith dierent weights on each of them (the weights depending on the degree of interest the experim enter has in estimating each percentile). They use a multiple objective criterion which is a convex combination of individual objective criteria. They modify the logit-design software of Chaloner and Lamtz (1989) to optim ize this compound criterion. Zhu and W ong (2001) com pare the Bayes optim al designs with sequential designs proposed by Rosenberger and Grill (1997) for estimating the quartiles of a dose-response curve. Zhu and W ong (2001) note that the sequential design, based on a generalized Polya um model, is com parable to the Bayes optim aldesign.W hen com pared to the locally compound optim al designs in Zhu and W ong (2001), it was noted, as anticipated, that the Bayesian design performs better than the locally optim al design, if the speci ed param eters are far from the true parameters. Berry and Fristedt (1985), Berry and Pearson (1985), Parmigiani (1993) and Parmigiani and Berry (1994) examine several clinical design problem susing Bayesian ideas not limited to just dose-response studies.

Example 1. Using the program by Smith and Ridout (1998), we evaluated the Bayesian optimal designs for several choices of prior and criterion functions in the context of the dose-response m odel mentioned in (6.4). We assumed that there is some prior know ledge on the range of and the sign of , which is often realistic. We arbitrarily chose the best guess of to be 0 and of to be 3 and assumed uniform priors of di erent spreads around these centers. Table 1 contains optim al designs for several choices of priors when one uses the Bayesian D-optim ality criterion as given in (6.5). Table 2 contains the optim aldesigns when one uses the Bayesian c-optim ality criterion form in in izing the variance of the estim ate of the 95th percentile of the logistic response curve. The explicit formula for this variance is given in (6.6) with $= \log(0.95 = (1 \ 0.95)) = 2.944$ for estim ating ED 95.

The program optim izes the design criterion under consideration for a xed value of n, the number of doses. The user has to vary n m anually. Then one

chooses the design which optim izes the criterion under consideration for the sm allest num ber of doses. The global optim ality of the design is then checked by evaluating the directional derivative d(;x) over allpossible values of x. The results are fairly clear, as noted in Chaloner and Lamtz (1989); as we increase the spread of the prior distribution, the number of support points of the optim aldesign increases.W ith decreasing variability in the prior distribution, the designs become closer to the locally optim al design for = 0 and = 3.W hile for the D -optim ality criterion the optim aldesigns in Table 1 are symmetric about 0, for the c-optim ality criterion for estim ating ED 95, the designs in Table 2 are asymmetric, tending to put more weight toward larger doses. One also notes that the designs for a given prior on are robust with respect to the choice of prior on , but the converse is not true. The optim aldesigns change quite appreciably as the uncertainty in the prior inform ation on changes. W e also experim ented with independent norm alpriors and essentially noted the same basic patterns. The results are not included here.

6.4 Exact Results

Chaloner (1993) characterizes the 1-optim aldesigns for priors with two support points for logistic regression models with a known slope. She also provides su cient conditions for a one-point design to be optimal under both local optimality and a Bayesian criterion with a nondegenerate prior distribution for a general nonlinear model. As anticipated, the conditions basically reduce to the support of the prior being su ciently sm all. Dette and Neugebauer (1996) provide a su cient condition for the existence of a Bayesian optim alone-point design for one-param eter nonlinear models in term s of the shape of the prior density. Haines (1995) presents an elegant geom etric explanation of these results for priors with two support points. Dette and Sperlich (1994) and Mukhopadhyay and Haines (1995) consider exponential grow th m odels with one parameter and derive analytical expressions for the weights and design points for the optim al Bayesian design. For m ore than one param eter and a dispersed prior distribution, analytical results are extremely hard to obtain and num erical optim izations are so far the only route.

Sebastiani and Settim i (1997) use the equivalence theorem to establish the localD -optim ality of a twopoint design suggested by Ford, Torsney and W u (1992) for a simple logistic model with design region bounded at one end. They also suggest an e cient approximation to the D -optim aldesigns which requires less precise know ledge of the model param eters.

M atthews (1999) considered Bayesian designs for the logistic m odel with one qualitative factor at 1 and derived closed-form expressions for the weights and support points which m inim ize the asym ptotic variance of the M LE of the log-odds ratio. He also studied the e ect of prior speci cation on the design and noticed that as uncertainty on the log-odds ratio increases, the design becom es m ore unbalanced.

6.5 M ore Than One Explanatory Variable

Atkinson et al. (1995) consider a dose response experim ent when the m ale and fem ale insects under study react di erently and considered the m odel

where (x;z) is the probability of death of the insect at dose level x and z is 0 form ales and 1 for fem ales. A ssum ing the proportion of males and fem ales to be equal, they illustrate that the larger the separation between the two groups, the larger is the cardinality of the support for the locally D -optim al design. They also consider a Bayesian version of this design problem by in posing a trivariate norm al distribution on the three parameters and notice that the design is robust with respect to uncertainty in the parameters for this problem. The paper also considers designs for estimating ED 95 for the two groups separately as well as the two groups combined together.

Sitter and Torsney (1995) consider locally D -optim al designs when the model contains two quantitative variables. Burridge and Sebastiani (1992) consider a generalized linear model with two design variables and a linear predictor of the form $= x_1 + x_2$ and obtain locally D-optim aldesigns. Burridge and Sebastiani (1994) obtain D-optimal designs for a generalized linear model when observations have variance proportional to the square of the mean. They do allow for any number of possible predictors. How ever, their results are restricted to the case of power link functions. They establish that under certain conditions on the param eters of a m odel, the traditional change \one factor at a time" designs are D -optim al. They also conduct a num erical study to compare the e ciency of classical factorial designs to the optim alones and suggest som e

e cient com prom ise designs. Sebastiani and Settim i (1998) obtain D -optim aldesigns for a variety of nonlinearm odels with an arbitrary num ber of covariates under certain conditions on the F isher inform ation m atrix.

In a more recent article by Smith and Ridout (2003), optim al Bayesian designs are obtained for bioassays involving two parallel dose response relationships where the main interest is in estimating the relative potency of a test drug or test substance. They consider a model for the probability of a response as

where z is 0 or 1 representing the two substances (called the standard and test substance, resp.) and F¹ is a link function. The parameter is the relative log potency of the test substance compared to the standard substance. Sm ith and R idout consider local and B ayesian D -optim al designs as well as the D_s-optim al design which is appropriate when interest is mainly in a subset of parameters (here

and), the others (here) being considered as nuisance parameters. The designs are obtained num erically and optimality is veried by using the corresponding directional derivative function. Thism odel contains one quantitative and one qualitative predictor with no interaction, and as discussed in Chapter 13 of Atkinson and Donev (1992), the local D – optimal designs for the two substances (z = 0 and z = 1) are identical. The number of support points for each substance is also the same as for the corresponding local D-optimal design with a single-substance experiment.

To illustrate the proposed designs, Sm ith and Ridout (2003) use a data set from A shton (1972, page 59) which provides the number of Chrysanthem um aphids killed out of the number tested at di erent doses of two substances. One can model the response probability [as given in (6.7)] as a function of $x = \log (\text{dose})$ and z = factor representing thetwo substances. Sm ith and Ridout (2003) investigate the problem of noing optim al designs under various link functions, optim ality criteria and prior choices. Since there are still very few illustrations of B ayesian optim al design in the multiparam eter situation, this num erical example is interesting in its own right.

Sm ith and R idout (2005) apply their work on multiparameter dose-response problems to obtain B ayesian optim aldesign in a three-parameter binary dose response m odel with controlm ortality as a param eter. In m any bioassays where the response is often death, death m ay som etim es occur due to natural causes of m ortality unrelated to the stim ulus. In such instances, the occurrence of response is due to natural m ortality or control m ortality. The m odel, including controlm ortality in a dose response setup, as considered in Sm ith and R idout (2005), is

The control mortality parameter is treated as a nuisance parameter and a wide range of prior distributions and criteria is investigated.

A general treatm ent of Bayesian optim al designs with any number of explanatory variables seems to be in order. The computations get much more involved with an increase in the number of parameters as integration and optimization need to be carried out in a higher-dimensional space. The simulationbased methods proposed in Muller (1999) may be of particular importance in these high-dimensional problems.

6.6 M iscellaneous Issues In Bayesian Design

Multiresponse models. D raper and H unter (1967) considerm ultiresponse experim ents in nonlinear problem s and adopt locally optim alor sequential design as their design strategy. Very little work has been done for multiresponse experiments for GLM susing Bayesian design ideas. Hatzis and Lamtz (1992) consider a nonlinear multiresponse model with the probability distribution for the responses given by a Poisson random process. They consider locally D -optim al designs which m in im ize the generalized variance (volum e of the con dence ellipsoid) of the estim ated param eters for given speci c values of the param eters. They also discuss the case when only a subset of the parameters is of interest, leading to the local D_s-optim ality criterion. They use a generalized simulated annealing algorithm along with the Nelder and Mead (1965) sim plex algorithm .0 btaining Bayesian optim aldesigns for nonlinear multiresponse models will certainly pose som e computational challenges as num erical integration needs to be carried out in a higher-dimensional space. Heise and M yers (1996) provides m ethods for producing D-optim al designs for bivariate logistic regression models.Zocchiand Atkinson (1999) uses D -optimal design theory to obtain designs for multinom ial logistic regression m odels.

Sequential Bayesian designs. Ridout (1995) considers a lim iting dilution m odel for a binary response in a seed testing experiment. Suppose that n sam ples of seed are tested; the ith sample (i = 1; ...; n)contains x_i seeds and yields a binary response variable y_i , where $y_i = 0$ if the sample is free of infection and $y_i = 1$ otherwise. Let i = P (ith sample is free of infection) and = the proportion of infected seeds in the population. Then the lim iting dilution model is y_i Bernoulli($_i$) with $_i = 1$)^{X1}, (1 i= 1; ...; n. The author reparam etrizes the problem in terms of $= \log f \log (1)$)g and the design criterion is based on expectations of functions of the Fisher information for with respect to some uniform prior. Single-stage and three-stage designs are developed and compared when the sample sizes are restricted to sm all num bers. The three-stage designs are found to be much more e cient than single-stage designs. This is an interesting example of multistage sequential Bayesian design for one-parameter nonlinear problem swhere the sample size is constrained to be sm all.M ehrabiand M atthews (1998) also consider the problem of implementing Bayesian optim al designs for lim iting dilution assay m odels. Zacks (1977) proposes two-stage Bayesian designs for a sim ilarproblem .Freem an (1970), Owen (1975), Kuo (1983) and Berry and Fristedt (1985) have also done work in the sequential dom ain.

Number of support points. In classical design theory, an upperbound on the num berof support points for an optim aldesign is usually obtained by invoking Caratheodory's theorem, as the inform ation matrix depends on a nite number of moments of the design m easure .For D -optim ality, the optim aldesign typically has as many support points as the num ber of unknown param eters in the modelw ith equal weights at each point (Silvey, 1980; Pukelsheim, 1993). This property helps to obtain the optim al design analytically but has the draw back that there is not a su cient number of support points to allow for any goodness of t checking. This type of upper bound result applies to local optim ality criteria and Bayesian optim ality criteria for linear models. For nonlinear models with a continuous prior distribution there is no such bound available. The space of possible Fisher information matrices is now innite dim ensional and Caratheodory's theorem cannot be invoked. For most concave optim ality criteria, if the prior distribution has k support points, then there exists a Bayesian optim aldesign which

is supported on at most $k^{p(p+1)=2}$ di erent points (D ette and N eugebauer, 1996), where p is the num – ber of param eters, but no such bounds are available for a continuous prior distribution. Chaloner and Lamtz (1989) rst illustrated how the number of support points of the optim al design changes as the prior becom es more dispersed. This is an advantage of the B ayesian design as it allows for possible model checking with the observed data. How to incorporate model uncertainty in the paradigm remains an important unresolved issue (Steinberg, 1985; D uM ouchel and Jones, 1994).

Sensitivity to prior speci cation. R obustness of the design to the prior distribution is a desirable property. DasG upta and Studden (1991), DasG upta, M ukhopadhyay and Studden (1992) and Tom an and G astwirth (1993, 1994) developed a fram ework for robust experim ental design in a linear m odel setup. E orts to propose robust B ayesian experim ental designs for nonlinear m odels and generalized linear m odels are needed.

Prior for inference. T sutakawa (1972) argues that when Bayesian inference is considered appropriate, it may be desirable to use two separate priors, one for constructing designs and the other for subsequent inference. Many practitioners believe in incorporating prior information for constructing designs, but carry out the analysis through maxim um likelihood or other frequentist procedures. U sing a design prior with small variability and an inference prior with an in ated variance, as recommended in T sutkawaka (1972), raises philosophical issues for discussion. Etzioni and K adane (1993) and Lindley and Singpurwalla (1991) address this dichotom y of using informative priors for design and noninform ative priors for the subsequent statistical analysis.

Statistical software. Finding optim alB ayesian designs for multiparam eter nonlinear problem s with a di use prior distribution is analytically very di cult and can only be obtained num erically. C haloner and Lamtz (1988) made the rst e ort in this direction. They introduced FORTRAN 77 program s for obtaining Bayesian optim al designs for logistic regression with a single explanatory variable. Sm ith and R idout (1998) introduced an enhanced version of their program called DESIGNV1, which provides a wider range of link functions (not only logistic) as considered in Ford, Torsney and W u (1992) along with a greater ensemble of prior distributions and optim ality criteria. The program SINGLE by Spears, Brown and Atkinson (1997), available in StatLib, also o ers the logistic and log(log link functions with various choices of priors and an autom ated procedure to determ ine the number of support points. Sm ith and R idout (2003) extended their software to DESIGNV2 to accommodate two explanatory variables, one quantitative, the other dichotom ous. All these programs use the Nelder(M ead (1965) optimization algorithm. The expectation over a prior distribution is computed by som e num erical quadrature form ulae (usually G auss(Legendre or G auss(H erm ite quadrature).

A exible design software developed by C lyde (1993b) isbuilt within X LISP-STAT (Tierney, 1990). This allows evaluation of exact and approximate B ayesian optim al designs for linear and nonlinear models. Locally optim al designs and non-B ayesian optim al designs for linear models can also be obtained as special cases of B ayesian designs. This requires the NPSOL FORTRAN library of G ill et al. (1986) to be installed in the system . The simulation-based ideas for obtaining optim al designs (M uller, 1999) can also be implemented through X LISP-STAT.

The use of B ayesian design depends greatly on updating and maintaining the existing program s and making them known to practitioners, in addition to including sim ilar software in other standard statistical software packages.

7. DESIGN COMPARISONS USING QUANTILE DISPERSION GRAPHS

A fourth approach to the design dependence problem was recently introduced by Robinson and Khuri (2003). Their approach is based on studying the distribution of the mean-squared error of prediction (M SEP) in (3.7) throughout the experim ental region R. For a given design D, let Q_D (p; ;) denote the pth quantile of the distribution of M SEP on R, where R represents the surface of a region obtained by shrinking the experim ental region R using a shrinkage factor , and is the parameter vector in the linear predictor in (2.2). By varying we can cover the entire region R . In order to assess the problem of unknown , a parameter space C to which is assumed to belong is specied. Subsequently, the m in im um and m axim um of Q_D (p; ;) over C are obtained. W e therefore get the extrem a

P lotting $Q_D^{max}(p;)$ and $Q_D^{min}(p;)$ against p results in the so-called quantile dispersion graphs (QDGs) of the MSEP. A desirable feature of a design D is to have close and small values of Q_D^{max} and Q_D^{min} over the range of p (0 p 1). Small values of Q_D^{max} indicate small MSEP values on R , and the closeness of Q_D^{max} and Q_D^{min} indicates robustness to changes in the values of that is induced by the design D. The QDGs provide a comprehensive assessment of the prediction capability of D and can therefore be conveniently utilized to compare two candidate designs by comparing their graphical proles.

The QDG approach has several advantages:

- The design's performance can be evaluated throughout the experimental region. Standard design optimality criteria base their evaluation of a design on a single measure, such as D – e ciency, but do not consider the quality of prediction inside R.
- (2) Estimation bias is taken into consideration in the comparison of designs.
- (3) The QDG s provide a clear depiction of the dependence of a design on the unknown parameter vector . D esigns can therefore be easily com pared with regard to robustness.
- (4) The use of the quantile plots of the M SEP perm its the comparison of designs for GLM s with several control variables.

7.1 Logistic Regression M odels

Robinson and Khuri (2003) applied the QDG approach to comparing designs for logistic regression models of the form

where W is the same as in (3.4) with $w_u = m_u_u$ (1 u), u = 1;2;...;n, and is an n 1 vector whose uth element is z_{uu} ($_u$ 0.5), where z_{uu} is the uth diagonal element of $Z = X (X^T W X)^1 X^T$. Here, m_u denotes the number of experimental units tested at the uth experimental run, and $_u$ is the value of

(x) at x_u , the vector of design settings at the uth experimental run (u = 1;2;...;n).

R obinson and K huriconsidered quantiles of a scaled version of M SE [b(x)], nam ely,

(7.3) SM SE
$$[b(x)] = \frac{N}{(x)[1 (x)]}$$
 M SE $[b(x)];$

where N = $P_{u=1}^{p} m_{u}$. Form ula (7.1) can then be applied with Q_{D} (p; ;) now denoting the pth quantile of SM SE [b(x)] on the surface of R . Two num erical examples were presented in Robinson and K huri (2003) to illustrate the application of the QDG approach to comparing designs for logistic regression m odels. The following example provides another illustration of this approach in the case of logistic regression.

Example 2. Sitter (1992) proposed a m inim ax procedure to obtain designs for the logistic regression m odel (7.2), where

$$f^{\perp}(x) = (x)$$

Thism odel is the same as the one given in (5.6). The designs proposed by Sitter are intended to be robust to poor initial estimates of and . The numericalexample used by Sitter concerns sport shing in British Columbia, Canada, where x is the amount of increased shing cost. The binary response designates shing or not shing for a given x. Thus (x) is the probability of wanting to sh for a given increase in shing cost.

U sing the D -optim ality criterion, Sitter com pared a locally D -optim al design against his minim ax D -optim al design. The rst design was based on the initial estimates $_0 = 40$, $_0 = 0.90$ for and , and consisted of two points, namely, x = 38.28;41:72, with equal allocation to the points. For the second design, Sitter assumed the parameter space C :33

47, 0:50 1:25. A coordingly, the m inim ax D -optim aldesign produced by Sitter entailed equal allocation to the points, x = 31:72;34:48;37:24;40:00; 42:76;45:52;48:28. This design was to be robust over C.

The QDG approach was used to compare Sitter's two designs. The same parameter space, C, was considered. The experimental region investigated was R:30 x 50, and the two designs consisted of 70 runs each with equal weights at the design points.




Fig. 1. Combined QDGs for the minim ax D -optim al and D -optim al designs.

The scaled mean-squared error of prediction (SM SEP) is given in (7.3). For selected values of (;) in C, values of SM SEP are calculated throughout the region R for each design. The maximum and minimum quantiles (over C) of the distribution of SM SEP on R are then obtained as in (7.1). Since in this example there is only one control variable, no shrinkage of the region R is necessary. The com bined QDGs for the two designs are shown in Figure 1. We note that the dispersion in the quantile values for the m inim ax D -optim al design is less than that for the locally D -optim aldesign. This indicates m ore robustness of the form er design to changes in the parameter values. This is consistent with the conclusion arrived at by Sitter that \form ost of the region, them in im ax D -optim aldesign perform sbetter than the locally D -optim al design."

8. CONCLUSION

The research on designs for generalized linearm odels is still very much in its developmental stage. Not much work has been accomplished either in terms of theory or in terms of computational methods to evaluate the optim al design when the dimension of the design space is high. The situations where one has several covariates (control variables) or multiple responses corresponding to each subject dem and extensive work to evaluate \optim al" or at least e cient designs. The curve tting approach of M uller and P am igiani (1995) m ay be one direction to pursue in higher-dim ensional design problem s. Finding robust and e cient designs in highdim ensional problem s w ill involve form idable com putational challenges and e cient search algorithm s need to be developed.

The stochastic approximation literature, as discussed in Section 5, dwells primarily on the developm ent of algorithm s for the selection of design points. Sim ilar ideas can be brought into case-control studies where the prime objective is to study the association between a disease (say, lung cancer) and som e exposure variables (such as sm oking, residence near a hazardous waste site, etc.). C lassical case-control studies are carried out by sam pling separately from the case (persons a ected with the disease) and control (persons w ithout the disease) populations, w ith the two sample sizes being xed and often arbitrary. Chen (2000) proposed a sequential sam pling procedure which rem oves this arbitrariness. Speci cally, he proposed a sampling rule based on all the accum ulated data, which m andates whether the next observation (if any) should be drawn from a case or a control population. He showed also certain optimality of his proposed sam pling rule.

However, like much of the stochastic approxim ation literature, Chen touched very brie y on the choice of a stopping rule, but without any optim ality properties associated with it. It appears that a Bayes stopping rule or som e approxim ation thereof

can be introduced along with Chen's sampling rule Atkinson, A.C. and Donev, A.N. (1992). Optimum Exso that the issues of optim al stopping and choice of designs can be addressed simultaneously.

The use of the quantile dispersion graphs (of the mean-squared error of prediction) provides a convenient technique for evaluating and com paring designs for generalized linearm odels. The main advantages of these graphs are their applicability in experim ental situations involving several control variables, their usefulness in assessing the quality of prediction associated with a given design throughout the experim ental region, and their depiction of the design's dependence on the parameters of the tted model. There are still several other issues that need to be resolved. For example, the e ects of m isspeci cation of the link function and/or the parent distribution of the data on the shape of the quantile plots of the quantile dispersion graph approach need to be investigated. In addition, it would be of interest to explore the design dependence problem in multiresponse situations involving several response variables that m ay be correlated. The multiresponse design problem in a traditional linear model setup was discussed by W ijesinha and Khuri (1987a, b).
