# LaRge And moderate deviations PRinciples for KERNEL ESTIMATORS OF THE MULTIVARIATE REGRESSION

#### Abstract

In this paper, we prove large deviations principle for the Nadaraya-Watson estimator and for the semi-recursive kernel estimator of the regression in the multidimensional case. Under suitable conditions, we show that the rate function is a good rate function. We thus generalize the results already obtained in the unidimensional case for the Nadaraya-Watson estimator. Moreover, we give a moderate deviations principle for these two estimators. It turns out that the rate function obtained in the moderate deviations principle for the semi-recursive estimator is larger than the one obtained for the Nadaraya-Watson estimator.

## 1 Introduction

Let $(X, Y),\left(X_{1}, Y_{1}\right), \ldots,\left(X_{n}, Y_{n}\right)$ be a sequence of independent and identically distributed $\mathbb{R}^{d} \times \mathbb{R}^{q_{-}}$ valued random variables with probability density $f(x, y)$ with $\mathbb{E}|Y|<\infty$. Moreover, let $g(x)$ be the marginal density of $X$ and $r(x)=\mathbb{E}(Y \mid X=x)=m(x) / g(x)$ the regression of $Y$ on $X$. The purpose of this paper is to establish large and moderate deviations principles for the NadarayaWatson estimator and for the semi-recursive kernel estimator of the regression.

Let us first recall the concept of large and moderate deviations. A speed is a sequence $\left(\nu_{n}\right)$ of positive numbers going to infinity. A good rate function on $\mathbb{R}^{m}$ is a lower semicontinuous function $I: \mathbb{R}^{m} \rightarrow[0, \infty]$ such that, for each $\alpha<\infty$, the level set $\left\{x \in \mathbb{R}^{m}, \quad I(x) \leq \alpha\right\}$ is a compact set. If the level sets of $I$ are only closed, then $I$ is said to be a rate function. A sequence $\left(Z_{n}\right)_{n \geq 1}$ of $\mathbb{R}^{m}$-valued random variables is said to satisfy a large deviations principle (LDP) with speed $\left(\nu_{n}\right)$ and rate function $I$ if:

\liminf _{n \rightarrow \infty}^{-1} \log \mathbb{P}\left[Z_{n} \in U\right] & \geq-\inf _{x \in U} I(x) \text { for every open subset } \mathrm{U} \text { of } \mathbb{R}^{m}, \\
\limsup _{n \rightarrow \infty} \nu_{n}^{-1} \log \mathbb{P}\left[Z_{n} \in V\right] & \leq-\inf _{x \in V} I(x) \text { for every closed subset } \mathrm{V} \text { of } \mathbb{R}^{m} .
\end{aligned}
$$

Moreover, let $\left(v_{n}\right)$ be a nonrandom sequence that goes to infinity; if $\left(v_{n} Z_{n}\right)$ satisfies a LDP, then $\left(Z_{n}\right)$ is said to satisfy a moderate deviations principle (MDP).

The Nadaraya-Watson estimator ([15], [20]) of the regression function $r(x)$ is defined by

r_{n}(x)=\left\{\begin{array}{l}
\frac{m_{n}(x)}{g_{n}(x)} \text { if } g_{n}(x) \neq 0  \tag{1}\\
0 \text { otherwise }
\end{array}\right.
$$

with

$$
m_{n}(x)=\frac{1}{n h_{n}^{d}} \sum_{i=1}^{n} Y_{i} K\left(\frac{x-X_{i}}{h_{n}}\right) \text { and } g_{n}(x)=\frac{1}{n h_{n}^{d}} \sum_{i=1}^{n} K\left(\frac{x-X_{i}}{h_{n}}\right),
$$

where the bandwidth $\left(h_{n}\right)$ is a positive sequence such that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} h_{n}=0 \text { and } \lim _{n \rightarrow \infty} n h_{n}^{d}=\infty \tag{2}
\end{equation*}
$$

and the kernel $K$ a continuous function such that $\lim _{\|x\| \rightarrow \infty} K(x)=0$ and $\int_{\mathbb{R}^{d}} K(x) d x=1$. The weak and strong consistency of $r_{n}$ has been widely discussed by many authors; let us cite, among many others, Collomb [4, Collomb and Härdle [5, Devroye [7, Mack and Silverman [12] and Senoussi [19]. For other works on the consistency of $r_{n}$, the reader is refered to the monographs of Bosq [3] and Prakasa Rao [16. The large deviations behaviour of $r_{n}$ has been studied at first by Louani [11, and then by Joutard [10] in the univariate framework. Moderate deviations principles have been obtained by Worms [21] in the particular case $Y=r(X)+\varepsilon$ with $\varepsilon$ and $X$ independent. The first aim of this paper is to generalize these large and moderate deviations results.

The approach used by Louani [11] and Joutard [10] to study the large deviations behaviour of $r_{n}$ is to note that, if $d=q=1$ and if the kernel is positive, then, for all $\delta>0$,

$$
\mathbb{P}\left[r_{n}(x)-r(x) \geq \delta\right]=\mathbb{P}\left[\frac{1}{n h_{n}} \sum_{j=1}^{n}\left[Y_{j}-r(x)-\delta\right] K\left(\frac{x-X_{j}}{h_{n}}\right) \geq 0\right]
$$

Obviously, their approach can not be extended to the multivariate framework. Thus, to study the large deviations behaviour of $r_{n}$, our approach is totally different. We first establish a large deviations principle for the sequence $\left(m_{n}(x), g_{n}(x)\right)$, and then show how the large deviations behaviour of $r_{n}$ can be deduced. More precisely, for $x \in \mathbb{R}^{d}$, let $\Psi_{x}$ be the function defined for any $(u, v) \in \mathbb{R}^{q} \times \mathbb{R}$ by

$$
\Psi_{x}(u, v)=\int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left(e^{(\langle u, y\rangle+v) K(z)}-1\right) f(x, y) d z d y
$$

(where $\langle u, y\rangle$ denotes the scalar product of $u$ and $y$ ) and let $I_{x}$ be the Fenchel-Legendre transform of $\Psi_{x}$. We give conditions ensuring that the sequence $\left(r_{n}(x)\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and good rate function $J$ defined, for any $s \in \mathbb{R}^{q}$, by

$$
J(s)=\inf _{t \in \mathbb{R}} I_{x}(s t, t)
$$

Concerning the moderate deviations behaviour of the Nadaraya-Watson estimator, we prove that, for any positive sequence $\left(v_{n}\right)$ such that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} v_{n}=\infty, \quad \lim _{n \rightarrow \infty} \frac{v_{n}^{2}}{n h_{n}^{d}}=0, \quad \text { and } \quad \lim _{n \rightarrow \infty} v_{n} h_{n}^{p}=0, \tag{3}
\end{equation*}
$$

(where $p$ denotes the order of the kernel $K$ ) the sequence ( $\left.v_{n}\left[r_{n}(x)-r(x)\right]\right)$ satisfies a LDP with speed $\left(n h_{n}^{d} / v_{n}^{2}\right)$ and good rate function $G_{x}$ defined for all $v \in \mathbb{R}^{q}$ by

$$
\begin{equation*}
G_{x}(v)=\frac{g(x)}{2 \int_{\mathbb{R}^{d}} K^{2}(z) d z} v^{T} \Sigma_{x}^{-1} v \tag{4}
\end{equation*}
$$

where $\Sigma_{x}$ denotes the $q \times q$ covariance matrix $V(Y \mid X=x)$. Let us note that, in the case the model $Y=r(X)+\varepsilon$ (with $X$ and $\varepsilon$ independent) is considered, the matrix $\Sigma_{x}$ is the covariance matrix of $\varepsilon$ and does depend on $x$; we then find the MDP proved in Worms [21] again.

A semi-recursive version of the Nadaraya-Watson estimator (1) is defined as

$$
\tilde{r}_{n}(x)=\left\{\begin{array}{l}
\frac{\tilde{m}_{n}(x)}{\tilde{g}_{n}(x)} \text { if } \tilde{g}_{n}(x) \neq 0  \tag{5}\\
0 \text { otherwise }
\end{array}\right.
$$

where

$$
\tilde{m}_{n}(x)=\frac{1}{n} \sum_{i=1}^{n} \frac{Y_{i}}{h_{i}^{d}} K\left(\frac{x-X_{i}}{h_{i}}\right) \text { and } \quad \tilde{g}_{n}(x)=\frac{1}{n} \sum_{i=1}^{n} \frac{1}{h_{i}^{d}} K\left(\frac{x-X_{i}}{h_{i}}\right) .
$$

Weak conditions for various forms of consistency of $\tilde{r}_{n}$ have been obtained by Ahmad and Lin [1] and Devroye and Wagner [8]. Roussas [18] studied its almost sure convergence rate. The second aim of this paper is to establish the large and moderate deviations behaviour of $\tilde{r}_{n}$.

It turns out that the rate function that appears in the LDP is much more complex to explicit in the case the semi-recursive kernel regression estimator is considered than in the case the NadarayaWatson estimator is used. That is the reason why we only consider bandwidths defined as $\left(h_{n}\right)=$ $\left(c n^{-a}\right)$ with $c>0$ and $\left.a \in\right] 0,1 / d\left[\right.$ (instead of bandwidths satisfying (2)). For $x \in \mathbb{R}^{d}$, let $\tilde{\Psi}_{a, x}$ be the function defined for all $(u, v) \in \mathbb{R}^{q} \times \mathbb{R}$ by

$$
\tilde{\Psi}_{a, x}(u, v)=\int_{[0,1] \times \mathbb{R}^{d} \times \mathbb{R}^{q}} s^{-a d}\left(e^{s^{a d}(\langle u, y\rangle+v) K(z)}-1\right) f(x, y) d s d z d y,
$$

and let $\tilde{I}_{a, x}$ be the Fenchel-Legendre transform of $\tilde{\Psi}_{a, x}$. We give conditions ensuring that the sequence $\left(\tilde{r}_{n}(x)\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and good rate function $\tilde{J}_{a}$ defined, for any $s \in \mathbb{R}^{q}$, by

$$
\tilde{J}_{a}(s)=\inf _{t \in \mathbb{R}} \tilde{I}_{a, x}(s t, t)
$$

To establish the moderate deviations behaviour of $\tilde{r}_{n}$, we consider bandwidths $\left(h_{n}\right)$ which vary regularly with exponent $(-a), a \in] 0,1 / d\left[\right.$. We prove that, for any positive sequence $\left(v_{n}\right)$ satisfying (3), the sequence $\left(v_{n}\left[\tilde{r}_{n}(x)-r(x)\right]\right)$ satisfies a LDP with speed $\left(n h_{n}^{d} / v_{n}^{2}\right)$ and good rate function defined for all $v \in \mathbb{R}^{q}$ by

$$
\begin{equation*}
\tilde{G}_{a, x}(v)=\frac{(1+a d) g(x)}{2 \int_{\mathbb{R}^{d}} K^{2}(z) d z} v^{T} \Sigma_{x}^{-1} v . \tag{6}
\end{equation*}
$$

Let us underline that, because of the factor $(1+a d)$ which is present in (6) but not in (4), the rate function obtained in the MDP in the case the semi-recursive estimator is used is larger than the one which appears in the case the Nadaraya-Watson kernel estimator is considered; this means that the semi-recursive estimator $\tilde{r}_{n}(x)$ is more concentrated around $r(x)$ than the Nadaraya-Watson estimator.

Our main results are stated in Section 2, whereas Section 3 is devoted to the proofs.

## 2 Assumptions and Main Results

We shall use the following notations.

- $\mathcal{D}(\mathcal{F})=\{x, \mathcal{F}(x)<\infty\}$ denotes the domain of a function $\mathcal{F}$ and $\stackrel{\circ}{\mathcal{D}}(\mathcal{F})$ is the interior domain of $\mathcal{F}$.
- $\|x\|$ is the euclidean norm of $x$.
- $\lambda$ is the Lebesgue measure.
- $a \wedge b=\min \{a, b\}$.
- $\overrightarrow{0}=(0, \ldots, 0) \in \mathbb{R}^{q}$.

The large and moderate deviations behaviours of the Nadaraya-Watson estimator $r_{n}$ are given in Section 2.1, whereas the ones of the semi-recursive kernel estimator $\tilde{r}_{n}$ are stated in Section 2.2.

### 2.1 Large and moderate deviations principles for the Nadaraya-Watson estimator

The assumptions required for the LDP of the Nadaraya-Watson estimator are the following.
(A1) $K: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is a bounded and integrable function, $\int_{\mathbb{R}^{d}} K(z) d z=1$ and $\lim _{\|z\| \rightarrow \infty} K(z)=0$.
(A2) For any $u \in \mathbb{R}^{q}, t \mapsto \int_{\mathbb{R}^{q}} e^{\langle u, y\rangle} f(t, y) d y$ is continuous at $x$ and bounded.

## Comments

- Notice that (A2) implies that the density $g$ is continuous at $x$ and bounded.
- In the model $Y=r(X)+\varepsilon$ with $\varepsilon$ and $X$ independent, let $h$ be the probability density of $\varepsilon$. Then

$$
\begin{aligned}
f(t, y) & =g(t) h(y-r(t)) \\
\int_{\mathbb{R}^{q}}\|y\| f(t, y) d y & =g(t) \int_{\mathbb{R}^{q}}\|y+r(t)\| h(y) d y \\
\int_{\mathbb{R}^{q}} e^{\langle u, y\rangle} f(t, y) d y & =g(t) e^{\langle u, r(t)\rangle} \int_{\mathbb{R}^{q}} e^{\langle u, y\rangle} h(y) d y .
\end{aligned}
$$

Thus, (A2) can be translated as assumptions on $g$ and $r$ and on the moments of $\varepsilon$.

- As it can be seen from the proofs, the boundness assumption in (A2) is useless if $K$ has a compact support.
- The boundness of the function $t \mapsto \int_{\mathbb{R}^{q}} e^{\langle u, y\rangle} f(t, y) d y$ for any $u \in \mathbb{R}^{q}$ implies that

$$
\begin{equation*}
\forall m \geq 0, \forall \rho \geq 0 \text { the function } t \mapsto \int_{\mathbb{R}^{q}}\|y\|^{m} e^{\rho\|y\|} f(t, y) d y \quad \text { is bounded. } \tag{7}
\end{equation*}
$$

Proof It suffices to prove that the function $t \mapsto \int_{\mathbb{R}^{q}} e^{\rho\|y\|} f(t, y) d y$ is bounded for any $\rho>0$. Set $y=\left(y_{1}, \ldots, y_{q}\right)$, we first note that

$$
\begin{aligned}
\int_{\mathbb{R}^{q}} e^{q \rho\left|y_{j}\right|} f(t, y) d y & \leq \int_{\left\{y_{j} \geq 0\right\}} e^{q \rho y_{j}} f(t, y) d y+\int_{\left\{y_{j}<0\right\}} e^{-q \rho y_{j}} f(t, y) d y \\
& \leq \int_{\mathbb{R}^{q}} e^{q \rho y_{j}} f(t, y) d y+\int_{\mathbb{R}^{q}} e^{-q \rho y_{j}} f(t, y) d y
\end{aligned}
$$

Now, we have

$$
\begin{aligned}
& \int_{\mathbb{R}^{q}} e^{\rho\|y\|} f(t, y) d y \\
& \quad \leq \int_{\mathbb{R}^{q}} e^{\rho\left|y_{1}\right|+\cdots+\rho\left|y_{q}\right|} f(t, y) d y \\
& \leq\left(\int_{\mathbb{R}^{q}} e^{q \rho\left|y_{1}\right|} f(t, y) d y \ldots \int_{\mathbb{R}^{q}} e^{q \rho\left|y_{q}\right|} f(t, y) d y\right)^{\frac{1}{q}} \text { by the generalized Hölder inequality. } \\
& \leq\left(\left(\int_{\mathbb{R}^{q}} e^{q \rho y_{1}} f(t, y) d y+\int_{\mathbb{R}^{q}} e^{-q \rho y_{1}} f(t, y) d y\right) \cdots\left(\int_{\mathbb{R}^{q}} e^{q \rho y_{q}} f(t, y) d y+\int_{\mathbb{R}^{q}} e^{-q \rho y_{q}} f(t, y) d y\right)\right)^{\frac{1}{q}}
\end{aligned}
$$

which is bounded.
Before stating our results, we need to introduce the rate function for the LDP of the NadarayaWatson estimator. Let $\Psi_{x}: \mathbb{R}^{q} \times \mathbb{R} \rightarrow \mathbb{R}$ and $I_{x}, \hat{I}_{x}: \mathbb{R}^{q} \times \mathbb{R} \rightarrow \mathbb{R}$ be the functions defined as follows:

$$
\begin{align*}
\Psi_{x}(u, v) & =\int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left(e^{(\langle u, y\rangle+v) K(z)}-1\right) f(x, y) d z d y,  \tag{8}\\
I_{x}\left(t_{1}, t_{2}\right) & =\sup _{(u, v) \in \mathbb{R}^{q} \times \mathbb{R}}\left\{\left\langle u, t_{1}\right\rangle+v t_{2}-\Psi_{x}(u, v)\right\},  \tag{9}\\
\hat{I}_{x}(s, t) & =I_{x}(s t, t) \tag{10}
\end{align*}
$$

Moreover, for any $s \in \mathbb{R}^{q}$, set

$$
\begin{aligned}
J^{*}(s) & =\inf _{t \in \mathbb{R}^{*}} I_{x}(s t, t) \\
& =\inf _{t \in \mathbb{R}^{*}} \hat{I}_{x}(s, t), \\
J(s) & =J^{*}(s) \wedge I_{x}(\overrightarrow{0}, 0) \\
& =\inf _{t \in \mathbb{R}} \hat{I}_{x}(s, t) .
\end{aligned}
$$

To prove that $J$ is a rate function, we need to assume that the following condition (C) is fulfilled.
$(\mathrm{C}) \inf _{s \in \mathbb{R}^{q}} I_{x}(s, 0)=I_{x}(\overrightarrow{0}, 0)$.
Before stating the properties of the function $J$, let us give some cases when Condition (C) is satisfied (under Assumptions (A1) and (A2)).

## Example 1: Nonnegative kernel

Condition (C) is satisfied when $K$ is nonnegative since, in this case, $I_{x}(s, 0)=+\infty$ for any $s \neq \overrightarrow{0}$, (this is stated in Proposition 3 of Section 3).

## Example 2: Model with symmetry

Condition (C) holds when $f$ is symmetric in each coordinate of the second variable $y \in \mathbb{R}^{q}$. As a matter of fact, for a diagonal $q \times q$ matrix $A$ such that $A_{i i}= \pm 1$, observe that

\begin{aligned}
\Psi_{x}(A u, v) & =\int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left(e^{(\langle A u, y\rangle+v) K(z)}-1\right) f(x, y) d z d y \\
& =\int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left(e^{(\langle u, A y\rangle+v) K(z)}-1\right) f(x, y) d z d y \\
& =\int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left(e^{\left(\left\langle u, y^{\prime}\right\rangle+v\right) K(z)}-1\right) f\left(x, A^{-1} y^{\prime}\right) d z d y^{\prime} \\
& =\Psi_{x}(u, v) .
\end{aligned}
$$

For any given $s \in \mathbb{R}^{q}$, set

$$
\mathcal{U}_{s}=\left\{u \in \mathbb{R}^{q},\langle u, s\rangle \geq 0\right\} .
$$

We have,

$$
\sup _{u, v}\left(-\Psi_{x}(u, v)\right)=\sup _{u \in \mathcal{U}_{s}, v \in \mathbb{R}}\left(-\Psi_{x}(u, v)\right) .
$$

Now, for any $u \in \mathcal{U}_{s}$ and $v \in \mathbb{R}$,

$$
\langle u, s\rangle-\Psi_{x}(u, v) \geq-\Psi_{x}(u, v),
$$

so that

$$
\sup _{u, v}\left\{\langle u, s\rangle-\Psi_{x}(u, v)\right\} \geq \sup _{u \in \mathcal{U}_{s}, v \in \mathbb{R}}\left(-\Psi_{x}(u, v)\right),
$$

and thus,

$$
I_{x}(\overrightarrow{0}, 0) \leq I_{x}(s, 0) \quad \forall s \in \mathbb{R}^{q},
$$

so that Condition (C) follows.

Example 3: A negative kernel without symmetry assumption on $f$, and for $d=q=1$ If the kernel $K$ can be written as $K=\mathbb{1}_{D}-\mathbb{1}_{D^{\prime}}$ where $D$ and $D^{\prime}$ are two subsets of $\mathbb{R}$ such that $D \cap D^{\prime}=\emptyset$ and $\lambda(D)-\lambda\left(D^{\prime}\right)=1$, then Condition (C) holds. As a matter of fact, we then have

$$
\begin{aligned}
\Psi_{x}(u, v) & =\int_{\mathbb{R} \times \mathbb{R}}\left(e^{(u y+v) K(z)}-1\right) f(x, y) d z d y \\
& =\int_{D \times \mathbb{R}}\left(e^{u y+v}-1\right) f(x, y) d z d y+\int_{D^{\prime} \times \mathbb{R}}\left(e^{-u y-v}-1\right) f(x, y) d z d y \\
& =e^{v} \lambda(D) \int_{\mathbb{R}} e^{u y} f(x, y) d y-\left[\lambda(D)+\lambda\left(D^{\prime}\right)\right] g(x)+e^{-v} \lambda\left(D^{\prime}\right) \int_{\mathbb{R}} e^{-u y} f(x, y) d y .
\end{aligned}
$$

Now, let $M_{x}$ denote the Laplace transform of $f(x, \cdot)$, then

$$
\Psi_{x}(u, v)=e^{v} \lambda(D) M_{x}(u)+e^{-v} \lambda\left(D^{\prime}\right) M_{x}(-u)-\left[\lambda(D)+\lambda\left(D^{\prime}\right)\right] g(x) .
$$

For any given $u$, it can easily be seen that the infimum of $\Psi_{x}(u, \cdot)$ is reached at

$$
v_{0}=\log \sqrt{\frac{\lambda\left(D^{\prime}\right) M_{x}(-u)}{\lambda(D) M_{x}(u)}}
$$

and

$$
\Psi_{x}\left(u, v_{0}\right)=2 \sqrt{\lambda(D) \lambda\left(D^{\prime}\right)} \sqrt{M_{x}(u) M_{x}(-u)}-\left[\lambda(D)+\lambda\left(D^{\prime}\right)\right] g(x) .
$$

Observe that

$$
\Psi_{x}\left(u, v_{0}\right)=\Psi_{x}\left(-u, v_{0}\right),
$$

and thus

$$
\begin{aligned}
\sup _{u}\left(-\Psi_{x}\left(u, v_{0}\right)\right) & =\sup _{u \geq 0}\left(-\Psi_{x}\left(u, v_{0}\right)\right) \\
& =\sup _{u \leq 0}\left(-\Psi_{x}\left(u, v_{0}\right)\right) \\
& =I_{x}(0,0) .
\end{aligned}
$$

Now, if $s \geq 0$, we have for any $u \geq 0$

$$
u s-\Psi_{x}\left(u, v_{0}\right) \geq-\Psi_{x}\left(u, v_{0}\right),
$$

and thus

$$
I_{x}(s, 0) \geq I_{x}(0,0) \forall s \geq 0 .
$$

Proceeding in the same way for $s<0$, we obtain Condition (C).
Such an example of a four order kernel is $K=\mathbb{1}_{[-a, a]}-\mathbb{1}_{[-b,-a[\cup] a, b]}$, with

$$
\begin{aligned}
a & =\frac{1}{6} \sqrt[3]{2}+\frac{1}{12}(\sqrt[3]{2})^{2}+\frac{1}{3} \\
b & =\frac{1}{3} \sqrt[3]{2}+\frac{1}{6}(\sqrt[3]{2})^{2}+\frac{1}{6}
\end{aligned}
$$

Let us now give the properties of the function $J$.

Proposition 1 Assume that (A1), (A2) and (C) hold. Then,
(i) $J$ is a rate function on $\mathbb{R}^{q}$. More precisely, for $\alpha \in \mathbb{R}$,

- if $\alpha<I_{x}(\overrightarrow{0}, 0)$, then $\{J(s) \leq \alpha\}$ is compact.
- if $\alpha \geq I_{x}(\overrightarrow{0}, 0)$, then $\{J(s) \leq \alpha\}=\mathbb{R}^{q}$.
(ii) If $I_{x}(\overrightarrow{0}, 0)=\infty$, then $J$ is a good rate function on $\mathbb{R}^{q}$ and $J=J^{*}$.
(iii) If $J^{*}(s)<\infty$, then $J(s)=J^{*}(s)$.
(iv) If $\alpha<I_{x}(\overrightarrow{0}, 0)$, then $\left\{J^{*}(s) \leq \alpha\right\}=\{J(s) \leq \alpha\}$.

Remark 1 In view of the definition of $J$ and $J^{*}$, and of Proposition 1 (iii), we have:

$$
J(s)=\left\{\begin{array}{l}
J^{*}(s) \text { if } J^{*}(s)<\infty \\
I_{x}(\overrightarrow{0}, 0) \text { if } J^{*}(s)=\infty .
\end{array}\right.
$$

Let us now state the LDP for the Nadaraya-Watson estimator.
Theorem 1 (Pointwise LDP for the Nadaraya-Watson estimator)
Assume that (A1), (A2) and (C) hold, and that ( $h_{n}$ ) satisfies the conditions in (2). Then, for any open subset $U$ of $\mathbb{R}^{q}$,

$$
\liminf _{n \rightarrow \infty} \frac{1}{n h_{n}^{d}} \log \mathbb{P}\left[r_{n}(x) \in U\right] \geq-\inf _{s \in U} J^{*}(s),
$$

and for any closed subset $V$ of $\mathbb{R}^{q}$,

$$
\limsup _{n \rightarrow \infty} \frac{1}{n h_{n}^{d}} \log \mathbb{P}\left[r_{n}(x) \in V\right] \leq-\inf _{s \in V} J(s)
$$

## Comments.

1) Set $E=\left\{J^{*}(s)<\infty\right\}$. For any open subset $U$ of $\mathbb{R}^{q}$ such that $U \cap E \neq \emptyset$, we have

$$
\liminf _{n \rightarrow \infty} \frac{1}{n h_{n}^{d}} \log \mathbb{P}\left[r_{n}(x) \in U\right] \geq-\inf _{s \in U} J(s) .
$$

2) If $I_{x}$ is finite in a neighbourhood of $(\overrightarrow{0}, 0)$, then $J^{*}$ is finite everywhere and by Proposition 1 (iii), $J(s)=J^{*}(s)<\infty \forall s$; thus $\left(r_{n}\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and rate function $J$. Of course, this does not hold for nonnegative kernel since in this case $I_{x}(s, 0)=+\infty$ for any $s$ (see Proposition 3 in Section 3). However, it can hold for kernels which take negative values. For example, consider the previous Example 3, and assume $f(x, y)$ is symmetric in $y$; in this case $M_{x}(u)=M_{x}(-u)$. The equation

$$
\frac{\partial \Psi_{x}}{\partial v}(u, v)=\left[\lambda(D) e^{v}-\lambda\left(D^{\prime}\right) e^{-v}\right] M_{x}(u)=0
$$

has solution $v_{0}=\log \sqrt{\frac{\lambda\left(D^{\prime}\right)}{\lambda(D)}}$ independent from $u$. Moreover, $M^{\prime}$ is continuous and has range $\mathbb{R}$, thus, there exists $u_{0}$ such that $M^{\prime}\left(u_{0}\right)=0$. This implies that the equation

$$
\frac{\partial \Psi_{x}}{\partial u}(u, v)=\left[\lambda(D) e^{v}+\lambda\left(D^{\prime}\right) e^{-v}\right] M_{x}^{\prime}(u)=0
$$

has a solution $u_{0}$ independent from $v$. Thus $(0,0)$ is in the range of $\nabla \Psi_{x}$. It follows from Proposition 3 Section 3 that $I_{x}$ is finite in a neighbourhood of $(0,0)$.

3）When $I_{x}(\overrightarrow{0}, 0)=\infty$ ，it follows from Proposition 1 and Theorem 1 that $\left(r_{n}\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and good rate function $J$ ．

In the case $K$ is a nonnegative kernel whose support has an infinity measure，we will show in Proposition 3 that $I_{x}(\overrightarrow{0}, 0)=\infty$ ．We have thus the following corollary．

Corollary 1 Let the assumptions of Theorem $⿴ 囗 十$ hold．If $K$ is a nonnegative kernel such that $\lambda\left(\left\{x \in \mathbb{R}^{d}, K(x)>0\right\}\right)=\infty$ ，then the sequence $\left(r_{n}\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and good rate function $J$ ．

This corollary is an extension of the results of Louani［11］and Joutard［10 to the multivariate framework（and to the case the kernel $K$ may vanish）．Moreover，it proves that the rate function that appears in their large deviations results is in fact a good rate function．

To establish pointwise MDP for the Nadaraya－Watson estimator，we need the following addi－ tionnal assumptions．
（A3）For any $u \in \mathbb{R}^{q}, t \mapsto \int_{\mathbb{R}^{q}}\langle u, y\rangle^{2} f(t, y) d y$ and $t \mapsto \int_{\mathbb{R}^{q}}\langle u, y\rangle f(t, y) d y$ are continuous at $x$ and $g(x) \neq 0$.
（A4） $\lim _{n \rightarrow \infty} v_{n}=\infty$ and $\lim _{n \rightarrow \infty} \frac{n h_{n}^{d}}{v_{n}^{2}}=\infty$ ．
（A5）i）There exists an integer $p \geq 2$ such that $\forall s \in\{1, \ldots, p-1\}, \forall j \in\{1, \ldots, d\}$ ，
$\int_{\mathbb{R}^{d}} y_{j}^{s} K(y) d y_{j}=0$ ，and $\int_{\mathbb{R}^{d}}\left|y_{j}^{p} K(y)\right| d y<\infty$.
ii） $\lim _{n \rightarrow \infty} v_{n} h_{n}^{p}=0$ ．
iii）$m$ and $g$ are $p$－times differentiable on $\mathbb{R}^{d}$ ，and their differentials of order $p$ are bounded and continuous at $x$ ．

We can now state the MDP for the Nadaraya－Watson estimator．
Theorem 2 （Pointwise MDP for the Nadaraya－Watson kernel estimator of the regression） Assume that（A1）－（A5）hold．Then，the sequence $\left(v_{n}\left(r_{n}(x)-r(x)\right)\right)$ satisfies a LDP with speed $\left(\frac{n h_{n}^{d}}{v_{n}^{2}}\right)$ and good rate function $G_{x}$ defined in（4） ．

## 2．2 Large and moderate deviations principles for the semi－recursive estimator

For $a \in] 0,1 / d\left[\right.$ ，let $\tilde{\Psi}_{a, x}: \mathbb{R}^{q} \times \mathbb{R} \rightarrow \mathbb{R}$ and $\tilde{I}_{a, x}: \mathbb{R}^{q} \times \mathbb{R} \rightarrow \mathbb{R}$ be the functions defined as follows：

$$
\begin{align*}
\tilde{\Psi}_{a, x}(u, v) & =\int_{[0,1] \times \mathbb{R}^{d} \times \mathbb{R}^{q}} s^{-a d}\left(e^{s^{a d}}(\langle u, y\rangle+v) K(z)\right.  \tag{11}\\
\tilde{I}_{a, x}\left(t_{1}, t_{2}\right) & =\sup _{(u, v) \in \mathbb{R}^{q} \times \mathbb{R}}\left\{\left\langle u, t_{1}\right\rangle+v t_{2}-\tilde{\Psi}_{a, x}(u, v)\right\} . \tag{12}
\end{align*}
$$

Moreover，let $\tilde{J}_{a}$ and $\tilde{J}_{a}^{*}$ be defined as follows：for any $s \in \mathbb{R}^{q}$ ，

$$
\begin{align*}
\tilde{J}_{a}^{*}(s) & =\inf _{t \in \mathbb{R}^{*}} \tilde{I}_{a, x}(s t, t)  \tag{13}\\
\tilde{J}_{a}(s) & =\tilde{J}_{a}^{*}(s) \wedge \tilde{I}_{a, x}(\overrightarrow{0}, 0) . \tag{14}
\end{align*}
$$

Let us give the following additionnal hypotheses．
(A'1) For any $u \in \mathbb{R}^{q}, t \mapsto \int_{\mathbb{R}^{q}} e^{\alpha\langle u, y\rangle} f(t, y) d y$ is continuous at $x$ uniformly with respect to $\alpha \in[0,1]$.

Condition (C) above is substituted by the following one,
$\left(\mathrm{C}^{\prime}\right) \inf _{s \in \mathbb{R}^{q}} \tilde{I}_{a, x}(s, 0)=\tilde{I}_{a, x}(\overrightarrow{0}, 0)$.
Examples for which Condition ( $\mathrm{C}^{\prime}$ ) holds are Examples 1 and 2 given for (C). The following proposition gives the properties of the function $\tilde{J}_{a}$.

Proposition 2 Assume that (A1), (A2), ( $A^{\prime} 1$ ) and ( $C^{\prime}$ ) hold. Then,
(i) $\tilde{J}_{a}$ is a rate function on $\mathbb{R}^{q}$. More precisely, for $\alpha \in \mathbb{R}$,

- if $\alpha<\tilde{I}_{a, x}(\overrightarrow{0}, 0)$, then $\left\{\tilde{J}_{a}(s) \leq \alpha\right\}$ is compact.
- if $\alpha \geq \tilde{I}_{a, x}(\overrightarrow{0}, 0)$, then $\left\{\tilde{J}_{a}(s) \leq \alpha\right\}=\mathbb{R}^{q}$.
(ii) If $\tilde{I}_{a, x}(\overrightarrow{0}, 0)=\infty$, then $\tilde{J}_{a}$ is a good rate function on $\mathbb{R}^{q}$ and $\tilde{J}_{a}=\tilde{J}_{a}^{*}$.
(iii) If $\tilde{J}_{a}^{*}(s)<\infty$, then $\tilde{J}_{a}(s)=\tilde{J}_{a}^{*}(s)$.
(iv) If $\alpha<\tilde{I}_{a, x}(\overrightarrow{0}, 0)$, then $\left\{\tilde{J}_{a}^{*}(s) \leq \alpha\right\}=\left\{\tilde{J}_{a}(s) \leq \alpha\right\}$.

Notice that, like for $J$ and $J^{*}$, we have

$$
\tilde{J}_{a}(s)= \begin{cases}\tilde{J}_{a}^{*}(s) & \text { if } \\ \tilde{J}_{a}^{*}(s)<\infty \\ \tilde{I}_{a, x}(\overrightarrow{0}, 0) & \text { if } \tilde{J}_{a}^{*}(s)=\infty .\end{cases}
$$

We can now state the LDP for the semi-recursive kernel estimator of the regression.

## Theorem 3 (Pointwise LDP for the semi-recursive estimator of the regression)

 Set $\left(h_{n}\right)=\left(c n^{-a}\right)$ with $c>0$ and $0<a<1 / d$, and let (A1), (A2), ( $A^{\prime} 1$ ) and ( $C^{\prime}$ ) hold. Then, for any open subset $U$ of $\mathbb{R}^{q}$,$$
\liminf _{n \rightarrow \infty} \frac{1}{n h_{n}^{d}} \log \mathbb{P}\left[\tilde{r}_{n}(x) \in U\right] \geq-\inf _{s \in U} \tilde{J}_{a}^{*}(s),
$$

and for any closed subset $V$ of $\mathbb{R}^{q}$,

$$
\limsup _{n \rightarrow \infty} \frac{1}{n h_{n}^{d}} \log \mathbb{P}\left[\tilde{r}_{n}(x) \in V\right] \leq-\inf _{s \in V} \tilde{J}_{a}(s) .
$$

The comments made for Theorem $\mathbb{1}$ are valid for Theorem 3. In particular, we have the following corollary.

Corollary 2 Let the assumptions of Theorem 3 hold. If $K$ is a nonnegative kernel such that $\lambda\left(\left\{x \in \mathbb{R}^{d}, K(x)>0\right\}\right)=\infty$, then the sequence $\left(\tilde{r}_{n}\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and good rate function $\tilde{J}_{a}$.

Before stating pointwise MDP for the semi-recursive estimator of the regression, let us recall that a sequence $\left(u_{n}\right)$ is said to vary regularly with exponent $\alpha$ if there exists a function $u$ which varies regularly with exponent $\alpha$ and such that $u_{n}=u(n)$ for all $n$ (see, for example, Feller [9] page
275). We will use in the sequel the following property (see Bingham et al. [2] page 26). If ( $h_{n}$ ) varies regularly with exponent $(-a)$ and if $\beta a<1$, then

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \frac{1}{n h_{n}^{\beta}} \sum_{i=1}^{n} h_{i}^{\beta}=\frac{1}{1-a \beta} . \tag{15}
\end{equation*}
$$

We also consider the following condition.

$$
\begin{equation*}
\sup _{i \leq n} \frac{h_{n}}{h_{i}}<\infty \tag{16}
\end{equation*}
$$

(For example, this condition holds when $h_{n}$ is nonincreasing).
Theorem 4 (Pointwise MDP for the semi-recursive kernel estimator of the regression) Assume that $\left(h_{n}\right)$ varies regularly with exponent $(-a)$ with $\left.a \in\right] 0,1 / d[$, and satisfies (16). Let (A1)(A5) hold. Then, the sequence $\left(v_{n}\left(\tilde{r}_{n}(x)-r(x)\right)\right)$ satisfies a LDP with speed $\left(\frac{n h_{n}^{d}}{v_{n}^{2}}\right)$ and good rate function $\tilde{G}_{a, x}$ defined in (6).

## 3 Proofs

The proofs of the results for the Nadaraya-Watson kernel estimator are in many cases similar to those of the semi-recursive kernel estimator of the regression, so we omit some details of the proofs for this last one.

First, let us state the following propositions which give the properties of the functions $\Psi_{x}, \tilde{\Psi}_{a, x}$, $I_{x}$ and $\tilde{I}_{a, x}$. Set

$$
S_{+}=\left\{x \in \mathbb{R}^{d}, K(x)>0\right\} \text { and } S_{-}=\left\{x \in \mathbb{R}^{d}, K(x)<0\right\} .
$$

## Proposition 3 (Properties of $\Psi_{x}$ and $I_{x}$ )

Let Assumptions (A1) and (A2) hold. Then,
i) $\Psi_{x}$ is strictly convex, continuously differentiable on $\mathbb{R}^{q} \times \mathbb{R}$, and $I_{x}$ is a good rate function on $\mathbb{R}^{q} \times \mathbb{R}$.
ii) $\nabla \Psi_{x}$ is an open map and the range of $\Psi_{x}$ is $\stackrel{\circ}{\mathcal{D}}\left(I_{x}\right)$. $I_{x}$ is strictly convex on $\stackrel{\circ}{\mathcal{D}}\left(I_{x}\right)$ and for any $t \in \stackrel{\circ}{\mathcal{D}}\left(I_{x}\right) \subset \mathbb{R}^{q} \times \mathbb{R}$,

$$
\begin{equation*}
I_{x}(t)=\left\langle\left(\nabla \Psi_{x}\right)^{-1}(t), t\right\rangle-\Psi_{x}\left(\left(\nabla \Psi_{x}\right)^{-1}(t)\right) . \tag{17}
\end{equation*}
$$

iii) If $\lambda\left(S_{-}\right)=0$, then $I_{x}(\overrightarrow{0}, 0)=g(x) \lambda\left(S_{+}\right)$, and for any $t_{1} \neq \overrightarrow{0}, I_{x}\left(t_{1}, 0\right)=+\infty$.

## Proposition 4 (Properties of $\tilde{\Psi}_{a, x}$ and $\tilde{I}_{a, x}$ )

Let Assumptions (A1) and (A2) hold. Then,
i) $\tilde{\Psi}_{a, x}$ is strictly convex, continuously differentiable on $\mathbb{R}^{q} \times \mathbb{R}$, and $\tilde{I}_{a, x}$ is a good rate function on $\mathbb{R}^{q} \times \mathbb{R}$.
ii) $\nabla \tilde{\Psi}_{a, x}$ is an open map and the range of $\tilde{\Psi}_{a, x}$ is $\stackrel{\circ}{\mathcal{D}}\left(\tilde{I}_{a, x}\right)$. $\tilde{I}_{a, x}$ is strictly convex on $\stackrel{\circ}{\mathcal{D}}\left(\tilde{I}_{a, x}\right)$, and for any $t \in \stackrel{\circ}{\mathcal{D}}\left(\tilde{I}_{a, x}\right) \subset \mathbb{R}^{q} \times \mathbb{R}$,

$$
\begin{equation*}
\tilde{I}_{a, x}(t)=\left\langle\left(\nabla \tilde{\Psi}_{a, x}\right)^{-1}(t), t\right\rangle-\tilde{\Psi}_{a, x}\left(\left(\nabla \tilde{\Psi}_{a, x}\right)^{-1}(t)\right) . \tag{18}
\end{equation*}
$$

iii) If $\lambda\left(S_{-}\right)=0$, then $\tilde{I}_{a, x}(\overrightarrow{0}, 0)=g(x) \lambda\left(S_{+}\right) /(1-a d)$, and for any $t_{1} \neq \overrightarrow{0}, \tilde{I}_{a, x}\left(t_{1}, 0\right)=+\infty$.

The two following lemmas are used for the proofs of Theorems 1 and 3 ,
Lemma 1 (Pointwise LDP for the sequence ( $m_{n}(x), g_{n}(x)$ ))
Let Assumptions (A1) and (A2) hold. Then, the sequence $\left(m_{n}(x), g_{n}(x)\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and rate function $I_{x}$ defined in (9)).

Lemma 2 (Pointwise LDP for the sequence ( $\tilde{m}_{n}(x), \tilde{g}_{n}(x)$ ))
Set $h_{n}=c n^{-a}$ with $c>0$ and $\left.a \in\right] 0,1 / d[$, and let Assumptions (A1), (A2) and (A'1) hold. Then, the sequence $\left(\tilde{m}_{n}(x), \tilde{g}_{n}(x)\right)$ satisfies a LDP with speed $\left(n h_{n}^{d}\right)$ and rate function $\tilde{I}_{a, x}$ defined in (12).

Our proofs are now organized as follows. Lemmas 1 and 2 are proved in Section 3.1, Theorems 1 and 3 in Section 3.2, Theorem 2 in Section 3.3, Theorem 4 is proved in Section 3.4. Section 3.5 is devoted to the proof of Propositions 3 and 4 on the rate functions $I_{x}$ and $I_{a, x}$. Propositions 1 and 2 are proved in Section 3.6.

### 3.1 Proof of Lemmas 1 and 2

### 3.1.1 Proof of Lemma 1

For any $w=(u, v) \in \mathbb{R}^{q} \times \mathbb{R}$, set

\begin{aligned}
\Psi_{n}(x) & =\left(m_{n}(x), g_{n}(x)\right), \\
\Lambda_{n, x}(w) & =\frac{1}{n h_{n}^{d}} \log \mathbb{E}\left[\exp \left(n h_{n}^{d}\left\langle w, \Psi_{n}(x)\right\rangle\right)\right] .
\end{aligned}
$$

Let us at first assume that the following lemma holds.
Lemma 3 (Convergence of $\Lambda_{n, x}$ )
Assume that (A1) and (A2) hold, then

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \Lambda_{n, x}(u, v)=\Psi_{x}(u, v) \tag{19}
\end{equation*}
$$

where $\Psi_{x}$ is defined in (8).
To prove Lemma 1, we apply Proposition 3, Lemma 3 and the Gärtner-Ellis Theorem (see Dembo and Zeitouni (6). Proposition 3 ensures that $\Psi_{x}$ is essentially smooth, lower semicontinuous function so that Lemma 1 follows from the Gärtner-Ellis Theorem.
Let us now prove Lemma 3. Set

Z_{i}=\left[\left\langle u, Y_{i}\right\rangle+v\right] K\left(\frac{x-X_{i}}{h_{n}}\right) .
$$

For any $(u, v) \in \mathbb{R}^{q} \times \mathbb{R}$, we have

$$
\Lambda_{n, x}(u, v)=\frac{1}{n h_{n}^{d}} \log \mathbb{E}\left[\exp \left(\sum_{i=1}^{n} Z_{i}\right)\right]
$$

and, since the random vectors $\left(X_{i}, Y_{i}\right), i=1, \ldots, n$ are independent and identically distributed, we get

$$
\Lambda_{n, x}(u, v)=\frac{1}{h_{n}^{d}} \log \mathbb{E}\left[e^{Z_{n}}\right]
$$

A Taylor's expansion implies that there exists $c_{n}$ between 1 and $\mathbb{E}\left[e^{Z_{n}}\right]$ such that

$$
\begin{aligned}
\Lambda_{n, x}(u, v) & =\frac{1}{h_{n}^{d}} \mathbb{E}\left[e^{Z_{n}}-1\right]-\frac{1}{2 c_{n}^{2} h_{n}^{d}}\left(\mathbb{E}\left[e^{Z_{n}}-1\right]\right)^{2} \\
& =\frac{1}{h_{n}^{d}} \int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left[e^{(\langle u, y\rangle+v) K\left(\frac{x-s}{h_{n}}\right)}-1\right] f(s, y) d s d y-R_{n, x}^{(1)}(u, v) \\
& =\Psi_{x}(u, v)-R_{n, x}^{(1)}(u, v)+R_{n, x}^{(2)}(u, v)
\end{aligned}
$$

with

$$
\begin{aligned}
R_{n, x}^{(1)}(u, v) & =\frac{1}{2 c_{n}^{2} h_{n}^{d}}\left(\mathbb{E}\left[e^{Z_{n}}-1\right]\right)^{2} \\
R_{n, x}^{(2)}(u, v) & =\int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left[e^{(\langle u, y\rangle+v) K(z)}-1\right]\left[f\left(x-h_{n} z, y\right)-f(x, y)\right] d z d y
\end{aligned}
$$

Let us prove that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} R_{n, x}^{(2)}(u, v)=0 \tag{20}
\end{equation*}
$$

Set $A>0$ and $\epsilon>0$; we then have

$$
\begin{align*}
R_{n, x}^{(2)}(u, v)= & \int_{\{\|z\| \leq A\} \times \mathbb{R}^{q}}\left[e^{(\langle u, y\rangle+v) K(z)}-1\right]\left[f\left(x-h_{n} z, y\right)-f(x, y)\right] d z d y \\
& +\int_{\{\|z\|>A\} \times \mathbb{R}^{q}}\left[e^{(\langle u, y\rangle+v) K(z)}-1\right]\left[f\left(x-h_{n} z, y\right)-f(x, y)\right] d z d y \tag{21}
\end{align*}
$$

Next, since for any $t \in \mathbb{R},\left|e^{t}-1\right| \leq|t| e^{|t|}$, we have

$$
\begin{align*}
& \int_{\{\|z\|>A\} \times \mathbb{R}^{q}}\left|e^{(\langle u, y\rangle+v) K(z)}-1\right|\left|f\left(x-h_{n} z, y\right)-f(x, y)\right| d z d y \\
& \leq \int_{\{\|z\|>A\} \times \mathbb{R}^{q}}|\langle u, y\rangle+v||K(z)| e^{|\langle u, y\rangle+v \| K(z)|}\left|f\left(x-h_{n} z, y\right)-f(x, y)\right| d z d y \\
& \leq \int_{\{\|z\|>A\} \times \mathbb{R}^{q}}|\langle u, y\rangle+v||K(z)| e^{|\langle u, y\rangle+v||K(z)|} f\left(x-h_{n} z, y\right) d z d y \\
& +\int_{\{\|z\|>A\} \times \mathbb{R}^{q}}|\langle u, y\rangle+v||K(z)| e^{|\langle u, y\rangle+v||K(z)|} f(x, y) d z d y \\
& \leq e^{|v|\|K\|_{\infty}}\|u\| \int_{\{\|z\|>A\}}|K(z)|\left[\int_{\mathbb{R}^{q}}\|y\| e^{\|K\|_{\infty}\|u\|\|y\|} f\left(x-h_{n} z, y\right) d y\right] d z \\
& +e^{|v|\|K\|_{\infty}}|v| \int_{\{\|z\|>A\}}|K(z)|\left[\int_{\mathbb{R}^{q}} e^{\|K\|_{\infty}\|u\|\|y\|} f\left(x-h_{n} z, y\right) d y\right] d z \\
& +e^{|v|\|K\|_{\infty}}\|u\| \int_{\{\|z\|>A\}}|K(z)| d z \int_{\mathbb{R}^{q}}\|y\| e^{\|K\|_{\infty}\|u\|\|y\|} f(x, y) d y \\
& +e^{|v|\|K\|_{\infty}}|v| \int_{\{\|z\|>A\}}|K(z)| d z \int_{\mathbb{R}^{q}} e^{\|K\|_{\infty}\|u\|\|y\|^{\prime}} f(x, y) d y \\
& \leq B \int_{\{\|z\|>A\}}|K(z)| d z, \tag{22}

\end{aligned}

and the first part of Theorem 1 is proved.

& \leq-\inf _{(s, t) \in H_{1}^{-1}(V) \cup\{(\overrightarrow{0}, 0)\}} I_{x}(s, t) \\
& \leq-\inf _{s \in V, t \in \mathbb{R}} I_{x}(s t, t) \\
& \leq-\inf _{s \in V, t \in \mathbb{R}} \hat{I}_{x}(s, t) \\
& \leq-\inf _{s \in V} J(s),
\end{aligned}
$$

where the second inequality comes from Condition (C); this concludes the proof of Theorem 1.

### 3.2.2 Proof of Theorem 3

Applying Lemma 2, Theorem 3 is proved by following the same approach as for the proof of Theorem 1 with replacing $m_{n}, g_{n}, J^{*}$ and $J$ by $\tilde{m}_{n}, \tilde{g}_{n}, \tilde{J}_{a}^{*}$ and $\tilde{J}_{a}$ respectively.

Now, since the sequence $\left(v_{n} B_{n}(x)\right)$ satisfies a LDP with speed $\left(\frac{n h_{n}^{d}}{v_{n}^{2}}\right)$ and good rate function $G_{x}$, there exists $c_{1}>0$ such that

- In the case $a p=1$, let $\mathcal{L}$ be the slowly varying function such that $h_{n}=n^{-a} \mathcal{L}(n)$, and set $\varepsilon>0$ small enough. Since $a(p-\varepsilon)<1$, we have $h_{n}^{p}=o\left(h_{n}^{p-\varepsilon}\right)$, and in view of (15) and (A4),

\ddot{R}_{n, x}^{(2)}(u) & =\frac{h_{n}^{d}}{2 g^{2}(x)} \frac{1}{n} \sum_{i=1}^{n} \frac{1}{h_{i}^{d}} \int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\langle u, y-r(x)\rangle^{2} K^{2}(z)\left[f\left(x-h_{i} z, y\right)-f(x, y)\right] d z d y .

- The strict convexity of $\Psi_{x}$ follows from its definition, since for any $\left.\gamma \in\right] 0,1[$, and $(u, v) \neq$ $\left(u^{\prime}, v^{\prime}\right)$,

< & \gamma \int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left(e^{(\langle u, y\rangle+v) K(z)}-1\right) f(x, y) d z d y \\
& +(1-\gamma) \int_{\mathbb{R}^{d} \times \mathbb{R}^{q}}\left(e^{\left(\left\langle u^{\prime}, y\right\rangle+v^{\prime}\right) K(z)}-1\right) f(x, y) d z d y,
\end{aligned}

Since $\Psi_{x}$ is a smooth convex on $\mathbb{R}^{q} \times \mathbb{R}$, it follows that $\Psi_{x}$ is essentially smooth so that $I_{x}$ is a good rate function on $\mathbb{R}^{q} \times \mathbb{R}$ (see Dembo and Zeitouni [6]), which proves the first part of Proposition 3.

Now, observe that $\stackrel{\circ}{\mathcal{D}}\left(\Psi_{x}\right)=\mathbb{R}^{q} \times \mathbb{R}$, and since $\Psi_{x}$ is strictly convex, it holds that the pair $\left(\stackrel{\circ}{\mathcal{D}}\left(\Psi_{x}\right), \Psi_{x}\right)$ is a convex function of Legendre type. It follows that $\left(\stackrel{\circ}{\mathcal{D}}\left(I_{x}\right), I_{x}\right)$ is a convex function of Legendre type (See Rockafellar [17]). Thus, Part 2 of Proposition 3 follows from Theorem 26.5 of Rockafellar [17.

- Let us now assume that $\lambda\left(S_{-}\right)=0$. Thus

Thus $\lim _{v \rightarrow-\infty} \Psi_{x}(u, v)=-g(x) \lambda\left(S_{+}\right)$and $I_{x}(\overrightarrow{0}, 0)=$ $g(x) \lambda\left(S_{+}\right)$. Now, when $t_{1} \neq \overrightarrow{0}$, let us show that

When $\lambda\left(S_{-}\right)=0$, for each $u \in \mathbb{R}^{q}$ and $\left.\left.s \in\right] 0,1\right]$, the map $v \mapsto s^{-a d}\left(e^{s^{a d} u^{T} y K(z)} e^{v K(z)}-1\right) \mathbb{1}_{S_{+}}(z) f(x, y)$ is increasing in $v$ and goes to $-s^{-a d} f(x, y)$ when $v \rightarrow-\infty$. We deduce that $\lim _{v \rightarrow-\infty} \tilde{\Psi}_{a, x}(u, v)=$ $-g(x) \lambda\left(S_{+}\right) \int_{0}^{1} s^{-a d}=-g(x) \lambda\left(S_{+}\right) /(1-a d)$ and $I_{x}(\overrightarrow{0}, 0)=g(x) \lambda\left(S_{+}\right) /(1-a d)$.

(i) Let us prove the first part of Proposition [1,

Now, let $\left(s_{n}, t_{n}\right)$ be a sequence of real numbers of $\hat{G}$, there exists $\left(x_{n}, y_{n}\right) \in G$ such that $\left(x_{n}, y_{n}\right)=F\left(s_{n}, t_{n}\right)=\left(s_{n} t_{n}, t_{n}\right) \in G$.
The compactness of $G$ on $\mathbb{R}^{q} \times \mathbb{R}$ ensures that there exists a sequence of real numbers $\left(x_{n_{k}}, y_{n_{k}}\right) \in G$ such that $\left(x_{n_{k}}, y_{n_{k}}\right) \rightarrow\left(x_{0}, y_{0}\right)$ as $k \rightarrow \infty$, where $\left(x_{0}, y_{0}\right) \in G$. Therefore, $\left(s_{n_{k}} t_{n_{k}}, t_{n_{k}}\right) \rightarrow\left(x_{0}, y_{0}\right)$ as $k \rightarrow \infty$.
Noting that Condition (C) ensures that $\forall s \in \mathbb{R}^{q}, I_{x}(s, 0) \geq I_{x}(\overrightarrow{0}, 0)>\alpha$ so that $(s, 0) \notin$ $G$.
It follows that $y_{0} \neq 0$, and thus $t_{n_{k}} \rightarrow y_{0}$ and $s_{n_{k}} \rightarrow s_{0}$ as $k \rightarrow \infty$, where $s_{0}=x_{0} / y_{0}$. We deduce that $\left(s_{n_{k}}, t_{n_{k}}\right) \rightarrow\left(s_{0}, y_{0}\right)$ as $k \rightarrow \infty$, so that $\left(s_{0}, y_{0}\right) \in \hat{G}$. Thus $\hat{G}$ is a compact set. Now we claim that the set $A=\{s, J(s) \leq \alpha\}$ is the image of $\hat{G}$ by the continuous map $\pi:(s, t) \mapsto s$, and thus it is a compact.
Indeed, clearly $\pi(\hat{G}) \subset A$. For the opposite inclusion, consider $\alpha<\alpha^{\prime}<I_{x}(\overrightarrow{0}, 0)$; the set $\hat{G}^{\prime}=\left\{\hat{I}_{x}(s, t) \leq \alpha^{\prime}\right\}$ is compact. Let $s_{0} \in A$, since $J\left(s_{0}\right) \leq \alpha$, we have $J\left(s_{0}\right)=$ $\inf _{\left(s_{0}, t\right) \in \hat{G}^{\prime}} \hat{I}_{x}\left(s_{0}, t\right) ;$ by compacity, there exists $t_{0}$ such that $J\left(s_{0}\right)=\hat{I}_{x}\left(s_{0}, t_{0}\right) ;\left(s_{0}, t_{0}\right) \in \hat{G}$ and $\pi\left(s_{0}, t_{0}\right)=s_{0}$, thus $A \subset \pi(\hat{G})$.

- If $\alpha \geq I_{x}(\overrightarrow{0}, 0)$, let $s \in \mathbb{R}^{q}$, we have

We deduce that $\mathbb{R}^{q} \subseteq\{J(s) \leq \alpha\}$ and the second part of Proposition 1 (i) follows.
(ii) It is an obvious consequence of (i) and the definitions of $J$ and $J^{*}$.
(iii) Assume that $J^{*}(s)<\infty$.

- If $I_{x}(\overrightarrow{0}, 0)>\inf _{t} I_{x}(s t, t)$, then

By the convexity of $I_{x}$, we have for any $\left.\left.\nu \in\right] 0,1\right], \quad I_{x}\left(s t_{0} \nu, t_{0} \nu\right)<\infty$ and

I_{x}\left(s t_{0} \nu, t_{0} \nu\right) \leq \nu I_{x}\left(s t_{0}, t_{0}\right)+(1-\nu) I_{x}(\overrightarrow{0}, 0) .

We deduce that

0 \leq I_{x}\left(s t_{0} \nu, t_{0} \nu\right)-I_{x}(\overrightarrow{0}, 0) \leq \nu\left(I_{x}\left(s t_{0}, t_{0}\right)-I_{x}(\overrightarrow{0}, 0)\right),
$$

and if we take $\nu \rightarrow 0$, the third part of Proposition 1 follows.
(iv) Let us suppose that $\alpha<I_{x}(\overrightarrow{0}, 0)$ and let $s \in\left\{J^{*}(s) \leq \alpha\right\}$, then we have $J^{*}(s)<\infty$. We deduce from (iii) that $J(s)=J^{*}(s)$. It follows that $J(s) \leq \alpha$, which ensures that $s \in\{J(s) \leq \alpha\}$. Conversely, if $s \in\{J(s) \leq \alpha\}$, then

$$
I_{x}(\overrightarrow{0}, 0)>\inf _{t} I_{x}(s t, t),
$$

so that

$$
\inf _{t} I_{x}(s t, t)=\inf _{t \neq 0} I_{x}(s t, t) .
$$

That is $J(s)=J^{*}(s)$. Therefore, $J^{*}(s) \leq \alpha$, which ensures that $s \in\left\{J^{*}(s) \leq \alpha\right\}$, and thus Proposition $\mathbb{1}$ is proved.

### 3.6.2 Proof of Proposition 2

Proposition 22 is proved by following the same approach as for the proof of Proposition 11 with replacing $I_{x}, J$ and $J^{*}$ by $\tilde{I}_{a, x}, \tilde{J}_{a}$ and $\tilde{J}_{a}^{*}$ respectively.
