ALGEBRAIC STATISTICAL MODELS

Abstract: M any statisticalm odels are algebraic in that they are de ned in term s of polynom ial constraints, or in term s of polynom ial or rational param etrizations. The param eter spaces of such m odels are typically sem i-algebraic subsets of the param eter space of a reference m odel with nice properties, such as for example a regular exponential fam ily. This observation leads to the de nition of an 'algebraic exponential fam ily'. This new de nition provides a uni ed fram ework for the study of statistical m odels with algebraic structure. In this paper we review the ingredients to this de nition and illustrate in examples how computational algebraic geom etry can be used to solve problem s arising in statistical inference in algebraic m odels.

K ey words and phrases: A lgebraic statistics, com putational algebraic geom etry, exponential fam ily, m axim um likelihood estimation, m odel invariants, singularities.

1. Introduction

A lepbra has seen m any applications in statistics (e.g.D iaconis, 1988; V iana and R ichards, 2001), but it is only rather recently that computational algebraic geometry and related techniques in commutative algebra and combinatorics have been used to study statistical m odels and inference problem s. This use of computational algebraic geometry was initiated in work on exact tests of conditional independence hypotheses in contingency tables (Diaconis and Sturm fels, 1998). A nother line of work in experim ental design led to the m onograph by P istone et al. (2001). A lebraic statistics', the buzz word in the titles of this monograph and the more recent book by Pachter and Sturm fels (2005), has now become the umbrella term for statistical research involving algebraic geometry. There has also begun to be a sense of community among researchers working in algebraic statistics as relected by workshops, conferences, and sum mer schools. One such workshop, the 2005 Workshop on Algebraic Statistics and Computational Biology held at the Clay Mathematics Institute led to the Statistica Sinica them e topic, of which this article forms a part. O ther recent work in algebraic statistics has considered contingency table analysis (A oki and Takem ura, 2005; D obra and Sullivant, 2004; Takem ura and A oki, 2005), phylogenetic tree m odels (A llm an and R hodes, 2003; E riksson et al., 2005; Sturm fels and Sullivant, 2005), maximum likelihood estimation under multinom ial sampling (Catanese et al., 2006; Hosten et al., 2005), reliability theory (Giglio and W ynn, 2004), and Bayesian networks

(G arcia et al., 2005). A special issue of the Journal of Sym bolic C om putation em phasizing the algebraic side em erged follow ing the 2003 W orkshop on C om putational A lgebraic Statistics at the Am erican Institute of M athem atics.

The algebraic problem s studied in algebraic statistics are of a rather diverse nature. At the very core of the eld, how ever, lies the notion of an algebraic statistical m odel. W hile this notion has the potential of serving as a unifying them e for algebraic statistics, there does not seem, at present, to exist a uni ed de nition of an algebraic statistical m odel. This lack of unity is apparent even when reading articles by the same authors, where two papers m ight use two di erent, non-equivalent de nitions of an algebraic statistical m odel, for di erent theoretical reasons. The usual set-up for discussing algebraic statistical m odels has involved rst restricting to discrete random variables and then considering m odels that are either conditional independence m odels or de ned param etrically w ith a polynom ial or rational param etrization. How ever, m any statistical m odels for continuous random variables also have an algebraic avor, though currently there has been no posited description of a general class of algebraic statistical m odels that would include m odels for continuous random variables.

The main goal of this paper is to give a unifying de nition of algebraic statistical models, as well as illustrate the usefulness of the de nition in examples. Our approach is based on the following philosophy. Let P = (P j 2) be a statistical model with parameter space R^k . In this paper, a model such as P is dened to be a family of probability distributions on some given sample space. (For a discussion of the notion of a statistical model see M of ullagh (2002) who proposes to rene the traditional denition to one that ensures that the model extends in a meaningful way under natural extensions of the sample space.) Suppose that in model P a statistical inference procedure of interest is well-behaved. If this is the case, then the properties of the inference procedure in a submodel $P_M = (P j 2 M)$ are often determined by the geometry of the set M. Hence, if the set M exhibits algebraic structure, then the inference procedure can be studied using tools from algebraic geometry. This philosophy suggests the following denition. The sem i-algebraic sets appearing in the denition will be dened in Section 3.

Denition 1. Let P = (P j 2) be a \well-behaved" statisticalm odelwhose parameter space R^{k} has non-empty interior. A submodel $P_{M} = (P j 2 M)$ is an algebraic statisticalm odel if there exists a sem i-algebraic set $A = R^{k}$ such that $M = A \setminus .$

De nition 1 is intentionally vague and the precise meaning of the adjective \wellbehaved" depends on the context. For example, if asymptotic properties of maximum likelihood estimators are of interest then the word \well-behaved" could refer to models satisfying regularity conditions guaranteeing that maximum likelihood estimators are asym ptotically norm ally distributed. However, one class of statistical models, namely regular exponential families, can be considered to be well-behaved with respect to nearly any statistical feature of interest.

Denition 2. Let (P j 2 N) be a regular exponential family of order k. The subfamily induced by the set M N is an algebraic exponential family if there exists an open set N R^{k} , a di comorphism g: N ! N, and a sem i-algebraic set A R^{k} such that $M = g^{1}(A \setminus N)$.

De nition 2 allows one to consider algebraic structure arising after the regular exponential fam ily is reparam etrized using the di eom orphism g (see Section 2.2 for a de nition of di eom orphism s). Frequently, we will make use of the mean param etrization. A lgebraic exponential fam ilies appear to include all the existing competing de nitions of algebraic statistical models as special cases. Am ong the exam ples covered by De nition 2 are the param etric models for discrete random variables studied by Pachter and Sturm fels (2005) in the context of computational biology. O ther models included in the fram ework are conditional independence models with or without hidden variables for discrete or jointly G aussian random variables. Note that som ework in algebraic statistics has focused on discrete distributions corresponding to the boundary of the probability sim plex (G eiger et al., 2006). These distributions can be included in an extension of the regular exponential fam ily corresponding to the interior of the probability sim plex; see B amdor -N ielsen (1978, pp.154), B rown (1986, pp.191), and C siszar and M atus (2005). M odels given by sem ialgebraic subsets of the (closed) probability sim plex can thus be term ed extended algebraic exponential fam ilies'.

In the remainder of the paper we will explain and exemplify our de nition of algebraic exponential families. We begin in Section 2 by reviewing regular exponential families and in Example 9 we stress the fact that submodels of regular exponential families are only well-behaved if the local geometry of their parameter spaces is su ciently regular. In Section 3, we review some basic term inology and results on semi-algebraic sets, which do have nice local geometric properties, and introduce our algebraic exponential families. We also show that other natural formulations of an algebraic statistical model in the discrete case fall under this description and illustrate the generality using jointly normal random variables. We then illustrate how problem sarising in statistical inference in algebraic models can be addressed using computational algebraic geometry. Concretely, we discuss in Section 4 how so-called model invariants reveal aspects of the geometry of an algebraic statistical model that are connected to properties of statistical inference procedures such as likelihood ratio tests. As a second problem of a somewhat di erent avour we show in Section 5 how systems of polynom ial equations arising from likelihood equations can be solved algebraically.

2. Regular exponential fam ilies

Consider a sample space X with -algebra A on which is dened a -n item easure . Let T : X ! R^k be a statistic, i.e., a measurable map. Dene the natural parameter space

$$N = 2 R^{k} : e^{t_{T}(x)} d(x) < 1 :$$

For 2 N, we can de ne a probability density p on X as

$$p(x) = e^{t_T(x)}$$

where

$$() = \log_{X} e^{t_{T}(x)} d(x)$$

is the logarithm of the Laplace transform of the measure $^{T} = T^{1}$ that the statistic T induces on the Borel -algebra of R^{k} . The support of T is the intersection of all closed sets A R^{k} that satisfy $^{T}(R^{k}nA) = 0$. Recall that the a ne dimension of A R^{k} is the dimension of the linear space spanned by all dimension X y of two vectors X; y 2 A.

Denition 3. Let P be the probability measure on (X;A) that has -density p. The probability distributions (P j 2 N) form a regular exponential family of order k if N is an open set in R^k and the a nedimension of the support of ^T is equal to k. The statistic T (x) that induces the regular exponential family is called a canonical su cient statistic.

The order of a regular exponential family is unique and if the same family is represented using two dierent canonical su cient statistics then those two statistics are non-singular a ne transform s of each other (Brown, 1986, Thm .1.9).

2.1. Exam ples

Regular exponential fam ilies com prise fam ilies of discrete distributions, which were the subject of much of the work on algebraic statistics.

Example 4 (D iscrete data). Let the sample space X be the set of integers f1;:::;mg. Let be the counting measure on X, i.e., the measure (A) of A X is equal to the cardinality of A. Consider the statistic T :X ! R^{m-1} ,

$$T(x) = I_{flg}(x); :::; I_{fm} (x)^{t};$$

whose zero-one components indicate which value in X the argument x is equal to. In particular, when x = m, T (x) is the zero vector. The induced measure ^T is a measure on

the Borel -algebra of \mathbb{R}^{m-1} with support equal to the m vectors in f0;1g^{m-1} that have at most one non-zero component. The di erences of these m vectors include all canonical basis vectors of \mathbb{R}^{m-1} . Hence, the a nedimension of the support of ^T is equal to m 1.

It holds for all $2 R^{m-1}$ that

() = log 1 +

x=1 < 1

Hence, the natural parameter space N is equal to all of \mathbb{R}^{m-1} and in particular is open. The -density p is a probability vector in \mathbb{R}^{m} . The components p (x) for 1 x m 1 are positive and given by

The last component of p is also positive and equals

$$p(m) = 1$$

The fam ily of induced probability distribution (P j 2 R^m¹) is a regular exponential fam ily of order m 1. The interpretation of the natural parameters $_x$ is one of log odds because p is equal to a given positive probability vector $(p_1; :::; p_m)$ if and only if $_x = \log(p_x = p_m)$ for x = 1; :::; m 1. This establishes a correspondence between the natural parameter space N = R^m¹ and the interior of the m 1 dimensional probability simplex.

The other distributional fram ework that has seen application of algebraic geometry is that of multivariate norm ald istributions.

Example 5 (Normaldistribution). Let the sample space X be Euclidean space \mathbb{R}^p equipped with its Borel -algebra and Lebesgue measure . Consider the statistic T : X! $\mathbb{R}^p = \mathbb{R}^{p(p+1)=2}$ given by

T (x) =

The polynom ial functions that form the components of T (x) are linearly independent and thus the support of T has the full and immension p + p(p + 1)=2.

If $2 R^p R^{p(p+1)=2}$, then write $p_{pl} 2 R^p$ for the vector of the rst p components i, 1 i p. Similarly, write p_{pl} for the symmetric p p-matrix formed from the last p(p+1)=2 components j_{ij} , 1 i j p. The function x 7 e^{tT (x)} is -integrable if and only if p_{pl} is positive denite. Hence, the natural parameter space N is equal to the Cartesian product of R $^{\rm p}$ and the cone of positive denite p $\,p\text{-m}$ atrices. If is in the open set N , then

The Lebesgue densities p can be written as

Setting = $\begin{bmatrix} 1 \\ [p p] \end{bmatrix}$ and = $\begin{bmatrix} 1 \\ [p p] \end{bmatrix}$, we not that

$$p(x) = \frac{1}{p(2)^{p} \det(x)} \exp(\frac{1}{2}(x)^{t-1}(x))$$

is the density of the multivariate norm all distribution N_p(;). Hence, the family of all multivariate norm all distributions on R^p with positive de nite covariance matrix is a regular exponential family of order p + p(p + 1)=2.

The structure of a regular exponential family remains essentially unchanged when sam - pling independent and identically distributed observations.

Example 6 (Samples). A sample X_1 ;:::; X_n from P comprises independent random vectors, all distributed according to P. Denote their joint distribution by $\prod_{i=1}^{n} P$. An important property of a regular exponential family (P j 2 N) of order k is that the induced family ($\prod_{i=1}^{n} P$ j 2 N) is again a regular exponential family of order k with canonical su cient statistic $\prod_{i=1}^{n} T(x_i)$ and Laplace transform n (). For discrete data as discussed in Example 4, the canonical su cient statistic is given by the vector of counts

$$N_{x} = \sum_{i=1}^{X^{n}} I_{fxg}(x_{i}); x = 1; ...; m 1:$$

For the norm all distribution in Example 5, the canonical su cient statistic is in correspondence with the empirical mean vector X and the empirical covariance matrix S; compare (4.1).

2.2. Likelihood inference in regular exponential fam ilies

A mong the nice properties of regular exponential fam ilies is their behavior in likelihood inference. Suppose the random vector X is distributed according to some unknown distribution from a regular exponential fam ily (P j 2 N) of order k with canonical su cient statistic T.G iven an observation X = x, the log-likelihood function takes the form

$$(jT(x)) = T(x)$$
 ():

The log-Laplace transform is a strictly convex and sm ooth, that is, in nitely m any times di erentiable, function on the convex set N (Brown, 1986, Thm .1.13, Thm .2.2, C or.2.3). The derivatives of yield the moments of the canonical su cient statistic such as the expectation and covariance m atrix,

The matrix () is positive de nite since the components of T (X) may not exhibit a linear relationship that holds almost everywhere.

The strict convexity of f in plies strict concavity of the log-likelihood function `. Hence, if the maximum likelihood estimator (MLE)

$$(T(x)) = \arg \max_{2N} (jT(x))$$

exists then it is the unique local and global maximizer of ' and can be obtained as the unique solution of the likelihood equations () = T(x). The existence of ^(T(x)) is equivalent to the condition T(x) 2 (N); the open set (N) is equal to the interior of the convex hull of the support of ^T (Brown, 1986, Thm .5.5).

If X₁;:::;X_n are a sample of random vectors drawn from P , then the previous discussion applies to the family ($_{i=1}^{n}P$ j 2 N). In particular, the likelihood equations become

By the strong law of large num bers, T converges alm ost surely to the true param eter point

 $(_0)$ 2 (N). It follows that the probability of existence of the MLE, Prob₀ T 2 (N), tends to one as the sample size n tends to in nity. Moreover, the mean parametrization map 7 () is a bijection from N to (N) that has a dimensible inverse with total derivative

which implies in conjunction with an application of the central limit theorem :

P roposition 7. The M LE (T) = 1 (T) in a regular exponential fam ily is asymptotically norm alin the sense that if $_0$ is the true parameter, then

A submodel of a regular exponential family (P j 2 N) of order k is given by a subset M N. If the geometry of the set M is regular enough, then the submodel may

inherit the favorable properties of likelihood inference from its reference model, the regular exponential family. The nicest possible case occurs when the submodel (P j 2 M) has parameter space $M = N \setminus L$, where $L = R^k$ is an a ne subspace of R^k . Altering the canonical su cient statistics one nds that (P j 2 M) form s a regular exponential family of order dim (L).

G iven a single observation X from P , the likelihood ratio test for testing H $_0$: 2 M versus H $_1$: 2 N nM rejects H $_0$ for large values of the likelihood ratio statistic

$$M (T (X)) = \sup_{2N} '(jT (X)) \sup_{2M} '(jT (X)):$$

If we observe a sample X₁;::;X_n from P , then the likelihood ratio statistic depends on T only and is equal to n_M (T). For a rejection decision, the distribution of n_M (T) can often be approximated using the next asymptotic result.

Proposition 8. If $M = N \setminus L$ for an a ne space L and the true parameter $_0$ is in M, then the likelihood ratio statistic n $_M$ (T) converges to $_{k \dim (L)}^2$, the chi-square distribution with k dim (L) degrees of freedom, as n ! 1.

In order to obtain asymptotic results such as uniform ly valid chi-square asymptotics for the likelihood ratio statistic, the set M need not be given by an a ne subspace. In fact, if M is an m-dimensional smooth manifold in \mathbb{R}^k , then n M (T) still converges in distribution to ${}^2_{k\ m}$ for any ${}_0\ 2\ M$. A set M is an m-dimensional smooth manifold if for all ${}_0\ 2\ M$ there exists an open set U \mathbb{R}^k containing ${}_0$, an open set V \mathbb{R}^k , and a di ecomorphism g:V ! U such that g V \ (\mathbb{R}^m fOg) = U. Here, \mathbb{R}^m fOg \mathbb{R}^k is the subset of vectors for which the last k m components are equal to zero. A di ecomorphism g:V ! U is a smooth bijective map that has a smooth inverse g 1 :U ! V. An exponential fam ily induced by a smooth manifold in the natural parameter space is commonly term ed a curved exponential fam ily; see K ass and Vos (1997) for an introduction to this topic.

The fact that m any interesting statistical models, in particular models involving hidden variables, are not curved exponential fam ilies calls for generalization. One attempt at such generalization was made by G eiger et al. (2001) who introduce so-called strati ed exponential fam ilies. A strati ed exponential fam ily is obtained by piecing together several curved exponential fam ilies. How ever, as the next example shows, strati ed exponential fam ilies appear to be a bit too general as a fram ew ork unless m ore conditions are im posed on how the curved exponential fam ilies are joined together. Example 9 is inspired by an example in Rockafellar and W ets (1998, p.199).

Example 9. Consider the regular exponential family P of bivariate normal distributions with unknown mean vector = $(_1;_2)^t 2 R^2$ but covariance matrix equal to the

identity matrix $I_2 \ 2 \ R^2 \ ^2$. The natural parameter space of this model is the plane R^2 . When drawing a sample X_1 ;:::; X_n from a distribution in P, the canonical statistic is the sum of the random vectors. Dividing by the sample size n yields the sample mean vector X 2 R^2 , which is also the MLE of . In the following we will assume that the true parameter $_0$ is equal to the origin. Then the rescaled sample mean vector $\frac{p}{n}X$ is distributed according to the bivariate standard norm all distribution N $_2(0;I_2)$.

If we de ne a submodel P_C P by restricting the mean vector to lie in a closed set C R^2 , then the MLE ^ for the model P_C is the point in C that is closest to X in Euclidean distance. For n = 1, the likelihood ratio statistic $_C(X)$ for testing 2 C versus 2 C is equal to the squared Euclidean distance between X and C. Hence, the likelihood ratio statistic based on an n-sample is

$$n_{C}(X) = n_{2C} \min X \quad j^{2} = \min_{2^{D} n C} j^{D} \overline{n} X \quad j^{2};$$

i.e., the squared Euclidean distance between the standard normal random vector $p \overline{n} X$ and the rescaled set $p \overline{n} C$.

As a concrete choice of a submodel, consider the set

$$C_1 = f(_1;_2)^t 2 R^2 j_2 = _1 sin(1 = _1); _1 \in Og[f(0;0)^t g:$$

This set is the disjoint union of the two one-dimensional smooth manifolds obtained by taking $_1 < 0$ and $_1 > 0$, and the zero-dimensional smooth manifold given by the origin. These manifolds form a stratication of C₁ (Geiger et al., 2001, p. 513), and thus the model P_{C1} constitutes a strati ed exponential family. In Figure 1, we plot three of the sets $p \overline{n} C_1$ for the choices $n = 100;100^2;100^3$. The range of the plot is restricted to the square [3;3]², which contains the majority of the mass of the bivariate standard norm all distribution. The gure illustrates the fact that as n tends to in nity the sets $p \overline{n} C_1$ II more and more densely the 2-dimensional cone comprised between the axes $_2 = _1$. Hence, n $_{C_1}$ (X) converges in distribution to the squared Euclidean distance between a bivariate standard norm all point and this cone. So although we pieced together sm ooth manifolds of codimension 1 or larger, the limiting distribution of the likelihood ratio statistic is obtained from a distance to a full-dimensional cone.

As a second submodel consider the one induced by the set

$$C_2 = f(_1;_2)^t 2 R^2 j_2 = _1 sin(log(j_1 \neq 4)); _1 2 [3;3]n f 0 gg [f(0;0)^t g:$$




Figure 2: Sets $p_{nC_{2}}$ for n = 100;100²;100³.

The model P_{C_2} is again a strati ed exponential fam ily. However, now the sets $pn C_2$ have a wave-like structure even for large sample sizes n; com pare Figure 2. We conclude that in this example the likelihood ratio test statistic n C_2 (X) does not converge in distribution as n tends to in nity.

The failure in the previous example of nice asymptotic behavior of the likelihood ratio test is part of our motivation for restricting to the class of algebraic exponential families, which we introduce next.

3. A lgebraic exponential fam ilies

In the following de nition, which was anticipated in the introduction, we propose the use of sem i-algebraic sets to unify di erent de nitions of algebraic statistical models. Using sem i-algebraic sets eliminates phenom ena as created in Example 9 because these sets have nice local geom etric properties. In addition, in posing algebraic structure allows one to employ the tools of computational algebraic geom etry to address questions arising in statistical inference. (M ore details on both these points are given in Section 4.)

Denition 2. Let (P j 2 N) be a regular exponential family of order k. The subfamily induced by the set M N is an algebraic exponential family if there exists an open set N R^{k} , a di comorphism g: N ! N, and a semi-algebraic set A R^{k} such that $M = g^{1}(A \setminus N)$.

The de nition states that an algebraic exponential fam ily is given by a sem i-algebraic subset of the parameter space of a regular exponential fam ily. However, this parameter space m ay be obtained by a reparametrization g of the natural parameter space N, which

provides the necessary exibility to capture the algebraic structure found in interesting statistical models including ones that do not form curved exponential families. The mean parametrization () is one example of a useful reparametrization.

B efore giving examples of algebraic exponential families we provide som e background on sem i-algebraic sets; more in depth introductions can be found, for example, in B enedetti and R isler (1990) or B ochnak et al. (1998).

3.1. Basic facts about sem i-algebraic sets

A monom ial in indeterm inates (polynom ial variables) t_1 ;:::; t_n , is a form al expression of the form $t = t_1^{-1}t_2^{-2}$ n^n to here = (1;:::;n) is the non-negative integer vector of exponents. A polynom ial

$$f = ct$$

is a linear combination of monomials where the coe cients c are in a xed eld K and B N^n is a nite set of exponent vectors. The collection of all polynomials in the indeterminates $t_1; :::; t_n$ with coe cients in a xed eld K is the set K $[t] = K [t_1; :::; t_n]$. The collection of polynomials K [t] has the algebraic structure of a ring. Each polynomial in K [t] is a form all linear combination of monomials that can also be considered as a function f : Kⁿ ! K, de ned by evaluation. Throughout the paper, we will focus attention on the ring R [t] of polynomials with real coe cients.

De nition 10. A basic sem i-algebraic set is a subset of points in Rⁿ of the form

$$A = f 2 R^{n} jf() > 08f2F; h() = 08h2Hg$$

where F = R[t] is a nite (possibly empty) collection of polynomials and H = R[t] is an arbitrary (possibly empty) collection of polynomials. A sem i-algebraic set is a nite union of basic sem i-algebraic sets. If F = i then A is called a real algebraic variety.

A particular special case of a general sem i-algebraic set occurs when we consider sets of the form

$$A = f 2 R^{n} jf() > 08f2 F; g() 08g2 G; h() = 08h2 Hg$$

where both F and G are nite collections of real polynom ials.

Example 11. The open probability simplex for discrete random variables is a basic sem ialgebraic set, where $F = ft_i ji = 1; :::; n \quad lg [f1 \overset{P}{\underset{i=1}{}^{n-1}} t_i g and H = ;. M ore generally, the relative interior of any convex polyhedron in any dimension is a basic sem i-algebraic set, while the whole polyhedron is an ordinary sem i-algebraic set.$ Example 12. The set R^{m} of positive denite matrices is a basic sem i-algebraic set, where F consists of all principal subdeterm inants of a symmetric matrix, and G is the empty set.

In our introduction, param etrically speci ed statisticalm odels were claim ed to be algebraic statisticalm odels. This non-trivial claim holds due to the fam ous Tarski-Seidenberg theorem (e.g. Bochnak et al., 1998), which says that the im age of a sem i-algebraic set under any nice enough m apping is again a sem i-algebraic set. To m ake this precise we need to de ne the class of m appings of interest.

Let $_1 = f_1=g_1; :::; _n = f_n=g_n$ be rational functions where $f_i;g_i \in \mathbb{R}$ [t] = R [t_1;:::;t_d] are real polynom ial functions. These rational functions can be used to de ne a rational map

 $: \mathbb{R}^{d} ! \mathbb{R}^{n}; a ? (_{1}(a); ...; _{n}(a));$

which is well-de ned on the open set $D = fa \quad R^d : \overset{Q}{:} g_i(a) \in 0g$.

Theorem 13 (Tarski-Seidenberg). Let $A = R^d$ be a sem i-algebraic set and a rational map that is well-de ned on A, that is, A = D. Then the image (A) is a sem i-algebraic set.

Pachter and Sturm fels (2005) de ne an algebraic statistical model as the image of a polynom ial parametrization (A) where A is the interior of a polyhedron and is the probability simplex. The emphasis on such models, which one might call parametric algebraic statistical models, results from the fact that most models used in the biological applications under consideration (sequence alignment and phylogenetic tree reconstruction, to name two) are parametric models for discrete random variables. Furthermore, the precise algebraic form of these parametric models is essential to parametric maximum a posteriori estimation, one of the major themes in the text of Pachter and Sturm fels (2005). The Tarski-Seidenberg theorem and Example 4 yield the follow ing unifying fact.

C orollary 14. If a parametric statistical model for discrete random variables is a wellde ned image of a rational map from a sem i-algebraic set to the probability simplex, then the model is an algebraic exponential family.

3.2. Independence m odels as exam ples

M any statistical m odels are de ned based on considerations of (conditional) independence. E xam ples include M arkov chain m odels, m odels for testing independence hypotheses in contingency tables and graphical m odels, see e.g. Lauritzen (1996). A swe show next, conditional independence yields algebraic exponential fam ilies in both the G aussian and discrete cases. The algebraic structure also passes through under m arginalization, as we will illustrate in Section 4. Example 15 (C onditional independence in norm ald istributions). Let $X = (X_1; :::; X_p)$ be a random vector with joint norm ald istribution $N_p(;)$ with mean vector 2 R^p and positive de nite covariance matrix . For three pairwise disjoint index sets A; B; C f1; :::; pg, the subvectors X_A and X_B are conditionally independent given X_C , in symbols $X_A ?: X_B j X_C$ if and only if

If C = ;, then conditional independence given X , is understood to m ean m arginal independence of X $_{\rm A}$ and X $_{\rm B}$. $\hfill \Box$

E xam ple 16 (C onditional independence in the discrete case). C onditional independence statem ents also have a natural algebraic interpretation in the discrete case. A s the sim plest exam ple, consider the conditional independence statem ent X₁ ? X₂ jX₃ for the discrete random vector (X₁;X₂;X₃). This translates into the collection of algebraic constraints on the joint probability distribution

where p_{ijk} is shorthand for Prob(X₁ = $i;X_2 = j;X_3 = k$). In general, any collection of conditional independence statements for discrete random variables corresponds to a collection of quadratic polynom ial constraints on the components of the joint probability vector.

4. M odel geom etry

O ffundam ental importance to statistical inference is the intuitive notion of the \shape" of a statistical model, rejected in its abstract geometrical properties. Examples of interesting geometrical features are whether or not the likelihood function is multimodal, whether or not the model has singularities (is non-regular) and the nature of the underlying singularities. These are all part of answering the question: How does the geometry of the model reject its statistical features? When the model is an algebraic exponential family, these problems can be addressed using algebraic techniques, in particular by computing with ideals. This is even true when the model comes in a parametric form, however, it is then often helpful to translate to an implicit representation of the model.

4.1 M odel invariants

Recall that an ideal I R[t] is a collection of polynom ials such that for all f;g 2 I, f + g 2 I and for all f 2 I and h 2 R[t], h f 2 I. Ideals can be used to determ ine real algebraic varieties by computing the zero set of the ideal:

W hen we wish to speak of the variety over the complex numbers we use the notation V_C (I). Reversing this procedure, if we are given a set $V = R^n$ we can compute its dening ideal, which is the set of all polynom ials that vanish on V:

De nition 17. Let A be a sem i-algebraic set de ning an algebraic exponential fam ily $P_M = (P j 2 M)$ via $M = g^1 (A \setminus g(N))$. A polynom ial f in the vanishing ideal I (A) is a model invariant for P_M .

R em ark 18. The term \m odel invariant" is chosen in analogy to the term \phylogenetic invariant" that was coined by biologists working with statistical m odels that are useful for the reconstruction of phylogenetic trees.

G iven a list of polynom

The H ilbert basis theorem says that every ideal in a polynom ial ring has a nite generating set. Thus, when working with a statistical model that we want to describe algebraically, we need to compute a nite list of polynom ials that generate the ideal of model invariants. These equations can be used to address questions like determining the structure of singularities which in turn can be used to address asymptotic questions.

E xam ple 19 (C onditional independence). In E xam ple 15 we gave a set of equations whose zero set in the cone of positive de nite matrices is the independence model obtained from $X_A ?? X_B j X_C$. However, there are more equations, in general, that belong to the ideal of model invariants I. In particular, we have

 is a ($jCj+1$) ($jCj+1$) submatrix of $A[C;B[C]$:

The fact that this ideal vanishes on the model follows from the fact that any in the model is positive de nite and, hence, each principalm inor is invertible. The fact that the

indicated ideal comprises all model invariants can be derived from a result in commutative algebra (Conca, 1994).

In the discrete case, the polynom ials we introduced in Example 16 generate the ideal of model invariants for the model induced by $X_1 ?? X_2 j X_3$. For models induced by collections of independence statements this need no longer be true; compare Theorem 8 in G arcia et al. (2005).

One may wonder what the use of passing from the set of polynomials exhibited in Example 15 to the considerably larger set of polynomials described in Example 19 is, since both sets of polynomials de nethermodel inside the cone of positive de nitermatrices. The smaller set of polynomials have the property that there lie singular covariance matrices in the positive sem ide nite cone that satisfy the polynomial constraints but are not limits of covariance matrices in the model. From an algebraic standpoint, the main problem is that the ideal generated by the smaller set of polynomials is not a prime ideal. In general, we prefer to work with the prime ideal given by all model invariants because prime ideals tend to be better behaved from a computational standpoint and are less likely to introduce extraneous solutions on boundaries.

For the conditional independence m odels described thus far, the equations I (A) that de ne the m odel come from the de nition of the m odel. For instance, conditional independence im poses natural constraints on covariance m atrices of norm alrandom variables and the joint probability distributions of discrete random variables. W hen we are presented w ith a parametric m odel, how ever, it is in general a challenging problem of com putational algebra to com pute the implicit description of the m odel A as a sem i-algebraic set. At the heart of this problem is the com putation of the ideal of m odel invariants I (A), which can be solved using G robner bases. M ethods for com puting an implicit description from a parametric description can be found in C ox et al. (1997), though the quest for better implicitization m ethods is an active area of research.

The vanishing ideal of a sem i-algebraic set can be used to address many questions about it, for instance, the dimension of a sem i-algebraic set. The following de nition and proposition provide a useful characterization of the dimension of a sem i-algebraic set.

Denition 20. A set of indeterm inates p_{i_1} ; ...; p_{i_k} is algebraically independent for the ideal I if there is no polynom ial only in p_{i_1} ; ...; p_{i_k} that belongs to I.

P roposition 21. The dimension of a sem i-algebraic set A is the cardinality of the largest set of algebraically independent indeterm inates for I(A).

The proof that algebraically independent sets of indeterm inates and Proposition 21 m eshes with the usual geometric notion of dimension can be found in C ox et al. (1997).

The subset $V_{sing} = V$ where a variety V is singular is also a variety. Indeed, suppose that polynom ials f_1 ;:::; f_k generate the vanishing ideal I (V). Let J 2 R $[x]^k$ a denote the Jacobian matrix with entry $J_{ij} = \frac{df_i}{dx_j}$.

P roposition 22. A point a 2 V_C (I) is a singular point of the complex variety if and only if J (a) has rank less than the codim ension of the largest irreducible component of V containing a.

The singularities of the real variety are dened to be the intersection of the singular locus of V_C (I) with R^n . Proposition 22 yields a direct way to compute, as an algebraic variety, the singular locus of V. Indeed, the rank of the Jacobian matrix is less than c, if and only if the c cm inors of J are all zero. Thus, if I denes an irreducible variety of codimension c, the ideal $M_C(J)$; f_1 ; :::; f_k i has as zero set the singular locus of V, where $M_C(J)$ denotes the set of c cm inors of J. If the variety is not irreducible, the singular set consists of the union of the singular set of all the irreducible components together with the sets of all pairwise intersections between irreducible components.

Removing the singularities V_{sing} from V one obtains a smooth manifold such that the local geometry at a non-singular point of V is determined by a linear space, namely, the tangent space. At singular points, the local geometry can be described using the tangent cone, which is the semi-algebraic set that approximates the limiting behavior of the secant lines that pass through the point of interest. In the context of parameter spaces of statistical models, the study of this limiting behavior is crucial for the study of large sample asymptotics at a singular point. The geometry of the tangent cone for semi-algebraic sets can be complicated and we postpone an in-depth study for a later publication. For the singular models that we encounter in the next section, the crucial point on the tangent cone is the follow ing proposition.

P roposition 23. Suppose that $A = V_1 \begin{bmatrix} & & \\ & & \\ & & \\ \end{pmatrix}$ Such that a \mathcal{B} V_k for k = j + 1. Then the tangent cone of A at a is the union of the tangent planes to V_1 ;:::; V_j at a.

4.2 A conditional independence model with singularities

Let $X = (X_1; X_2; X_3)$ have a trivariate norm all distribution N_3 (;), and de ne a model by requiring that X_1 ? X_2 and simultaneously X_1 ? X_2 j X_3 . By Example 15, the model is an algebraic exponential family given by the subset $M = {}^1(A \setminus N)$, where

If (;) is an element of the smooth manifold A nA $_{sing}$, then $_{M}$ (X;S) converges to a $_{2}^{2}$ -distribution as n tends to in nity; but over the singular locus the limiting distribution is non-standard as detailed in D rton (2006).

Proposition 24. Let (;) 2 A sing. As n ! 1, the likelihood ratio test statistic M (X;S) converges to the minimum of two dependent $\frac{2}{2}$ -distributed random variables, namely,

Similar asymptotics arise in the model of joint marginal and conditional independence in the discrete case with X₃ binary. In this case the variety breaks again into the union of two independence varieties X₁? fX_2 ; X₃g and X₂? fX_1 ; X₃g, whose intersection is the complete independence variety corresponding to X₁? X₂? X₃. Non-standard asymptotics will occur at the intersection of these two varieties. However, as both of the varieties X₁? fX_2 ; X₃g and X₂? fX_1 ; X₃g are smooth, the tangent cone is simply the union of the two tangent spaces to the two component varieties. The asymptotics behave in a manner similar to the G aussian case, as the minimum of chi-square distributions.

4.3 Hidden random variables

A nother in portant use for the in plicit equations de ning a model are that they can be used to determ ine a (partial) description of any new models that arise from the given model via marginalization. In particular, algebraic methods can be used to explore properties of models with hidden random variables. In this section, we describe how to derive model invariants via elimination in the presence of hidden variables for Gaussian and discrete random variables.

P roposition 25. Suppose that the random vector $X = (X_1; :::; X_p)$ is distributed according to a multivariate norm all distribution from a model with ideal of model invariants I R[i; ij j1 i j p]. Then the elimination ideal I \ R[i; ij j1 i j p 1] com - prises the model invariants of the model created by marginalizing to $X^0 = (X_1; :::; X_p)$.

The indicated elim ination can be computed using G robner bases (C ox et al., 1997). A similar type of elimination formulation can be given for the marginalization in the discrete case.

Proposition 26. Let X_1 ;:::; X_p be discrete random variables with X_k taking values in $[m_k] = f1$;:::; m_kg . Consider a model for the random vector $(X_1$;:::; X_p) that has the ideal of model invariants I R $[p_{i_1},...,i_p]$. Let J R $[q_{i_1},...,i_{p-1};p_{i_1},...,i_p]$ be the ideal

Then the elimination ideal $J \setminus R[q_{i_1}, ..., i_{p-1}]$ is the ideal of model invariants of the model created by marginalizing to $X^0 = (X_1; ...; X_{p-1})$.

Up to this point, we have m ade very little use of the inequality constraints that can arise in the de nition of a sem i-algebraic set. In both of our conditional independence m odels, the inequality constraints arose from the fact that we needed to generate a probability distribution, and were supplied by the positive de nite cone or the probability sim plex. In general, how ever, we may need non-trivial inequality constraints to describe the m odel. Currently, very little is known about the needed inequality constraints, even in simple examples. This occurs, for instance, in the marginalization of conditional independence m odels.

Example 27 (M arginalization of an Independence M odel). Let A be the sem i-algebraic set of probability vectors for a discrete random vector $X = (X_1; X_2; X_3)$ satisfying the conditional independence constraint $X_1 ?? X_2 j X_3$. Let (A) denote the image of this m odel after m arginalizing out the random variable X_3 .

The joint distribution of X₁ and X₂ can be represented as a matrix (p_{ij}). A ssum ing as above that X_k takes on values in [m_k], the conditional independence constraint X₁? ? X₂ jX₃ implies that the matrix (p_{ij}) has rank less than or equal to m₃. The set of equality constraints that arise from this parametrization are the set of (m₃ + 1) (m₃ + 1) m inors of the matrix (p_{ij}). However, it is not true that these equality constraints together with the inequality constraints arising from the probability simplex su ce to de ne this model. The smallest example of this occurs when, m₁ = m₂ = 4 and m₃ = 3. In this case the idealI((A)) is generated by the determ inant of the generic 4 4 matrix (p_{ij}). Fix a small value of > 0. The matrix

represents a probability distribution that satis es the determ inant constraint (the matrix has rank 3). However, it can be shown that this probability distribution does not belong to (A). That is, this bivariate distribution is not the marginalization of a trivariate distribution exhibiting conditional independence. Thus, in addition to the equality constraint, there are non-trivial inequality constraints that de ne the marginalized independence model. More about this example can be found in M ond et al. (2003).

5. Solving likelihood equations

Let $P = (P \ j \ 2 \ N)$ be a regular exponential family with canonical su cient statistic T. If we draw a sample X_1 ;:::; X_n of independent random vectors from P, then, as detailed in Section 2, the canonical statistic becomes $P_{i=1}^{n} T(X_{i}) = :nT$ and the log-likelihood function takes the form

For maximum likelihood estimation in an algebraic exponential family $P_M = (P j 2 M)$, M N, we need to maximize '(jT) over the set M.

Let A and g be the sem i-algebraic set and the di eom orphism that de ne the parameter space M. Let I(A) = $hf_1; :::; f_m$ i be the ideal of model invariants and = g() the parameters after reparametrization based on g. If boundary issues are of no concern then the maximization problem can be relaxed to

If (jT) has rational partial derivatives then the maximization problem (5.2) can be solved algebraically by solving a polynomial system of critical equations. Details on this approach in the case of discrete data can be found in Catanese et al. (2006); Hosten et al. (2005). How ever, depending on the interplay of g^{-1} and the mean parametrization , which according to (2.1) is the gradient map of the log-Laplace transform , such an algebraic approach to maximum likelihood estimation is possible also in other algebraic exponential families.

P roposition 28. The function '(jT) has rational partial derivatives if (i) the map g^1 is a rational map and (ii) the map g^1 has partial derivatives that are rational functions.

Example 29 (D iscrete likelihood equations). For the discrete exponential family from Example 4, the mean parameters are the probabilities $p_1; \dots; p_{m-1}$. The inverse of the mean parametrization map has component functions $(^{-1})_x = \log (p_x = p_m)$, where $p_m =$ 1 p_1 m p. Since d log (t)=dt = 1=t is rational, ⁻¹ has rational partial derivatives. Hence, maximum likelihood estimates can be computed algebraically if the discrete algebraic exponential family is de ned in terms of the probability coordinates $p_1; \dots; p_{m-1}$. This is the context of the above mentioned work by Catanese et al. (2006); Hosten et al. (2005).

E xam ple 30 (Factor analysis). The mean parametrization for the family of multivariate norm ald istributions and its inverse 1 are based on matrix inversions and thus are rational

maps. Thus algebraic maximum likelihood estimation is possible whenever a Gaussian algebraic exponential family is de ned in terms of coordinates g() for a rational map g. This includes families de ned in the mean parameters (;) or the natural parameters $\binom{1}{3}$.

As a concrete example, consider the factor analysis model with one factor and four observed variables. In centered form this model is the family of multivariate norm aldistributions N $_4$ (0;) on R 4 with positive de nite covariance matrix

where $! 2 (0;1)^4$ and $2 R^4$. Equation (5.4) involves polynom ial expressions in = (!;). For algebraic maximum likelihood estimation, however, it is computationally more e cient to employ the fact that condition (5.4) is equivalent to requiring that the positive de nite natural parameter 1 can be expressed as

Let S be the empirical covariance matrix from a sample of random vectors X_1 ;:::; X_n in \mathbb{R}^4 ; compare (4.1). We can solve the maximization problem (5.2) by plugging the polynom ialparametric expression for = ¹ from (5.5) into the Gaussian version of the log-likelihood function in (5.3). Taking partial derivatives we not the equations

These equations can be made polynomial by multiplying by det($^{1}()$). Clearing the denominator introduces many additional solutions $2 C^{8}$ to the system, which lead to non-invertible matrices $^{1}()$. However, these extraneous solutions can be removed using an operation called saturation. A fler saturation, the (com plex) solution set of (5.6) is seen to consist of 57 isolated points. These 57 solutions com e in pairs = (!;); one solution has = 0.

W hen the empirical covariance matrix S is rounded then we can compute the 57 solutions using software for algebraic and numerical solving of polynom ial equations. For the example 0 1

The matrix to the left has the larger value of the likelihood function and we claim that it yields the global maximum. For this claim to be valid we have to check that no matrix close to the boundary of the set f¹() j 2 (0;1 f⁴ R⁴g has larger value of the likelihood function. Suppose this was not true. Then the likelihood function would have to achieve its global maximum over the cone of positive de nite matrices outside the set f¹() j 2 (0;1 f⁴ R⁴g. In order to rule out this possibility, we consider all the complex solutions \mathfrak{G} (0;1 f⁴ R⁴ of (5.6) that induce real and positive de nite matrices

 1 (). There are ten such solutions, which allhave ! 2 R⁴ and purely in aginary 2 iR⁴. There are ve di erent induced matrices 1 (), but at all of them the likelihood function is smaller than for the two quoted local maxim izer. This con rm s our claim .

As a second interesting example consider

$$S_{2} = \begin{bmatrix} 0 & & & 1 \\ 31 & 11 & 1 & 5 \\ B & 11 & 23 & 3 & 2C \\ 0 & 1 & 3 & 7 & 1C \\ 5 & 2 & 1 & 7 \end{bmatrix}$$

The equations (5.6) have again 11 feasible solutions $\hat{}$. A spociated are 6 distinct factor analysis covariance matrices that all correspond to saddle points of the likelihood function. Hence, if we close the set of inverse covariance matrices f¹() j 2 (0;1 f R⁴g, then the global optimum of the likelihood function over this closure must be attained on the boundary.

In order to determ ine which boundary solution provides the global maximum of the likelihood function, it is more convenient to switch back to the standard param eterization in (5.4), which writes the covariance matrix as () for = (!;) in (0;1)⁴ R⁴. The closure of f () j 2 (0;1)⁴ R⁴g is obtained by closing the parameter domain to $[0;1)^4$ R⁴. Since S₂ is positive de nite, the global maximizer of the likelihood function must be a matrix of full rank, which in plies that at most one of the four parameters !_i can be zero. In each of the four possible classes of boundary cases the induced likelihood equations (in 7 parameters) have a closed form solution leading to a unique covariance

matrix. We nd that the global maximum is achieved in the case $!_1 = 0$. The global maximizer of the likelihood functions over the closure of the parameter space equals

In the factor analysis literature data leading to such boundary problems are known as H eywood cases. Hence, our computation proves that S_2 constitutes a H eywood case.

6. Conclusion

In this paper, we have attempted to present a useful, uni ed de nition of an algebraic statistical model. In this de nition, an algebraic model is a submodel of a reference model with nice statistical properties. Working primarily with small examples of conditional independence models, we have tried to illustrate how our de nition might be a useful framework, in which the geometry of parameter spaces can be related to properties of statistical inference procedures. Since we im pose algebraic structure, this geometry can be studied using algebraic techniques, which allow one to tack le problem s where simple linear arguments will not work. In order to apply these algebraic techniques in a particular example of interest, one can resort to one of the many software systems, both free and commercial, that provide implementations of algorithms for carrying out the necessary computations. A comprehensive list of useful software can be found in Chapter 2 of Pachter and Sturm fels (2005).

W hile we believe that future work in algebraic statistics m ay involve reference m odels in which the notion of \nice statistical properties" is lled with life in m any di erent ways, we also believe that the m ost in portant class of reference m odels are regular exponential fam ilies. This led us to consider what we term ed algebraic exponential fam ilies. These fam ilies were shown to be exible enough to encom pass structures arising from m arginalization, i.e., the involvement of hidden variables. Hidden variable m odels typically do not form curved exponential fam ilies, which triggered G eiger et al. (2001) to introduce their strati ed exponential fam ilies. These strati ed fam ilies are m ore general than both algebraic and curved exponential fam ilies but, as our E xam ple 9 suggests, they seem in fact to be too general to allow the derivation of results that would hold in the entire class of m odels. In algebraic exponential fam ilies, on the other hand, the restriction to sem ialgebraic sets entails that parameter spaces always have nice local geometric properties and phenom ena as created in E xam ple 9 cannot occur. In light of this fact, our algebraic exponential fam ilies appear to be in particular a good fram ework for the study of hidden variable m odels, which are widely used m odels whose statistical properties have yet to be understood in entirety.
