H yperbolic buildings, a ne buildings and autom atic groups

A b stract. We see that a building whose C oxeter group is hyperbolic is itself hyperbolic. Thus any nitely generated group acting co-compactly on such a building is hyperbolic, hence automatic. We turn our attention to a nebuildings and consider a group which acts simply transitively and in a \type-rotating" way on the vertices of a locally nite thick building of type A_n . We show that is biautomatic, using a presentation of and unique normal form for each element of , as described in [5].

x1. Introduction.

Two standard references for the theory of automatic groups are the book [11] and the paper [2], which both contain numerous examples of automatic groups. Perhaps the \canonical" class of automatic groups is the class of word hyperbolic groups of Gromovetal. [14]. As we shall see in Section 3, any building whose underlying Coxeter group is word hyperbolic is itself hyperbolic in the word metric. In particular any nitely generated group acting co-compactly with nite stabilizers on such a building is word hyperbolic and thus automatic. Thus, from the viewpoint of automatic groups, it is natural to look next at actions on a ne buildings.

The rst result in this direction is provided by G ersten and Short [12] who prove that a nitely generated torsion free group that acts co-com pactly discretely by isom etries on a Euclidean building of dimension 2 is automatic. It has often seemed likely that the restriction on dimension could be lifted. In this paper, we prove this for nitely generated groups which act simply transitively (and in a type-rotating way) on the vertices of a thick building of type \hat{A}_n . We call such groups \hat{A}_n -groups. In fact, we will show more. We shall see that these groups are biautomatic. The structure in question is a symmetric automatic structure [11]. (The term \fully automatic" is used in [7] and early versions of [11].) In particular this implies that \hat{A}_n -groups have solvable conjugacy problem [13]. Further, the structure consists of geodesics, and thus these groups have rational growth functions. Examples of nitely generated \hat{A}_n -groups are known in dimensions n=2 [6], n=3;4 [5] and n=5 [Cartwright, unpublished], and for n=2;3;4 and for any prime power q there are examples of \hat{A}_n -groups which are arithmetic lattices in PGL $(n+1;F_q(X))$). It remains an open problem whether \hat{A}_n -groups exist for every n.

The paper is organized as follows. Section 2 de nes hyperbolic groups and reviews some basic background information, most of which can be found in [1]. In Section 3 we show

that a building is hyperbolic (in an appropriate sense) if and only if its underlying C oxeter group is hyperbolic. Section 4 de nes \bar{A}_n -groups and reviews the necessary background from [5]. Section 5 gives the proof that nitely generated \bar{A}_n -groups are bi-automatic. Sections 4 and 5 require no knowledge of buildings, Section 3 uses elementary results which can be found in [3, IV 3].

x2. H yperbolic groups

We say that a metric space (X;d) is a geodesic metric space if for every x;y 2 X, there is a path from x to y which realizes their distance. Such a path is called a geodesic. Following [14] we say that a geodesic metric space is -hyperbolic if whenever P is a point on side of a geodesic triangle with sides , , and , there is a point Q on [so that d(P;Q) . We say that (X;d) is hyperbolic if it is -hyperbolic for some .

Now given any connected graph—there is a natural metric on . Take each edge of to be isometric to the unit interval and take the path metric which this induces on . Further, given any nitely generated group G, the choice of a nite generating set $G = fa_1; \ldots; a_k g$ turns G into a directed labelled connected graph = $_G$. The vertices of are the elements of G and the edges of are f(g;ga) jg 2 G; a 2 Gg. We direct the edge (g;ga) from g to ga and label it with a. We assume that G is closed under inverses and identify (g;ga) with the inverse of (ga;g). is called the Cayley graph of G with respect to G.

We say that G is hyperbolic if = G is hyperbolic. While this appears to depend on G, in fact only the particular value of depends on G.

We will want a standard fact about hyperbolic metric spaces. Given a path in X and 0 < 1 and 0, we will say that is a (;)-quasigeodesic if for every decomposition , the endpoints of are separated by at least '() . (Here '()) denotes the length of .) If X is a hyperbolic metric space then there is N = N (;;) so that if is a (;)-quasigeodesic and is a geodesic with the same endpoints, then and each lie in the N-neighborhood of each other [1, 3.3]. Geodesics are simply (1;0)-quasigeodesics, and thus there is N = N (;1;0) so that all geodesics joining common endpoints live in a N-neighborhood of each other. We call a pair of geodesics with common endpoints a bigon.

From this one can construct a proof that any geodesic metric space quasi-isometric to a hyperbolic space is itself hyperbolic, and that in particular, hyperbolicity of a group is independent of generating set. Now it is a standard result that if a nitely generated group G acts co-compactly by isometries and with nite stabilizers on a geodesic metric space (X;g), then every G ayley graph of G is quasi-isometric to G. (See, for example, [4].) In particular, when G is hyperbolic, so is G.

We have seen that the de nition of a hyperbolic metric space requires checking that geodesic triangles are \thin", that is, that no side of a triangle is ever far from the union of the other two sides. Papasoglu [16], [17], has shown that in graphs it is only necessary to check bigons. Note that the endpoints of geodesics (and hence the endpoints of bigons) need not be vertices of .

Theorem. (Papasoglu) Suppose that is a graph and there is a constant K so that if , 0 is a bigon, then and 0 each lie in a K-neighborhood of each other. Then is

hyperbolic.

Notice that the hypothesis is equivalent to the a priori stronger hypothesis that there exists K 0 so that if and 0 form a bigon then for all t, d((t); 0 (t)) K 0 . For suppose that (t) is within K of 0 (t 0). Then the fact that these are geodesics emanating from a common point allows us to use the triangle inequality to see that t t 0 j K . Hence, taking K 0 = 2K , we have d((t); 0 (t)) K 0 .

x3. H yperbolic buildings

In his doctoral thesis [15], Moussong constructs actions of Coxeter groups on non-positively curved geodesic metric spaces. An account of this metric can be found in [9]. The metric spaces in question are locally Euclidean or locally hyperbolic complexes, and can be made negatively curved if and only if the Coxeter group in question is word hyperbolic. The actions are co-compact, by isometries and with nite stabilizers. As a scholium of his construction, one knows exactly which Coxeter groups are word hyperbolic.

Theorem (Moussong) Let (W;S) be a Coxeter system. Then the following are equivalent: 1. W is word hyperbolic.

- 2. W has no Z Z subgroup.
- 3. (W;S) does not contain a a ne sub-C oxeter system of rank 3, and does not contain a pair of disjoint commuting sub-C oxeter systems whose groups are both in nite.

Charmey and Davis [8] have pointed out that using Moussong's metric of non-positive curvature, one can give a building a metric of non-positive curvature, and that the metric on the building is negatively curved if and only if the Coxeter group is word hyperbolic. (Construction of the metric on the building can be done along the lines of [3, VI3].)

We give a sim ilar characterization in terms of graphs. Given a building , there is a metric on the set of chambers of , and we will want a path metric space which rejects this metric. To do this we let 0 be the graph dual to . That is to say, the vertices of 0 are the barycenters of the chambers of . Two such vertices are connected by an edge when they lie in chambers with a common face. As usual, 0 is metrized considering each edge as isometric to the unit interval. Non-stuttering galleries of correspond to edgepaths in 0 . The decomposition of into apartments induces a decomposition of into apartments which are isometric as labelled graphs to the C ayley graph of (W;S), the C oxeter system of .

Theorem 1. Suppose is a building whose apartments are the Coxeter complex of a word hyperbolic Coxeter group. Then $^{\,0}$ is hyperbolic.

R em ark. The converse is also true. That is, if 0 is hyperbolic, the associated C oxeter group is word hyperbolic. This follows im mediately from the fact that the embedding of the C ayley graph into 0 is an isometry.

Corollary. Suppose is a building whose apartments are the Coxeter complex of a word hyperbolic Coxeter group and that G is a nitely generated group which acts simplicially, co-compactly with nite stabilizers on . Then G is word hyperbolic.


Proof. G acts on , and the natural embedding of 0 into is equivariant with respect to this action. This induces an action of G on 0 . Since there are nitely many G-orbits

of cham bers of and nitely many G-orbits of codim ension 1 faces, the induced action on 0 is co-compact. Now G carries edges of 0 to edges of 0 and thus acts by isometries of the graph metric. Since the action of G has nite stabilizers, the (setwise) stabilizer of each chamber and co-dimension 1 face of is nite. These are the stabilizers of the vertices and edges of 0 . Hence, as we have outlined in Section 2, G is quasi-isometric to 0 and thus word hyperbolic.

Proof of Theorem 1. To prove the Theorem, we consider a bigon , ⁰. It su ces to show that there is K so that if C is any point of , then C is within K of ⁰. We distinguish three cases depending on whether both, one, or neither of the endpoints of this bigon are vertices.

Case 1: Both ends of the bigon are vertices. Now given any two chambers of , there is an apartment containing them both. Any geodesic gallery in connecting these two chambers lies in . (See [3,p.88].) It now follows that and 0 lie in a common apartment of 0 , and by the hyperbolicity of the underlying Coxeter group, we are done.

Case 2: The geodesics and 0 begin at a vertex, but do not end at a vertex. We let x and x^{0} be the beginning and endpoints of our bigon. We let y and z be the last vertices of and 0 respectively, and let and 0 be the initial segments of and 0 ending at y and z respectively. It now follows that '() = '(0) and that x^{0} is the midpoint of an edge e. If y = z, and 0 lie in a common apartment, and we are done by Case 1. Thus we may assume $y \in z$. Now and 0 cannot lie in a common apartment. For if this were so, e 01 would label a relator of odd length in the underlying Coxeter group, and this is impossible.




Let be an apartment containing. We consider C = (t) and may suppose this is a vertex lying on. We let $= ;_C$ be the retraction onto centered at C. (See, for example [3, IV.3].) Now d(y; (z)) 1 and since does not increase distance, we have

$$n - 1 - d(x; (z)) - n$$

where n = '(). Now consider the path $(^{0})$. This may not be an edge path, as some edge of 0 may be folded by . However its length as a path is still n. We thus have a path of length n whose endpoints lie at distance at least n 1. It follows that $(^{0})$ is a (1;1)-quasigeodesic. Since $(^{0})$ lies in , it now follows from the hyperbolicity of that $(^{0})$ lies close to . We can thus not $C^{0} = ^{0}(t^{0})$ so that (C^{0}) lies close to C^{0} . Since C^{0} preserves distance from C^{0} , C^{0} lies close to C^{0} and we are done.

C ase 3: Neither end of the bigon is a vertex. In this case we let a and b, (respectively a^0 and b^0) be the rst and last vertices of (respectively a^0), and let (respectively a^0)

be the segment of (respectively 0) connecting these rst and last vertices. If $a=a^0$ or $b=b^0$ or both we are reduced to previous cases, so we can assume $a \in a^0$ and $b \in b^0$. We let e be the edge from a to a^0 and e^0 be the edge from e to e0. It is easy to check that e0 is e1. We let e2 be a geodesic from e3 to e6.



If $d(a;b^0) = n + 1$ then $e^{0.1}$ and form a bigon whose ends are the vertices a and b. If $d(a;b^0) = n$, we let y and y^0 be the m idpoints of e and e^0 . We then have a bigon whose ends are a and y^0 whose sides consist of and , each with a half of e^0 appended. Similarly, we have a bigon with ends b^0 and y and sides e^0 and e^0 with the halves of e appended. Now we can apply C ase 2 twice.

Finally, if $d(a;b^0) = n+1$ then and e^0 form a bigon as do and e^0 , and once again we can apply C ase 1 twice.

$x4. R eview of \mathcal{R}_n$ -groups.

 A_n -groups were introduced for general n-2 in [5], after earlier work on the case n=2 in [6]. (One dimensional buildings are trees, and thus hyperbolic.) Recall that a building is a labellable complex, that is, that each vertex v of a building of type A_n has a type (v) 2 f0;1;:::;ng, with each chamber having one vertex of each type. If g is an automorphism of , and if there is an integer c such that gv = v + c (mod n+1) for each vertex v, then g is called type-rotating. Such automorphisms some a subgroup of index at most 2 in the group of all automorphisms of .

If K is a eld with discrete valuation, then there is a thick building $_{\rm K}$ of type ${\mbox{\mbox{$\mbox{Λ}}}}_n$ associated with K [18, Section 9.2], [3, Section V .8], and the group PGL (n + 1;K) acts transitively and in a type-rotating way on $_{\rm K}$.

A group is said to be an \mathcal{R}_n -group if it acts $\sin p \ln t$ transitively on the vertices of a thick building of type \mathcal{R}_n in a type-rotating way.

We now describe A_n -groups. Let be a projective geometry of dimension n 2 (see [10, p. 24] or [19, p. 105], for example). For i=1;:::;n, let i=1,2:dim(x)=ig. To avoid unnecessary abstraction, the readermay assume that is the set (V) (partially ordered by inclusion) of nontrivial proper subspaces of an n+1-dimensional vector space V over a eld k, and that dim(x) refers to the dimension of the subspace x of V. For when n=1, or when n=1 and is desarguesian, must be isomorphic to (V) for some V ([10, pp. 27{28] or [19, p. 203]). Let :! be an involution such that (i=1)=1

for i=1;:::;n, and let T is an \tilde{A}_n -triangle presentation compatible with . This means that T is a set of triples (u;v;w), where u;v;w 2 , such that

- (A) given u; v2 , then (u; v; w) 2 T for som e w 2 if and only if (u) and v are distinct and incident;
- (B) if (u;v;w)2 T, then (v;w;u)2 T;
- (C) if $(u; v; w_1) 2 T$ and $(u; v; w_2) 2 T$, then $w_1 = w_2$;
- (D) if (u;v;w) 2 T, then ((w);(v);(u)) 2 T;
- (E) if (u; v; w) 2 T, then dim (u) + dim (v) + dim (w) = n + 1 or 2(n + 1);
- (F) if $(x;y;u) 2 T^0$ and $(x^0;y^0; (u)) 2 T^0$, then for som ew 2 we have $(y^0;x;w) 2 T^0$ and $(y;x^0; (w)) 2 T^0$.

Here T 0 denotes the \half' of T consisting of the triples (u;v;w) 2 T for which dim (u) + dim (v) + dim (w) = n + 1. G iven u;v 2 , then (u;v;w) 2 T 0 for some w 2 if and only if (u) $^{\circ}$ v. We also write T 0 for T n T 0 .

We form the associated group T with a generating set indexed by :

It was shown in [5] that the Cayley graph of $_{\rm T}$ with respect to the generators $a_{\rm v}$, v 2 , is the 1-skeleton of a thick building $_{\rm T}$ of type $\mbox{\mbox{\it A}}_{\rm n}$. Clearly, $_{\rm T}$ acts, by left multiplication, simply transitively on the set of vertices of $_{\rm T}$. Conversely, if is a group of typerotating automorphisms of a thick building of type $\mbox{\mbox{\it A}}_{\rm n}$, and acts $\mbox{sim}\,{\rm ply}$ transitively on the vertices of , then = $_{\rm T}$ and = $_{\rm T}$ for some $\mbox{\mbox{\it A}}_{\rm n}$ -triangle presentation T . This generalized earlier work on the case n = 2 [6].

In this paper, is assumed nite. The number of x 2 $_1$ incident with any given y 2 $_2$ is denoted q+1, and is independent of y. Here q is called the order of , and when = (V), q is the number of elements in the eld k. It remains an open problem whether A_n -triangle presentations exist for every n. They have been found when = (V) for n = 2 [6] and for n = 3;4 [5] for any prime power q, and for n = 5 and q = 2 [Cartwright, unpublished].

Let L denote the set of all strings u_1u_2 ower such that $(u_i) + u_{i+1} = V$ for $i=1;\ldots;$ 1. (The notation assumes that =(V), but in general, $(u_i) + u_{i+1} = V$ is interpreted as \there is no x 2 such that (u_i) x and u_{i+1} x, where we write y x if x and y are incident, and dim (y) dim (x).) Theorem 2.2 in [5] states that $u=u_1$ \tag{7} to $u=a_{u_1}$ \tag{a} as a bijection L! \tag{7}. Moreover, in the notation of [11], each string u_1 \tag{2} L is geodesic, and so the number is the word length y=0 in the strings in L as being in normal form. When g is the identity element 1, its normal form is the empty word, and its word length is 0, by definition. We write $d(g;g^0)$ for y=0 in the word metric.

x5. Finitely generated \mathbf{A}_n -groups are automatic.

Throughout this section, let = $_{\rm T}$ be a nitely generated $A_{\rm n}$ -group.

We start by showing that L is a regular language. For we can de ne a nite state autom aton M accepting L as follows: the set S of states of M is together with an initial state s_0 (not in) and a single failure state s_1 (not in , and distinct from s_0); the alphabet of M is ; the transition function of M is given by $(s_0;x) = x$ and $(s_1;x) = s_1$ for $x \ge 1$, while for $x \ge 1$, we set $(x \ge 1)$ y if (x) + y = V and $(x \ge 1)$ otherwise; the set Y of accept states of M is $[fs_0g.C.ex]$ by $(s_0;x) = x$ and $(s_1;x) = s_1$ otherwise;


Note that is a set of sem igroup generators for $_{\rm T}$ which is closed under inversion (as a $_{\rm (x)}$ = $a_{\rm x}^{-1}$). Moreover, L has the uniqueness property (i.e., u $_{\rm T}$ u is a bijection L! $_{\rm T}$), is obviously pre x-closed, and is symmetric (i.e., $u_{\rm 1}$ v $_{\rm 2}$ L implies that (u $_{\rm 1}$) $_{\rm 1}$ (u2 L). This last property of L and our Theorem 2 below imply that $_{\rm T}$ is biautomatic, and in fact symmetric automatic or fully automatic.

If $u=u_1$ \ 2 L, let u(0) be the identity element 1 in , and for 1 t ', let u(t) denote the element a_{u_1} u_t and . For t> ', let $u(t)=a_{u_1}$ u_t as u. Let $x \ge 1$, and let v_1 u by the normal form of $\overline{ux}=a_{u_1}$ u and u. By [11, Theorem 2.3.5], to show that u is automatic, it is enough to show that for some u (independent of u and u), u0 (u1) u1) u2. This property is called the u3-fellow traveller property [2]. In fact, we show this property holds for u3.

We start with a lemma which concerns the last of these cases. In this lemma and below, we consistently identify a string u over with its image u in $_{\rm T}$, sometimes writing \u in $_{\rm T}$ " for emphasis, when thinking of u as u.

Lem m a 1. Suppose that u; x 2, and that (u) and x are distinct and nonincident, and that (u) + x = (s) ($6 \ V$). Thus we can write (s; (u); x^0) 2 T 0 and (s; x; (v)) 2 T 0 for som e $x^0; v 2$, and ux = x^0v in . Then x^0v is in normal form. That is, (x^0) + v = V. Conversely, if two triples (s; (u); x^0); (s; x; (v)) 2 T 0 are given, with (x^0) + v = V, then (u) and x m ust be distinct and nonincident, with (u) + x = (s).

We illustrate this lem m a w ith a diagram in the Cayley graph of T:



Proof. Firstly, $(x^0) \in v$. O therw ise, $x^0 = (v)$, and so A xiom s (B) and (C) imply that (u) = x, contrary to hypothesis. We shall henceforth use A xiom s (A) { (E) in the denition of an A_n -triangle presentation without comment, but refer to A xiom (F) when it is used. Next, suppose that $(x^0) \in v$, but that (x^0) and v are incident. Thus $(x^0; v; w) \in v$.

for som e w 2 . If $(x^0;v;w)$ 2 T 0 , then $(w;x^0;v)$ 2 T 0 , (s;x;(v)) 2 T 0 and Axiom (F) imply that (x;w;y) 2 T 0 and $(x^0;s;(y))$ 2 T 0 for som e y 2 . Thus y=u. But then (u;x;w) 2 T, so that (u) and x are incident, contrary to hypothesis. If $(x^0;v;w)$ 2 T 0 , then $(s;(u);x^0)$ 2 T 0 , $((w);(v);(x^0))$ 2 T 0 and Axiom (F) imply that ((v);s;y) 2 T 0 and ((u);(w);(y)) 2 T 0 for som e y 2 . Then y=x, and so (x;w;u) 2 T 0 , so that again (u) and x are incident, contrary to hypothesis.

Suppose that $(x^0) \notin v$, that (x^0) and v are not incident, and that $(x^0) + v = (s^0) \notin V$. So $(s^0; (x^0); x^0) \ge T^0$ and $(s^0; v; (v^0)) \ge T^0$ for som $ex^0; v^0 \ge .$ Now $(s; (u); x^0) \ge T^0$, $(x^0; s^0; (x^0)) \ge T^0$ and A xiom (F) show that $(s^0; s; z) \ge T^0$ and $((u); x^0; (z)) \ge T^0$ for som $ez \ge .$ Sim ilarly, $((v^0); s^0; v) \ge T^0$ and $(s; x; (v)) \ge T^0$ imply that $(x; (v^0); z^0) \ge T^0$ and $(s^0; s; (z^0)) \ge T^0$ for som $ez^0 \ge .$ Thus $(z^0) = z$. Hence $((u); x^0; (z)) \ge T^0$ and $(x; (v^0); (z)) \ge T^0$, so that z (u); x. Hence z (u) + x = (s). But $(s^0; s; z) \ge T^0$ implies that $z \le (s)$. This contradiction completes the proof of the rest part of the lem ma.


Consider the converse part. Firstly, (u) and x m ust be distinct, for otherwise $x^0 = (v)$ m ust hold, which is impossible, because $(x^0) + v = V$. Next, (u) % x cannot hold. For otherwise (u;x;y) 2 T 0 for some y 2 . This, ($(u);x^0;s$) 2 T 0 and A xiom F then imply that (s;x;z) 2 T 0 and $(y;x^0;(z))$ 2 T 0 hold for some z 2 . Thus z = (v), so that $(y;x^0;v)$ 2 T 0 , which implies that (x^0) v, again a contradiction. Similarly, (u) \$ x leads to a contradiction. Finally, the hypotheses imply that (u) + x (s). If $(u) + x \in (s)$, write $(u) + x = (s^0)$, and then we can not $x^0;v^0$ 2 such that $(s^0; (u);x^0);(s^0;x; (v^0))$ 2 T 0 . But then $x^0v = ux = x^0v^0$, and both x^0v and x^0v^0 are in normal form (by the hypotheses, and by the rst part of the lemma, respectively). Uniqueness of normal forms now shows that $x^0 = x^0$, so that $s^0 = s$, a contradiction. This completes the proof.

Lem m a 2. Let u_1 ; u_2 ; x 2 , with u_1u_2 in norm aliform. Then to get the norm aliform of u_1u_2x , there are the following 5 possibilities:

- (1) If $(u_2) + x = V$, then u_1u_2x is in normal form.
- (2) If $(u_2) = x$, then the normal form of u_1u_2x is u_1 .
- (3) If (u_2) % x, then $(u_2;x; (w))$ 2 T 0 for som e w 2 , and the normal form of u_1u_2x is u_1w .
- (4) If (u_2) \$ x, then $(u_2;x; (w))$ 2 T 00 for som e w 2 . Thus $u_1u_2x = u_1w$ in . There are now the following possibilities:
 - (a) Either $(u_1) + w = V$, in which case the normal form of u_1u_2x is u_1w , or
 - (b) (u_1) % w, in which case $(u_1; w; (w^0))$ 2 T 0 for some w^0 2 , and the normal form of u_1u_2x is w^0 , or
 - (c) (u_1) and w are distinct and nonincident, with $(u_1) + w \in V$. Then writing $(u_1) + w = (s^0)$, there are unique w^0 ; $v_1 = v_1 + v_2 = v_3 = v_4 = v_3 = v_4 = v_3 = v_4 = v_3 = v_4 = v_$
- (5) If (u_2) and x are distinct and nonincident, with $(u_2) + x \in V$, then writing $(u_2) + x = (s)$, there are unique x^0 ; $v_2 = such that (s; <math>(u_2)$; x^0) 2 T and $(s; x; (v_2))$ 2 T . Thus $u_1u_2x = u_1x^0v_2$ in . There are now the following possibilities:
 - (a) Either $(u_1) + x^0 = V$, in which case the normal form of $u_1 u_2 x$ is $u_1 x^0 v_2$, or

- (b) (u_1) % x^0 , in which case $(u_1; x^0; (w^0))$ 2 T 0 for som e w^0 2 , and the normal form of u_1u_2x is w^0v_2 , or
- (c) (u_1) and x^0 are distinct and nonincident, with $(u_1) + x^0 \in V$. Then writing $(u_1) + x^0 = (s^0)$, there are unique x^0 ; $v_1 = v_2$ such that $(s^0; (u_1); x^0) = v_1 = v_2$ and $(s^0; x^0; (v_1)) = v_2 = v_3 = v_3 = v_4$.

W e illustrate the more complicated cases:



Proof. The assertions in (1) and (2) are obvious.

Let us consider the situation in (3). Then $(u_2; x; (w)) \ge T^0$ implies that $w = u_2$. Thus $(u_1) + w = (u_1) + u_2 = V$, and so u_1w is in normal form.

Let us consider the situation in (4). In this case, again w \in (u₁). For otherwise, (u₂;x;u₁) = (u₂;x; (w)) 2 T ⁰, contradicting the hypothesis that u₁u₂ is in normal form. Also, (u₁) \$ w cannot hold. For otherwise, ((w); (u₁);w⁰) 2 T ⁰ for som e w ⁰ 2 . Now ((x); (u₂);w) 2 T ⁰, ((u₁);w⁰; (w)) 2 T ⁰ and Axiom (F) in ply that (w⁰; (x);y) and ((u₂); (u₁); (y)) are in T ⁰ for som e y 2 . This again contradicts the hypothesis that u₁u₂ is in normal form. We are left with the three possibilities 4(a), 4(b) and 4(c). The assertions in 4(a) and 4(b) are obvious, while in 4(c), the fact that the word w ⁰v₁ is in normal form is in mediate from Lemma 1.

Let us consider the situation in (5). In this case, (u_1) cannot equal x^0 . For otherw ise $(s; (u_2); (u_1)) = (s; (u_2); x^0) 2 T^0$, which contradicts the hypothesis that u_1u_2 is in normal form. Also, $(u_1) \$ x^0 cannot happen. For otherw ise, $((x^0); (u_1); w^0) \$ $2 T^0$ for some $w^0 \$ 2. Now $(s; (u_2); x^0) \$ $2 T^0$, $((u_1); w^0; (x^0)) \$ $2 T^0$ and Axiom (F) imply that $(w^0; s; y) \$ $2 T^0$ and $((u_2); (u_1); (y)) \$ $2 T^0$ for some y y . This last fact again contradicts the hypothesis that (u_1u_2) is in normal form. We are left with the three possibilities (u_1u_2) is obvious, by Lemma 1.

Consider the situation in 5 (b). First notice that $(x^0; (w^0); u_1); (x^0; s; (u_2))$ 2 T 0 and the converse part of Lem m a 1 im ply that $(w^0) + s = (x^0)$. As $(s; x; (v_2))$ 2 T 0 , we have

 v_2 s, and so $(w^0) + v_2 = (w^0) + s + v_2 = (x^0) + v_2 = V$, the last equation holding by Lem m a 1. So w^0v_2 is in norm al form .

Finally, consider the situation in 5(c). First observe that $(v_1) + s = (x^0)$. This follows from the converse part of Lem m a 1, because $(x^0; (v_1); s^0); (x^0; s; (u_2))$ 2 T 0 , and because, using $(s^0; (u_1); x^0)$ 2 T 0 , we have $(s^0) + u_2 = (u_1) + u_2 = V$. Now $(s; x; (v_2))$ 2 T 0 , so that $v_2 = s$. Hence $(v_1) + v_2 = (v_1) + s + v_2 = (x^0) + v_2 = V$, the last equation holding by Lem m a 1. Lem m a 1 also shows that $(x^0) + v_1 = V$, and so $x^0v_1v_2$ is in norm alform.

Remark. In later work, we shall need a converse to Lemma 2. Let us write $x + {}^0y = z$ for x;y;z 2 if x;y are distinct and nonincident, with x + y = z. Then by the converse part of Lemma 1, we have $(w^0) + {}^0(x) = (w)$ in part 4(b), $(v_1) + {}^0(x) = (w)$ in part 4(c), $(w^0) + {}^0s = (x^0)$ in part 5(b) and $(v_1) + {}^0s = (x^0)$ in part 5(c). Provided these conditions are added, the converses of parts (4) and (5) hold. For example, for 5(b), if $u_1; u_2; x; s; x^0; v_2; w^0$ 2 and triples (s; $(u_2); x^0); (s; x; (v_2))$ 2 T are given with $(w^0) + {}^0s = (x^0)$ and $(w^0) + v_2 = V$, then u_1u_2 is in normal form and $(u_2) + {}^0x = (s)$. The rst of these is immediate from Lemma 1, since $(x^0; (w^0); u_1); (x^0; s; (u_2))$ 2 T 0 . To see that $(u_2) + {}^0x = (s)$, notice that $(x^0) + v_2 = V$, and so the converse part of Lemma 1 is applicable.

The normal form $v_1 = k \text{ of } a_{u_1} = u \cdot \mathbf{a}_x$.

We can now describe how to obtain the normal form v_1 $_k$ or $\overline{ux} = a_{u_1}$ $_u \cdot a_x$, given u_1 $\cdot 2$ L and $x \cdot 2$. When $(u \cdot) + x = V$, this is obviously u_1 $\cdot xu$ If $(u \cdot) = x$, then the normal form of \overline{ux} is clearly u_1 $\cdot u$. When $(u \cdot) \cdot x$, then $(u \cdot x; (w)) \cdot 2$ T 0 for som $e \cdot w \cdot 2$, and the normal form of \overline{ux} is $u \cdot u$. When $(u \cdot x; (w)) \cdot 2$ T 0 for som $e \cdot w \cdot 2$, and the normal form of \overline{ux} is $u \cdot u$.

Then by part (5) of Lem m a 2, either the word on the right in (4.1) is in norm all form , or $(u \cdot i)$ % x_i , in which case $(u \cdot i; x_i; (w))$ 2 T 0 for som e w 2 , and the norm all form of \overline{ux} is
