





























The STRUCTURE of BRANCH ING in ANOSOV FLOW S of 3-M AN IFOLD S

1 Introduction

In this article we study the topological structure of the lifts to the universal of the stable and unstable foliations of 3-dimensional Anosov ows. In particular we consider the case when these foliations do not have H ausdor leaf space. We completely determ ine the structure of the set of non separated leaves from a given leaf in one of these foliations. As a consequence of this suspensions are characterized, up to topological conjugacy, as the only 3-dimensional Anosov ows without freely hom otopic closed orbits. Furthermore the structure of branching is related to the topology of the manifold: if there are in nitely many leaves not separated from each other, then there is an incompressible torus transverse to the ow. Transitivity is not assumed for these results. Finally, if the manifold has negatively curved fundamental group we derive some in portant properties of the limit sets of leaves in the universal cover.

This article deals with a powerful technique for analysing A nosov ow s in dimension 3, namely the study of the topological structure of the (weak) stable and unstable foliations when lifted to the universal cover. This technique was introduced in a remarkable paper of Verjovsky [Ve] in order to study codimension one A nosov ows. If the lifted (say) stable foliation has H ausdor leaf space, then it is hom eom orphic to the set of real numbers and we say that the stable foliation in the manifold is R -covered. When both foliations are R -covered the ow is said to be R -covered. Two early uses of this technique were: (1) G hys [Gh] proved that an A nosov ow in a Seifert bered space is R -covered. This was an essential step in showing that the ow is, up to nite covers, topologically conjugate to a geodesic ow in the unit tangent bundle of a closed surface of negative curvature (brie y, a geodesic ow). (2) If the fundam ental group of the manifold is solvable then the R -covered property, proved by B arbot [B a1, B a2], is again an essential step in P lante's proof [P 12, P 13] that the ow is topologically conjugated to

a suspension of an Anosov di eom orphism of the torus (a suspension). In fact this last result holds for any codim ension one Anosov ow.

M ore recently, a lot of information has been gained by analysing not just the individual leaf spaces, but rather the joint topological structure of the stable and unstable foliations. U sing this and D ehn surgery on closed orbits of suspensions or geodesic ows Fr, G o], a large family of examples was constructed where every closed orbit of the ow is freely hom otopic to in nitely many other closed orbits Fe3]. This never happens for suspensions or geodesic ow s, and was thought to be impossible for any Anosov ow.

In addition the topological study gives inform ation about metric properties of ow lines: We say that a ow is quasigeodesic if ow lines are uniform ly e cient (up to a bounded multiplicative distortion) in measuring distances in relative hom otopy classes. Suspensions and geodesic ows are always quasigeodesic and there are many quasigeodesic \pseudo-Anosov" ows in hyperbolic 3-manifolds [Ca-Th, Mos]. The Dehn surgery construction mentioned above produces a large fam ily of Anosov ows in hyperbolic manifolds which are not quasigeodesic.

Barbot [Ba3, Ba4] also used this topological theory to study A nosov ow s and proved the following remarkable result: A ssume that there is a Seifert bered piece of the torus decomposition of the manifold [Jo, Ja-Sh] and suppose that the corresponding ber is not freely hom otopic to a closed orbit of the ow. First isotopically adjust the boundary tori to be as transverse to the ow as possible [Ba3]. Then the ow in that piece is topologically conjugate to a (generalized) geodesic ow on the unit tangent bundle of a compact surface with boundary. If the manifold is a graph manifold and all bers satisfy the condition above, then the ow is up to topological conjugacy obtained by D ehn surgery on nitely many closed orbits of a geodesic ow [Ba5]. U sing this Barbot [Ba4, Ba5] has obtained the rst known examples of graph manifolds which are neither torus bundles over the circle, nor Seifert bered spaces and which do not admit A nosov ow s.

The results above are in great part due to a complete characterization of the possible joint topological structures of R -covered Anosov ow s [Ba2, Fe3]. On the other hand very little is known about the non R -covered case, for the simple reason that their structure is not understood at all. The purpose of this article is to start a system atic study of Anosov ow s which are not R -covered, where we then say the lifted foliations have branching.

It is easy to show that intransitivity in plies that the ow is not R -covered [So, Bal] and for many years there was a great e ort in trying to prove that these two properties are equivalent [Ve, Gh, Fe3, Ba2]. However in a

surprising developm ent Bonatti-Langevin [Bo-La] have recently constructed a transitive, non R -covered Anosov ow in dimension 3. Their example has an embedded torus transverse to the ow.

This leads us to two basic and very important questions concerning branching: (1) when can branching occur and (2) what are the possible structures of branching in Anosov ow s of 3-m anifolds. In this article we give a complete answer to the second question. We then show that the structure of branching is strongly related to dynam ics of the ow, the topology of the manifold and the metric behavior of the stable and unstable foliations.

Let then be an Anosov ow in M ³ with two dimensional stable and unstable foliations F^s; F^u. Let F^{es} ; F^{eu} be the respective lifts to the universal cover M. Let H^s and H^u denote the leaf spaces of F^{es} and F^{eu} respectively. If F^s is not R-covered, then H^s is not H ausdor. The branching leaves of F^{es} correspond to the non H ausdor points in H^s. Two leaves F \notin F⁰ of F^{es} form a branching pair if the corresponding points in H^s are not separated from each other. This is equivalent to saying that F; F⁰ do not have disjoint saturated neighborhoods in M, where a saturated neighborhood of F^{es} is an open set which is a union of leaves of F^{es} . Sim ilarly for F^{eu} .

Since the universal cover is simply connected, F^{es} and F^{eu} are always transversely orientable and an orientation is chosen. Then there is a notion of branching in the positive or negative directions. The rst non trivial result about the structure of branching is the following [Fe5]: Suppose the ow is transitive. If there is branching in the positive direction of (say) the stable foliation then this foliation also has branching in the negative direction. This is a result about the \global" structure of branching.

We analyse the \local" structure of branching. For general foliations the branching of the lifted foliations can be very complicated [Im]. We will show here that branching in Anosov foliations is of a simple type which is very rigid. For simplicity m any theorem s are stated for F^{es} but they work equally well for F^{eu} .

A leaf of F^{es} or F^{eu} is said to be periodic if it is left invariant by a non trivial covering translation of the universal cover. Equivalently, its image in M contains a closed orbit of . We set show that branching puts a restriction in the type of the leaf.

Theorem A Let be an Anosov ow in M 3 . If F is a branching leaf of F^{es} , then F is periodic.

Theorem A should be interpreted as a rigidity result in the sense that

periodic leaves are \rigid" while non periodic leaves are non rigid. This is best seen in the manifold: if the stable leaf (in the manifold) is periodic, then it contains a closed orbit of and every orbit in the leaf is forward asymptotic to this closed orbit. The nearby returns are in the same local stable leaf. In case the leaf is not periodic the forward orbits lim it in orbits in the manifold, but the nearby returns are always in distinct local stable leaves. This means that when lifted to the universal cover one can perturb slightly the local structure, which will then produce a contradiction.

O urnext goal is to understand the structure of the set E of non separated leaves from a given leaf F of (say) F^{es} . There is a natural order in E given by: if E; L 2 E then we say that E < L if there are G; H 2 F^{eu} with G \ E \notin ; H \ L \notin ; and G is in the back of H, see g. 1. It is easy to see that this is a total order in E. U sing this we can say that a branching leaf D is between E and L if E < D < L.

One measure of the complexity of branching is the number of branching leaves between any E; L 2 E. A priori there could be in nitely many in between branching leaves producing a very complicated structure. We prove:

Theorem B Let be an Anosov ow in M 3 . Let F be a branching leaf of F^{es} and E be the set of non separated leaves from F with the total order de ned above. Then either

(1) E is nite, hence order isom orphic to f1;2; :::; ng or,

(2) E if in nite and order isom orphic to the set of integers Z.

In particular given any E ;L 2 E, there are only nitely many branching leaves between them .

As in the case of theorem A, there is a rigidity proof of this result. However it is quite long and complicated. Our tactic will be to rst show: Theorem C Let be an Anosov ow in M ³ and let (F;L) be a branching pair of F^{e_s} . Let g be a non trivial covering translation with g(F) = F and so that g preserves transversal orientations to $F^{e_s};F^{e_u}$. Then g(L) = L.

Using the important idea of lozenges (see de nition in section 3) and a key result from [Fe4], theorem B is an easy consequence of theorem C, except that to rule out the case that E is order isom orphic to the natural numbers N we need theorem E below. Section 4 contains a more detailed description of the set E.

Theorem C in plies that (F) and (L) contain freely hom otopic closed orbits of the ow , which highlights the pervasivines of freely hom otopic orbits. This shows that the topological structure of the foliations is intim ately related to the dynamics of the ow:

C orollary D Let be an Anosov ow in M 3 . Then is topologically conjugate to a suspension of an Anosov dieom orphism of the torus if and only if there are no freely hom otopic closed orbits of (including non trivial free hom otopies of a closed orbit to itself).

This result does not assume that is not R-covered. Another consequence of theorem C is the following:

Theorem E Let be a non R-covered Anosov ow in M 3 . Then up to the action of covering translations, there are nitely many branching leaves in F^{es} . Equivalently there are nitely many distinguished closed orbits of in M so that their stable leaves lift to branching leaves in the universal cover.

It is very in portant to stress here that in the above results we do not assume that the ow is transitive nor is there any assumption on the manifold. Consequently these results are the most general possible. We also remark that theorem sA; B; C and E were previously proved under the assumption that M has negatively curved fundamental group and furtherm ore that the ow is quasigeodesic [Fe4]. This last hypothesis is a very strong assumption. The above results use only the topological structure of the lifted foliations and have no metric assumption.

We also show that the structure of branching is strongly related to the topology of the am bient manifold. We say that there is in nite branching if there are in nitely many leaves which are not separated from each other, otherwise we say that the branching is nite. An easy corollary of theorem E is the following:

C orollary F Let be an Anosov ow in M 3 orientable, atoroidal. Then in nite branching cannot occur.

Even though the proof of corollary F is easy, it depends on a deep result of G abai, namely the general torus theorem [Ga] which in turn depends on the solution of the Seifert bered conjecture. In addition the proof uses the characterization of A nosov ows in Seifert bered 3-manifolds [Gh]. In section 5 we study product regions (see de nition in section 5) and then prove the following stronger result, using only the study of the topological structure of \mathbf{F}^{es} ; \mathbf{F}^{eu} :

Theorem G Let be an Anosov ow in M 3 orientable so that there is in nite branching in \mathbb{P}^{e_s} . Then there is in nite branching in \mathbb{P}^{e_u} . Furtherm ore there is an embedded torus T transverse to , hence T is incompressible.

We remark that in nite branching does occur, for example in the Bonatti-Langevin ow. Furthermore we show that nite (but non trivial) branching also occurs for a large class of A nosov ows, for example in the ows constructed by Franks and W illiams [FrW i].

Finally we apply these results to the case when M has negatively curved fundam ental group. Then M is compactified with a sphere at in nity S_1^2 . Furtherm one the intrinsic geometry of a leaf F of \mathbb{F}^{e_S} or \mathbb{F}^{e_U} is always negatively curved in the large so there is an intrinsic ideal boundary \mathbb{Q}_1 F. In these manifolds it is fundam ental to understand asymptotic behavior of sets in M [Th1, Th2], Mor], Bon]. We say that e has the continuous extension property if the embedding ': F ! M extends continuously to ': F [\mathbb{Q}_1 F ! M [S_1^2 , for any leaf F in \mathbb{F}^{e_S} or \mathbb{F}^{e_U} . This relates the foliation to the geometry in the large of the universal cover. This property can be defined for any R expless codimension 1 foliation in such manifolds and it is true for brations [Ca-Th] and many depth one foliations [Fe1]. Recall that the lim it set of B is the set of accumulation points of B in S_1^2 . In this article we use the structure of branching to analyse lim it sets of leaves when the continuous extension property holds.

Theorem H Let be an Anosov ow in M 3 with $_1$ (M) negatively curved. Suppose that e has the continuous extension property. If is not R -covered then the limit set of any leaf F of \mathbb{P}^{e_s} or \mathbb{P}^{u} is a Sierpinski curve, that is, the complement of a countable, dense union of open disks in S_1^2 .

If is R-covered then the lim it set of any F 2 \mathbb{F}^{e_s} [\mathbb{F}^{e_u} is S_1^2 , regardless of whether the continuous extension property holds or not [Fe2]. There are

m any R -covered exam ples [Fe3].

Bonatti and Langevin's example of a transitive, non R -covered A nosov ow in dimension 3, was generalized by Brunella [Br] who produced many examples by Dehn surgery on geodesic ows. The tool used to show that these ows are not R -covered was the existence of a transverse torus; hence all such examples were not in hyperbolic 3-m anifolds. The main open conjecture in this theory was whether M being hyperbolic would im ply that the ow is R -covered. In this article we answer this conjecture in the negative:

Theorem I There is a large class of transitive, non R -covered A nosov ow s where the underlying 3-m anifold is hyperbolic. This includes all A nosov ow s in non orientable, hyperbolic 3-m anifolds.

In a forthcom ing paper [Fe8] we use the results of this article to study incompressible tori in 3-manifolds supporting Anosov ows. It is of great interest to nd, in the isotopy class of the torus, the best position with respect to the ow [Ba3, Ba4]. We prove:

Theorem (Fe8]) Let be an Anosov ow in M 3 and let T an incompressible torus in M. Suppose that no loop in T is freely homotopic to a closed orbit of . Then is topologically conjugate to a suspension Anosov ow. Furthermore T is isotopic to a torus transverse to .

The article is organized as follows: in the next section we develop background material. In section 3 we prove theorem A and in the following section we prove theorem C and immediately derive theorems B and E and corollaries D and F. Section 5 studies product regions, which is then applied to a more detailed analysis of in nite branching and the construction of a transverse torus in section 6. In the nal section we study the continuous extension property.

2 Background

Let t:M ! M be a nonsingular ow in a closed R iem annian manifold M. The ow is Anosov if there is a continuous decomposition of the tangent bundle TM as a W hitney sum TM = $E^0 E^s E^u$ of D t invariant subbundles and there are constants $_0 1$, $_1 > 0$ so that: (i) E^{0} is one dimensional and tangent to the ow,

(ii) j $\mathfrak{D}_{t}(\mathbf{v})$ jj $_{0}e^{-t}$ j \mathbf{v} jj for any $\mathbf{v} \ge E^{s}$; t 0,

(iii) j $\mathfrak{p}_{t}(\mathbf{v})$ jj $_{0}e^{1^{t}}$ jjvjj for any v 2 E^u; t 0.

In this article we restrict to M of dimension 3. Then $E^s; E^u$ are one dimensional and integrate to one dimensional foliations $F^{ss}; F^{uu}$ called the strong stable and strong unstable foliations of the ow. Furthermore, the bundles $E^0 = E^s$ and $E^0 = E^u$ are also integrable [An] producing 2-dimensional foliations $F^s; F^u$ which are the stable and unstable foliations of the ow.

The ow is said to be orientable when both F^{s} ; F^{u} are transversely orientable. We remark that there is always a regular cover of order 4 where the lifted F^{s} and F^{u} are transversely orientable. Whenever possible we will lift to such a cover.

The leaves of F s ; F u are either topological planes, annuli or M orbits bands. The last two correspond exactly to leaves containing closed orbits of

. There is at most one closed orbit in a leaf of F $\,^{\rm s}$, in which case all other orbits are forward asymptotic to it. Similarly for F $^{\rm u}$.

The foliation F^s is R eebless, so N ovikov's theorem [N o] in plies that given any closed orbit of , ⁿ is not null hom otopic for any n \in 0.

Let : M ! M be the universal covering space of M. This notation will be xed throughout the article. The Anosov foliations F^{s} ; F^{u} lift to foliations F^{es} ; F^{eu} in M. The leaves of F^{es} ; F^{eu} are topological planes, so M is hom eom orphic to R³ [Pa]. Therefore M is irreducible that is every embedded sphere in M bounds a 3-ball. The induced ow in M is denoted by e.

Let 0 be the orbit space of ^e obtained by collapsing ow lines to points and let : M^{f} ! 0 be the projection map. A fundam ental property which will be repeatedly used here is that 0 is Hausdor and hence hom eom orphic to R² [Fe3]. This is a signi cant sim pli cation since now much of the analysis can be done in dimension 2 instead of dimension 3. We stress that 0 is only a topological object. There is no natural metric in 0 since the ow direction contracts and expands distances in M^{f} . The foliations F^{es} ; F^{eu} induce two transverse 1-dimensional foliations in 0, which will also be denoted by F^{es} ; F^{eu} . By an abuse of notation we will many times identify sets in M^{f} or orbits of e to their respective in ages in 0.

The fundam ental group $_1 (M)$ is isomorphic to the set of covering translations of M. We will usually assume one such identication is xed. Given a covering translation g, we will also denote by g its action on H^s; H^u.

Let $W^{s}(x)$ be the leaf of F^{s} containing x and similarly de ne $W^{u}(x)$, $W^{ss}(x); W^{uu}(x); \overline{W}^{s}(x); \overline{W}^{u}(x); \overline{W}^{ss}(x)$ and $\overline{W}^{uu}(x)$. In the same way if is an orbit of we de ne $W^{s}()$, etc.. General references for A nosov ows are [An], [An-Si], [Bow], [Sh] and [Sm].

An incompressible surface (\notin S²) is an embedded surface in M³ which is injective in the fundam ental group level. A manifold is toroidal if it contains an incompressible torus and atoroidal otherwise.

3 Periodic branching leaves

The following de nitions will be useful. If L is a leaf of F^{es} or F^{eu} , then a half leaf of L is a connected component A of L , where is any full orbit in L. The closed half leaf is $\overline{A} = A$ [and its boundary is @A = . If L is a leaf of F^{es} or F^{eu} then a ow band B de ned by orbits e in L is the connected component of L f; g which is not a half leaf of L. The closed ow band associated to it is $\overline{B} = B$ [f; g and its boundary is @B = f; g.

Since M is simply connected, F^{es} and F^{eu} are transversely orientable. C hoose one such orientation, assumed to agree with the lifts of the transversal orientations to F^s; F^u if any of these is transversely oriented. Notice that in general, covering translations may not preserve transversal orientations.

For p 2 M¹, let $\overline{\#}_{+}^{s}(p)$ be the half leaf of $\overline{\#}^{s}(p)$ de ned by the orbit ${}^{e}{}_{R}(p)$ and the positive transversal orientation to F^{eu} at p. This is also called a positive half leaf of $\overline{\#}^{s}(p)$. Sim ilarly de ne $\overline{\#}^{s}(p)$, a negative half leaf and also de ne $\overline{\#}_{+}^{u}(p)$ and $\overline{\#}^{u}(p)$.

A fundamental property for us is that any leaf L in \mathbb{F}^{s} or \mathbb{F}^{u} separates \mathbb{M} . This is a consequence of \mathbb{M} being simply connected. The front of L is the component of \mathbb{M} L dened by the positive transversal orientation to L. Similarly dene the back of L. For p 2 \mathbb{M} let $\mathbb{W}_{+}^{s}(p) = \mathbb{W}_{+}^{s}(p) \setminus \mathbb{W}^{ss}(p)$. In the same way dene $\mathbb{W}_{+}^{ss}(p), \mathbb{W}_{+}^{uu}(p)$ and $\mathbb{W}_{+}^{uu}(p)$.

If F 2 P^{es} and G 2 P^{eu} then F and G intersect in at most one orbit, since two intersections would force a tangency of P^{es} and P^{eu} . This is easiest seen in O, as P^{es} and P^{eu} are then 1-dimensional foliations of the plane.

We say that leaves F;L 2 F^{es} and G;H 2 F^{eu} form a rectangle if F intersects both G and H and so does L, see g. 2 a. We also say that E intersects G between F and L if E \ G is contained in the ow band in G de ned by G \ F and G \ L. Then it is easy to prove [Fe5] that if E 2 F^{es} intersects G between F and L then E also intersects H between F and L. This means that there is a product structure of F^{es} and F^{eu} in the region bounded by F;L;G and H.

The following two de nitions will be essential for all resuts in this article.

De nition 3.1 Given p2 M (or p20), let

Notice that the ow bands L_1 ; H_1 (or the leaves L; H) are not uniquely determined given the perfect t (F;G). We will also say that F and G are asymptotic in the sense that if we consider stable leaves near F and on the side containing G they will intersect G and vice versa. Perfect ts produce \ideal" rectangles, in the sense that even though F and G do not intersect,

there is a product structure (of \mathbb{P}^s and \mathbb{P}^u) in the interior of the region bounded by F;L;G and H .

It is easy to show [Fe5] that there is at most one leaf G 2 F^{eu} making a perfect twith a given half leaf of F 2 F^{es} and in a given side of F. Therefore a perfect t is a detectable property in M. This means that if (L;G) form s a perfect t and g is any orientation preserving covering translation with g(L) = L, then g(G) = G. The last assertion follows from uniqueness of perfect ts and the fact that, as g acts by hom eom orphism s in the leaf spaces, it takes perfect ts to perfect ts.

If p;q are in the same strong stable leaf let $[p;q]_s$ denote the closed segment in that leaf from p to q and let $(p;q)_s$ be the corresponding open segment. Sim ilarly de ne $[p;q]_u$ and $(p;q)_u$.

We say that $J_{+}^{s}(p)$ and $J_{+}^{s}(q)$ are comparable and will denote this by $J_{+}^{s}(p) = J_{+}^{s}(q)$, if one of them is contained in the other. Then we write $J_{+}^{s}(p) < J_{+}^{s}(q)$ if the former is strictly contained in the latter. Similarly dene ;> and . The symbol 6 m eans not comparable.

We also say that an orbit of $^{\rm e}$ is periodic if it is left invariant by a non trivial covering translation.

Theorem 3.3 Let be an Anosov ow in M³ and let F be a branching leaf of \mathbb{P}^{e_s} . Then there is a non trivial covering translation g with g(F) = F, that is, F is periodic.

Proof of 3.3: By taking a nite cover if necessary, we may assume that is orientable. Let L 2 F^{es} , L \in F, so that F; L form a branching pair of F^{es} . Assume without loss of generality that F and L are not separated on their negative sides, that is they are associated to branching of F^{es} in the positive direction (positive branching).

Let $w_0 \ge F$, $w^0 \ge L$. Since F and L are not separated in their negative sides there are $y_0 \ge \overline{\#}^{uu}(w_0)$ (y_0 su ciently near w_0) and $x_0 \ge \overline{\#}^{u}(w^0) \setminus \overline{\#}^{ss}(y_0)$ so that if $r_0 = \overline{\#}^{uu}_+(x_0) \setminus L$, then for any $E \ge F^{es}$,

This fact, which follows from the separation property of leaves of \mathbb{P}^{e_s} , will often be implicitly used.

By switching F and L if necessary we may assume that $\overset{\text{ff}}{=} {}^{u}(x_0)$ is in the front of $\overset{\text{ff}}{=} {}^{u}(y_0)$. Our rst goal will be to nd unique leaves associated to the branching which form perfect ts with F and L.

As there are $z \ 2 \ [y_0; x_0]_s$ with $\overline{\#}^u(z) \setminus F = i$ (for instance $z = x_0$), let p_0 be the closest point to y_0 in $[y_0; x_0]_s$ so that $\overline{\#}^u(p_0) \setminus F = i$.

Lem m a 3.4 The leaves F and $\overline{\mathbb{M}}^{u}(p_{0})$ form a perfect t.

Proof of 3.4: For candidates of ow bands let $A = {}^{e}{}_{R} ((y_{0};w_{0})_{u})$ and $B = {}^{e}{}_{R} ((y_{0};p_{0})_{s})$. Conversely let E 2 \mathbb{F}^{s} with $E \setminus \tilde{\mathbb{W}}_{+}^{u}(p_{0}) \in ;$. Suppose that $E \setminus A = ;$. Since $\tilde{\mathbb{W}}^{u}(p_{0}) \setminus F = ;$, then the front of E is disjoint from the front of F. For any z 2 $\tilde{\mathbb{W}}^{ss}(p_{0})$ near enough $p_{0}, \tilde{\mathbb{W}}^{u}(z) \setminus E \in ;$. As E is in the back of F, it follows that $\tilde{\mathbb{W}}^{u}(z) \setminus F = ;$. This contradicts the choice of p_{0} . We conclude that $E \setminus A \in ;$, $E \setminus \tilde{\mathbb{W}}_{+}^{u}(p_{0}) \in ;$.

Conversely suppose that $\mathbb{R} \setminus \overline{\mathbb{M}}^{s}_{+}(w_{0}) \in ;$. Let $\mathbb{F} = 2 \mathbb{F}^{e^{s}}$ be close enough to \mathbb{F} so that $\mathbb{F} \setminus \mathbb{R} \in ;$, $\mathbb{F} \setminus \overline{\mathbb{M}}^{u}(y_{0}) \in ;$ and $\mathbb{F} \setminus \overline{\mathbb{M}}^{u}(x_{0}) \in ;$. Then $\overline{\mathbb{M}}^{u}(y_{0}); \overline{\mathbb{M}}^{u}(x_{0}); \overline{\mathbb{M}}^{s}(y_{0})$ and \mathbb{F} form a rectangle. Since and $\mathbb{R} \setminus \mathbb{F} \in ;$ is between $\mathbb{F} \setminus \overline{\mathbb{M}}^{u}(y_{0})$ and $\mathbb{F} \setminus \overline{\mathbb{M}}^{u}(x_{0})$ then $\mathbb{R} \setminus \overline{\mathbb{M}}^{s}(y_{0}) \in ;$. As \mathbb{R} is in front of $\overline{\mathbb{M}}^{u}(y_{0})$ then $\mathbb{R} \setminus \overline{\mathbb{M}}^{s}_{+}(y_{0}) \in ;$. Since $\mathbb{R} \setminus \mathbb{F} \in ;$ then \mathbb{R} is in the back of $\overline{\mathbb{M}}^{u}(p_{0})$. Therefore $\mathbb{R} \setminus \mathbb{B} \in ;$. This nishes the proof of the lemma.

Continuation of the proof of theorem 3.3

In the same way there is a unique $q_0 2 [y_0; x_0]_s$ with $\overline{\mathbb{W}}^{u}(q_0)$ and L form ing a perfect t. By uniqueness of perfect ts, the leaves $\overline{\mathbb{W}}^{u}(p_0); \overline{\mathbb{W}}^{u}(q_0)$ depend only on F and L. If follows from () and lemma 3.4, that given E 2 \mathbb{F}^{es} , E \ $\overline{\mathbb{W}}^{u}_+(p_0) \in ;$, E \ $\overline{\mathbb{W}}^{u}_+(q_0) \in ;$. Equivalently $J^{u}_+(p_0) = J^{u}_+(q_0)$.

<u>Case 1</u> $p_0 = q_0$.

Let $G = \emptyset^{u}(p_{0}) = \emptyset^{u}(q_{0})$. If G is periodic there is $g \in id w$ ith g(G) = G. By uniqueness of perfect ts and preserving of transversal orientations it follows that g(F) = F and we are done. So we may assume that G is not periodic.

Let $c_0 = (p_0)$. Since G is not periodic, $_R(c_0)$ is not a closed orbit, nor is it backwards asymptotic to a closed orbit. Let c be a negative lim it point of $_R(c_0)$ and let $c_i = _{t_i}(c_0)$, $t_i ! 1$, with $c_i ! c$. If c_i and c_j are in the same local unstable leaf near c, then there is a closed path in W^u(c_i) consisting of the ow segment from c_i to c_j and then a small strong unstable segment from c_j to c_i in the local unstable leaf through c_j . This path is not nullhom otopic in W^u(c_i), hence W^u(c_i) contains a closed orbit, contradiction to our assumption. This is the key fact used in the proof of the theorem and it will imply that non periodic leaves in the universal cover are not rigid.

Lift c_i to $p_i 2 M$ with $p_i ! p$ and (p) = c. Then $p_i = g_i (e_{t_i} (p_0))$, where g_i are covering translations. By the above argument $\mathcal{F}^{s}(p_i) \in \mathcal{F}^{s}(p_k)$ for any $i \in k$. This is the non rigidity we are booking for.

Choose i;k so that p_i is in the back of $\overline{\mathbb{H}}^{u}(p_k)$, see g. 4. Since $d(p_i;p_k) < 1$ it follows that $\overline{\mathbb{H}}^{s}(p_k) \setminus \overline{\mathbb{H}}^{u}(p_i) \in ;$ and $\overline{\mathbb{H}}^{s}_{+}(p_i) \setminus \overline{\mathbb{H}}^{u}(p_k) \in ;$. By (), this implies that y is in the back of $\overline{\mathbb{H}}^{u}(p_i)$ and x_i is in the front of $\overline{\mathbb{H}}^{u}(p_k)$, see g. 4. Hence $\overline{\mathbb{H}}^{u}(y_k)$ is in the back of $\overline{\mathbb{H}}^{u}(p_i)$. Then $\overline{\mathbb{H}}^{u}(p_i) \setminus B_k \in ;$, hence $\overline{\mathbb{H}}^{u}(p_i) \setminus F_k \in ;$. As L_i makes a perfect twith

 $end{aligned}^{u}(p_{i})$, this implies that L_{i} is in front of F_{k} , hence L_{i} is in the back of $end{aligned}^{u}(p_{k})$.

On the other hand, $L_i \setminus \overline{\#}^u(x_i) \in ;$. Since $\overline{\#}^u(x_i)$ is in front of $\overline{\#}^u(p_k)$ then $\overline{\#}^u(p_k) \setminus {e \atop R} ([p_i;x_i]_s) \in ;$. As L_i and $\overline{\#}^u(p_i)$ form a perfect t, this in plies that $\overline{\#}^u(p_k) \setminus L_i \in ;$. This contradicts the previous paragraph.

This shows that if $p_0 = q_0$, then G is periodic, left invariant by g, hence F and L are periodic and both left invariant under g.

R em arks: (1) If we apply the argument above when G is periodic, we get $\overset{\text{ff}}{=} {}^{s}(p_{i}) = \overset{\text{ff}}{=} {}^{s}(p_{k})$ for all i;k. There is no small perturbation of the local picture, which is then rigid. This will imply that the whole set of non separated leaves from F is very rigid.

(2) It is tempting to try the following \intuitive" approach to the above proof: as $(\[mmmode mmmode + 1]{}^{u}(p_0))$ is not compact in M, there are always translates S_1 and S_2 of $\[mmmode mmmode + 1]{}^{u}(p_0)$ and points $u_i \ 2 \ S_i$ arbitrarily near each other. However there is no control of the rest of the picture. For instance we do not know a priori what happens to the respective stable lengths. This is the reason why we xed an orbit $_R$ ($\[mmmode p_0]$) and owed <u>backwards</u> in order to insure that stable lengths are as big as we want.

<u>Case 2</u> $p_0 \notin q_0$.

We use the same notation as in case 1. As $q_0 \in p_0$, let $q_i = q_i (e_{t_i}(q_0))$.

There is no a priori contradiction because now L_i does not form a perfect t with $\overset{\text{de}}{\#}^{u}(p_i)$, and in fact L_i is probably in the front of $\overset{\text{de}}{\#}^{u}(p_k)$. Let

Then $J_{+}^{u}(p_{k}) < J_{+}^{u}(e_{2})$ and by the local product structure of $\mathbb{F}^{e_{3}}$; $\mathbb{F}^{e_{u}}$ near p, it follows that $J_{+}^{u}(p_{i}) > J_{+}^{u}(e_{1})$, see g. 5. Choose E 2 $J_{+}^{u}(p_{i}) = J_{+}^{u}(e_{1})$. By the above considerations it is clear that $E \setminus \overset{\text{ff}}{\mathbb{F}}^{u}(p_{k}) = ;$. But

hence E 2 $J_{+}^{u}(q_{i})$. As a result $E \setminus \overline{\#}_{+}^{u}(q_{i}) \in ;$. But now $\overline{\#}^{u}(q_{i})$ is in the front of $\overline{\#}^{u}(p_{k})$. Since $\overline{\#}^{u}(p_{k})$ separates $\overline{\#}$, then $E \setminus \overline{\#}^{u}(p_{k}) \in ;$, contradiction. As before we conclude that G is periodic, left invariant by $g \in id$, so F is also left invariant by g.

Caution: The same argument shows that L and $\overset{1}{\Re}$ ^u (q₀) are also periodic. We do not know at this point that the same covering translation leaves invariant <u>both</u> F and L. This is a much stronger fact.

4 Branching structure

In this section we show that if F and L are not separated, then not only are they periodic, but there is a common covering translation leaving both of them invariant. As a result, branching forces a non-trivial free hom otopy between closed orbits of in M and this gives the topological characterization of suspensions. Furtherm ore we will show that F and L are connected by a nite sequence of lozenges, as de ned below. This completely determ ines the structure of the set of non separated leaves from F. As a consequence we show there are only nitely many branching leaves up to covering translations. This in turn implies that if there is in nite branching then there is an incompressible torus in M.

De nition 4.1 Lozenges - Let p;q 2 M^f, p 8 $\overset{\text{ff}}{=}$ ^s(q), p 8 $\overset{\text{ff}}{=}$ ^u(q). Let H_p be the half leaf of $\overset{\text{ff}}{=}$ ^u(p) de ned by ^e_R (p) and contained in the same side of $\overset{\text{ff}}{=}$ ^s(p) as q. Let L_p be the similarly de ned half leaf of $\overset{\text{ff}}{=}$ ^s(p) and in the same fashion de ne H_q;L_q. Then p;q form a lozenge, g. 6, a if H_p;L_q and H_q;L_p respectively form perfect ts.

We say that p;q (or ${}^{e}R$ (p); ${}^{e}R$ (q)) are corners of the bzenge. If the bzenge with corner p is contained in the back of \overline{W} ^s(p) then p is a corner of type (+;), otherwise it is of type (;). Sim ilarly using ^u(p) de ne types (;+);(;). The sides of the bzenge are H_{p} ;L_p;H_q and L_q. Since given any four leaves there is at most one bzenge de ned by them we will also

say the full leaves are the sides of the lozenge. Notice that if p is a corner of type (;) then $J^{u}_{+}(p) = J^{u}(q)$, $J^{s}_{+}(p) = J^{s}(q)$ and similarly for the other cases.

Two lozenges are adjacent if they share a corner and there is a stable or unstable leaf intersecting both of them, see g. 6 b. A chain of lozenges is a collection fB_ig; 1 i n, where n 2 N, so that B_i and B_{i+1} share a corner. Consecutive lozenges m ay be adjacent or not.

The following theorem will be essential for the results in this section:

Theorem 4.2 (Fe4) Let be an Anosov ow in M³. Suppose that F_i ; i = 0; 1 are bases of F^{es} for which there is a non trivial covering translation g with $g(F_i) = F_i$; i = 0; 1. Let $_i$; i = 0; 1 be the periodic orbits of e in F_i so that $g(_i) = _i$. Then $_0$ and $_1$ are connected by a nite chain of lozenges fB_ig; 1 i n and g bases invariant each lozenge B_i as well as their corners.

Furtherm one there is a unique chain that is minimal, in the sense that any other chain from $_0$ to $_1$ contains this chain [Fe7]. Given any chain $B = fB_ig;1$ i n from $_0$ to $_1$, let $_0 = _0$ and inductively de ne $_i;i > 0$ to be the remaining corner of B_i . The minimal chain from $_0$ to $_1$ is de ned by: B_{i+1} is on the same side of $\overline{\mathbb{M}}^{s}(_i)$ and $\overline{\mathbb{M}}^{u}(_i)$ that $_1$ is. A closed orbit of traversed once is called an indivisible closed orbit. The following result will be often used in this article:

Theorem 4.3 (Fe7) Let be an orientable Anosov ow in M³. If is an indivisible closed orbit of , then represents an indivisible element in $_1$ (M). Equivalently if g^n (F) = F, where F 2 F^{es} [F^{eu}, g is a covering translation and n \in 0, then g(F) = F.

There is a related result if is not assumed to be orientable.

The stabilizer T (F) of a leaf F of F^{es} (or F^{eu}) is the subgroup of $_1$ (M) of those g with g(F) = F. If (F) does not contain a periodic orbit, then T (F) is trivial. O therwise let be the indivisible closed orbit in (F). Then T (F) is in nite cyclic and it has a generator conjugate to [] in $_1$ (M).

The main technical result in this section is the following:

Theorem 4.4 Let be an Anosov ow in M³. Suppose that F;L form a branching pair of F^{es} . Let g be a non trivial covering translation with g(F) = F, so that g preserves transversal orientations to $F^{es};F^{eu}$. Then g(L) = L. Sim ilarly for F^{eu} . Proof of 4.4: Up to a nite cover assume that is orientable. Since g preserves transversal orientations, then g is still a covering translation of the nite cover. W ithout loss of generality suppose that F and L are not separated on their negatives sides, corresponding to positive branching. Finally we may assume that g generates T (F).

As in theorem 3.3 there are unique leaves $G : H \ 2 \ \mathbb{P}^{2u}$ making perfect ts with F and L respectively and so that: G separates F from L and so does H. Let p 2 G so that $\overline{\mathbb{M}}^{ss}(p)$ intersects H and let $q = \overline{\mathbb{M}}^{ss}(p) \setminus H$. Recall from the proof of theorem 3.3, that $J_{+}^{u}(p) = J_{+}^{u}(q)$.

Since g preserves transversal orientations then g(G) = G. Our goal is to show that g(L) = L. Suppose then that $g(L) \in L$, hence by the same argument $g(H) \in H$. Let G be the periodic orbit of e in G, so g() = .

<u>Claim 1</u> – There is R 2 \mathbb{P}^{e_u} in the back of L making a perfect twith a positive half leaf of L, hence R is in the front of H.

W e m ay assume that p 2 $\cancel{\#}_{+}^{u}$ (). Let E = $\cancel{\#}^{s}$ (p). By taking g¹ if necessary assume that g(E) is in front of E. Hence g(E) 2 J $_{+}^{u}$ (p), therefore g(E) 2 J $_{+}^{u}$ (q). Then H \ g(E) $\underbrace{\bullet}_{+}^{s}$; There are 2 cases:

(1) g(H) is in front of H, see g. 7.

Let $e^0 = \frac{1}{2} e^{ss}(g(p)) \setminus H$. Since $g(p) 2 e^{u}(p)$ then $J^{u}_+(g(p)) = J^{u}_+(e^0)$. But also $J^{u}_+(g(p)) = J^{u}_+(g(q))$, so $J^{u}_+(g(q)) = J^{u}_+(e^0)$, where g(q) 2 g(H)and $e^0 2 H$. Since L makes a perfect twith H and g(L) makes a perfect twith g(H) this shows that g(L) is not separated from L.

As in the proof of theorem 3.3, there is a unique $e_0 \ 2 \ [e^0;g(q)]_s$ with $\overline{\mathbb{H}}^{u}(e_0)$ making a perfect twith L and L in the back of $\overline{\mathbb{H}}^{u}(e_0)$. In this case let $R = \overline{\mathbb{H}}^{u}(e_0)$.

(2) Suppose now that g(H) is in the back of H.

Notice that E;g(E);H and G form a rectangle. Since g(H) \ g(E) \notin ; and g(H) is between G and H it follows that g(H) \ E \notin ; and g(H) \ E is an orbit in E between E \ G and E \ H.

In this case let $c = g(H) \setminus \overline{\#}$ ^{ss} (p). Then c2 (p;q)_s. Since $J_{+}^{u}(p) = J_{+}^{u}(q)$ and L $\cancel{B} J_{+}^{u}(q)$, then $g(L) \cancel{B} J_{+}^{u}(q)$, so $g(L) \setminus H = ;$. Hence g(L) is in the back of H. As in case (1), it follows that L and g(L) form a branching pair. Let $c_{2} 2$ (c;q)_s with $\overline{\#}^{u}(c_{2})$ making a perfect twith g(L) and with g(L)in the back of $\overline{\#}^{u}(c_{2})$. Then $R = g(\overline{\#}^{u}(c_{2}))$ makes a perfect twith L and L is in the back of $\overline{\#}^{u}(c_{2})$. This nishes the proof of claim 1.

By theorem 3.3, L is periodic and let be the indivisible periodic orbit in L. Let h a generator of T(H). Since is orientable, h(H) = H, h(R) = R. Let be the periodic orbit in H. Therefore L and H are 2 of the sides of a lozenge N₁ with other sides in $\overset{\text{ff}}{\text{f}}$ ^s() and $\overset{\text{ff}}{\text{f}}$ ^u(), that is and are the corners of the lozenge. In the same way L and R are the 2 sides of a lozenge N₂. The lozenges are adjacent and intersect the stable leaf E. Let N = N₁ [N₂.

We now show that F also makes a perfect twith U 2 \mathbb{F}^{e_u} , U \in G and F in the front of U, hence G is in the front of U, see g. 8. If h(G) = G then since g generates T (G), it follows that $h = g^n$ for some n 2 Z. Hence $g^n(H) = H$. Theorem 4.3 then in plies that g(H) = H contrary to assumption. It follows that $h(G) \in G$. Using claim 1 with the roles of F; L exchanged, we produce the required U 2 \mathbb{F}^{e_u} . Furtherm ore there are two adjacent lozenges D_1 and D_2 with (some) sides in U; F; G. Let D be their union. Both lozenges intersect a stable leaf which we may assume is E.

From now on the proof goes roughly as follows: We will show that $\overline{\#}^{s}()$ intersects of $\overline{\#}_{+}^{u}()$ and sim ilarly that $\overline{\#}^{s}()$ intersects $\overline{\#}_{+}^{u}()$ producing a contradiction.

By taking g^1 if necessary suppose that g(H) is in the back of H. Let $H_i = g^i(H)$. Then as in case (2) of the claim, H_{i+1} is in the back of H_i , and for all i $0, H_i \setminus E \in$; Furtherm ore H_i is always in front of G. This implies that H_i ! S with $S \setminus E \in$; (and maybe H_i also converges to other leaves of F^{e_u}).

Conversely suppose that E 2 F^{es} is not separated from F;L and is between F and L. Let B_k ;k 2 N, be a sequence of stable leaves so that B_k ! F as k! 1. As E is not separated from F, B_k ! E in H^s when k! 1. But since F and L are connected by a nite chain of lozenges, then for k big all B_k intersect the interior of these lozenges. Therefore the only possible leaves in the limit of B_k which are between F and L are those in the stable boundary of the lozenges B_i . This completely characterizes such leaves and hence there are nitely many in between leaves.

An R-covered Anosov ow can only have one of two topological types (up to isotopy in M) for the joint structure of F^{es} ; F^{eu} [Fe3]. They are characterized by:

(1) Any leaf of F^{e^s} intersects every leaf of F^{e^u} and vice versa. This is the called the product type.

(2) There is a leaf of \mathbb{P}^s which does not intersect every leaf of \mathbb{P}^u . This is the skewed type, see detailed de nition in [Fe3].

Suspensions have product type and geodesic ows have skewed type.

C orollary 4.6 Let be an Anosov ow in M 3 . Then is topologically conjugate to a suspension of an Anosov di eom orphism of the torus if and only if there are no free hom otopies between closed orbits of (including non trivial free hom otopies from an orbit to itself).

Proof of 4.6: If is not R-covered, theorem 4.4 shows that there are $F_0 \notin F_1 2 F^{\otimes s}$ and g a nontrivial covering translation with $g(F_i) = F_i$. Let i be the periodic orbit in F_i . Then g(i) = i. Therefore (0); (1) are closed orbits of (they may be the same orbit) which are non trivially freely hom otopic to each other.

If is R-covered and has product type, then by theorem 2.8 of [Ba2] (see announcemment in [So]) is topologically conjugate to a suspension. O therwise has skewed type and theorem 3.4 of [Fe3] produces many non trivial free hom otopies between closed orbits of .

Corollary 4.8 Let be an Anosov ow in M ³. Let F be a branching leaf of \mathbb{P}^{e^s} and E be the set of non separated leaves from F. Given E;L 2 E we say that E < L in E if there are G;H 2 \mathbb{P}^{e^u} , with G \ E \notin ; H \ L \notin ; and G in the back of H. Then either

In particular given any E; L 2 E, there are only nitely many branching leaves between them .

Proof of 4.8: Up to nite cover if necessary assume that is orientable. Let E be the set of non separated leaves from E 2 F^{es} . If E is nite, the result is immediate, so assume it is in nite. Suppose all leaves in E are not separated on their negative sides.

By corollary 4.7 there are E⁰ \in 2 E and f a covering translation with f (E⁰) = E . A sume that E⁰ < E in the ordering of E. Theorem 4.2 in plies that E⁰; E are connected by a nite chain with positive stable boundaries in E₀ = E⁰; E₁; :::: E_n = f (E₀) = E 2 F^{es}. Clearly E_i < E_j if i < j. Since E₀ is not separated from E_n, then f (E₀) = E_n is not separated from f (E_n). This produces E_{n+1}; ::::: E_{2n} = f (E_n), a sequence of non separated leaves. U sing fⁱ; i 2 Z, one constructs a sequence fE_ig_{i2Z} E of non separated leaves.

Let now E 2 E. Then E and E₀ are not separated, hence connected by a nite chain of adjacent lozenges all intersecting a common stable leaf. Notice that the lozenges in the chain are completely determined by a corner plus a direction. On the other hand, starting from E₀ and in any direction from E₀ (in E) there are in nitely many adjacent lozenges intersecting a common stable leaf. This implies that E will be eventually achieved by lozenges in

E, that is $E = E_i$ for some i 2 Z. Hence $E = fE_{i}g_{i2Z}$. Clearly the order induced above shows that $E_i < E_j$ if i < j. Hence E is order isomorphic to Z as desired.

Notice that any covering translation f conjugates the stabilizers of F and f (F) that is f (T (F)) $f^1 = T (f (F))$. Therefore conjugation by f takes a generator of T (F) to a generator of T (F).

C orollary 4.9 Let be an Anosov ow in M 3 , orientable. If F_i ; i 2 N F^{es} is an in nite collection of non separated leaves of F^{es} , then M has an incompressible torus.

Proof of 4.9: A s M is orientable, then if necessary lift to a double cover M₂ where both F^s and F^u are transversely orientable. The structure of F^{es} ; F^{eu} is the same. By corollary 4.7 there is a covering translation f of M₂ with f (F_i) = F_j and i \in j.

Let $g \in id$ be a generator of the stabilizer of F_i in $_1 (M_2)$. Then fgf¹ is a generator of T (F_j). Theorem 4.4 in plies that $g(F_j) = F_j$. By theorem 4.3, g is indivisible in $_1 (M_2)$, hence g is also a generator of T (F_j). This in plies that either fgf¹ = g or fgf¹ = g¹.

In the rst case f and g generate an abelian subgroup of $_1 (M_2)$. If $f^n g^m = 1$, then $f^n g^m (F_i) = F_i$ hence $f^n (F_i) = F_i$. If $n \notin 0$ theorem 4.3 in plies that $f(F_i) = F_i$, contradiction to $F_i \notin F_j$. Hence n = 0. Since no multiple of a closed orbit is null hom otopic, them $g^m = id$ im plies that m = 0 also. Hence there is a Z Z subgroup of $_1 (M_2)$.

If fgf¹ = g¹, then f² and g generate an abelian subroup of $_1 (M_2)$ and the same argument produces Z Z < $_1 (M_2)$. Therefore there is a Z Z subgroup of $_1 (M)$. By the torus theorem [Ga] (which uses M being orientable), either M is a Seifert bered space or there is an embedded incompressible torus. In the rst case, G hys [Gh] proved that is up to nite covers, topologically conjugate to a geodesic ow. But then would

be R -covered, contrary to hypothesis. Hence M is toroidal as desired.

5 Product regions

Denition 5.1 A positive unstable product region P of e is a region in \mathbb{M} dened by an open strong stable segment $F \ge F^{es}$ (or by a ow band e_{R} ()) so that

The segment (which may be in nite) is called a base segment for the product region. Similarly de ne negative unstable product regions and stable product regions.

The main property of product regions is the following: for any F 2 F^{e_s} , G 2 F^{e_u} so that (i) F \ P \in ; and (ii) G \ P \in ;, then F \ G \in ;. To see why this is true, notice rst that (ii) in plies that; \in G \ = p. By (i) let q 2 with F \ $\overline{\mathbb{M}}_+^{u}$ (q) \in ;. Then F 2 J_+^{u} (q) hence F 2 J_+^{u} (p), that is F \ G \in ;. This is the reason for the term inology product region.

The purpose of this section is to show that the existence of product regions implies that the ow is R-covered. The main diculty is that we will not assume that is transitive. With the additional hypothesis of transitivity the proof of this fact is simple and was done in Fe5].

Given e > 0 and $z \ge M$, let $e^s(z)$ be the segment in $\overline{W}^{ss}(z)$ centered at z and with length e.

Theorem 5.2 Let be an Anosov ow in M 3 . If there is a product region in M then is R-covered. Furtherm ore any leaf of \mathbf{F}^{es} intersects every leaf of \mathbf{F}^{eu} and vice versa. As a result is topologically conjugate to a suspension Anosov ow.

Proof of 5.2: By lifting to a nite cover if necessary suppose that is orientable. A sum e that there is a positive unstable product region de ned by $\overset{\text{ff}}{\Rightarrow}$ ^{ss}(y₁). The proof will be achieved by producing bigger and bigger product regions in $\overset{\text{ff}}{\Rightarrow}$, which eventually llall of $\overset{\text{ff}}{\Rightarrow}$. This will show there is a product structure in $\overset{\text{ff}}{\Rightarrow}$ and hence that the ow is R-covered.

In this section we show that, if in nite branching occurs, then a particular type of structure, called a scalloped region, occurs in M. (or 0) and there is an embedded torus transverse to the ow. We then show that there are many examples with only nite branching.

Theorem 6.1 Let be an Anosov ow in M³. It there is in nite branching in \mathbb{P}^{e_s} , then there is associated in nite branching in \mathbb{P}^{e_u}

Proof of 6.1: Let $E = fE_{i}g_{i2Z}$ be an in nite, totally ordered collection of non separated leaves. A ssume they are not separated on their negative sides. Let $_{i}$ be the periodic orbit in E_{i} . Theorem 4.2 in plies that for any i, E_{i} form s part of the boundary of two bizenges: let $B_{2i 1}$ be the bizenge with (+;+) corner $_{i}$ and let B_{2i} be the bizenge with (+;) corner $_{i}$. Let $F_{i} 2 F^{es}$ be the other leaf in the boundary of B_{2i} and B_{2i+1} , where B_{2i} and B_{2i+1} are in front of F_{i} . Let $_{i}$ be the periodic orbit in F_{i} , see g. 12. Then the $fF_{i}g_{i2Z}$ F^{es} are all non separated from each other on their positive sides. Furtherm ore all B_{i} intersect a common stable leaf.

Let C_i be the back of $\overline{\mathbb{W}}^{u}(_{i})$ and let $C = [_{i2N} C_i$. The set L is a union of adjacent lozenges. Then for any p;q 2 $\overline{\mathbb{W}}^{u}(_{0})$ and any i > 0, $\overline{\mathbb{W}}^{u}(_{i}) 2 J_{+}^{s}(p) \setminus J_{+}^{s}(q)$. If $C = \overline{\mathbb{M}}$, then the intersections of $\overline{\mathbb{W}}^{u}(_{i})$ with $\overline{\mathbb{W}}^{ss}(p)$ and $\overline{\mathbb{W}}^{ss}(q)$ are escaping to in nity in these leaves. contradiction. Hence the leaves $g^n (\bar{\#}^u (p)); n \ 2 \ Z$ are all distinct and all non separated from each other on their negative sides. By theorem 4.4, $g^n (\bar{\#}^u (p))$ are all periodic and let f be the indivisible covering translation leaving all invariant and acting as an expansion in the set of orbits in $\bar{\#}^u (p)$.

Notice that $g(\[mathbf{m}]^{s}(p))$ is in front of $\[mathbf{m}]^{s}(p)$. Let $H_{0} = \[mathbf{m}]^{u}(p); H_{1}; :::; H_{n} = g(\[mathbf{m}]^{u}(p))$ be the chain of non separated leaves from $\[mathbf{m}]^{u}(p)$ to $g(\[mathbf{m}]^{u}(p))$. Theorem 6.2 Let be an Anosov ow in M 3 orientable. If there is in nite branching in (say) \mathbb{F}^{s} then there is an embedded torus transverse to .

Proof of 6.2: A ssume rst that is orientable. We use the notation from the previous theorem . Let $_{(i;k)} = \oint_{a}^{a} u(_{i}) \setminus \oint_{a}^{a} s(_{k})$ an orbit of ^e. Since $_{(0;0)}$ $\overset{\text{ff}}{=} {}^{u}(_{0})$, $_{(0;0)}$ is not a periodic orbit of ^e. Therefore the last equation above implies that gf = fg. Furtherm ore $f^{n}g^{m} = id$, clearly implies that n = m = 0 so f;g generate a Z Z subgroup of $_{1}(M)$. Notice that this subgroup preserves L and hence also preserves @L.

After a sm all perturbation of D₁ near $(D_1, we may assume that D = (D_1)$ is a sm ooth closed surface transverse to . A priori D is only an immersed surface. Again after a sm all perturbation of D, we may assume that D is transverse to itself. Using cut and paste techniques [He, Ja], as explicit done by Fried [Fr], one can eliminate all triple points of intersection and double curves of intersection, transform ing D into a union of embedded surfaces transverse to .

A ny such surface has induced stable and unstable foliations hence it has zero Euler characteristic. It is transverse to the ow, hence it is two sided in M and as M is orientable, then this transverse surface has to be a torus.

If is not orientable, the above proof can be applied to a double cover M^{0} of M where the lifted ow is orientable. The image in M of the transverse torus in M^{0} is an (immersed) torus in M and again cut and paste techniques yield the result.

R em arks: (1) W ith much more work, one can in fact show there is a transverse torus T intersecting exactly those orbits in (L). This is done in detail by Barbot in the proof of theorem B in [Ba3] where the hypothesis are the existence of two commuting covering translations f;g, so that both f and g are associated to (di erent free hom otopy classes of) closed orbits of in M.

(2) As mentioned earlier the Anosov ow constructed by Bonatti and Langevin has in nite branching. The scalloped region of this ow was explained in detail in [Fe5]. The Bonatti-Langevin ow is the simplest Anosov ow with in nite branching in the sense that there is only one orbit of which does not intersect the transverse torus T. In this case all periodic

orbits in \mathbb{Q} L are lifts of . The picture in \mathbb{M} is very symmetric.

We now prove that a large class of Anosov ows in dimension 3 have only nite branching. If the branching is nite we de ne its length to be the

number of non separated leaves.

Theorem 6.3 Any Anosov ow obtained by the Franks-W illiam s construction [Fr-W i] is not R -covered and has only length 2 branching.

Proof of 6.3: First we recall the Franks-W illiam s construction [Fr-W i]. Start with a suspension Anosov ow $_0$ in N and a closed orbit -. M odify the ow in a neighborhood of using Sm ale's DA (derived from Anosov) construction [Sm, W i], so that - becomes an expanding orbit and 2 new hyperbolic orbits $_1$ and $_2$ parallel to - are created, see g. 14, a. This produces the new ow in N.

O ne can do this in a way that the stable foliation is still preserved by the new ow. Now remove a solid torus neighborhood V of $^-$ with a boundary torus T_1 , transverse to the ow. This creates a manifold $M_1 = N$ V where the ow is incoming in the boundary. There is an induced stable foliation in $@M_1 = T_1$, which has two closed leaves and two Reeb components in between them. U sing a time reversal of this ow construct M_2 with a boundary torus T_2 where the ow is outgoing and there is an induced unstable foliation in T_2 . Finally glue T_1 to T_2 so that after glueing the stable and unstable foliations are transverse. Let T be the torus obtained by glueing T_1 to T_2 . Franks and W illiam s show that such ow s are Anosov and clearly intransitive since T is a separating torus. Hence the ow s are not R -covered.

By theorem 4.4, any branching of \mathbb{P}^{e_s} and \mathbb{P}^{e_u} produces freely hom otopic closed orbits, so we rst understand free hom otopies. Let and be freely hom otopic closed orbits of . and let : A ! M be an annulus realizing the free hom otopy. A ssum e that A is in general position and is transverse to T. Notice that $\mathbb{Q}A = [$ is disjoint from T. Then ¹(T) is a union of closed curves in A. We can elim inate all null hom otopic components as follows: since T is transverse to , it is incompressible [Fe4]. Then any null hom otopic component of ¹(T) also produces a null hom otopic curve in T. U sing cut and paste arguments [He, Ja] and the fact that M is irreducible we can elim inate this component by a hom otopy of the annulus. We may then assume that ¹(T) is a union of nitely many curves parallel to $\mathbb{Q}A$.

Let now B_1 be the closure of a component of A (¹ (T)) containing a boundary component of A. Let $@_1B$ be this boundary component (suppose that $(@_1B) =$) and let $@_2B = @B @_1B$. Assume that $(B_1) M_1$. Notice that M_1 bers over the circle with ber F a torus minus a disk. Any closed orbit of in M_1 has non zero algebraic intersection with F, hence the same is true for the other boundary of B, that is $@_2B$ is not a multiple

The DA construction is equivalent to spliting $\overline{\mathbb{M}}^{u}(\Gamma)$ into two and blow – ing air in between the 2 sides [W i], much in the sense of essential lam inations [G a-O e]. In particular there is a topological sem icon jugacy between and

0. Hence free hom otopies between closed orbits of produce a free hom otopy between two closed orbits of $_0$ in N. But any free hom otopy in a suspension is trivial [Fe3]. Therefore is either $_1$ or $_2$ and the free hom otopy can be hom otoped into W $^{\rm s}(_1)$ (or into W $^{\rm s}(_2)$).

Furtherm ore M $_1$ is acylindrical, that is, any properly immersed annulus can be hom otoped into the boundary. This is due to W aldhausen (for a proof see [Jo]) and follows from the fact that M $_1$ is atoroidal (in fact it is hyperbolic [Th2]), M $_1$ not a Seifert bered space and @M $_1$ is a single torus.

These two facts in ply that the only non trivial free hom otopies between closed orbits of can always be hom otoped into T. Notice that there are such free hom otopies, since $_1$ is freely hom otopic to $_2$ in M $_1$ and also there are two closed orbits of in M $_2$ which are freely hom otopic to each other and freely hom otopic to $_1$. These orbits are associated to the 4 closed leaves of the induced stable and unstable foliations in T.

As a result of this, in order to understand branching in the universal cover all we need to do is understand the structure of F^{e_s} ; F^{e_u} induced in lifts of T. Since there are two closed leaves in $F^{s} \setminus T$ and Reeb components in

between them and similarly for $F^u \setminus T$, the picture in the universal cover of T is as in g. 14 b. This shows that $F_1 \ge F^{es}$ is not separated from F_2 on their negative sides, F_2 not separated from F_3 in their positive sides and so on. This implies that F_1 is separated from F_3 . Therefore F_2 is the only leaf non separated from F_1 which is in the negative side of F_1 . We conclude that in such ows any branching has length two.

7 Continuous extension of A nosov foliations

If is an Anosov ow in M³, Sullivan [Su] showed that the intrinsic geometry of leaves of \mathbb{P}^{e_s} and \mathbb{P}^{e_u} is negatively curved in the large as dened by G rom ov [Gr]. This holds without any assumption on M. Then any leaf F 2 \mathbb{F}^{e_s} [\mathbb{F}^{e_u} has a canonical compactication with an intrinsic ideal boundary \mathbb{Q}_1 F [Gr]. We proved in [Fe2] that \mathbb{Q}_1 F is always homeomorphic to a circle.

If F 2 F^{es} then the intrinsic ideal points correspond to the (distinct) negative limit points of ow lines in F and to the common positive limit point of all ow lines [Fe3]. The intrinsic geometry of F 2 F^{es} resembles that of the hyperbolic plane H² where the ow lines correspond to the geodesics in H² which have a common limit point in the ideal boundary of H², see g. 15. A nalogous results hold for F^{eu} .

If $p \ge F \ge F^{es}$, we define $p \ge e_1 \ge 1$ to be the intrinsic negative limit point of the ow line through p, that is $p = \lim_{t \ge 1} e_t(p)$, where the limit

is taken in F [$@_1$ F, see g. 15. Sim ilarly de nep₊. For any p;q 2 F 2 F^{es}, p₊ = q₊ 2 $@_1$ F and this is also denoted by F₊. Furtherm one if p_i 2 # ^{ss} (p) and p_i ! 1 in # ^{ss} (p), then (p_i) ! p₊ as points in $@_1$ F [Fe3]. This can be clearly seen in the model of the hyperbolic plane.

Notice that p = q for any p; q in the same ow line of e, so this is also denoted by () 2 Q_1 F and sim ilarly ()₊ = F₊.

From now on we assume that $_{1}$ (M 3) is negatively curved as defined by G rom ov [G r]. G rom ov constructed a canonical compactification of M with an ideal boundary (M \cdot W hen M is inreducible (always the case for us), Bestvina and M ess [Be-M e] showed that (M is hom eom orphic to a sphere, denoted by S_{1}^{2} . Furtherm ore M [S_{1}^{2} is hom eom orphic to a closed 3-ball. Recall that the foliations F^{es} ; F^{eu} are transversely oriented.

Denition 7.1 The limit set of a subset B of M^{f} is $_{B} = \overline{B} \setminus S_{1}^{2}$, where the closure is taken in M^{f} [S_{1}^{2} . Given F 2 F^{es} or F^{eu} and p 2 S_{1}^{2} $_{F}$, we say that p is above F if there is a neighborhood U of p in M^{f} [S_{1}^{2} so that U $\setminus M^{f}$ is in front of F. O therwise we say that p is below F. Given a connected component of S_{1}^{2} $_{F}$ either all of its points are above F and we say this component is above F or all points are below F and we say the component is below F. Sim ilarly for G 2 F^{eu} .

P roposition 7.2 Let be an Anosov ow in M ³ with negatively curved ${}_{1}M$). Either ${}_{F} = S_{1}^{2}$ for every F 2 F^{es} ; or for every F 2 F^{es} , $S_{1}^{2} {}_{F}$ has at least one connected component above F and one component below F.

Proof of 7.2: Classical 3-dimensional topology [He, Ja] and Sm ale's spectral decomposition theorem [Sm] im ply that is transitive [Fe4].

We may assume that F^s; F^u are transversely orientable. Suppose there is F 2 F^{es} with $_{\rm F}$ \notin ; Assume that there is a component Z of S²₁ $_{\rm F}$ which is above F. Since stable leaves are dense in M, then for every L 2 F^{es} there is a covering translation g with g(L) in the back of F and so that F;g(L) intersect a common unstable leaf. Then Z \ $_{g(L)}$ = ; and since Z is in front of F, it is also in front of g(L). Therefore there is a component of S²₁ $_{g(L)}$ above g(L). Translating by g¹ we conclude that there is a component of S²₁ $_{L}$ above L.

If were R-covered, then $_{\rm F} = S_1^2$ [Fe2], contrary to assumption. Hence is not R-covered and by transitivity, it follows that has branching in the positive and negative directions [Fe5]. Let then E; E⁰2 F^{es} so that they

are not separated on their negative sides. By the above argum ent $S_1^2 = E$ has a component Z_0 above E. Since E is in the back of E^0 and E^0 is in the back of E it follows that $Z_0 \setminus_{E^0} = i$ and all points in Z_0 are below E^0 . Hence $S_1^2 = E^0$ has a component below E^0 . Using the same argum ent as above we conclude that for every $L = 2 F^{es}$, there is a component of $S_1^2 = E^{es}$ below L. This completes the proof.

We say that ^e has the continuous extension property if for any leaf F 2 F^{es} [F^{eu} , the embedding '_F : F ! M, extends continuously to '_F : F [$@_1 F$! M [S_1^2 . This gives a continuous parametrization of the limit sets $_F = '_F (@_1 F)$. This also implies that there is a continuous function

$$:M ! S_1^2; (x) = \lim_{t \to 1^+} e_t(x);$$

where the limit is computed in \mathbb{M} [S_1^2 . Since the function is constant along an orbit of ^e, this will also denote (). Furthermore for any G 2 \mathbb{F}^{e_u} , is a constant function in G with value '_G (G). Similarly de ne + : \mathbb{M} ! S_1^2 . The continuous extension property in plies that for any p 2 F 2 \mathbb{F}^{e_s} , $_F = '_F (\mathbb{Q}_1 F) = (\mathbb{M}^{s_s}(p)) [+(p).$

In [Fe6] we study the continuous extension property for R -covered ows.

Theorem 7.3 Let be an Anosov ow in M 3 with negatively curved $_1$ (M). Suppose that is not R-covered and in addition that $^{\rm e}$ has the continuous extension property. Then for any leaf C 2 $F^{\rm es}$ [$F^{\rm eu}$, the limit set $_{\rm C}$ is a Sierpinski curve, that is the complement of a countable, dense union of open disks in the sphere S_1^2 .

Proof of 7.3: W e m ay assume that $F^s; F^u$ are transversely orientable. W e rst prove that $_C \notin S_1^2$ and then use part of the proof of this fact to show that limit sets are Sierpinski curves. The rst part is the same as the proof of theorem 5.5 of Fe4]. In Fe4] we used the hypothesis of quasigeodesic behavior of ow lines of e in order to describe the structure of branching of F^{es} and F^{eu} . In this article we obtained a description of branching without any hypothesis and this is what is needed for the proof of theorem 7.3.

Since is transitive, F^{es} has branching in the positive and negative directions. Using theorem 4.8 we produce , a union of two adjacent lozenges in \dot{M} (or O) intersecting a common stable leaf so that: (1) the boundary of has unstable sides in G;S 2 F^{eu} , and stable sides in E;F;L 2 F^{es} (2)

ibig enough. Therefore (F $_i)$ Y 0 and as a result $_{\rm F_i}$ is contained in the closure of Y 0 and is not S $_1^2$.

We can now apply the previous proposition to deduce that for any $L^{0}2$ F^{es} , there are components of S_1^2 L^0 above L^0 and components below L^0 .

For each i let Z_i be a component of S_1^2 F_i below F_i . Since C is in front of F_i , $Z_i \setminus_C =$; Hence Z_i is contained in a component Z_i of $S_1^2 \cap_C$ which is below C. The argument above used to prove that $C \in S_1^2$ shows that $F_i \cap_C$, hence the component Z_i of $S_1^2 \cap_C$ is equal to Z_i .

For each i, Z_i is below F_i . In addition for each i \notin j, F_i is in the front of F_j and F_j is in the front F_i . This implies that $Z_i \setminus Z_j = ;$. Hence $fZ_ig;i2$ N is an in nite family of distinct components of S_1^2 C below C. Using branching of F^{es} in the negative direction, one constructs countably many components of S_1^2 C above C.

Since is transitive, then for any C⁰2 F^{es} there is a covering translation f so that $f(C^0) \setminus G$; Since S²₁ $_{f(C^0)}$ has in nitely m any components above and below $f(C^0)$, translation by f¹ yields the same result for C⁰.

Notice that these arguments also in ply that for every leaf F⁰2 F^{es} either F⁰ is in the back of C, hence F⁰ m isses at least all components of S²₁ C above C for xed C; or F⁰ is in front of C and F⁰ m isses all components of S²₁ C below C for a xed C. In particular this in plies that there is > 0 so that every F⁰ m isses at least some disk of radius in S²₁.

Suppose now that for some R in \mathbb{F}^{e_s} , R has no empty interior. Let h be a covering translation with both xed point in the interior of R. By applying h^n for n big we get $g^n(R)$ is almost all of S_1^2 except for an arbitrarily small neighborhood of the attracting xed point of h. This contradicts the previous paragraph. This nishes the proof of the theorem.

because the intrinsic negative lim it points of h^n () converge in $@_1 F$ to the positive lim it point associated to F and in addition F extends continuously to S_1^2 . This would imply (x) = +(x), a contradiction to x being in a periodic orbit. Similarly $(x_1) \in +(x)$. This proves the lemma.

We now prove a local property of the lim it sets. Given L 2 F^{es} , L is the im age of $Q_1 \perp S^1$ under a continuous map, hence L is locally connected.

Theorem 7.5 Let be an Anosov ow in M ³ with negatively curved fundamental group. Assume that has the continuous extension property. Given any L 2 \mathbb{F}^{e_s} or \mathbb{F}^{e_u} and any p 2 L, then for each neighborhood U of p 2 S_1^2 , L \ U is neither a Jordan arc nor a Jordan curve.

Proof of 7.5: Since $_{\rm L}$ is locally connected, we can choose U so that U \setminus $_{\rm L}$ is connected.

A ssume that U \ $_{\rm L}$ is a Jordan arc or Jordan curve and let z be a relative interior point. Suppose that $z \notin _{+}(L)$. Then $z = (c^0)$ for some $c^0 2$ L and there is $e^0 > 0$ sm allenough so that the segment $_{e^0}^{\rm s}(c^0)$ # ^{ss} (c^0) (as de ned in section 5), satisfies $(_{e^0}^{\rm s}(c^0))$ U \ $_{\rm L}$. As this is connected we can assume this is a Jordan arc. Since periodic orbits are dense in M, choose c in a periodic orbit of $e^{\rm n}$ near c^0 and let e > 0 so that the segment $_{e^0}^{\rm s}(c^0)$ if and only if it intersects $_{e^{\rm s}}^{\rm s}(c)$. Therefore is continuous, hence a homeomorphism. This implies that $(S^1) = {}_C$ is a Jordan curve. If is R-covered this contradicts the fact that ${}_C = S_1^2$. If is not R-covered this contradicts theorem 7.3. The result follow s.

8 Non R-covered Anosov ows in hyperbolic 3-m an ifolds

Theorem 8.1 There is a large class of non R-covered Anosov ows in hyperbolic 3-m anifolds, including all Anosov ows in non orientable hyperbolic 3-m anifolds.

Proof of 8.1: Theorem C of [Ba2] states that if is an R-covered Anosov ow in M³, then either is topologically conjugate to a suspension Anosov ow or the underlying manifold is orientable (notice that Barbot uses the term \product" instead of R-covered). Since hyperbolic manifolds can never be the underlying manifolds of suspension Anosov ow s, it su ces to produce Anosov ow s in non orientable hyperbolic 3-manifolds.

Consider therefore the suspension of an orientation reversing Anosov dieomorphism of the torus T 2 . Let M be the underlying manifold of the

suspension and let be an orientation preserving closed orbit of the ow. As described by Goodman [Go] and Fried [Fr], one can do Dehn surgery along this orbit. Then (n;1) Dehn surgery on yields an Anosov ow in the surgered manifold M $_{(n;1)}$.
