# Structures and Diagram matics of Four Dimensional Topological Lattice Field Theories

#### Abstract

C rane and Frenkel proposed a state sum invariant for triangulated 4-m anifolds. They de ned and used new algebraic structures called H opf categories for their construction. C rane and Y etter studied H opf categories and gave some examples using group cocycles that are associated to the D rinfeld double of a nite group.

In this paper we de ne a state sum invariant of triangulated 4-m anifolds using C rane-Y etter cocycles as B oltzm ann weights. O ur invariant generalizes the 3-dim ensional invariants de ned by D ijkgraaf and W itten and the invariants that are de ned via H opf algebras. W e present diagram m atic m ethods for the study of such invariants that illustrate connections between H opf categories and m oves to triangulations.

### 1 Introduction

W itten's formulation [45] of an intrinsic de nition of the Jones polynom ial [22] based on physical models lead to the more rigorous mathematical de nitions via representations of quantum groups that were given by Reshetikhin, Turaev, and V iro [40], [43]. These quantum invariants are speculated to generalize to higher dimensions. Such putative invariants have their origins in a theory of quantum gravity [4] and higher categories [5]. In relation to the current work, the following progress has been made.

Quantum spin networks were generalized by C rane-Yetter [16] to give 4-m anifold invariants that were based on O oguri's proposal [36]. The invariants can be used to compute the signature as shown in [41, 14, 15]. B irm ingham -R akow ski [8] generalized the D ijkgraaf-W itten [18] invariant of 3-m anifolds, de ned by group 3-cocycles, to triangulated 4-m anifolds using pairs of cocycles. C rane and Frenkel [13] constructed H opf categories to de ne 4m anifold invariants, and they gave examples using canonical bases of quantum groups. In [17] C rane and Yetter used cocycles to construct H opf categories.

In this paper we provide direct relations between the cocycle conditions of [17] and Pachner m oves of 4-m anifolds, thus constructing a generalization of the D ikgraafW itten invariants to dimension 4. The relations are established diagram m atically, providing connections between H opf categorical structures and triangulations via dual graphs and their m ovies.

The current paper is self-contained, but the reader m ight enjoy our introduction to the subject given in [10], where m any of our ideas and m otivations are introduced in a m ore leisurely fashion. For the diagram m atic foundation of the invariants in dimension 3 see [25], [26], and [24]. For the algebraic approach see [9]. Finally, there is a relation to higher dimensional knot theory as found in [11].

Let us continue our motivational remarks. In 3 dimensions, planar diagrams played a key role in the de nitions of both knot invariants and manifold invariants. Such diagrams are convenient since they help one grasp the categorical and algebraic structures needed for de ning invariants. One of the di culties in generalizing to dimension 4 or higher is the lack of such visualizations and diagram matic machinery. The purpose of this paper is to provide basic diagram matic tools to study 4-manifold triangulations, and to use such form ulations to de ne invariants.

In particular, we form ulate the C rane-Frenkel approach in terms of cocycles as initial data and prove the invariance under Pachner m oves in a diagram m atic way. We introduce spin networks for the study of such invariants. We hope that the present work serves as a basic tool in exploring the possibilities in higher dimensions.

There is a close relationship bew teen certain physical models in statistical mechanics and quantum eld theory and the form ulation of \quantum " invariants of knots, links and three-manifolds. We hope that this relationship continues into dimension four. In particular, one can hope that a four dimensional toplogical eld theory (such as we study here) would be related to the calculation of amplitudes in quantum gravity. The naive reason for this hope is quite simple: An amplitude for quantum gravity must sum over the possible metrics on the four-dimensional spacetime. A veraging over metrics should in principle produce basic numbers that are metric-independent. In other words a valid process of averaging over metrics should produce topological invariants of the underlying four-space. O focurse on the physical side it will be neccessary to extricate the topological part from the complexities of the model. On the pure mathematical side it will be neccessary to see the relevance of the mathematics. Nevertheless this hope for an application to quantum gravity is one of the forces that drives our project.

The organization of the paper is as follows. In Section 2, we review state sum invariants for triangulated m anifolds in dim ensions 2 and 3. W e em phasize diagram m atic relations between triangulations and algebraic structures. At the end of the section, we sum marize the idea of categori cation in relation to the construction of higher dimensional invariants. In Section 3 we present diagram s of Pachner m oves in dimension 4. We also introduce singular m oves in dimension 4, and prove that singular m oves together with 3-dimensional Pachner moves in ply 4-dimensional Pachner moves. These Lemmas will be used to prove the well-de nedness of our invariants. In Section 4 we give generalization of spin networks to dim ension 4. Triangulations are represented by m ovies of graphs, and these graph m ovies will be used to give a direct relation between H opf category structures and triangulations. C ocycle conditions de ned by [17] will be reviewed in Section 5. Sym metry of cocycles are de ned. In Section 6 the state sum invariants will be de ned, and will be proved to be well-de ned in Section 7. Our proofs are diagram matic. They provide the basic machinery necessary to de ne other invariants de ned via Hopf categories. The axiom s of Hopf categories are related to moves on triangulations of 4-m anifolds in a manner similar to the relationship between Hopfalgebras and moves on 3-manifolds. Section 8 reviews the de nition of Hopf category and m ake the connection with the rest of the paper.

## 2 Quantum 2-and 3-m anifold invariants

In this section, we review topological lattice eld theories in dimension 3 and explain how they are generalized from those in dimension 2. First we review dimension 2 following [21, 12] where sem i-simple algebras are used. An alternative approach is given by Law rence in [33] in which the algebra is assumed to be Frobinius. Next the Turaev-V iro [43] theory is reviewed following [9] and [26]. Invariants of 3-m anifolds derived from Hopf algebras are presented following [12]. A Iternative approaches are found in Kuperburg [30] and K au man-Radford [27]. Some of the sum mary appeared in [10]. We sum marize W akui's de ntion [44] of the D ikgra -W itten invariants [18], but here we show invariance using the Pachner Theorem. This section closes with a conceptual scheme for generalizing to dimension 4.

2.1 Topological lattice eld theories in dimension 2. Let A denote a nite dimensional associative algebra over the complex numbers C. Let  $f_{ijl} = 1$ ; ;ng denote an ordered basis for A, and for x; y; z 2 f1; :::; ng, let  $C_{xy}^{z}$  denote the structure constant of the algebra A. Thus the multiplication between basis elements is given by the formula:

$$x y = X C_{xy z}^{z}$$

Apply the associativity law, (ab)c = a(bc), to the basis elements as follows:

In this way, we obtain the equation

$$\begin{array}{c} X \\ C_{ab}^{j}C_{jc}^{d} = \begin{array}{c} X \\ C_{ai}^{d}C_{bc}^{i} \end{array}$$

whose geom etrical interpretation will be presented shortly.

For x; y 2 f1; 2; :::; n (= dim A)g, de ne

$$g_{xy} = \sum_{u,v}^{X} C_{ux}^{v} C_{vy}^{u}$$

Then this is invertible precisely when the algebra A is sem i-simple [21], and the matrix inverse  $g^{xy}$  of  $g_{xy}$  de nes a bilinear form on the algebra A. The geometric interpretation of this bilinear form and that of the associativity identity will allow us to de ne from a sem i-simple associative algebra, an invariant of 2-dimensional manifolds.

We follow the de nition given in [21]. Let T be a triangulation of a closed 2-dimensional  $m anifold F \cdot Let N = f1;2;$ ; ng. This is called the set of spins. Let  $ET = f(e; f)\dot{e}$ fq be the set of all the pairs of edges, e, and faces, f, such that e is an edge of f. The set ET is a partial ag. A labeling is a map L : ET ! N. Thus a labeling is an assignment of spins to all the edges with respect to faces. G iven a labeling, we assign weightings to faces and edges as follows: Suppose that we are given functions C and q, C : N<sup>3</sup> ! C, C (x;y;z) =  $C_{xyz}$ and  $g: N^2 ! C, g(x; y) = g^{xy}$ . If a face has three edges labeled with spins x; y; z, then assign the complex number  $C_{xyz}$  to the face. It is assumed that the function C posesses a cyclic sym m etry; so  $C_{xyz} = C_{yzx} = C_{zxy}$ . If an edge is shared by two faces, and the edge with respect to these faces receives spins x and y, then assign the complex number  $g^{xy}$  to the edge. Then de ne a partition function (T) by  $_{L}^{Q}$  C<sub>xyz</sub> $g^{uv}$  where the sum is taken over all the labelings and the product is taken over all the elements of ET. Values of  $C_{xyz}$  and  $g^{\mu\nu}$  are given in terms of the structure constants for the algebra and the bilinear form  $g_{\mu\nu}$ in the fourth paragraph forward. First, we discuss topological aspects that motivate their de nition.

In order for the partition function to be topologically invariant, it cannot depend on the choice of triangulation. There are two steps in constructing such an invariant quantity. First, we work topologically. There is a set of local moves to triangulations that su ces to relate any two triangulations of a given manifold. These moves were discovered by Pachner [37] in the general case of n-manifolds, and they generalize a classical theorem of A lexander [2]. Therefore for the partition function to be independent of the choice of triangulation, it is su cient to prove that the weighting assigned to triangles and edges satis es equations that correspond to these local moves. The second step, therefore, is algebraic. We seek functions C and g that satisfy these equations. We will indicate that the structure constants of an associative algebra can be used for the function C and that the bilinear form on A can be used to de ne the function g, as the notation suggests.

Let us consider the topological aspects. The Pachnerm oves in dimension 2 are depicted in Figure 1. The move on the left of Figure 1 is called the  $(2 \ 2)$ -move; that on the right is called the  $(1 \ 3)$ -move. The names of the moves indicate the number of triangles that are involved.

We now intepret associativity and the bilinear form in a sem isimple algebra over C in terms of the Pachner moves. Speci cally, the  $(2 \ 2)$ -Pachner moves is related to the associativity law (ab)c = a (bc). The relationship is depicted in Figure 2. The dual graphs, indicated in the Figure by dotted segments, are sometimes useful for visualizing the relations between triangulations and the algebraic structure. The diagram given in Figure 3 illustrates the geometrical interpretation of the bilinear form  $g_{xy} = \begin{bmatrix} v \\ u,v \end{bmatrix} C_{xu}^{v} C_{yv}^{u}$ : In the gure, two triangles share two edges in the left picture, representing the local weighting  $\begin{bmatrix} u \\ u,v \end{bmatrix} C_{xu}^{v} C_{yv}^{u}$ , and the right represents a single edge corresponding to  $g_{xy}$ . Finally, this relationship together with the associativity identity can be used to show that the partition function is invariant under the (1  $\ 3$ )-Pachner m ove. The essence of the proof is indicated in Figure 4.

Having illustrated the algebra axiom s diagram matically, we turn to show how the structure constants and the bilinear form of associative sem is in ple algebras solve the equations corresponding to the Pachner moves. G iven, structural constants  $C_{xy}^{z}$  and a non-degenerate bilinear form  $g^{uz}$  with inverse  $g_{uz}$ , de ne  $C_{xyu}$  by the equation (using E instein summation convention of summing over repeated indices),

Then since

$$\sum_{j}^{X} C_{ab}^{j} C_{jc}^{d} = \sum_{i}^{X} C_{ai}^{d} C_{bc}^{i}$$

the partition function de ned in this way is invariant under the  $(2^{\prime} 2)$ -m ove. Furtherm ore, we have (again, under sum m ation convention)

$$C_{de}^{a}C_{ab}^{j}C_{jc}^{d} = C_{de}^{a}C_{ai}^{d}C_{bc}^{i} = g_{ie}C_{bc}^{i} = C_{ebc};$$

and so the partition function is invariant under the  $(1 \ 3)$ -m ove. In this way, a sem isimple nite dimensional algebra de ness an invariant of surfaces. On the other hand, given a partition function one can de ne a sem i-simple algebra with these structure constants and that bilinear form. In [21], this is stated as Theorem 3:

The set of all TLFTs is in one-to-one correspondence with the set of nite dimensional sem i-simple associative algebras.

Observe that the  $(1 \ 3)$ -m ove follows from the  $(2 \ 2)$ -m ove and a non-degeneracy condition. In the sequel, we will see similar phenonem a in dimensions 3 and 4.

In general, the idea of de ning a partition function to produce a manifold invariant is (1) to assign spins to simplices of a triangulation, and (2) to nd weightings that satisfy equations corresponding to Pachner moves. This approach, of course, depends on nding such solutions to (offen extrem ely overdeterm ined) equations. Such solutions com e from certain algebraic structures. Thus one hopes to extract appropriate algebraic structures from the Pachner moves in each dimension. This is the motivating philosophy of quantum topology.

In the following sections we review such invariants in dimension 3 in more detail to explain such relations between triangulations and algebras.

2.2 Pachner m oves in dimension 3. In this section we review the Pachner m oves [37] of triangulations of m anifolds in dimension 3. The Pachner m oves in n-dimensions form a set of m oves on triangulations such that any two dimensions of a manifold can be related by a sequence of m oves from this set. Thus, two triangulations represent the same m anifold if and only if one is obtained from the other by a nite sequence of such m oves. In Figure 5 the 3-dimensional Pachner m oves are depicted, these are called the (2 ) 3)-m ove and the (1 ) 4)-m ove.

Notice that the 2-dimensional Pachner moves relate the faces of a tetrahedron. Speci – cally, the (2 <sup>\*</sup> 2)-m ove consists of two pairs of triangles and they together form a tetrahedron (Figure 6). Meanwhile, the (1 <sup>\*</sup> 3)-m ove relates three triangular faces of a tetrahedron to

the remaining face. The three triangles form the central projection of a tetrahedron. A nalogous facts are true for the 3-dimensional Pachnerm oves as well; let us explain. One side of each move is a union of 3-faces of the boundary of a 4-sim plex and the other side of the move is the rest of the 3-faces, and they together form the boundary of a 4-sim plex. For exam ple, the  $(1 \ 4)$ -move indicates two 3-balls on the boundary of a 4-sim plex as they appear in a central projection of the sim plex.

In F igure 6, the relation between faces of a tetrahedron and their dual graphs is depicted. The m iddle picture shows pairs of front and back faces of a tetrahedron on the center left. Note that these pairs represent the  $(2 \ 2)$  Pachner m ove (as indicated by the vertical double arrow in the m iddle). Thus the  $(2 \ 2)$  Pachner m ove corresponds to a tetrahedron, a 1-dimensionally higher simplex. On the right of the gure, the change on dual graphs is depicted by dotted lines. In Figure 7, a sim ilar correspondence is depicted for the  $(2 \ 3)$  Pachner m ove. Here faces of unions of tetrahedra are depicted from left to right, in two di erent ways that correspond to the Pachner m ove. These are the faces taken from the union of tetrahedra depicted in top and bottom of the gure, respectively. The dual graphs are also depicted, which are the graphs used for the B iedenham-E lliott identity of the 6j-sym bols. This direct diagram m atic correspondence is pointed out in [9].

2.3 Turaev-V iro invariants. One way to view the Turaev-V iro invariants [43, 26] is to \categorify" the TLFT in dimension 2. In this process, the sem i-simple algebra is replaced by a sem i-simple monoidal category | namely the category of representations of  $U_q$  (sl(2)) where q is a primitive 4rth root of unity. First we review the de nition of the Turaev-V iro invariants, and then explain the view point mentioned above.

A triangulation of a 3-m anifold is given. A coloring, f, is admissible if whenever edges with colors a;b; j bound a triangle, then the triple (a;b; j) is a q-admissible triple in the sense that

If edges with labels a; b; c; j; k; n are the edges of a tetrahedron such that each of (a; n; k), (b; c; n); (a; b; j), and (c; j; k) is a q-adm issible triple, then the tetrahedron, T, receives a weight of  $T_f = \begin{cases} a & b & n \\ c & k & j \end{cases}$ : If any of these is not adm issible, then the weight associated to a tetrahedron is, by de nition, 0.

For a xed coloring f of the edges of the triangulation of a 3-m anifold M , the value

is associated where t is the number of vertices in the triangulation, the st product is taken over all the edges in the triangulation, the second product is over all the tetrahedra, the factor is a normalization factor (= const.) and f(E) is a certain quantum integer

associated to the color of the edge E . To obtain an invariant of the manifold one form s the sum  $$_{\rm X}$$ 

where the sum is taken over all colorings. Further details can be found in [43, 26] or [9].

Several points should be made here. First, the sum is nite because the set of possible colors is nite. Second, the quantity M j is a topological invariant because the 6j-symbols satisfy the Beidenham-Elliott identity and an orthogonality condition. The orthogonality is a sort of non-degeneracy condition on the 6j-symbol. In [26, 9] it is shown how to use orthogonality and Beidenham-Elliott (together with an identity am ong certain quantum integers) to show invariance under the  $(1 \ 4)$  m ove. Third, the 6j-symbol is a measure of non-associativity as we now explain.

The situation at hand can be seen as a categori cation. In 2-dimensions associativity (ab)c = a(bc) played a key role. In 3-dimensions the 6j-symbols are dened by comparing two dimensions threaketting ( $V^a \quad V^b$ )  $V^c$  and  $V^a \quad (V^b \quad V^c)$  of representations  $V^a, V^b$ , and  $V^c$ . Here the algebra elements became vector spaces as we went up dimensions by one, and the symbol measuring the dimension in associativity satis as the next order associativity, corresponding to the Pachnerm ove.

Given representations  $V^a$ ,  $V^b$ ,  $V^c$ , we can form their triple tensor product and look in this product for a copy of the representation  $V^k$ . If there is such a copy, it can be obtained by regarding  $V^k$  as a submodule of  $V^a$   $V^n$  where  $V^n$  is a submodule of  $V^b$   $V^c$ , or it can be obtained as a submodule of  $V^j$   $V^c$  where  $V^j$  is a submodule of  $V^a$   $V^b$ . From these two considerations we obtain two bases for the set of  $U_q$  (sl(2)) maps  $V^k$ !  $V^a$   $V^b$   $V^c$ . The 6j-symbol is the change of basis matrix between these two.

Considering such inclusions into four tensor products, we obtain the Biedenham-Elliott identity. Each such inclusion is represented by a tree diagram. Then the Biedenham-Elliott identity is derived from the tree diagrams depicted in Fig. 7.

2.4 Invariants de ned from Hopfalgebras.

In this section we review invariants de ned by Chung-Fukum a-Shapere [12] and Kuperberg [30] (we follow the description in [12]). We note that the invariants obtained in this section are also very closely related to the invariants de ned and studied by Hennings, Kau – m an, R adford and O tsuki (see [27] for exam ple). For background m aterial on H opfA lgebras see [42] or [34], for exam ple.

2.4.1 De nition (Bialgebras). A bialgebra over a eld k is a quintuple (A;m;;;) such that

- 1. (A;m; ) is an algebra where m : A A ! A is the multiplication and : k ! A is
  the unit. (i.e., these are k-linear maps such that m (1 m) = m (m 1), m (1 ) =
  1 = m ( 1)).
- 2. : A ! A A is an algebra hom om orphism (called the comultiplication) satisfying (id ) = ( id) ,

3. : A ! k is an algebra hom om orphism called the counit, satisfying ( id) = id = (id ) .

2.4.2 De nition (Hopfalgebras). An antipode is a map s: A ! A such that m (s 1) = m (1 s) .

A Hopfalgebra is a bialgebra with an antipode.

The image of the comultiplication is offen written as  $(a) = a_1 \quad a_2$  for a 2 A. The image in fact is a linear combination of such tensors but the coe cients and the summation are abbreviated; this is the so-called Sweedler notation [42]. The most important property from the present point of view is the compatibility condition between the multiplication and the comultiplication (i.e., the condition that the comultiplication is an algebra hom on orphism), and we include the commuting diagram for this relation in Figure 8. The condition is written more speci cally  $m = (m \quad m) \not B$  () where  $P_{23}$  denotes the permutation of the second and the third factor:  $P_{23}(x \quad y \quad z \quad w) = (x \quad z \quad y \quad w)$ . In the Sweedler notation, it is also written as  $(ab)_1$  ( $ab)_2 = a_1b_1$   $a_2b_2$ .

The denition of invariants dened in [12] is similar to the 2-dimensional case. Given a triangulation T of a 3-m anifold M, give spins to edges with respect to faces (triangles). The weights then are assigned to edges and to faces. The structure constants  $C_{xyz}$  (resp.  $_{xyz}$ ) of multiplication (resp. comultiplication) are assigned as weights to faces (resp. edges). If an edge is shared by more than three faces, then a composition of comultiplications are used. For example for four faces sharing an edge, use the structure constant for (1). The coassociativity ensures that the other choice  $\begin{pmatrix} 1 \\ P \end{pmatrix}_Q$  gives the same constant  $_{v_1,v_2,v_3,v_4}$ . Thus the partition function takes the form  $(T) = {P \atop_L} C_{xyz} v_1; v_1; v_2$ . This form ula exhibits the form of the partition function for this model, but is not technically complete. The full form ula uses the antipode in the Hopf algebra to take care of relative orientations in the labellings of the simplicial complex. See [12] for the details.

In [12] the well de nedness was proved by using singular triangulations | these generalize triangulations by allowing certain cells as building blocks. In this case the move called the cone move for a singular triangulation plays an essential role. This move is depicted in Figure 9 with a dual graph to illustrate the relationship to the compatibility condition.

Let us now explain the relation of this move to the compatibility condition verbally. In the left hand side of Fig. 9 there are distinct and parallel triangular faces sharing the edge

(12) and (13); these triangles have di erent edges connecting the vertices 2 and 3. One of these is shared by the face (234) while the other is shared by the face (235).

The parallel faces (123) and (123)' are collapsed to a single face to obtain the right hand side of F ig. 9. Now there is a single face with edges (12), (23), and (31), and the edge (23) is shared by three faces (123), (234), and (235).

The thick segments indicate part of the dual graph. Each segment is labeled by Hopf algebra elements. Reading from bottom to top, one sees that the graphs represent maps from A A to itself. The left-hand-side of the gure represents

while the right-hand-side represents

and these are equal by the consistency condition between multiplication and comultiplication. This shows that the Hopf algebra structure gives solutions to the equation corresponding to the cone move.

That the partition function in this case does not depend on the choice of triangulation is proved by showing that the Pachnerm oves follow from the cone move and other singular moves. Figure 10 explains why the  $(2 \ 3)$ -move follows from singular moves (this gure is basically the same as a Figure in [12]).

Let us explain the gure. The rst polyhedron is the right-hand-side of the  $(\cancel{2})$  3)-m ove. There are three internal faces and three tetrahedra. Perform the cone m ove along edge (25) thereby duplicating face (125). Internally, we have face (125) glued to face (235) along edge (25) and face (125)<sup>0</sup> glued to face (245) along edge (25)<sup>0</sup>. These faces are depicted in the second polyhedron. By associativity these faces can be replaced by four faces parallel to four faces on the boundary; (123), (135), (124), (145). This is the con guration in the third polyhedron. Then there are two 3-cells bounded by these parallel faces. Collapse these cells and push the internal faces onto the boundary (this is done by singular moves). The result is the fourth polytope which now is a single polytope without any internal faces. This is the middle stage in the sense that we have proved that the right-hand-side of the  $(2 \ 3)$ -m ove is in fact equivalent to this polytope.

Now introduce a pair of internal faces parallel to the faces (135) and (145) to get the fit polytope (the left bottom one). Perform associativity again to change it to a pair of faces (134) and (345) to get the sixth polytope. Perform a cone move along the pair of faces with vertices (345): These faces share edges (35) and (45); edge (34) is duplicated.) The last picture which is the left-hand-side of the  $(2 \ 3)$ -m ove.

In sum m ary, we perform cone m oves and collapse som e 3-cells to the boundary and prove that both sides of the Pachner m ove is in fact equivalent to the polyhedral 3-cell w ithout internal faces. We give a generalization of this Theorem to dimension 4 in Lemmas 32.4, 32.5, and 32.6.

2.5 D ijkgraaf-W itten invariants. We review the D ijkgraaf-W itten invariants for 3dimensional manifolds. In [18] D ijkgraaf and W itten gave a combinatorial de nition for Chem-Sim ons invariants with nite gauge groups using 3-cocycles of the group cohom ology. We follow W akui's description [44] except we use the Pachner moves. See [44] for more detailed treatments.

Let T be a triangulation of an oriented closed 3-m anifold M , with a vertices and n tetrahedra. Give an ordering to the set of vertices. Let G be a nite group. Let : foriented edges  $g \mid G$  be a map such that

Then the Dijkgraaf-Witten invariant is de ned by

Here a denotes the number of the vertices of the given triangulation, W (;) =  $[g_{1h}k]$ where  $(hv_0;v_1i) = g$ ,  $(hv_1;v_2i) = h$ ,  $(hv_2;v_3i) = k$ , for the tetrahedron =  $jv_0v_1v_2v_3j$ with the ordering  $v_0 < v_1 < v_2 < v_3$ , and = 1 according to whether or not the orientation of with respect to the vertex ordering m atches the orientation of M.

Then one checks the invariance of this state sum under Pachnerm oves, see Figure 11.

2.6 Sum mary: Going up dimensions. As we reviewed the invariants in dimensions 2 and 3, there are two ways to go up the dimension from 2 to 3. One way is to consider

the algebras form ed by representations of quantum groups as in Turaev-V iro invariants. In this case algebra elements are regarded as vector spaces (representations) and algebras are replaced by such categories. This process is called categori cation. The second way is to include a comultiplication in addition to the multiplication of an algebra as in Hopf algebra invariants and consider bialgebras (in fact Hopf algebras) instead of algebras.

Crane and Frenkel de ned invariants in dimension 4 using these ideas. We reach at the idea of the algebraic structure called Hopf categories either by (1) categorifying Hopf algebras, or (2) including comultiplications to categories of representations. The following chart represent this idea.



In the following sections we follow this idea to de ne invariants in dimension 4.

We also point out here that the theories reviewed above have remarkable features in that they have direct relations between algebraic structures and triangulations via diagram s

(trivalent planar graphs, or spin networks). On the one hand such diagram s appear as dual com plexes through m ovie descriptions of duals of triangulations, and on the other hand they appear as diagram m atic representations of m aps in algebras. In the following sections we explore such relations and actually utilize diagram s to prove well-de ned-ness of the invariants proposed by C rane and Frenkel.

## 3 Pachner M oves in dim ension 4

In Section 2.2 we reviewed the Pachner m oves for triangulations in dimensions 2 and 3 and their relations to associativity of algebras. In this section, we describe Pachner m oves in dimension 4. Relations of these m oves to the Stashe polytope was discussed in [10].

In general, an n-dimensional Pachner move of type (i j), where i + j = n + 2, is obtained by decomposing the (spherical) boundary of an (n + 1)-simplex into the union of two n-balls such that one of the balls is the union of i n-simplices, the other ball is the union of j n-simplices, and the intersection of these balls is an (n 1)-sphere. By labeling the vertices of the (n + 1)-simplex these moves are easily expressed. For example, the table below indicates the lower dimensional Pachner moves:

The relationship between the general Pachnerm ove and the higher order associativity relations are explained in [10]. Next we turn to a more explicit description of the 4-dimensional Pachner M oves.

3.1 4-dim ensional Pachner m oves. In this section we explain the 4-dim ensional Pachner m oves. One side of a 4-dim esional Pachner m ove is the union of 4-faces of a 5-sim plex (hom eom orphic to a 4-ball), and the other side of the m ove is the union of the rest of 4-faces.

In Figures 12 13, and 14 the  $(3 \ 3)$ -m ove,  $(2 \ 4)$ -m ove, and  $(1 \ 5)$ -m ove are depicted, respectively. Recall here that each 3-dimensional Pachner m ove represents a 4-sim plex. Therefore the 3-dimensional Pachner m ove depicted in the top left of Figure 12, the m ove represented by an arrow labeled (01234), represents the 4-sim plex with vertices 0, 1, 2, 3 and 4. Then the left-hand side of Fig. 12 represents the union of three 4-sim plices (01234) [ (01245) [ (02345). 3.2 Singular m oves. In dimension 4, the Pachner m oves can be decomposed as singular m oves and lower dimensional m oves. Here we de ne a 4-dimensional singular m oves (called cone, pillow, taco m oves) and show how the Pachner m oves follow. This material was discussed in [10].

3.2.1 De nition (cone move). The cone move for CW -complexes for 4-manifolds is de ned as follows.

Suppose there is a pair of tetrahedra  $(1234)_1$  and  $(1234)_2$  that share the sam e faces (123), (124) and (134), but have di erent faces  $(234)_1$  and  $(234)_2$ , such that (1)  $(234)_1$  and  $(234)_2$  bound a 3-ballB in the 4-m anifold, (2) the union of B,  $(1234)_1$  and  $(1234)_2$  is di eom orphic to the 3-sphere bounding a 4-ballW in the 4-m anifold.

The situation is depicted in Figure 15 which we now explain. The left-hand-side of the Figure has two copies of tetrahedra with vertices 1, 2, 3, and 4. They share the same faces (123), (124), and (134) but have two di erent faces with vertices 2, 3, and 4.

Collapse these two tetrahedra to a single tetrahedra to get the right-hand-side of the Figure. Now we have a single tetrahedron with vertices 1, 2, 3, and 4. The face (234) now is shared by three tetrahedra (1234), (2348), and (2349) while three faces (123), (124), and (134) are shared by two tetrahedra.

3.2.2 D e nition (taco m ove). Suppose we have a CW -com plex such that there is a pair of tetrahedra  $(1234)_1$  and  $(1234)_2$  that share two faces (123) and (124) but have di erent faces  $(134)_1$ ,  $(134)_2$  and  $(234)_1$ ,  $(234)_2$  (of  $(1234)_1$ ,  $(1234)_2$  respectively). Suppose further that  $(134)_1$ ,  $(134)_2$ ,  $(234)_1$ , and  $(234)_2$  together bound a 3-cell B and  $(1234)_1$ ,  $(1234)_2$ , and B bounds a 4-cell. Then collapse this 4-cell to get a single tetrahedron (1234). As a result  $(134)_1$  (resp.  $(234)_1$ ) and  $(134)_2$  (resp.  $(234)_2$ ) are identi ed. This move is called the taco move.

3.2.3 D e nition (pillow move). Suppose we have a CW -complex such that there is a pair of tetrahedra sharing all four faces cobounding a 4-cell. Then collapse these tetrahedra to a single tetrahedron. This move is called the pillow move.

3.2.4 Lem m a. The (3 ) Pachner m ove is described as a sequence of cone m oves, pillow m oves, taco m oves, and 3-dim ensional Pachner m oves.

Proof. The proof can be facilitated by following the Figures 16 through 24. Figure 16 is a preliminary sketch that indicates in dimension 3 the methods of the subsequent gures. It illustrates that the  $(2 \ 5 \ 3)$ -move in dimension 3 can be interpreted in terms of the  $(2 \ 5 \ 2)$ -move via a non-generic projection. The thick vertical line on the left-hand-side of the gure is the projection of the triangle along which the two tetrahedra are glued. The thick horizontal line on the right is the projection of one of the three triangles that are introduced on the right-hand-side of the move. The other two triangles project to ll the lower right quadrilateral. The dotted lines indicate that som e edges in the gure will project to these lines. Som e information is lost during the projection process, but at worst, the projected gures serve as a schematic diagram of the actual situation.

In Fig. 17 the union of the three 4-sim plices (ABCDE), (ACDEF), and (ABCEF) is illustrated; these share the triangle (ACE) which is shaded in gure. The union form s the left-hand-side of the of the (3  $^{\circ}$  3)-m ove. Let P denote this union. In the top of Fig. 18, the triangle (ACE) has been projected to the thick line (EAC). At the bottom of Fig. 18, the 4-sim plex (ACEF) has been split into sim plices (ACEF)<sub>1</sub> and (ACEF)<sub>2</sub> by a cone m ove. The cone m ove is illustrated in this projection, and the schem atic resembles the cone m ove in dimension 3 as is seen on the bottom left of the gure. Thus (ACEF) and (ACEF)<sub>2</sub> share the same faces (ACE), (AEF) and (CEF) but have di erent faces (ACE) and (ACE)<sub>2</sub>. The face (ACE)<sub>1</sub> is shared with (ABCE) and the face (ACE)<sub>2</sub> is shared with (ACDE) respectively.

A fter the splitting, P consists of three 4-polytopes,  $\frac{1}{j}$ , j = 1;2;3. Here the polytope  $\frac{1}{1}$  is bounded by tetrahedra (ABCD), (ABDE), (ABCE), (ACDE), (BCDE), (ACEF), and (ACEF)<sub>2</sub>. The polytope  $\frac{1}{2}$  is bounded by tetrahedra (ABCE), (ABEF), (ACEF)<sub>1</sub>,

(ABCF), and (BCEF). The polytope  $\frac{1}{3}$  is bounded by tetrahedra (ACDE), (ACEF)<sub>2</sub> (ACDF), (ADEF), and (CDEF). The polytope  $\frac{1}{1}$  corresponds to (ABCDE) and it is illustrated on the left bottom of Fig. 18 (labeled (ABCDE) to indicate the correspondence). On the bottom right of the gure, we see the polytope  $\frac{1}{2}$  labeled (ABCEF). In the bottom center of the gure the polytope  $\frac{1}{3}$  labeled (ACDEF) to indicate its antecedent. Our rst work will be on  $\frac{1}{1}$  and  $\frac{1}{3}$ .

Next perform a Pachner m ove to the pair of tetrahedra (ACDE) [ (ACEF)<sub>2</sub> sharing the face (ACE)<sub>2</sub>. Note that these two tetrahedra are shared by  $\frac{1}{1}$  and  $\frac{1}{3}$  so that the Pachner m ove we perform does not a ect  $\frac{1}{2}$ . Thus we get three 4-cells  $\frac{2}{j}$ , j = 1;2;3, where  $\frac{2}{2} = \frac{1}{2}$ , and  $\frac{2}{1}$  is bounded by (ABCD), (ABDE), (ABCE), (BCDE), (ACEF)<sub>1</sub>, (ACDF)<sup>0</sup>, (ADEF)<sup>0</sup>, and (CDEF)<sup>0</sup>. Here (ACDF)<sup>0</sup>, (ADEF)<sup>0</sup>, and (CDEF)<sup>0</sup> denote new tetrahedra obtained as a result of perform ing a Pachnerm ove to (ACDE) [ (ACEF)<sub>2</sub>. Then the last polytope  $\frac{2}{3}$  is bounded by (ACDF)<sup>0</sup>, (ADEF)<sup>0</sup>, and (CDEF)<sup>0</sup> that are explained above, and (ACDF), (ADEF), (CDEF) that used to be faces of  $\frac{1}{3}$ .

The (2 3)-m ove to (ACDE) [ (ACEF) is illustrated in Fig. 19. In the upper left the the 4-cell  $_{1}^{2}$  is shown while  $_{3}^{2}$  is shown on the upper right. In the lower part of the gure the three new tetrahdera (ACDF)<sup>0</sup> (ADEF)<sup>0</sup>, and (CDEF)<sup>0</sup> are illustrated.

Then we can collapse  $\frac{2}{3}$  to the tetrahedra (ACDF), (ADEF), (CDEF) as in the following 3 paragraphs and 2 tables.

The polytope  $\frac{2}{3}$  is a 4-cellbounded by (ACDF), (ADEF), (CDEF), (ACDF)<sup>0</sup>, (ADEF)<sup>0</sup>, and (CDEF)<sup>0</sup>. The incidence relations for these tetrahdra are indicated in the next table. A los see the top two rows of Fig. 20.

Then perform the taco move to the pair (CDEF) and  $(CDEF)^0$  that share two faces (CDE) and (CEF). Thism ove is illustrated at the bottom of Fig. 20. Then the faces (CDF) and  $(CDF)^0$ , (DEF) and  $(DEF)^0$  are identified after the move respectively. The result is a 4-cell bounded by (ACDF), (ADEF),  $(ACDF)^0$ , and  $(ADEF)^0$ . (Precisely speaking these tetrahdera share new faces so that we should use the different labels, but adding a new layer of labels here will cause more confusion than leveing the old labels intact). The incidence relations among the triangles and the tetrahedra are summarized in the next table.

The cone move to (ADEF) and  $(ADEF)^0$  (which is illustrated schematically in Fig.21) followed by the pillow move to (ACDF) and  $(ACDF)^0$  collapses  $\frac{2}{3}$  to (ACDF) [ (ADEF) [ (CDEF) as claimed.

Thus we get two polytopes  ${}_{1}^{2}$  and  ${}_{2}^{2}$ . Next perform a Pachner move to (ABCE) [ (ACEF)<sub>1</sub> which shares (ACE)<sub>1</sub>. As a result we get three new tetrahedra (ABEF)<sup>0</sup> [ (ABCF)<sup>0</sup>[ (BCEF)<sup>0</sup>. The (2 \* 3)-m ove is illustrated in Fig. 22; the labels on the polytopes indicate their antecendents.

Thus we obtain  $\frac{3}{1}$  bounded by (ABCD), (ABDE), (BCDE), (ACDF), (ADEF), (CDEF), (ABEF)<sup>0</sup>, (ABCF)<sup>0</sup>, and (BCEF)<sup>0</sup>, and  $\frac{3}{2}$  bounded by (ABEF), (ABCF), (BCEF), (BCEF), and (ABEF)<sup>0</sup> [ (ABCF)<sup>0</sup> [ (BCEF)<sup>0</sup>.

Hence we now can collapse  $\frac{3}{2}$  to the tetrahedra (ABEF), (ABCF), and (BCEF) in the same manner as we did to  $\frac{2}{3}$ . The collapsing is indicated in Fig. 23. The result is a single polytope <sup>4</sup> resulted from  $\frac{3}{1}$  which has the same boundary tetrahedra as those of the left hand side of the 4-dimensional Pachner move. Figure 23 indicates the resulting polytope at the bottom of the gure. In Fig. 24 the 3-dimensional boundary is illustrated. Notice the following: (1) triangle (ACE) is no longer present; (2) among the nine tetrahedra illustrated, neither triangle (ACE) nor triangle (BDF) appears; (3) these are all of the tetrahedral faces of the 5 simplex that contain neither (ACE) nor (BDF). Thus we can apply the same method starting with (BDF) to get to this polytope. This proves that (3 \* 3)-m ove is described as a sequence of singular moves (cone, taco, and pillow moves) and Pachner moves.

3.2.5 Lem m a. The  $(2 \ 4)$ -m ove is described as a sequence of cone m oves, pillow m oves, taco m oves, and 3-dim ensional P achner m oves.

Proof. We use the following labeling for the  $(2 \ 1)$ -m ove in this proof:

(ABCDE) [ (ABCEF) ) (ABCDF) [ (ABDEF) [ (ACDEF) [ (BCDEF):

Perform a (3 % 3)-m ove (which was proved to be a sequence of the singular m oves in the preceeding Lemma) to (ABCDF) [ (ABDEF) [ (ACDEF) to get (ABCDE)<sup>0</sup> [ (ABCEF)<sup>0</sup> [ (ACDEF)<sup>0</sup>. Then the polytope now consists of (ABCDE)<sup>0</sup>, (ABCEF)<sup>0</sup>, (ACDEF)<sup>0</sup>, and (ACDEF).

Perform a Pachner move to the tetrahedra (ACDF) [ (ADEF) [ (CDEF), that are shared by  $(ACDEF)^0$  and (ACDEF), to get  $(ACDE)^0$  [  $(ACEF)^0$ .

This changes  $(ACDEF)^0$  [ (ACDEF) to a 4-cell bounded by (ACDE),  $(ACDE)^0$ , (ACEF), and  $(ACEF)^0$ . The cone m ove followed by the pillow m ove collapses this polytope yielding (ABCDE) [ (ABCEF), the left-hand-side of the  $(2 \ 4)$ -m ove. 2

3.2.6 Lem m a. The (1 \* 5)-m ove is described as a sequence of cone m oves, pillow m oves, taco m oves, and 3-dim ensional P achner m oves.

Proof. We use the following labelings:

(ABCDE) / (ABCDF) [ (ABCEF) [ (ABDEF) [ (ACDEF) [ (BCDEF):

Perform the  $(3 \ 3)$ -move to (ABCDF) [ (ABDEF) [ (BCDEF) to get (ABCDE) [  $(ABCEF)^{0}$  [  $(ACDEF)^{0}$ .

The 4-sim plices (ACDEF) and (ACDEF)<sup>0</sup> share all their tetrahedral faces except (ADEF) (and (ADEF)<sup>0</sup>). Perform a (1 % 3)-m ove to each of these shared tetrahedra to get 4-cells bounded by copies of (ADEF) sharing all the 2-faces. Thus the pillow m oves w ill collapse (ACDEF) and (ACDEF)<sup>0</sup>. The same argument collapses (ABCEF) [ (ABCEF)<sup>0</sup> to get the left-hand-side of the (1 % 5)-m ove. 2

3.2.7 R em ark. In [13] C rane and Frenkel proposed constructions of 4-m anifold quantum invariants using H opf categories. H opf categories generalize the de nition of H opf algebra to a categorical setting in the sam e way that m odular categories generalize m odules. O ne of the conditions in their de nition is called the coherence cube which generalizes the com patibility condition of H opf algebras between m utiplication and com utiplication (See Section 8). They showed that this condition corresponds to the cone m ove. Thus Lem m as in this section can be used to prove the well-de nedness of invariants they proposed by showing that their de nition is invariant under P achner m oves.

## 4 Triangulations and D iagram s

In dimension 3, quantum spin networks are used on the one hand to provide calculations of identities among representations of quantum groups [9]. On the other hand they are cross sections of the dual complex of a triangulated 3-m anifold (see Section 2.2).

In this section, we use similar graphs to relate them to the dual com plex of triangulated 4-m anifold. We begin the discussion on the local nature of triangulated 4-m anifolds near 2-dimensional faces.

4.1 G raphs, 2-com plexes, and triangulations. Let be a triangulation of an oriented closed 4-m anifold M . In this section we associate graphs to triangulations and their duals.

4.1.1 Denition. The dual complex of is dened as follows. Pick a vertex v of in the interior of each 4-simplex of . Connect two vertices  $v_1$  and  $v_2$  of if and only if the corresponding 4-simplices of share a 3-face. Thus each edge of is dual to a tetrahedron of . Edges  $e_1$ ;  $k_p ef$  bound a face f if and only if the corresponding tetrahedra share a 2-face of . A set of 2-faces  $f_1$ ;  $k_p eff$  bounds a 3-face (a polyhedron) if and only if the corresponding faces of share an edge of . Finally a set of 3-faces of bounds a 4-face if and only if the corresponding edges of share a vertex. Thus gives a CW -com plex structure to the 4-m anifold.

4.1.2 Denition. Let be a triangulation of a 4-m anifold M, and let be the dual complex. Each 3-face of is a polytope. Choose a triangulation of each 3-face into tetrahedra so that it denes a triangulation of the 3-skeleton of . We require that such a triangulation does not have interior vertices in the 2-faces of . Thus the restriction on each n-agonal 2-face consists of (n 2) triangles. Such a choice of triangulation is called a 3-face triangulation (a triangulation for short) of . A 3-face triangulation is denoted by '.

4.1.3 D e nition (Carrier Surface). In each tetrahedron of the triangulation , we em - bed the dual spine to the tetrahedron. The intersection of the dual spine with a triangular face is a graph consisting of a 3-valent vertex with edges intersecting the edges of the tetrahedron. There is a vertex in the center of the 2-com plex at which four edges (corresponding to the faces of the tetrahedron) and six faces (corresponding to the edges) intersect. The union (taken over all tetrahedra in the triangulated 4-m anifold) of these 2-com plexes form a 2-com plex, C, that we call the carrier surface. Let us exam ine the incidence relations of the carrier surface along faces and edges of the triangulation.

Consider a 2-face, f, of the triangulation . Suppose that n tetrahedra are incident along this triangle f. Then the dual face f is an n-gon. The 4-m anifold in a neighborhood of the face f looks like the C artesian product f f. The carrier surface in this neighborhood then appears as Y X<sub>n</sub> where X<sub>n</sub> is the 1-com plex that consists of the cone on n-vertices (i.e., the n-valent vertex), and Y is the graph that underlies that alphabet character (a neighborhood of a trivalent vertex). For example X<sub>2</sub> is an interval, X<sub>3</sub> = Y, X<sub>4</sub> = X, etc. W e can think of X<sub>n</sub> being embedded in f with the edges of X<sub>n</sub> intersecting the centers of the edges of f and the vertex of X<sub>n</sub> lying at the \center" of f (i.e. we may assume that f is a regular polygon).

Consider an edge, e, of , and the 3-cell, e, that is dual to e. The faces of e are n-gons, f, that are dual to the triangular faces, f, which are incident to e. The carrier surface intersects a face f in the graph X<sub>n</sub>. The carrier surface intersects e in a 2-com plex that is the cone on the union of the X<sub>n</sub> where the union is taken over all the faces of e.

The situation is depicted in Fig. 25 in which three tetrahedra intersect along a triangular face. On the right hand side of the gure, we illustrate a graph movie. The two graphs that are drawn there represent the intersection of the carrier complex with the boundary of f f. In a neighborhood of this face the carrier complex looks like Y Y. In this and subsequent gures, the vertices that are labeled with open circles correspond to the dual faces f. In this gure, three such circled vertices appear since the dual face appears on each of the duals to the three edges.

4.2 Faces and diagram s. Suppose that the face (012) of a triangulation of a 4-m anifold is shared by three tetrahedra  $T_i$ , i = 1;2;3. Take a neighborhood N of the face (012) in the 3-skeleton of the triangulation such that  $N \setminus T_i$  is di comorphic to (012) I for each i = 1;2;3.

In Fig. 25 the projection of a neighborhood N of the face (012) is depicted in 3-space. Denote by  $0^0$ ,  $0^{00}$ ,  $0^{00}$  the vertices obtained from the vertex 0 by pushing it into  $T_i$ , i = 0;1;2; respectively (they are depicted in Fig. 25). Sim ilar notation is used for the other vertices.

The graph movie for N is constructed as follows. Regard N as a 3-dimensional polyhedral complex consisting of the following faces:  $(0^{0}1^{0}2^{0})$ ,  $(0^{00}1^{00}2^{00})$ ,  $(0^{00}1^{00}2^{00})$ ,  $(011^{0}0^{0})$ ,  $(010^{0}1^{00})$ ,  $(010^{00}1^{00}), (122^{0}1^{0}), (122^{00}1^{00}), (200^{0}2^{0}), (200^{0}2^{00}), (200^{00}2^{00}).$  Then trivalent vertices are assigned to the m iddle points of the triangular faces  $(0^{\circ}1^{\circ}2^{\circ})$ ,  $(0^{\circ}1^{\circ}2^{\circ})$ ,  $(0^{\circ}1^{\circ}2^{\circ})$ ,  $(0^{\circ}1^{\circ}2^{\circ})$ , and the m iddle points of the edges (01), (12), (20). These are connected by segments as indicated in the gure where this 1-complex is depicted in two parts. The middle point in the interior of N is the cone point of this 1-dim ensional com plex. W ithin N we have an embedding of the Cartesian product Y Y where Y represents the obvious graph with one trivalent vertex. The graphs on the right of Fig. 25 represent portions of the boundary of Y Y. The space Y is indicated in Fig. 26 in which the subspace Υ Y, where denotes a vertex, is indicated as a fat vertex times Y. The labels on the Figure will be explained in Section 6.1.1 and Fig. 34.

Below (Sections 6.4 and 8) we will relate these spin networks to cocycle conditions in a speci cHopfcategory. In this way, we will obtain a direct connection among these structures.

4.2.1 De ntion. We perturb the carrier surface to construct a 2-dimensional complex that has the following properties:

1. The vertices of the complex all have valence 4 or valence 6.

2. Exactly three sheets m eet along an edge;

- 3. The set of edges can be partitioned into two subsets; we color the edges accordingly.
- 4. A valence 4 vertex has 4 edges of the same color incident to it;
- 5. A valence 6 vertex has 3 edges of each color incident to it.
- 6. Thus, the 2-complex has a tripartite graph as its 1-complex and a bipartition on the set of edges.

Such a 2-com plex will be called a perturbed carrier.

4.2.2 Lem m a. A perturbed carrier can be constructed from the carrier surface by m eans of a 3-face triangulation.

Proof. Consider a 3-face triangulation; recall this is a triangulation of the dual 3-cells of the triangulation , and a 3-face is the dual to an edge e. A n-agonal face of e is divided into (n 2) triangles. The graph  $X_n$  in the n-agonal face is replaced with the dual to the triangulation. In e, the cone on the union of the  $X_n$ s is replaced by the union of the duals to the tetrahedra in the triangulation. These are the surfaces with 6 faces, 1 vertex, and 4 edges; they glue together in e to form the subcom plex in which all of the vertices have one color. An example is illustrated in Fig. 27 in which the dual of an edge is a cube.

The vertices that have two di erent colored edges incident to them are found on the triangular faces of the 3-face triangulation. Three of the edges are coming from the dual face, the other three edges are coming from the dual com plex of the original tetrahedra. The local structure at the 6-valent vertices was explained in detail above. This com pletes the proof. 2

4.2.3 D e nition. A graph movie is a sequence of graphs that appear as cross sections of a portion of the perturbed carrier when a height function is chosen, such that the stills of movies are graphs having trivalent (circled and uncircled) vertices and between two stills, the movie changes in one of the following ways:

- 1. The change of the movie at a face (a 6-valent vertex of a carrier surface) is as de ned above (the change of graphs shown in Fig. 25).
- 2. The change of the movie at a 4-valent vertex is as depicted in Fig. 32 bottom .

3. The changes of the movie at critical points of edges and faces of the carrier surface is generic. They are depicted in Fig. 28.

In the graphs we use circled vertices and uncircled vertices. These are cross section of two types of edges. In the gures of carrier surfaces (Fig. 38, 39, and 27), the edges corresponding to circled vertices are depicted by thin tubes. The graph movie de ned here includes de nitions given above (which are clearly equivalent). The graph movie allows us to view the perturbed carrier via a sequence of 2-dimensional cross-sections whereas the carrier surface itself does not embed in 3-dimensional space.

4.3 Taco m oves and graph m ovies. Herein we directly relate the graph m ovies to the taco m ove. In Figs. 29 and 30 the left-hand-side and the right-hand-side of the taco m ove are depicted, respectively. In each gure, the underlying union of tetrahedra rem ains unchanged from frame to frame. Instead the thick lines change as follows. Consider the (i; j)th entry of the gure to be that illustration in the ith row jth column. Going from the (i; 1)st entry to the (i; 2)nd entry, the graphs change by one of the graph m ovie changes (either going across Y Y or going across tetrahedra). There is no change from the (i; 2)nd entry to the (i+1;1)st entry. In these gures thick lines indicate the graph that was de ned in Section 4.2. The transitions between the two entries on the same row m ay be visualized by m eans of a cross-eyed stereo-opsis. P lace a pen in the center of the gure, and m ove the pen tow ards your face while keeping it in focus. The two im ages on the left and right should converge into one with the thick lines popping out of the plane of the paper. In this way, the di erence between the gures can be experienced directly.

Observe that the di erences in the graphs are illustrated as well in the Fig. 36 which illustrates the graph movies for the cocycle conditions and which is obtained by purely algebraic information. The time elapsed version of the graph movie for the taco move is illustrated in Fig. 38 and Fig. 39. Sim ilar diagrams can be drawn for the cone move and the pillow move and in this way a direct correspondence can be obtained among the moves, the cocycle conditions, and the axiom s of a Hopf category (Section 8). The taco, cone, and pillow moves all correspond to the moves correspondence among these moves should not be surprising since all of these moves correspond to splitting a tetrahedron open (the higher dimensional analogue of the coherence relation between multiplication and comultiplication).

# 5 Cocycles and cocycle conditions

In this section, we list cocycles and their equalities that will be used in the following sections. These cocycles are given in [17] in relation to Hopf categories (See Section 8). Some non-trivial examples are given therein. First, we mention that two of the cocycle conditions are depicted in Figs. 36 and 37 as relations to graph movies where the edges of the graph have been colored with pairs of group elements and dual group elements. These graph movies correspond to the dual graphs that correspond to the taco move (Fig. 29 and 30). The coloring will be explained in the subsequent section.

Let G be a nite group and K be the multiplicative group of a eld K. Let  $C_{n,m} = C_{n,m}$  (G;K) denote the abelian group of all functions from  $G^n = \hat{G}^m$  to K where

W e need the following functions (called cocycles if they satisfy the conditions given in the next section).

5.2 C ocycle sym m etries. In addition to the above cocycle conditions, we will suppose that the cocycles satisfy some equations that correspond to the sym m etries of tetrahedra and of the space Y Y. The imposition of such conditions will be su cient to construct an invariant. We do not know if the sym m etry conditions are necessary. (They may be satis-

ed autom atically for certain cocycles, or the invariants m ay be de ned without symmetry conditions.)

5.2.1 De nition. The following are called the cocycle symmetries.

### 6 Labels, weights, and the partition function

6.1 Labeling. Let denote a triangulation of the 4-m anifold M, and let denote the dual complex. Each 3-face of is a polytope that corresponds to an edge of . Choose a triangulation of the 3-skeleton of . There are no interior vertices in the 2-faces of . Thus the restriction on each polygonal 2-face consists of (n 2) triangles. A sbefore, such a choice of triangulation is called a 3-face triangulation of . A 3-face triangulation is denoted by  $\frac{1}{2}$ .

W hen an order, O, is xed for the vertex set, V, we de ne the orientation of dual edges as follows. A vertex of is a 4-simplex of whose vertices are ordered. Then 4-simplices are ordered by lexicographic ordering of their vertices. This gives an order on vertices of , giving orientations of edges of . O rientations of edges of <sup>!</sup> are ones that are compatible with the above orientation.

6.1.1 De nition. A labeling (or color) of with oriented edges with respect to a nite group G is a function

where  $G = f(q; \hat{h}) 2 G$   $\hat{G}q$  and

Here E denotes the set of oriented edges, and T is the set of tetrahedra. We require the following compatibility condition.

If  $(e_1;e_2; e_3)$  form s an oriented boundary of a face of a tetrahedron t,  $S_0(e_1;t) = (k; \hat{})$ , and  $S_0(e_2;t) = (g;\hat{h})$ , then  $S_0(e_3;t) = (m;\hat{n})$ , where m = gk,  $n = \hat{}$ , and  $k^{-1}hk = \hat{}$ . We call this rule the boal rule of colors at a triangle (or simply a boal rule). The situation is depicted on the left of Fig. 31.

W hen an order of vertices is given, the edges are oriented by ascending order of vertices (if the vertices v and w of an edge have the order v < w, then the edge is oriented from v to w). However in this de nition the order on vertices is not required, although orientations on edges are required. For an oriented edge e, the sam e edge with the opposite orientation

is denoted by e. Consider the edge  $e_2$  on the left of Fig. 31, and reverse the orientation of  $e_2$  to get  $e_2$ . Then the color of  $e_2$  is required to be S ( $e_2$ ;t) = (g<sup>1</sup>;gk  $k^{d_1}g^1$ ) where S ( $e_2$ ;t) = (g;k  $k^{d_1}k^1$ ) as depicted in the gure. In other words, the color for an edge with reversed orientation is de ned to satisfy the local requirem ent of the left of Fig. 31.

We often use sets of non-negative integers to represent simplices of . For example, x a 3-face (or tetrahedron) T of . Let 0, 1, 2, and 3 denote the vertices of T. For a pair of an oriented edge (01) and a tetrahedron T = (0123) a labeling assigns a pair (g;ĥ) which we sometimes denote by  $S_0(01)(23) = S_0((01);(0123))$ . When a total order is xed, the integers are assumed to have the compatible order (0 < 1 < 2 < 3).

W e will show (Lemma 6.1.5) that there is a coloring of each tetrahedron satisfying the local rule. Furthermore, we will show that changing the orientations of edges of a colored tetrahedron results in a unique coloring.

6.1.2 De nition. A labeling (or color) of <sup>!</sup> with oriented dual edges is a function

Here  $E^{!}$  (resp. P) denotes the set of oriented edges (resp. 3-polytopes) of  $^{!}$  (resp. ). The following compatibility conditions are required.

If  $(e_1; e_2; e_3)$  form an oriented boundary of a face of a tetrahedron t of <sup>!</sup>, then the rst factors of colors (group elements) coincide, and if they are S<sup>!</sup> $(e_1;t) = (g; \hat{1})$ , and S<sup>!</sup> $(e_2;t) = (g; \hat{k})$ , then S<sup>!</sup> $(e_3;t) = (g; \hat{h})$ , where it is required that h = kl.

W hen an order of vertices is given, the edges are oriented by ascending order of vertices as before. Consider the edge  $e_2$  in the Fig. 31 right, and reverse the orientation of  $e_2$  to get  $e_2$ . Then the color of  $e_2$  is required to be S<sup>!</sup>( $e_2$ ;t) = (g; $k^{l_1}$ ) where S ( $e_2$ ;t) = (g;k) as depicted in the gure. In other words, the color for an edge with reversed orientation is de ned to satisfy the local requirem ent of the right side of Fig. 31.

In the gure, dual graphs in triangles are also depicted. We put a small circle around a trivalent vertex for the dual faces. As in the case for tetrahedra, dual tetrahedra can be colored, and changing the orientation for colored dual tetrahedra gives a unique new coloring (Lem m a 6.1.5). Note that there is a pair (p;e<sup>0</sup>) 2 EP <sup>!</sup> which is dual to a pair (e;t) 2 ET, in the sense that e<sup>0</sup> is dual to the tetrahedron t and p is dual to the edge e. How ever there are pairs in EP <sup>!</sup> that are not to dual to pairs in ET.

6.1.3 D e nition. A labeling (or color) of = [ ' is a function

such that  $S(p;e^0) = S(e;t)$  if  $(p;e^0) \ge EP^{!}$  is dual to  $(e;t) \ge ET$ . This function is also called a state. For a particular pair  $(e;t) \ge ET$  (resp.  $(p;e^0) \ge EP^{!}$ ), the image S(e;t) (resp.  $S(p;e^0)$ ) is also called a spin. This is sometimes denoted by  $S(p;e^0)$ .

6.1.4 De nition. We say that two simplices are adjacent if they intersect. We say a simplex and a dual simplex are adjacent if intersects the polyhedron of the dual complex in which is included.

6.1.5 Lem m a. (1) For a tetrahedron or dual tetrahedron, there are colors satisfying the local rule at every face or dual face.

(2) There are colors on the edges and dual edges adjacent to a given face satisfying the local rules.

(3) Let C be a color assigned to the oriented edges (or dual edges) of a tetrahedron (or dual tetrahedron). Let C<sup>0</sup> be a color assigned to the same tetrahedron (or dual tetrahedron) with orientations reversed on some of the edges. Then C<sup>0</sup> is uniquely determined. If the color C is assigned to oriented edges and dual edges that are adjacent to a face, then the color C<sup>0</sup> is uniquely determined when some of the edges or dual edges have their orientations reversed.

Proof. We prove (1) and (2) in the case of tetrahedra. The proof for dual tetrahedra is similar and follows from [44].

For tetrahedra, the situation is depicted in Fig. 32. In the top of the gure, a tetrahedron with colors on three edges is depicted. O ther edges receive compatible colors that are determ ined by these three. In the middle, pairs of front faces and back faces are depicted in the left and right respectively, together with dual graphs. In the bottom of the gure, only the dual graphs are depicted, together with colors on all the edges. We check that the rst factors of colors m atch in multiplication convention in Fig. 31. The second factors are also checked as follows: in the bottom left gure, '= m nm<sup>1</sup> and h = k 'k<sup>1</sup>. In the bottom right gure, '= m nm<sup>1</sup> k ' = k 'k<sup>1</sup>, the same relation as above. Thus the requirements on faces m atch at a tetrahedron.

To prove (3) for tetrahedra, rst consider the case where the orientation of the edge 23 is reversed. Then the face (123) forces the change S (23j0123) = (g<sup>1</sup>;gk Y<sup>d 1</sup>g<sup>1</sup>). The

other face (023) forces the change S ( 23j0123) = (g<sup>1</sup>; (gkm) f<sup>1</sup>(gkm) <sup>1</sup>). These are equal since '= m nm<sup>1</sup>. The situation is depicted in the top right of F ig. 33 where the reversed orientations are depicted by a small circle on the edge. The top left gure indicates the original colors. In the gure, the \hats" on the dual group elements are abbreviated for simplicity.

The other cases when the orientation of a single edge is reversed, are also depicted for the cases (0213), (1023). The general case follows because all cases are obtained by compositions of these changes.

Next consider statement (2). In Fig. 34 the colors are depicted using dual graphs (identify this graph with the graph in Fig. 25). First we check the orientation conventions in the

gure. Identify the circled vertex of the right-hand-side graph of bottom of Fig. 25 with the right-hand-side of Fig. 31. Then the orientation conventions of dual edges coincide where  $e_1$  of Fig. 31 corresponds to the edge (02) (0123),  $e_2$  to (02) (0125),  $e_3$  to (02) (0124). The tetrahedron (0123) is shared by (01234) and (01235), that are ordered as (01234) < (01235) < (01245) am ong three 4-sim plices. Thus this correspondence to  $e_1$  m atches with the de nition of the orientation of dual edges.

Now we check the constraints. In the left bottom of Fig. 25 the following relations must hold:  $i = km k^{1}$  (from the top left vertex),  $j = k'k^{1}$  (from the top right vertex), h = m' (from the bottom right vertex), and  $ij = khk^{1}$  (from the bottom left vertex). The last relation is reduced by substitution to  $k (m')k^{1}$  both sides, so that the weight is compatible. In the right of the gure, we get the relation h = m' from the top vertex, which is the same as above, and the condition for the bottom vertex is already incorporated (by using khk<sup>1</sup> in bottom left). Thus the colors around a face are compatible.

Now let us check that the orientation conventions are compatible in Fig. 34. The orientations on the edges are the orientations from the vertex ordering as seen in the gure. The orientations on dual edges are checked as follows. In the gure the face (012) is shared by three 4-sim plices, (01234), (01245), and (01235). The dual edge labeled by (gk;  $\hat{}$ ) is dual to the tetrahedron (0123) and oriented from (01234) to (01235), corresponding to the edge e<sub>1</sub> on the right of Fig. 31. Respectively, the one labeled by (gk;  $\hat{n}$ ) goes from (01235) to (01245) corresponding to e<sub>2</sub>, the one labeled (gk;  $\hat{h}$ ) goes from (01234) to (01245) corresponding to e<sub>3</sub>. Thus the orientations de ned from the order on vertices m atch the convention in Fig. 31.

To prove part (3), we check the cases of interchanging the orientation of some of the edges. The general case will follow from the cases depicted in Fig. 40 and 41 since the orientation changes depicted therein generate all the orientation changes.

First consider the case where the edge (12) has reversed orientation. This corresponds to changing the vertex order from (012345) in the gure to (021345). (The orientations on dual edges do not change.) Then three colors change:  $(g; \hat{i})$  to  $(g^{1}; (gk)m^{d}(gk)^{1})$ ,  $(g; \hat{j})$  to  $(g^{1}; (gk)m^{d}(gk)^{1})$ , and  $(g; kh^{d}k^{1})$  to  $(g^{1}; (gk)h^{d}(gk)^{1})$ . These changes are forced by the nules at faces (uncircled trivalent vertices of the graphs). Hence we check the nules at circled trivalent vertices. Proof. This follows from Lemma 422 and the de nition of S.2

6.2 W eighting. A weighting (also called a Boltzm ann weight) is de ned for each tetrahedron, face, edge of triangulations and 'as follows.

6.2.1 D e nition (weights for tetrahedra). Let T 2 be a tetrahedron with vertices 0, 1, 2, and 3. Suppose S (01j)123) = (m;  $\hat{n}$ ), S (12j)123) = (k;  $\hat{1}$ ), and S (23j)123) = (g;  $\hat{h}$ ).

The weight of T with respect to the given labelings of edges is a number (an element of the ground eld) de ned by

$$B(T) = B(0123) = (q;k;m;\hat{n})^{(T)}$$

Here (T) is 1 and is de ned as follows. Let  $T = (a_1; a_1; a_2; a_3)$  be the tetrahedron in consideration where  $a_0 < a_1 < a_2 < a_3$ . Then T is shared by two 4-simplices, say,  $S = (a_0; a_1; a_2; a_3; v)$  and  $(a_0; a_1; a_2; a_3; w)$ . Here we ignore the given labels of v and w, and consider the orders written above (v and w coming last). Then exactly one of these two 4-simplices, say, S, with this order  $a_0 < a_1 < a_2 < a_3 < v$ , m atches the orientation of the 4-m anifold, and the other has the opposite orientation.

Consider the label on v induced by the ordering on the vertices. If the integer index of v is such that the oriented simplex  $(a_0;a_1;a_2;a_3;v)$  is obtained from the order induced by labeling by an even permutation, then (T) = 1. O therwise, (T) = 1. (Sometimes we represent the order of vertices by labeling the vertices by integers.)

6.2.2 D e nition (weights for faces). Suppose that a face F = (012) is shared by three tetrahedra (0123), (0124), and (0125). Suppose  $S_0$  (01 $\dot{D}$ 123) = (k;  $\hat{N}$ ,  $S_0$  (12 $\dot{D}$ 123) = (g;k<sup>Q</sup>k<sup>1</sup>),  $S_0$  (02 $\dot{D}$ 123) = (gk;  $\hat{N}$ ),  $S_0$  (01 $\dot{D}$ 124) = (k; $\hat{h}$ ), and  $S_0$  (02 $\dot{D}$ 125) = (gk;  $\hat{m}$ ). The situation is depicted in Fig. 34.

Then the weight for the face F = (012) is de ned as the num ber

$$B(F) = B(012) = (g;k;m;1)^{(F)}$$

Here the sign (F) = 1 is de ned as follows. If the local orientation de ned by (012) in this order together with the orientation of the link (34) ! (45) ! (53) of F in this order gives the same orientation as that of the 4-m anifold, then (F) = 1, otherwise (F) = 1.

Suppose the face (012) is shared by n (m one than three) tetrahedra (012k), k = 3;; n. Note that the vertices of these tetrahedra other than 0;1;2 form a link of the face (012). A sum e that these vertices are cyclically ordered by 3;4; n, and that the link of (012) and (34) ! (45) ! ! (n3) m atches the orientation of the 4-m anifold. If the cyclic order of vertices is not as above, then it can be obtained from the above by transpositions. When a transposition between k-th and (k + 1)-st vertex occurs, change the argument of k-th weight  $(g;k;\mathfrak{m}_k;\mathfrak{m}_{k-1}^d \ _1\mathfrak{h}$  to  $(g;k;\mathfrak{m}_k^d;\mathfrak{m}_{k-1}^d \ _1\mathfrak{h})$ .

Notice that by the conditions in the de nition of a triangulation each face must be shared by at least three tetrahedra. However In the course of computation we may have to deal with singular triangulations. In this case it can happen that only two tetrahedra share a face. Let 0123 and 0124 be such two terahedra sharing the face 012. Then the weight assigned to the face 012 in this case is the product of K ronecker's deltas:

#### S (01 D123); S (01 D124) S (02 D123); S (02 D124) S (12 D123); S (12 D124)

There are other cases of singular triangulations that appear in our proofs of well-de nedness, and their weights are de ned as follows.

Suppose that two tetrahedra share vertices 0;1;2;3 and share all of their faces except (013). Meanwhile, suppose that the face (013) on each of the respective tetrahedra is shared with tetrahedra (0134) and (0135). The other faces are shared by the tetrahedra (0126), (0237), and (1238). The situation is depicted in Fig. 42 top. In the gure, colors and weights are also depicted. The signs for each weight are also depicted in the gure in this situation, by indicating the power 1 on one of the s.

Suppose in another situation that two tetrahedra share all vertices and all 2-faces (triangles) as depicted in Fig. 43. The signs for this situation are also depicted in the gure.

In general if the order of vertices are dierent, then they are obtained from the above species is situations by compositions of permutations. Then the weights and signs are deened by applying Lemma 6.1.5.

6.2.3 D e nition (w eights for edges). Consider the triangulation of the 3-sphere S<sup>3</sup> consisting of 5 tetrahedra (1234), (1235), (1245), (1345), and (2345), where integers represent the vertices. This triangulation is depicted in F igure 35 by solid lines. Here, the subdivided tetrahedron w ith vertices 2;3;4 and 5 w ith the interior vertex 1 is a triangulation of a 3-ball, and together w ith the \outside" tetrahedron (2345) they form a triangulation of S<sup>3</sup>. Now take a cone of this triangulation w ith respect to the vertex 0 to obtain a triangulation of a 4-ball consisting of 5 4-sim plices (01234), (01235), (01245), (01345), and (02345). This is

depicted in Figure 35 also, where edges having 0 as end point are depicted by dotted lines. (Regard dotted lines as lying in the interior of the 4-ball.)

Suppose an edge E = (01) has this particular triangulation as the neighborhood. Suppose  $S(01 \cancel{0}123) = (g; \cancel{3}), S(01 \cancel{0}124) = (g; \cancel{k}), and S(01 \cancel{0}125) = (g; \cancel{3}).$  Then the weight for the edge (01) is defined by

$$B(E) = B(01) = (q; \hat{j}; \hat{k}; \hat{j})^{(E)}$$

The sign (E) = 1 is de ned in the same manner as B (T) simply taking the dual orientations.

If the neighborhood of an edge has a di erent triangulation, then the weight is de ned as follows. Let  $H_1$ ;  $_{s}$ ; a 'be the set of tetrahedra of the polytope p 2 , and let  $h_i^j$  be the set of edges of  $H_i$ , j = 1; ;6. Then the weight is de ned by

B (E) =

where each is assigned to a tetrahedron of the above triangulation following the order convention of vertices. The product of the above expression is taken over all the shared edges, and the sum is taken over all the possible states on shared edges. The exponent, a, on the norm alization factor,  $1=j_{\rm G}$   $j^{\rm a}$ , is the num ber of verticies in the interior of the polyhedron dual to the given edge.

6.3 Partition function. Let be a triangulation of a 4-m anifold M with the set of vertices (resp. edges, faces, tetrahedra) V (resp. E, F, T). Fix also a triangulation  $\,^!$  of the dual  $\,$ .

6.3.1 D e nition. The partition function () for a triangulation = [ ! with a total order on vertices is defined by

where the product ranges over tetrahedra, faces and edges of the triangulation  $\,$ , the sum – m ation ranges over all the possible states, and the exponent a on the normalization factor is the number of vertices in the triangulation.

6.3.2 M ain Theorem . The partition function () de ned above for triangulations = [ ! of a 4-m anifold M is independent of the choice of the triangulation and ! and independent of choice of order on vertices.

Therefore the partition function de nes an invariant of a 4-m anifold M .

Section 7 is devoted to giving the proof of this theorem .

6.4 D iagram s, cocycles, and triangulations. Here we explain relations among diagram s, cocycles, and triangulations. Figure 31 illustrates the coloring rules at triangles and dual triangles. In these triangles and dual triangles graphs are embedded; the verticies of the graphs in the dual triangles are labeled by small circles. The cocycles are assigned to tetrahedra; the cocycles are assigned to dual tetrahedra, and the cocycles are assigned to triangular faces. Each such gure also corresponds to a graph m ovie which depicts a part of the perturbed carrier surface. We can think of the cocycles as being assigned to the vertices of the perturbed carrier surface which has a tripartition on its vertex set. Indeed the m any scenes that constitute the graph m ovie are found on the boundary of a regular neighborhood of the vertices of the carrier surface. In this way we can directly visualize the construction of the invariant as a colored surface with weighted vertices or as a colored graph m ovie with weights associated to the scenes.

Sim liarly, the cocycle conditions can be described as relations on m ovies of tree diagram s. Figures 36 and 37 depict these relations. Each change of a tree diagram (scene in the m ovie) corresponds to a cocycle as indicated. W hen we multiply the left-hand-side and the right-hand-side of cocycles in the m ovies, we obtain cocycle conditions among , , and .

The cocycle conditions can also be understood in terms of certain singular surfaces that are embedded in the 4-m anifold. These surfaces are depicted in Figs. 38 and 39. In these gures the cocycles corresponds to the surface (Y Y) and the cocycle corresponds to the surface that is dual to a tetrahedron. The assignment of to Y Y is indicated in the

weights on Fig. 26. The reasons for these assignments is that the cocycle is found when three tetrahedra share a triangular face, and the cocycle is assigned to a tetrahedra. In Figs. 38 and 39 some edges are denoted as tubes. A tube of the form Y corresponds to a triangle that is shared by three tetrahdra as in Fig. 25.

# 7 On invariance of the partition function

Recall the notation in Section 6: denotes a triangulation of a 4-m anifold M, its dual complex, 'a 3-face triangulation of . In Section 7.1 we show that the partition function de ned is independent of the order on vertices. In Section 7.2, we show that the partition function is independent of the triangulation. In Section 7.3 we show that the partition function is independent of the choice of dual triangulation.

7.1 Independence on order of vertices. In this section we prove

7.1.1 Lem m a. The cocycle symmetries imply the independence of the partition function on the order on vertices of the triangulation.

P roof. For tetrahedra and dual tetrahedra, the weights are the cocycles and respectively. As in [44], it is su cient to check how weights change when the order of vertices are changed from (0123) to (0132), (0213), and (1023). Such changes are illustrated in Fig. 33 for , and the corresponding conditions are listed for , and in Section 5.2.1.

For a face, we check as follows. In Fig. 34 an order of vertices are given, where the face is given by (012), and the other vertices are given labels 3, 4, and 5. The changes of orders

of vertices are generated by the changes from (012345) to (021345), (102345), (for the face) (012354), (012435), (for the dual face) since only the relative orders among the vertices of the face and those of the dual faces are in consideration. For these changes, the colors are listed in Fig. 40 and Fig. 41. They are depicted in terms of dual graphs, and on the right hand side, the orientations of edges of faces/dual faces are shown. The sm all circles indicate reversed orientations. The corresponding conditions are listed in Section 5.2.1.

If m one than three tetrahedra share a face, then a change in order of the vertices can be achieved by such pairwise switches. Futherm one, in order to a ect such changes, we may have to group the vertices in sets of 3. This grouping is achieved by a 3-face triangulation. So the proof will follow once we have shown invariance under the 3-face triangulation. 2

7.2 Independence under Pachner moves. In this section, we explicitly relate the cone move, taco move and pillow move to the cocycle conditions. Since these moves and lower dimensional moves generate the Pachner moves, we will use the cocycle conditions to show that the partition function is invariant under the Pachner moves.

7.2.1 Lem m a. The partition function is invariant under the cone move for a local triangulation with a speci c choice of order depicted in Fig. 42.

Proof. Let  $(0123)_1$  and  $(0123)_2$  be tetrahedra sharing the same faces (012), (013) and (023), but having di erent faces  $(123)_1$  and  $(123)_2$ , such that (1) the union of the triangles  $(123)_1$ [  $(123)_2$  bounds a 3-ball B in the 4-m anifold, (2) the union of B ,  $(0123)_1$  and  $(0123)_2$  is di eom orphic to the 3-sphere bounding a 4-ball W in the 4-m anifold. (See Figs. 15, 42.) In these gures, the movies of dual graphs are depicted where each of the faces (013), (023), (123) is shared by another tetrahedron ((0124), (0125), (0126), respectively). We prove the invariance in this case. The general case follows from such computations together with the pentagon identity of .

Fig. 42 shows the colors and cocycles assigned to this local triangulation (again note the direct relation between this assignment and those for the top graph in Fig. 36). The left hand side of the cone move (top of Fig. 42) has the local contribution

(note that the orientation of the face (9123) is opposite), and the right hand side of the cone m ove (bottom of the gure) has the local contribution

Thus the partition function is invariant under the cone move because the cocycle condition is satis ed. 2

7.2.2 Lem m a. The partition function is independent under the pillow move for a speci c local triangulation with the order depicted in Fig. 43.

Proof. In Fig. 43 the assignments of colors and cocycles are shown. The left hand side of the pillow move (top of Fig. 43) has the local contribution

and the right hand side of the pillow move (bottom of the gure) has the local contribution (g;k;m;pq): This follows from the cocycle condition used in the above lemma. 2

7.2.3 Lem m a. The partition function is independent under the taco move for a speci c local triangulation with the order depicted in Fig. 44.

Proof. In Fig. 44 the assignments of colors and cocycles are shown. The left hand side of the taco m ove (top of Fig. 44) has the local contribution

and the right hand side of the taco move (bottom of the gure) has the local contribution

This is exactly one of the cocycle conditions. 2

O bærve that the diagram m atics of the graph m ovie m ove that results from the taco m ove m atch exactly the graph m ovie m ove that represents the cocycle condition F ig. 36. Sim ilar graph m ovies can be drawn for the cone and pillow m oves and the correspondence with the m ove and the coycle conditions can be worked out via the graph m ovies. M aking such correspondence shows explicitly the m ethod of constructing invariants via H opf categories w here, instead of cocycle conditions, coherence relations are used. The coherence relations can be expressed by such graph m ovie m oves (See Section 8).

Since the partition function is invariant under the cone, taco, and pillow m oves, and since satis es a pentagon relation, we have the partition function is invariant under the Pachner m oves.

7.3 Independence on triangulations of the dual complexes. In this section, we complete the proof that the partition function is well-de ned by showing that the partition function does not depend on the 3-face triangulation, <sup>!</sup>.

7.3.1 Lem m a. If  $T_1$  and  $T_2$  are triangulations of a 3-dimensional polytope which is diecomorphic to a 3-ball such that  $T_1$  and  $T_2$  restrict to the same triangulation on the boundary, then they are related by a nite sequence of P achner moves.

Proof. We is prove the corresponding statement in dimension 2, then use the result in dimension 2 to achieve the result in dimension 3. In the proof we use the notation  $(i \ j)$ -move to indicate the move in which i simplices are replaced by j simplices. So the  $(j \ j)$ -move is the inverse move, and the order of i and j matter.

In dimension 2, we have two triangulations of the disk that agree on the boundary, and we are to show that they they can be arranged by Pachner moves xing the boundary to agree on the interior. We prove the result by induction on the number of vertices on the boundary.

Recall [39] [7], that the star of a k-simplex (in a simplicial complex) is the union of all the simplices that contain the k-simplex. The link of a k-simplex is the union of all the simplices in the star that do not contain the k-simplex. W e will exam ine the stars and links of vertices on the boundary of a disk (and later on the bounday of a 3-ball). So denote the

star of v with respect to the boundary by:  $st_s$  (v). Similarly, the link of v with respect to the boundary is  $lk_s$  (v) while these sets with respect to the interior are  $st_B$  (v) and  $lk_B$  (v), respectively.

In dimension 2, st<sub>s</sub> (v) is a pair of edges that share the vertex v. Meanwhile,  $\mathbb{k}_{B}$  (v) is a polygonal path properly embedded in the disk that is the most proximate to v among all paths in the interior that join the points of  $\mathbb{k}_{s}$  (v).

We x our consideration on one of the triangulations, say  $T_1$  of D<sup>2</sup>. We want to alter this triangulation so that  $lk_B$  (v) is an edge (so it has no interior vertices). If we can achieve this alteration, then we can perform similar moves to  $T_2$ . The vertex v on either triangulation then will become the vertex of a triangle that is attached to the disk along a single edge.

W e can rem ove such a triangle (or alternatively, work in the interior) and apply induction on the number of vertices on the boundary.

Consider an interior vertex,  $v^0$  in B. If the star of  $v^0$  in B is the union of three triangles at  $v^0$ , then we can remove this vertex from D by means of a (3 ) 1)-move. Perform such moves until there are no interior vertices of valence 3. In this way we may assume that a vertex,  $v^0 2$   $k_B$  (v) has valence larger than 3. If the valence of  $v^0$  is greater than 3, then there are a pair of triangles in st<sub>B</sub> (v) sharing edge v;  $v^0$  upon which a Pachner move of type (2 ) 2) can be performed. Such a move removes  $v^0$  from the link of v. A fter such a move, check for interior vertices of valence 3 and remove them by type (3 ) 1)-m oves. In this way we can continue until the link of v is an edge. If D is a triangle, then the process will reduce the triangulation until there are no interior vertices.

Now we min ic the proof given in dimension 2, to dimension 3. First, assume that an interior vertex  $v^0$  in D<sup>3</sup> has as its star the union of 4 tetrahedra. Then we may eliminate such an interior vertex by means of a type (4 1) Pachner move.

Consider the link,  $\mathbb{I}_{B}$  (v) of a vertex, v, on the boundary. If this link is a triangle, then we may eliminate the vertex from the boundary, as in the 2-dimensional case. For the star of v is a single tetrahedron that is glued to the ball along a single face.

M ore generally,  $s_s$  (v) is a union of triangles forming a polygon, so  $s_s$  (v) is the cone on the polygon  $k_s$  (v) where v is the cone point. Consider the disk properly embedded in B that is the link of v. This link,  $k_B$  (v), is a triangulated disk. There is a sequence of 2-dimensional Pachner moves that change  $k_B$  (v) to a triangulation of an n-gon, with no interior vertices. We use these 2-dimensional moves to determ ine 3-dimensional moves performed in a neighborhood of  $s_B$  (v) as follows.

Suppose that a (3 % 1)-m ove is used to simplify the disk that is the link of v. Then consider the vertex v<sup>0</sup> at which such a m ove is performed. By our rst step, its star is not the union of 4 tetrahedra. Three tetrahedra intersect along the edge, v; v<sup>0</sup>, and a (3 % 2)-m ove can be performed in the star of v to remove the vertex v<sup>0</sup> from the link. A fler such a m ove, then check for vertices in the interior whose valence is 4. Remove these by (4 % 1)-m oves, until no such vertices remain. Potentially, some vertices from the link of v are removed, and the e ect of such a removal on the link is to perform a (3 % 1)-m ove. In general a

 $(3 \ 1)$ -m ove to the link corresponds to a  $(3 \ 2)$ -m ove to the star, or a  $(4 \ 1)$ -m ove to a part of the star and a tetrahedron on the other side of the link.

If a  $(2 \ )^{2}$  -m ove is used to simplify  $k_{B}$  (v), then there is either a  $(3 \ )^{2}$  -m ove or a  $(2 \ )^{2}$  -m ove to that ball which induces it. Specifcally, if an edge in  $k_{B}$  (v) has as its star the union of 3 tetrahedra, then two of these are found in st<sub>B</sub> (v) and the other one is on the other side of the link of v. In this case perform a  $(3 \ )^{2}$  -m ove to B. The link of v changes by a  $(2 \ )^{2}$  -m ove. If the link of the edge to be changed is more than 3 tetrahedra, then perform a  $(2 \ )^{2}$  -m ove to st<sub>B</sub> (v). In this way, a triangulation always results from these m oves. A fler each such m ove, one m ust go and check for vertices of valence 4 and rem ove them by  $(4 \ )^{2}$  1)-m oves.

Eventually, we can remove all interior vertices from  $\mathbb{I}_{B}$  (v) and we can further make sure that the link of v is in some standard position. We can remove v from the boundary of B by removing v and the (n 2)-tetrahedra in its star where n is the valence of v with represent to the boundary. The result follows by induction. 2

 $7.3.2\,$  Lem m a. The partition function  $\,$  does not depend on the choice of 3-face triangulations of  $\,$  .

P roof. First let us analyze the case when a face (012) is shared by four tetrahedra. Then we will discuss the general case. Figures 45 and 46 depict the case where a face (012) is shared by four tetrahedra (0123), (0124), (0125) and (0126).

Then the dual complex has a rectangular 2-face (012) which is dual to the face (012). There are two triangulations of a rectangle, say  $t_1$  and  $t_2$ , for (012). (These are the triangulations that have no interior vertices). The 3-polytopes in that share (012) are duals (01), (02) and (12). Let  $T_1$  and  $T_2$  be 3-face triangulations of that restrict to  $t_1$  and  $t_2$

respectively and restrict to the same triangulation on all the other 2-faces of  $\$ . We show that the partition functions de ned from  $T_1$  and  $T_2$  give the same value.

Recall (Fig. 6) that two pairs of faces of a tetrahedron give two triangulation of a rectangle. We attach a tetrahedron in between (012) and (01) and change the triangulations on the face. More speci-cally, attach a pair of adjacent faces of a tetrahedron onto the face (012) of (01) along the triangulation  $T_1$  restricted to  $t_1$ . Perform the same attachment for (02) and (12). Then we get a new triangulation  $T_1^0$  of which restricts to  $t_2$  on (012). Thus  $T_1^0$  and  $T_2$  have the same triangulation on the 2-skeleton of by the assumption that all the other faces have the same triangulation. Thus  $T_1^0$  and  $T_2$  are related by a nite sequence of Pachner moves xing the boundary triagulation by Lemma 7.3.1 which does not change the partition function by the pentagon identity and the orthogonality of the cocycle . Hence it remains to prove that  $T_1$  and  $T_1^0$  give the same value of the partition function.

If the dual face (012) is in general a polygon of more than four faces (say n-gon), then triangulations consist of (n 2) triangles (by the condition of the de nition of 3-face triangulation). Such trianglations are related by only  $(2 \ 2)$ -m oves, which are realized by attaching a pair of faces of tetrahedra once at a time as above. Thus the above argument is applied to general cases by repeating the argument.

Now we prove that  $T_1$  and  $T_1^0$  in the case (012) is a rectangle give the same value of the partition function. Figure 47 depicts the graphs for the triangulation. In Fig. 47 the perturbations of these graphs to trivalent graphs are also depicted. These perturbations correspond to <sup>1</sup> (triangulations of a rectangle (012) in this case) as depicted in the bottom of Fig. 47. Thus the colors assigned near the face (012) with triangulations  $T_1$  and  $T_1^0$  are also assigned to edges of the perturbed graphs (the right pictures of arrows in the gure, marked (A), (A'), (B), and (B')).

These graphs are identified by the following graphs in Fig. 37: (A) corresponds to top graph, (A') to top left, (B) to bottom right, (B') to bottom. The weights assigned to each triangulation are thus  $(g;k;\hat{p};\hat{r})$   $(g;k;pr;\hat{s})$  for  $T_1$  and  $(g;k;\hat{r};\hat{s})$   $(g;k;\hat{p};rs;)$  for  $T_1^0$  (or vice versa), if the group elements assigned are as indicated in Fig. 37.

Now since  $T_1^0$  is obtained from  $T_1$  by attaching three tetrahedra, and they receive the weights  $(g;k\hat{p}k^{-1};k\hat{p}k^{-1};k\hat{p}k^{-1})$ ,  $(k;\hat{p};\hat{r};\hat{s})$ ,  $(gk;\hat{p};\hat{r};\hat{s})$ , therefore the cocycle condition depicted in Fig. 37 shows that they are equal. 2

# 8 H opf categories

8.1 O verview of H opf categories. We refer the reader to [13, 17, 35] for details about H opf categories. Here we give a brief overview. A H opf category is a categori cation of a H opf algebra. R oughly speaking, this means that the multiplication between elements becomes the tensor product between two objects, and there is a cotensor product de ned for objects.

First we recall 2-categories from [29, 23, 6].

8.1.1 R eview of 2-categories A (sm all) strict 2-category consists of the following data:(1) a set of objects 0 b j,

(2) a set of 1-m orphisms 1-M or, whose elements have source and target objects,

(3) a set of 2-m orphism s 2-M or, whose elements have source and target 1-m orphism s. Explicitly, given any two objects A; B, there is a set of 1-m orphism s 1-M or (A; B) between them; the object A is called the source object, B is the target. Such a 1-m orphism f is also denoted by f : A ! B . G iven any two 1-m orphism s f, g 2 1-M or (A; B) there is a set of 2-m orphism s between them; f is the source arrow (1-m orphism), and g is the target arrow (1-m orphism). The object A is the source object and the object B is the target object (of the 2-m orphism). Therefore both the sources and targets of f and g are required to coincide. Such a 2-m orphism is also denoted by :f) g. (The sm allness is the condition that these are sets.)

The following compositions of m orphisms are de ned and related as indicated in items (1) through (5).

(1) For any 1-m orphism sf: A ! B and g: B ! C, a 1-m orphism g f (= gf): A ! C is the composite.

(2) For any 1-m orphism f:A ! B and a 2-m orphism  $:g) g^0$  between 1-m orphisms  $g;g^0:B ! C$ , there is a composition (a 2-m orphism)  $f:gf) g^0f$ . Similarly, there is a 2-m orphism  $g:gf) gf^0$  when  $:f) f^0$ . These compositions are depicted on the left and m iddle of Fig. 48.

(3) For any 2-m orphisms : f) g and : g) h where f;g;h : A ! B, there is a composition : f) h. This is depicted in Fig. 48 right. The composition is called the vertical composition of 2-m orphisms.

(4) The composition depicted in Fig. 49 is unambiguous in the sense that

The result is called the horizontal com position of the 2-m orphism s and . (5) The com position depicted in Fig. 50 is also unambiguous in the sense that

W e assum e further that

where f;g are 1-m orphism s, is a 2-m orphism and these composites are de ned.

For any object A (resp. 1-m orphism f), the identity 1-m orphism  $id_A$  (resp. 2-m orphism  $id_f$ ) is defined. The identity 2-m orphism satisfies (id) = , (id) = for any 2-m orphism .

For any 2-m orphism : f) g where f;g:A ! B,  $(id_A) = and (id_B) = .$ The following are the conditions for the strictness.

(1) The compositions of 1- and 2-m orphisms are associative ( (fg)h = f(gh), ( ) = ( )).

(2) For any 1-m orphism f : A ! B,  $f(id_A) = f = (id_B)f$ .

This concludes the de nition of a small strict 2-category.

Note that by composing morphisms we can represent 2-morphisms by planar polygons. More on 2-categories can be found also in [11].

We follow the de nitions in [35] for the rest of this section.

A monoidal 2-category consists of a 2-category C together with the data: (1) an object I, (2) for any object A two 2-functors  $L_A = A 2$  :C ! C and  $R_A = 2A$  :C ! C such that  $L_A$  (B) =  $R_B$  (A) for any objects A, B, and (3) for any two 1-m orphisms f :A !  $A^0$  and g :B !  $B^0$  a 2-m orphism

These data satisfy 8 conditions that we om it here.

A 2-vector space is a k-linear additive category (C; ) that admits a subset B C such that (1) any object X 2 B is simple, (2) for any X 2 B, dim<sub>k</sub> (H om (X;X)) = 1, and (3) for any object A 2 C there is a unique nite subset B<sup>0</sup> B such that  $A = X_{i^2B} \circ X_{i}^{n_1}$ . The set B is called a basis and a 2 vector space is nite if B<sup>0</sup> is nite.

The 2-category of nite dimensional 2-vector spaces is denoted by 2 vect. The set of 1-m orphism s are k-linear functors, and 2-m orphism s are natural transform ations. This is a subcategory of the 2-category  $C_k$  of small k-linear additive categories with the k-linear functors as 1-m orphism s.

Theorem 2.7 of [35] says that 2 vect adm its the structure of a strongly involutory moniodal 2-category in such a way that for C; D 2 2 vect,  $Obj(C 2D) = f(A_1; n)A_i$  are pairs of objects of C and D,  $Mor((A_1; n)A_i(B_1; m)B) = f(f_{ij})f_{ij}:A_j)$  B ig.

A com oidal category is a category C in  $C_k$  with the following data. Two k-linear functors  $\}$ : C ! C 2 C and : C ! vec where vec= the category of vector spaces, and som e natural isom orphism s, including : (1 2  $\}$ )  $\}$ ) ( $\}$  21)  $\}$ , satisfying certain relations, including the pentagon relation for .

A 2-bialgebra or a bim onoidal category is a category C 2  $C_k$  which has both monoidal and com oidal category structures and with additional data including a natural isom orphism

: (2)(12T21)(22)) satisfying certain conditions, where T denotes permutations, including gures depicted in 52, 54, and 56. The faces in the gures are 2-m orphisms, and these cubes are relations among 2-m orphisms in the Hopf category.

8.2 C ocycle conditions and H opf categories. The cocycles and their equations given in the previous sections to construct partition functions are given by C rane and Y etter [17] to construct examples of H opf categories. W e refer the reader to [17] and [35] for the detailed relation between cocycles and H opf categories.

Here we give a sketch description. The Hopf category constructed is a categori cation of the D rinfeld quantum double of a nite group. Thus rst we recall D (G), the quantum double of a nite group G. It is an algebra generated by pairs of gropus and dual group elements,  $f(g;\hat{h})g$ . The multiplication is de ned by  $(g\hat{h})$   $(k\hat{j}) = {}_{k}{}^{1}hk; (gk;\hat{j}), com ultiplication by <math>((g;\hat{h})) = {}_{k}^{P}(g;\hat{k})$   $(g;h\hat{k}^{1})$ . The unit is  $I = {}_{h}^{P}(g;\hat{h})$ , the counit is  $(g;\hat{h}) = {}_{h;e}$ , the antipode is S  $(g;\hat{h}) = (g^{1};gh^{cl}g^{1})$ .

The Hopf category C = D (G), a categori cation of D (G), has the one dimensional vector space over a eld k generated by pairs  $f(g\hat{h})g$  as objects. They are also simply denoted

by pairs. The functor C 2 C ! C is a fam ily of isom orphism s  $(g;\hat{h})$   $(k;\hat{h})$  !  $(gk;\hat{h})$  where  $h = k k^{1}$ , and the functor } : C ! C 2 C is given by a fam ily  $(g;\hat{h})$  !  $P_{k}(g;\hat{k}) 2 (g;xk^{1})$ . The transform ation (2-m orphism)

$$(g;\hat{h});(k;\hat{\gamma};(m;\hat{n})) : ((g;\hat{h}) 2 (k;\hat{\gamma}) 2 (m;\hat{n}) ! (g;\hat{h}) 2 (k;\hat{\gamma}) 2 (m;\hat{n}))$$

is a family of scalars  $(g;k;m;\hat{n})$  since the objects are nontrivial only when  $'=k^{1}hk$  and  $n = '^{1}m$  '. Similar for  $(g;\hat{i};\hat{j};\hat{k})$ , and for the transformation , one has scalars

$$(q;k;m;n): m_{n=1}(qk;m) 2 (qk;n)! = (qk;k^{q}ak) 2 (qk;k^{q}bk):$$

Thus we get these cocycles as transform ations (or 2-m orphism s) in a H opf category. The cocycle conditions are obtained from the axiom s of the H opf categories.

8.3 D iagram s for m orphism s. W e use the diagram m atic convention depicted in Fig.51. The top two gures represent tensor and cotensor functors (1-m orphism s). W e read the diagram from bottom to top, the segments correspond to categories, and trivalent vertices correspond to tensor (uncircled vertices) functors and cotensor (circles ones) functors. Thus a tree diagram s represent com positions of such functors. The bottom three gures represent 2-m orphism s. For each of these, two com positions of functors are related by a double arrow representing a transform ation (2-m orphism ) between 1-m orphism s that are com positions of tensor and cotensor functors.

For the categori cation of the quantum double, the objects are represented by pairs  $f(g;\hat{h})g$ , therefore the edges of the graphs are labled by these pairs. The situation is seen in Fig. 31. The functors, then, are represented by trivalent vertices of the graphs. These are depicted in Figs. 32, 34. In Fig. 32, the functor corresponding to is depicted, and in Fig. 34, the functor corresponding to (or ) is depicted. The diagram s for is similar to , except that the vertices have sm all circles.

8.4 C oherence cubes and diagram s. Certain compositions of 2-m orphisms in Hopf categories are required to satisfy relations, such as those called coherence cubes in [13]. There are relations between the coherence cubes in [13] and the diagram s (graphs) we have de ned in this paper. Here we include F igures 53, 55, 57 that indicate such relations. F igures 52, 54, 56 are the coherence cubes given in [13]. The labels in the parentheses are in fact (co-)tensor products and equalities are morphism s. There is another cube in [13] which is dual to F igure 52 and is ommitted.

In each of these gures, there is an initial vertex and a term inal vertex in the cube. These cubes appear in [13] in the de nition of Hopf categories. Each arrow from the initial vertex to the term inal vertex represents a morphism, which is represented by a diagram with trivalent vertices.

Through each rectangular face, such a path is hom otoped to another such path. This hom otopy causes a change in diagram s. These changes in diagram s are the scenes from our movies, and in the case of the Hopf category associated to a D rinfeld double, these scenes are group cocycles.

Note that relations are represented by diagrams (graphs) and the relations take form s of equating two sequences (graph m ovies) of graphs. These equations are in fact identical that appeared in cocycle conditions (Figs. 36, 37) since these cocycles came from constructions of H opf categories in [16]. On the other hand these diagrams are related to the taco m ove via the dual graphs. Thus we see that the the form alism proposed in [13] can be used to construct invariants of 4-m anifolds via a state-sum provided the propsed set of states is nite.

## 9 Concluding rem arks

In this paper we established diagram m atic m achinery for the study of 4-m anifold invariants using triangulations and graphs. In particular, invariance under Pachner m oves of C rane-Frenkel invariants for cocycles constructed by C rane-Y etter is proved by using graphs. This strongly suggests generalizations of the D ikgraaf-W itten invariant to 4-m anifolds using cocycles de ned in [16]. We have shown direct relations among algebraic structures (H opf categories), triangulations, and (graph) diagram s in dimension 4, generalizing spin network theory in 3-dimensions.

Further study on higher dimensional TQFTs and higher algebraic structures are anticipated. We expect that our diagram matic machinery established in this paper serve as tools for further developments in the area.

Open questions remain. Which nite groups contain cocycles that satisfy the symmetry conditions? Can other examples of H opf C ategories be constructed. What do the invariants from this construction measure? Can these invariants be related to invariants that arise from D onaldson Theory?
