A bstract


#### Abstract

C rane and Frenkel proposed a state sum invariant for triangulated 4 m anifolds. They de ned and used new algebraic structures called H opf categories for their construction. C rane and Yetter studied H opf categories and gave som e exam ples using group cocycles that are associated to the D rinfeld double of a nite group.

In this paper we de ne a state sum invariant of triangulated 4 m anifolds using C rane-Y etter cocycles as B oltzm ann w eights. O ur invariant generalizes the 3-dim ensional invariants de ned by D ijkgraafand $W$ itten and the invariants that are de ned via H opf algebras. W e present diagram $m$ atic $m$ ethods for the study of such invariants that ir lustrate connections betw een H opf categories and $m$ oves to triangulations.

## 1 Introduction

W itten's form ulation 45] of an intrinsic de nition of the Jones polynom ial [24] based on physical m odels lead to the $m$ ore rigorous $m$ athem atical de nitions via representations of quantum groups that were given by R eshetikhin, Turaev, and $V$ iro [4]], 43]. These quantum invariants are speculated to generalize to higher dim ensions. Such putative invariants have their origins in a theory of quantum gravity [7] and higher categories [5]. In relation to the current work, the follow ing progress has been $m$ ade.

Q uantum spin netw orks were generalized by $C$ rane-Y etter [16] to give $4-m$ anifold invariants that were based on O oguri's proposal 36]. The invariants can be used to com pute the signature as show n in [41, 14, 15]. B irm ingham Rakow ski 罗] generalized the D ijkgraafW itten [18] invariant of 3 m anifolds, de ned by group 3 -cocycles, to triangulated 4 -m anifolds using pairs of cocycles. C rane and Frenkel [13] constructed Hopf categories to de ne 4m anifold invariants, and they gave exam ples using canonical bases of quantum groups. In [17] C rane and Y etter used cocycles to construct H opf categories.

In this paper we provide direct relations between the cocycle conditions of [17] and Pachner $m$ oves of $4-\mathrm{m}$ anifolds, thus constructing a generalization of the D ijkgraaff itten invariants to dim ension 4. The relations are established diagram $m$ atically, providing connections betw een H opf categorical structures and triangulations via dual graphs and their m ovies.

The current paper is self-contained, but the reader m ight en joy our introduction to the sub ject given in [19], where $m$ any of our ideas and $m$ otivations are introduced in a more leisurely fashion. For the diagram $m$ atic foundation of the invariants in dim ension 3 see 25], 26], and 24]. For the algebraic approach se [6]. Finally, there is a relation to higher dim ensional knot theory as found in [11].

Let us continue our m otivational rem arks. In 3 dim ensions, planar diagram s played a key role in the de nitions of both knot invariants and $m$ anifold invariants. Such diagram $s$ are convenient since they help one grasp the categorical and algebraic structures needed for de ning invariants. O ne of the di culties in generalizing to dim ension 4 or higher is the lack of such visualizations and diagram $m$ atic $m$ achinery. The purpose of this paper is to provide basic diagram $m$ atic tools to study $4-\mathrm{m}$ anifold triangulations, and to use such formulations to de ne invariants.

In particular, we form ulate the C rane $F$ renkel approach in term s of cocycles as indial data and prove the invariance under Pachner $m$ oves in a diagram $m$ atic way. $W$ e introduce spin netw orks for the study of such invariants. W e hope that the present work serves as a basic tool in exploring the possibilities in higher dim ensions.

There is a close relationship bew teen certain physical models in statistical m echanics and quantum eld theory and the form ulation of \quantum " invariants of knots, links and three m anifolds. W e hope that this relationship continues into dim ension four. In particular, one can hope that a four dim ensional toplogical eld theory (such as we study here) would be related to the calculation of amplitudes in quantum gravity. The naive reason for this hope is quite sim ple: An am plitude for quantum gravity m ust sum over the possible $m$ etrics on the four-dim ensional spacetime. A veraging over $m$ etrics should in priniciple produce basic num bers that are $m$ etric-independent. In other w ords a valid process of averaging over $m$ etrics should produce topological invariants of the underlying four-space. O foourse on the
physical side it w illbe neccessary to extricate the topological part from the com plexities of the model. On the pure $m$ athem atical side it $w i l l$ be neccessary to see the relevance of the $m$ athem atics. Nevertheless this hope for an application to quantum gravity is one of the foroes that drives our pro ject.

The organization of the paper is as follow s. In Section ${ }^{2}$, we review state sum invariants for triangulated $m$ anifolds in dim ensions 2 and 3 . W e em phasize diagram $m$ atic relations betw een triangulations and algebraic stnuctures. At the end of the section, we sum $m$ arize the idea of categori cation in relation to the construction of higher dim ensional invariants. In Section 3 we present diagram s ofP achner moves in dim ension 4. W e also introduce singular $m$ oves in dim ension 4, and prove that singular $m$ oves together w ith 3-dim ensional Pachner $m$ oves im ply 4-dim ensional Pachner $m$ oves. These Lem $m$ as $w i l l$ be used to prove the well-de nedness of our invariants. In Section[4 we give generalization of spin netw orks to di$m$ ension 4. Triangulations are represented by $m$ ovies of graphs, and these graph movies will be used to give a direct relation betw een H opf category structures and triangulations. C ocycle conditions de ned by [1]] w illbe review ed in Section[\$. Sym m etry ofcocycles are de ned. In Section 6 the state sum invariants $w i l l$ be de ned, and will be proved to be well-de ned in Section 7. O ur proofs are diagram $m$ atic. They provide the basic $m$ achinery necessary to de ne other invariants de ned via Hopf categories. The axiom s of H opf categories are related to m oves on triangulations of 4 m anifolds in a m anner sim ilar to the relationship betw een H opf algebras and moves on 3-m anifolds. Section 8 review s the de nition of H opf category and $m$ ake the connection $w$ th the rest of the paper.

## 2 Q uantum 2-and 3-m an ifold invariants

In this section, we review topological lattice eld theories in dim ension 3 and explain how they are generalized from those in dim ension 2. First we review dim ension 2 follow ing [21, [12] w here sem i-sim ple algebras are used. An altemative approach is given by Law rence in [33] in which the algebra is assum ed to be Frobinius. N ext the Turaev-V iro [43] theory is review ed follow ing [9] and 26]. Invariants of $3-\mathrm{m}$ anifolds derived from H opf algebras are presented follow ing [12]. A ltemative approaches are found in $K$ uperburg 30] and $K$ au m an$R$ adford 27]. Som e of the sum $m$ ary appeared in [19]. W e sum $m$ arize $W$ akui's de ntion [44] of the D ikgra w itten invariants [ $1 \beta]$, but here we show invariance using the $P$ achner $T$ heorem. $T$ his section closes w ith a conceptual schem e for generalizing to dim ension 4.
2.1 Topological lattice eld theories in dim ension 2. Let A denote a nite dimensional associative algebra over the complex numbers C. Let f i $\mathrm{j}=1$; $\quad$; ng denote an ordered basis for $A$, and for $x ; y ; z 2 f 1 ;::: ; n g$, let $C_{x y}^{z}$ denote the structure constant of the algebra A. T hus the m ultiplication betw een basis elem ents is given by the form ula:

Then this is invertible precisely when the algebra $A$ is sem i-sim ple 21], and the $m$ atrix inverse $g^{x y}$ of $g_{x y}$ de nes a bilinear form on the algebra $A$. The geom etric interpretation of this bilinear form and that of the associativity identity $w$ ill allow us to de ne from a sem i-sim ple associative algebra, an invariant of 2 -dim ensionalm anifolds.

We follow the de nition given in [24]. Let $T$ be a triangulation of a closed 2-dim ensional m anifold F. Let $\mathrm{N}=\mathrm{f1} ; 2$; ;ng. This is called the set ofspins. Let $E T=\mathrm{f}(\mathrm{e} ; \mathrm{f}) \dot{\mathrm{e}} \quad \mathrm{fg}$ be the set of all the pairs of edges, $e$, and faces, $f$, such that $e$ is an edge of $f$. The set ET is a partial ag. A labeling is a map L :ET ! N. Thus a labeling is an assignm ent of spins to all the edges $w$ th respect to faces. $G$ iven a labeling, we assign w eightings to faces and edges as follow s: Suppose that we are given functions $C$ and $g, C: N^{3}!C, C(x ; y ; z)=C_{x y z}$, and $g: N^{2}!C, g(x ; y)=g^{x y}$. If a face has three edges labeled with spins $x ; y ; z$, then assign the com plex num ber $\mathrm{C}_{\mathrm{xyz}}$ to the face. It is assum ed that the fiunction C posesses a cyclic symm etry; so $C_{\mathrm{xyz}}=C_{\mathrm{yzx}}=\mathrm{C}_{\mathrm{zxy}}$. If an edge is shared by two faces, and the edge $w$ ith respect to these faces receives spins $x$ and $y$, then assign the com plex num ber $g^{x y}$ to the edge. Then de ne a partition function ( $T$ ) by ${ }_{\mathrm{L}}{ }^{\mathrm{C}} \mathrm{C}_{\mathrm{xyz}} \mathrm{g}^{\text {uv }}$ where the sum is taken over all the labelings and the product is taken over all the elem ents of ET. Values of $\mathrm{C}_{\mathrm{xyz}}$ and $g^{\text {uv }}$ are given in term $s$ of the structure constants for the algebra and the bilinear form guv in the fourth paragraph forw ard. F irst, we discuss topological aspects that m otivate their de nition.

In order for the partition function to be topologically invariant, it cannot depend on the choice of triangulation. T here are tw o steps in constructing such an invariant quantity. F irst, we w ork topologically. There is a set of localm oves to triangulations that su ces to relate any two triangulations of a given $m$ anifold. These $m$ oves were discovered by P achner 37] in the general case of $n-m$ anifolds, and they generalize a classical theorem of A lexander [1] . $T$ herefore for the partition function to be independent of the choige of triangulation, it is su cient to prove that the weighting assigned to triangles and edges satis es equations that correspond to these localm oves. The second step, therefore, is algebraic. W e seek functions $C$ and $g$ that satisfy these equations. $W$ e will indicate that the structure constants of an associative algebra can be used for the function $C$ and that the bilinear form on $A$ can be used to de ne the function $g$, as the notation suggests.

Let us consider the topological aspects. The P achner m oves in dim ension 2 are depicted in $F$ igure 1 . The $m$ ove on the left of $F$ igure 1 is called the $\left.(2)^{*} 2\right)$ m ove; that on the right is called the ( 1$)^{\dagger} 3$ ) m ove. The nam es of the $m$ oves indicate the num ber of triangles that are involved.

We now intepret associativity and the bilinear form in a sem i-sim ple algebra over C in term s of the Pachner moves. Speci cally, the (2 $)^{*} 2$ )Pachner $m$ oves is related to the associativity law (ab)c = a (bc). The relationship is depicted in Figure Z. The dual graphs, indicated in the $F$ igure by dotted segm ents, are som etim es useful for visualizing the relations betw een triangulations and the algebraic structure. T he diagram given in $F$ igure ${ }^{3}$ ilhustrates the geom etrical interpretation of the bilinear form $g_{x y}={ }_{u ; v} C_{x u}^{v} C_{y v}^{u}$ : In the gure, two triangles share two edges in the left picture, representing the local weighting ${ }_{u, v} C_{\mathrm{xu}}^{\mathrm{v}} \mathrm{C}_{\mathrm{yv}}^{\mathrm{u}}$, and the right represents a single edge corresponding to $g_{x y} . F$ inally, this relationship together w ith the associativity identity can be used to show that the partition function is invariant under the ( 1$)^{*}$ 3) Padhner $m$ ove. The essence of the proof is indicated in $F$ igure 4.
$H$ aving illustrated the algebra axiom s diagram $m$ atically, we tum to show how the structure constants and the bilinear form of associative sem i-sim ple algebras solve the equations corresponding to the P achner $m$ oves. G iven, structural constants $C_{x y}^{z}$ and a non-degenerate bilinear form $g^{u z}$ w ith inverse $g_{u z}$, de ne $C_{x y u}$ by the equation (using $E$ instein sum $m$ ation convention of sum $m$ ing over repeated indioes),

the partition fiunction de ned in this way is invariant under the (2* 2 ) -m ove. Furtherm ore, we have (again, under sum $m$ ation convention)

and so the partition function is invariant under the ( $\left.\begin{array}{l}\left.()^{\dagger}\right)\end{array}\right)$-m ove. In this way, a sem $i-$ simple nite dim ensional algebra de nes an invariant of surfaces. On the other hand, given a partition function one can de ne a sem i-sim ple algebra w ith these structure constants and that bilinear form. In 21], this is stated as $T$ heorem 3:
The set of all TLFTs is in one-to-one correspondence with the set of nite dim ensional sem i-sim ple associative algebras.

O bserve that the ( $\xi^{*} 3$ )-m ove follows from the ( 2$)^{\star} 2$ )-m ove and a non-degeneracy condition. In the sequel, we w ill see sim ilar phenonem a in dim ensions 3 and 4.

In general, the idea of de ning a partition function to produce a $m$ anifold invariant is (1) to assign spins to sim plices of a triangulation, and (2) to nd weightings that satisfy equations corresponding to $P$ achner $m$ oves. This approach, of course, depends on nding such solutions to (often extrem ely overdeterm ined) equations. Such solutions come from certain algebraic structures. Thus one hopes to extract appropriate algebraic structures from the $P$ achner $m$ oves in each dim ension. T his is the $m$ otivating philosophy of quantum topology.

In the follow ing sections we review such invariants in dim ension 3 in $m$ ore detail to explain such relations betw een triangulations and algebras.
2.2 Pachner $m$ oves in dim ension 3. In this section we review the Pachner moves 37] of triangulations of $m$ anifolds in dim ension 3. The Pachner $m$ oves in $n$-dim ensions form a set of $m$ oves on triangulations such that any two di erent triangulations of a $m$ anifold can be related by a sequence ofm oves from this set. Thus, tw o triangulations represent the sam e $m$ anifold if and only if one is obtained from the other by a nite sequence of such $m$ oves. In $F$ igure 5 the 3-dim ensional Pachner $m$ oves are depicted, these are called the ( $\mathbf{2 l}^{*} 3$ )-m ove and the ( 1 ) 4)-m ove.
$N$ otice that the 2 -dim ensional P achner $m$ oves relate the faces of a tetrahedron. Speci cally, the (2 $)^{\star} 2$ ) -m ove consists oftw o pairs oftriangles and they together form a tetrahedron (Figure (6) . M eanw hile, the ( 1$)^{*}$ 3)-m ove relates three triangular faces of a tetrahedron to

the rem aining face. The three triangles form the central projection of a tetrahedron. A nalogous facts are true for the 3-dim ensionalP achner $m$ oves as well; let us explain. O ne side of each $m$ ove is a union of3-faces of the boundary of 4 -sim plex and the other side of the $m$ ove is the rest of the 3-faces, and they together form the boundary of a 4 -sim plex. For exam ple, the ( $)^{\star} 4$ )-m ove indicates two $3-b a l l s$ on the boundary of a 4 -sim plex as they appear in a œentral projection of the sim plex.

In $F$ igure , the relation betw een faces of a tetrahedron and their dualgraphs is depicted. $T$ he $m$ iddle picture show s pairs of front and back faces of a tetrahedron on the center left. $N$ ote that these pairs represent the (2 ) 2) Pachner m ove (as indicated by the vertical double arrow in the $m$ iddle). Thus the (2 $)^{\star}$ 2) Pachner $m$ ove corresponds to a tetrahedron, a 1-dim ensionally higher sim plex. On the right of the gure, the change on dual graphs is depicted by dotted lines. In Figure 7 , a sim ilar correspondence is depicted for the ( $\begin{aligned} & \text { ( }\end{aligned}$ 3) Pachner $m$ ove. Here faces of unions of tetrahedra are depicted from left to right, in two di erent ways that correspond to the Pachner $m$ ove. These are the faces taken from the union of tetrahedra depicted in top and bottom of the gure, respectively. The dual graphs are also depicted, which are the graphs used for the B iedenham $\Psi$ liott identity of the $6 j$ sym bols. This direct diagram $m$ atic correspondence is pointed out in 9$]$.
2.3 Turaev $-V$ iro invariants. O ne way to view the Turaev $-V$ iro invariants [43, 26] is to \categorify" the TLFT in dim ension 2. In this process, the sem i-sim ple algebra is replaced by a sem i-sim ple m onoidal category | nam ely the category of representations of $U_{q}(s l(2))$ where $q$ is a prim itive $4 r$ th root of unity. First we review the de nition of the Turaev $-V$ iro invariants, and then explain the view point $m$ entioned above.

A triangulation of a 3 m anifold is given. A coloring, $f$, is adm issible if whenever edges $w$ ith colors $a ; b ; j$ bound a triangle, then the triple $(a ; b ; j)$ is a $q$-adm issible triple in the sense that

1. $a+b+j$ is an integer,
2. $a+b$ j, $b+j a ;$ and $a+j b$ are all 0
3. $a+b+j$ r 2:

Ifedges $w$ ith labels $a ; b ; c ; j ; k ; n$ are the edges of a tetrahedron such that each of $(a ; n ; k)$, $(b ; c ; n) ;(a ; b ; j)$ and $(c ; j ; k)$ is a $q$-adm issible triple, then the tetrahedron, $T$, recives a weight of $T_{f}=\begin{array}{lll}a & b & n \\ c & k & j\end{array} \quad$ : If any of these is not adm issible, then the weight associated to a tetrahedron is, by de nition, 0 .

For a xed coloring $f$ of the edges of the triangulation of a $3-m$ anifold $M$, the value

is associated where $t$ is the number of vertioes in the triangulation, the rst product is taken over all the edges in the triangulation, the second product is over all the tetrahedra, the factor is a norm alization factor ( $=$ const.) and $\mathrm{f}(\mathrm{E})$ is a certain quantum integer
associated to the color of the edge E. To obtain an invariant of the $m$ anifold one form $s$ the sum
$\mathrm{M} j={ }_{\mathrm{f}}^{\mathrm{X}} \mathrm{M}_{\mathrm{M}}^{\mathrm{E}}$
where the sum is taken over all colorings. Further details can be found in 43, 26] or 9$]$.
Several points should be $m$ ade here. First, the sum is nite because the set of possible colors is nite. Second, the quantity $M \mathrm{j}$ is a topological invariant because the $6 j$-sym bols satisfy the Beidenham Elliott identity and an orthogonality condition. T he orthogonality is a sort of non-degeneracy condition on the $6 j$-symbol. In [26, 旦] it is shown how to use orthogonality and Beidenham E liott (together w ith an identity am ong certain quantum integers) to show invariance under the ( 1$)^{\dagger} 4$ ) move. Third, the $6 j$-symbol is a m easure of non-associativity as we now explain.

The situation at hand can be seen as a categori cation. In 2-dim ensions associativity $(\mathrm{ab}) \mathrm{c}=\mathrm{a}(\mathrm{bc})$ played a key role. In 3-dim ensions the 6j-sym bols are de ned by com paring two di erent bracketting ( $V^{a} V^{b}$ ) $V^{c}$ and $V^{a} \quad\left(V^{b} \quad V^{c}\right)$ of representations $V^{a}, V^{b}$, and $V^{c}$. H ere the algebra elem ents becam e vector spaces as we went up dim ensions by one, and the symbolm easuring the di erence in associativity satis es the next order associativity, corresponding to the P achner m ove.

G iven representations $\mathrm{V}^{\mathrm{a}}, \mathrm{V}^{\mathrm{b}}, \mathrm{V}^{\mathrm{c}}$, we can form their triple tensor product and look in this product for a copy of the representation $V^{k}$. If there is such a copy, it can be obtained by regarding $V^{k}$ as a subm odule of $V^{a} \quad V^{n}$ where $V^{n}$ is a subm odule of $V^{b} V^{c}$, or it can be obtained as a subm odule of $V^{j} \quad V^{c}$ where $V^{j}$ is a subm odule of $V^{a} V^{b}$. From these two considerations we obtain two bases for the set of $U_{q}(s l(2)) \mathrm{m}$ aps $\mathrm{V}^{k}!V^{a} \quad V^{b} \quad V^{c}$. $T$ he $6 j$-sym bol is the change of basis $m$ atrix betw een these two.

C onsidering such inclusions into four tensor products, we obtain the B iedenham $\Psi$ lliott identity. Each such inchusion is represented by a tree diagram. T hen the B iedenham E liott identity is derived from the tree diagram s depicted in F ig. 7 .

### 2.4 Invariants de ned from H opfalgebras.

In this section we review invariants de ned by C hung Fukum a-Shapere [12] and K uperberg [30] (we follow the description in [12]). We note that the invariants obtained in this section are also very closely related to the invariants de ned and studied by H ennings, K au $m$ an, R adford and O tsuki (see 27] for exam ple). For background $m$ aterial on $H$ opfA lgebras see [42] or 34], for exam ple.
2.4.1 De nition (B ialgebras). A bialgebra over a eld $k$ is a quintuple (A ; m ; ; ) such that

2.4.2 D e nition (H opfalgebras). An antipode is a map s:A! A such that m (s 1) $=\quad=m \quad\left(\begin{array}{ll}1 & s\end{array}\right)$

A H opf algebra is a bialgebra with an antipode.
The im age of the com ultiplication is often written as (a) = $a_{1} \quad a_{2}$ fora 2 A . The im age in fact is a linear combination of such tensors but the coe cients and the sum $m$ ation are abbreviated; this is the so-called Sw eedler notation [42]. Them ost im portant property from the present point of view is the com patibility condition between the multiplication and the com ultiplication (i.e., the condition that the com ultiplication is an algebra hom om onphism ), and we include the com $m$ uting diagram for this relation in $F$ igure 8. The condition is w ritten $m$ ore speci cally $m=(m \quad m) \quad B \quad(\quad)$ where $P_{23}$ denotes the perm utation of the second and the third factor: $P_{23}\left(\begin{array}{llll}x & y & z & w\end{array}\right)=\left(\begin{array}{llll}x & z & y & w\end{array}\right)$. In the Sw eedler notation, it is also written as $(a b)_{1} \quad(a b)_{2}=a_{1} b_{1} \quad a_{2} b_{2}$.
$T$ he de nition of invariants de ned in [ [ 2 ] is sim ilar to the 2 -dim ensional case. $G$ iven a triangulation $T$ of a 3 m anifold M , give spins to edges $w$ ith respect to faces (triangles). The weights then are assigned to edges and to faces. The structure constants $\mathrm{C}_{\mathrm{xyz}}$ (resp. xyz) of m ultiplication (resp. com ultiplication) are assigned as weights to faces (resp. edges). If an edge is shared by $m$ ore than three faces, then a com position of com ultiplications are used. For exam ple for four faces sharing an edge, use the structure constant for (1). The coassociativity ensures that the other choige ( $\left.1 \quad{ }_{P}\right)_{Q}$ gives the same constant ${ }_{v_{1}, v_{2} ; v_{3}, v_{4}}$. $T$ hus the partition function takes the form $\quad(T)={ }^{P}{ }_{L}{ }^{Q} C_{x y z} \quad V_{1} ; \quad{ }_{i}$. This formula exhibits the form of the partition function for this $m$ odel, but is not technically com plete. The full form ula uses the antipode in the Hopf algebra to take care of relative orientations in the labellings of the sim plicial com plex. See [12] for the details.

In [12] the well de nedness was proved by using singular triangulations | these generalize triangulations by allow ing certain cells as building blocks. In this case the $m$ ove called the cone $m$ ove for a singular triangulation plays an essential role. This $m$ ove is depicted in Figure 9 w ith a dual graph to ilhustrate the relationship to the com patibility condition.

Let us now explain the relation of this $m$ ove to the com patibility condition verbally. In the left hand side of F ig. g there are distinct and parallel triangular faœes sharing the edge

(12) and (13); these triangles have di erent edges connecting the vertioes 2 and 3 . O ne of these is shared by the face (234) while the other is shared by the face (235).

The parallel faces (123) and (123)' are collapsed to a single face to obtain the right hand side of Fig. G. N ow there is a single face w ith edges (12), (23), and (31), and the edge (23) is shared by three faces (123), (234), and (235).

The thidk segm ents indicate part of the dual graph. Each segm ent is labeled by H opf algebra elem ents. Reading from bottom to top, one sees that the graphs represent m aps from A A to itself. The left-hand-side of the gure represents

and these are equalby the consistency condition betw een $m$ ultiplication and com ultiplication. $T$ his show $s$ that the $H$ opf algebra stnucture gives solutions to the equation corresponding to the cone $m$ ove.

That the partition function in this case does not depend on the choice of triangulation is proved by show ing that the P achner $m$ oves follow from the cone $m$ ove and other singular $m$ oves. Figure 10 explains why the ( 2$)^{\star}$ 3)-m ove follow from singularm oves (this gure is basically the sam e as a Figure in [12]).

Let us explain the gure. The rst polyhedron is the right-hand-side of the ( $4^{*} 3$ ) -m ove. $T$ here are three intemal faces and three tetrahedra. P erform the cone $m$ ove along edge (25) thereby duplicating face (125). Intemally, we have face (125) glued to face (235) along edge (25) and face $(125)^{0}$ glued to face (245) along edge (25). These faces are depicted in the second polyhedron. By associativity these faces can be replaced by four faces parallel to four faces on the boundary; (123), (135), (124), (145). This is the con guration in the third
polyhedron. Then there are tw o 3-cells bounded by these parallel faces. C ollapse these cells and push the intemal faces onto the boundary (this is done by singular m oves). The result is the fourth polytope which now is a single polytope w ithout any intemal faces. T his is the m iddle stage in the sense that we have proved that the right-hand-side of the ( 2$)^{*} 3$ ) m ove is in fact equivalent to this polytope.

N ow introduce a pair of intemal faces parallel to the faces (135) and (145) to get the fth polytope (the left bottom one). Perform associativity again to change it to a pair of faces (134) and (345) to get the sixth polytope. Perform a cone $m$ ove along the pair of faces w ith vertices (345):T hese faces share edges (35) and (45); edge (34) is duplicated.) The last picture which is the left-hand-side of the ( $\left.\right|^{*} 3$ ) -m ove.

In sum $m$ ary, we perform cone $m$ oves and collapse som e 3-œells to the boundary and prove that both sides of the P achner $m$ ove is in fact equivalent to the polyhedral 3-cell w thout intemal faces. We give a generalization of this $T$ heorem to dim ension 4 in Lem mas 32.4, 3.2 .5 , and 32.6.
2.5 D ijkgraaf-W itten invariants. We review the D ijkgraaf F itten invariants for 3dim ensional manifolds. In [18] D ikgraaf and $W$ itten gave a combinatorial de nition for C hem-Sim ons invariants w ith nite gauge groups using 3-cocycles of the group cohom ology. We follow $W$ akui's description [44] except we use the $P$ achner $m$ oves. See [44] for $m$ ore detailed treatm ents.

2.6 Sum m ary: G oing up dim ensions. Aswe reviewed the invariants in dim ensions 2 and 3 , there are two ways to go up the dim ension from 2 to 3 . O ne way is to consider

the algebras form ed by representations of quantum groups as in Turaev-V iro invariants. In this case algebra elem ents are regarded as vector spaces (representations) and algebras are replaced by such categories. This process is called categori cation. The second way is to include a com ultiplication in addition to the multiplication of an algebra as in H opfalgebra invariants and consider bialgebras (in fact H opf algebras) instead of algebras.

C rane and Frenkel de ned invariants in dim ension 4 using these ideas. We reach at the idea of the algebraic structure called Hopf categories either by (1) categorifying Hopf algebras, or (2) including com ultiplications to categories of representations. The follow ing chart represent this idea.

In the follow ing sections we follow this idea to de ne invariants in dim ension 4.
W e also point out here that the theories review ed above have rem arkable features in that they have direct relations between algebraic structures and triangulations via diagram s
(trivalent planar graphs, or spin netw orks). O $n$ the one hand such diagram $s$ appear as dual com plexes through $m$ ovie descriptions of duals of triangulations, and on the other hand they appear as diagram $m$ atic representations of $m$ aps in algebras. In the follow ing sections we explore such relations and actually utilize diagram s to prove well-de ned-ness of the invariants proposed by $C$ rane and Frenkel.

## $3 \quad \mathrm{P}$ achner M oves in dim ension 4

In Section 22 we review ed the Pachner m oves for triangulations in dim ensions 2 and 3 and their relations to associativity of algebras. In this section, we describe Pachner $m$ oves in dim ension 4. Relations of these $m$ oves to the Stashe polytope was discussed in [⿴囗].

In general, an n-dim ensional Pachner move of type (i ${ }^{*} j$ ), where $i+j=n+2$, is obtained by decom posing the (spherical) boundary of an ( $n+1$ )-sim plex into the union of tw o $n$-balls such that one of the balls is the union of $i n$-simplices, the other ball is the union of $j n$-sim plioes, and the intersection of these balls is an ( $n$ 1)-sphere. By labeling the vertioes of the ( $n+1$ )-sim plex these $m$ oves are easily expressed. For exam $p l e$, the table below indicates the low er dim ensional Padhner m oves:

The relationship betw een the generalP achnerm ove and the higher order associativity relations are explained in 10]. N ext we tum to a m ore explicit description of the 4-dim ensional P achner M oves.
3.1 4-dim ensional $P$ achner $m$ oves. In this section we explain the 4-dim ensionalP achner $m$ oves. O ne side of a 4-dim esional P achner $m$ ove is the union of 4-faces of a 5 -sim plex (hom eom orphic to a $4-b a l l$ ), and the other side of the $m$ ove is the union of the rest of 4 -faces.

In $F$ igures 12 13, and 14 the (3 $)^{*} 3$ )-m ove, ( $)^{*} 4$ ) m ove, and ( $)^{*}$ 5) -m ove are depicted, respectively. Recall here that each 3 -dim ensional $P$ achner $m$ ove represents a 4sim plex. Therefore the 3 -dim ensional $P$ achner $m$ ove depicted in the top left of $F$ igure 12, the $m$ ove represented by an arrow labeled (01234), represents the 4 -sim plex with vertioes 0 , $1,2,3$ and 4. Then the lefthand side of $F$ ig. 12 represents the union of three 4 -sim plices (01234) [ (01245) [ (02345). Sim ilarly, the right-hand side ofF ig. 12 represents the union of the three 4-sim plioes (01345) [ (01235) [ (12345).

3.2 Singu lar m oves. In dim ension 4, the Pachner m oves can be decom posed as singular $m$ oves and lower dim ensionalm oves. Here we de ne a 4-dim ensional singular m oves (called cone, pillow, taco moves) and show how the Pachner moves follow. This material was discussed in 10].
3.2.1 D e nition (cone m ove). The cone m ove for $\mathrm{C} W$-com plexes for 4 m anifolds is de ned as follows.

Suppose there is a pair of tetrahedra $(1234)_{1}$ and $(1234)_{2}$ that share the sam e faces (123), (124) and (134), but have di erent faces (234) and (234) ${ }_{2}$, such that (1) (234) $)_{1}$ and (234) bound a $3-b a l l \mathrm{~B}$ in the $4-\mathrm{m}$ anifold, (2) the union of , $(1234)_{1}$ and $(1234)_{2}$ is di eom orphic to the 3 -sphere bounding a 4 -ballw in the 4 m anifold.

The situation is depicted in $F$ igure 15 which we now explain. The lefthand-side of the $F$ igure has two copies of tetrahedra $w$ th vertioes $1,2,3$, and 4 . T hey share the sam efaces (123), (124), and (134) but have two di erent faces with vertices 2, 3, and 4.

Collapse these two tetrahedra to a single tetrahedra to get the right-hand-side of the F igure. N ow we have a single tetrahedron w ith vertices 1, 2, 3, and 4. The face (234) now is shared by three tetrahedra (1234), (2348), and (2349) while three faces (123), (124), and (134) are shared by two tetrahedra.
3.2.2 D e nition (taco move). Suppose we have a C W -com plex such that there is a pair of tetrahedra $(1234)_{1}$ and $(1234)_{2}$ that share two faces (123) and (124) but have di erent faces $(134)_{1},(134)_{2}$ and $(234)_{1},(234)_{2}$ (of $(1234)_{1},(1234)_{2}$ respectively). Suppose further that $(134)_{1},(134)_{2},(234)_{1}$, and $(234)_{2}$ together bound a $3-œ e l l$ B and $(1234)_{1},(1234)_{2}$, and B bounds a 4 -œll. Then collapse this 4 -œll to get a single tetrahedron (1234). A s a result $(134)_{1}$ (resp. (234) $)$ and $(134)_{2}$ (resp. (234) $)_{2}$ ) are identi ed. This $m$ ove is called the taco m ove.
3.2.3 D e nition (pillow m ove). Suppose we have a CW -com plex such that there is a pair of tetrahedra sharing all four faces cobounding a 4-cell. Then collapse these tetrahedra to a single tetrahedron. T his $m$ ove is called the pillow $m$ ove.

3.2.4 Lem ma.The (3 ${ }^{\star}$ 3) Pachnerm ove is described as a sequence of conem oves, pillow m oves, taco m oves, and 3-dim ensionalP achner m oves.

P roof. The proof can be facilitated by follow ing the F igures 16 through 24. Figure 16 is a prelim inary sketch that indicates in dim ension 3 the $m$ ethods of the subsequent gures. It illustrates that the ( $2^{*} 3$ ) m ove in dimension 3 can be interpreted in term $s$ of the (2 $)^{*}$ 2)-m ove via a non-generic projection. The thick vertical line on the lett-hand-side of the gure is the projection of the triangle along which the two tetrahedra are glued. The thick horizontal line on the right is the projection of one of the three triangles that are introduced on the right-hand-side of the $m$ ove. The other two triangles project to $l l$ the low er right quadrilateral. The dotted lines indicate that som e edges in the gure will pro ject to these lines. Som e inform ation is lost during the projection process, but at worst, the projected gures serve as a schem atic diagram of the actual situation.

In F ig. 17 the union of the three 4 -sim plices ( ABCDE ), ( ACDEF ), and ( ABCEF ) is illustrated; these share the triangle (ACE) which is shaded in gure. The union forms the left-hand-side of the of the (3 $)^{*} 3$ )-m ove. Let $P$ denote this union. In the top off ig. 1q, the triangle (ACE) has been projected to the thick line (EAC). At the bottom of Fig. 18, the 4 -sim plex (ACEF) has been split into simplioes (ACEF) $)_{1}$ and (ACEF) $)_{2}$ by a cone $m$ ove. $T$ he cone $m$ ove is illustrated in this pro jection, and the schem atic resem bles the cone $m$ ove in dim ension 3 as is seen on the bottom left of the gure. Thus ( $A C E F \downarrow$ and ( $A C E F)_{2}$ share the same faces ( $A C F$ ), ( $A E F$ ) and (CEF) but have di erent faces ( $A C E 1$ and ( $A C E)_{2}$. The face ( $A C E)_{1}$ is shared with ( $A B C E$ ) and the face $(A C E)_{2}$ is shared with (ACDE) respectively.

A fter the splitting, $P$ consists of three 4 -polytopes, ${ }_{j}^{1}, j=1 ; 2 ; 3$. H ere the polytope
 and ( $\operatorname{ACEF})_{2}$. The polytope $\frac{1}{2}$ is bounded by tetrahedra (ABCE), (ABEF), (ACEF) ,

( $A B C F$ ), and ( $B C E F$ ). The polytope $\frac{1}{3}$ is bounded by tetrahedra ( $A C D E$ ), ( $\left.A C E F\right)_{2}$ ( $A C D F$ ), ( $A D E F$ ), and ( $C D E F$ ). The polytope ${ }_{1}^{1}$ corresponds to ( $A B C D E$ ) and it is illustrated on the left bottom ofF ig. 18 (labeled (ABCDE) to indicate the correspondence). On the bottom right of the gure, we see the polytope ${ }_{2}^{1}$ labeled (ABCEF). In the bottom center of the gure the polytope $\frac{1}{3}$ labeled (ACDEF) to indicate its antecedent. O ur rst work willibe on ${ }_{1}^{1}$ and ${ }_{3}^{1}$.
$N$ ext perform a Pachner $m$ ove to the pair of tetrahedra (ACDE) [ (ACEF) 2 sharing the face ( ACE$)_{2}$. N ote that these two tetrahedra are shared by ${ }_{1}^{1}$ and ${ }_{3}^{1}$ so that the Pachner $m$ ove we perform does not a ect $\frac{1}{2}$. Thus we get three 4 -œlls ${ }_{j}^{2}, j=1 ; 2 ; 3$, where ${ }_{2}^{2}=\frac{1}{2}$, and ${ }_{1}^{2}$ is bounded by ( $\operatorname{ABCD}$ ), ( $\operatorname{ABDE}$ ), ( ABCE ), ( BCDE ), ( ACEF$)_{1}$, $(A C D F)^{0},(A D E F)^{0}$, and $(C D E F)^{0}$. H ere $(A C D F)^{0},(A D E F)^{0}$, and (CDEF) $)^{0}$ denote new tetrahedra obtained as a result of perform ing a Pachnerm ove to (ACDE) [ (ACEF) . Then the last polytope ${ }_{3}^{2}$ is bounded by (ACDF) ${ }^{0}$, $(A D E F)^{0}$, and (CDEF ) ${ }^{0}$ that are explained above, and ( $\operatorname{ACDF}$ ), ( ADEF ), ( $C D E F$ ) that used to be faces of $\frac{1}{3}$.

The ( $2^{*} 3$ ) move to ( $A C D E$ ) [ ( ACEF ) is ilhustrated in $F$ ig. 19. In the upper left the the 4 -œll ${ }_{1}^{2}$ is shown while ${ }_{3}^{2}$ is shown on the upper right. In the lower part of the gure the three new tetrahdera $(\operatorname{ACDF})^{0}(\mathrm{ADEF})^{0}$, and (CDEF) ${ }^{0}$ are illustrated.

Then we can collapse ${ }_{3}^{2}$ to the tetrahedra (ACDF), (ADEF), (CDEF) as in the follow ing 3 paragraphs and 2 tables.

Thepolytope ${ }_{3}^{2}$ is a 4-œlllounded by (ACDF), (ADEF), (CDEF), (ACDF) ${ }^{0}$, (ADEF) ${ }^{0}$, and ( $C D E F)^{0}$. The incidence relations for these tetrahdra are indicated in the next table. A lso see the top two row soff ig. 20.

Then perform the taco $m$ ove to the pair (CDEF) and (CDEF) that share two faces (CDE) and (CEF). Thism ove is illustrated at thebottom ofF ig. 20. Then the faces (CD F ) and (CDF) ${ }^{0},(D E F)$ and (DEF) ${ }^{0}$ are identi ed after the $m$ ove respectively. The result is a 4 -œll bounded by ( ACDF ), ( ADEF ), ( ACDF$)^{0}$, and ( ADEF ). (Precisely speaking these tetrahdera share new faces so that we should use the di erent labels, but adding a new layer of labels here will cause m ore confusion than leveing the old labels intact). The incidence relations am ong the triangles and the tetrahedra are sum $m$ arized in the next table.

The cone m ove to ( $A D E F$ ) and (ADEF) (which is illustrated schem atically in Fig. 21) follow ed by the pillow m ove to (ACDF) and (ACDF) ${ }^{0}$ collapses $3_{3}^{2}$ to (ACD F) [ (ADEF) [ (CDEF) as claím ed.

Thus we get two polytopes ${ }_{1}^{2}$ and ${ }_{2}^{2}$. Next perform a Pachner move to (ABCE) [ (ACEF) $)_{1}$ which shares (ACE) $)_{1}$. As a result we get three new tetrahedra (ABEF) ${ }^{0}$ [ $(A B C F)^{0}\left[(B C E F)^{0}\right.$. The (2 $\left.{ }^{*} 3\right)$-m ove is ilhustrated in $F$ ig. 22; the labels on the polytopes indicate their antecendents.

Thus we obtain ${ }_{1}^{3}$ bounded by ( $\operatorname{ABCD),(ABDE),(BCDE),(ACDF),(ADEF),~}$ (CDEF), ( ABEF$)^{0},(\mathrm{ABCF})^{0}$, and $(\mathrm{BCEF})^{0}$, and $2_{2}^{3}$ bounded by ( ABEF ), ( ABCF ), ( BCEF ), and ( ABEF$)^{0}\left[(\mathrm{ABCF})^{0}\left[(\mathrm{BCEF})^{0}\right.\right.$.

Hence we now can collapse ${ }_{2}^{3}$ to the tetrahedra ( ABEF ), ( ABCF ), and (BCEF) in the sam e m anner as we did to ${ }_{3}^{2}$. The collapsing is indicated in F ig. 23. The result is a single polytope ${ }^{4}$ resulted from ${ }_{1}^{3}$ which has the sam e boundary tetrahedra as those of the left hand side of the 4 -dim ensional $P$ adhner $m$ ove. $F$ igure 23 indicates the resulting polytope at the bottom of the gure. In Fig, 24 the 3-dim ensionalboundary is illustrated. N otioe the follow ing: (1) triangle (ACE) is no longer present; (2) am ong the nine tetrahedra illustrated, neither triangle (ACE) nor triangle (BDF) appears; (3) these are all of the tetrahedral faces of the 5 simplex that contain nether ( ACE ) nor ( $B D F$ ). Thus we can apply the sam em ethod starting w th ( B D F ) to get to this polytope. This proves that ( 3$)^{*} 3$ ) m ove is described as a sequence of singular moves (cone, taco, and pillow moves) and Pachner m oves.

3.2.5 Lem ma.The (2 $)^{\star}$ 4)-m ove is described as a sequence of cone moves, pillow m oves, taco m oves, and 3-dim ensionalP achner $m$ oves.

3.2.7 R em ark. In 13] C rane and Frenkel proposed constructions of 4 m anifold quantum invariants using Hopf categories. H opf categories generalize the de nition of H opfalgebra to a categoricalsetting in the sam ew ay that m odular categories generalize m odules. O ne of the conditions in their de nition is called the coherence cube which generalizes the com patibility condition of opfalgebras betw een $m$ utiplication and com utiplication (See Section 8) . They showed that this condition corresponds to the cone $m$ ove. Thus Lem mas in this section can be used to prove the well-de nedness of invariants they proposed by show ing that their de nition is invariant under Pachner $m$ oves.

## 4 T riangulations and $D$ iagram $s$

In dim ension 3, quantum spin netw orks are used on the one hand to provide calculations of identities am ong representations of quantum groups [9]. On the other hand they are cross sections of the dual com plex of a triangulated 3-m anifold (see Section 2.2).

In this section, we use sim ilar graphs to relate them to the dual com plex of triangulated 4 m anifold. W e begin the discussion on the local nature of triangulated 4 m anifolds near 2-dim ensional faces.
4.1 G raphs, 2-com plexes, and triangu lations. Let be a triangulation ofan oriented closed 4 m anifold M . In this section we associate graphs to triangulations and their duals.
4.1.1 De n ition. The dual com plex of is de ned as follow s . P idk a vertex v of in the interior ofeach 4 -sim plex of . C onnect two vertiges $v_{1}$ and $v_{2}$ of if and only if the corresponding 4-sim plioes of share a 3-face. Thus each edge of is dual to a tetrahedron of . Edges $e_{i}$; bound a face $f$ if and only if the corresponding tetrahedra share a 2-face of . A set of 2-faces $f_{1}$; $k$ fff bounds a 3-face (a polyhedron) if and only if the corresponding faces of share an edge of . F inally a set of3-faces of bounds a 4-face if and only if the corresponding edges of share a vertex. Thus gives a CW -com plex structure to the $4-\mathrm{m}$ anifold.
4.1.2 D e nition. Let be a triangulation of a $4-\mathrm{m}$ anifold M , and let be the dual com plex. E ach 3-face of is a polytope. Choose a triangulation of each 3-face into tetrahedra so that it de nes a triangulation of the 3-skeleton of . W e require that such a triangulation does not have interior vertioes in the 2-faces of. $T$ hus the restriction on each $n$-agonal 2-face consists of ( $n \quad 2$ ) triangles. Such a choice of triangulation is called a 3-face triangulation (a triangulation for short) of . A 3-face triangulation is denoted by $!$.
4.1.3 D e nition (C arrier Surface). In each tetrahedron of the triangulation ,weembed the dual spine to the tetrahedron. The intersection of the dual spine with a triangular face is a graph consisting of a 3-valent vertex w th edges intersecting the edges of the tetrahedron. There is a vertex in the center of the 2 -com plex at which four edges (corresponding to the faces of the tetrahedron) and six faces (corresponding to the edges) intersect. The union (taken over all tetrahedra in the triangulated 4-m anifold) of these 2-com plexes form a 2 -com plex, $C$, that we call the carrier surface. Let us exam ine the incidence relations of the carrier surface along faces and edges of the triangulation.

C onsider a 2-face, $f$, of the triangulation. Suppose that $n$ tetrahedra are incident along this triangle $f$. Then the dual face $f$ is an $n$-gon. The $4-\mathrm{m}$ anifold in a neighborhood of the face $f$ looks like the C artesian product $f \quad f$. The carrier surface in this neighborhood then appears as $Y \quad X_{n}$ where $X_{n}$ is the 1 -com plex that consists of the cone on $n$-vertices (i.e., the $n$-valent vertex), and $Y$ is the graph that underlies that alphabet character (a neighborhood of a trivalent vertex). For exam ple $\mathrm{X}_{2}$ is an interval, $\mathrm{X}_{3}=\mathrm{Y}, \mathrm{X}_{4}=\mathrm{X}$, etc. W e can think of $X_{n}$ being em bedded in $f$ with the edges of $X_{n}$ intersecting the centers of the edges of $f$ and the vertex of $X_{n}$ lying at the \œenter" of $f$ (i.e. we $m$ ay assume that $f$ is a regular polygon).

C onsider an edge, $e$, of , and the $3-œ l_{l}, \mathrm{e}$, that is dual to $e$. The faces ofe are n -gons, $f$, that are dual to the triangular faces, $f$, which are incident to $e$. The carrier surface intersects a face $f$ in the graph $X_{n}$. The carrier surface intersectse in a 2 -com plex that is the cone on the union of the $X_{n}$ where the union is taken over all the faces ofe .

The situation is depicted in F ig. 23 in which three tetrahedra intersect along a triangular face. O $n$ the right hand side of the gure, we illustrate a graph movie. The two graphs that are draw $n$ there represent the intersection of the carrier com plex w ith the boundary of f f. In a neighborhood of this face the carrier com plex looks like Y Y. In this and subsequent gures, the vertioes that are labeled w ith open circles correspond to the dual faces $f$. In this gure, three such circled vertioes appear since the dual face appears on each of the duals to the three edges.
4.2 Faces and diagram s. Suppose that the face (012) of a triangulation of a 4-m anifold is shared by three tetrahedra $T_{i}, i=1 ; 2 ; 3$. Take a neighborhood $N$ of the face (012) in the 3 -skeleton of the triangulation such that $\mathrm{N} \backslash \mathrm{T}_{\mathrm{i}}$ is di eom onphic to (012) I for each i=1;2;3.

In $F$ ig. 25 the projection of a neighborhood $N$ of the face (012) is depicted in 3-space. D enote by $0^{0}, 0^{\infty}, 0^{\infty 0}$ the vertices obtained from the vertex 0 by pushing it into $T_{i}, i=0 ; 1 ; 2$; respectively (they are depicted in F ig. 25). Sim ilar notation is used for the other vertices.
$T$ he graph $m$ ovie for $N$ is constructed as follow $S$. Regard $N$ as a 3-dim ensionalpolyhedral com plex consisting of the follow ing faces: $\left(0^{0} 1^{0} 2^{\circ}\right),\left(0^{\left.\infty_{1}{ }^{\infty} 2^{\infty}\right),\left(0^{\infty} 0_{1}{ }^{\infty} 2^{\infty}\right)}\right.$ ), ( $\left.\left.011^{0} 0^{\circ}\right),\left(010^{\infty_{1}}\right)^{\infty}\right)$, $\left(010^{\infty 0} 1^{\infty}\right),\left(122^{0} 1^{0}\right),\left(122^{\infty} 1^{\infty}\right),\left(122^{\infty} 1^{\infty 0}\right),\left(200^{\circ} 2^{\circ}\right),\left(200^{\infty} 2^{\infty}\right),\left(200^{\infty} 2^{\infty}\right)$. Then trivalent vertioes are assigned to the $m$ iddle points of the triangular faces $\left(0^{0} 1^{0} 2^{0}\right),\left(0^{\infty} 1^{\infty} 2^{\infty}\right),\left(0^{\infty 0} 1^{\infty 00} 2^{\infty 0}\right)$, and the m iddle points of the edges (01), (12), (20). These are connected by segm ents as indicated in the gure where this 1-com plex is depicted in two parts. Them iddle point in the interior of $N$ is the cone point of this 1-dim ensional com plex. $W$ ithin $N$ we have an em bedding of the $C$ artesian product $Y \quad Y$ where $Y$ represents the obvious graph $w$ ith one trivalent vertex. $T$ he graphs on the right of $F$ ig. 25 represent portions of the boundary of $Y$ Y . The space $Y \quad Y$ is indicated in $F$ ig. 26 in which the subspace $Y$, where denotes a vertex, is indicated as a fat vertex tim es $Y$. The labels on the $F$ igure $w$ ill be explained in Section 6.1 .1 and F ig. 34 .

Below (Sections 6.4 and (8) we w ill relate these spin netw orks to cocycle conditions in a speci cH opfcategory. In thisway, wew illobtain a direct connection am ong these structures.
4.2.1 De ntion. W e perturb the carrier surface to construct a 2-dim ensional com plex that has the follow ing properties:

1. The vertices of the com plex all have valence 4 or valence 6 .
2. E xactly three sheets $m$ eet along an edge;
3. The set of edges can be partitioned into tw o subsets; we color the edges accordingly.
4. A valence 4 vertex has 4 edges of the sam e color incident to it;
5. A valence 6 vertex has 3 edges of each color incident to it.
6. Thus, the 2 -com plex has a tripartite graph as its 1-com plex and a bipartition on the set of edges.

Such a 2-com plex will be called a perturbed carrier.
4.2.2 Lem m a. A perturbed carrier can be constructed from the carrier surface by m eans of a 3-face triangulation.

Proof. C onsider a 3-face triangulation; recall this is a triangulation of the dual 3-œells of the triangulation , and a 3-face is the dual to an edge e. A n-agonal face ofe is divided into ( $n \quad 2$ ) triangles. The graph $X_{n}$ in the $n$-agonal face is replaced $w$ ith the dual to the triangulation. In e, the cone on the union of the $\mathrm{X}_{\mathrm{n}} \mathrm{S}$ is replaced by the union of the duals to the tetrahedra in the triangulation. These are the surfaces $w$ ith 6 faces, 1 vertex, and 4 edges; they glue together in e to form the subcom plex in which all of the vertioes have one color. A $n$ exam ple is illustrated in $F$ ig. 27 in which the dual of an edge is a cube.

The vertioes that have two di erent colored edges incident to them are found on the triangular faces of the 3 -face triangulation. Three of the edges are com ing from the dual face, the other three edges are com ing from the dual com plex of the original tetrahedra. The local structure at the 6-valent vertioes was explained in detail above. This com pletes the proof. 2
4.2.3 D e nition. A graph $m$ ovie is a sequence of graphs that appear as cross sections of a portion of the perturbed carrier when a height function is chosen, such that the stills of m ovies are graphs having trivalent (circled and uncircled) vertioes and between two stills, the $m$ ovie changes in one of the follow ing ways:

1. The change of the $m$ ovie at a face (a 6-valent vertex of a carrier surface) is as de ned above (the change of graphs show $n$ in $F$ ig. (25).
2. The change of the $m$ ovie at a 4 -valent vertex is as depicted in $F$ ig. 32 bottom .

3. The changes of the $m$ ovie at critical points of edges and faces of the carrier surface is generic. They are depicted in $F$ ig. 28 .

In the graphs we use circled vertioes and uncircled vertices. These are cross section of two types of edges. In the gures of carrier surfaces ( $F$ ig. $\sqrt{38}, \sqrt{39}$, and 27 ), the edges corresponding to circled vertioes are depicted by thin tubes. T he graph movie de ned here includes de nitions given above (which are clearly equivalent). The graph $m$ ovie allow s us to view the perturbed carrier via a sequence of 2 -dim ensional cross-sections w hereas the carrier surface itself does not em bed in 3-dim ensional space.
4.3 T aco m oves and graph m ovies. Herein we directly relate the graph m ovies to the taco move. In Figs. 29 and 30 the lefthand-side and the right-hand-side of the taco $m$ ove are depicted, respectively. In each gure, the underlying union of tetrahedra rem ains unchanged from fram e to fram e. Instead the thick lines change as follow s. C onsider the $(i ; j)$ th entry of the gure to be that illustration in the ith row jth column. Going from the $(i ; 1)$ st entry to the ( $i ; 2$ ) nd entry, the graphs change by one of the graph $m$ ovie changes (either going across Y Y or going across tetrahedra). T here is no change from the ( $i ; 2$ ) nd entry to the (i+1;1)st entry. In these gures thick lines indicate the graph that was de ned in Section 4.2. The transitions betw een the two entries on the sam e row $m$ ay be visualized by $m$ eans of a crosseyed stereo-opsis. P lace a pen in the center of the gure, and $m$ ove the pen tow ards your face while keeping it in focus. The two im ages on the left and right should converge into one w ith the thick lines popping out of the plane of the paper. In this way, the di erence betw een the gures can be experienced directly.

O bserve that the di erences in the graphs are illustrated as well in the Fig. $3 \$$ whidh illustrates the graph $m$ ovies for the cocycle conditions and which is obtained by purely algebraic inform ation. The tim e elapsed version of the graph $m$ ovie for the taco $m$ ove is illustrated in Fig. 38 and $F$ ig. 39. Sim ilar diagram $s$ can be drawn for the cone $m$ ove and the pillow m ove and in this way a direct correspondence can be obtained am ong the m oves, the cocycle conditions, and the axiom s of a H opf category (Section Z). The taco, cone, and pillow m oves all correspond to the rst coherence cube. The correspondence am ong these m oves should not be surprising since all of these $m$ oves correspond to splitting a tetrahedron open (the higher dim ensional analogue of the coherence relation between multiplication and com ultiplication).

## 5 C ocycles and cocycle conditions

In this section, we list cocycles and their equalities that willbe used in the follow ing sections. These cocycles are given in [17] in relation to H opf categories (See Section 8). Som e nontrivial exam ples are given therein. First, we $m$ ention that tw o of the cocycle conditions are depicted in $F$ igs. 36 and 37 as relations to graph $m$ ovies where the edges of the graph have been colored with pairs of group elem ents and dual group elem ents. These graph $m$ ovies correspond to the dual graphs that correspond to the taco move (Fig. 29 and 30). The coloring will.be explained in the subsequent section.

5.2 C ocycle sym m etries. In addition to the above cocycle conditions, we will suppose that the cocycles satisfy som e equations that correspond to the sym $m$ etries of tetrahedra and of the space Y Y. The im position of such conditions willbe su cient to construct an invariant. W e do not know if the sym $m$ etry conditions are necessary. (T hey may be satised autom atically for certain cocycles, or the invariants $m$ ay be de ned w ithout sym $m$ etry conditions.)

## 6 Labels, w eights, and the partition function

6.1 Labeling. Let denote a triangulation of the $4-\mathrm{m}$ anifold M , and let denote the dual com plex. Each 3-face of is a polytope that corrresponds to an edge of . Choose a triangulation of the 3 -skeleton of. There are no interior vertioes in the 2 -faces of . Thus the restriction on each polygonal2-face consists of $\left(\begin{array}{ll}n & 2\end{array}\right)$ triangles. A s before, such a choice of triangulation is called a 3-face triangulation of . A 3-face triangulation is denoted by !.
$W$ hen an order, $O$, is xed for the vertex set, $V$, we de ne the orientation of dualedges as follows. A vertex of is a 4 -sim plex of whose vertices are ordered. Then 4 -sim plices are ordered by lexioographic ordering of their vertioes. This gives an order on vertioes of giving orientations of edges of . O rientations of edges of ! are ones that are com patible w ith the above orientation.

$H$ ere $E$ denotes the set of oriented edges, and $T$ is the set of tetrahedra. $W$ e require the follow ing com patibility condition.

If ( $e_{1} ; e_{2} ; e_{3}$ ) form $s$ an oriented boundary of a face of a tetrahedron $t_{1} S_{0}\left(e_{1} ; t\right)=(k ; \hat{v})$, and $S_{0}\left(e_{2} ; t\right)=(g ; \hat{h})$, then $S_{0}\left(e_{3} ; t\right)=(m ; \hat{n})$, where $m=g k, n=\imath$, and $k{ }^{1} h k=` . W e$ call this rule the local rule of colons at a triangle (or sim ply a bcal rule). The situation is depicted on the left of Fig. 31.

W hen an order of vertices is given, the edges are oriented by ascending order of vertices (if the vertices $v$ and $w$ of an edge have the order $v<w$, then the edge is oriented from $v$ to $w$ ). H ow ever in this de nition the order on vertiges is not required, although orientations on edges are required. For an oriented edge $e$, the sam e edge $w$ th the opposite orientation

is denoted by $e$. C onsider the edge $e_{2}$ on the left of $F i g .31$, and reverse the orientation of $e_{2}$ to get $e_{2}$. Then the color of $e_{2}$ is required to be $S\left(e_{2} ; t\right)=\left(g^{1} ; g k{ }^{\prime}{ }^{1} g^{1}\right)$ where $S\left(e_{2} ; t\right)=\left(g ; k^{d} k^{1}\right)$ as depicted in the gure. In other words, the color for an edge $w$ ith reversed orientation is de ned to satisfy the local requirem ent of the left of F ig. 3. .

W e often use sets of non-negative integers to represent simpliges of. For exam ple, $x$ a 3-face (or tetrahedron) T of $. \operatorname{Let} 0,1,2$, and 3 denote the vertiges of $T$. For a pair of an oriented edge (01) and a tetrahedron $\mathrm{T}=(0123)$ a labeling assigns a pair ( $g$; $\hat{\mathrm{h}}$ ) which we som etim es denote by $S_{0}(01 j 0123)=S_{0}((01) ;(0123))$. W hen a total order is xed, the integers are assum ed to have the com patible order $(0<1<2<3)$.

W e will show (Lem m a 6.1.5) that there is a coloring of each tetrahedron satisfying the local rule. Furtherm ore, we will show that changing the orientations of edges of a colored tetrahedron results in a unique coloring.

H ere $E$ ! (resp. P ) denotes the set of oriented edges (resp. 3-polytopes) of ! (resp. ). T he follow ing com patibility conditions are required.

If $\left(e_{1} ; e_{2} ; e_{3}\right)$ form an oriented boundary of a face of a tetrahedron $t$ of $!$, then the rst factors of colors (group elem ents) coincide, and if they are $S!\left(e_{1} ; t\right)=(g ; \hat{l})$, and $S!\left(e_{2} ; t\right)=$ $(g ; \hat{k})$, then $S^{!}\left(e_{3} ; t\right)=(g ; \hat{h})$, where it is required that $h=k l$.

W hen an order of vertioes is given, the edges are oriented by ascending order of vertiaes as before. C onsider the edge $e_{2}$ in the $F$ ig. 31 right, and reverse the orientation of $e_{2}$ to get $e_{2}$. Then the color of $e_{2}$ is required to be $S^{!}\left(e_{2} ; t\right)=\left(g ; k^{1}\right)$ where $S\left(e_{2} ; t\right)=(g ; k)$ as depicted in the gure. In other words, the color for an edge w ith reversed orientation is de ned to satisfy the local requirem ent of the right side of $F i g \sqrt{31}$.

In the gure, dual graphs in triangles are also depicted. W e put a sm all circle around a trivalent vertex for the dual faces. A $s$ in the case for tetrahedra, dual tetrahedra can be colored, and changing the orientation forcolored dualtetrahedra gives a unique new coloring (Lemma 6.1.5). N ote that there is a pair ( $\mathrm{p} ; \mathrm{e}^{0}$ ) 2 EP ! which is dual to a pair (e;t) 2 ET , in the sense that $e^{0}$ is dual to the tetrahedron $t$ and $p$ is dual to the edge $e$. H ow ever there are pairs in EP ! that are not to dual to pairs in ET .

6.1.5 Lem m a. (1) For a tetrahedron or dual tetrahedron, there are colors satisfying the local rule at every face or dual face.
(2) There are colors on the edges and dual edges adjacent to a given face satisfying the local rules.
(3) Let C be a colbr assigned to the oriented edges (or dual edges) of a tetrahedron (or dual tetrahedron). Let $\mathrm{C}^{0}$ be a color assigned to the sam e tetrahedron (or dual tetrahedron) $w$ ith orientations reversed on som e of the edges. Then $\mathrm{C}^{0}$ is uniquely determ ined. If the color C is assigned to oriented edges and dual edges that are adjacent to a face, then the color $\mathrm{C}^{0}$ is uniquely determ ined when som e of the edges or dualedges have their orientations reversed.

Proof. W e prove (1) and (2) in the case of tetrahedra. The proof for dual tetrahedra is sim ilar and follow s from 44].

For tetrahedra, the situation is depicted in Fig. 32. In the top of the gure, a tetrahedron w ith colors on three edges is depicted. O ther edges receive com patible colors that are determ ined by these three. In the $m$ iddle, pairs of front faces and back faces are depicted in the left and right respectively, together with dual graphs. In the bottom of the gure, only the dual graphs are depicted, together w ith colors on all the edges. W e check that the rst factors of colors $m$ atch in $m$ ultiplication convention in F ig. 31. The second factors are also checked as follow s: in the bottom left gure, ${ }^{\wedge}=\mathrm{mnm}^{1}$ and $\mathrm{h}=\mathrm{k} \mathrm{k}^{1}$. In the bottom right gure, ${ }^{\prime}=\mathrm{m} \mathrm{nm}^{1}$ (the sam e relation as above) and $\left.\mathrm{h}=(\mathrm{km}) \mathrm{n}(\mathrm{km})^{1}\right)$ whid reduces to $\mathrm{km} \mathrm{nm}{ }^{1} \mathrm{k}^{1}=\mathrm{k}^{\mathrm{k}}{ }^{1}$, the sam e relation as above. Thus the requirem ents on faces m atch at a tetrahedron.

To prove (3) for tetrahedra, rst consider the case where the orientation of the edge 23 is reversed. Then the face (123) foroes the change $S(23-0123)=\left(g^{1} ; \mathrm{gk} \mathrm{V}^{1} \mathrm{~g}^{1}\right)$. The

other face (023) foroes the change $S(23-0123)=\left(g^{1} ;(g \mathrm{~km}) n^{d}(g k m)^{1}\right)$. These are equal since ${ }^{`}=\mathrm{m} \mathrm{nm}{ }^{1}$. The situation is depicted in the top right of $F$ ig. 33 where the reversed orientations are depicted by a sm all circle on the edge. The top left gure indicates the original colors. In the gure, the \hats" on the dual group elem ents are abbreviated for sim plicity.

The other cases when the orientation of a single edge is reversed, are also depicted for the cases (0213), (1023). T he general case follow s because all cases are obtained by com positions of these changes.

N ext consider statem ent (2). In Fig. 34 the colors are depicted using dualgraphs (identify this graph w ith the graph in Fig. 25). First we chedk the orientation conventions in the gure. Identify the circled vertex of the right-hand-side graph of bottom of $F$ ig. 2 b w ith the right-hand-side of Fig . 31. Then the orientation conventions of dual edges coincide where $e_{1}$ of $F$ ig. 31 corresponds to the edge (02) (0123), $e_{2}$ to (02) (0125), $e_{3}$ to (02) (0124). The tetrahedron (0123) is shared by (01234) and (01235), that are ordered as $(01234)<(01235)<(01245)$ am ong three 4 -sim plices. Thus this correspondence to $e_{1}$ $m$ atches $w$ th the de nition of the orientation of dual edges.

N ow we check the constraints. In the left bottom of F ig. 25 the follow ing relations $m$ ust hold: $i=k m k^{1}$ (from the top left vertex), $j=k^{\prime \prime}{ }^{1}$ (from the top right vertex), $h=m^{\prime}$ (from the bottom right vertex), and $i j=\mathrm{khk}^{1}$ (from the bottom left vertex). The last relation is reduced by substitution to $\mathrm{k}\left(\mathrm{m}^{`}\right) \mathrm{k}^{1}$ both sides, so that the weight is com patible. In the right of the gure, we get the relation $h=m$ 'from the top vertex, which is the sam $e$ as above, and the condition for the bottom vertex is already inconporated (by using khk ${ }^{1}$ in bottom left). Thus the colors around a face are com patible.

N ow let us check that the orientation conventions are com patible in $F$ ig. 34. The orientations on the edges are the orientations from the vertex ordering as seen in the gure. The orientations on dual edges are chedked as follow s . In the gure the face (012) is shared by three 4 -sim plices, (01234), (01245), and (01235). T he dualedge labeled by (gk ; ${ }^{\wedge}$ ) is dual to the tetrahedron (0123) and oriented from (01234) to (01235), corresponding to the edge $e_{1}$ on the right ofF ig. 31. R espectively, the one labeled by ( gk ; m ) goes from (01235) to (01245) corresponding to $e_{2}$, the one labeled (gk; $\hat{\mathrm{h}}$ ) goes from ( 01234 ) to ( 01245 ) corresponding to $e_{3}$. Thus the orientations de ned from the order on vertices $m$ atch the convention in $F$ ig 31 .

To prove part (3), we check the cases of interchanging the orientation of som e of the edges. The general case will follow from the cases depicted in $F$ ig. 40 and 41 since the orientation changes depicted therein generate all the orientation changes.

First consider the case where the edge (12) has reversed orientation. This corresponds to changing the vertex order from (012345) in the gure to (021345). (The orientations on dual edges do not change.) Then three colors change: $(g ; \hat{i})$ to $\left(g^{1} ;(g k) m^{d}(g k)^{1}\right),(g ; \hat{j})$ to $\left(g^{1} ;(g k)^{d}(g k)^{1}\right)$, and $\left(g ; k h^{1}{ }^{1}\right)$ to $\left(g^{1} ;(g k) h^{d}(g k)^{1}\right)$. These changes are forced by the nules at faces (uncircled trivalent vertioes of the graphs). H ence we check the rules at circled trivalent vertioes. The only relevant vertex is the one on the left bottom in the gure. It m ust hold that $(\mathrm{gk}) \mathrm{h}(\mathrm{gk})^{1}=(\mathrm{gk}) \mathrm{m}(\mathrm{gk})^{1} \quad(\mathrm{gk})^{`}(\mathrm{gk})^{1}$. 6.2.1 Denition (weights for tetrahedra). Let T 2 be a tetrahedron w ith vertioes $0,1,2$, and 3 . Suppose $S(01 j 0123)=(m ; \hat{n}), S(12 j 0123)=(k ; 1)$, and $S(23 j 0123)=(g ; \hat{h})$.

The weight of $T$ w ith respect to the given labelings of edges is a num ber (an elem ent of the ground eld) de ned by

Then $T$ is shared by two 4 -simpliees, say, $S=\left(a_{0} ; a_{1} ; a_{2} ; a_{3} ; v\right)$ and $\left(a_{0} ; a_{1} ; a_{2} ; a_{3} ; w\right)$. Here we ignore the given labels of $v$ and $w$, and consider the orders w ritten above ( $v$ and $w$ com ing last). Then exactly one of these two $4-\operatorname{sim}$ plioes, say, S, w th this order $\mathrm{a}_{0}<\mathrm{a}_{1}<\mathrm{a}_{2}<\mathrm{a}_{3}<\mathrm{v}$, m atches the orientation of the $4-\mathrm{m}$ anifold, and the other has the opposite orientation.

C onsider the label on $v$ induced by the ordering on the vertices. If the integer index of $v$ is such that the oriented simplex ( $a_{0} ; a_{1} ; a_{2} ; a_{3} ; v$ ) is obtained from the order induced by labeling by an even perm utation, then ( $T$ ) $=1$. Otherw ise, ( $T$ ) $=1$. (Som etim es we represent the order of vertioes by labeling the vertioes by integers.)

N otice that by the conditions in the de nition of a triangulation each facem ust be shared by at least three tetrahedra. H ow ever In the course of com putation wem ay have to dealw ith singular triangulations. In this case it can happen that only two tetrahedra share a face. Let 0123 and 0124 be such tw o terahedra sharing the face 012. T hen the weight assigned to the face 012 in this case is the product of K ronedker's deltas:

There are other cases of singular triangulations that appear in ourproofs ofw ell-de nedness, and their weights are de ned as follows.

Suppose that two tetrahedra share vertices $0 ; 1 ; 2 ; 3$ and share all of their faces except (013). M eanw hile, suppose that the face (013) on each of the respective tetrahedra is shared w ith tetrahedra (0134) and (0135). The other faces are shared by the tetrahedra (0126), (0237), and (1238). The situation is depicted in Fig. 42 top. In the gure, colors and w eights are also depicted. The signs for each weight are also depicted in the gure in this situation, by indicating the power 1 on one of the $s$.

Suppose in another situation that tw o tetrahedra share all vertioes and all 2-faces (triangles) as depicted in $F$ ig. 43. The signs for this situation are also depicted in the gure.

In general if the order of vertices are di erent, then they are obtained from the above speci c situations by com positions of perm utations. Then the weights and signs are de ned by applying Lem ma 6.1.5.
6.2.3 De nition (w eights for edges). C onsider the triangulation of the 3-sphere $S^{3}$ consisting of 5 tetrahedra (1234), (1235), (1245), (1345), and (2345), where integers represent the vertioes. This triangulation is depicted in $F$ igure 35 by solid lines. H ere, the subdivided tetrahedron $w$ th vertioes $2 ; 3 ; 4$ and 5 w th the interior vertex 1 is a triangulation of a $3-b a l l$, and together w th the \outside" tetrahedron (2345) they form a triangulation of $S^{3}$. N ow take a cone of this triangulation with respect to the vertex 0 to obtain a triangulation of a 4 -ball consisiting of 54 -sim plices (01234), (01235), (01245), (01345), and (02345). This is
depicted in F igure 35 also, where edges having 0 as end point are depicted by dotted lines. (R egard dotted lines as lying in the interior of the 4 -ball.)

Suppose an edge E = (01) has this particular triangulation as the neighborhood. Suppose $S(01-j 0123)=(g ; \hat{\imath}), S(01 j 0124)=(g ; \hat{k})$, and $S(01 j 0125)=(g ; \hat{j})$. Then the weight for the edge (01) is de ned by

If the neighborhood of an edge has a di erent triangulation, then the weight is de ned as follow s. Let $H_{1} ; \quad{ }_{\mathrm{s}}$; ■ ! be the set of tetrahedra of the polytope p 2 , and let $h_{i}^{j}$ be the set of edges of $H_{i}, j=1 ; \quad ; 6$. Then the weight is de ned by

where each is assigned to a tetrahedron of the above triangulation follow ing the order convention of vertioes. The product of the above expression is taken over all the shared edges, and the sum is taken over all the possible states on shared edges. The exponent, $a$, on the nom alization factor, $1=j G$ fac is the num ber of verticies in the interior of the polyhedron dual to the given edge.
6.3 Partition function. Let be a triangulation of a 4-manifold $M$ with the set of vertioes (resp. edges, faces, tetrahedra) V (resp. E, F , T ). Fix also a triangulation ! of the dual .
6.3.1 D e nition. The partition function ( ) for a triangulation $=$ [ ! with a total order on vertioes is de ned by
where the product ranges over tetrahedra, faces and edges of the triangulation , the sum $m$ ation ranges over all the possible states, and the exponent $a$ on the norm alization factor is the num ber of vertioes in the triangulation.
6.3.2 M ain T heorem . The partition function ( ) de ned above for triangulations =
[ ! of a 4-m anifold $M$ is independent of the choice of the triangulation and ! and independent of choice of order on vertices.
$T$ herefore the partition function de nes an invariant of a $4-\mathrm{m}$ anifold M .
Section $[7$ is devoted to giving the proof of this theorem.

6.4 D iagram s, cocycles, and triangulations. Here we explain relations am ong diagram s, cocycles, and triangulations. Figure 31 illustrates the coloring rules at triangles and dual triangles. In these triangles and dual triangles graphs are em bedded; the verticies of the graphs in the dual triangles are labeled by sm all circles. The cocycles are assigned to tetrahedra; the cocycles are assigned to dualtetrahedra, and the cocycles are assigned to triangular faces. Each such gure also corresponds to a graph $m$ ovie which depicts a part of the perturbed carrier surface. W e can think of the cocycles as being assigned to the vertioes of the perturbed carrier surface which has a tripartition on its vertex set. Indeed the $m$ any scenes that constitute the graph $m$ ovie are found on the boundary of a regular neighborhood of the vertices of the carrier surface. In this way we can directly visualize the construction of the invariant as a colored surface w ith w eighted vertices or as a colored graph $m$ ovie w ith weights associated to the scenes.

Sim liarly, the cocycle conditions can be described as relations on $m$ ovies of tree diagram s. $F$ igures 36 and 37 depict these relations. E ach change of a tree diagram (scene in the $m$ ovie) corresponds to a cocycle as indicated. W hen we multiply the left-hand-side and the right-hand-side of cocycles in the $m$ ovies, we obtain cocycle conditions am ong , , and .

The cocycle conditions can also be understood in term s of certain singular surfaces that are em bedded in the 4 m anifold. These surfaces are depicted in F igs. 38 and 39. In these gures the cocycles corresponds to the surface ( Y ) and the cocycle corresponds to the surface that is dual to a tetrahedron. The assignm ent of to $Y \quad Y$ is indicated in the weights on Fig. 26. The reasons for these assignm ents is that the cocycle is found when three tetrahedra share a triangular face, and the cocycle is assigned to a tetrahedra. In Figs. 38 and 39 som e edges are denoted as tubes. A tube of the form Y corresponds to a triangle that is shared by three tetrahdra as in Fig. 25.

## 7 On invariance of the partition function

Recall the notation in Section 6: denotes a triangulation of a 4-m anifold M, its dual complex, ! a 3-face triangulation of. In Section 7.1 we show that the partition function de ned is independent of the order on vertices. In Section 77, we show that the partition function is independent of the triangulation. In Section 7.3 we show that the partition function is independent of the choioe of dual triangulation.

### 7.1 Independence on order of vertices. In this section we prove

7.1.1 Lem ma. The cocycle sym $m$ etries im ply the independence of the partition function on the order on vertices of the triangulation.

P roof. For tetrahedra and dualtetrahedra, the weights are the cocycles and respectively. A s in [44], it is su cient to check how weights change when the order of vertioes are changed from (0123) to (0132), (0213), and (1023). Such changes are illustated in Fig. 33 for , and the corresponding conditions are listed for , and in Section 52.1.

For a face, we check as follow s. In Fig. 34 an order of vertices are given, where the face is given by (012), and the other vertioes are given labels 3, 4, and 5. T he changes of orders

of vertices are generated by the changes from (012345) to (021345), (102345), (for the face) (012354), (012435), (for the dual face) since only the relative orders am ong the vertiges of the face and those of the dual faces are in consideration. For these changes, the colors are listed in Fig. 40 and $F$ ig. 41. They are depicted in term $s$ of dual graphs, and on the right hand side, the orientations of edges of faces/dual faces are show $n$. T he sm all circles indicate reversed orientations. The corresponding conditions are listed in Section 52.1.

Ifm ore than three tetrahedra share a face, then a change in order of the vertices can be achieved by such pairw ise sw itches. Futherm ore, in order to a ect such changes, we may have to group the vertioes in sets of 3. This grouping is achieved by a 3-face triangulation. So the proofw ill follow once we have shown invariance under the 3-face triangulation. 2
7.2 Independence under P achner m oves. In this section, we explicitly relate the cone m ove, taco m ove and pillow m ove to the cocycle conditions. Since these m oves and lower dim ensionalm oves generate the P achner m oves, we will use the cocycle conditions to show that the partition function is invariant under the $P$ achner $m$ oves.
7.2.1 Lem ma. The partition function is invariant under the cone move for a local triangulation w ith a speci c choice of order depicted in Fig. 42.

Proof. Let (0123) ${ }_{1}$ and $(0123)_{2}$ be tetrahedra sharing the sam e faces (012), (013) and (023), but having di erent faces (123) and (123) ${ }_{2}$, such that (1) the union of the triangles (123) [ $(123)_{2}$ bounds a 3 -ball B in the 4 m anifold, (2) the union of B , $(0123)_{1}$ and $(0123)_{2}$ is di eom orphic to the 3 -sphere bounding a $4-$ ballw in the $4-\mathrm{m}$ anifold. (See F igs $\sqrt{18}, 42$.) In these gures, the m ovies of dual graphs are depicted where each of the faces (013), (023), (123) is shared by another tetrahedron ( (0124), (0125), (0126), respectively). W e prove the invariance in this case. The general case follow s from such com putations together w ith the pentagon identity of .

Fig. 42 show s the colors and cocycles assigned to this local triangulation (again note the direct relation between this assignm ent and those for the top graph in Fig. 36). The left hand side of the cone $m$ ove (top off ig. 42) has the local contribution

P roof. In Fig. 44 the assignm ents of colors and cocycles are shown. The left hand side of the taco m ove (top of Fig .44) has the local contribution

This is exactly one of the cocycle conditions. 2
O bserve that the diagram $m$ atics of the graph $m$ ovie $m$ ove that results from the taco $m$ ove $m$ atch exactly the graph $m$ ovie $m$ ove that represents the cocycle condition $F$ ig. 36. Sim ilar graph $m$ ovies can be draw $n$ for the cone and pillow $m$ oves and the correspondence $w$ ith the $m$ ove and the coycle conditions can be worked out via the graph $m$ ovies. $M$ aking such correspondence show sexplicitly the $m$ ethod of constructing invariants via H opf categories where, instead of cocycle conditions, coherence relations are used. T he coherence relations can be expressed by such graph $m$ ovie $m$ oves (See Section (8).

Since the partition function is invariant under the cone, taco, and pillow moves, and since
satis es a pentagon relation, we have the partition function is invariant under the $P$ achner m oves.
7.3 Independence on triangulations of the dual com plexes. In this section, we com plete the proof that the partition function is well-de ned by show ing that the partition function does not depend on the 3-face triangulation, !.
7.3.1 Lem m a. If $\mathrm{T}_{1}$ and $\mathrm{T}_{2}$ are triangulations of a 3-dim ensionalpolytope which is dieom orphic to a 3 -ball such that $\mathrm{T}_{1}$ and $\mathrm{T}_{2}$ restrict to the sam e triangulation on the boundary, then they are related by a nite sequence of $P$ achner $m$ oves.

Proof. We rst prove the corresponding statem ent in dim ension 2, then use the result in dim ension 2 to achieve the result in dimension 3. In the proof we use the notation (i ${ }^{*}$ j) m ove to indicate the $m$ ove in which i sim plioes are replaced by $j$ sim plices. So the ( $j^{*}$ i) m ove is the inverse $m$ ove, and the order of $i$ and $j m$ atter.

In dim ension 2, we have two triangulations of the disk that agree on the boundary, and we are to show that they they can be arranged by Pachner $m$ oves xing the boundary to agree on the interior. W e prove the result by induction on the num ber of vertioes
on the boundary.
Recall 39] [7], that the star of a $k$-sim plex (in a sim plicial com plex) is the union of all the sim plices that contain the $k$-sim plex. The link of a $k$-sim plex is the union of all the sim plices in the star that do not contain the k -sim plex. W e w ill exam ine the stars and links of vertices on the boundary of a disk (and later on the bounday of a 3-ball). So denote the
star of $v$ w ith respect to the boundary by: sts ( $v$ ). Sim ilarly, the link of $v w i t h$ respect to the boundary is $\mathbb{k}_{\mathrm{S}}(\mathrm{v})$ while these sets w ith respect to the interior are $s t_{B}(\mathrm{v})$ and $\mathbb{k}_{\mathrm{B}}(\mathrm{v})$, respectively.

In dim ension 2 , $s t_{s}(\mathrm{v})$ is a pair of edges that share the vertex $\mathrm{v} . \mathrm{M}$ eanwhile, $\mathbb{k}_{\mathrm{B}}(\mathrm{v})$ is a polygonal path properly em bedded in the disk that is the $m$ ost proxim ate to v am ong all paths in the interior that join the points of $\mathbb{k}_{\mathrm{s}}(\mathrm{v})$.

W e $x$ our consideration on one of the triangulations, say $T_{1}$ ofD ${ }^{2}$. Wewant to alter this triangulation so that $\mathbb{k}_{\mathrm{B}}(\mathrm{v})$ is an edge (so it has no interior vertiges). If we can achieve this alteration, then we can perform sim ilar $m$ oves to $T_{2}$. The vertex $v$ on either triangulation then w ill becom e the vertex of a triangle that is attached to the disk along a single edge.

W e can rem ove such a triangle (or altematively, work in the interior) and apply induction on the num ber of vertioes on the boundary.
$C$ onsider an interior vertex, $v^{0}$ in $B$. If the star of $v^{0}$ in $B$ is the union of three triangles at $v^{0}$, then we can rem ove this vertex from $D$ by $m$ eans of a (3 $)^{*} 1$ ) move. Perform such $m$ oves until there are no interior vertices of valence 3. In this way we $m$ ay assum e that a vertex, $v^{\infty} 2 \mathbb{k}_{\mathrm{B}}(\mathrm{v})$ has valence larger than 3 . If the valence of $\mathrm{v}^{\infty}$ is greater than 3 , then there are a pair of triangles in $s t_{B}(v)$ sharing edge $v ; v^{\infty}$ upon which a P achner $m$ ove of type $(2)^{\star}$ 2) can be perform ed. Such a $m$ ove rem oves $v^{\infty}$ from the link of $v$. A fter such a $m$ ove, check for interior vertioes of valence 3 and rem ove them by type (3 $)^{*} 1$ )-m oves. In this way we can continue until the link of $v$ is an edge. IfD is a triangle, then the process w ill reduce the triangulation until there are no interior vertioes.

Now we m im ic the proof given in dimension 2, to dim ension 3. First, assum e that an interior vertex $v^{0}$ in $D^{3}$ has as its star the union of 4 tetrahedra. Then we may elm inate such an interior vertex by $m$ eans of a type (4 $)^{*} 1$ ) Pachner $m$ ove.
$C$ onsider the link, $\mathbb{k}_{\mathrm{B}}(\mathrm{v}$ ) of a vertex, v , on the boundary. If this link is a triangle, then we $m$ ay elim inate the vertex from the boundary, as in the 2 -dim ensional case. For the star of $v$ is a single tetrahedron that is ghed to the ball along a single face.

M ore generally, $s t_{\mathrm{s}}(\mathrm{v})$ is a union of triangles form ing a polygon, so sts ( v ) is the cone on the polygon $\mathbb{k}_{\mathrm{S}}(\mathrm{v})$ where v is the cone point. C onsider the disk properly em bedded in $B$ that is the link of $v$. This link, $\mathbb{k}_{\mathrm{B}}(\mathrm{v})$, is a triangulated disk. There is a sequence of 2 -dim ensional $P$ achner $m$ oves that change $\mathbb{k}_{\mathrm{B}}(\mathrm{v})$ to a triangulation of an $n$-gon, w ith no interior vertices. W e use these 2-dim ensional $m$ oves to determ ine 3-dim ensional $m$ oves perform ed in a neighborhood of $s t_{B}(v)$ as follow $s$.

Suppose that a (3 $)^{*} 1$ ) -m ove is used to simplify the disk that is the link of $v$. Then consider the vertex $v^{0}$ at which such a $m$ ove is perform ed. By our rst step, its star is not the union of 4 tetrahedra. Three tetrahedra intersect along the edge, $\mathrm{v} ; \mathrm{v}^{0}$, and a (3 $)^{\text {* }} 2$ ) m ove can be perform ed in the star of $v$ to rem ove the vertex $v^{0}$ from the link. A fter such a $m$ ove, then check for vertioes in the interior whose valence is 4 . Rem ove these by (4) $)^{*}$ )-m oves, until no such vertioes rem ain. Potentially, som e vertioes from the link of $v$ are rem oved, and the e ect of such a rem oval on the link is to perform a (3) 1)-m ove. In general a

(3 $)^{*}$ 1) m ove to the link corresponds to a $\left.(3)^{*} 2\right) \mathrm{m}$ ove to the star, or a (4 $\left.)^{*} 1\right) \mathrm{m}$ ove to a part of the star and a tetrahedron on the other side of the link.

If a $\left.(2)^{*} 2\right)$ m ove is used to sim plify $\mathbb{k}_{\mathrm{B}}(\mathrm{v})$, then there is either a (3) $)^{\star}$ ) m ove or a (2 ${ }^{*}$ 3) m ove to that ball which induces it. Specifcally, if an edge in $\mathbb{1}_{k_{B}}(v)$ has as its star the union of 3 tetrahedra, then $t w o$ of these are found in $s t_{B}(v)$ and the other one is on the other side of the link of $v$. In this case perform a (3 $)^{*} 2$ ) move to $B$. The link ofv changes by a (2 $)^{*} 2$ ) m ove. If the link of the edge to be changed is more than 3 tetrahedra, then perform a (2 $\left.)^{\star} 3\right) \mathrm{m}_{\mathrm{m}}$ ove to $\mathrm{st}_{\mathrm{B}}(\mathrm{v})$. In this way, a triangulation always results from these $m$ oves. A fter each such $m$ ove, one $m$ ust $g o$ and check for vertioes of valence 4 and rem ove them by (4 $)^{*} 1$ ) m oves.

Eventually, we can rem ove all interior vertices from $\mathbb{k}_{\mathrm{B}}(\mathrm{v})$ and we can further $m$ ake sure that the link of $v$ is in som e standard position. W e can rem ove $v$ from the boundary of $B$ by rem oving $v$ and the ( $n \quad 2$ )-tetrahedra in its star $w$ here $n$ is the valence of $v$ w ith repsect to the boundary. T he result follow s by induction. 2
7.3.2 Lem ma. The partition function does not depend on the choige of 3-face triangulations of .
$P$ roof. $F$ irst let us analyze the case when a face (012) is shared by four tetrahedra. Then we w ill discuss the general case. Figures 45 and 46 depict the case where a face (012) is shared by four tetrahedra (0123), (0124), (0125) and (0126).

Then the dual com plex has a rectangular 2-face (012) which is dual to the face (012). $T$ here are two triangulations of a rectangle, say $t_{1}$ and $t_{2}$, for (012) . (T hese are the triangulations that have no interior vertioes). T he 3-polytopes in that share (012) are duals (01) , (02) and (12) . Let $T_{1}$ and $T_{2}$ be 3-face triangulations of that restrict to $t_{1}$ and $t_{2}$

respectively and restrict to the sam e triangulation on all the other 2-faces of . W e show that the partition functions de ned from $T_{1}$ and $T_{2}$ give the sam e value.

Recall (Fig. G) that tw o pairs of faces of a tetrahedron give two triangulation of a rectangle. W e attach a tetrahedron in between (012) and (01) and change the triangulations on the face. M ore speci cally, attach a pair of adjacent faces of a tetrahedron onto the face (012) of (01) along the triangulation $T_{1}$ restricted to $t_{1}$. Perform the sam e attachm ent for (02) and (12) . Then we get a new triangulation $T_{1}^{0}$ of which restricts to $t_{2}$ on (012). T hus $\mathrm{T}_{1}^{0}$ and $\mathrm{T}_{2}$ have the sam e triangulation on the 2 -skeleton of by the assum ption that all the other faces have the same triangulation. Thus $T_{1}^{0}$ and $T_{2}$ are related by a nite sequence of $P$ achner $m$ oves xing the boundary triagulation by Lem $m$ a.3.1 whidh does not change the partition function by the pentagon identity and the orthogonality of the cocycle . H ence it rem ains to prove that $T_{1}$ and $T_{1}^{0}$ give the sam $e$ value of the partition fiunction.
If the dual face (012) is in general a polygon of $m$ ore than four faces (say $n$-gon), then triangulations consist of ( $n \quad 2$ ) triangles (by the condition of the de nition of 3-face triangulation). Such trianglations are related by only (2 $)^{*} 2$ )-m oves, which are realized by attaching a pair of faces of tetrahedra once at a tim e as above. Thus the above argum ent is applied to general cases by repeating the argum ent.

N ow we prove that $T_{1}$ and $T_{1}^{0}$ in the case (012) is a rectangle give the sam e value of the partition function. Figure 47 depicts the graphs for the triangulation. In Fig. 47 the perturbations of these graphs to trivalent graphs are also depicted. These perturbations correspond to ! (triangulations of a rectangle (012) in this case) as depicted in the bottom of F ig. 47. T hus the colors assigned near the face (012) w ith triangulations $\mathrm{T}_{1}$ and $\mathrm{T}_{1}^{0}$ are also assigned to edges of the perturbed graphs (the right pictures of arrows in the gure, $m$ arked ( $A$ ), ( $A^{\prime}$ ), ( $B$ ), and ( $\left.B^{\prime}\right)$ ).

These graphs are identi ed by the follow ing graphs in $F$ ig $\sqrt[37]{37}$ : (A) corresponds to top graph, ( $A^{\prime}$ ) to top left, ( $B$ ) to bottom right, ( $B^{\prime}$ ) to bottom. The weights assigned to each triangulation are thus $(g ; k ; \hat{p} ; \hat{r})(g ; k ; p r ; \hat{s})$ for $T_{1}$ and $(g ; k ; \hat{i} ; \hat{s})(g ; k ; \hat{p} ; \mathbb{s} ;)$ for $T_{1}^{0}$ (or vice versa), if the group elem ents assigned are as indicated in $F$ ig. 37.

N ow since $T_{1}^{0}$ is obtained from $T_{1}$ by attaching three tetrahedra, and they receive the
 depicted in F ig. 37 show s that they are equal. 2

## 8 H opf categories

8.1 O verview of $H$ opf categories. W e refer the reader to 13, 17, 35] for details about H opf categories. H ere we give a brief overview. A H opf category is a categori cation of
 becom es the tensor product betw een tw o ob jects, and there is a cotensor product de ned for ob jects.

First we recall 2 -categories from 29, 23, 6].

Explicitly, given any two ob jects A; B , there is a set of 1 m orphism s $1-\mathrm{M}$ or ( A ; B ) betw een them ; the ob ject A is called the souroe ob ject, B is the target. Such a 1 m orphism f is also denoted by $f: A!B$. G iven any two 1 m onphism $\mathrm{f} f, \mathrm{~g} 21 \mathrm{M}$ or $(\mathrm{A} ; \mathrm{B})$ there is a set of 2 m orphism s between them; f is the source arrow ( $1-\mathrm{m}$ orphism ), and $g$ is the target arrow ( 1 -m orphism ). $N$ ote that by com posing $m$ onphism $s$ we can represent $2-\mathrm{m}$ orphism $s$ by planar polygons. $M$ ore on 2 -categories can be found also in 11].

W e follow the de nitions in [ 3 F ] for the rest of this section.

These data satisfy 8 conditions that we om it here.
A 2-vector space is a $k$-linear additive category ( $C$; ) that adm its a subset $B \quad C$ such that (1) any ob ject X 2 B is smple, (2) for any $X 2 B$, dim $k(H$ om ( $X$; $X)$ ) $=1$, and (3) for any ob ject A $2 C$ there is a unique nite subset $B^{0} \quad B$ such that $A=x_{i} 2 B^{0} X_{i}^{n_{1}}$. The set $B$ is called a basis and a 2 vector space is nite if $B^{0}$ is nite.

The 2-category of nite dim ensional 2-vector spaces is denoted by 2 vect. The set of 1 m onphism s are k -linear functors, and 2 m onphism s are natural transform ations. This is a subcategory of the 2 -category $C_{k}$ of $s m$ all $k$-linear additive categories $w$ th the $k$-linear functors as 1 m onphism s.

A 2 -bialgebra or a bim onoidal category is a category C $2 \mathrm{C}_{\mathrm{k}}$ which has both monoidal and com oidal category structures and w ith additionaldata including a natural isom orphism
: ( 2 ) (12 T 21) (\} 2\})) \} satisfying certain conditions, where $T$ denotes perm utations, including gures depicted in 57,54 , and 56 . The faces in the gures are 2 m onphism s , and these cubes are relations am ong 2 m onphism s in the H opf category.
8.2 C ocycle conditions and H opf categories. The cocycles and their equations given in the previous sections to construct partition functions are given by C rane and Yetter [17] to construct exam ples of H opf categories. W e refer the reader to [17] and 35] for the detailed relation betw een cocycles and Hopf categories.

Here we give a sketch description. The H opf category constructed is a categori cation of the rinfeld quantum double ofa nite group. Thus rstwe recalld (G), the quantum double of a nite group $G$. It is an algebra generated by pairs of gropus and dual group elem ents, $\mathrm{f}(\mathrm{g} ; \hat{\mathrm{h}}) \mathrm{g}$. Themultiplication is de ned by $(\mathrm{g} \hat{\mathrm{A}}) \quad(\mathrm{k} \hat{\mathrm{s}})=\mathrm{k}^{1 \mathrm{hk}} ;^{\prime}(\mathrm{gk} ; \hat{})$, com ultiplication by

Thus we get these cocycles as transform ations (or 2 fm orphism s) in a H opf category. The cocycle conditions are obtained from the axiom s of the H opf categories.

8 .3 D iagram $s$ form orphism $s$. W e use the diagram $m$ atic convention depicted in F ig. 51. The top two gures represent tensor and cotensor functors ( 1 m onphism s). W e read the diagram from bottom to top, the segm ents correspond to categories, and trivalent vertices correspond to tensor (uncircled vertices) fiunctors and cotensor (circles ones) functors. Thus a tree diagram s represent com positions of such functors. The bottom three gures represent 2 m onphism s . For each of these, two com positions of functors are related by a double arrow representing a transform ation ( 2 m onphism) between 1 -m orphism $s$ that are com positions of tensor and cotensor functors.

For the categori cation of the quantum double, the ob jects are represented by pairs $f(g ; \hat{h}) g$, therefore the edges of the graphs are labled by these pairs. The situation is seen in F ig. 31. The fiunctors, then, are represented by trivalent vertices of the graphs. These are depicted in Figs. 32, 34. In Fig. 32, the functor corresponding to is depicted, and in Fig.34, the functor corresponding to (or ) is depicted. The diagram sfor is sim ilar to , except that the vertioes have sm all circles.

8.4 C oherence cubes and diagram s. Certain com positions of 2 m orphism s in H opf categories are required to satisfy relations, such as those called coherence cubes in 133]. There are relations between the coherence cubes in 13] and the diagram s (graphs) we have de ned in this paper. H ere we include $F$ igures 53, 55, 57 that indicate such relations. Figures 52, 54, 56 are the coherence cubes given in 13]. The labels in the parentheses are in fact ( co )tensor products and equalities are $m$ orphism $s$. There is another cube in [13] which is dual to $F$ igure 52 and is om $m$ ited.

In each of these gures, there is an initial vertex and a term inal vertex in the cube. These cubes appear in [13] in the de nition of $H$ opf categories. Each arrow from the initial vertex to the term inal vertex represents a $m$ orphism, which is represented by a diagram w ith trivalent vertioes.

Through each rectangular face, such a path is hom otoped to another such path. This hom otopy causes a change in diagram $s$. These changes in diagram $s$ are the scenes from our $m$ ovies, and in the case of the H opf category associated to a D rinfeld double, these scenes are group cocycles.

N ote that relations are represented by diagram s (graphs) and the relations take form s of equating two sequences (graph m ovies) of graphs. These equations are in fact identical that appeared in cocycle conditions ( $F$ igs. 36, 37) since these cocycles cam e from constructions of H opf categories in [16]. On the other hand these diagram s are related to the taco m ove via the dual graphs. Thus we see that the the form alism proposed in 13] can be used to construct invariants of 4 m anifolds via a state-sum provided the propsed set ofstates is nite.

## 9 C oncluding rem arks

In this paper we established diagram $m$ atic $m$ achinery for the study of $4-\mathrm{m}$ anifold invariants using triangulations and graphs. In particular, invariance under $P$ achner $m$ oves of $C$ raneFrenkel invariants for cocycles constructed by C rane-Y etter is proved by using graphs. This strongly suggests generalizations of the D ikgraaff itten invariant to 4 -m anifolds using $00-$ cycles de ned in [1\$]. W e have shown direct relations am ong algebraic structures (H opf categories), triangulations, and (graph) diagram s in dim ension 4, generalizing spin netw ork theory in 3-dim ensions.

Further study on higher dim ensional TQFTs and higher algebraic structures are anticipated. W e expect that our diagram $m$ atic $m$ achinery established in this paper serve as tools for further developm ents in the area.

O pen questions rem ain. Which nite groups contain cocycles that satisfy the sym $m$ etry conditions? C an other exam ples of H opfC ategories be constructed. W hat do the invariants from this construction $m$ easure? C an these invariants be related to invariants that arise from D onaldson Theory?
