# Integrable geodesic ow with positive topological entropy

### 1 Introduction and main results

The main result of this paper is the following theorem.

Theorem 1 There is a real-analytic Riemannian manifold M  $_{\rm A}$  dieomorphic to the quotient of T  $^2$  R  $^1$  with respect to the free Z-action generated by the map

$$(X;z)! (AX;z+1);$$

where  $X = (x;y) \ 2 \ T^2 = R^2 = Z^2$ ,  $z \ 2 \ R$ , and A is the Anosov automorphism of the 2-torus  $T^2$  de ned by the matrix

$$A = \begin{pmatrix} 2 & 1 \\ 1 & 1 \end{pmatrix}; (1)$$

such that

- i) the geodesic ow on M  $_{\rm A}$  is (Liouville) integrable by C  $^{\rm 1}$  rst integrals;
- ii) the geodesic ow on M  $_{\rm A}$  is not (Liouville) integrable by real-analytic rst integrals;
  - iii) the topological entropy of the geodesic ow Ft is positive;
- iv) the fundamental group  $_{1}$  (M  $_{\rm A}$  ) of the manifold M  $_{\rm A}$  has an exponential growth;
- v) the unit covector bundle SM  $_{\rm A}$  contains a submanifold N such that N is di eom orphic to the 2-torus T  $^2$  and the restriction of F  $_1$  onto N is the Anosov autom orphism given by matrix (1).

To explain the statement in detail we recall main de nitions and results on topological obstructions to integrability of geodesic  $\,$  ow  $\,$ s.

Let  $g_{jk}$  be a R iem annian m etric on an n-dim ensional m anifold M  $^n$ . It de nes the geodesic ow on the tangent bundle TM  $^n$  which is a Lagrangian system with the Lagrange function

and the Hamilton function

H (x;p) =

This Hamiltonian system is also called the geodesic ow of the metric.

The sym plectic form de nes the Poisson brackets on the space of sm ooth functions on T M  $^{\rm n}$  by the form ula

where  $! = h_{jk} dy^{j} \wedge dy^{k}$  locally.

It is said that a H am iltonian system on a 2n-dimensional symplectic manifold is (Liouville) integrable if there are no rst integrals  $I_1; :::; I_n$  of this system such that

- 1) these integrals are in involution:  $fI_{i}$ ;  $I_{k}g = 0$  for any j; k, 1 j; k n;
- 2) these integrals are functionally independent almost everywhere, i.e., on a dense open subset.

Since restrictions of the geodesic ow onto di erent non-zero level surfaces of its H am ilton function  $H = I_n$  are smoothly trajectory equivalent, we may replace this notion of integrability by the weaker condition that there are n 1 additional rst integrals  $I_1; :::; I_{(n-1)}$  which are in involution and functionally independent almost everywhere on the unit covector bundle SM  $^n = fH$  (x;p) = 1g  $^n$  T M  $^n$  [8].

If M  $^n$  is real-analytic together with the m etric and all  $\,$  rst integrals  $I_1$ ;:::; $I_n$ , then it is said that the geodesic  $\,$  ow is analytically integrable.

K ozlov established the  $\,$  rst topological obstruction to analytic integrability of geodesic  $\,$  ow  $\,$  s proving that the geodesic  $\,$  ow of a real-analytic metric on a two-dimensional closed oriented manifold M  $^2$  of genus g > 1 does not adm it an additional analytic  $\,$  rst integral [4] (see also [5] for general setup of nonintegrability problem ).

For higher-dim ensional manifolds, obstructions to integrability were found in  $[8,\,9]$  where it was proved that analytic integrability of the geodesic ow on a manifold M  $^n$  implies that

- 1) the fundam ental group  $_1$  (M  $^n$ ) of M  $^n$  is alm ost com m utative, i.e., contains a com m utative subgroup of nite index;
- 2) if the rst Betti number  $b_1 \, (M^n)$  equals k, then the real cohom ology ring H  $(M^n;R)$  contains a subring isom orphic to the real cohom ology ring of a k-dimensional torus and, in particular,  $b_1 \, (M^n)$  dim  $M^n = n$ .

In these results the analyticity condition m ay be replaced by stronger geom etric condition called geom etric simplicity and rejecting some tameness properties of the singular set where the integrals are functionally dependent. For instance, one may only assume that SM  $^{\rm n}$  is a disjoint union of a closed invariant set  $^{\rm n}$  which is nowhere dense and of nitely many open toroidal domains foliated by invariant tori.

Later P atemain proposed another approach to nding topological obstructions to integrability based on a vanishing of the topological entropy of the geodesic ow on SM  $^{\rm n}$ . If this quantity vanishes, then  $_1$  (M  $^{\rm n}$ ) has a subexponential growth [2] and, if in addition M  $^{\rm n}$  is a C  $^1$  sim ply-connected manifold, then Y is rationally-elliptic (this follows from results of G rom ov and Y om din) [6,7]. Integrability in plies vanishing of the topological entropy under some additional conditions which were

established in [6,7,10] and restrict not only the singular set but also the behaviour of the ow on this set.

Recently Butler has found new examples of  $C^1$  integrable geodesic ows of hom ogeneous metrics on nilm anifolds [1]. The simplest of them is a 3-m anifold M  $_{\rm B}$  obtained from a product  $T^2$  [0;1] by identifying the components of the boundary by a homeom orphism

where

$$B = \begin{pmatrix} 1 & 1 \\ 0 & 1 \end{pmatrix}$$

and X 2 T². The fundam ental group of the resulting manifold M  $_{\rm B}$  is not alm ost commutative,  $b_{\rm l}$  (M  $_{\rm B}$ ) = 2, and H (M  $_{\rm B}$ ; R) does not contain a subring isom orphic to H (T²; R). However,  $b_{\rm l}$  (M  $_{\rm B}$ ) < dim M  $_{\rm B}$ . This shows that some of the results of [8, 9] are not generalized for the C  $^{\rm l}$  case. Note that the topological entropy vanishes for Butler's examples.

The present paper is based on an observation that Butler's construction is generalized for constructing C  $^1$  integrable geodesic ows on all T  $^{\rm n}$ -bundles over S  $^1$ . In the case when the gluing automorphism C : T  $^{\rm n}$ ! T  $^{\rm n}$  is hyperbolic we obtain remarkable H am iltonian systems on a cotangent bundle to M  $_{\rm C}$ : they are C  $^1$  integrable but have positive topological entropy. This, in particular, shows that treating positivity of topological entropy as a criterion for chaos which is used sometimes is not correct.

We con ne only to one example of such a ow which we study in detail.

## 2 The metric on $M_A$ and its geodesic ow

Let

$$A : Z^2 ! Z^2$$

be an automorphism determined by matrix (1). It determines the following action on  ${\bf T}^2$ :

$$(x;y) \mod Z^2$$
!  $(2x + y;x + y) \mod Z^2$ :

We construct M  $_{\rm A}$  as follows. Take a product T  $^2$  [0;1] and identify the components of its boundary using the automorphism A:

$$(X;0)$$
  $(AX;1);$ 

where X = (x;y) 2 T<sup>2</sup>. We denote the resulted manifold by M<sub>A</sub>. Near every point p 2 M<sub>A</sub> we have local coordinates x;y and t, where z is a linear coordinate on  $S^1 = R = Z$ .

Take the following m etric on M A:

$$ds^2 = dz^2 + q_{11}(z)dx^2 + 2q_{12}(z)dxdy + q_{22}(z)dy^2$$

Indeed, this formula de nes a metric on an in nite cylinder  $C = T^2$  R which is invariant with respect to the Z-action generated by

$$(x;y;z) ! (2x + y;x + y;z + 1);$$
 (3)

and, therefore, it descends to a metric on the quotient space M  $_{\rm A}$  = C=Z .

Proposition 1 The geodesic ow of metric (2) on the in nite cylinder C admits three rst integrals which are functionally independent almost everywhere.

Proof of Proposition. The Ham iltonian function

$$F_3 = H = \frac{1}{2} p_z^2 + g^{11}(z)p_x^2 + 2g^{12}(z)p_xp_y + g^{22}(z)p_y^2$$

of this ow is, by the construction, a rst integral. Since H does not depend on x and y the quasimom enta  $F_1 = p_x$  and  $F_2 = p_y$  are also rst integrals. It is clear that the set of rst integrals  $I_1$ ;  $I_2$ , and  $I_3$  is functionally independent almost everywhere. This proves the proposition.

Since action (3) preserves the sym plectic form  $\,!\,$ , it induces the following action on T  $\,$ C:

This descends to a linear action on T  $\,\mathrm{M}_{\,\mathrm{A}}\,$  which preserves bers and takes the form

It is evident that the inde nite quadratic form

$$I_1 = p_x \frac{1 + \frac{p_{\overline{5}}}{5}}{2} p_y p_x \frac{1 + \frac{p_{\overline{5}}}{5}}{2} p_y = p_x^2 p_x p_y p_y^2$$

and the positively de nite quadratic form

$$I_3 = H = \frac{1}{2} p_z^2 + g^{11}(z)p_x^2 + 2g^{12}(z)p_xp_y + g^{22}(z)p_y^2$$

are invariants of this action. To construct the third invariant we notice that

$$\frac{\log p_x \quad \frac{1+\frac{p-5}{5}}{2}p_y}{\log p_x}$$

is not invariant but the action adds 1 to this quantity when it is correctly de ned. Therefore, the following function

$$I_2 = f(I_1) \sin \frac{\log p_x - \frac{1+p_{\overline{5}}}{2}p_y}{\log}$$
;

w here

$$f(u) = \exp \frac{1}{u^2}$$
;

is everywhere de ned and invariant with respect to action (4).

P roposition 2 The functions  $I_1$ ;  $I_2$ , and  $I_3$  are  $C^1$  rst integrals of the geodesic ow on M A which are functionally independent almost everywhere. Therefore, the geodesic ow on M A is (Liouville) integrable by  $C^1$  functions.

Proof of Proposition. The functions  $I_1$ ;  $I_2$ , and  $I_3$  on T C are invariants of action (4) and, therefore, descend to functions on T M  $_A$ . We may consider  $I_1$  and  $I_2$  as replacing  $F_1$  and  $F_2$ : they are pairwise involutive and independent on spatial variables x;y;z. Moreover they do not depend on  $p_z$  and, therefore, they are in involution with  $I_3$  = H which, in particular, means that they are rst integrals of the geodesic ow. It remains to notice that, by their construction, they are  $C^1$ . This nishes the proof of Proposition.

P roposition 3 Let N be a subset of the unit covector bundle SM  $_{\rm A}$  formed by the points with

$$z = 0$$
;  $p_x = p_v = 0$ ;  $p_z = 1$ :

Then it is dieomorphic to  $T^2$  and the translation

along the trajectories of the geodesic ow for t = 1 m aps N into itself and this m ap is the Anosov automorphism given by matrix (1).

Proof of Proposition. The geodesic ow on M  $_{\rm A}$  is covered by the geodesic ow on C for which  $p_x$  and  $p_y$  are rst integrals. Therefore, on C the translation of the preim age of N under projection is as follows:

$$F_t(x;y;z;p_x;p_y;p_z) = F_t(x;y;0;0;0;1) = (x;y;t;0;0;1)$$
:

Recalling the construction of M  $_{\rm A}$  proves the proposition.

Note that Propositions 2 and 3 prove statements i) and v) of Theorem 1, respectively.

# 3 The fundam ental group $_1$ (M $_A$ ) and the topological entropy of the geodesic ow on M $_A$

The m anifold M  $_{\rm A}\,$  is covered by R  $^3$  on which acts  $_1$  (M  $_{\rm A}$  ). This group is generated by

a: 
$$(x;y;z)$$
!  $(x + 1;y;z)$ ; b:  $(x;y;z)$ !  $(x;y + 1;z)$ ;  
c:  $(x;y;z)$ !  $(2x + y;x + y;z + 1)$ :

The relations between these generators are

$$[a;b] = 1;$$
  $[c;a] = ab;$   $[c;b] = a:$ 

Proposition 4 (see, for instance, [3])  $_1$  (M  $_A$ ) has an exponential growth.

This follows from the hyperbolicity of A or m ay be proved directly: the words ca" $_1$  ca" $_2$ :::ca" $_k$  are di erent for " $_j$  = 0;1 and, therefore, (2k)  $2^k$ , where is the growth function of  $_1$  (M  $_A$ ) with respect to generators a;b, and c.

C orollary 1 The geodesic ow on M  $_{\rm A}$  is not (Liouville) integrable by real-analytic rst integrals.

It follows from the results of [8] (also exposed in Section 1) that if this ow is analytically integrable, then  $_1$  (M  $_{\rm A}$ ) is almost commutative and, therefore, has a polynom ial growth. This contradiction establishes the corollary.

C orollary 2 The topological entropy of the geodesic ow on M  $_{\rm A}$  is positive.

Indeed, it was proved by D inaburg, that if the fundam ental group of a manifold M $^n$  has an exponential growth, then the topological entropy of the geodesic ow of any R iem annian metric on M $^n$  is positive [2].

The latter corollary also follows from Proposition 3: it is known that the topological entropy equals the suprem um of the measure entropies taken over all ergodic invariant Borelmeasures. Hence, we may take a singular measure concentrated on N SM  $_{\rm A}$  which has the form

$$d = dx \wedge dy$$
:

It is well known that the measure entropy of the Anosov automorphism A:N!N is positive (this follows, for instance, from nonvanishing of the Lyapunov exponents for any point of N).

Note that Proposition 4 and Corollaries 1 and 2 establish statements iv), ii), and iii) of Theorem 1, respectively.
