# From the B irkho -G ustavson norm alization to the $B$ ertrand $-D$ arboux integrability condition

#### Abstract

The Bertrand-D anboux integrability condition for a certain class of perturbed harm onic oscillators is studied from the view point of the B irkho G ustavson (BG)-norm alization: In solving an inverse problem of the BGnorm alization on com puter algebra, it is shown that if the perturbed harm onic oscillators w ith a hom ogeneous cubic-polynom ialpotential and with a hom ogeneous quartic-polynom ial potential share the sam e BG-norm al form up to degree-4, then both oscillators satisfy the Bertrand $-D$ arboux integrability condition.

## 1. Introduction

The Bertrand-D arboux theorem is well known to provide a necessary and su cient condition for tw o-degree-of-freedom natural $H$ am iltonian system $s$ associated w ith the Euclidean $m$ etric to $a d m$ it an integral of $m$ otion quadratic in $m$ om enta ( $D$ arboux 1901). M oreover, that condition is necessary and su cient for the naturalH am iltonian system $s$ to be separable in either C artesian, polar, parabolic or elliptic coordinates (Marshall and W ojciechowski 1988). This theorem thereby provide a su cient condition for the com plete integrability of the natural H am iltonian system s , which will be referred to as the Bertrand-D arboux integrability condition (BD IC) in the present paper. The BD IC has been studied repeatedly from various view points; the separation of variables (Marshall and W ojciechow ski1988, G rosche et al 1995 in the path-integral form ulation), the com plete integrability (P erelom ov 1990), and so-called the direct $m$ ethod (H ietarinta 1987), for exam ple (see also W hittaker 1944 as an older reference and the references in the above-cited literatures).

The aim of the present paper is to show that the BD IC is obtained as an outcom e of a study on the B irkho -G ustavson (BG)-norm alization (G ustavson 1966, M oser 1968) for the $H$ am iltonians of the perturbed harm onic oscillators $w$ ith hom ogeneous cubic-polynom ial potentials (PHOCP's). In solving an inverse problem of the BGnorm alization for a given P H O CP Ham iltonian with a help of com puter algebra, the fam ily of the perturbed ham onic oscillators with hom ogeneous quartic-polynom ial potentials ( PHOQP 's) is identi ed which share the sam eBG-norm alform up to degree4 w th the given PHOCP. Consequently, a new deep relation is found between the BDIC for the PHOCP's and that for the PHOQP's: It is shown that if a PHOCP and a PHOQP share the sameBG-norm al form up to degree-4 then both oscillators are integrable in the sense that they satisfy the BD IC. It is worth noting that the present w ork w as inspired in the debugging process of the com puter-program m enam ed ANFER' for the BG -norm alization ( $U$ wano et al1999, Uwano 2000), where the oneparam eter $H$ enon $H$ eiles system $w$ as taken as an exam ple.

Before the outline of the present paper, the inverse problem of the BGnorm alization is explained very brie $y$. The BG -nom alization has been a powerfiul $m$ ethod for nonlinear $H$ am iltonian system $s$. For exam ple, when a two-degree-offreedom Ham iltonian system with a 1:1-resonant equilibrium point is given, the BG-norm alization of its Ham iltonian around the equilibrium point provides an approxim ate' H am iltonian system : T he truncation of the norm alized H am iltonian up to a nite degree is associated w ith the approxim ate H am iltonian system, which provide a good account of the surface of section with su ciently small energies (K um m er 1976, Cushm an 1982). Such a good approxim ation im plies that nding the class of Ham iltonian system s adm itting the sam e BG -norm alization up to a nitedegree am ounts to nding a class of $H$ am iltonian system $s$ which adm it the surface of section sim ilar to each other. The follow ing question has been hence posed by the author as an inverse problem of the BG -norm alization (C hekanov et al 1998, 2000, Uw wo et al1999): W hat kind of polynom ialH am iltonians can be brought into a given polynom ialH am iltonian in BG -norm al form ? Since elem entary algebraic operations, di erentiation, and integration of polynom ials have to be repeated $m$ any tim es to solve the inverse problem, com puter algebra is w orth applying to solve the inverse problem ; see Uwano et al (1999) and Uwano (2000) for the programme nam ed ANFER' and C hekanov et al $(1998,2000)$ for $G$ ITA ${ }^{1}$ '.

The organization of this paper is outlined as follows. Section 2 sets up the
ordinary and the inverse problem s of the BG -nom alization for H am iltonians, which w ill be often referred to as the ordinary problem for H am iltonians' and the inverse problem for BG-norm al form H am iltonians', respectively, henceforth. A though the setting-up of the ordinary problem seem $s$ to be $m$ erely a review of M oser (1968), it is of great use to de ne the ordinary problem in an $m$ athem atically-sound form : Through the review, the class of canonical transform ation to be utilized in the BGnorm alization can be speci ed explicitly. In section 3, the one-param eter $H$ enon $H$ eiles H am iltonian is taken as an exam ple to ilhustrate how the ordinary and the inverse problem are proceeded. From the solution of the inverse problem, it follows that if the one-param eter $H$ enon $H$ eiles system and the perturbed harm onic oscillator $w$ ith a hom ogeneous-quartic polynom ial potential ( PHOQP ) share the sam e BG-norm al form up to degree-4 then both dynam ical system s satisfy the BD IC, so that they are integrable. In section 4, the discussion in section 3 m ade for the one-param eter $H$ enon $H$ eiles $H$ am iltonian is extended to the $H$ am iltonians of the perturbed harm on ic oscillators with hom ogeneous-cubic polynom ial potentials (P H OCP's): The ordinary and the inverse problems of the BG-nom alization for the PHOCP Ham iltonians are dealt w th there. In the ordinary problem, the Ham iltonians for PHOCP's are norm alized up to degree-4. For the B G -norm alform thus obtained, the inverse problem is solved up to degree-4. B oth of the problem s are solved w ith (a prototype of) the symbolic-com puting program ANFER working on Reduce 3.6 (Uwano 2000). It is shown that if aPHOCP and aPHOQP share the sameBG-norm alform up to degree4 then both oscillators are integrable in the sense that they satisfy the BD IC . Section 5 is for concluding rem arks including a con jecture on a further extension.
2. Setting-up the ordinary and the inverse problem s of

B G -norm alization
In this section, the ordinary and the inverse problem s of the BG norm alization are review ed for the tw o-degree-offreedom H am iltonians (U wano et al1999).

### 2.1. The ordinary problem

W e start w ith de ning the ordinary problem along $w$ ith a review of M oser (1968). Let $R^{2} \quad R^{2}$ be the phase space w th the canonical coordinates ( $q ; p$ ) ( $q ; p 2 R^{2}$ ), and $K(q ; p)$ be the $H$ am iltonian expressed in power-series form,

where each $K_{k}(q ; p)(k=3 ; 4 ; \quad$ ) is a hom ogeneous polynom ial of degree $k$ in ( $q ; p$ ).
Rem ark 1. The convergent radius of the pow er series (1,1)) $m$ ay vanish. This happens to any K that is not analytic but di erentiable around the origin, for exam ple. In such a case, the power series $\frac{\overline{1})}{(1)}$ is considered only in a form al sense. W e w ill, how ever, often elim inate the word 'form al' from such form alpow er series henceforth.

W e norm alize the $H$ am iltonian $K$ through the local canonical transform ation of the follow ing form. Let ( ; ) be another canonical coordinates working around the origin of $R^{2} R^{2}$. W e consider the canonical transform ation of ( $q ; p$ ) to (; ) associated
w ith a generating function (G oldstein 1950) in pow er-series form,

where each $W_{k}$ is a hom ogeneous polynom ial of degree $k$ in ( $q$; ) ( $k=3 ; 4$; ). The W ( $q$; ) is said to be of the second-type since W ( $q ;$ ) is a function of the bld' position variables $q$ and the hew' $m$ om entum ones (see Goldstein 1950). The canonical transform ation associated with $W$ ( $q$; ) is given by the relation

through the transform ation $(\overline{3} \overline{3})$. The BG norm alization for $K$ is accom plished by choosing the generating function $W(q ;)$ in (ALi) to put $G(;)$ in BG norm al form :

Since we willdealw th only the B G -norm alization up to degree-4 in the present paper, we will not get the expression of $k$ for $k>4$ into $m$ ore detail (see $U w$ ano et al1999, if necessary).

To solve equation $\overline{\underline{T}}_{1}$ ), the direct-sum decom position induced by $\mathrm{D}_{\mathrm{q}}$; of the spaces of hom ogeneous polynom ials is of great use. Let $V_{k}(q ;)$ denote the vector space of hom ogeneous polynom ials of degreek in ( $q$; ) w ith real-valued coe cients $(k=0 ; 1 ; \quad)$. Since the di erential operatorf; $D$ acts linearly on each $V_{k}(q ;)$, the action of $\mathrm{q}_{\mathrm{q}}$ naturally induces the direct-sum decom position,

Rem ark 3. The convergent radius of the $B G$ norm al form $G$ in power-series ( $\bar{p}_{1}^{\prime}$ ) vanishes in general (see M oser 1968). In such a case, $G$ is considered only in a form al sense. H ow ever, like in Rem ark '11] for $K$, we will often elim inate lorm al from such form alpow er series henœforth.

### 2.2. The inverse problem

To de ne the inverse problem of the BG-norm alization appropriately, we review the key equation (4) of the ordinary problem from a viewpoint of canonical transform ations. Leet us regard the power series $W$ ( $q$; ) in ( $\overline{4} 1$ ) as a third-type generating function, a generating function of the hew' position variables $q$ and the bld' m om entum ones (G oldstein 1950), which provides the inverse canonical transform ation,

Such a sim ilarity w illbe utilized e ectively in future in writing the program ANFER for the ordinary and the inverse problem sin a uni ed form.

Like in the ordinary problem, we solve (2-4) for $H_{k}$ and $S_{k}$ by using the directsum decom position (10) of $\mathrm{V}_{\mathrm{k}}(\mathrm{q} ;)$, the vector spaces of hom ogeneous polynom ials of degreek $(k=3 ; 4 ; \quad$ ). Let us decom pose ind $k$ to be

### 2.3. The degree-2 ordinary and inverse problem s

In the preceding subsections, we have de ned the ordinary and the inverse problem s of BG-nom alization, and then nd their solutions in pow er-series. From a practicalpoint of view, how ever, we usually dealw ith the BG norm alform s not in pow er-series but in polynom ial. Indeed, as mentioned in section 1, when we utilize the BG -norm alization to provide an approxim ate system for a given system, we truncate the norm alized Ham iltonian up to a nite degree. Hence it is natural to think of a ' nite-degree version' ofboth the ordinary and the inverse problems (U wano et al1999).

Rem ark 5. The reason why we think of only the even-(2 -)degree case is that the BGnom al form of any 1:1 resonant H am iltonian consists of even-degree term s only (see Rem ark $\overline{2} 1$ and Lem ma $\left.\underline{2}_{2}^{2} \overline{2}\right)$.

In closing this section, we w ish to $m$ ention of the way to solve the (degree-2 ) ordinary and the inverse problem s on com puter algebra. A though the discussion throughout this section is $m$ athem atically com plete, it is not easy to calculate even on com puter algebra (1-1 1 ) and $[2,30,31$ ) as they present because we are faced $w$ th a highly combinatorial di culty in calculating $k$ and $k$ : To calculate $k$ for example,

 rises in a combinatorial $m$ anner as ' increases, where the symbol indicates the binom ial coe cient. These facts $w i l l$ cause a com binatorial increase of the $m$ em orysize on com puter required for calculation. To get rid of such a di culty, we break the transform ations, (4, (1) and (22') into a recursion of certain canonical transform ations of sim pler form, which will be presented in A ppendix for the degree-4 case.

Under (54a), the PHOQPHam iltonian ${ }^{(4)}$ sharing its

Theorem 4.2. If the perturbed harm onic oscillators with a hom ogeneous-cubic polynom ialpotential and w ith a hom ogeneous-quartic polynom ialpotential share the sam e BG norm alform up to degree-4, then both oscillators are integrable in the sense that they satisfy the Bertrand-D arboux integrability condition.

## 5. C oncluding $R$ em arks

As is shown in the previous section, the new deep relation between the BD IC for PHOCP's and that for PHOQP's are found (see theorem sin and in in . The results obtained in the present paper are expected to provide several interesting sub jects, which are listed below.
(1) A further generalization of theorem s and 4 con jecture is posed as follow S , which is investigated now.

Conjecture 5.1. Let $\mathrm{F}^{(r)}(\mathrm{q} ; \mathrm{p})$ and $\mathrm{F}^{(2 \mathrm{r} 2)}(\mathrm{q} ; \mathrm{p}) \quad(\mathrm{r}=3 ; 4$; ) denote the perturbed harm onic oscillator $H$ am iltonians of the form

If the perturbed harm onic oscillators w ith the H am iltonian $\mathrm{F}^{(r)}$ and w ith $\mathrm{F}^{\text {(2r 2) }}$ share a BGNF up to degree-(2r 2 2) then both oscillators are integrable in the sense that they satisfy the Bertrand -D arboux integrability condition.
(2) As is pointed out after theorem 13.1 , the H am iltonians, $\mathrm{K}_{1=3}$ and Q have a signi cant feature other than integrability; they are separable in $q_{1} q_{2}$. Such a separability can be found also in $F{ }^{(3)} w$ th (54a) and $Q$, the generalization of $K_{1=3}$ and $Q$, respectively. In fact, we can nd, from theorem i4. 1 , the PHOCP's w ith

which is also known to be separable in of $q_{1}$ (Perelom ov 1990). It is worth noting that all the PHOQP's with (7) cover a quarter of the class of all the PHOQPHam iltonians separable in $q_{1} \quad G_{2}$ in view of $a^{2} ; b^{2} \quad 0$. Thus we reach through theorem 1 $w$ th (72) and PHOQP'S w th (73) separable in $q_{1} q_{2}$. Since $F^{(3)}$ with (54a) and $Q$ are thought to include severalclasses of $H$ am iltonians separable in several coordinate system $s$ other than $q_{1} \quad G_{2}$, the separability $w$ ill be worth studying extensively from the BG-norm alization view point in future.
(3) The perturbed oscillators referred to in theorem 5 to provide good exam ples of the quantum bifurcation in the BG-nom alized Ham iltonian system s (Uwano 1994, 1995, 1998, 1999): Since the perturbed oscillators referred to in theorem si4 and are integrable, their quantum spectra are expected to be obtained exactly. Then we will be able to think of whether or not the quantum bifurcation in the BG nom alized $H$ am iltonian system for those oscillators approxim ates the bifircation in these oscillators in a good extent.
(4) In section 1, tw o approaches to the BD IC (or BD -theorem) have been m entioned. As another approach to the BD IC, the work of Yam aguchi and $N$ am bu (1998) is worth pointing out, in which the BDIC for the PHOCP's and the PHOQP's (see Lem m a (3, ${ }^{(3)}$ ) cam $e$ out from the renorm alization of H am iltonian equations. It will be an interesting problem in future to study a relation between the BGnorm alization and the renorm alization.
 real-valued param eters. W em ay hence expect to obtain other integrable system s , so-called the electrom agnetic type (H ietarinta 1987), for exam ple.

On closing this section, we wish to $m$ ention of the role of com puter algebra in the present paper: W ithout com puter algebra, it would have been very di cult to nd theorem sin $1,11,4,14$ and 142.

W hat is characteristic of the algorithm above is that the procedure of solving (24) w ith $k=4$ is divided into a pair ofsteps, Step-I and Step-II (extending to the degree2 case, we have 22 steps). A though it is not so signi cant in the inverse problem of low er-degree (like degree-4), such a division will contribute a lot to the reduction of the $m$ em ory-size required through com putation.
