Nonintegrability and Chaos in the Anisotropic Manev Problem

A bstract

The anisotropic M anev problem, which lies at the intersection of classical, quantum, and relativity physics, describes the motion of two point masses in an anisotropic space under the in uence of a Newtonian force-law with a relativistic correction term. Using an extension of the Poincare-Melnikov method, we rst prove that for weak anisotropy, chaos shows up on the zero-energy manifold. Then we put into the evidence a class of isolated periodic orbits and show that the system is nonintegrable. Finally, using the geodesic deviation approach, we prove the existence of a large non-chaotic set of uniformly bounded and collisionless solutions.

I. Introduction

The M anev problem studies the dynam ics of two point m asses in a at space for an attraction law given by a potential of the form $\frac{A}{r} + \frac{B}{r^2}$, where r is the distance between particles and A; B > 0 are constants. The correction term to the Newtonian potential provides a classical approximation to general relativity [1], [2]. The anisotropic M anev problem, proposed by the rst author in the m id 1990s [3], replaces the at space with an anisotropic one.

The main reason for considering this question was that of seeking similarities between classical mechanics, quantum theory, and general relativity. Its study was inspired by the anisotropic Kepler problem introduced by Gutzwiller in the early 1970s [4], [5]. Gutzwiller aimed to not connections between classical and quantum mechanics. His interest in the anisotropic Kepler problem was aroused by an old quantum mechanical question related to a paper of Einstein [6].

Even though for a special class of (integrable) systems the Born-Sommer-field-Einstein conditions [6] seemed appropriate for describing a Coulomb limit of quantum theory, it was unclear how to not a classical approximation for ergodic systems. Two qualities made the anisotropic Kepler problem suitable for addressing this issue: its chaotic character and its suitability to model various physical phenomena, as for example those encountered in certain semiconductors [4]. Using a classical evaluation of the quantum Green's formula, Gutzwiller [7] found an approximate spectrum, in good agreement with previous quantum calculations. All these properties of the anisotropic Kepler problem raised hopes for the study of the Manevanalogue, which also brought general relativity into the game.

Som e of the qualitative features of the anisotropic M anev problem problem have already been studied. In a previous paper we proved the existence of an open, connected invariant manifold of uniform ly bounded, collisionless orbits that lie within the negative-energy manifold [8]. In [3] it was shown that the di erential equations describing the anisotropic M anev problem exhibit properties characteristic to all three aforem entioned branches of

physics. That paper also brought arguments favoring the nonintegrability of the system by putting into the evidence a network of heteroclinic orbits within the zero-energy manifold. Up to now, however, the existence of chaos and the nonintegrability of the system have not been rigorously proved.

The rst result of this paper shows the presence of chaos for a small set of solutions within the zero-energy manifold (see Section III). We will base our proof on an extension of the Poincare-Melnikov method developed in an earlier paper [9]. This method was used there to show the presence of chaos in several problems, including the restricted circular 3-body problem and the Gylden problem. The latter had been earlier identified as a degenerate case for applying the Poincare-Melnikov method [10]. In the 3-body problem the perturbation function, W = W(r;;t), where (r;) are the polar coordinates, appeared in its most general form. In the Gylden problem this function was isotropic, W = W(r;t). From the methodological point of view, we will now complete the applicative picture by o ering a time-independent but an isotropic perturbation function of the form W = W(r;), which is specient to the anisotropic Meneral problem (see Section II).

It is interesting to rem ark that di erent perturbations break up di erent sym m etries, which a ect the M elnikov integrals. In the general case both the hom ogeneity of time and the rotational sym m etry are destroyed. This leaves us with two independent M elnikov conditions. In the G ylden problem the rotational sym m etry is preserved (the angular momentum is constant), which leads us to one M elnikov condition. In the present case only the time hom ogeneity is preserved (through the conservation of the H am iltonian), so the only object of study is the other M elnikov condition (see Section III).

Our second result proves that the anisotropic M anev problem has no other analytic integrals beyond the H am iltonian function. To show this, we use a method designed by Poincare [11], [12], which we present in Section IV. The idea is to prove the existence of at least one isolated periodic orbit, which obstructs the occurrence of other analytic integrals. To apply Poincare's method we need to write the perturbation as a Fourier series. This leads to some technical diculties, which we overcome in Section V. In Section VI we prove the existence of many isolated periodic orbits in the hypothesis of weak anisotropy. We then show that this implies nonintegrability. The existence of periodic orbits, however, is an interesting result in itself, which raises hopes for applying Gutzwiller's formula to this problem in the context of semiclassical studies of the atom.

In the last part of the paper we are concerned with the qualitative behavior of collisionless orbits for which the two particles stay close to each other. In Section V II we present the geodesic deviation method [13], which provides a criterion for excluding the presence of chaos. The idea is to transform the equations ofmotion into some equivalent ones. The new equations put the solutions of the given system in a one-to-one correspondence with the geodesics of a certain Riemannian manifold whose metric is determined by the initial equations ofmotion. Measuring the deviation of the geodesics, we can draw conclusions about the behavior of the initial solutions. If the geodesics diverge, chaos may appear; if they converge, chaos is ruled out. In Section VIII we show that there exists a positive-measure invariant manifold of orbits that fail to encounter collisions but for which the particles stay close to each other. Using the geodesic deviation method we then prove that the corresponding geodesics converge, thus showing that the orbits of this manifold are not chaotic.

II. Equations of motion

The (planar) anisotropic M anev problem is described by the H am iltonian

where b> 0 and > 1 are constants, $q=(q_1;q_2)$ is the position of one body with respect to the other considered xed at the origin of the coordinate system, and $p=(p_1;p_2)=q$ is the momentum of the moving particle. The constant measures the strength of the anisotropy; the larger, the higher the dierence between the weakest and the strongest directions of attraction. For =1 we recover the classical (isotropic) M anev problem of which we have a complete qualitative understanding [14], [1]. Therefore, if is only slightly larger than 1, we are dealing with a weakly anisotropic case. Unlike in the isotropic problem, the angular momentum K (t) = p(t) - q(t) of the anisotropic case is not a rst integral of the system. This is because the rotational invariance of the H am iltonian breaks for > 1. Therefore we expect to encounter richer dynam ics in the anisotropic case.

In the rst part of this paper we will be interested in aspects related to weak anisotropy, i.e., in values of > 1 that are close to 1. To put into

the evidence the perturbative character of the anisotropy with respect to the isotropic problem, we introduce the notations = 1 and $r = q_1^2 + q_2^2$. For > 1 close to 1, the quantity > 0 is small, so the H am iltonian (1) can be viewed as describing a perturbation of the M anev problem by writing

As in [10], we now consider the parabolic solutions of the unperturbed problem (de ned by the H am iltonian H $_0$) that lie on the zero-energy manifold. These orbits, which play the role of hom oclinic solutions corresponding to the critical point at in nity (r = 1; r = 0), satisfy the equations

where $k \in 0$ is the constant angular momentum of the unperturbed problem; the negative (positive) sign corresponds to t < 0 (t > 0). From (3) we get that

be the expressions of r and $\,$ with respect to t, obtained by inverting equations (4) and assuming that R (0) = $r_{m \text{ in}}$ = k^2 =2 and (0) = . We will not need their expressions; as in [9], we only retain the information that R is even and that . is odd.

III. The M elnikov integral

We now consider the problem de ned by the Hamiltonian H given in (2). We will call homoclinic manifold the set of solutions of the unperturbed system that are doubly asymptotic to the point r=1; $\underline{r}=0$. For $k \in 0$, the two-dimensional homoclinic manifold is described by r=R (t t₀) and $\#=(t-t_0)+0$, with arbitrary constants t₀ and $\#=(t-t_0)+0$, with arbitrary constants t₀ and $\#=(t-t_0)+0$.

It is interesting to remark that in this problem we are dealing with negatively and positively asymptotic sets to the critical point r=1; r=0 and that this point would correspond to the \critical point at in nity," obtained with the help of M of ehee's transform ation [15]

But instead of using M of ehee's technique, we will apply here the method introduced in [9]. It was shown there that undernatural assumptions imposed on the perturbation function W (r;), one can guarantee the existence of smooth solutions approaching the point r=1; $\underline{r}=0$ for t! 1. It was also proved that the Poincare map leads to in nitely many intersections of the stable and unstable manifold for the corresponding xed point.

In our case the perturbation arising from a weak anisotropy vanishes as r! 1. This happens because W (r;) 1=r, which is exactly condition (18) in [9]. So we can write the Melnikov condition as in [9], with the only amendment of dropping the time dependence. Therefore the two Melnikov integrals become

Since W vanishes as t! 1, the rst Melnikov condition takes the form

M $_1$ is identically zero since the perturbation function W $_1$ is independent of time. This simplies our discussion because, unlike in the general case, we only need to $_1$ nd the zeroes of the integral in (8).

It is signi cant to rem ark, and easy to check, that the previous conditions can also be written in terms of the rst integrals of the unperturbed problem as

Notice that M $_1$ ($_0$) is identically zero. This resembles a results obtained for the G ylden problem [9], [10] and is related to the sym metries of the problem. In the G ylden problem the perturbation is independent of the angle—but depends on time. This means that the perturbation alters the homogeneity of time, so the Hamiltonian is not an integral of motion anymore, but it leaves the rotational invariance intact; thus the angular momentum is still conserved. Therefore there is only one condition here, given by relation (9). On the other hand in the anisotropic Manev problem the anisotropy of the space alters only the rotational symmetry but not the homogeneity of time. This also leads to only one condition, given by relation (8).

For the anisotropic M anev problem the M elnikov condition M $_2$ takes the form

Since we found simple zeroes of the Melnikov function, the following result holds.

Theorem 1 In some invariant set contained in the zero-energy manifold, the weakly anisotropic Manev problem exhibits chaotic dynamics.

This type of chaotic behavior, which usually takes place for a small set of orbits, is induced by the in nitely many intersections of the stable and unstable manifolds for the Poincare map associated to the critical point at in nity. Let us notice that the Poincare-Birkho -Smale theorem [16] does not directly apply to this situation, which is degenerate. However, the existence of Smale horseshoes and of positive topological entropy is not restricted to hyperbolic equilibria. This phenomenon is also encountered in nonhyperbolic cases, as for example those arising when dealing with area-preserving perturbations [17]. Thus, Theorem 1 adds to the class of results describing chaotic dynamics near degenerate equilibria.

IV . Poincare's m ethod

In this section we will present a classical result of Poincare [11], [12] in connection with the nonexistence of additional analytic integrals in H am iltonian system s. B ased on the investigation of long periodic solutions, this criterion is suitable for proving the nonintegrability of the anisotropic M anev problem for weak anisotropy, as we will see in Section V.

First we need to write the unperturbed system, i.e. the (isotropic) M anev problem, in terms of action-angle variables [18]. The action variables are given by

Recall that the eigenvalues of the monodromy operator of a T-periodic solution are called characteristic multipliers and that the numbers dened by $= \exp(T)$ are called characteristic exponents [16], [18]. We would like to show the nonexistence of other analytic integrals, independent of the Hamiltonian H $_0$. Our main theoretical tool in proving the nonintegrability of the perturbed system is the following result, proved in [11].

Theorem 2 Suppose that the two degree of freedom Hamiltonian system with Hamiltonian function H has two rst integrals H and F that are independent along a periodic solution. Then four characteristic exponents vanish.

One exponent vanishes because the system is autonomus. The second vanishes due to the presence of the rst integral H. If the remaining exponents are dierent from zero, the periodic solution is called nondegenerate. It is well known that nondegenerate periodic orbits are isolated [12].

To establish the existence of a large number of isolated periodic orbits, suppose that for $I=I^0$ and $K=K^0$, the frequencies $!_I$ and $!_K$ of the unperturbed problem are commensurable and that $!_I \in 0$. Then the perturbing function W $(I;K;!_It;!_Kt+)$, de ned by W given in (2) and then transformed with the help of the action-angle variables, is periodic in t and has period T. Consider its average

Then the following theorem, also due to Poincare [11], establishes the existence of isolated periodic orbits.

Theorem 3 Assume that the following conditions are satised:

- (1) The Hamiltonian is nondegenerate at the point $I = I^0$; $K = K^0$,

V. Fourier series of the perturbation

In order to apply these results to our perturbed problem, we rst need to write the perturbation function as a Fourier series. For this let us rst notice that r can be expressed in parametric form with respect to time. Following the same procedure used in [19] for the Kepler problem, we can write

V I. Periodic orbits and nonintegrability

We can now apply the method of the previous section to the anisotropic M anev problem. As we are going to show, all the assumptions of Theorem 3 are satised, so for weak anisotropy the existence of isolated periodic orbits follows. This leads to the following result.

This means that for =0; $\frac{3}{2}$; $\frac{3}{2}$, the second condition of Theorem 3 is satisfied if G is not identically zero.

We will now show that, in general, G cannot be identically zero. Indeed, notice rst that G depends on A and is analytic in A. But G cannot be identically zero beyond a discrete set of values of A unless the Bessel function is itself identically zero. However, the Bessel function has only a discrete set of zeroes. Therefore, generically, G cannot be identically zero, so the existence of isolated periodic orbits follows. This completes the proof.

For the anisotropic M anev problem, we are now able to prove the nonexistence of rst integrals that are independent of H and analytic in the parameter. In more formal terms, the following result holds.

Theorem 6 For small values of , the weakly anisotropic M anev problem does not admit a formal rst integral F independent of H that can be written as a power series $^{P}_{s}$ $_{0}$ F $_{s}$ (I;K;;) s whose coe cients F $_{s}$ are analytic functions.

Proof. According to Theorem 4, the only thing we need to prove is that inequality (19) is satisfied. Then using Theorem 5 the result follows. In our case inequality (19) can be written as

If we substitute $!_K = \frac{p}{q}!_I$ (where $!_I \in 0$ and $p \in 0$) we obtain that (19) is always veri ed except for the solutions of the equation

But this equation has at most ve distinct solutions, which do not a ect the outcome since, if elim inating them, the remaining set is still dense in the real line. This completes the proof.

V II. G eodesic deviation

In this and the following section we will show that if the particles do not collide but stay close enough together, the motion is not chaotic. This is somewhat surprising since one expects that, as in celestial mechanics or atom ic physics, chaos appears because of near-collision approaches. Of course, our result does not exclude the possibility that chaos is determined by only brief passages close to collision.

Our proof is based on a local criterion due to Szczesny and Dobrowolski [13]. The idea is to rewrite the equations of motion in terms of the geodesic equation with respect to the Jacobim etric and to measure the local tendency of the geodesics to diverge or converge. If they diverge, chaos may appear, but if they converge, chaos is impossible.

Let us st outline the ideas that lead to the above mentioned criterion. In general, for a Ham iltonian function

H
$$(q;p) = \frac{1}{2}g^{ij}(q)p_ip_j + U(q);$$

where g^{ij} are the components of the covariant tensor corresponding to the R iem annian metric $g_{ij}dq^i-q^j$, with $p_i=g_{ij}q^i$, the equations of motion can be written as the Euler-Lagrange system

$$q^{i} + {}^{i}_{kl} \underline{q}^{k} \underline{q}^{l} = g^{ik} \theta_{k} U (q);$$
 (20)

in which $^{i}_{kl}$ is the Levi-C ivita connection for the metric g_{ij} . The energy relation H (q;p)=h foliates the phase space in codimension-one manifolds. Let us x an h and de ne an open set D $_h$ of the con guration space as D $_h$ = fq jU (q) < hg. It can be shown that the orbits of (20) are orthogonal to the boundary of D $_h$. Let us de ne the Jacobi metric $\mathring{g}^{ij}=2(h+U)\mathring{g}^{ij}$ and the parameter s such $\frac{ds}{dt}=2(h+U)$. It can be shown that on the set D $_h$, equations (20) are equivalent to the geodesic equations

$$\frac{\mathrm{d}^2 q^i}{\mathrm{d}s^2} + ^i{}_{jk} \frac{\mathrm{d}q^j}{\mathrm{d}s} \frac{\mathrm{d}q^k}{\mathrm{d}s} = 0; \tag{21}$$

where $^{^{1}}_{jk}$ is the Christo elsymbol with respect to the metric \hat{g}^{ij} . Note that $\hat{g}_{ij}(q(s))\frac{dq^{i}}{ds}\frac{dq^{j}}{ds}=1$. Equations (21) can be further written as

$$\hat{r}_{11}u = 0;$$

where u is the tangent vector to the geodesic and $\hat{\mathbf{r}}$ is the covariant derivative with respect to the Jacobi metric. A iming to understand the relative motion of geodesics in a domain inside D $_{\rm h}$, we take a curve transversal to the geodesics, then take a copy of it by transporting each point of the initial curve along the geodesic, and measure in this way the local relative deviation of the geodesics. It can be proved that, in classical form, the measure of the deviation is given by the solution of the Jacobi equation [20]

$$\frac{d^2x}{ds^2} = K(s)x; (22)$$

where x is the variable that measures the deviation and K is the Gauss curvature at x(s). If K > 0 the geodesics approach each other, whereas if K < 0 they diverge. For 2-degree of freedom systems the curvature is given by the formula [13]

$$K = \frac{g^{ij} (@_{i}V) (@_{j}V) + (h U) U}{4 (h U)^{3}};$$
 (23)

where = 2 + 2 + 2 = 2 is the Laplacian operator. In [13] the following result is proved.

Theorem 7 If K given by formula (23) is negative, the geodesics diverge and chaos may appear; if K is positive, the geodesics converge and chaos cannot take place.

Wewill further use this result to investigate the possibility of encountering chaotic motion in the neighborhood of collisions.

V III. A bsence of chaos near collision

In order to apply Theorem 1 to the equations of motion of the anisotropic M anev problem, let us rst show that the hypothesis that leads to the geodesic deviation equation (22) is satis ed. For this we need to make sure that the geodesics do not reach the boundary of the set D $_{\rm h}$, in other words we must isolate a set of solutions with this property. This will be achieved while proving the following result, which shows that collisionless solutions that keep the particles close together cannot be chaotic.

Theorem 8 There exists a positive-measure set of orbits that are free of collisions and for which the distance between particles does not exceed a certain uniform bound. Within this set, chaotic motion is ruled out.

Proof. In the case of the anisotropic M anev problem, the expression of the kinetic energy shows that the metric is at and that $g_{ij}=1$ for i=j and $g_{ij}=0$ for $i \notin j$. Therefore the curvature K given by formula (23) takes the form

$$K = \frac{\dot{j} r U \dot{j} + (h U) U}{4 (h U)^{3}};$$
 (24)

where U (q) = $\frac{p-1}{q_1^2+q_2^2}$ $\frac{b}{q_1^2+q_2^2}$. Let us now see that there exists a set of solutions, whose projection in the con guration space lies inside D $_h$. These will form an open set of uniform ly bounded and collisionless solutions.

For this consider the analytic dieom orphic transform ation of the dependent variables,

and the analytic dieom orphic transform ation of the independent variable

$$d = r^{1}dt: (25)$$

Notice that r and ' are polar coordinates, whereas v and u represent the rescaled radial and tangential components of the velocity. In these new variables, the equations of motion take the form

and the energy relation H (q;p) = h becomes

$$u^2 + v^2$$
 2r(\cos^2 ' + \sin^2 ') ¹⁼² 2b(\cos^2 ' + \sin^2 ') ¹ = 2hr²: (27)

The new dependent variables (r; v; '; u) 2 (0; 1) R S¹ R are functions of the ctitious time, so the prime denotes from now on dierentiation with respect to this new independent variable.

Let us rst notice that there exist two constants, m $_1$ and m $_2$ with 0 < m $_1$ < m $_2$ < 1 , such that along any solution (r;v;';u) of system (26), the function of given by \cos^2 ' + \sin^2 ' satis es the relations

$$m_1 < cos^2' + sin^2' < m_2;$$

for all $\,$ for which ' is de ned. Consequently there exist two constants, M $_1$ and M $_2$, with 0 < M $_1$ < M $_2$ < 1 , such that

$$M_1 < (\cos^2 ' + \sin^2 ')^{1=2} < M_2$$
 (28)

for all . From the rst two equations of system (26), we obtain the nonhomogeneous second-order equation

$$r^{00}$$
 2hr = $(\cos^2 r + \sin^2 r)^{1=2}$; (29)

which represents a forced harm onic oscillator. We will further ignore the last two equations of system (26) and retain only the information that the forcing function ($\cos^2 \prime + \sin^2 \prime$) ¹⁼² is uniformly bounded from above and away from zero from below, as relations (28) indicate.

We will further restrict our analysis to the invariant manifold of solutions of negative energy, h < 0, which obviously exists according to relation (27). Solving the hom ogeneous equation r^{0} 2rh = 0 and then applying to equation (29) the method of variation of parameters, we obtain the general solution of equation (29) in the form

$$r(\) = c_1 + \frac{1}{p-1} R_0 \frac{p - \cos(\frac{p-1}{2h})}{\cos^2(\frac{p+1}{2h})} d \sin(\frac{p-1}{2h})$$

$$+ c_2 \frac{1}{p-1} R_0 \frac{p - \sin(\frac{p-1}{2h})}{\cos^2(\frac{p+1}{2h})} d \cos(\frac{p-1}{2h})$$

If, for every solution of constants c_1 and c_2 , we apply to each of the above integrals the interm ediate-value theorem and then use some trigonometry we obtain

$$r(\) = \ (c_1^2 + c_2^2)^{\frac{1}{2}} \cos(! \ !_0)$$

$$\frac{p \sin^2(\frac{p}{2h})}{2h \cos^2(\frac{p}{2h})} \frac{p \cos^2(\frac{p}{2h})}{2h \cos^2(\frac{p}{2h})};$$
where 1 and 2 belong to the interval (0;), ! = $\frac{p}{2h}$ and ! 0 = $\arctan \frac{c_2}{c_1}$.

where $_1$ and $_2$ belong to the interval (0;), ! = $^{\frac{1}{2}}$ 2h and ! $_0$ = arctan $\frac{c_2}{c_1}$. Relations (28) and (30) allow us to draw the conclusion that for any solution (r;v;';u) of system (26), the inequalities

$$q \frac{1}{c_1^2 + c_2^2} \cos(! \quad !_0) \quad \frac{M_1}{2h} < r() < \frac{q}{c_1^2 + c_2^2} \cos(! \quad !_0) \quad \frac{M_2}{2h} \quad (31)$$

take place for all for which the solution is de ned.

Let us now x som e h_0 < 0, as close to 0 as we like, and de ne the set (h_0) of solutions form ed by the union of all sets h, for h in the interval (1; h_0), where each set h contains all the solutions given by (30) that satisfy the inequality

$$c_1^2 + c_2^2 < \frac{M_1^2}{4h^2}$$
:

O bviously, this is an open, nonempty, and connected invariant manifold of system (26). From (31) it follows that, for every solution of this manifold, r is positive and bounded, therefore the orbits are collisionless and bounded. Let us denote by (h_0) the projection of (h_0) into the conguration space. For xed, suitable choices of $c_1;c_2$, and h provide solutions with q_1 and q_2 small enough such that U $(q) < h_0$. Moreover these choices can be made such that r is as close to 0 as we like but still positive. O bviously, the set of the corresponding solutions has positive measure. Let us denote by (h_0) the corresponding projection of the set of such solutions in the conguration space. O bviously (h_0) is contained in (h_0) as well as in D h_0 . This shows that the hypothesis leading to the criterion of the previous section is satis ed. A straightforward computation yields

$$K = \frac{3 (h \ U) (^2 q_1^2 + q_2^2)}{(\ q_1^2 + q_2^2)^{5-2}} \quad \frac{[1 \ 8b (h \ U)] (^2 q_1^2 + q_2^2)}{(\ q_1^2 + q_2^2)^3} + \frac{4b^2 (^2 q_1^2 + q_2^2)}{(\ q_1^2 + q_2^2)^4} + \frac{4b (^2 q_1^2 + q_2^2)}{(\ q_1^2 + q_2^2)^4} \cdot \frac{1}{(\ q_1^2 + q_2^2)^7} \cdot \frac$$

The rst term is always negative and the second can also be negative, depending on the xed value of b. But since the last two terms are positive and the powers at their denominators exceed those of the denominators of the rst two terms, for su ciently small q_1 and q_2 , the curvature K is positive. We can always de ne (h_0) such that the congurations corresponding to the solutions with corresponding q_1 and q_2 are contained in (h_0) . Therefore, according to Theorem 7, the set of collisionless solutions for which the bodies stay close enough together, does not exhibit chaotic behavior. This completes the proof.
